









Information about students enrolling in colleges and universities after graduation is collected from the National Student Clearinghouse (NSC), which collects data from at least 97% of higher education institutions nationwide. New Jersey graduates are matched to postsecondary enrollment data by NSC each year. While most students who enroll in a postsecondary institution each year are able to be matched by NSC, there are some students each year who cannot be matched. Some reasons that students may not be matched are: 1. Postsecondary enrollment cannot be shared with the NJDOE if students request a FERPA block on their postsecondary enrollment records; 2. In 2023, NSC implemented an additional manual review process to reduce the number of students who do not match due to #4 above, which may result in NSC matching additional students to postsecondary records moving forward. As a result, the NJDOE is not including trend data from prior to 2022-2023 in the reports.

Students in grades 9-12 are provided a variety of learning opportunities through the College Prep, Advanced, Honors, and AP-level courses that are offered, as well as numerous electives, including fine arts and music programs. An integrated approach to instruction emphasizes the importance of thinking critically in order to grow academically, socially, emotionally, and physically. The rigorous program of studies contains a full complement of courses, and each discipline offers an advanced placement course. Twenty-three of the AP courses and one honors course have been accepted into the Seton Hall Project Acceleration Program, as well as the concurrent enrollment program with RVCC. Students can also take courses at Hunterdon County Polytech. Hunterdon County Vocational School District offers three four-year academies; North Hunterdon houses the Biomedical Sciences Academy.

There are three full-day staff in-service days during the school year, along with four half-day opportunities. The 2023-2024 Professional Development Plan focused on accelerating learning; examining common assessment results; issues relating to diversity, equity, and inclusion; and social and emotional learning. The in-service time is used to complete mandated trainings, hold department meetings, and take professional development classes. In addition, Faculty and Staff are involved in department professional learning communities to collaborate on goals and initiatives.



The Counseling Office holds a variety of post-secondary evening programs for parents and students, such as Financial Aid Night, Introduction to College Planning, and NCAA Night. Free Math and English SAT Prep classes are offered and taught by our teachers. Parent organizations also offer workshops that include Navigating the College Process, College Application 101, College Essays, Mock Interviews, SAT prep, Financial Aid sessions, and parent chats to assist in post-secondary planning. Every year, North Hunterdon graduates attend the top colleges/universities in the country. For the Class of 2024, 82% are attending two- or four-year colleges/universities, 0.3% are attending business/art/technical schools, and 0.4% joined the military.



Special Services include a wide variety of programs across the Special Education continuum. Classes include, but are not limited to, consultation, in-class resource, pull-out replacement, and an array of special class programs that support students with multiple disabilities, autism, and emotional regulation impairments. Lower-level ELL students are allowed to attend a specialized program. At-risk students are assisted with Response to Intervention services. For tutoring, students can use Tutor.com, a 24/7 online tutoring site, or sign up for virtual tutoring with district teachers after school and evening. The District contracts with Effective School Solutions, which provides a therapeutic level of mental health support. An 8th-grade orientation program assists students with the transition to high school. Most recently, the District opened an alternative school called The Lion PRIDE Academy in the 2019-2020 school year for students with severe emotional regulation impairments.

Health and wellness educational information is shared throughout the year with parents and students. Topics in 2023-2024 included: Suicide Prevention, Effective Communication for Teens and Adults, Raising Resilient Teens, Underage Drinking, Trends in Drug Use, and Teen Dating Violence. The district placed an increased emphasis on social-emotional learning for students by providing bi-monthly information on mental health, stress & anxiety, methods to deal with mental health, coping skills, stress reduction techniques, etc. The overall goal was to give the students additional tools to use for a more balanced mental health approach. Group & individual counseling are available with the Student Assistance Counselor as well as crisis counseling with Effective School Solutions. Lifelines Suicide Prevention Program included in Health curriculum for freshmen, and reinforced in subsequent years.



North Hunterdon has a very active parent community. There are opportunities for parents to get involved in the Parent Teacher Student Association (PTSA), North Hunterdon Music Association (NHMA), North Hunterdon Education Foundation (NHEF), North Hunterdon Athletic Booster Club, Principal's Parent Advisory Committee, and Special Education Parent Advisory Group (SEPAG).

The North Hunterdon-Voorhees district follows the Standard Response Protocol, which has been adopted by every school district in Hunterdon County. Staff and students drill monthly on various security protocols. Security measures include additional security cameras, security vestibule at main entrance, visitor management system, electronic locks and ID access, door alarm system that activates at security desk with video surveillance, vehicle-stopping bollards in front of building, and digital radio system connecting administration and law enforcement. School also has a School Resource Officer and Class III Security Officers.



The North Hunterdon-Voorhees district is a 1:1 mobile computing device district. Every student is provided with a Chromebook for use in school and at home, which was instrumental in our ability to move to all virtual instruction during the school closure for COVID-19 in spring 2020, as well as offer hybrid and all virtual instruction options for students during the 2020-2021 school year. Every teacher is provided with a laptop, and all classrooms are equipped with projectors. The district offers various STEM courses, from Engineering to Robotics to Computer Science through Gaming. Students can also take vocational courses at Hunterdon County Polytech.



The school runs regular reports listing the students who have been chronically absent at that point in the school year along with their number of absences. Counselors and administrators follow up with the students to develop a plan to improve their attendance. The school also has support services to assist students with school avoidance issues.

North Hunterdon High School provides an outstanding academic program. We have been ranked repeatedly as one of the top 50 high schools in New Jersey by "New Jersey Monthly Magazine" and have been honored by the College Board for our Advanced Placement programs. We are a comprehensive secondary (9-12) school with a student population of about 1,500. North Hunterdon educates students from six different municipalities. We have 139 teachers on staff, of which about 50% have earned advanced degrees in their field. Our school provides an academic and activity-rich environment with multiple opportunities for student involvement in extra-curricular clubs/activities and sports. We have received Best Practice Awards from the New Jersey Department of Education in Mathematics, Special Education, Music, and Science. The district implemented a new 55-minute rolling drop-block schedule over a four-day rotation in the 2017-2018 school year.
