




English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. The data includes the results of students taking both the New Jersey Student Learning Assessment (NJSLA) and the DLM alternate assessment for English language arts (ELA) and mathematics. The Proficiency Rate for Federal Accountability measures the percentage of students who met or exceeded expectations on the assessments (NJSLA or DLM) with an adjustment made if the participation rate is below 95% to ensure reporting on at least 95% of students. Students who were enrolled for less than half a school year are excluded from performance results. 



Mathematics Assessment - Performance By Test: Geometry

This table shows performance on the NJSLA Geometry end-of-course assessment. The performance results in this table include all students who took the NJSLA assessment, it does not exclude students that were enrolled less than half a year.

This includes any students who were enrolled in a Geometry course and took the Geometry assessment in grades 7 through 12. Students in sixth grade who were enrolled in a Geometry course were required to take both the Geometry and Grade 6 mathematics assessment. The results of their Geometry assessment are not included in these results but will be reported when the student is in grade 9.












Information about students enrolling in colleges and universities after graduation is collected from the [National Student Clearinghouse \(NSC\)](#), which collects data from at least 97% of higher education institutions nationwide. New Jersey graduates are matched to postsecondary enrollment data by NSC each year. While most students who enroll in a postsecondary institution each year are able to be matched by NSC, there are some students each year who cannot be matched. Some reasons that students may not be matched are: 1. Postsecondary enrollment cannot be shared with the NJDOE if students request a FERPA block on their postsecondary enrollment records; 2. Students who attend a college or university outside of the United States are not included in NSC data; 3. Certain colleges or universities may not participate in sharing data with NSC or may fail to report data for a certain semester or a certain group of students; and 4. NSC may not be able to match a student's name or date of birth in NJ SMART to the information provided by the postsecondary institution(s) with a high level of confidence.

In 2023, NSC implemented an additional manual review process to reduce the number of students who do not match due to #4 above, which may result in NSC matching additional students to postsecondary records moving forward. As a result, the NJDOE is not including trend data from prior to 2022-2023 in the reports.

Note for 2023-2024: Postsecondary enrollment data for the 2023-2024 school year is not yet available. The NJDOE expects to release the data in the coming months. Please refer to the 2022-2023 reports for the most recently available postsecondary enrollment rates.







Student absences provide important information about a school's culture and climate. Research shows that absences impact a student's ability to succeed in school. The NJDOE used input from stakeholders to select chronic absenteeism as its measure of school quality and student success for the ESSA accountability plan. **Chronic absenteeism** is defined as being absent for 10% or more of the days enrolled during the school year. A student who is not present for any reason, whether excused, unexcused, or for disciplinary action, is considered absent unless permitted by state statute or regulations. Students with fewer than 45 days in membership are excluded from attendance calculations.





Based on New Jersey's [approved ESSA state plan](#), NJDOE will identify schools in the following four federal categories every three years:

- **Comprehensive Support and Improvement (CSI): Overall Low Performing:**
 - Title I schools with a summative score in the bottom 5% of Title I schools.
- **Comprehensive Support and Improvement (CSI): Low Graduation Rate:**

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. - Students at Voorhees High School consistently score above the state average on the NJSLA and SAT tests.

Voorhees High School is a 2015 National Blue Ribbon School that continually ranks among the top public high schools in New Jersey and in the country. Each year, students earn recognition as National Merit Semi-Finalists and/or Commended Students as well as AP Scholars. The Unified initiative and addition of a Unified Sports program has helped to build on unity and equality among students. We are honored to have been named a National Unified Champion School by Special Olympics within two years of launching the initiative.

Courses, Curriculum, Instruction:

Students in grades 9-12 are provided a variety of learning opportunities through the College Prep, Advanced, Honors, and AP-level courses that are offered. An integrated approach to instruction emphasizes the importance of thinking critically in order to grow academically, socially, emotionally, and physically. The rigorous program of studies contains a full complement of courses, and each discipline offers an advanced placement course. Students can also earn college credit for certain AP and Honors courses through the Seton Hall Project Acceleration Program and RVCC Concurrent Enrollment Program. Students can take courses at Hunterdon County Polytech. Hunterdon County Vocational School District offers three four-year academies; Voorhees houses the Environmental Sustainability and Computer Sciences Academies, as well as part of the four-year Polytech program for Animal Science.



Sports and Athletics:

The Voorhees Athletic Program has enjoyed some successful years in recent history. We have won State Championships in the following sports: Boys Cross Country, Girls Cross Country, Field Hockey, Cheerleading, and Baseball, in addition to various Skyland Conference Divisional Titles. Our Girls Golf won the Hunterdon-Warren-Sussex Championship two years in a row and had a player place second in the state in 2023. We have had various other individual athletes distinguish themselves at the state level, and our program has produced multiple collegiate athletes, including some at the Division One level. We are excited to offer Unified Sports in all three seasons. Most importantly, our coaching staff continually provides a structured and positive learning environment where student-athletes can improve their skills, experience the thrill of competition, bond as a team, and be privy to all the important life lessons scholastic sports has to offer.



Clubs and Activities:

Voorhees has 35 total clubs (11 of which are co-curricular, including ones for languages and honor societies) that offer opportunities of involvement and community service. We have 14 academic competition programs (including 6 co-curricular, such as for sciences and mathematics) that allow students to compete statewide and nationally. We have 11 intramural activities that allow students to be active both before and after school.

Staff and Professional Learning:

There are three full-day staff in-service days during the school year, along with four half-day opportunities. The 2023-2024 Professional Development Plan focused on accelerating learning; examining common assessment results; issues relating to diversity, equity, and inclusion; and social and emotional learning. The in-service time is used to complete mandated trainings, hold department meetings, and take professional development classes. In addition, Faculty and Staff are involved in department professional learning communities to collaborate on goals and initiatives.



Postsecondary Information:

The Counseling Office holds a variety of post-secondary evening programs for parents and students, such as Financial Aid Night, Introduction to College Planning, and NCAA Night. Staff advisors and parent organizations offer SAT prep and financial aid sessions to assist in post-secondary planning. PSAT testing is administered to all 9-11 grade students. Every year, Voorhees graduates attend the top colleges/universities in the country. For the Class of 2024, 88% are attending two- or four-year colleges/universities, 2% are attending business/art/technical schools, and 0.3% entered the military.



Student Supports and Services:

Special Education programs include employment orientation, multiple disabilities, autism, alternative learning program, consultation, in-class Support, and Resource Replacement. In addition, the school offers Unified Sports, which brings together students with and without disabilities on the same team. Lower-level ELL students are given the opportunity to attend a specialized program. At-risk students are assisted with Response to Intervention services. For tutoring, students can use a 24/7 online tutoring site or sign up for virtual tutoring with district teachers after school and evening. An 8th-grade orientation program assists students with the transition to high school, and Voorhees has a student club called SHIP (Student High School Integration Program) through which high school students reach out to 8th graders coming up from the sending districts to help them transition to a new school district.

Student Health and Wellness:

Health and wellness educational information is shared throughout the year with parents and students. Topics in 2023-2024 included: Suicide Prevention, Effective Communication for Teens and Adults, Raising Resilient Teens, Underage Drinking, Trends in Drug Use, and Teen Dating Violence. The district placed an increased emphasis on social-emotional learning for students by providing bi-monthly information on mental health, stress & anxiety, methods to deal with mental health, coping skills, stress reduction techniques, etc. The overall goal was to give the students additional tools to use for a more balanced mental health approach. Group & individual counseling are available with the Student Assistance Counselor as well as crisis counseling with Effective School Solutions. Lifelines Suicide Prevention Program included in Health curriculum for freshmen, and reinforced in subsequent years.



Parent and Community Involvement:

Parent groups include: PTSO (Parent Teacher Student Organization), Principal's Parent Advisory Committee, SEPAG (Special Education Parent Advisory Group), VHS Music Association, and an array of athletic Booster Clubs. The school district has a variety of parent nights offered at both of our high schools, including a college financial planning night, counseling events, Music Association's Winter Festival, and Senior Nights at athletic games.



Climate Surveys:

The surveys are professionally normed and administered through Rutgers University as part of the School Climate Transformation Project. While the domains differ between the student, staff, and parent surveys, Voorhees High School scored highest in Sense of Physical Safety, Supportive Staff-Student Relationships and Student Voice and Involvement for each survey.

School Safety:

The North Hunterdon-Voorhees district follows the Standard Response Protocol, which has been adopted by every school district in Hunterdon County. Staff and students drill monthly on various security protocols. Security measures include security cameras, security vestibule at main entrance with visitor management system, full time School Resource Officer and Class III Security Officers, security system for electronic locks and ID access, which includes door alarm system that activates at security desk with video surveillance, vehicle stopping bollards in front of building, and digital radio system connecting administration and law enforcement.



Technology and STEM:

The North Hunterdon-Voorhees district is a 1:1 mobile computing device district. Every student is provided with a Chromebook for use in school and at home, which was instrumental in our ability to move to all virtual instruction during the school closure for COVID-19 in spring 2020 as well as offer hybrid and all virtual instruction options for students during the 2020-2021 school year. Every teacher is provided with a laptop, and all classrooms are equipped with projectors. The district offers various STEM courses. Students can also take vocational courses at Hunterdon County Polytech.



Attendance:

The school runs regular reports listing the students who have been chronically absent at that point in the school year along with their number of absences. Counselors and administrators follow up with the students to develop a plan to improve their attendance. The school also has support services to assist students with school avoidance issues.

Other Information:

Voorhees High School provides an outstanding academic program. We have been repeatedly ranked as one of the top high schools in New Jersey by "New Jersey Monthly Magazine." We are a comprehensive secondary (9-12 grade) school with a student population of slightly under 1,000. Voorhees educates students from six different municipalities. We have 91 teachers on staff, of which about 50% have earned advanced degrees in their field. Our school provides an academic and activity-rich environment with multiple opportunities for student involvement in extra-curricular clubs/activities and sports. The advanced level curriculum is designed to develop individual potential while meeting the entrance requirements of America's most competitive colleges. The rigorous program of studies contain a full complement of courses, and each discipline offers an advanced placement course. Advanced placement courses are offered in Art History, Drawing, 2-D Design, English Literature and Composition, English Language and Composition, French, Latin, Spanish, Calculus AB and BC, Statistics, Computer Science, Music Theory, Biology, Chemistry, Environmental Science, Physics 1 and C, U.S. History, United States Government, World History, Psychology, Microeconomics, Macroeconomics, and Human Geography. All students are required to complete a comprehensive course in Financial Literacy. Starting in 2017-2018, Voorhees implemented a 55-minute rolling drop-block schedule over a four-day rotation cycle.
