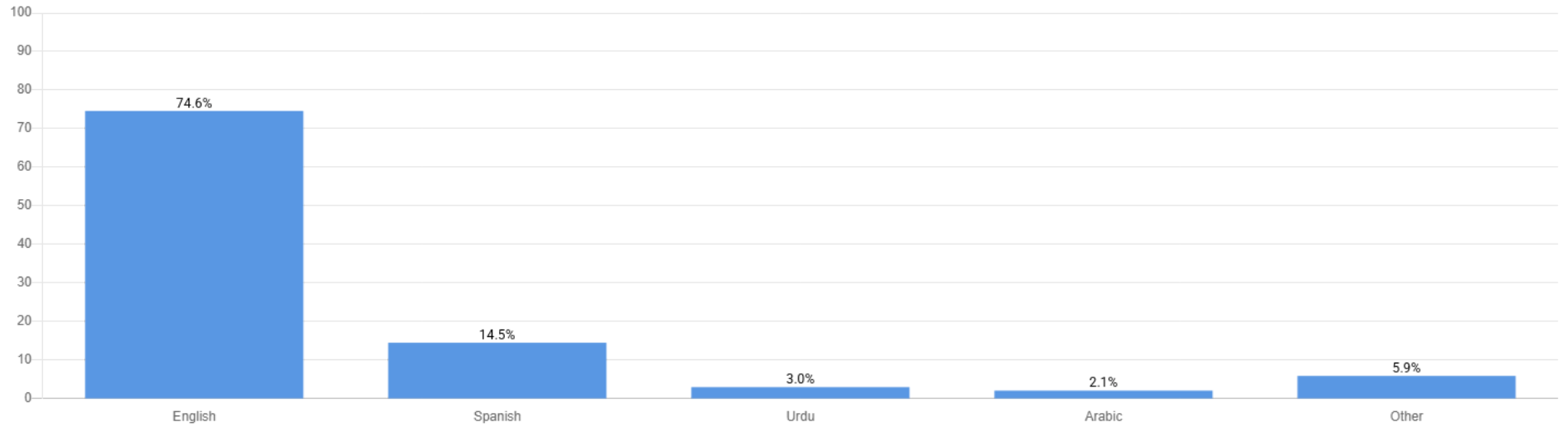

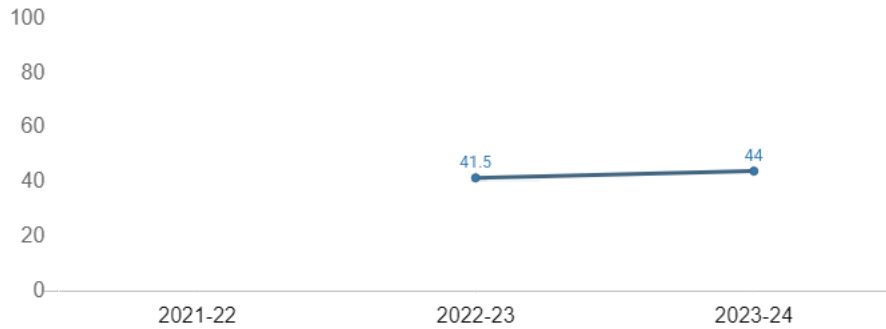

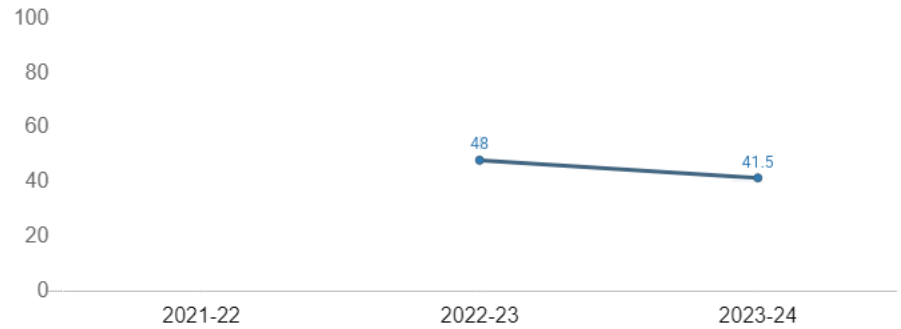

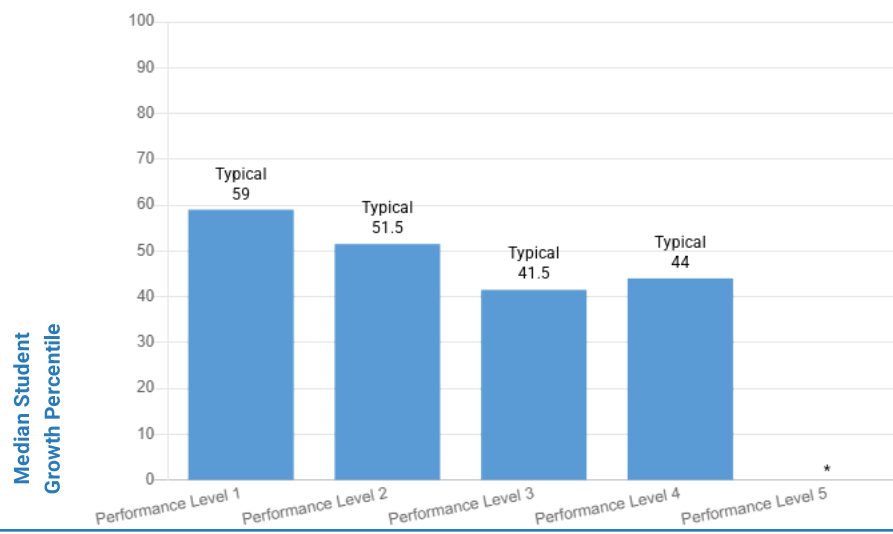

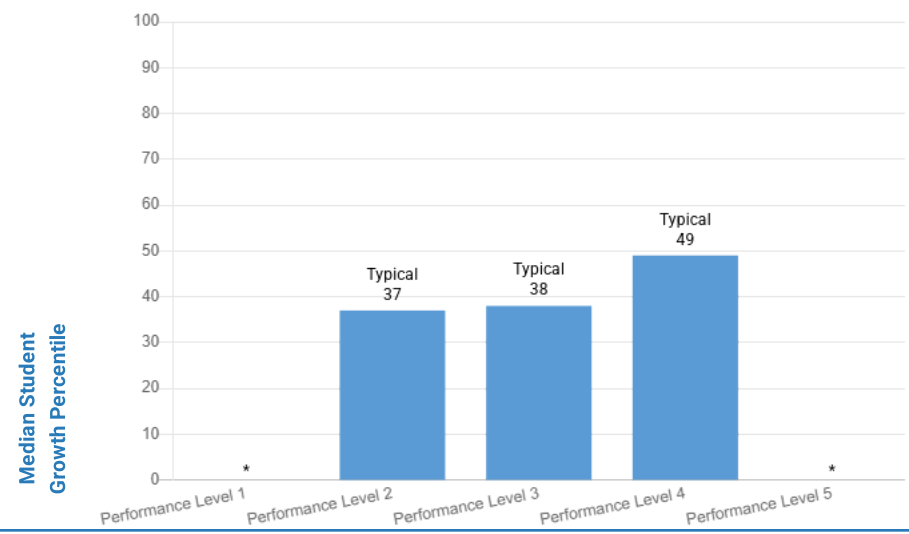

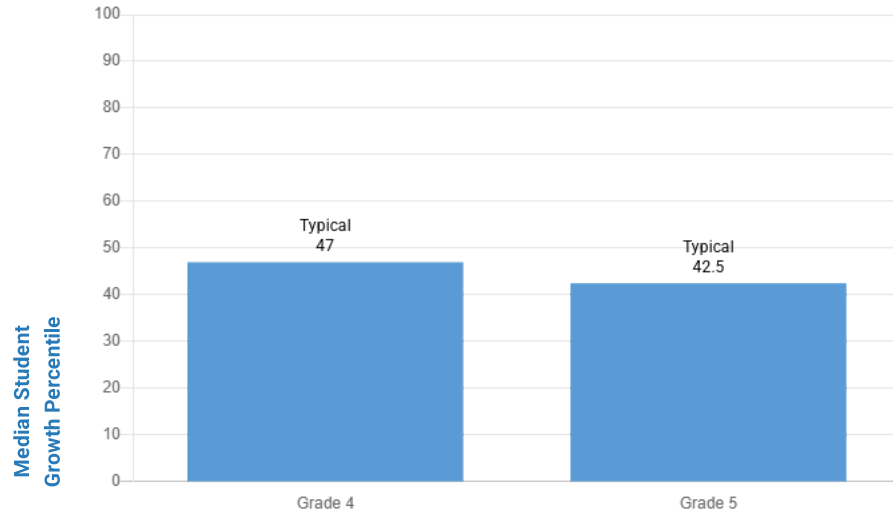

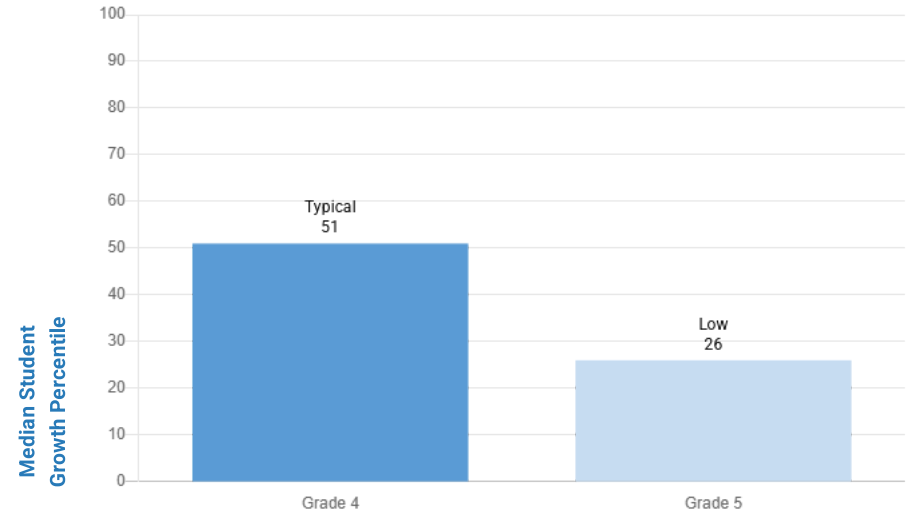

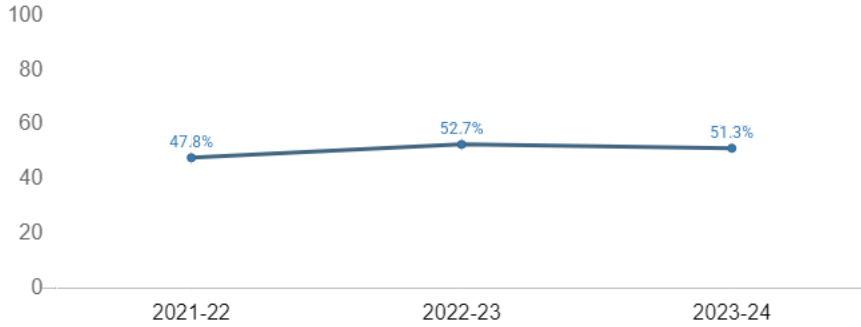

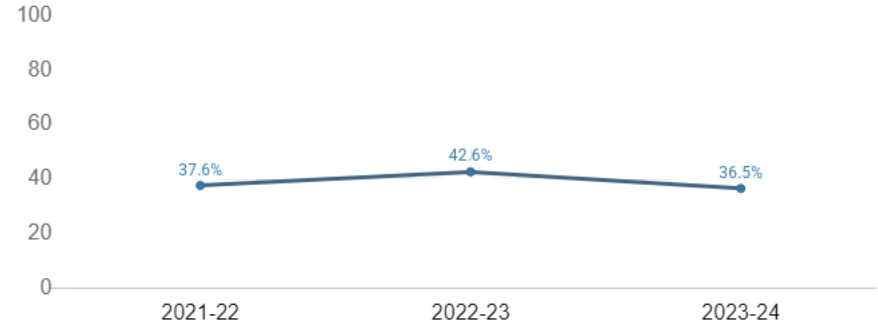
English Language Arts and Mathematics Performance Trends

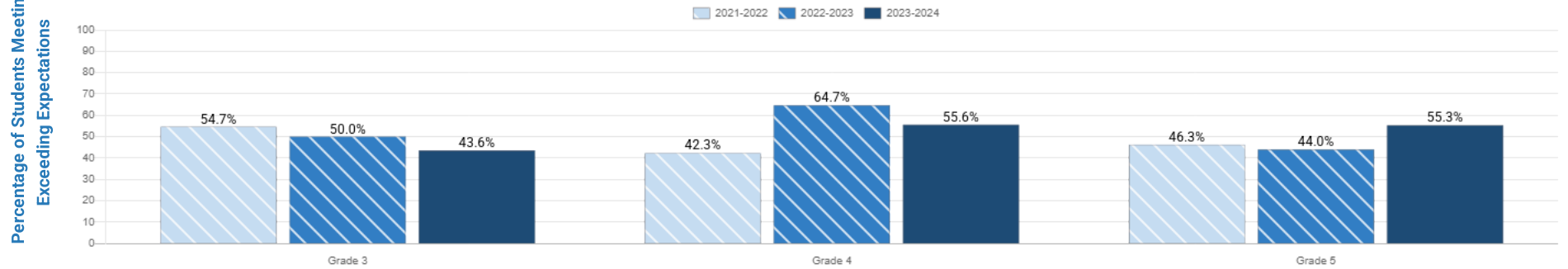

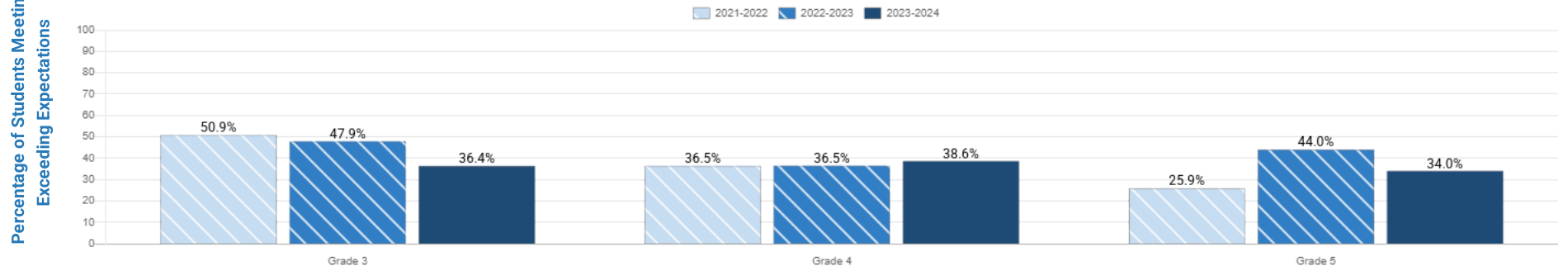

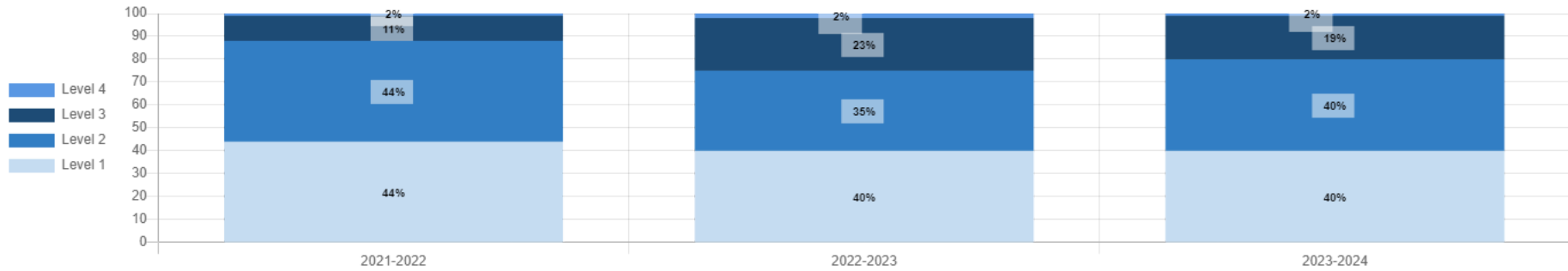

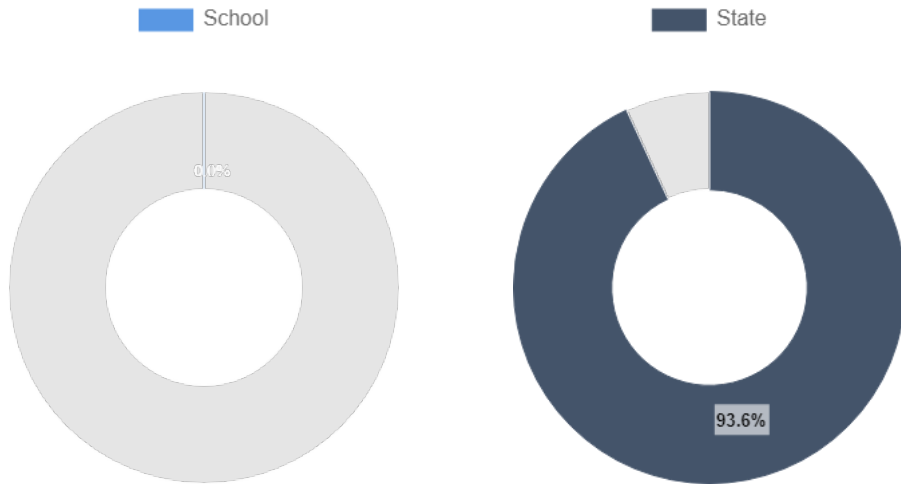

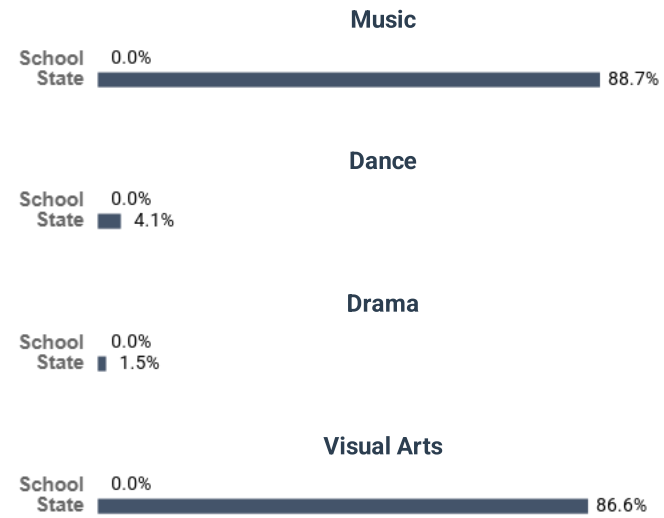

Students enrolled in one or more classes by discipline:



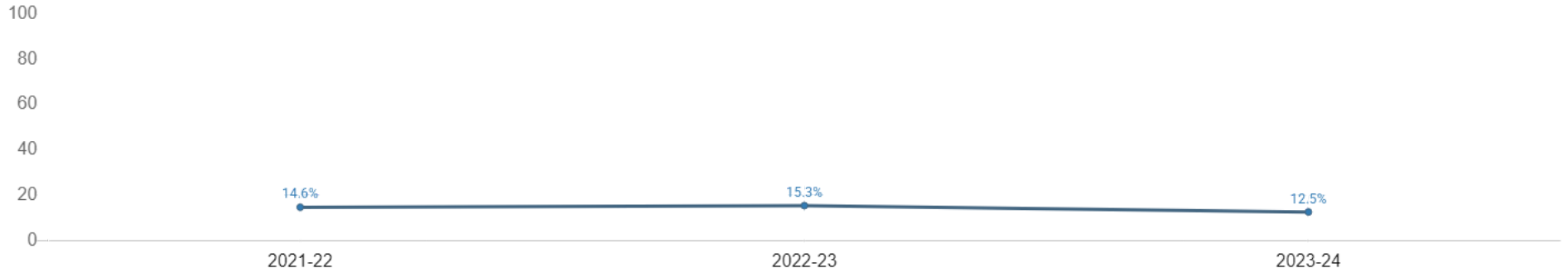

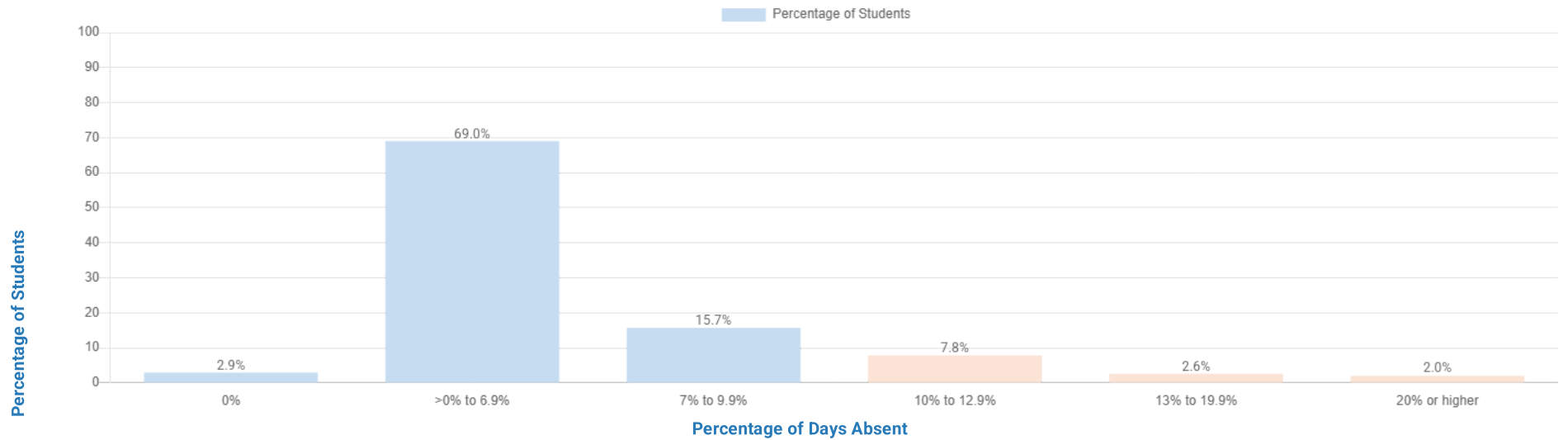

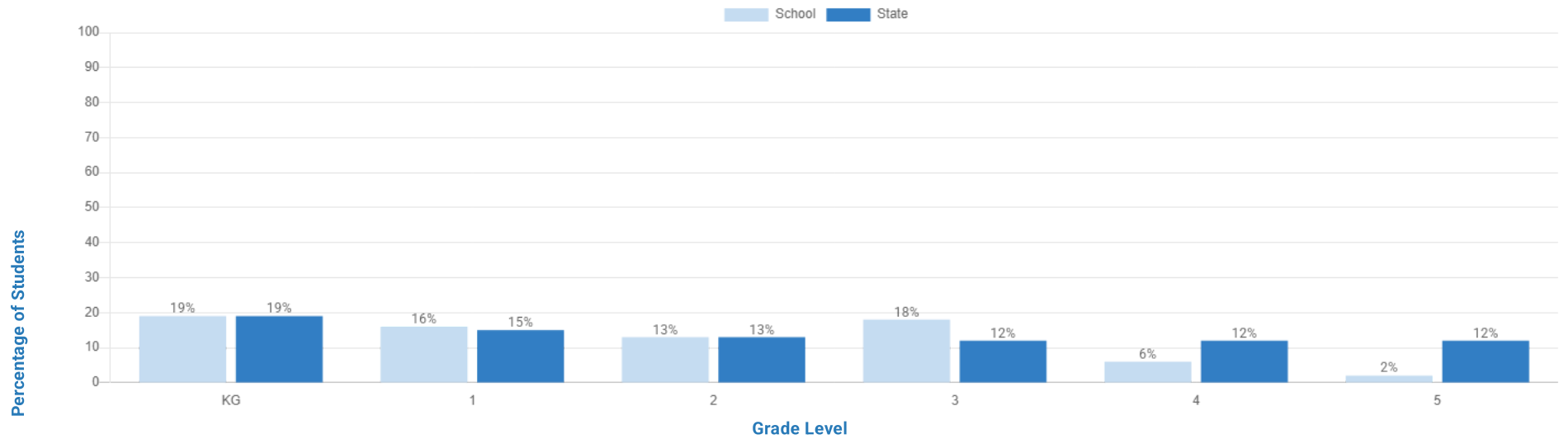

Staff

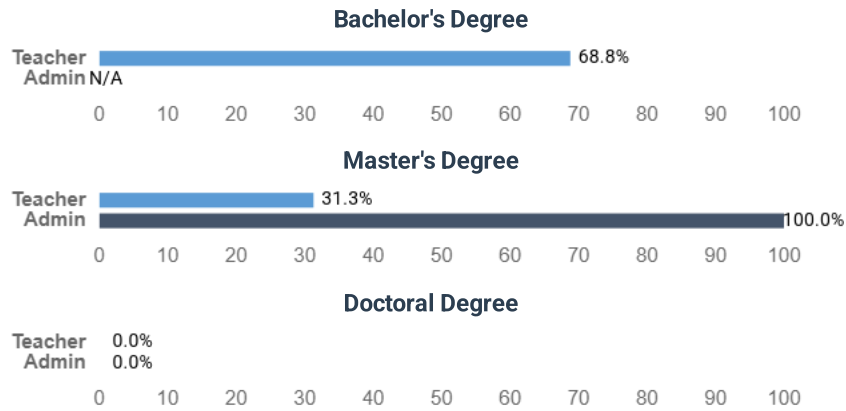

Mercerville offers full in-class resource at every grade level for our students with Individual Education Plans. In addition, we implement New Jersey Tiered System of Support, which is a framework of supports and interventions to improve student achievement, based on the core components of Multi-Tiered Systems of Support and the three tier prevention logic of Response to Intervention (RTI). With a foundation of strong district and school leadership, a positive school culture and climate and family and community engagement, NJTSS builds on Intervention and Referral Services (I&RS) and gives us the structure to meet the academic, behavioral, health, enrichment and social/emotional needs of all students. Related services such as speech, OT and PT are also available. Daily English as a Second Language program is offered for our English language learners.



Student Health and Wellness:

Mercerville School has a full time nurse on site. Annual health screenings are performed on every student. The school nurse monitors all health issues and works closely with parents/guardians to ensure the safety and well being of students.



Parent and Community Involvement:

The next addition came in 1951 and added two kindergarten classrooms and four primary classrooms, all with their own lavatories and sinks. In 1994-95 a two classroom addition and nurse's office was added to the primary wing .



School Safety:

Mercerville has a new visitor management system which checks the identification of each individual before entering the building. The building has also been equipped with an extensive security camera system both inside and out. In addition the district has supplied each school with radios that have a district wide capability. In addition, each elementary school now has a full time Campus Monitor.
