




English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. The data includes the results of students taking both the New Jersey Student Learning Assessment (NJSLA) and the DLM alternate assessment for English language arts (ELA) and mathematics. The Proficiency Rate for Federal Accountability measures the percentage of students who met or exceeded expectations on the assessments (NJSLA or DLM) with an adjustment made if the participation rate is below 95% to ensure reporting on at least 95% of students. 
















Information about students enrolling in colleges and universities after graduation is collected from the [National Student Clearinghouse \(NSC\)](#), which collects data from at least 97% of higher education institutions nationwide. New Jersey graduates are matched to postsecondary enrollment data by NSC each year. While most students who enroll in a postsecondary institution each year are able to be matched by NSC, there are some students each year who cannot be matched. Some reasons that students may not be matched are: 1. Postsecondary enrollment cannot be shared with the NJDOE if students request a FERPA block on their postsecondary enrollment records; 2. Students who attend a college or university outside of the United States are not included in NSC data; 3. Certain colleges or universities may not participate in sharing data with NSC or may fail to report data for a certain semester or a certain group of students; and 4. NSC may not be able to match a student's name or date of birth in NJ SMART to the information provided by the postsecondary institution(s) with a high level of confidence.

In 2023, NSC implemented an additional manual review process to reduce the number of students who do not match due to #4 above, which may result in NSC matching additional students to postsecondary records moving forward. As a result, the NJDOE is not including trend data from prior to 2022-2023 in the reports.











Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. Schools are identified for ATSI if they have at least one student group that has a summative score that would be in the bottom 5% of Title I schools if it was its own school. Mission, Vision, Theme:

Hopewell Valley Central High School is distinguished by the strong commitment to our community and staff toward providing outstanding educational opportunities to our students. This commitment has helped HVCHS place consistently among the top-rated schools in New Jersey. We have directed our focus on project-based learning through technology to prepare our students for the changing global economic landscape.



Awards, Recognition, Accomplishments:

Based on the results of the 2023 PSAT scores, the district had 3 National Merit Semi-Finalists, 17 Commended Scholars, 2 College Board Hispanic Recognition Scholars, 1 College Board Indigenous Recognition Scholar, and 2 College Board African American Recognition Scholars. In 2024, there were 746 Advanced Placement exams taken in 28 subjects by 334 students. 96% of the students taking AP exams earned a score of 3 or higher and 29% of the scores were a 5. HVCHS is currently listed on the College Board AP Honor Roll with silver recognition. In 2023, HVCHS was nationally recognized as a Unified Champion School based on our inclusive and supportive environment.

Courses, Curriculum, Instruction:

Our rich curriculum includes 24 Advanced Placement courses, honors-level opportunities in all academic subject areas, a work-study program with field experiences, shared-time opportunities at county vocational-technical schools and the local community college, in-depth study in five world languages, and a complete program in the visual and performing arts. Dual-credit partnerships with Syracuse University, The College of New Jersey, and Seton Hall University allow students to receive college credits while taking courses at HVCHS.

During the 2023-24 seasons, Boys & Girls Cross Country Teams won the CVC Valley Division, Boys Swimming won the CVC Valley Division, the Wrestling Team won the CVC Valley Division, the Mercer County Tournament and the Central Jersey Group 3 Sectional Title, the Boys Lacrosse Team won the Mercer County Tournament, the Boys Tennis Team won the CVC Valley Division, the Central Jersey Group 2 Sectional Title, and the Group 2 State Title, and a female golfer was the first to win the NJSIAA Boys Sectional Title.



Clubs and Activities:

Over 90 clubs and activities, both curricular and extra-curricular, are available to students, which include numerous volunteer opportunities. HVCHS also offers a Performing Arts Academy for students to showcase their talents. Competitions are open to students who participate in DECA, FBLA, the Thespian Society, Robotics, Model UN, HOSA, Jazz Band, Chorus, and those involved with the NJ Center for Civic Education.

Before and After School Programs:

For over 10 years, HVCHS has partnered with Kenya to provide a cultural exchange experience. Our Global Diversity Day exposes the school and the surrounding community to the culture of Kenya, including meeting with the Kenyan Ambassador. Each of our World Language programs provide exchange opportunities with host families and cultural immersion. Several times per year, HVCHS partners with our local Senior Citizen Center to expose the seniors to our arts programs.



Staff and Professional Learning:

Our staff is engaged in ongoing Professional Learning Communities, working with their colleagues to improve student achievement. The district continues to focus on improving our Cultural Competency, Social Emotional Learning, and Blended-Personalized Learning. Our professional development opportunities are planned with an emphasis on these concepts throughout the year. In addition, Hopewell Valley Central High School is exploring equitable grading practices, implementation of student led conferences, and development of a service learning pathway for students.



Postsecondary Information:

HVCHS had a 99% graduation rate for the class of 2024. 88% of the students attended post secondary schooling while other students attended the military and technical schools. There is strong college planning curriculum beginning in freshman year and college planning programs are offered to parents, including financial aid planning. HVCHS students take the PSAT during the school day to help prepare for the SAT, for which fee waivers are available.

Student Supports and Services:

Recitation periods, academic enrichment courses, and seminar courses enable teachers to provide extra academic assistance for students all day. In addition, HVCHS offers Supplemental Support Sessions after school each week in order to support students who may be struggling academically. The National Honor Society provides peer tutoring after school. We have a strong 504 and I&RS committees, focused on creating meaningful plans designed to assist students who are experiencing learning, behavior, or health difficulties. We have an emerging ELL program, and our special education services allow for the least restrictive environment while supporting students. We offer several specialized special education programs, including Academic Essentials (for students with multiple disabilities), IDEAS (for students with behavioral needs), and STEP (for students with emotional challenges). In addition, our ATLAS program provides additional support to general education students at risk for failure.



Student Health and Wellness:

We offer a comprehensive health and physical education program. Units consist of outdoor adventure education, fitness, various sports, and cooperative activities. Our health curriculum includes units on nutrition, human sexuality and emotional health. We also offer Teen PEP, which is a sexual health program that utilizes peer-to-peer education to increase students' knowledge, attitudes, skills, and behaviors associated with healthy decision-making.



Parent and Community Involvement:

A strong HVCHS PTO, along with the Special Education PTO, support the schools and students. HVCHS's Parents Advisory Council and our HVCHS Parent Diversity, Equity, and Inclusion Advisory Board guide the building administration and serve as a think-tank for school improvement. Community groups include HVCHY, the Municipal Alliance, and the YMCA. In connection with the district, these create a robust parent education program. All student information can be accessed through our OnCourse Parent Portal. In addition, weekly updates are sent through the district and monthly newsletters are sent from the school.

Facilities:

Recently, Hopewell Valley Central High School finalized construction projects passed through a bond referendum to improve our roofs, HVAC system, fire alarms and intercoms, renovation of main entrance and office reconfiguration, and renovation of the kitchen and cafeteria, restrooms, lighting and ceilings, and the addition of arts and wellness space. The media center was also recently renovated to be a truly transformational technology center.



School Safety:

HVCHS employs three full-time and one part-time Campus Safety Officers, who are former police officers responsible for the safety and security of the building. All visitors enter through our secure vestibule, where they are screened by a Campus Safety Officer. HVCHS regularly engages in safety drills and training opportunities for both staff and students.
