





# Graduation/Postsecondary

Information about students enrolling in colleges and universities after graduation is collected from the National Student Clearinghouse (NSC), which collects data from at least 97% of higher education institutions nationwide. New Jersey graduates are matched to postsecondary enrollment data by NSC each year. While most students who enroll in a postsecondary institution each year are able to be matched by NSC, there are some students each year who cannot be matched. Some reasons that students may not be matched are: 1. Postsecondary enrollment cannot be shared with the NJDOE if students request a FERPA block on their postsecondary enrollment records; 2. Students who attend a college or university outside of the United States are not included in NSC data; 3. Certain colleges or universities may not participate in sharing data with NSC or may fail to report data for a certain group of students; and 4. NSC may not be able to match a student's name or date of birth in NJ SMART to the information provided by the postsecondary institution(s) with a high level of confidence.

In 2023, NSC implemented an additional manual review process to reduce the number of students who do not match due to #4 above, which may result in NSC matching additional students to postsecondary records moving forward. As a result, the NJDOE is not including trend data from prior to 2022-2023 in the reports.

Note for 2023-2024: Postsecondary enrollment data for the 2023-2024 school year is not yet available. The NJDOE expects to release the data in the coming months. Please refer to the 2022-2023 reports for the most recently available postsecondary enrollment rates.



## **Before and After School Programs:**



LHS proudly serves our students with 121 highly qualified teachers from 13 departments, 13 CST & Counselors, and 54 support staff members. There are 5, full-day district professional development planned days organized by a collaborative process between staff and administration. Staff may also attend their professional learning through a variety of opportunities beyond the walls of our district in person or on-line.

## **Staff and Professional Learning:**



LHS seniors consistently have over a 94% HS graduation rate with nearly 90% attending a post-secondary education institution locally and nationally (30% 2-year college; 60% 4-year college). Annually we have about 2% of students enter the military service while 6% enter directly into the job force stemming from vocational and technical school learning facilitated through Mercer County Vo-Tech schools. All 10th and 11th grade LHS students take the PSAT on campus for free each October.

**Student Supports and Services:** 

LHS has a 6% English Language Learner population with a dedicated teacher; 19% Special Education population with 20 highly qualified Special Education teachers and 19 classroom assistants dedicated to the academic needs of special education students (this includes a dedicated alternative school assistant), along with mulitple job coaches focused solely on transitions programs to prepare students for life after HS.



The LHS Health and PE curriculum is focused upon lifetime wellness and mindfulness. In addition to Varsity sports teams, students can join the Safe Driving Club or Weight training/Fitness club, and our Red & White monthly activities that include fitness and sports themed activities. LHS has over 20% Economically Disadvantaged population and provides Breakfast and Lunch programs for students. There are dedicated Wellness & Mindfulness themed P.D. for staff during the year.



**Parent and Community Involvement:** 

The Superintendent, members of COA and the Board of Ed conducted referendum outreach at community events including "Music in the Park," Fall Arts Day, Back to School nights at all seven schools, the LTPD National Night Out, and conducted "Community Conversations" with all of our seven school communities, plus a special community conversation with the low-income housing complexin Lawrence (ECV). The Superintendent or Asst. Superintendent also meets with the Special Education Parent Advisory Group (SEPAG). The District conducted a community survey regarding the community's wishes and ideas regarding the upcoming bond referendum and presented the results at a public BOE meeting. The District publishes a print newsletter that is distributed throughout the community guarterly, a weekly e-newsletter, web site postings, Facebook posts, and tweets.
