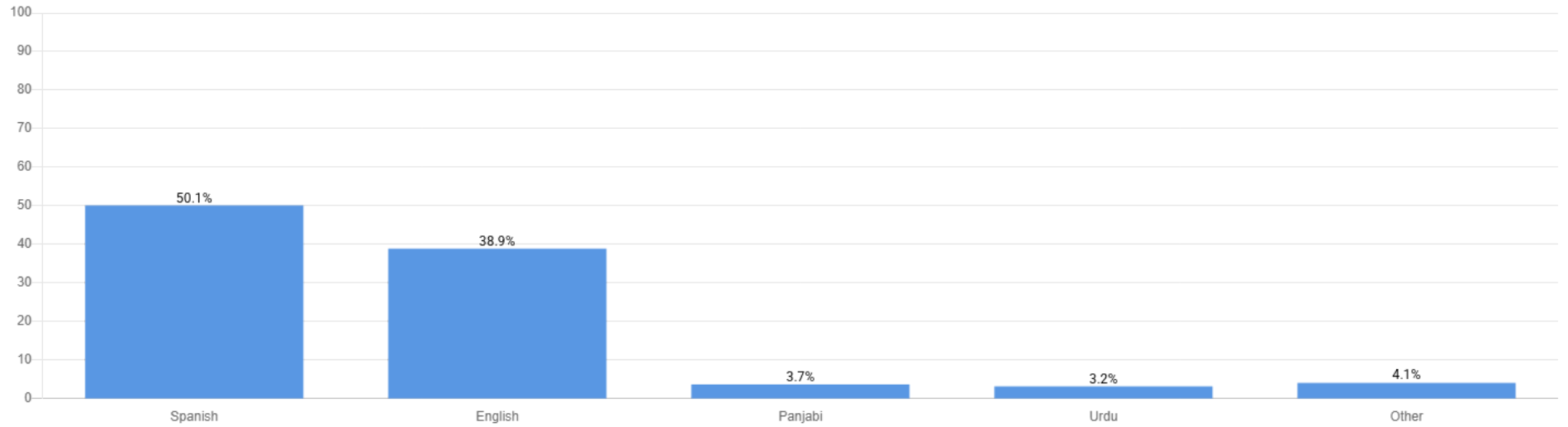

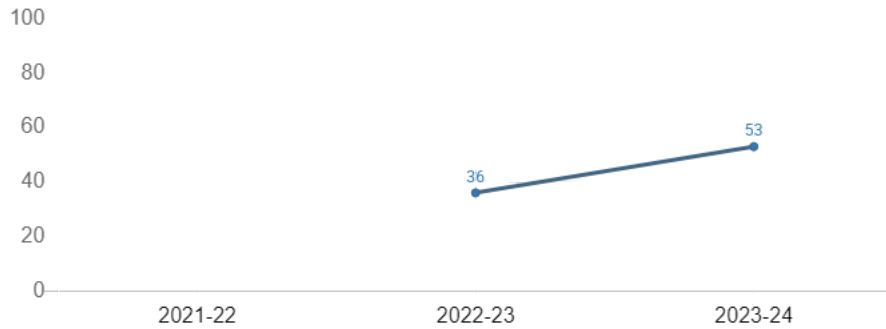

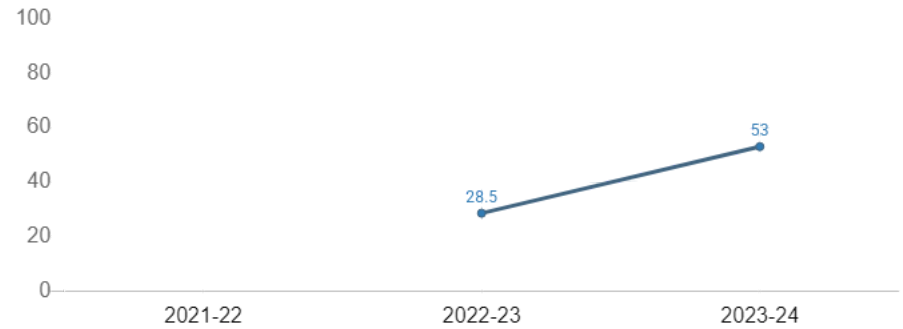

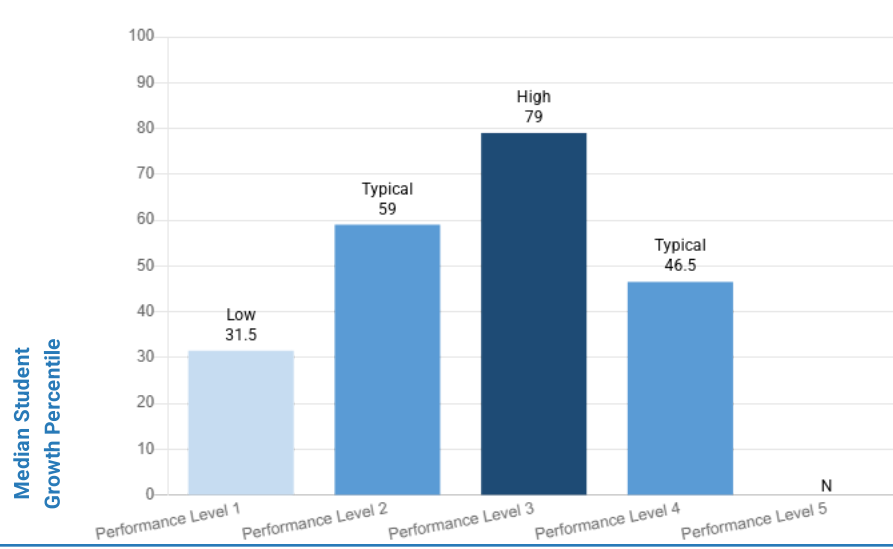

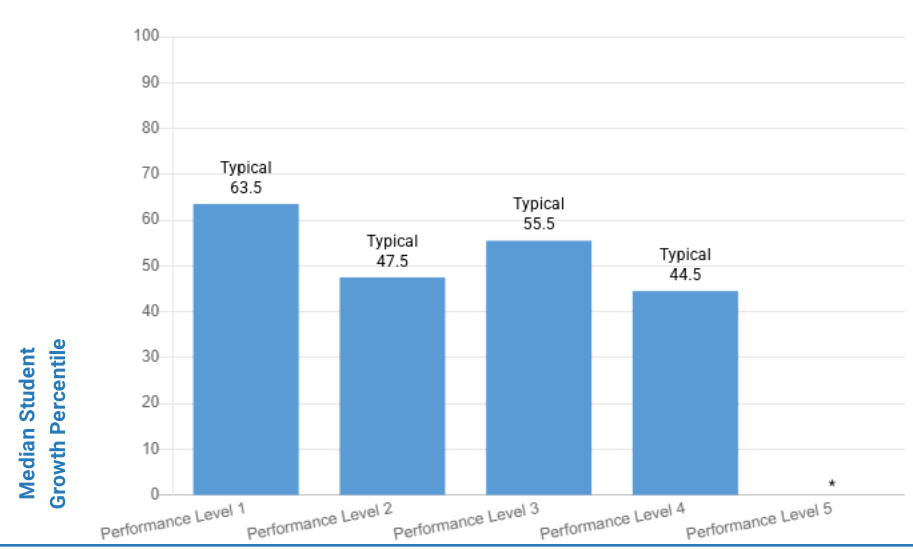

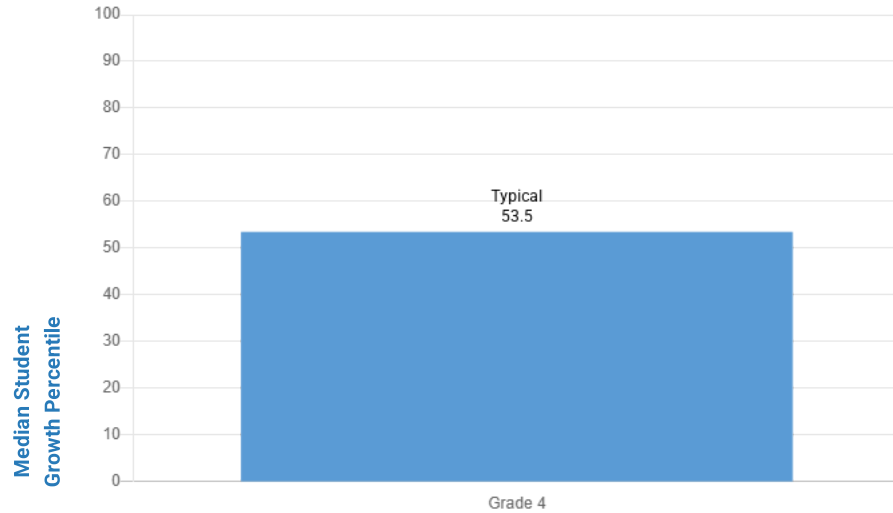

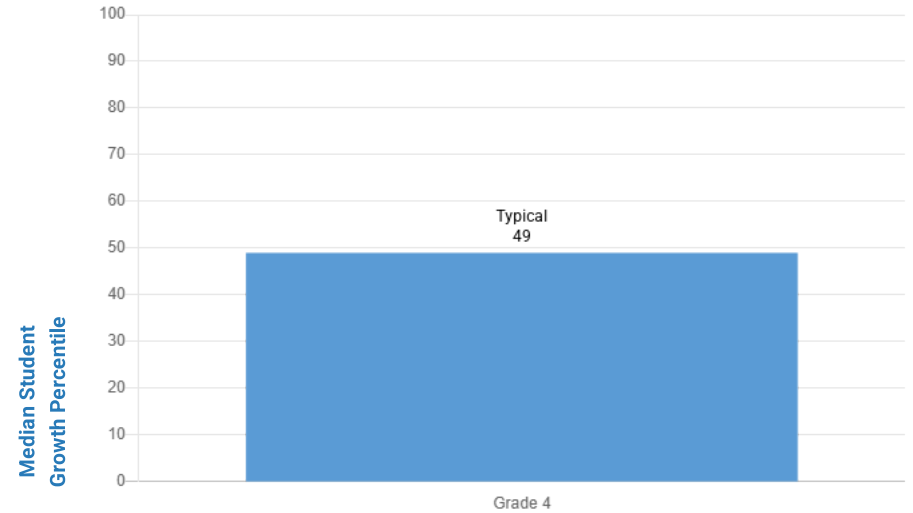

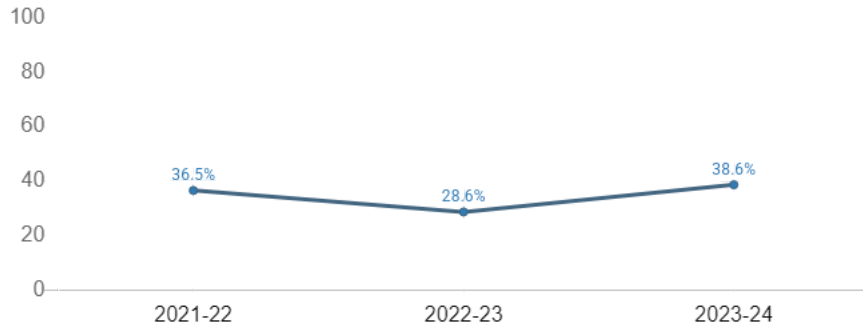

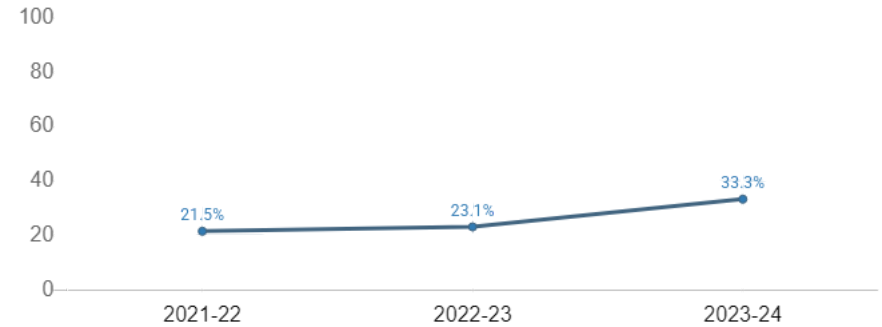
### English Language Arts and Mathematics Performance Trends

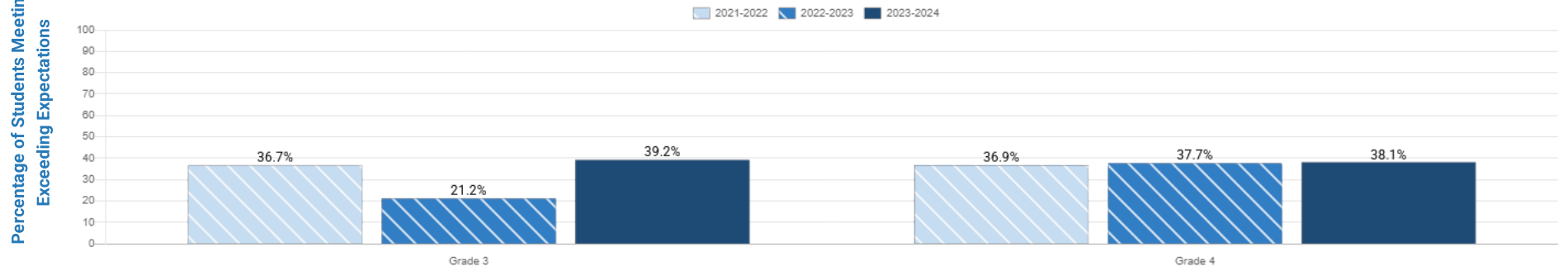

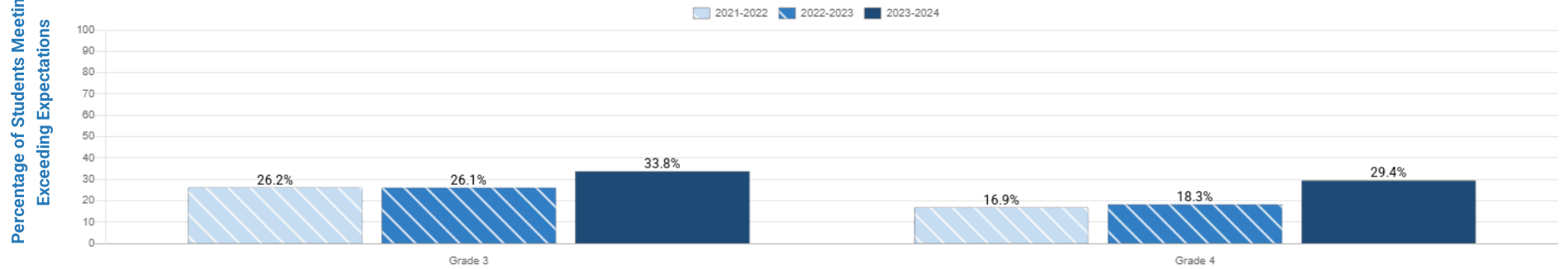

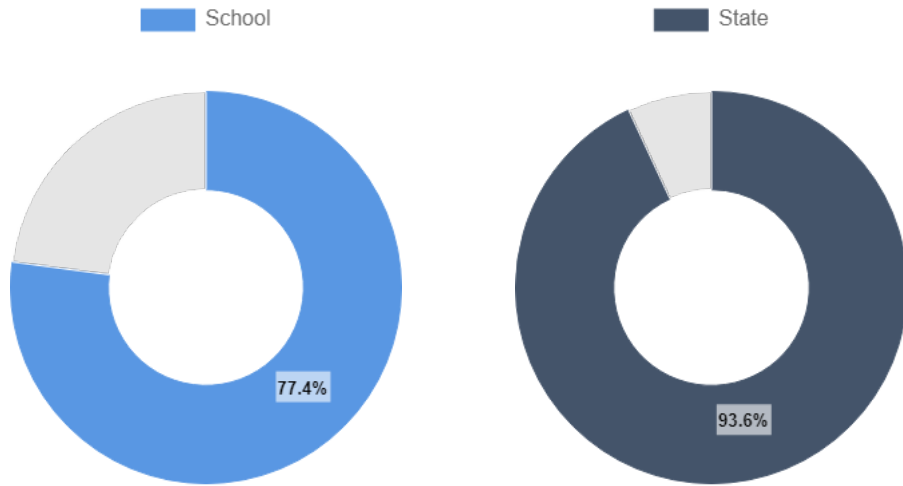

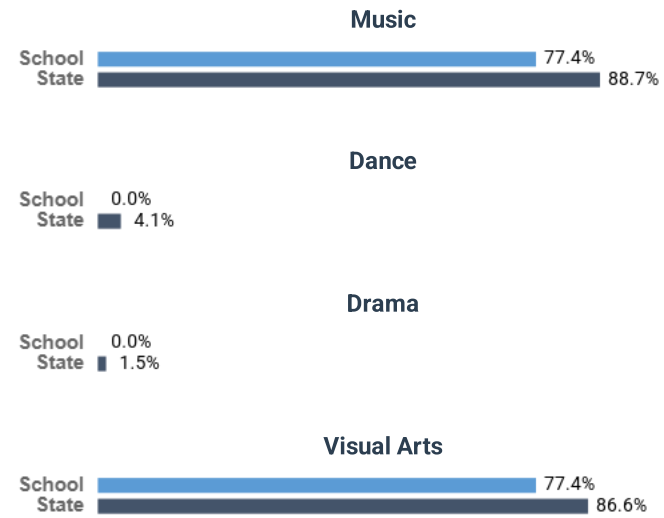

**Students enrolled in one or more classes by discipline:**



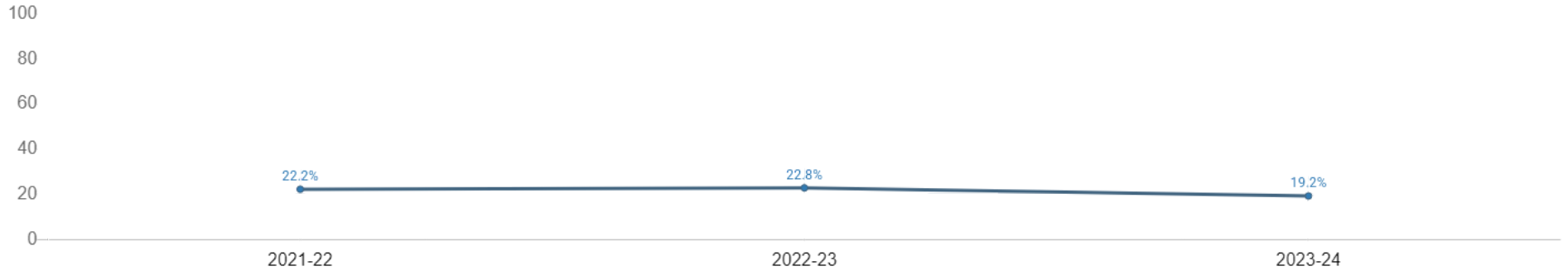

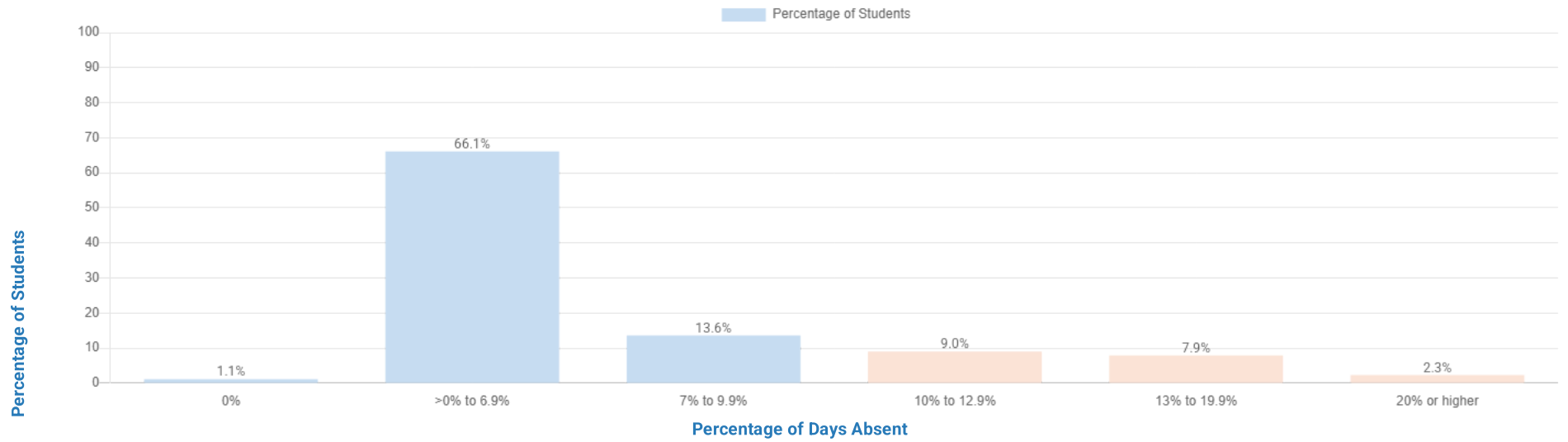

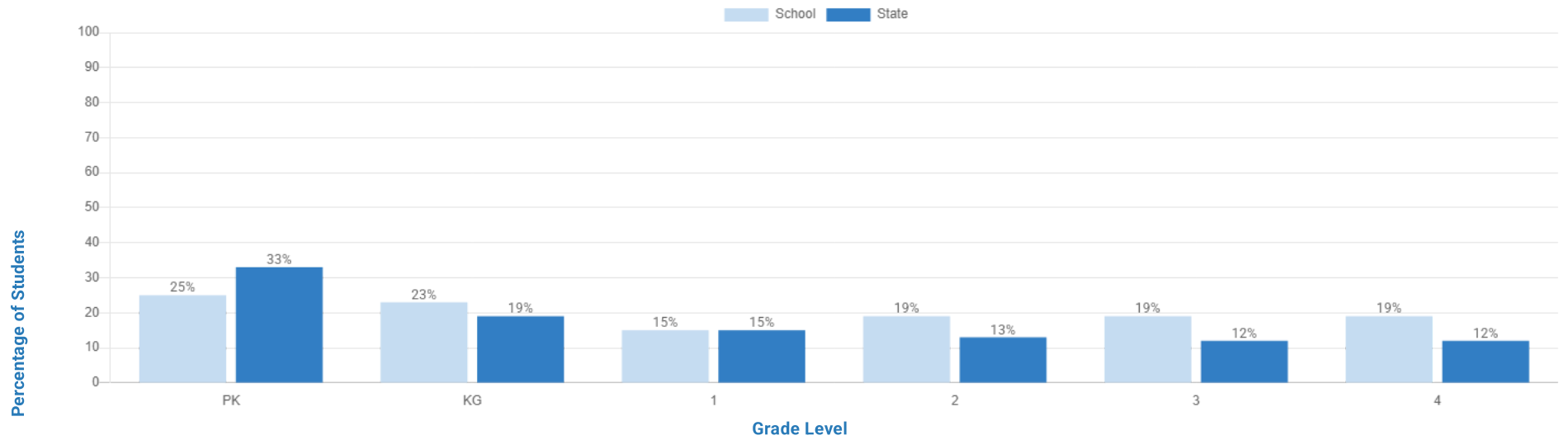

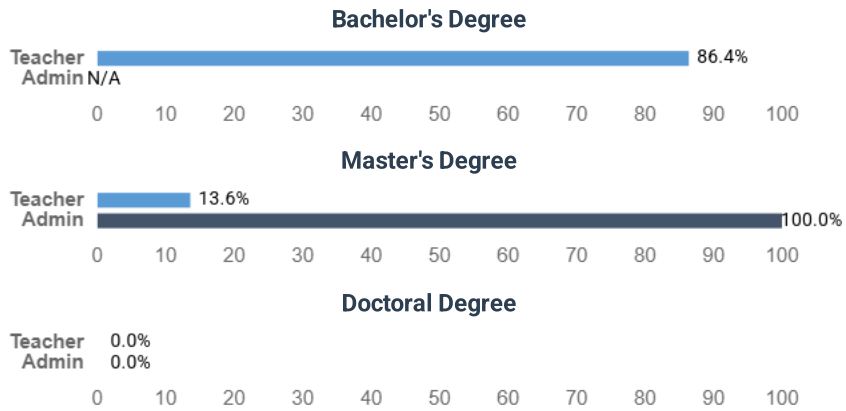

This could occur if the teacher cannot be found in the NJDOE's certification system, if their job code does not match their certification, or if the teacher has an expired certificate.

**Provisional Teacher:** A teacher with provisional certifications is a fully certified novice teacher of record who must meet further requirements of evaluation and mentoring during their induction into the profession before being granted "standard" or permanent certification.

### Teachers by Subject Area

This table shows the counts of teachers by subject area with gender breakdown, experience, and level of education. The staff counts in this table reflect staff assignments as submitted by districts to NJ SMART and reflect any teachers assigned and are not based on full-time equivalent (FTE). ### Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. ### Courses, Curriculum, Instruction:

K-4 students are immersed in a learning environment focused on small group instruction using Being a Reader & Writer, math workshop model, providing all students access to rigorous instruction and personalized learning opportunities with a growth mindset. Students are empowered readers and writers through a workshop model approach. Our school offers a S.P.A.R.K. program to provide opportunities for identified students to participate in varying units of study that incorporate humanities, independent investigation, and STEM. Students participate in Google Classroom, online programs that enrich the curriculum and utilize technology to create multi-media presentations and STEM projects. RTI Model Program for Grades K-3 is fully implemented providing interventions including Orton Gillingham, iRead, & Fountas and Pinnell LLI, SIPPs. Math intervention teacher meets with students to target and personalize instruction.



### Clubs and Activities:

Nathan Hale offers a variety of clubs and activities including Student Council, Choir, Instrumental Band, Title I, Title III, a Cancer Walk-a-thon, and Flutophones for grade 3. We have a highly active PTO that hosts monthly activities that coincide with our Student of the Month and Kindness Award recognitions. We celebrate community-building events like Grandparents Day, Hispanic Heritage Celebration, Ladies' Tea Party, Gentlemen's Tee Party, and other events.



### Before and After School Programs:

Students in need of additional support in Language Arts and/or Mathematics in grades first through fourth participate in Title I After School programs. English Language Learners in need of additional support participate in after-school programs focused on English language development. Our district offers a fee-for-service, Before and After School Program for students in grades kindergarten through fifth grade. The program offered in our school provides homework assistance to students and focuses on developing positive interpersonal relationships.

### Staff and Professional Learning:

The results of state and local assessments are continuously analyzed by our faculty and school-level data teams to assist in guiding instructional improvement. Focused upon identified district goals and school needs, our faculty participates in mentor programs, and professional learning communities, shares research-based instructional practices at grade-level meetings, attend workshops and conferences, conducts and shares action research, and completes graduate-level courses.



### Student Supports and Services:

School resources include a Bilingual Spanish PreK to 4th grade program, Child Study Team, Intervention and Referral Services, a Reading Specialist, a Math Specialist, a school-based social worker, a behavioral consultant, and specific intervention programs in Response to Intervention. High-Intensity programs in English as a Second Language that support the needs of ELL students in mainstream classrooms. Students identified in need of support for Literacy and Mathematics receive Title I services during and after school.



### Student Health and Wellness:

Students participated in the Fresh Fruit and Vegetable Program to improve their dietary quality and their exposure to new items. A breakfast program is offered in the classroom during homeroom. Physical education, recess, teachers use GoNoodle and give breaks throughout the day. Gym teachers and the nurse educate students in 4th grade on body changes. Implementation of Social Emotional Learning Days based on themes that support mental health, building school community, and the development of positive behavior.

The PTO works collaboratively with school staff to enrich the learning of our students. Parents engage in Family Literacy Nights, Family Math Night, Book Fairs, guest author events, and Fall Festival. Our school uses Class Dojo, Realtime Parent Portal, School Twitter, Facebook, and Instagram accounts, and all calls in a variety of languages are sent out to keep parents informed. We also host Career Day and cultural events such as Hispanic Heritage and Asian Heritage celebrations in the evening to allow for community involvement.



### Climate Surveys:

Is a Climate Survey Used: Yes; Who is surveyed: Students, Parents, Administrators, Teachers. A school survey is completed once a year by parents, faculty, and students and then it is reviewed through the School Safety & Climate Committee to highlight positive comments and to review areas that need development. The results of the survey are shared with stakeholders through digital graphics. Results from the survey are used to develop goals to improve school climate and culture. The School Safety, Culture, and Climate team meet regularly to develop improvements for school culture. Results of our school survey are used to improve the culture and climate of the school.



### Facilities:

Our building is a well-maintained facility offering students a bright, inviting, and clean learning environment. Our building boasts new student bathrooms, new office floors, updated learning spaces, and painted classrooms. New air conditioning units, new boilers, a new storage shed, and new water heaters have been installed. A T.H.I.N.K. Tank room, which focuses on a creative design using STEM activities was recently added, enriching our curriculum. In addition, a new playground was installed for all students to utilize during outdoor recess with an outdoor learning space for outdoor learning. We also offer reading intervention rooms.

### School Safety:

Full time security personnel are on staff. All staff and students are required to wear school identification. New cameras and door buzzers have been purchased to enhance our security protocols. We have also purchased LobbyGuard, a 7 ID security system allowing us to monitor visitors to the building. Annual training is provided to staff on the topics of Safety and Security. Students and staff participate in monthly security/safety drills. An Anti-Bullying Specialist provides programs and resources to parents, students, faculty and staff. Student safety patrols assist with the monitoring of passing students.



### Technology and STEM:

Technology is embedded into all curricula and each teacher uses Google Classroom for interactive lessons. Grades one to five classrooms are equipped with an interactive white board and a cart with 30 chrome books for student use. Students are also scheduled into the T.H.I.N.K. Tank every week to complete STEM related activities and projects, which include Robotics, Coding, Circuits, Design and Structures.



### Early Childhood Education:

Preschool and kindergarten teachers utilize Tools of the Mind and some Kindergarten staff use the Being a Reader & Writer curriculum within a full-day program. Intense professional development combined with a comprehensive curriculum that helps young children to develop cognitive, social-emotional, self-regulation, and foundational academic skills. Within the programs teachers incorporate the use of technology using iPads. Teachers report on student progress on a trimester basis that includes all areas of development and content based learning in literacy and mathematics.

In compliance with NJ Statute 18A:38-25.1, our school addresses chronic absenteeism (grades 1-4) through weekly attendance monitoring and family outreach after 5+ unexcused absences. Communication includes September and pre-fall break letters, plus parent surveys on attendance barriers. We incentivize attendance through Battle of the Grades with monthly dress-down days and family gift card raffles. Our engaging environment features diverse events: Hispanic Heritage, Grandparent's Day, Veteran's Day, Walk to School Day, and student recognition (Kindness Awards, Student of the Month). Additional activities include our school play, Trunk or Treat, Holiday events, and seasonal grams. These evidence-based practices foster an environment where attendance is valued, supported by monitoring, family engagement, and positive reinforcement.
