





Graduation/Postsecondary

Information about students enrolling in colleges and universities after graduation is collected from the National Student Clearinghouse (NSC), which collects data from at least 97% of higher education institutions nationwide. New Jersey graduates are matched to postsecondary enrollment data by NSC each year. While most students who enroll in a postsecondary institution each year are able to be matched by NSC, there are some students each year who cannot be matched. Some reasons that students may not be matched are: 1. Postsecondary enrollment cannot be shared with the NJDOE if students request a FERPA block on their postsecondary enrollment records; 2. Students who attend a college or university outside of the United States are not included in NSC data; 3. Certain colleges or universities may not participate in sharing data with NSC or may fail to report data for a certain group of students; and 4. NSC may not be able to match a student's name or date of birth in NJ SMART to the information provided by the postsecondary institution(s) with a high level of confidence.

In 2023, NSC implemented an additional manual review process to reduce the number of students who do not match due to #4 above, which may result in NSC matching additional students to postsecondary records moving forward. As a result, the NJDOE is not including trend data from prior to 2022-2023 in the reports.

A variety of opportunities are provided throughout the school year via After-School Professional Development (PD) sessions, Professional Learning Communities, grade level meetings and building-based PD sessions. The offerings are aligned to both district, school and individual professional growth goals.



92% of students attend schools of higher education and 8% enter the military or join the workforce. To support post-secondary planning, School Counselors utilize the Naviance program in individual student meetings, classroom presentations and during parent night presentations to assist students in planning their future. A College and Career Fair is hosted with representatives from various colleges and trade schools, college representatives host small student information sessions in school and a Financial Aid Night presentation is offered. East Brunswick High School services Grades 10-12 and sits on 108.08 acres. This 360,422 square-foot facility was originally built in 1958 and has had several expansions since then. The athletic complex includes artificial- and natural-turf fields. Recognizing that this aging facility requires a great deal of expansion, improvements, and modifications, the Board of Education has authorized planning for a new high school, which is currently underway.



All district buildings have security protocols and personnel in place.



Students in East Brunswick Public Schools begin exploring STEM and Technology units of study across several curricula areas in kindergarten through grade 12. Our elementary students (K-6) receive STEM and Technology lessons from our specialty area teachers and media specialists, with additional instruction in our practical arts department courses in grades 7-12. Students begin taking specific STEM and Technology elective courses in grades 5 through 12 which include: Computers in the Classroom, Computational Thinking, Computer Keyboarding Applications, STEM (grade-level specific), Graphic Communication, Exploring Technology in Society, IT Support and Careers Workshop, Principles of Cybersecurity, Introduction to Computer Science, AP Computer Science, and AP Computer Science Principles.
