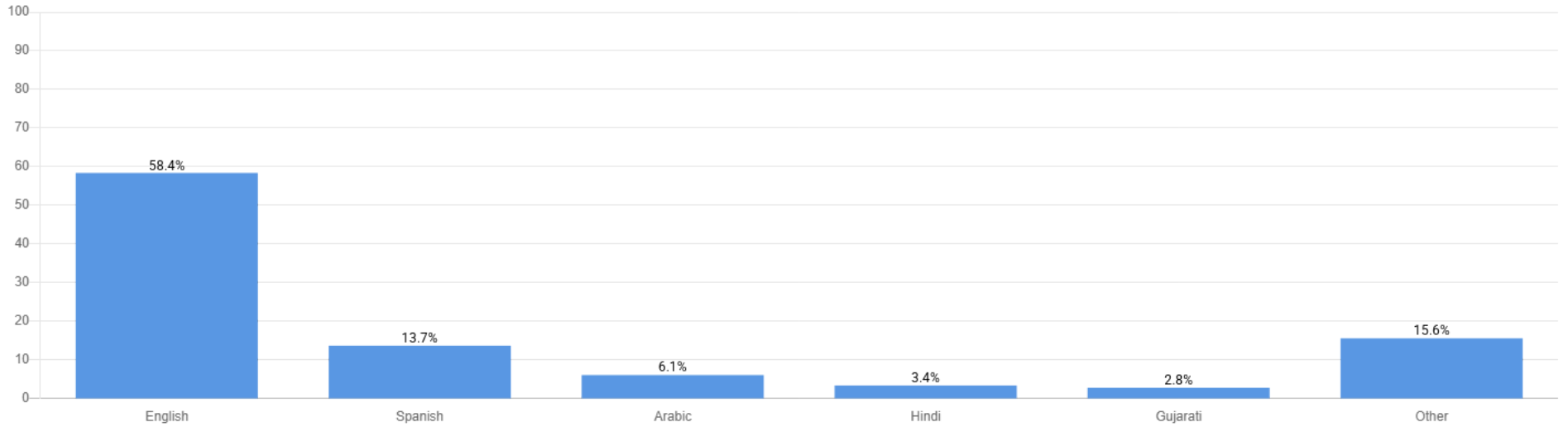

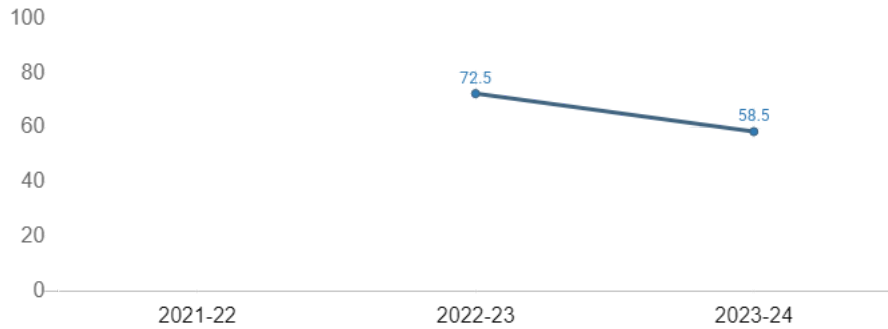

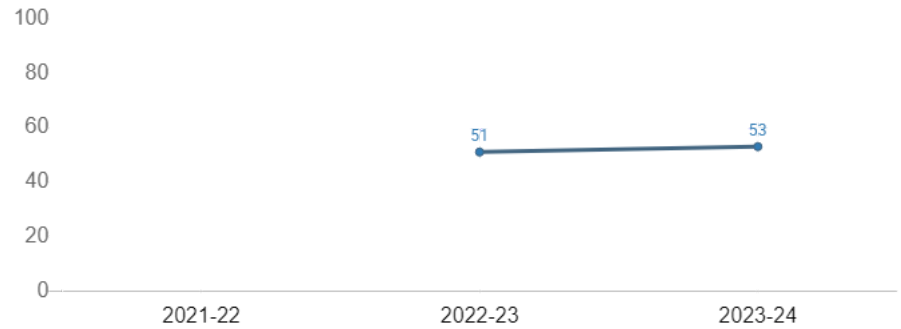

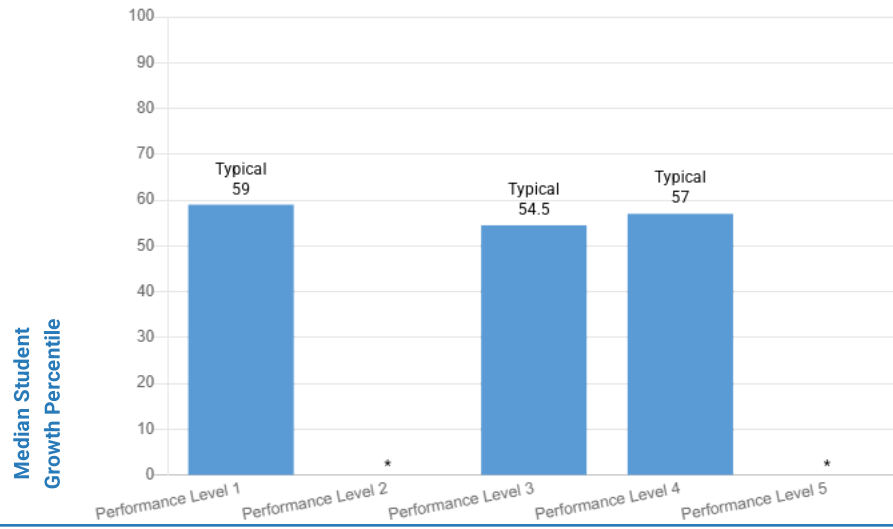

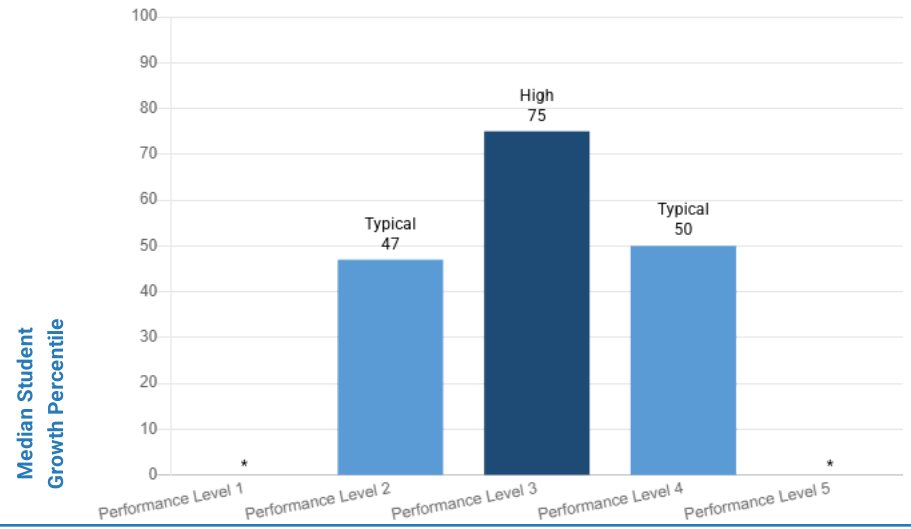

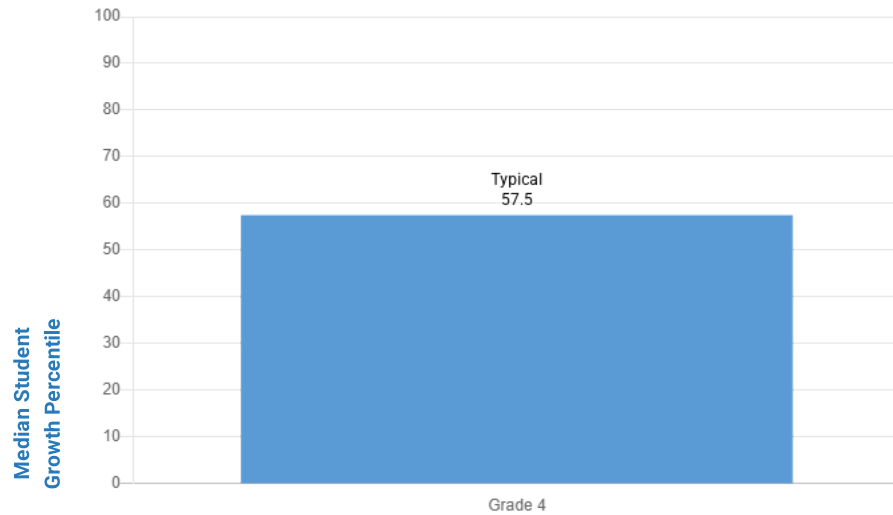

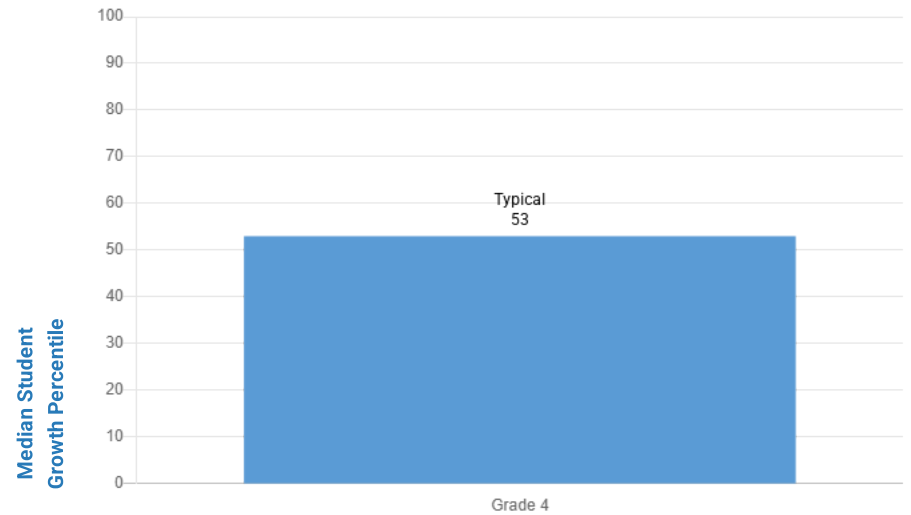

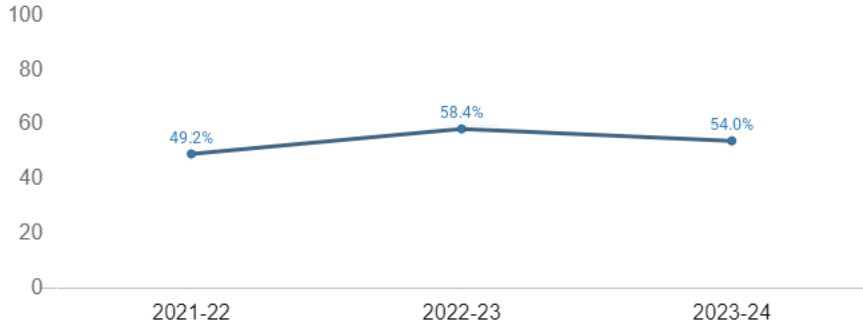

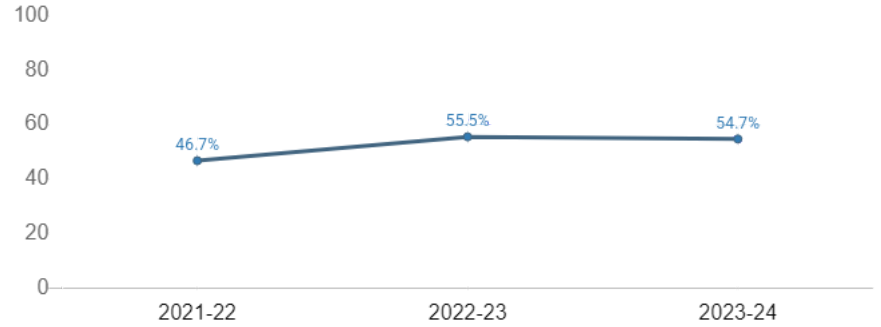
### English Language Arts and Mathematics Performance Trends

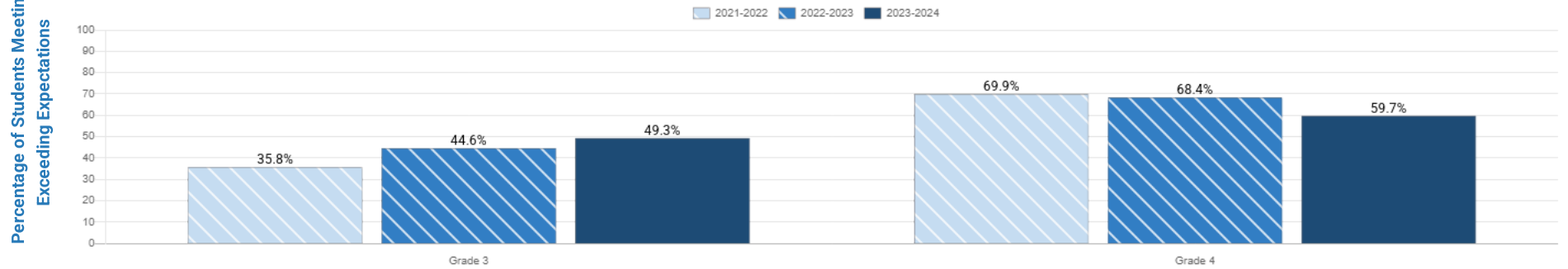

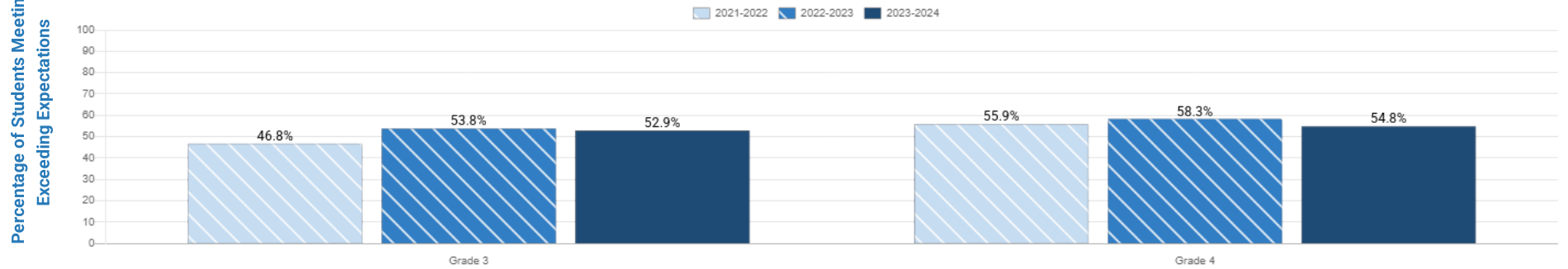

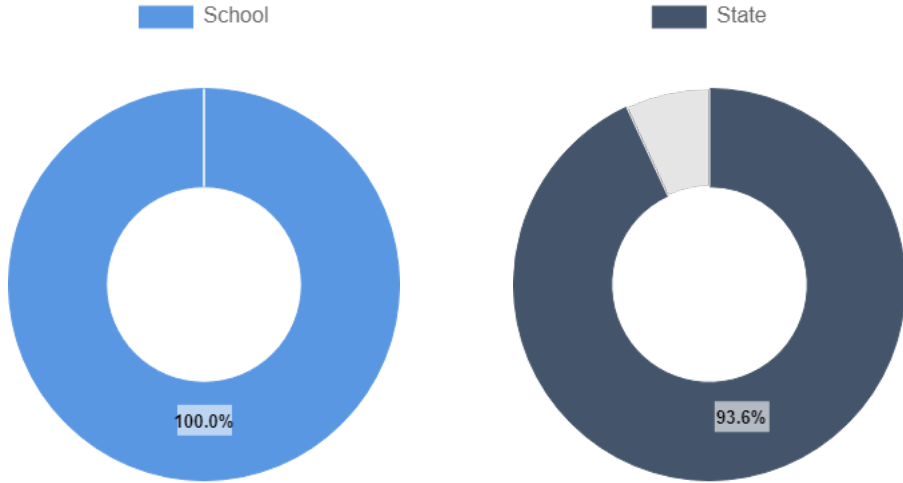

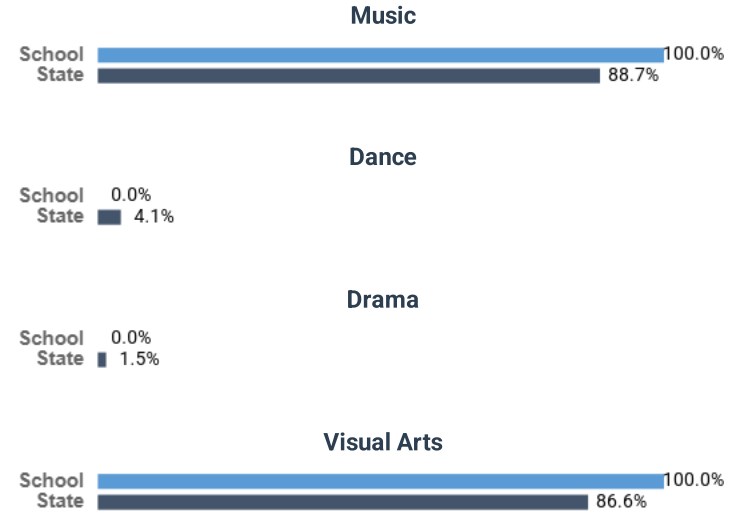

**Students enrolled in one or more classes by discipline:**



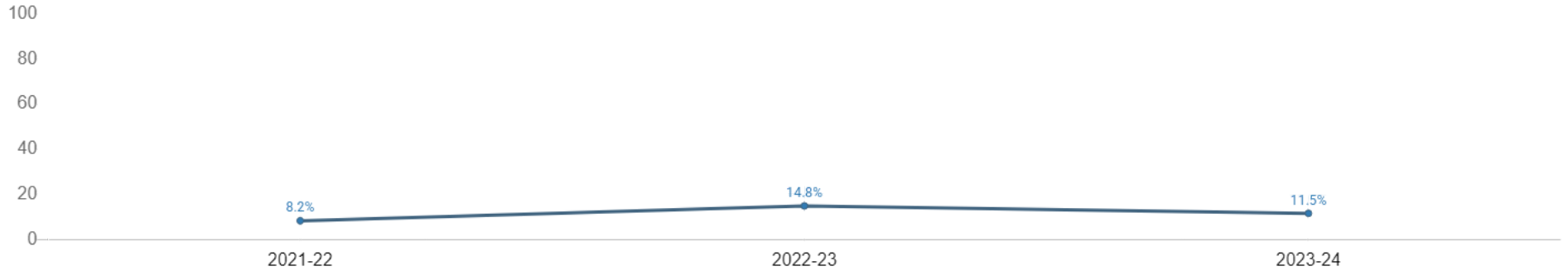

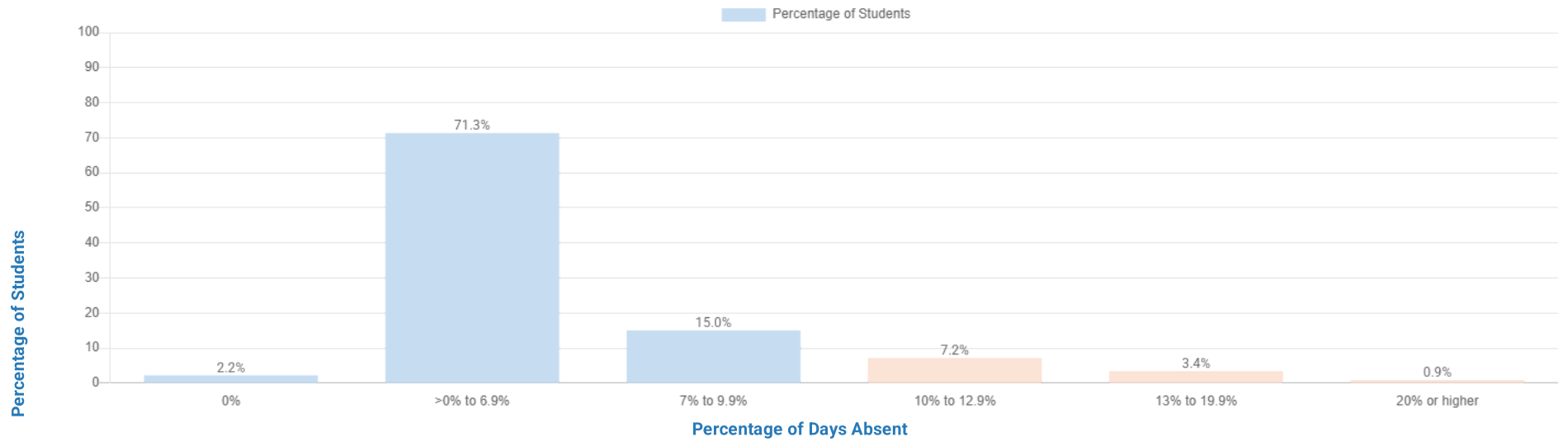

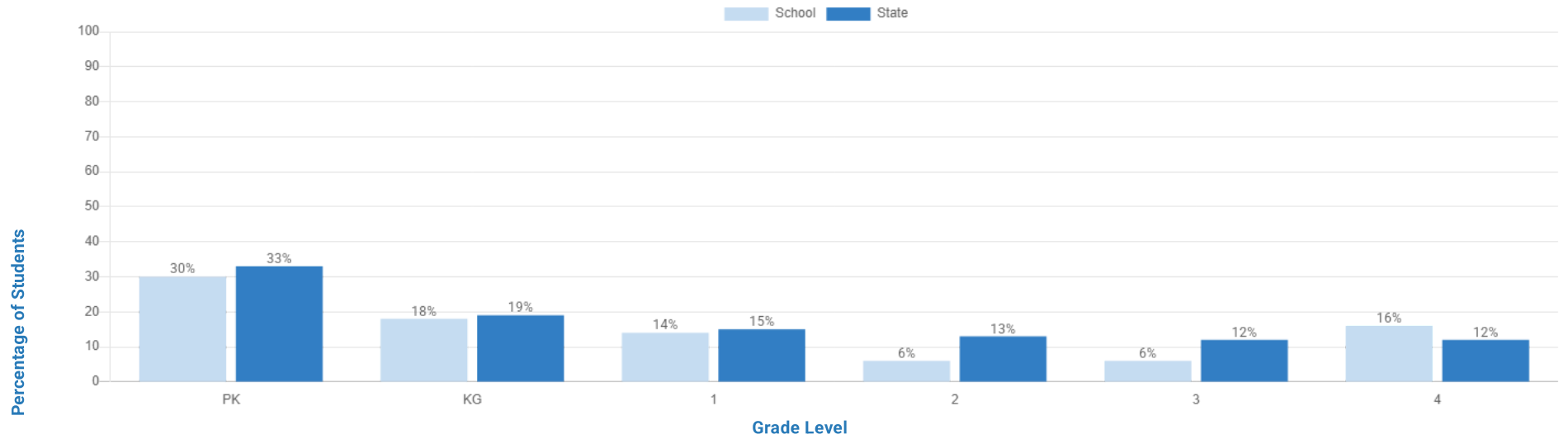

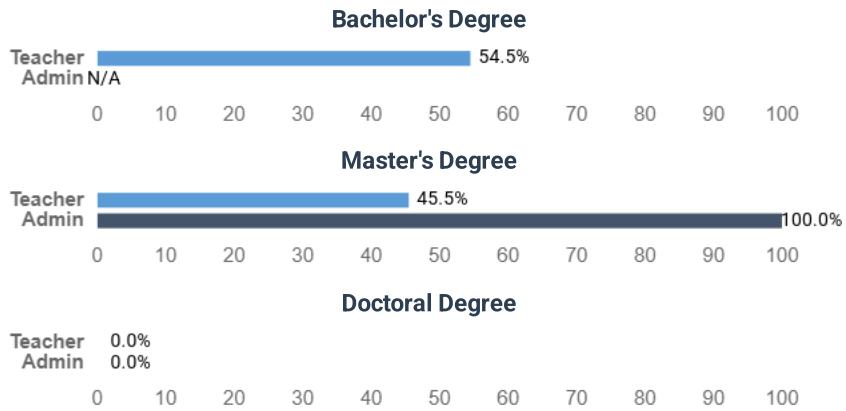

### Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. Schools are identified for ATSI if they have at least one student group that has a summative score that would be in the bottom 5% of Title I schools if it was its own school. An experienced and caring staff implements the instructional plans and daily routines inclusive of social/emotional development, curriculum (Language, Arts, Math, etc.), cognitive, and physical development.
