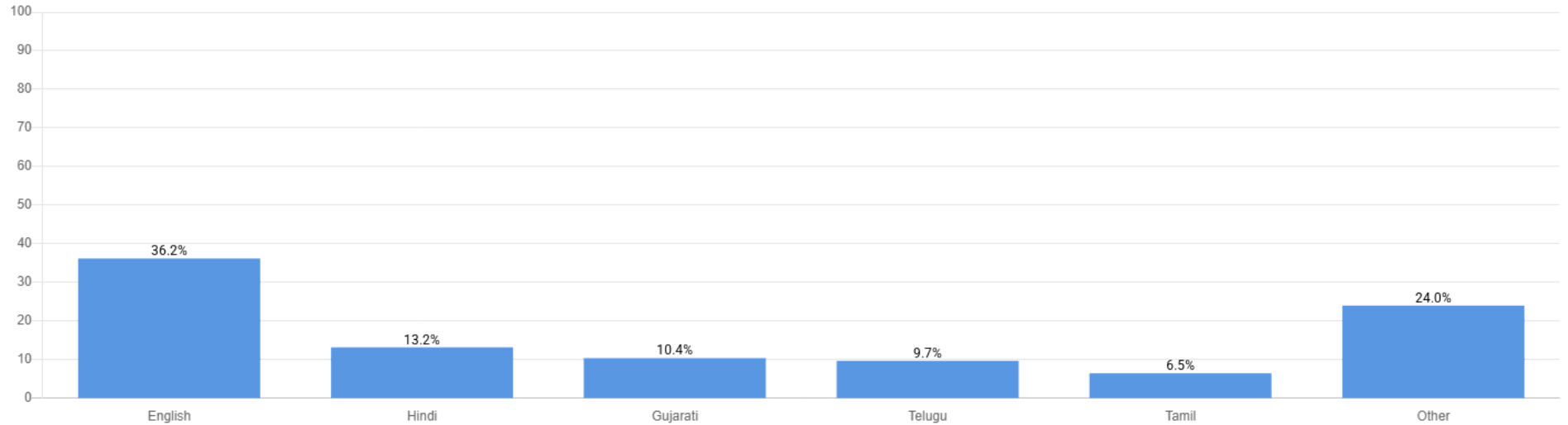

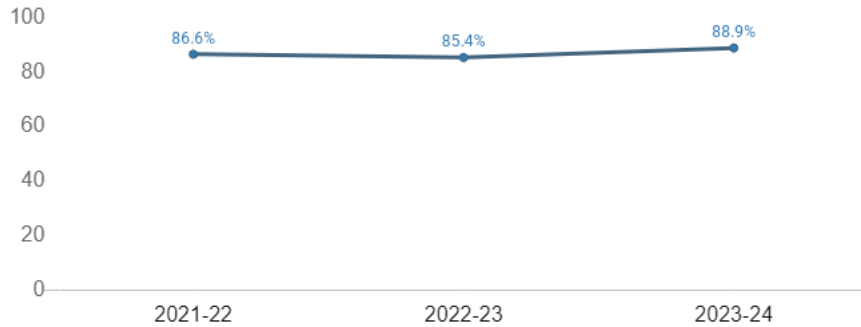

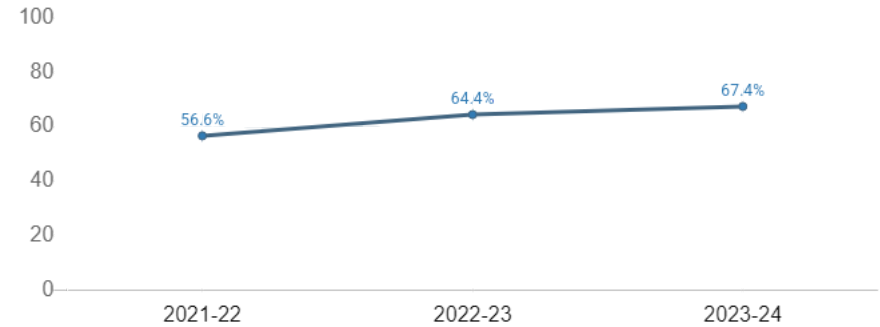
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. The data includes the results of students taking both the New Jersey Student Learning Assessment (NJSLA) and the DLM alternate assessment for English language arts (ELA) and mathematics. 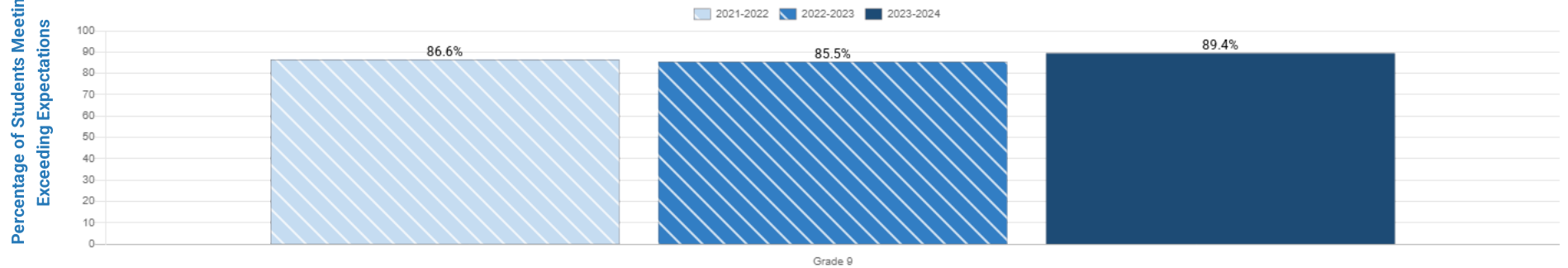

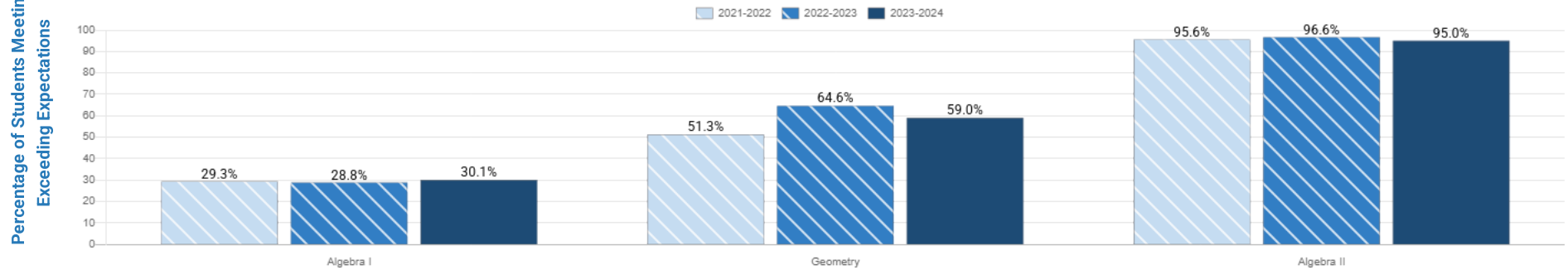

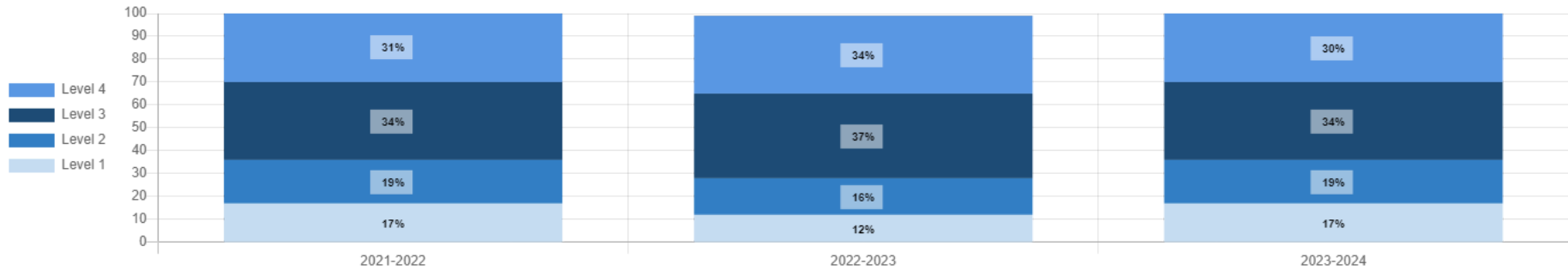

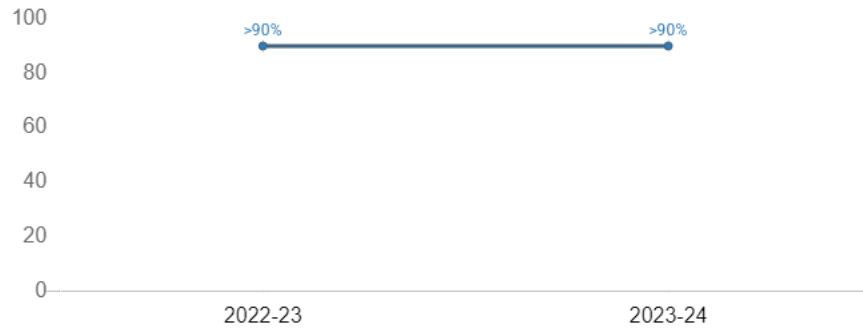

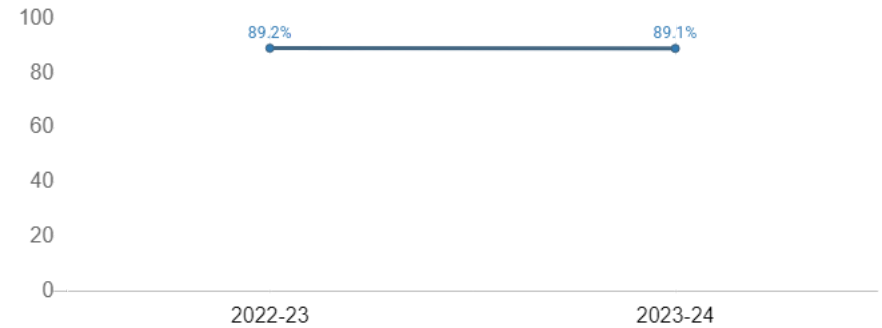

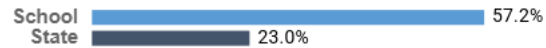

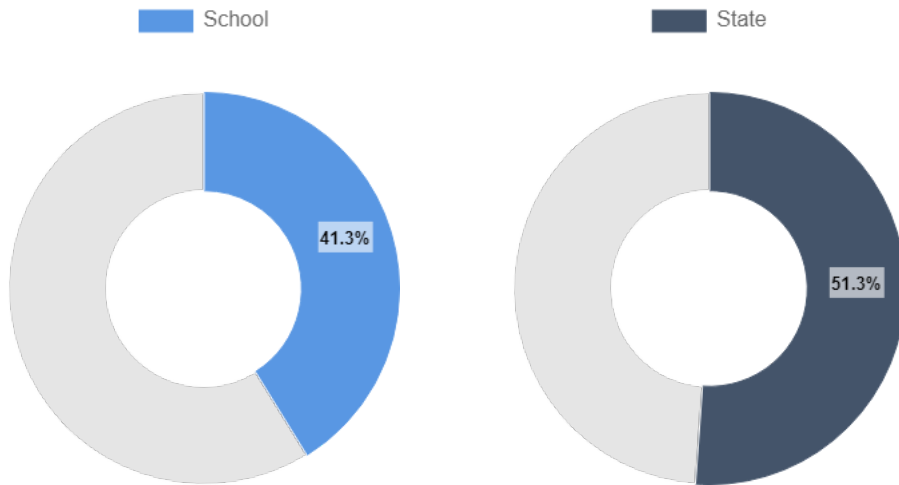

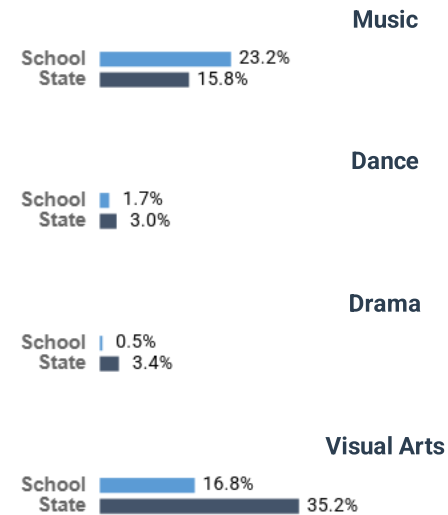

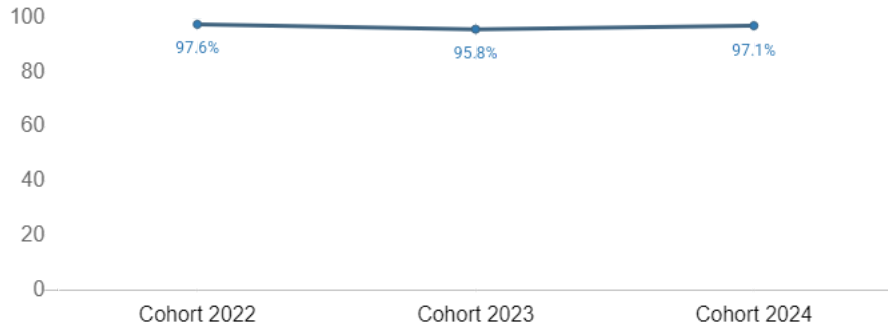

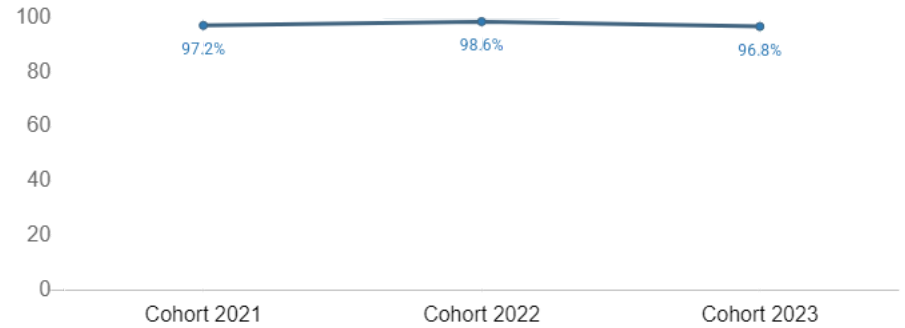

Graduation/ Postsecondary

New Jersey graduates are matched to postsecondary enrollment data by NSC each year. While most students who enroll in a postsecondary institution each year are able to be matched by NSC, there are some students each year who cannot be matched. Some reasons that students may not be matched are: 1. Postsecondary enrollment cannot be shared with the NJDOE if students request a FERPA block on their postsecondary enrollment records; 2. Students who attend a college or university outside of the United States are not included in NSC data; 3. Certain colleges or universities may not participate in sharing data with NSC or may fail to report data for a certain semester or a certain group of students; and 4. NSC may not be able to match a student's name or date of birth in NJ SMART to the information provided by the postsecondary institution(s) with a high level of confidence.

In 2023, NSC implemented an additional manual review process to reduce the number of students who do not match due to #4 above, which may result in NSC matching additional students to postsecondary records moving forward. As a result, the NJDOE is not including trend data from prior to 2022-2023 in the reports.

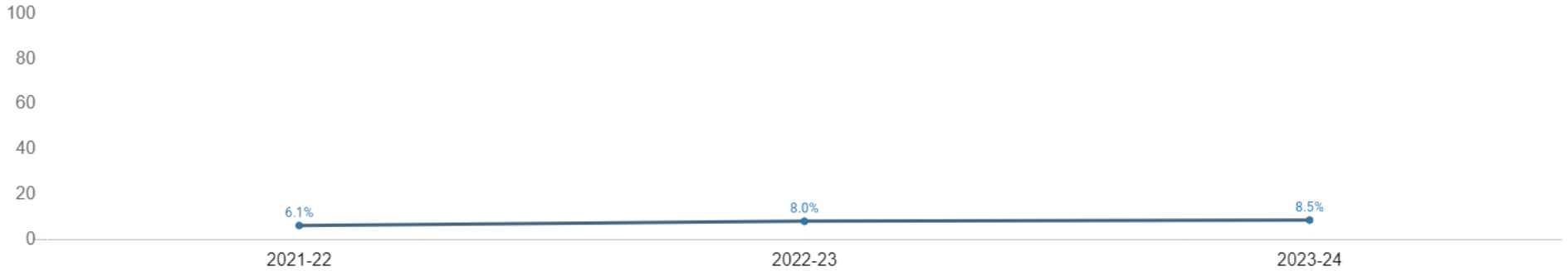

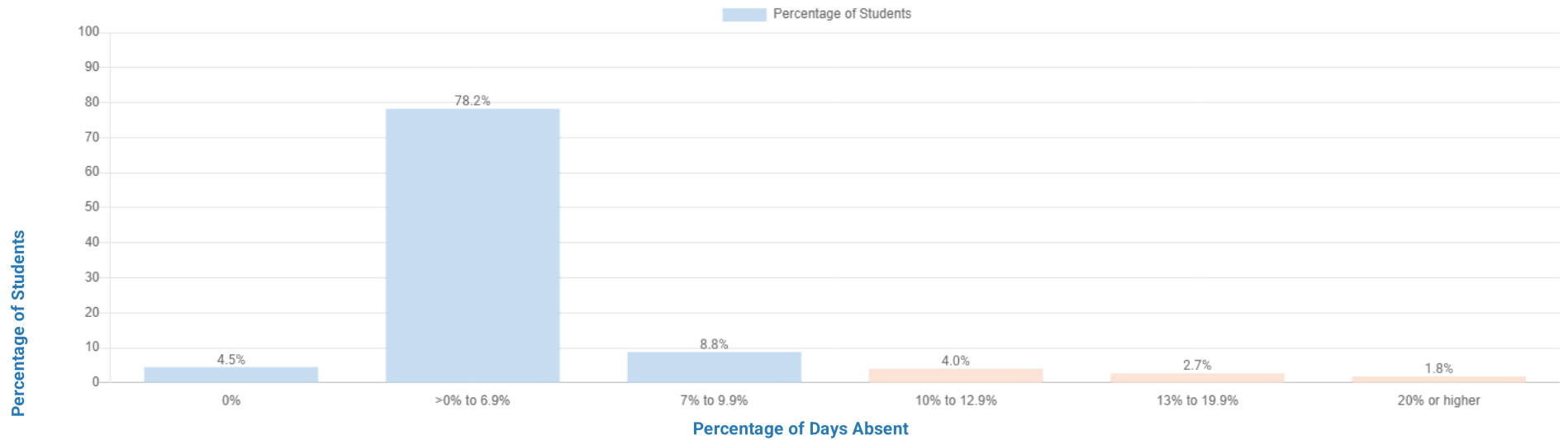

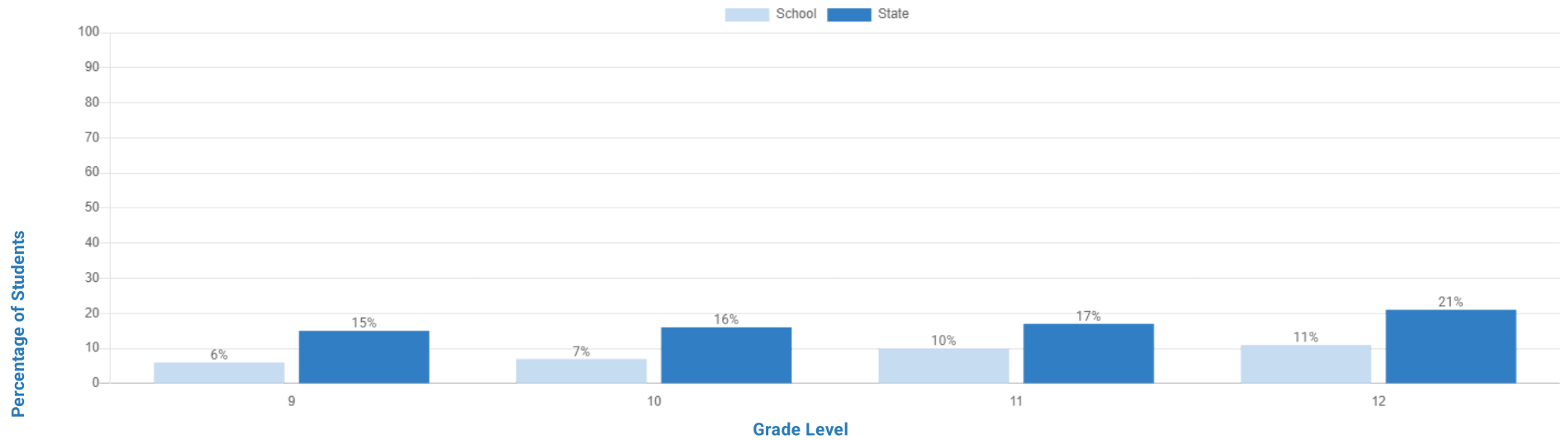

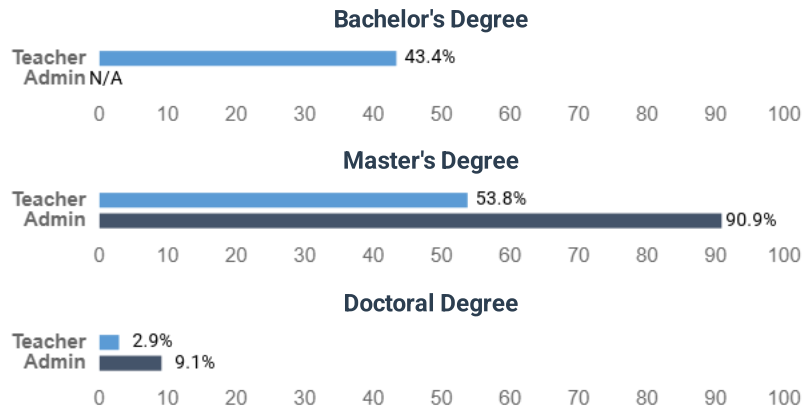

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. Our DECA, FCCLA, and Odyssey of the Mind clubs are perennial award winning clubs also with regional, national, and international recognition. Courses, Curriculum, Instruction:

JPS offers a total of twenty-five AP courses (pending enrollment). Last year, 1,212 students took 3,164 AP exams, and 81% earned a passing score of three or higher. Thirty-three percent of the students earned a top score of five. Our students continue to take advantage of the countless opportunities at the school including, 25 AP courses, 45 Honors courses, our one to one MacBook initiative, 2 dedicated college counselors, and a fully computerized college application/career awareness program. The Class of 2023 had an average SAT Math score of 672 and ERW score of 641. We also have strong elective programs such as Engineering, Anatomy & Physiology, Economics, Dance, Electronics, Computer Science, five different world languages and more.



Sports and Athletics:

JPS athletes compete in one of the most challenging conferences in the state. Our 25 Varsity Sports in the Greater Middlesex Conference build young women and men of character. Before and After School Programs:

JPS has a wealth of co-curricular and athletic programs available for students to be involved in after school. The school library is available for students to attend after school. Tutoring is offered to students after school. Late buses are offered three days per week to allow students a way home an hour and a half after school ends.



Staff and Professional Learning:

Teachers engage in professional development weekly through faculty meetings, department meetings, and in Professional Learning Communities. In addition, they attend local and district workshops focused on improving their craft. All teachers are provided professional development opportunities during in-service days offered 5 times per year.



Postsecondary Information:

JPS succeeds in sending 97% of its graduates to college, many being accepted to Ivy League Colleges and prestigious universities. Note that Covid-19 resulted in estimated data in this area. The Counseling Department hosts a virtual College Fair and offers many workshops on college applications and financial aid. The College and Career counselors run workshops on college essay writing, resume writing and interview skills for all eleventh graders. The JPS Transition program aims to support 9th graders throughout the year with Teacher Coaches, student mentors, and tutors. Counselors meet with students regularly, and Rutgers provides two mental health counselors. Struggling students are supported and monitored through I & RS. The Child Study Team ensures that the needs of all special education students are met. ELL students are supported by specialized staff and a parent-teacher panel. Honor Society members provide tutoring.



Student Health and Wellness:

Students are offered a nutritional breakfast every morning. Every student is required to take a Physical Education and Health class. Our counseling department offers targeted mental health seminars to our different grade levels. In addition, the school offers a Healthy Living Workshop to all students and provides a weekly Healthy Living tip through the JPS Weekly. In conjunction with Rutgers University Behavioral Health Care, we provide our students a Mental Health Conference which hosts guest speakers and many resources. Mindfulness is promoted throughout the school community.



Parent and Community Involvement:

Parents are very involved in the JPS community. Almost every athletic team, musical group, and club has an active parent group. In addition, the PTSO holds informative workshops for parents and students while raising money to organize and offer all seniors Project Graduation, an all-night lock-in party after graduation. Parent Portal keeps parents informed of student progress, and the school website informs them of all the school community activities.

Facilities:

JPS opened in 1964. A newer wing includes four state-of-the-art science labs and five classrooms. The library has been renovated to be more student-centered. Six years ago, a fitness center filled with treadmills, exercise bikes, lifting equipment, and workout gear was added. A dance studio was added four years ago to create expanded opportunities for our students. JPS has a beautiful turf field and many other sports fields. In addition, JPS has a 60-foot greenhouse and a farm stand.



School Safety:

Each school in the Edison Township Public School System has video surveillance and security personnel under a district director and follows all local, state, and federal laws in regards to ensuring student safety. We have active student and staff Safety Teams to discuss and address school wide safety concerns. We also have an AED Response Team.



Technology and STEM:

Even though JPS is a comprehensive high school, Newsweek ranks it among the top 10% of STEM high schools in the nation. This is due to the strong STEM education we offer our students through our curricular and co-curricular programing. We have a 1:1 initiative in which we provide each of our students a MacBook.
