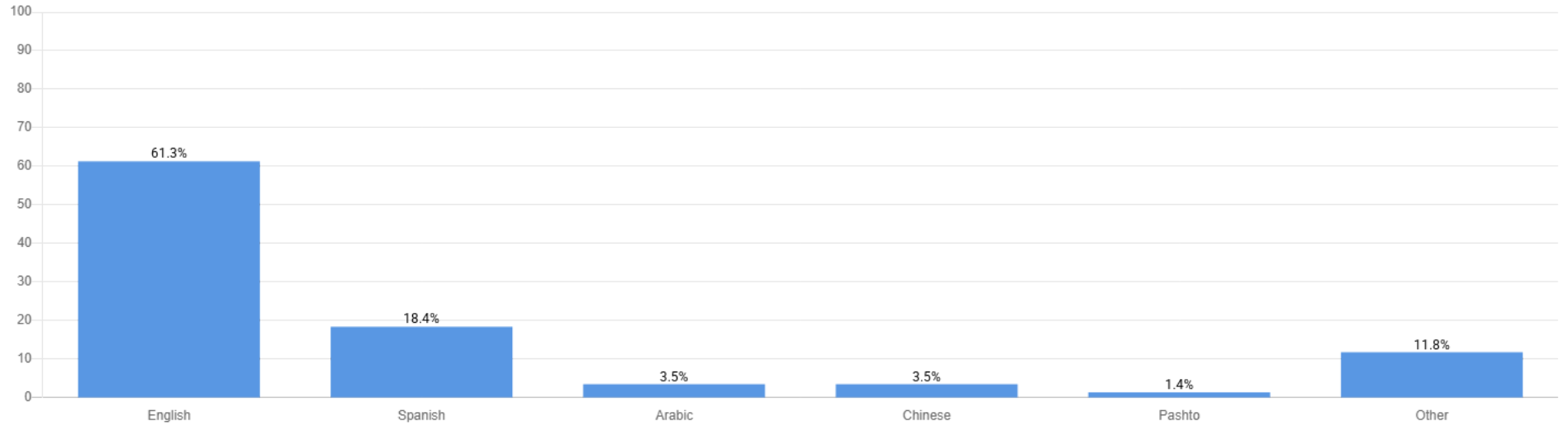

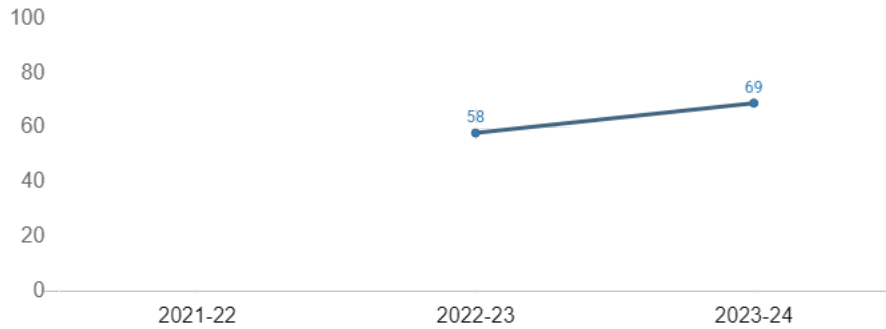

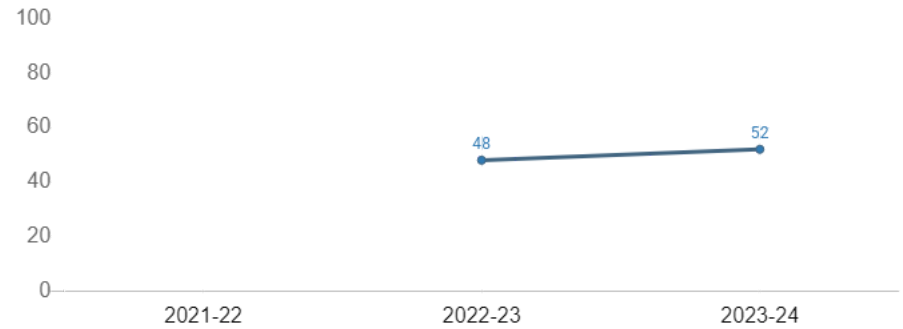

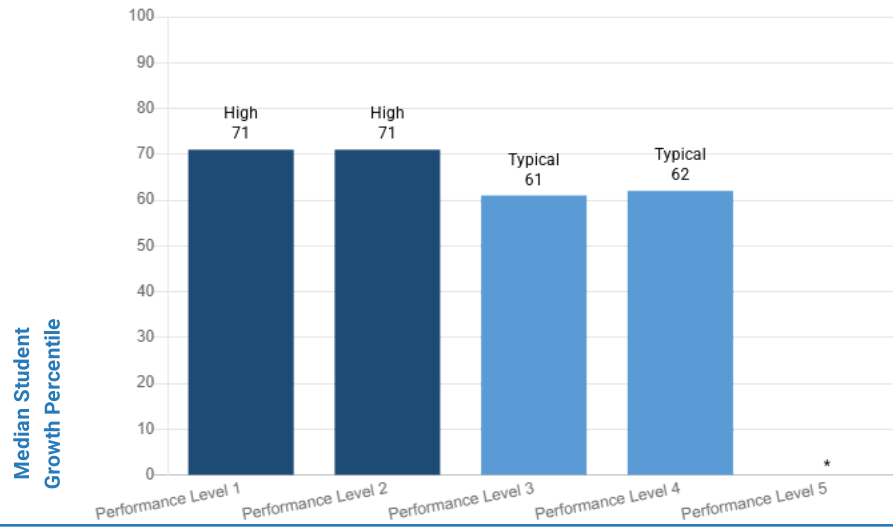

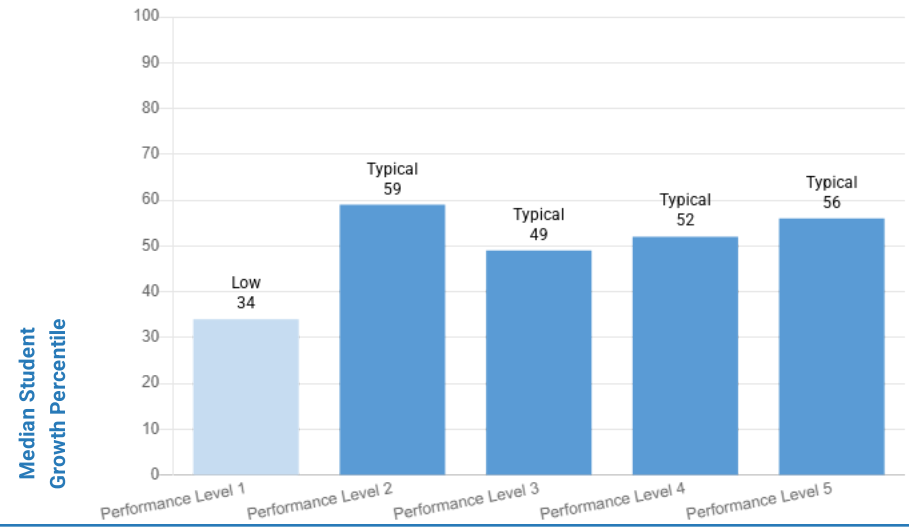

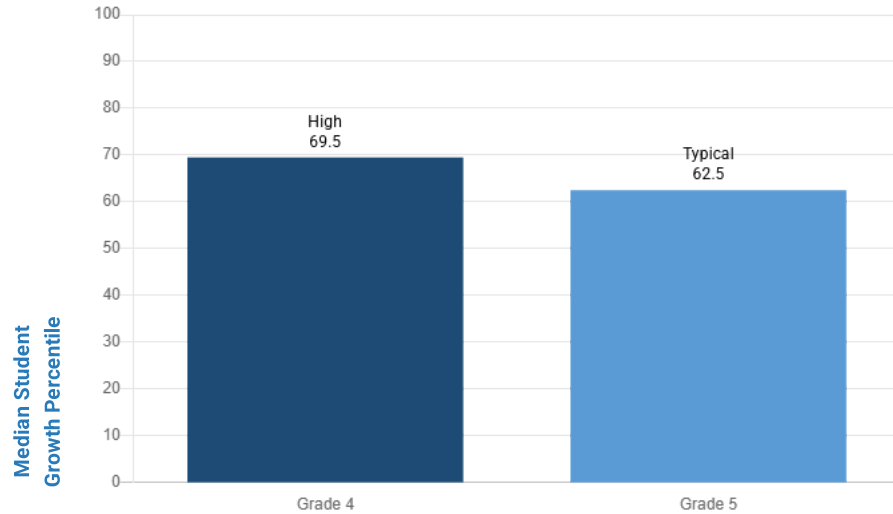

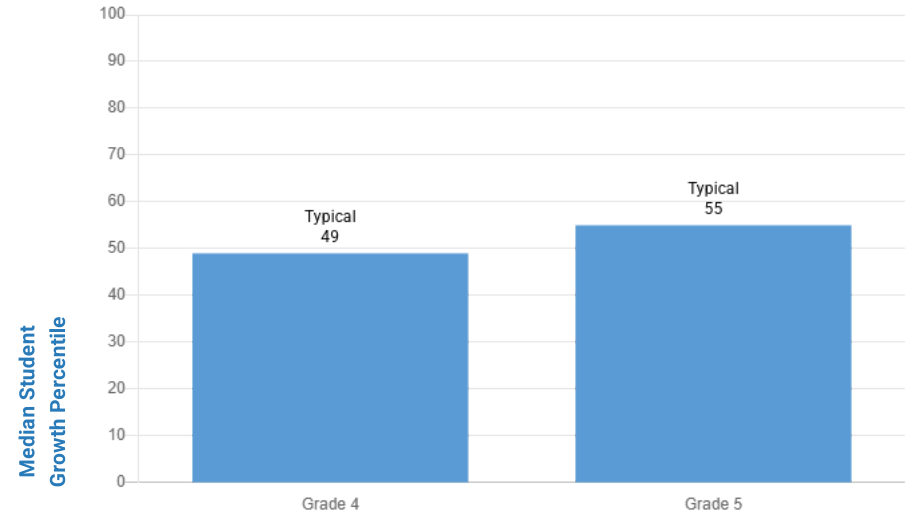

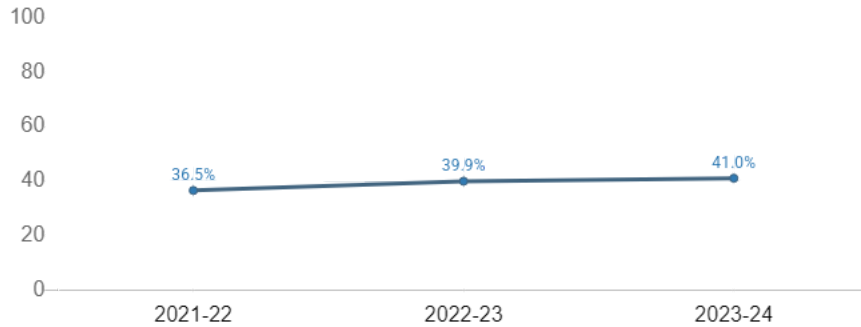

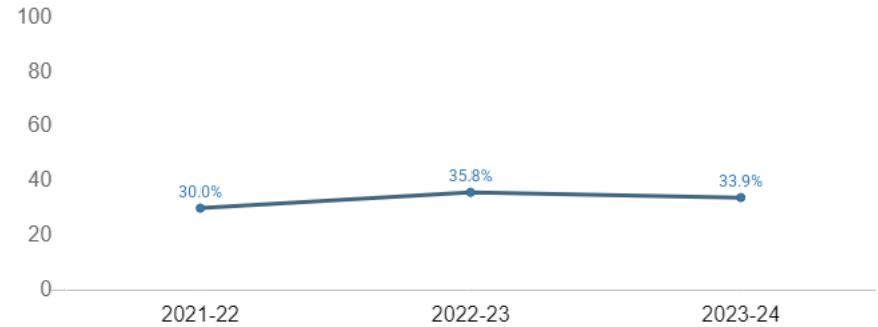
English Language Arts and Mathematics Performance Trends

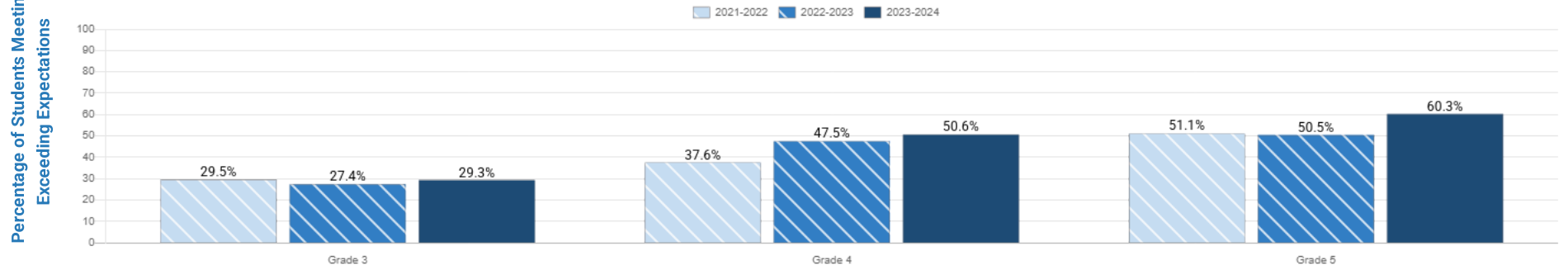

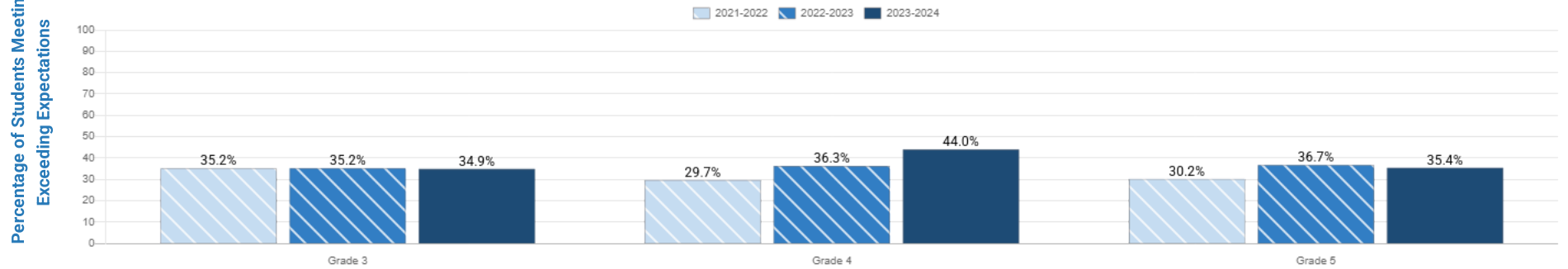

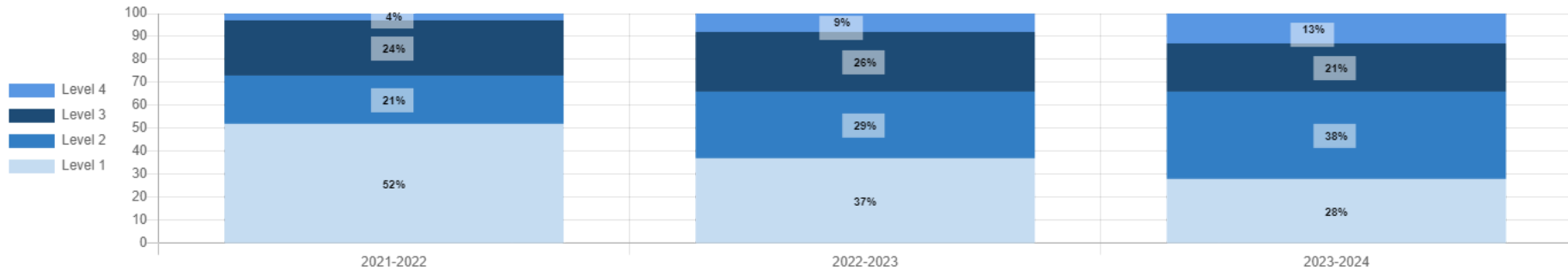

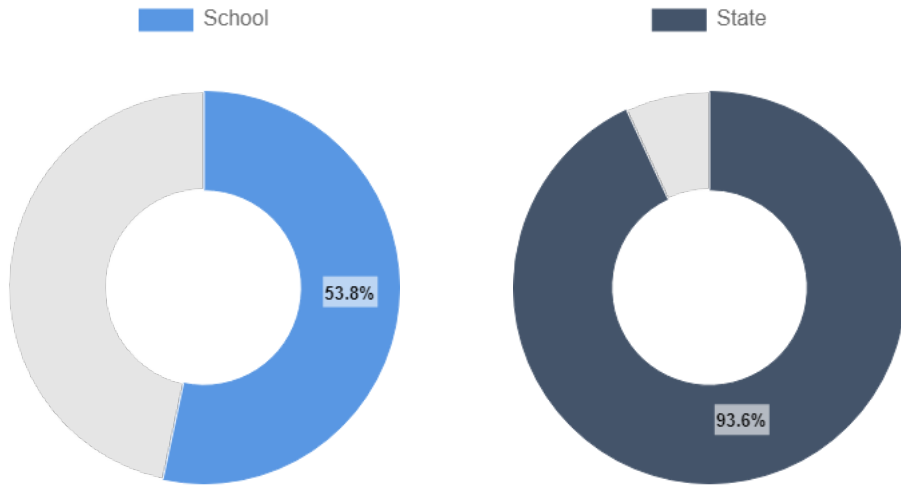

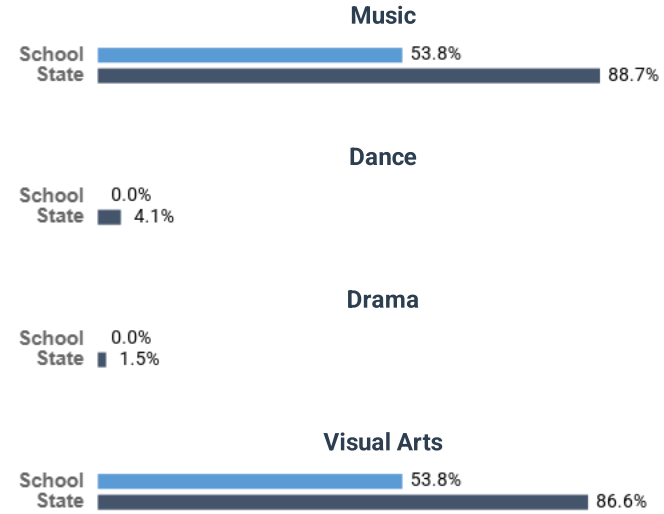

Students enrolled in one or more classes by discipline:



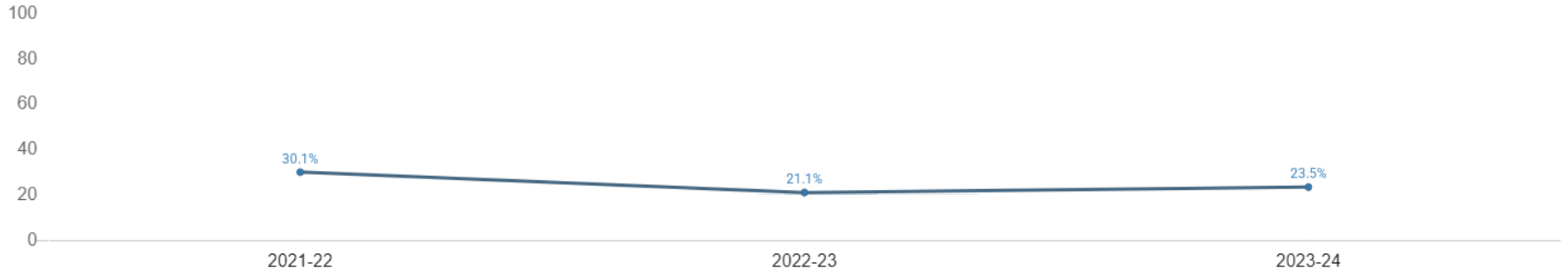

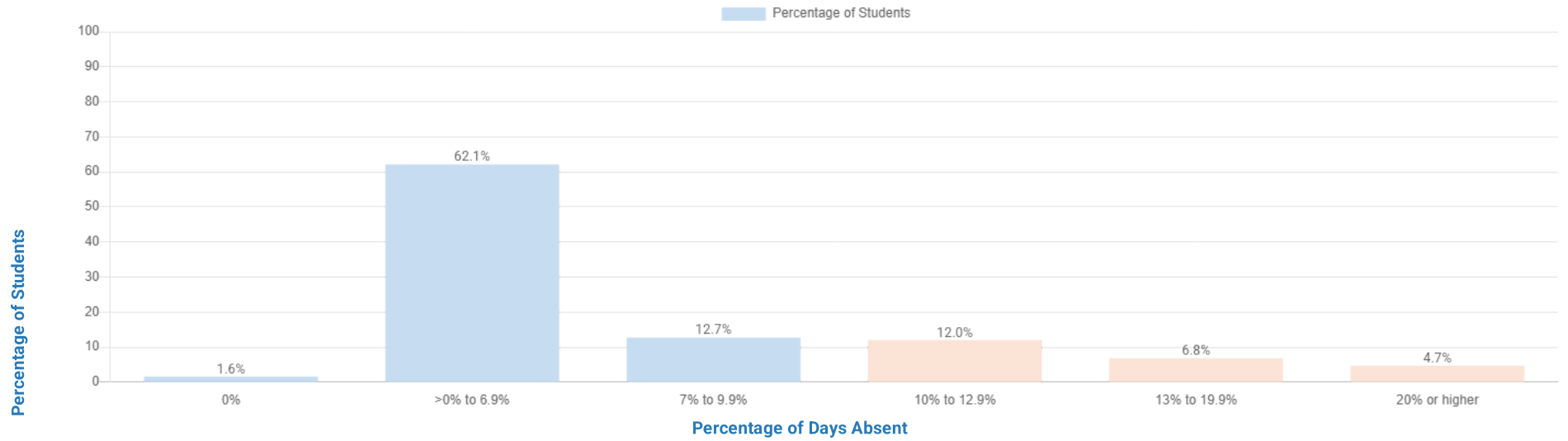

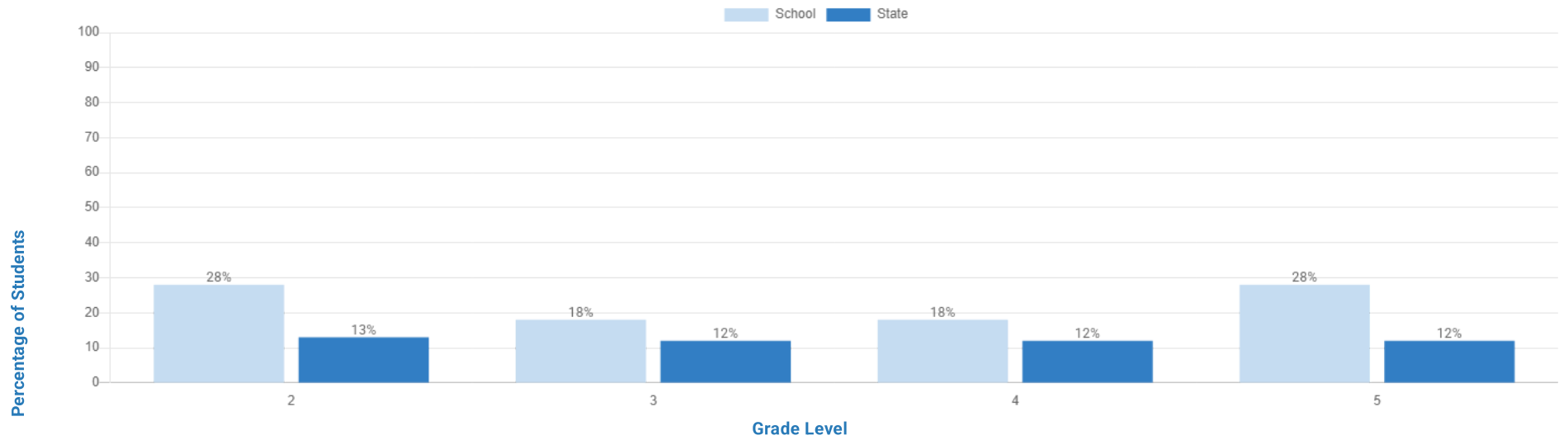

Staff

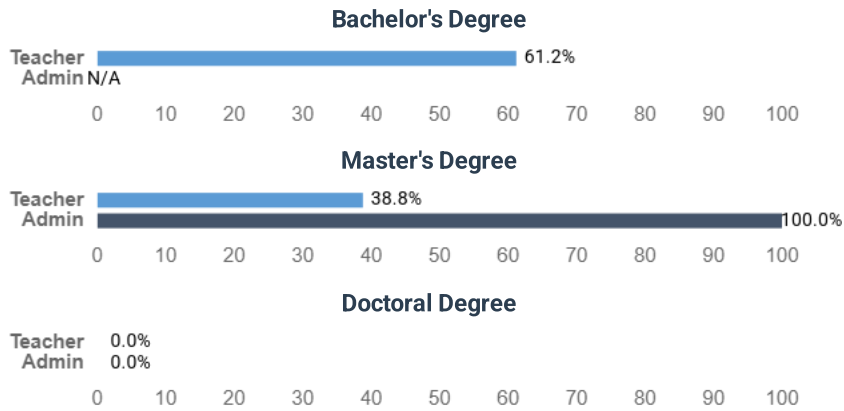

We have a school Lead Teacher that supports non-tenured teachers. PLCs meet 2 times a month focusing on school and district goals to improve student learning.



Student Supports and Services:

Students with Disabilities Programs: Paraprofessional Support, In-class Resource, Pull-out Resource, Self-Contained, Speech and Language Therapy, Occupational Therapy, Physical Therapy, Counseling Services, Behavioral Intervention Services, Wilson. We have an I&RS and 504 team to assist students who are experiencing learning, behavior or health difficulties. We utilize the Sheltered Instruction model with our MLL students. We have lunch bunch groups run by the school counselor. We implement Responsive Classroom and have a Social and Emotional Learning Lab. We also have a Tween Center that focusses on student mental health.



Student Health and Wellness:

We have a Breakfast After the Bell Program. We have a full time nurse and school counselor. Students receive 90 minutes of Physical Education weekly and have recess daily. Brain Breaks, mindfulness and movement are utilized in the classroom. We have Operation Snowflake and our Thanksgiving Food Drive to support families in need. Students receive health/SEL lessons twice a week.

Parent and Community Involvement:

Bartle values family and community involvement in supporting the education of our students. We have a PTO that plans events, raises money, and supports the school. Parents have access to the Gensis Parent Portal to access important information. Bartle has a Parent/Guardian Advisory Committee that meets regularly throughout the year to receive input from our families. Parent newsletters are sent monthly to keep families up to date on the child's education. We hosts family nights throughout the year to get parent/guardians involved. We have a BPAC and SEPAG. School Safety:

The district has a safety committee that meets regularly. Safety drills are implemented twice monthly to prepare students and staff in case of emergency. All staff has access to our district Crisis Plan. We have a crisis team that meets throughout the year to plan for emergency situations. Cameras were installed in multiple locations around the school.



Technology and STEM:

Bartle has a FUSE Lab that all 5th grade students participate in during the year. Our STEM teacher pushes in to every class once a week to teach STEM activities to students in grade 2-5. The media specialist implements a coding unit in the curriculum for all grade levels.
