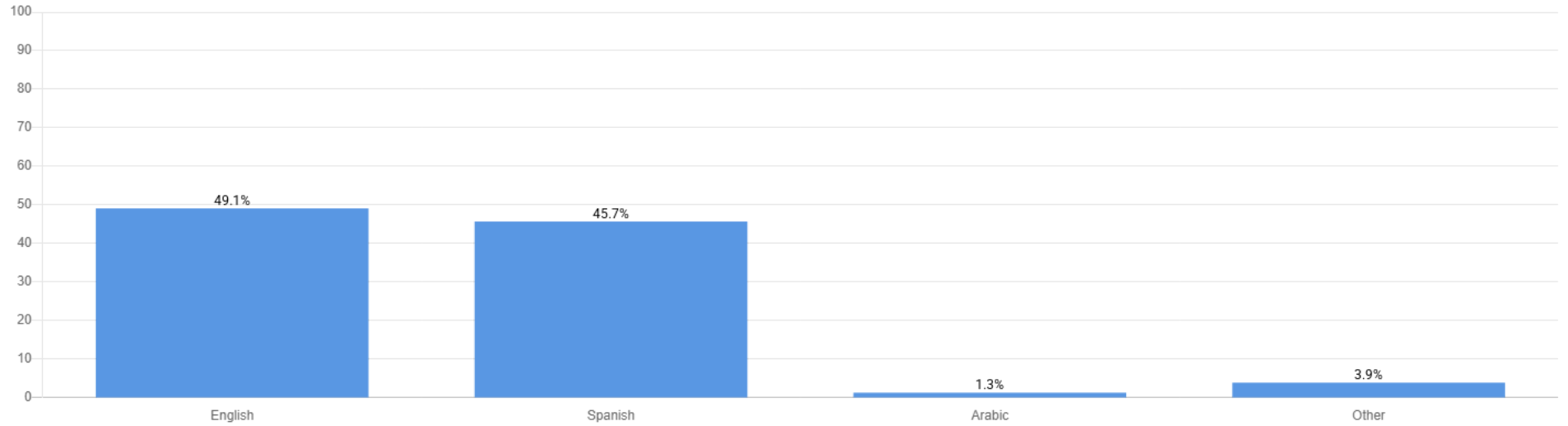

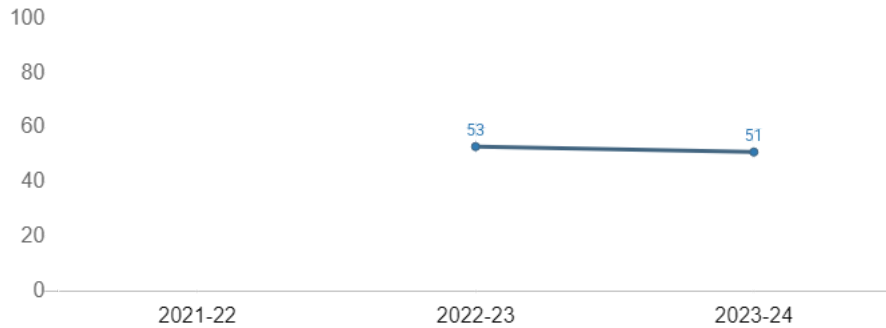

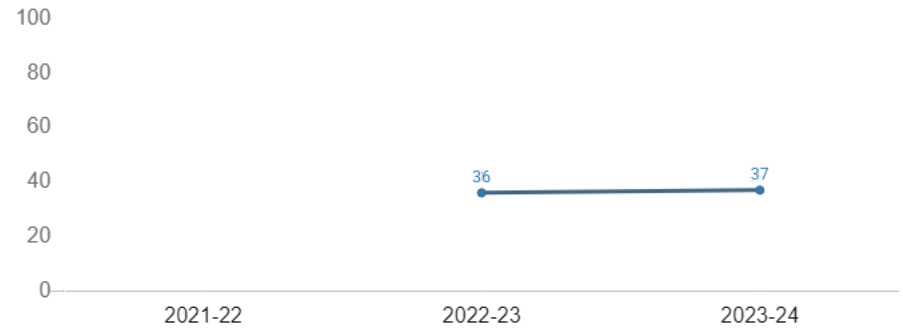

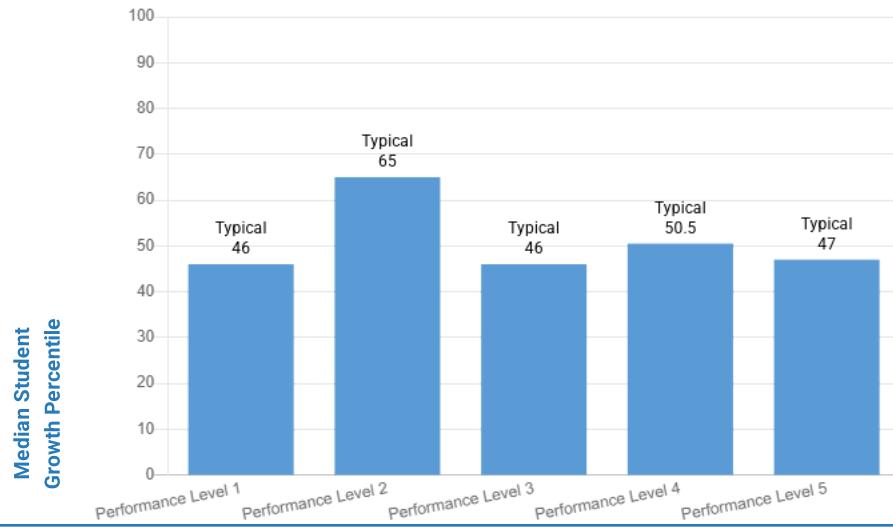

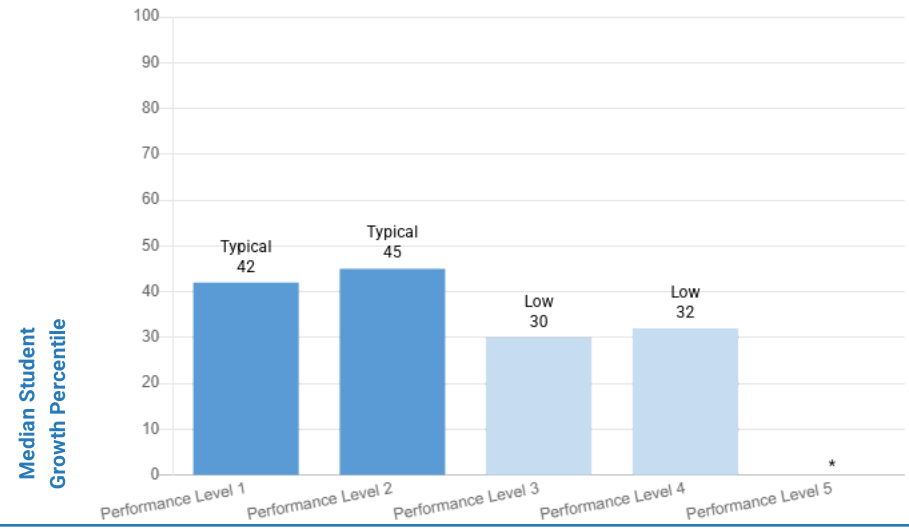

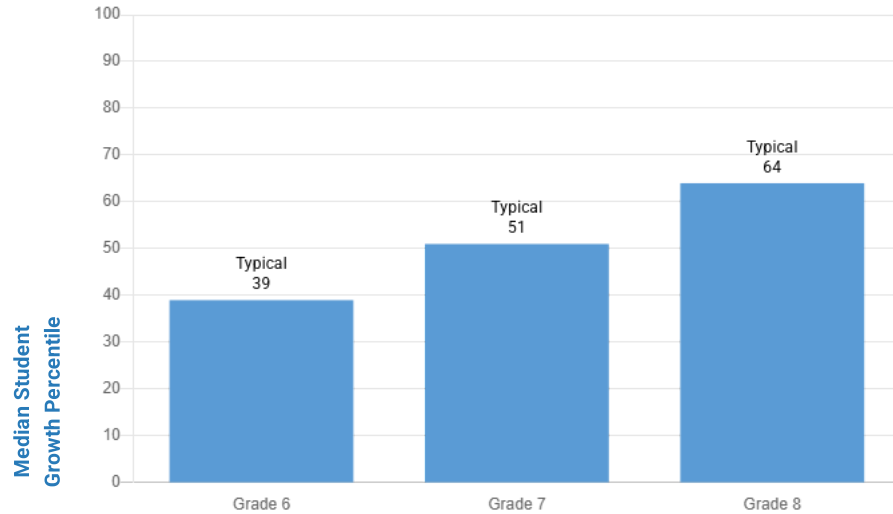

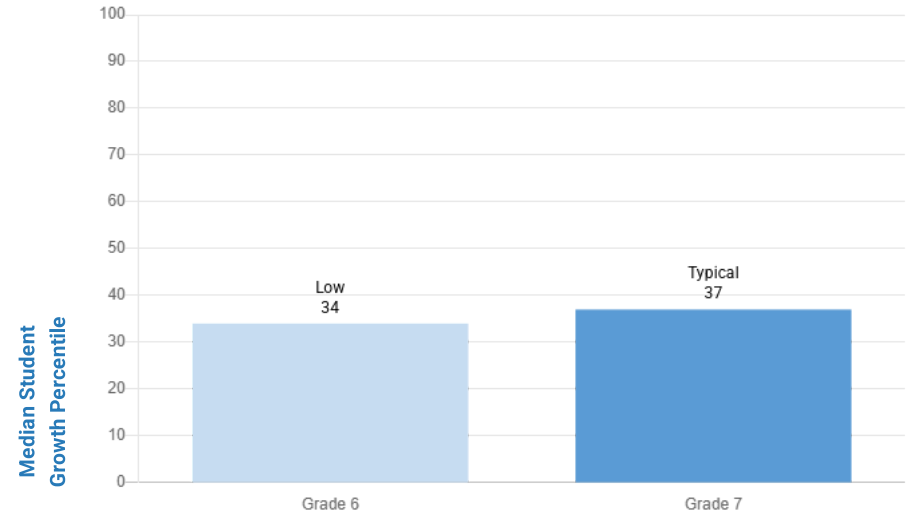

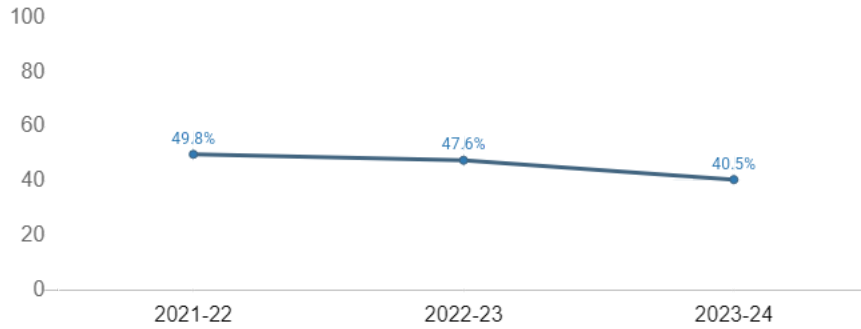

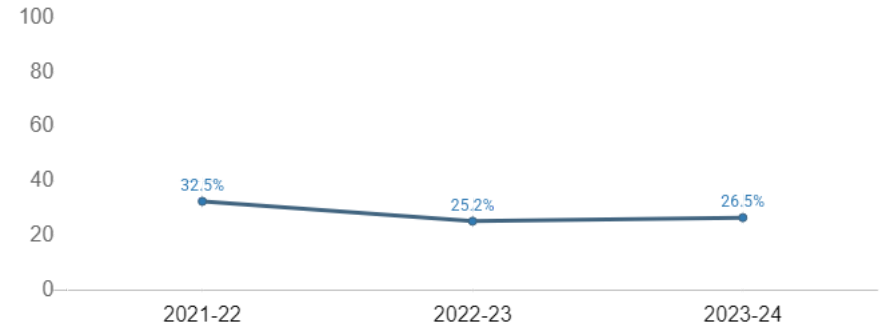
English Language Arts and Mathematics Performance Trends

English Language Arts Assessment - Participation and Performance

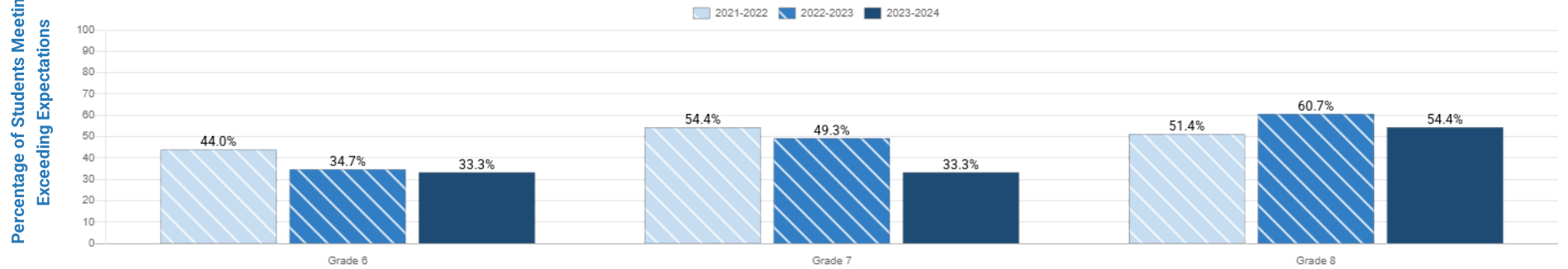

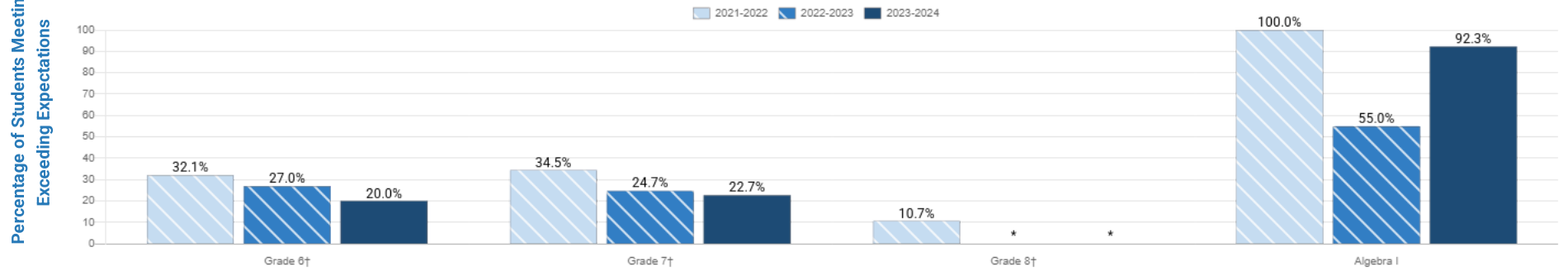

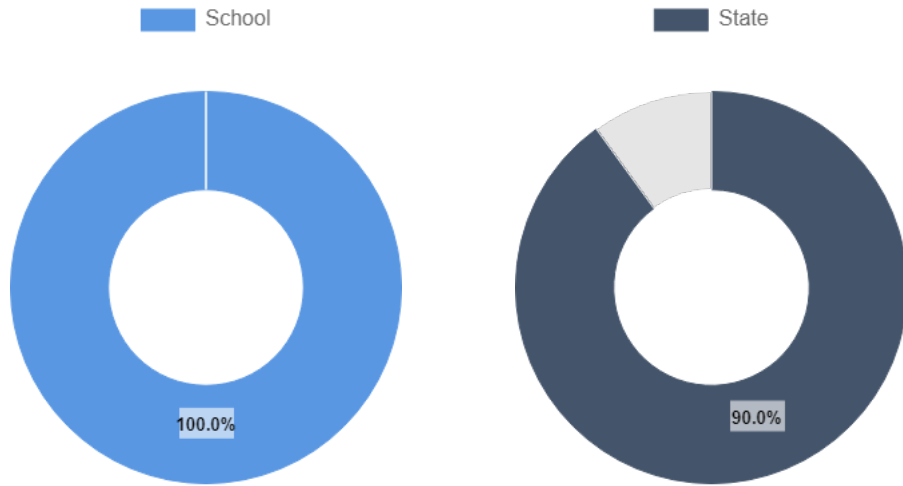

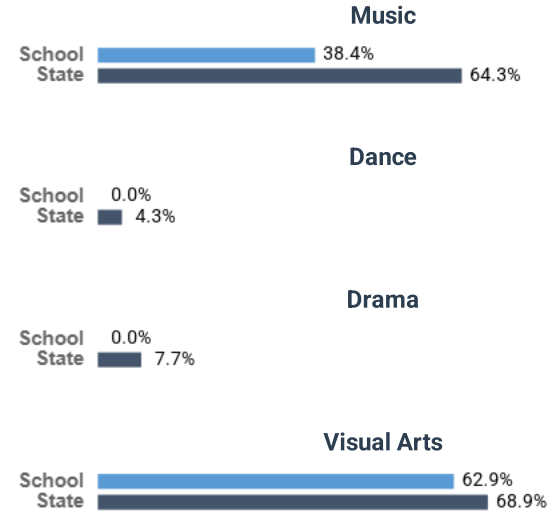

Students enrolled in one or more classes by discipline:



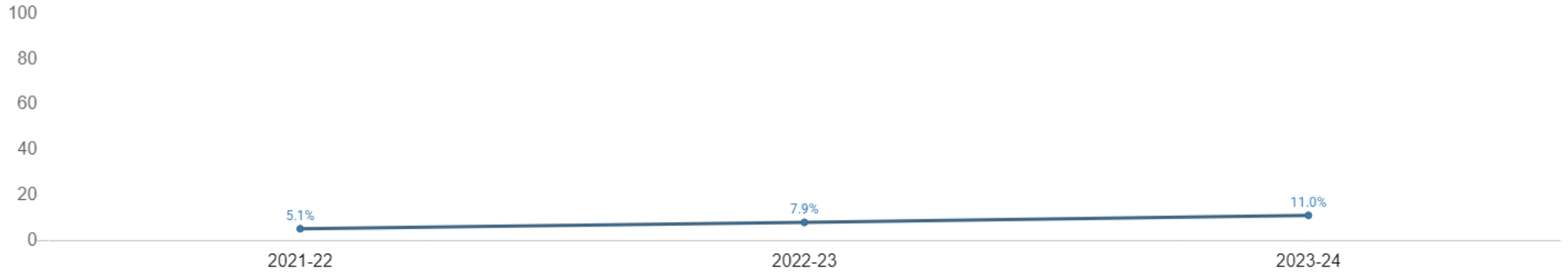

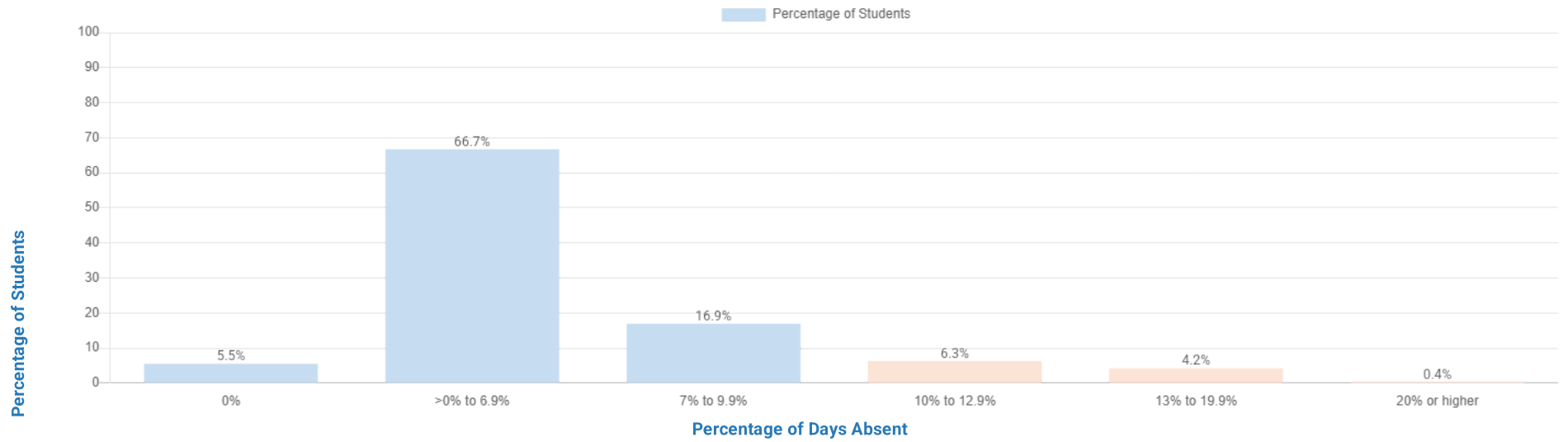

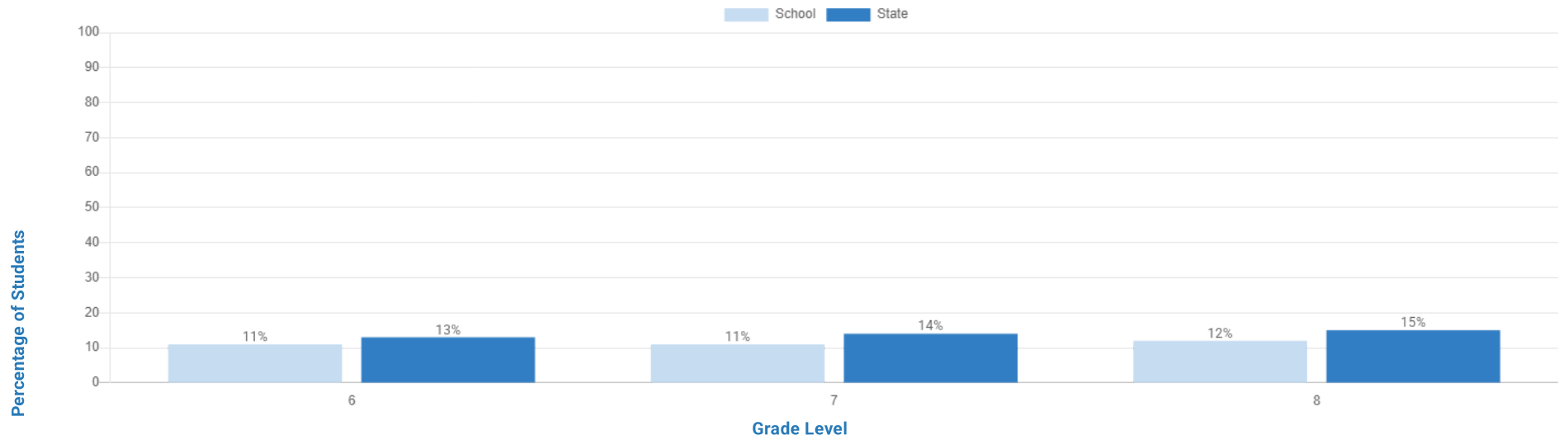

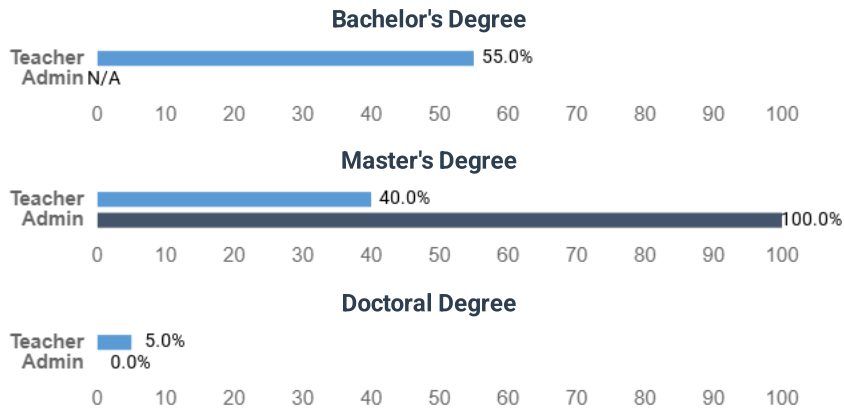

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. Schools are identified for ATSI if they have at least one student group that has a summative score that would be in the bottom 5% of Title I schools if it was its own school. Mission, Vision, Theme:

The mission of the Jamesburg Public Schools is to develop, through an active partnership with the community, more independent young citizens who achieve the New Jersey Student Learning Standards (NJSLS) at all grade levels, possess the knowledge, skills, self-esteem, and motivation to continue their individual educational growth, solve problems and respect the cultural differences that exist in our American Society.



Courses, Curriculum, Instruction:

At GMB School, students have daily double periods of Language Arts and Math. They also have Social Studies and Science daily with one double block per week. Within Visual and Performing Arts, students can choose between Art, Choir, Band, and Keyboard courses. All students take a Spanish Class, STEAM, Health, and Physical Education class. Additionally, students receive tiered support and accelerated learning opportunities through our GRACE (Gifted, Research, AVID (Advancement Through Individual Determination, Character Education, Extension/Enrichment) courses. Students at the middle school level can participate in AVID, which focuses on closing the opportunity gap by preparing students for college readiness and success in a global society.

Our staff members participate in monthly faculty and district meetings. They also work with their grade-level partners in Professional Learning Communities during common planning times. Extensive professional development is offered for specific programs and specialty areas directly from the program providers. Staff share-outs and peer observations are embraced and welcomed to support colleagues throughout the school year.



Student Supports and Services:

Student Services include special education teachers, guidance counselors, nurses, CSTs, and related service providers. The school nurse works with students and families to support the health of all students. Students receive hearing and vision screenings. Annual classroom upgrades included two rooms this year, receiving all new flooring and updated paint.

Staff members participate in professional development related to school safety matters, including, but not limited to, safety procedures, training in health and safety topics, and CPR and AED training, as appropriate.
