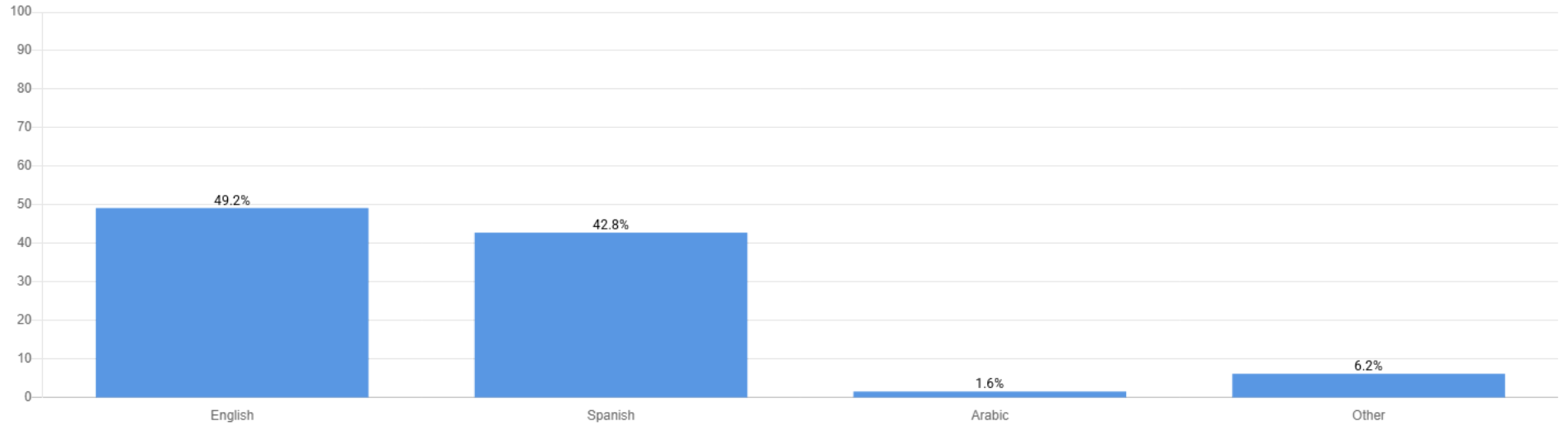

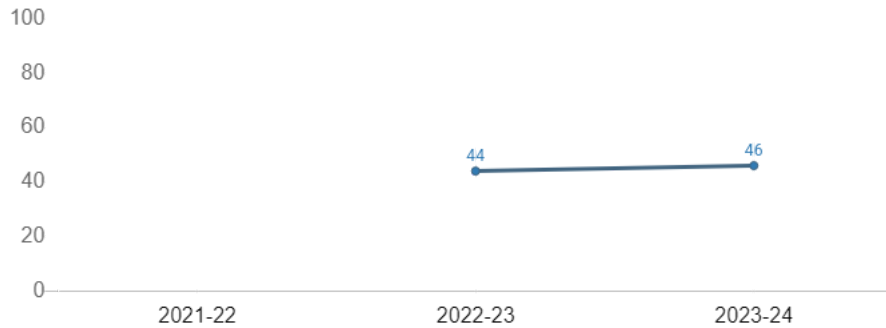

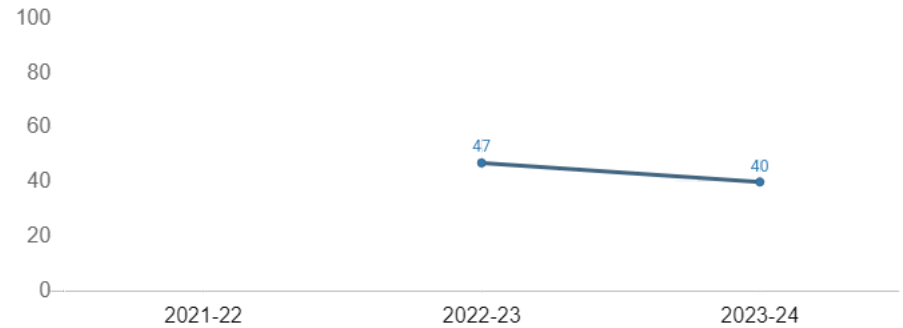

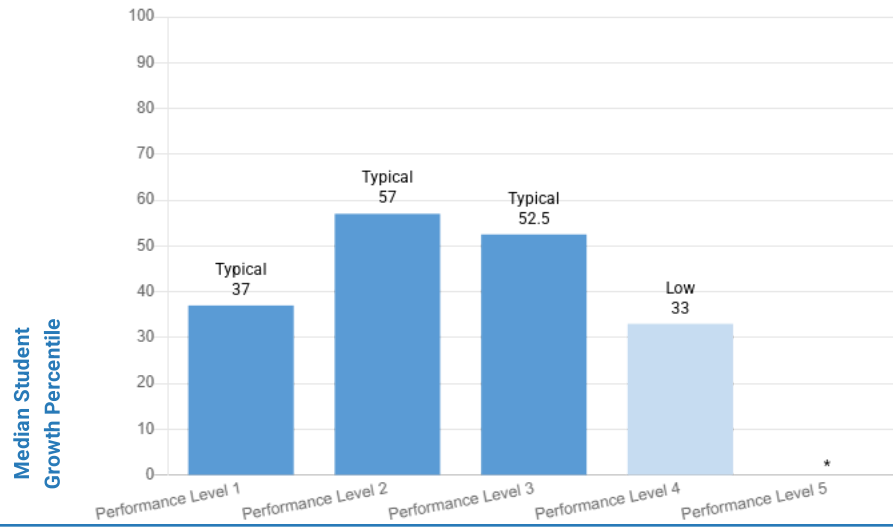

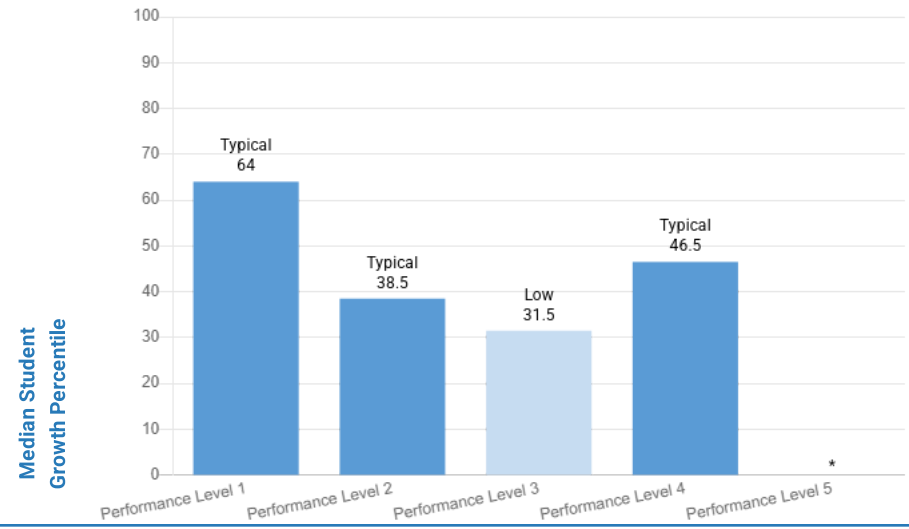

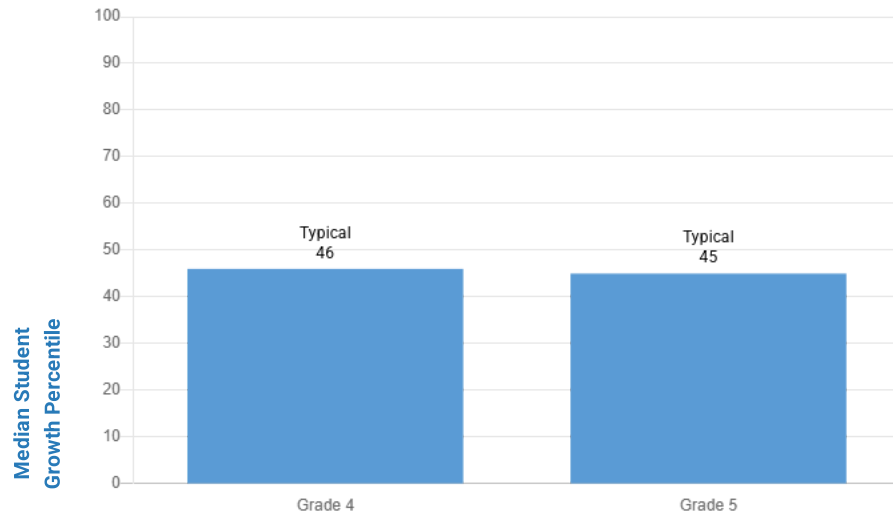

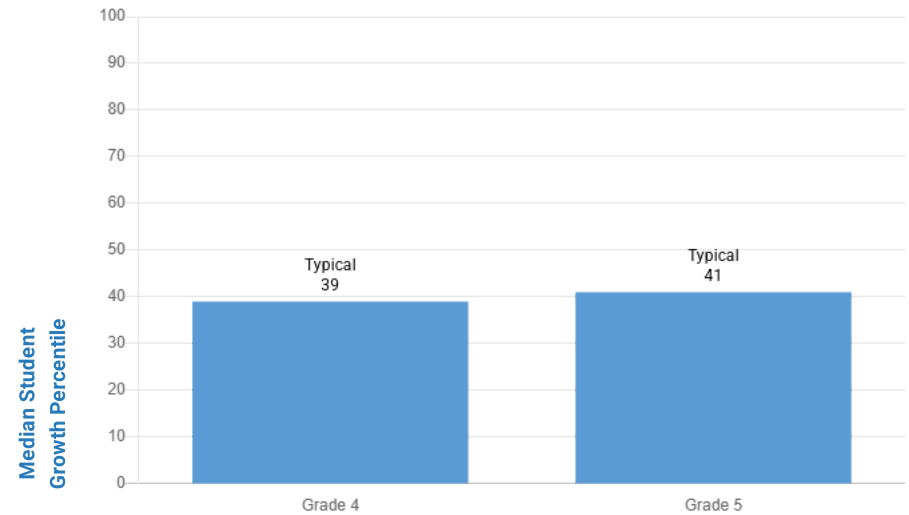

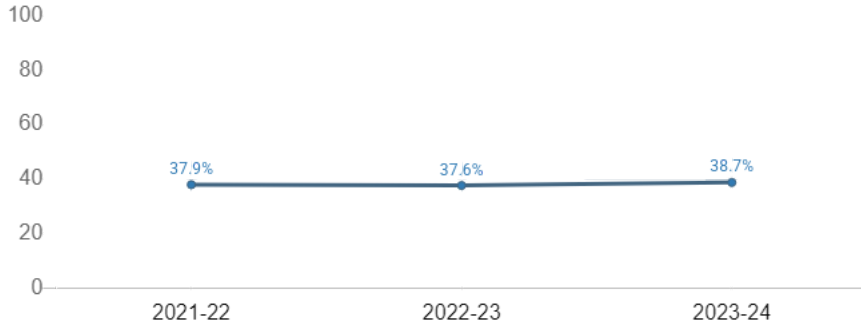

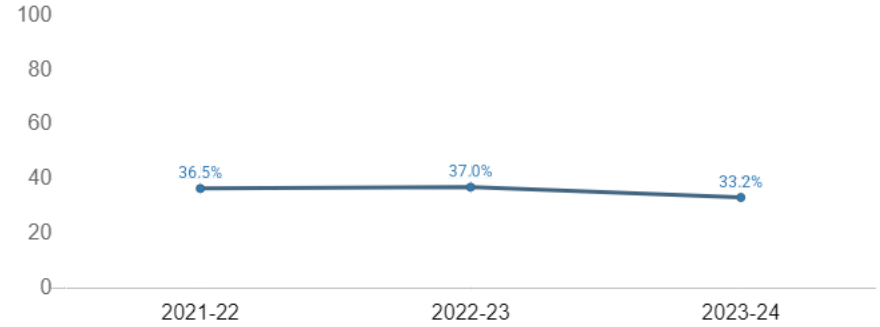
English Language Arts and Mathematics Performance Trends

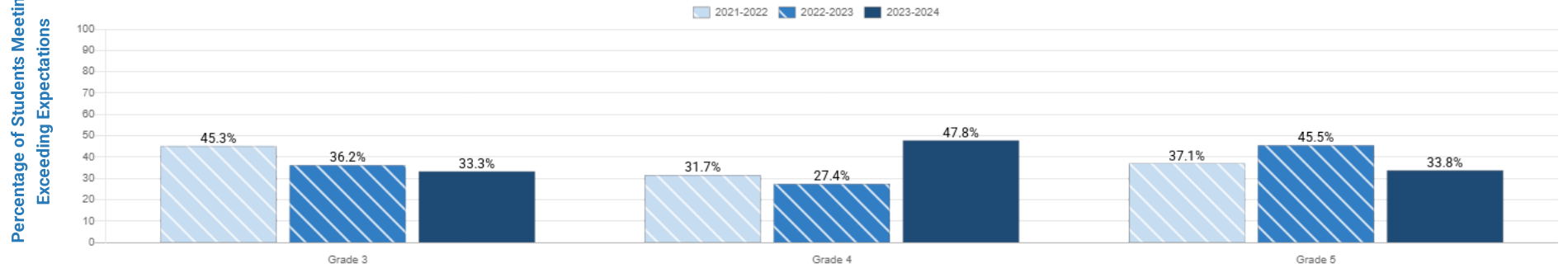

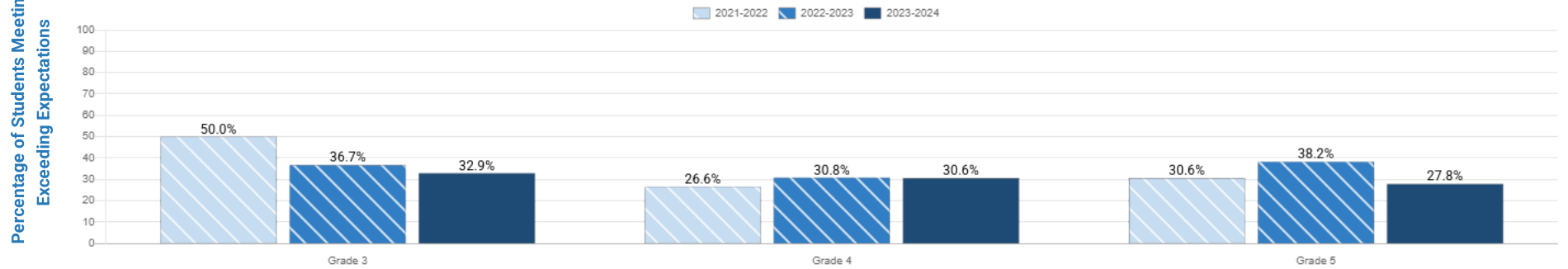

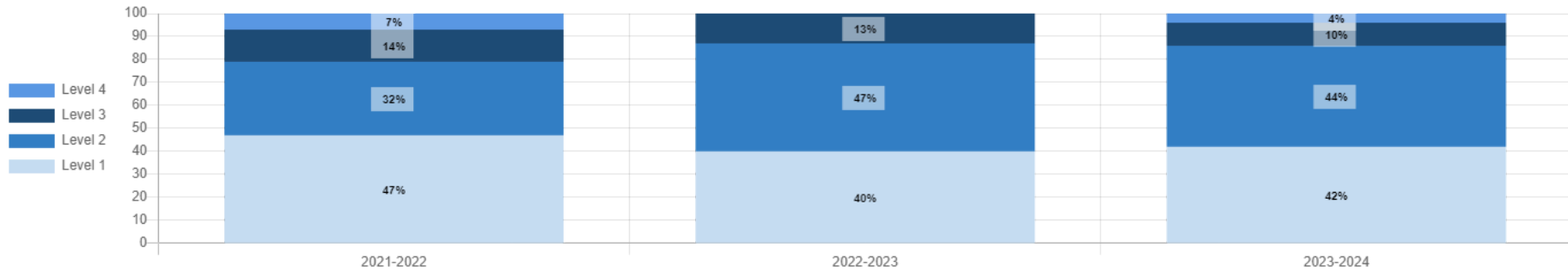

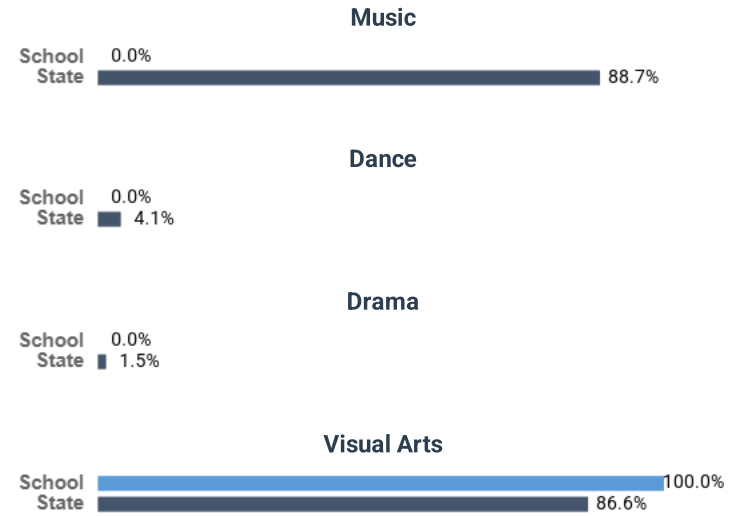

Students enrolled in one or more classes by discipline:



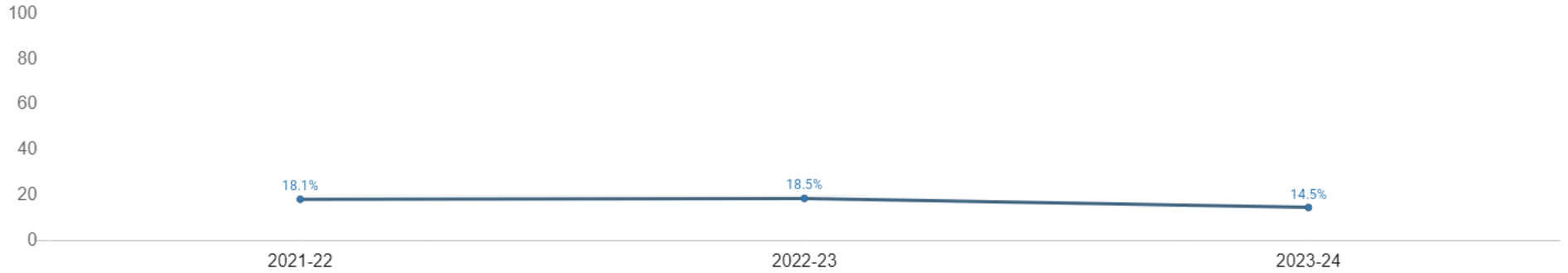
Climate and Environment

Student absences provide important information about a school's culture and climate. Research shows that absences impact a student's ability to succeed in school. The NJDOE used input from stakeholders to select chronic absenteeism as its measure of school quality and student success for the ESSA accountability plan. **Chronic absenteeism** is defined as being absent for 10% or more of the days enrolled during the school year. A student who is not present for any reason, whether excused, unexcused, or for disciplinary action, is considered absent unless permitted by state statute or regulations. Students with fewer than 45 days in membership are excluded from attendance calculations.

Chronic Absenteeism Trends

This table shows the number and percentage of students in grades K-12 both overall and by student group who were chronically absent during the school year. Pursuant to N.J.S.A. 18A:38-25.1, any school where 10 percent or more of the students enrolled are chronically absent must develop a corrective action plan to improve chronic absenteeism rates. The Requires Corrective Action Plan column in the table indicates whether the school's chronic absenteeism rate is 10% or higher, meaning that the school must complete a corrective action plan. The NJDOE Data-based Decision Making for Addressing Chronic Absenteeism guidance document (found on the [NJDOE attendance page](#) under Chronic Absenteeism) provides districts with guidance on responding to chronic absenteeism and includes sample corrective action plan templates.

The ESSA Target: State Average for Grades Served column is the target used for ESSA accountability purposes. It reflects the statewide average for students in the grades offered by the school. 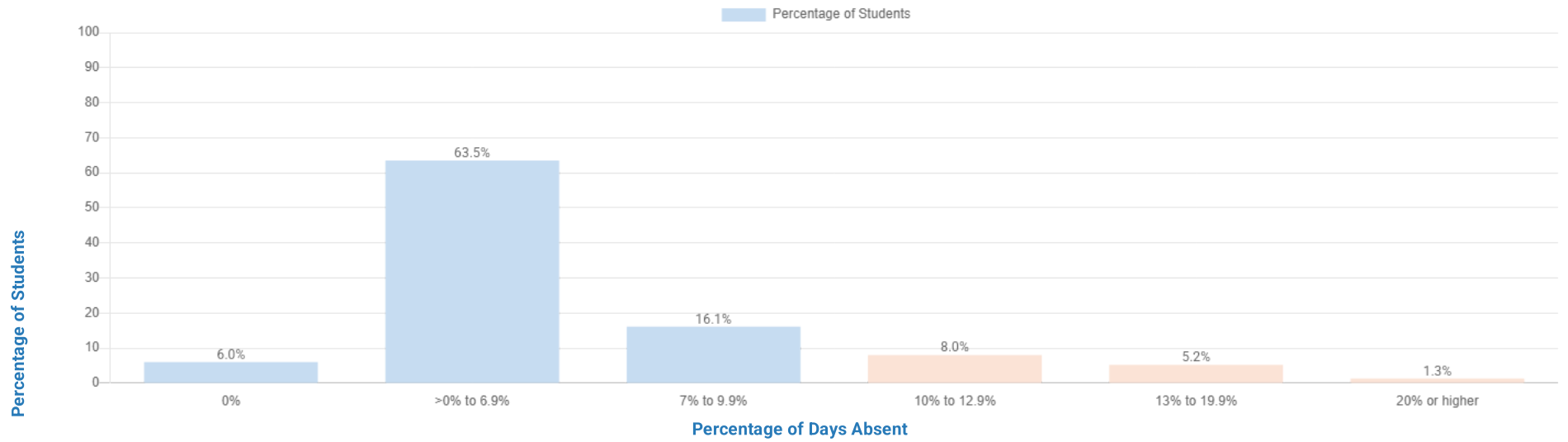

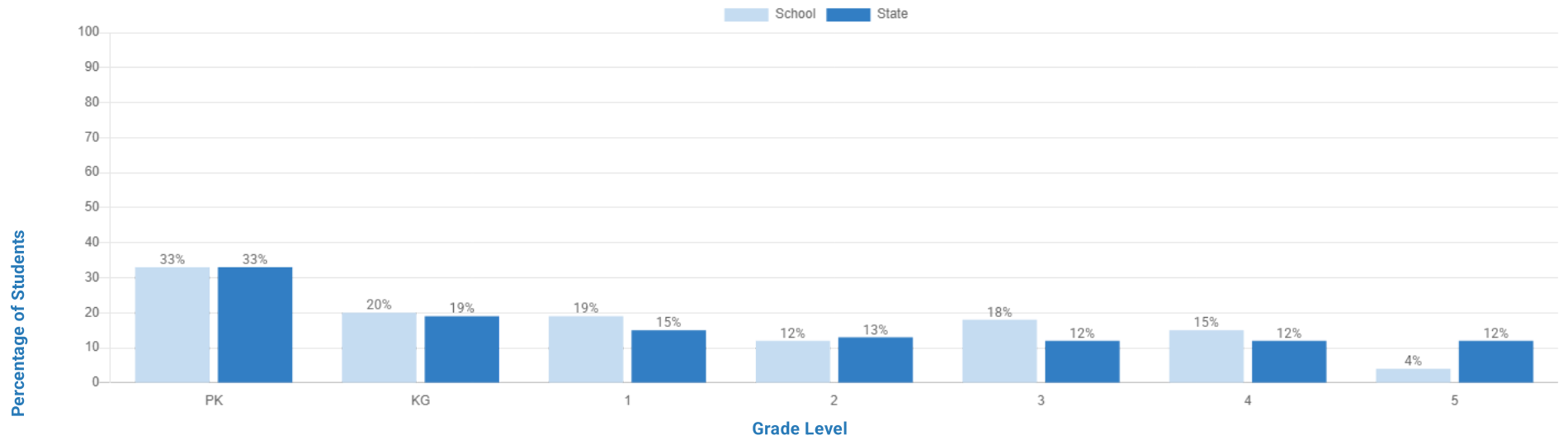

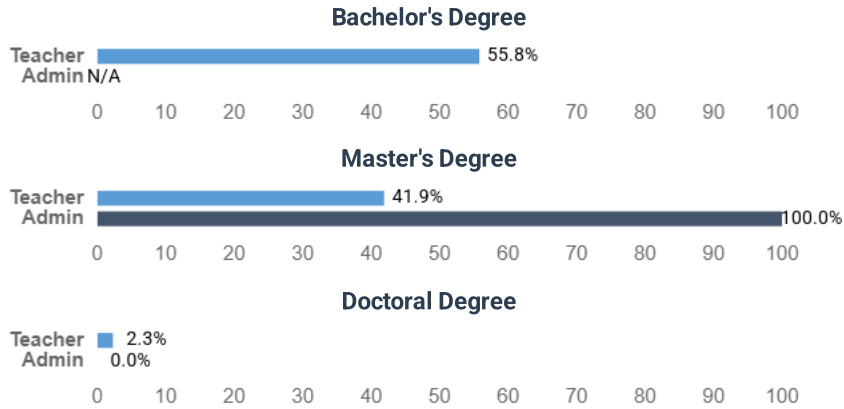

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. Before and After School Programs:

Childcare provided through the High Five Program is offered before and after school. Academic activities, extracurricular activities, and athletics are offered after school. English as a Second Language (ESL) and Academic Support Instruction (ASI) are also available through after-school support programs.



Staff and Professional Learning:

Our staff participates in a well-developed in-house professional development (PD) program. We offer four full-day PD opportunities throughout the year. In addition, we offer monthly hour-long PD sessions on data-driven instructional practices and best teaching practices. Professional development is brought into the district for all new content programs and follow-up support sessions are offered. Intervention and resource Our teachers participate in professional learning communities regularly. The PLCs focus on state mandates, improving pedagogy, and social-emotional learning. Additionally, our staff supports their colleagues with professional development sessions focusing on their areas of expertise.



Student Supports and Services:

Student Services include special education teachers, guidance counselors, nurses, CSTs, and related service providers. The district has modeled student interventions in the NJ TSOS and tracks student data for general/special education and Academic Support Intervention. English as a Second Language and sheltered instruction is provided across grade levels.

The school nurse works with students and families to support the health of all students. Students receive hearing and vision screenings. Families are offered dental exams, vision testing, and glasses as needed. Counselors and CSTs collaborate with students, school, and community members to promote students' emotional well-being.

JFK School was originally constructed in 1959 with 12 classrooms. The building has since expanded to include a three-level addition, constructed in 1998. Modular classrooms were also introduced in 2019 to support the influx of students. The building is now home to eight preschool classrooms, 19 grade-level classrooms, four resource rooms, three self-contained classrooms, gym, music room, and art room. As of 2023, 100% of JFK is fully air-conditioned.

School Safety:

School safety and security is taken seriously in Jamesburg Public Schools. Multiple safety measures have been implemented across the district. Technology and STEM:

Technology is an integral part of our curriculum with a focus on student technology including one-to-one Chromebooks for preschool through fifth grade. We continue to expand our instructional technology tools to enhance the teaching and learning experience. All our content-based programs feature online components to support student learning. We offer STEAM as a related arts rotation at the elementary school. Additionally, the gifted and talented program at the elementary school is a STEAM-based program.



Early Childhood Education:

The JFK Elementary School offers free full-day preschool and kindergarten to all residents. Our inclusive preschool provide learning environments for three-year-olds, four-year-olds, and students entering from Early Intervention. Our teachers are trained in implementing the Creative Curriculum and utilize Pyramid Model Strategies to support the academic, social and emotional development of our youngest learners.
