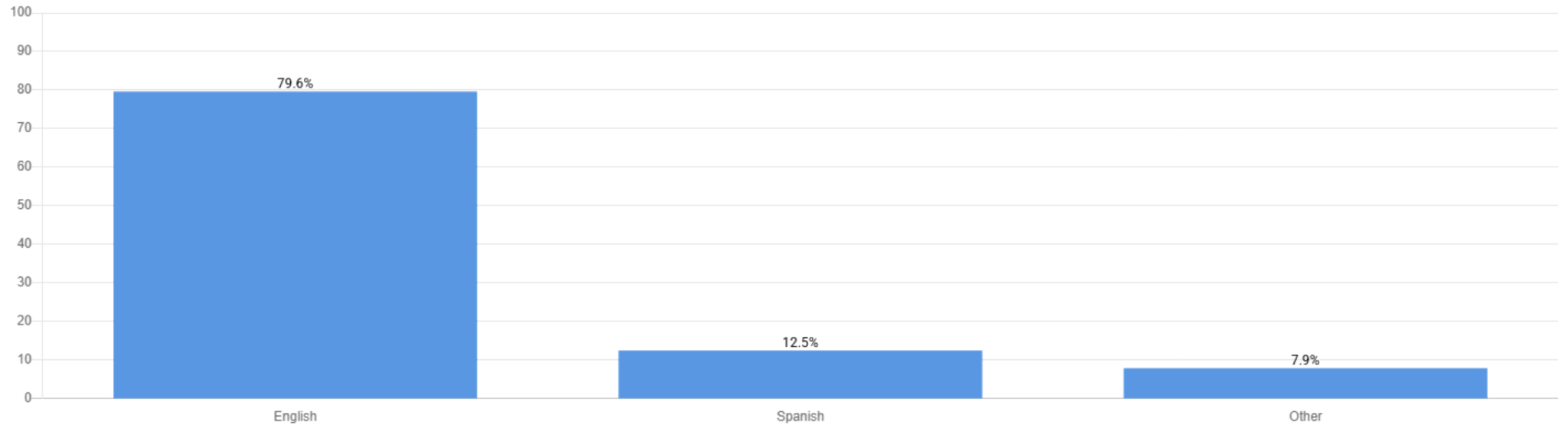

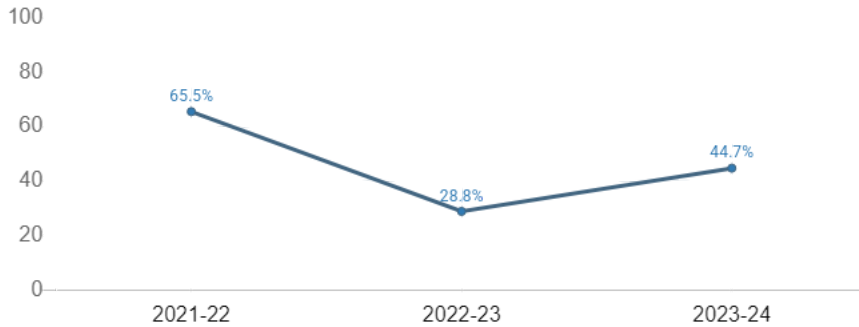

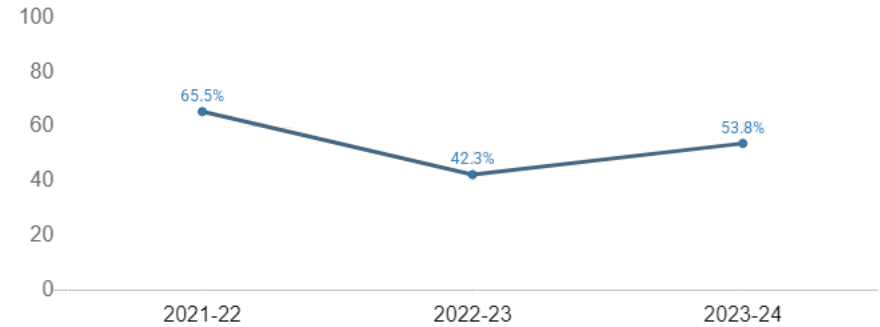
English Language Arts and Mathematics Performance Trends

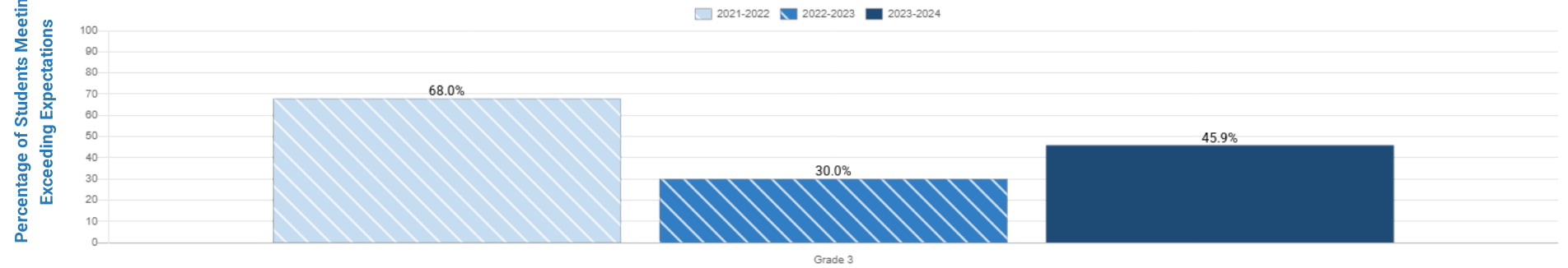

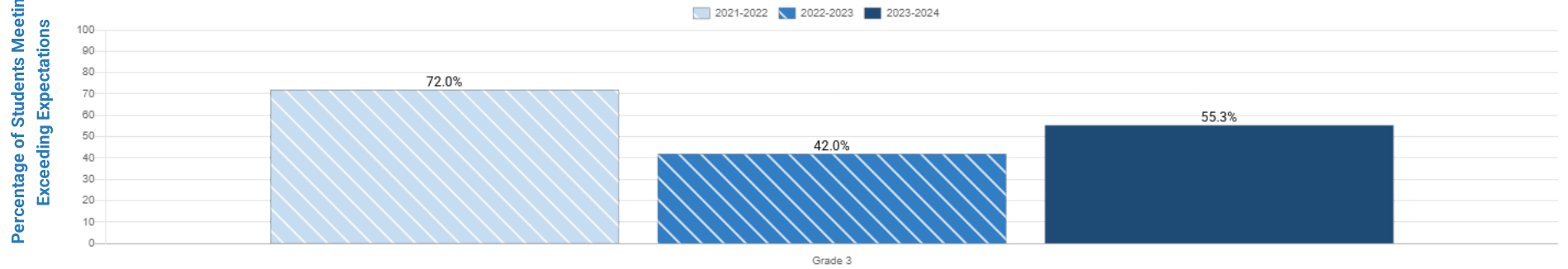

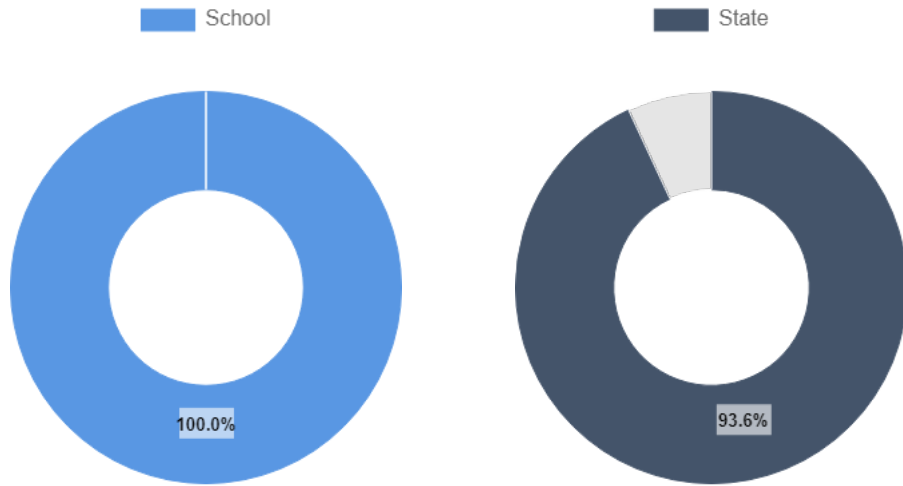

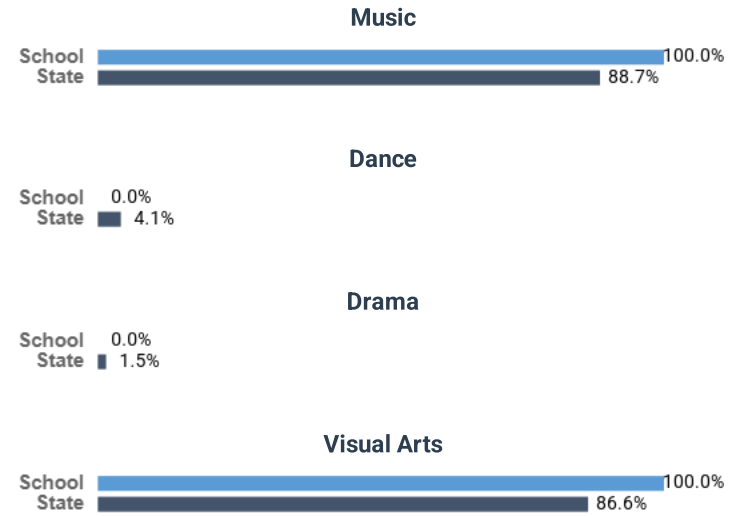

Students enrolled in one or more classes by discipline:



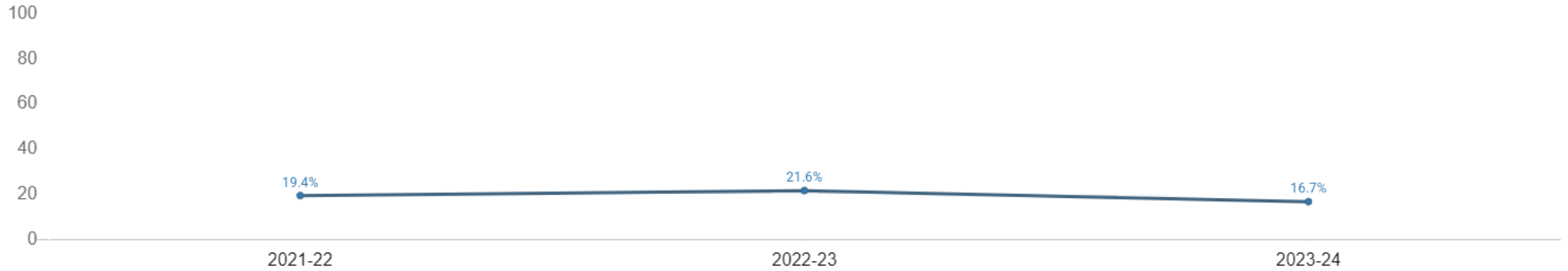
Climate and Environment

Student absences provide important information about a school's culture and climate. Research shows that absences impact a student's ability to succeed in school. The NJDOE used input from stakeholders to select chronic absenteeism as its measure of school quality and student success for the ESSA accountability plan. **Chronic absenteeism** is defined as being absent for 10% or more of the days enrolled during the school year. A student who is not present for any reason, whether excused, unexcused, or for disciplinary action, is considered absent unless permitted by state statute or regulations. Students with fewer than 45 days in membership are excluded from attendance calculations.

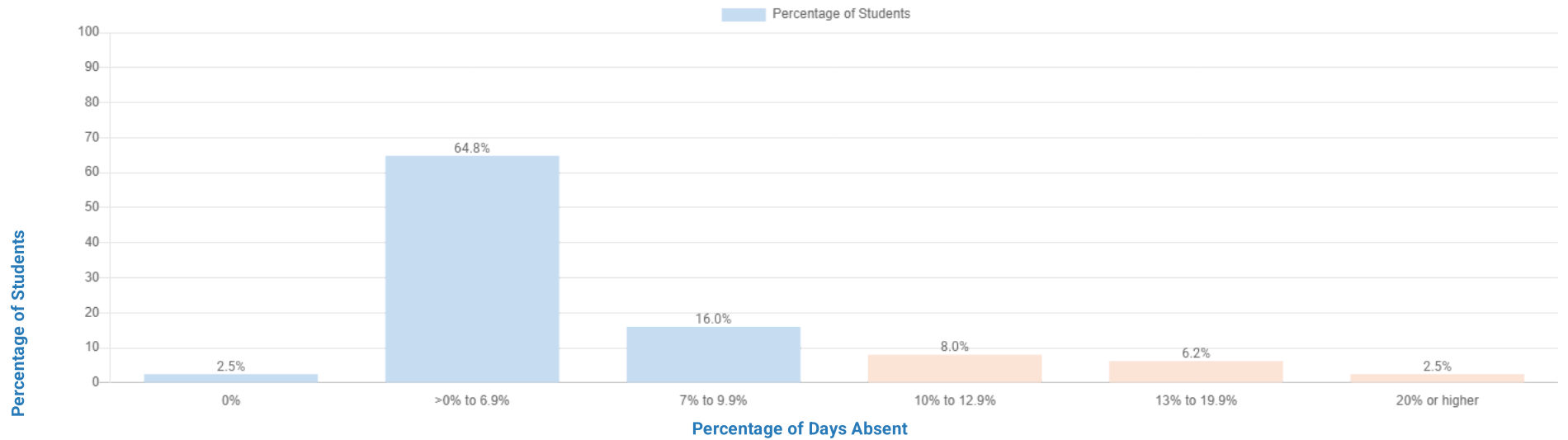

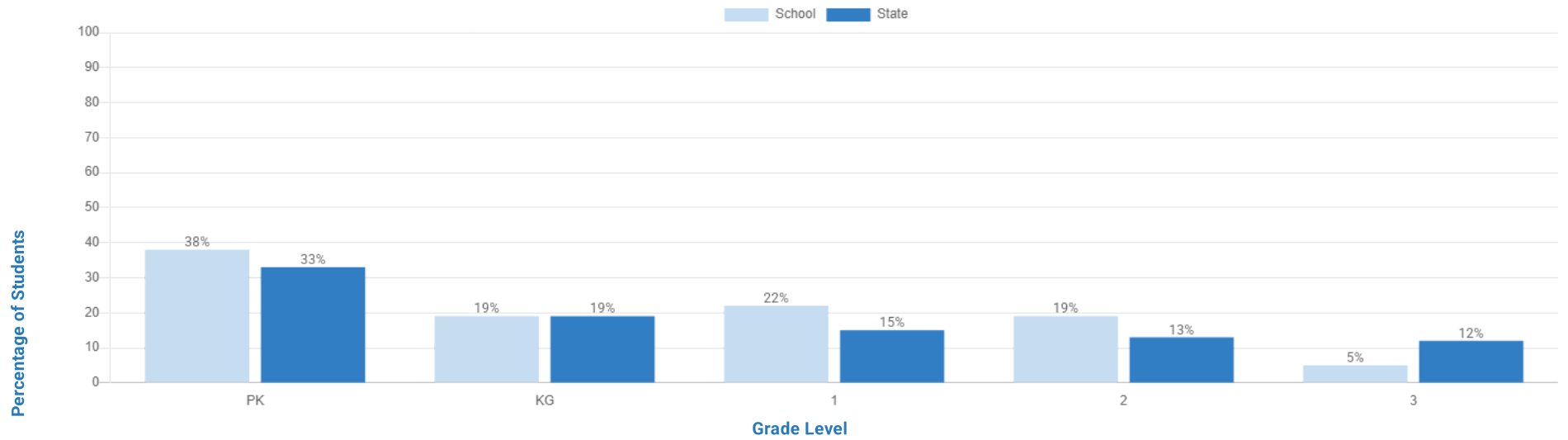

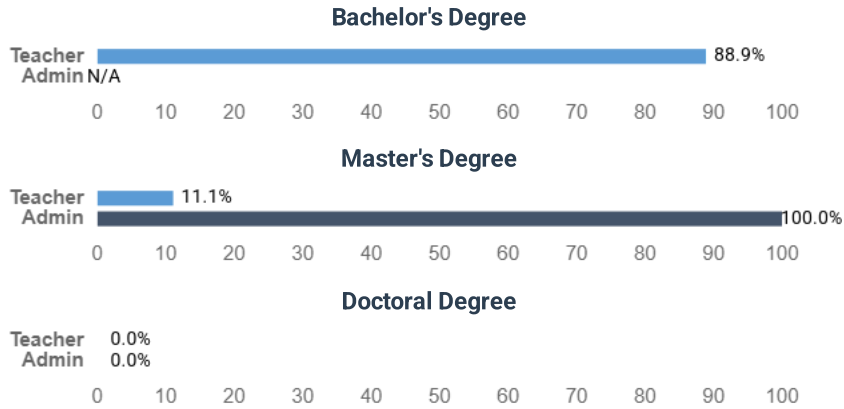

Prominent educational experts support our faculty in strengthening their instructional approaches and embracing best practices. Educators receive training regarding pedagogical approaches, and how to support the whole child. Teachers attend out-of-district professional development to support their growth as instructional leaders and experts in their respective subjects. Faculty members also engage in monthly grade level, department, and curriculum meetings to collaborate, learn, and enhance their teaching strategies.



Student Supports and Services:

Hazelwood School offers academic support and interventions(ASI) in ELA and math, structured English Language Learner (ELL) programming, and robust Special Education services. Students are also supported through the Intervention and Referral Service (I&RS) process and targeted tutoring programming.
