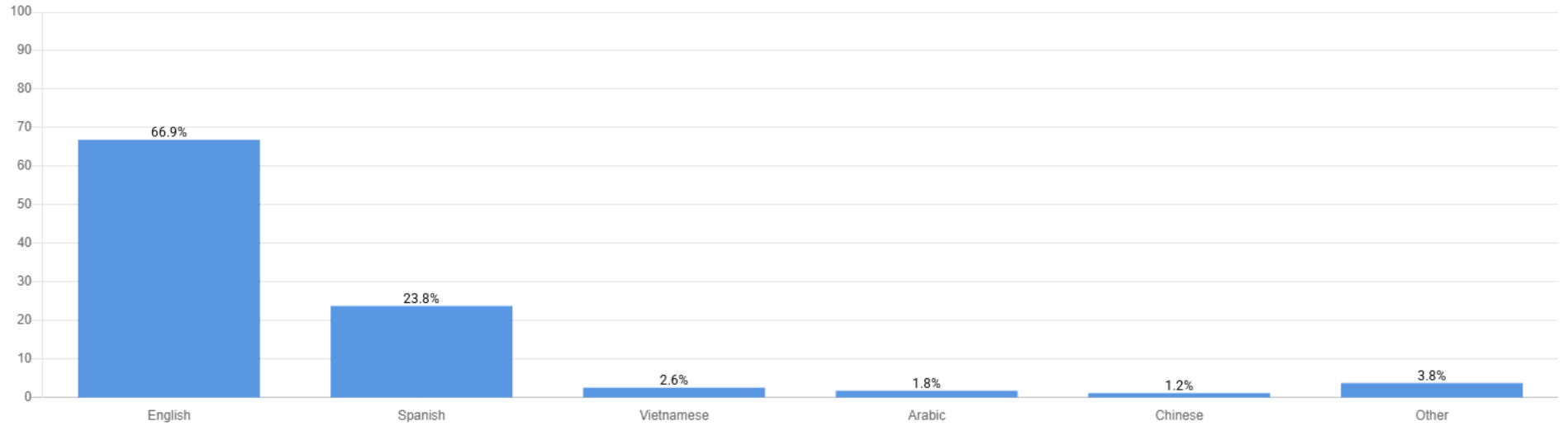

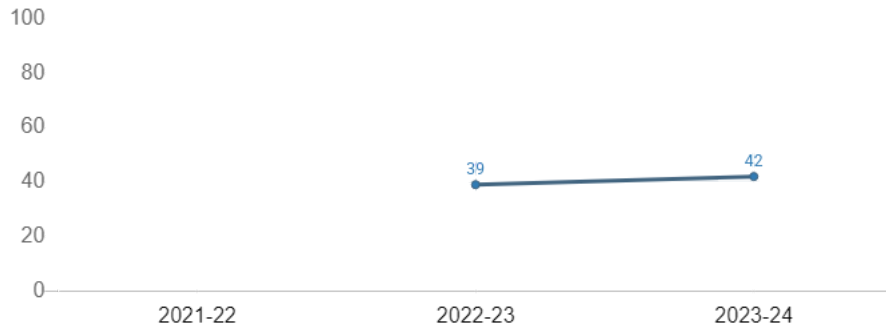

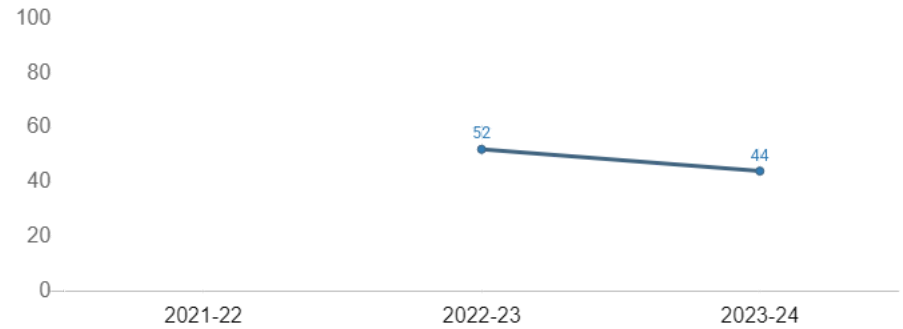

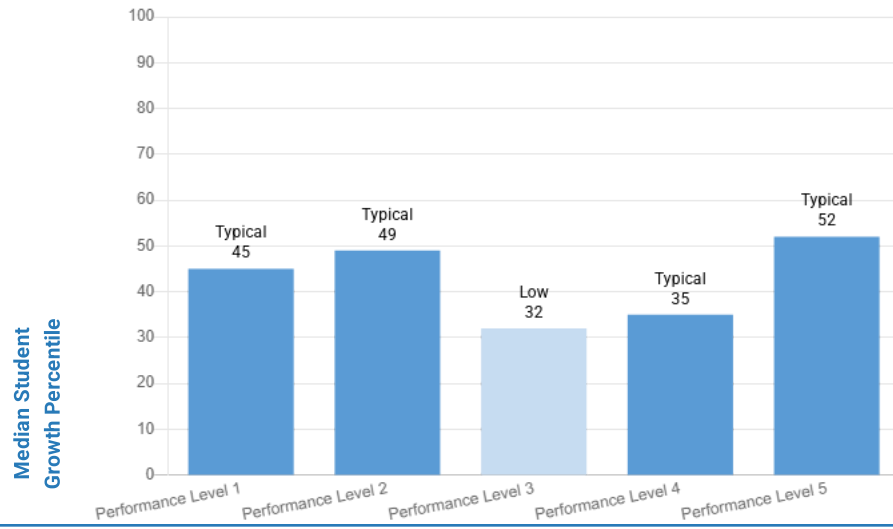

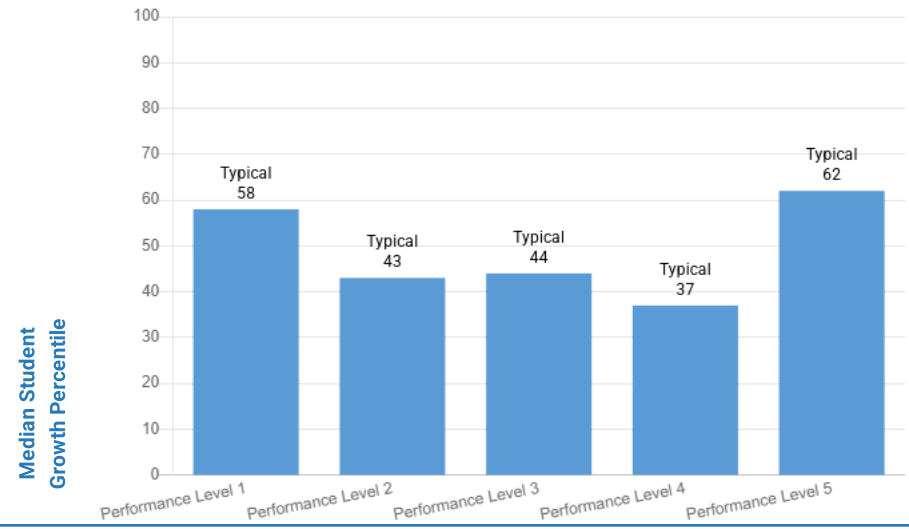

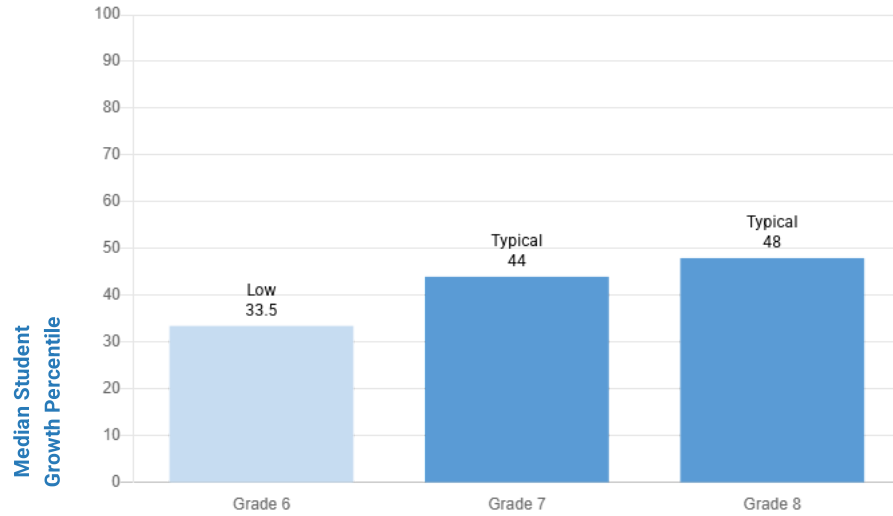

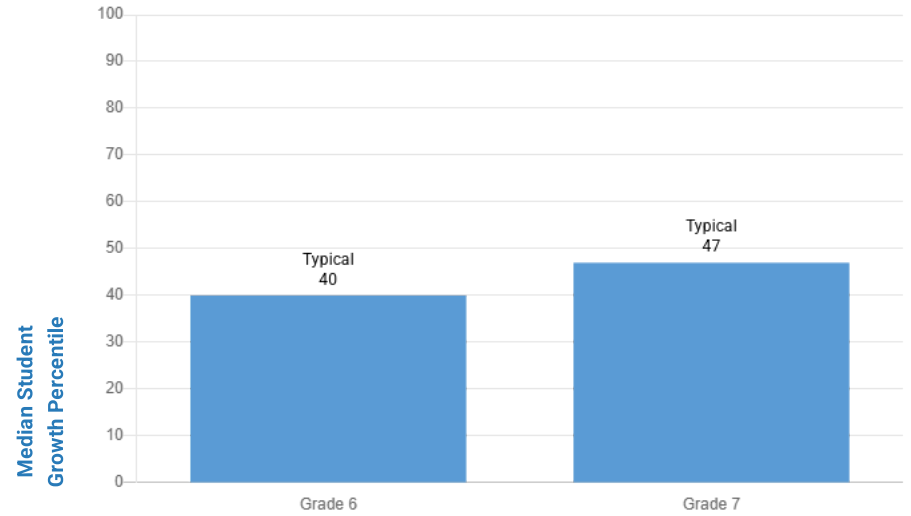

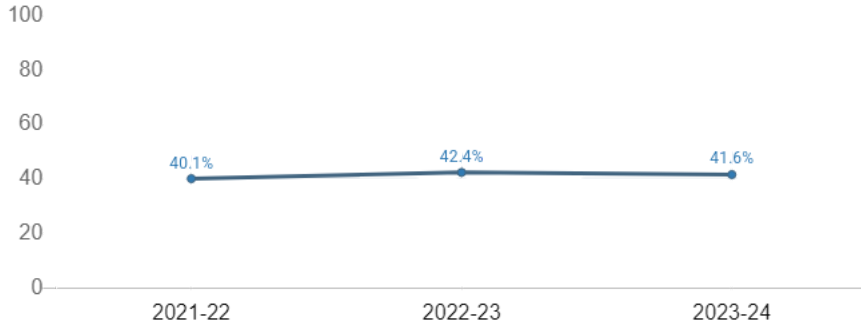

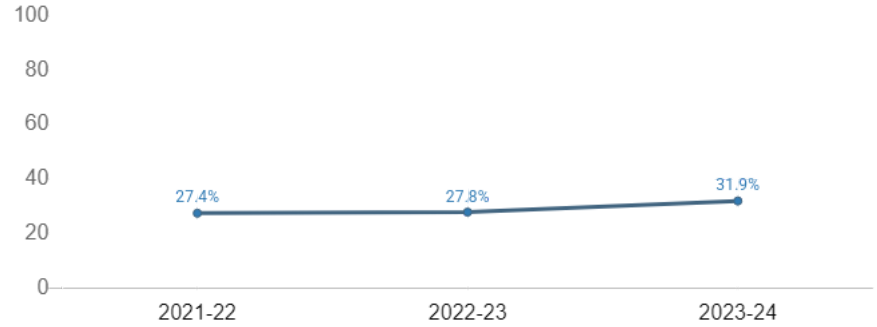
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. 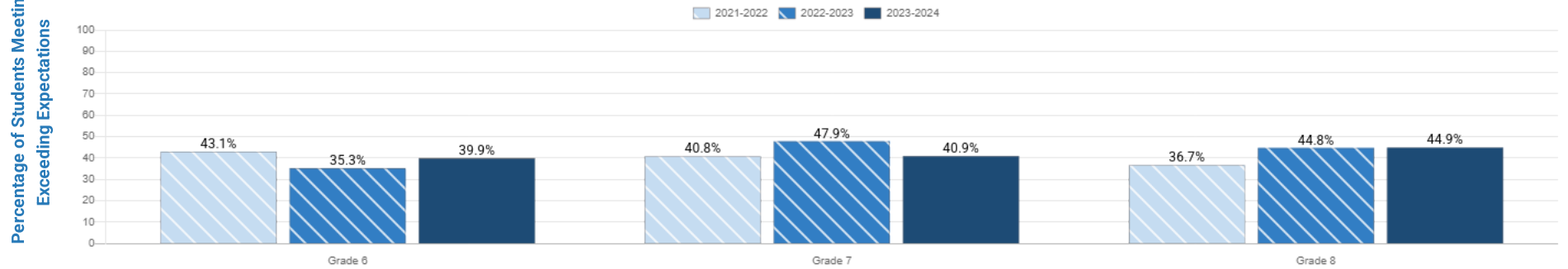

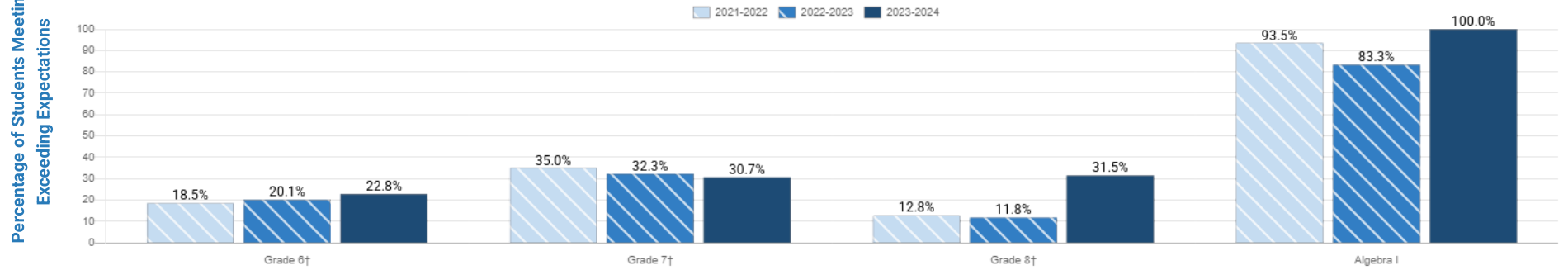

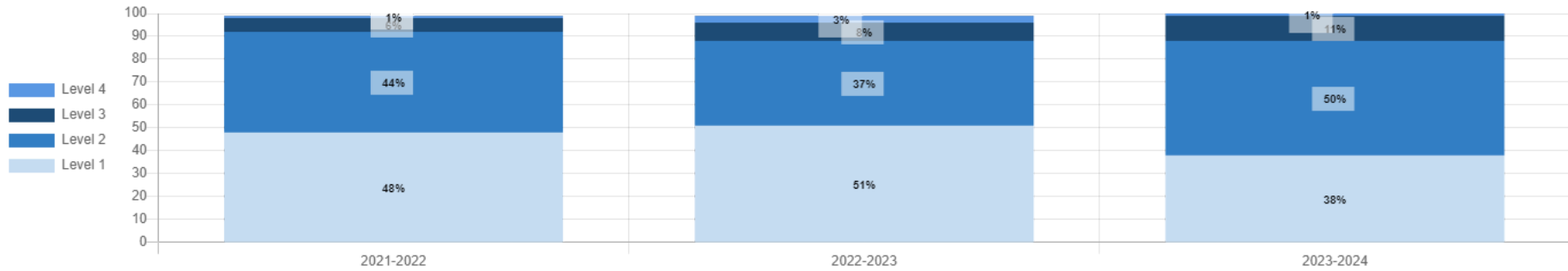

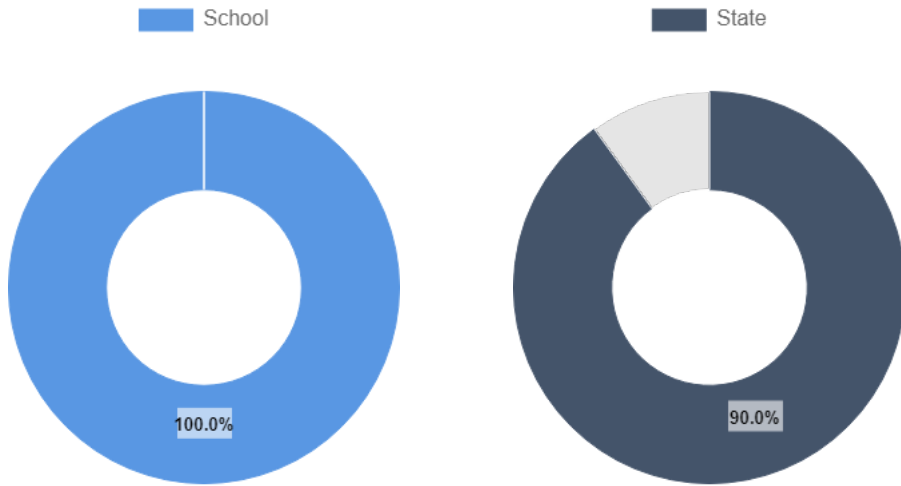

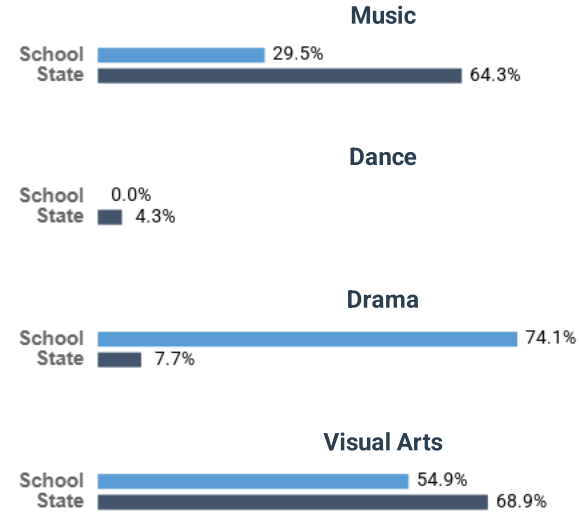

Students enrolled in one or more classes by discipline:



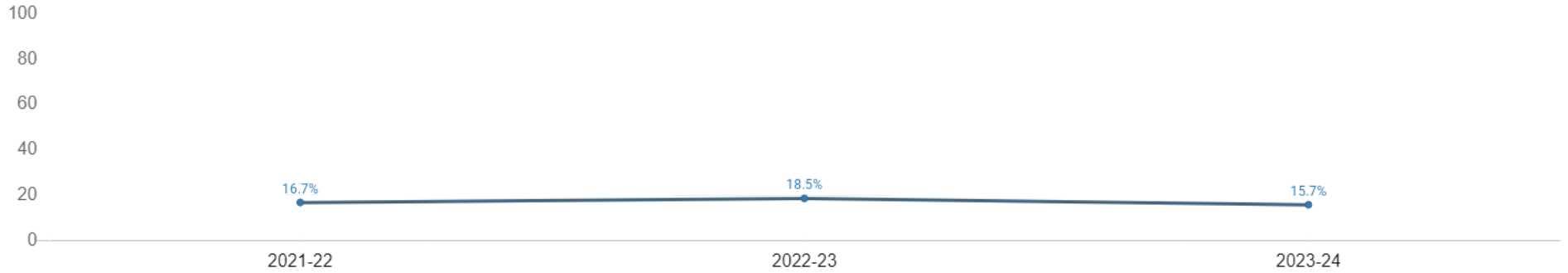

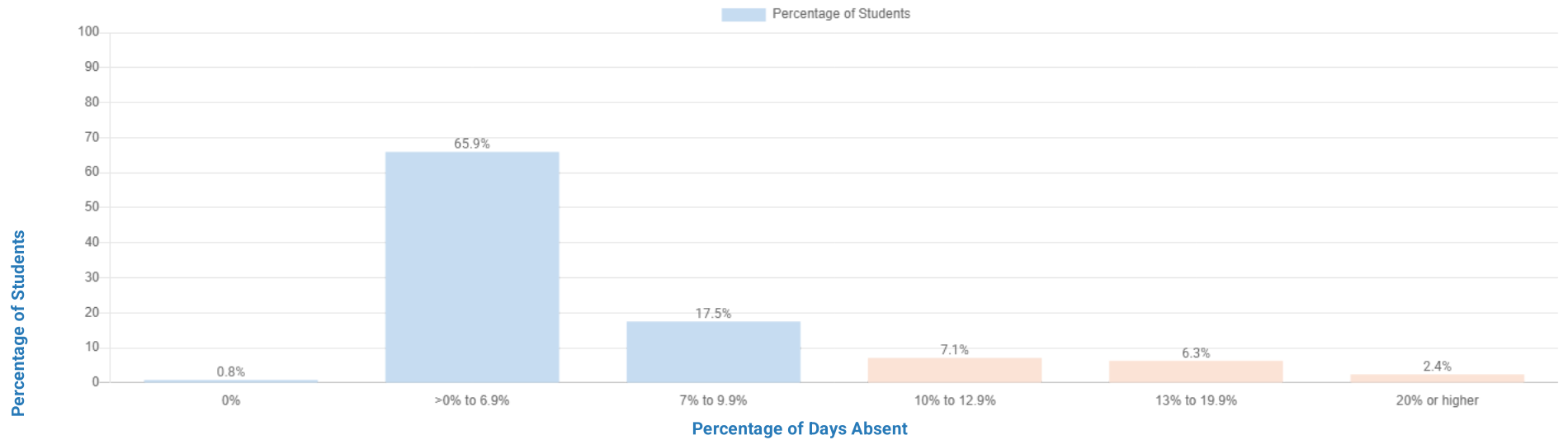

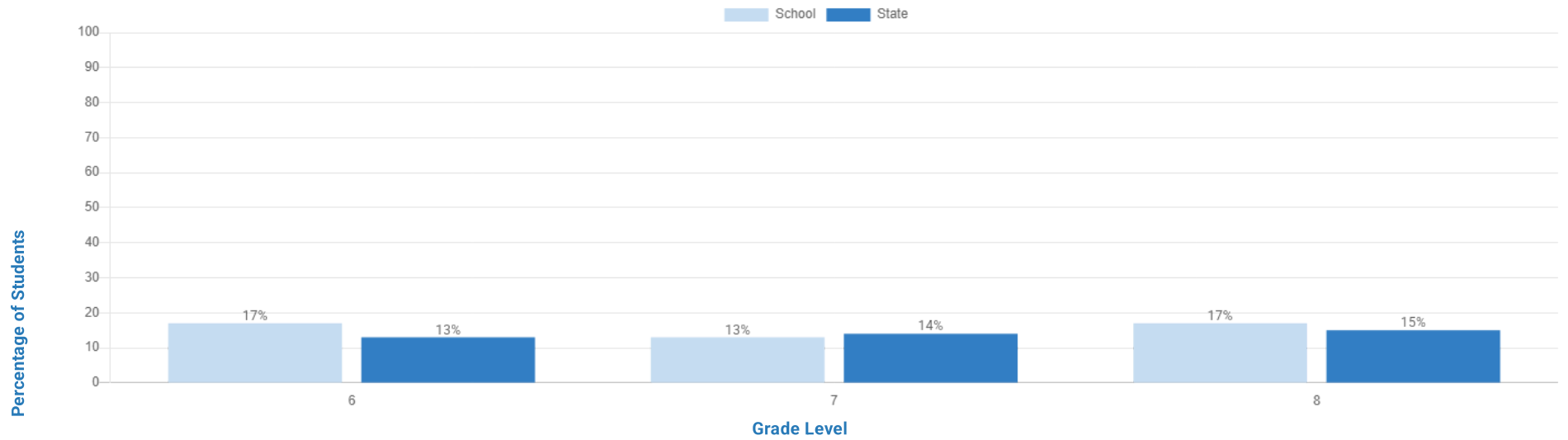

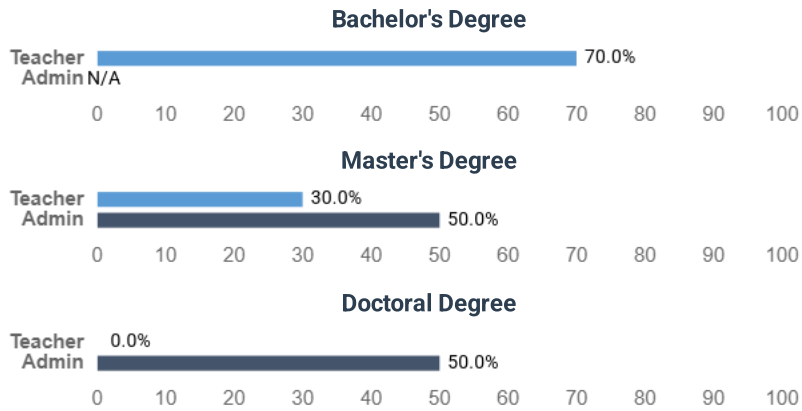

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. Schools are identified for ATSI if they have at least one student group that has a summative score that would be in the bottom 5% of Title I schools if it was its own school. Schools are identified for TSI if they have at least one student group that missed annual targets or standards for all indicators for two years in a row. Before and After School Programs:

Before and After School Child is available to students in grades 6 through 8. Students who participate in the program receive homework help, participate in planned activities/parties, and socialize with their peers. The program is available to parents for a nominal fee.



Staff and Professional Learning:

Professional development opportunities are available to staff at the district and building level. Staff members participate in weekly grade level meeting and bi-weekly articulation sessions. Staff members may attend outside professional development sessions that are directly aligned to their Professional Development Plan. District professional development sessions are link to the districts goals, monitoring student progress and teaching and learning.



Student Supports and Services:

Student support services within VEM provide students with an opportunity to receive strategies and support that will enable them to be successful within the school. VEM partnered with Rutgers BRIGHT program to provide school based counseling services to support the needs of students. Staff members at VEM receive ongoing training in the Sheltered Instruction Protocol. The implementation of the protocol is to help support our English Language Learners. Our ELLs also receive additional support through our Bi-lingual Aide. The Bi-lingual Aide provides additional support within the Social Studies and Science classes. Our Intervention and Referral Service (I&RS) team meets with teachers and parents with strategies to address academic and behavioral challenges.

Through our Health Department, our school nurses provide nutritional information, health updates, and physical exams to students. In conjunction with the Student Advisory Committee, the nurses work with the Food Service Department to discuss meal options and nutrition with our students. Students at VEM have the option of participating in breakfast and lunch options.

School Safety:

School safety is our top priority. We work directly with the Middlesex Police Department, and Office of Emergency Management to ensure the health and safety of our staff and students. Our building-based BTAM Safety and Medical Teams meet periodically to ensure that schoolwide procedures and protocols are implemented. Monthly security and safety drills are held to ensure that staff and students are aware of the procedures.



Technology and STEM:

VEM continues to focus on STEAM initiatives. As a school participating in the Middle Grades Career Awareness and Exploration Program, staff and students are exposed to various STEAM opportunities. With a dedicated MakerSpace within the Media Center, students are able to participate in hands-on activities. The instruction space within the Media Center is a technology rich environment that provides students with access to the following tools: 3D Printers, circuit boards, Encyclopedia Britannica online, MindStorm Legos, Spike Robots, Little-Bits and kineticks. Our technology lab features a green screen which enables the students to create and record our daily broadcast message. The daily messages provide students in grades 6th through 8th with highlights and upcoming activities and events.



Attendance:

To improve and maintain regular school attendance for the 2023-2024 school year, several evidence-based practices were implemented. We focus on early intervention, using attendance data to identify and support students at risk of chronic absenteeism. Teachers regularly communicate with parents to discuss attendance concerns and collaborate on strategies to support student engagement. Collaboration with community partners ensures that students and families have access to necessary resources. By fostering a positive school culture and engaging students in relevant, hands-on learning, we aim to ensure consistent attendance and support students' academic success.
