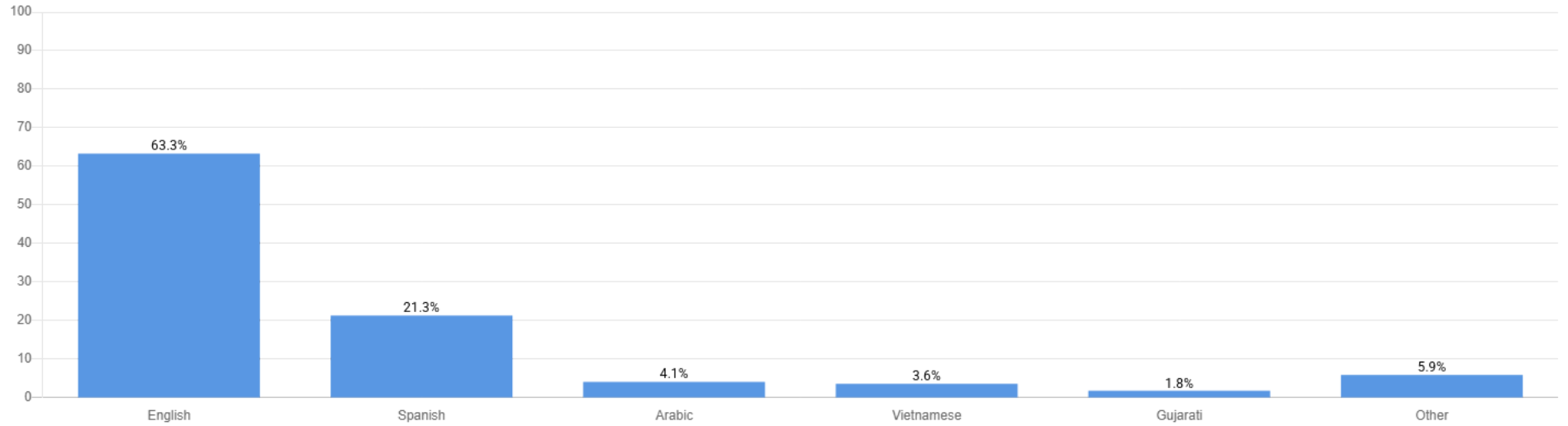

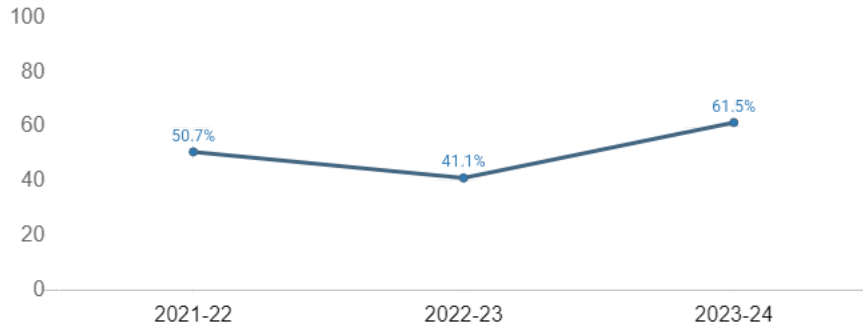

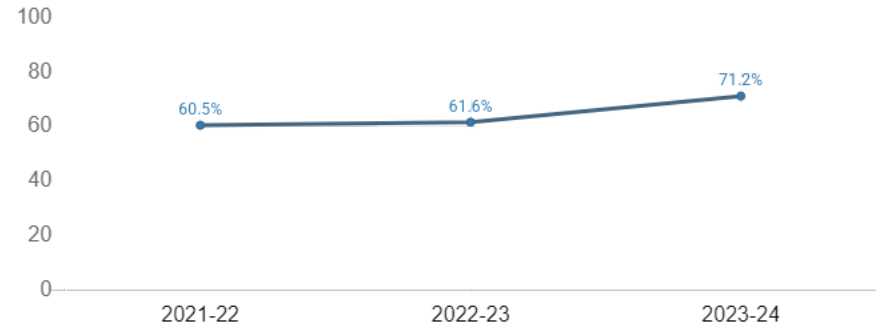
English Language Arts and Mathematics Performance Trends

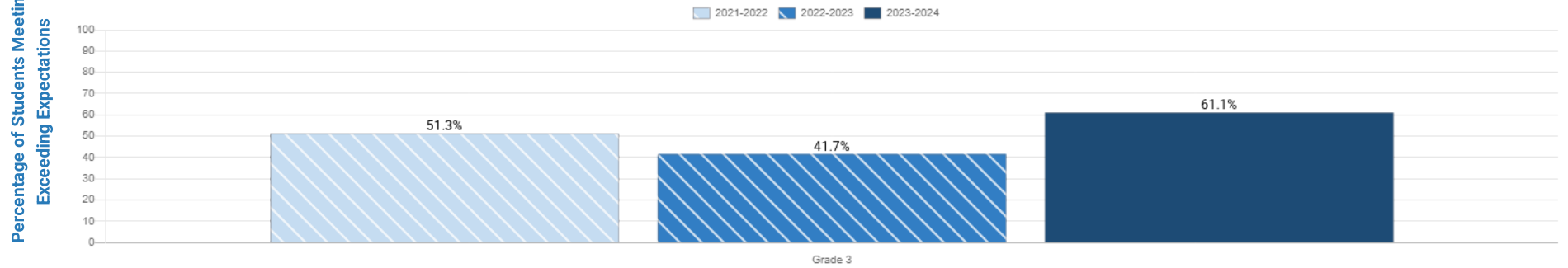

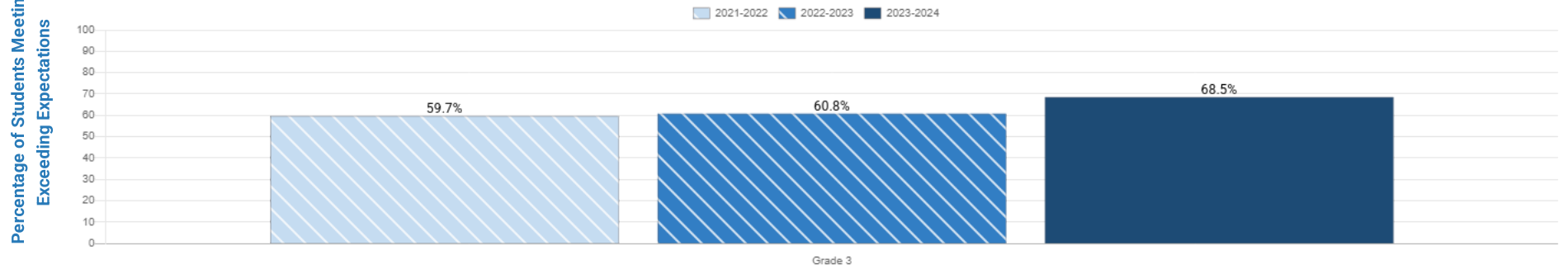

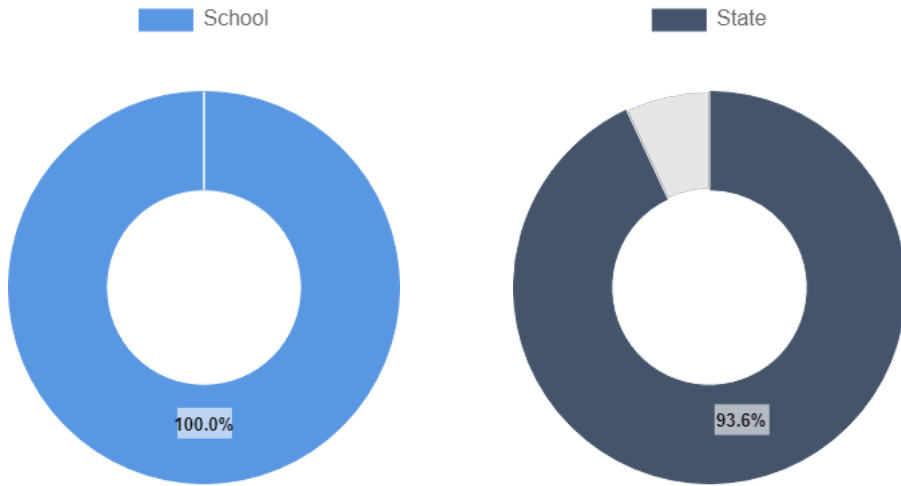

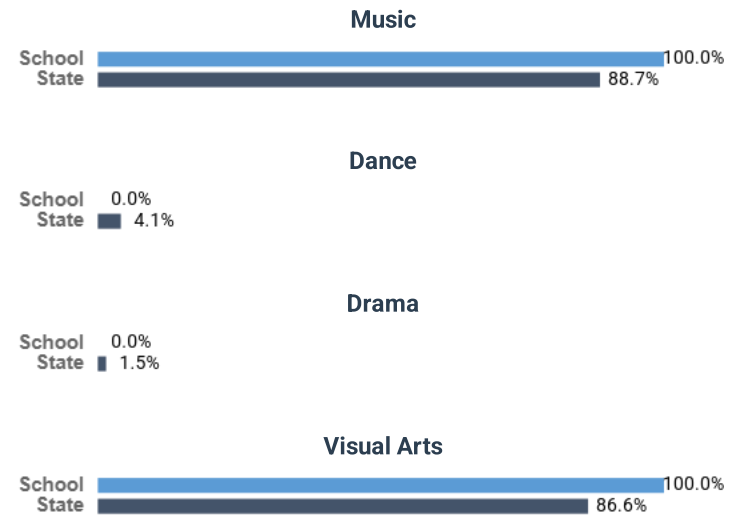

Students enrolled in one or more classes by discipline:



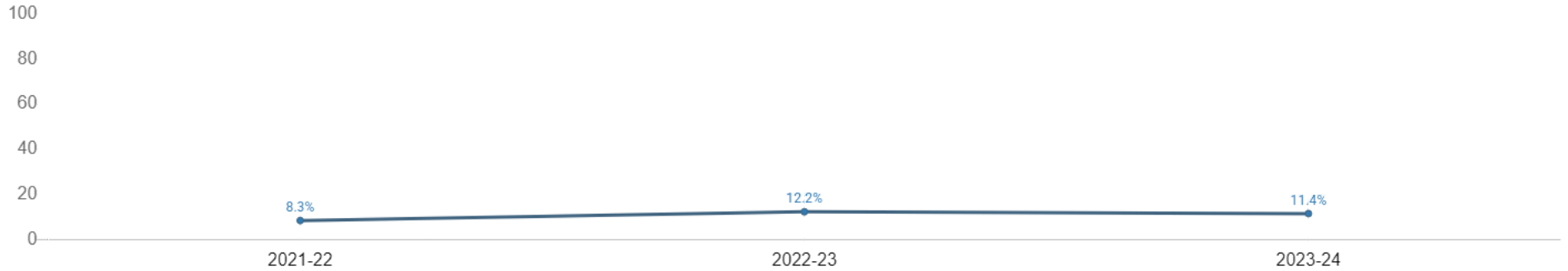
Climate and Environment

Student absences provide important information about a school's culture and climate. Research shows that absences impact a student's ability to succeed in school. The NJDOE used input from stakeholders to select chronic absenteeism as its measure of school quality and student success for the ESSA accountability plan. **Chronic absenteeism** is defined as being absent for 10% or more of the days enrolled during the school year. A student who is not present for any reason, whether excused, unexcused, or for disciplinary action, is considered absent unless permitted by state statute or regulations. Students with fewer than 45 days in membership are excluded from attendance calculations.

Chronic Absenteeism Trends

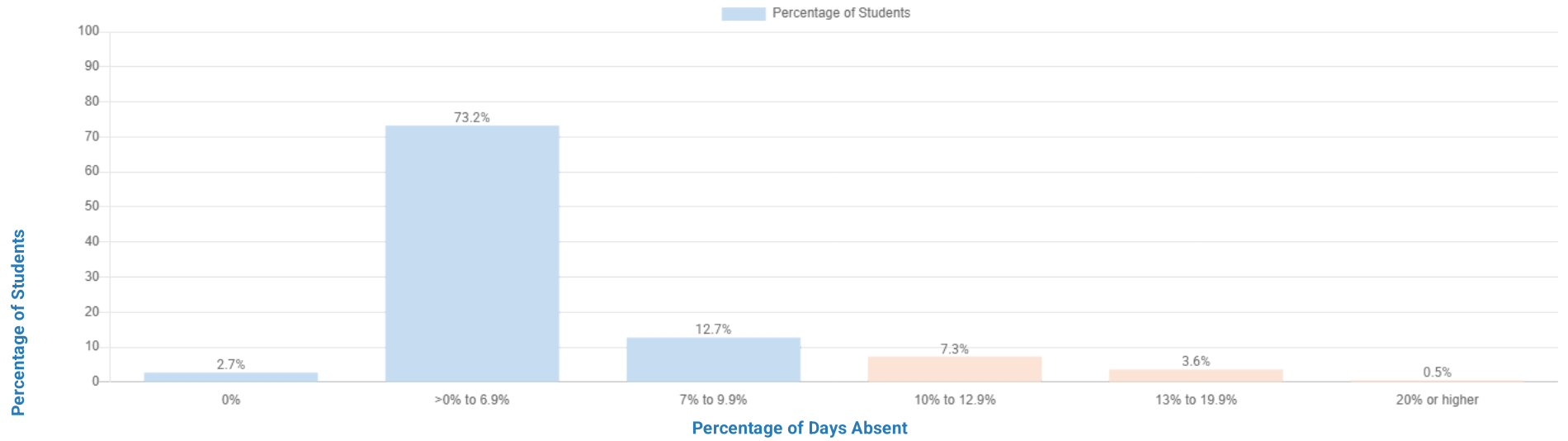

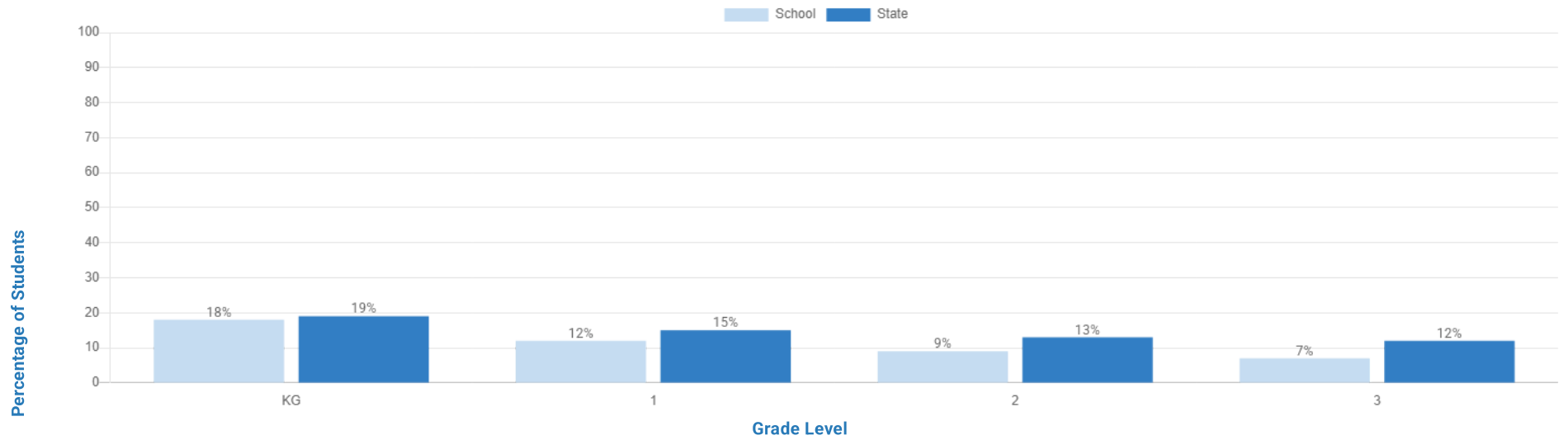

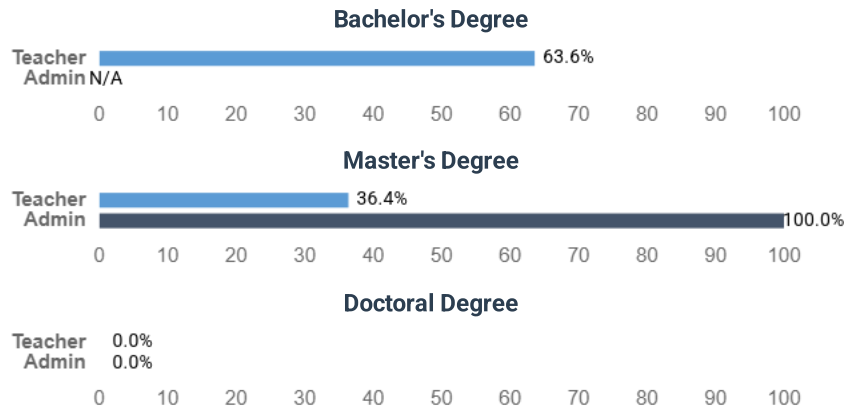

Courses, Curriculum, Instruction:

Reading is a cornerstone of student success in Watchung, where students take pride in their growth as readers. Our school library program enhances this by fostering a love of reading and engaging students in monthly STEAM lessons centered on the engineering and design process. English Language Arts instruction is grounded in the science of reading, ensuring research-based practices. In mathematics, the district utilizes the Big Ideas Math program alongside a guided math instruction model, incorporating math workstations to personalize learning and build foundational skills.



Before and After School Programs:

Watchung School provides a Before and After Care Program for students in kindergarten through third grade through the Middlesex Community School. The program supports students with homework, socialization, and engaging activities led by the supervisor. Activities include field trips, computer time, talent shows, bowling, movies, games, free play, holiday celebrations, arts and crafts, and special presentations featuring art, music, and educational performances.



Staff and Professional Learning:

Professional development days allow staff to collaborate with in-house trainers or outside experts, focusing on district curricular initiatives. Teachers tailor instruction to meet individual student needs, providing reinforcement or enrichment as needed. Teacher-led committees, guided by district supervisors, routinely review and update curricula to ensure relevance and effectiveness.

The I&RS team develops and monitors strategies for identified students, while the CST evaluates and assists those with learning difficulties. Speech/Language services address listening skills, language development, articulation, voice, and fluency. Academic Support staff provide targeted reinforcement of grade-level concepts, and support for multilingual learners is provided to help students with language acquisition.

Other Information:

The educational climate at Watchung School prioritizes academic achievement, positive social experiences, and emotional well-being. In collaboration with parents and the Middlesex community, we aim to foster a school culture that nurtures the whole child. Teachers focus on developing organizational, study, and research skills, while student success is measured through diverse assessments, including daily classwork, cumulative projects, portfolios, performance assessments, Reading Assessments, district assessments, and standardized testing. Results are entered into the LinkIt data platform to inform classroom instruction. Our technology teacher coordinates weekly lessons to support classroom learning, and all classrooms are equipped with internet access, interactive whiteboards, document cameras, and student Chromebooks. Teachers integrate technology into lessons to enhance learning experiences. Exposure to the performing arts promotes creativity, and all students participate in visual arts and vocal music programs. Spanish is taught to kindergarten through third-grade students, promoting cultural awareness through active participation. Character education is integral to our approach, teaching students the value of teamwork and mutual support. The school counselor leads lessons on how teamwork helps solve problems at school and home, a theme reinforced during Week of Respect and School Violence Awareness Week.
