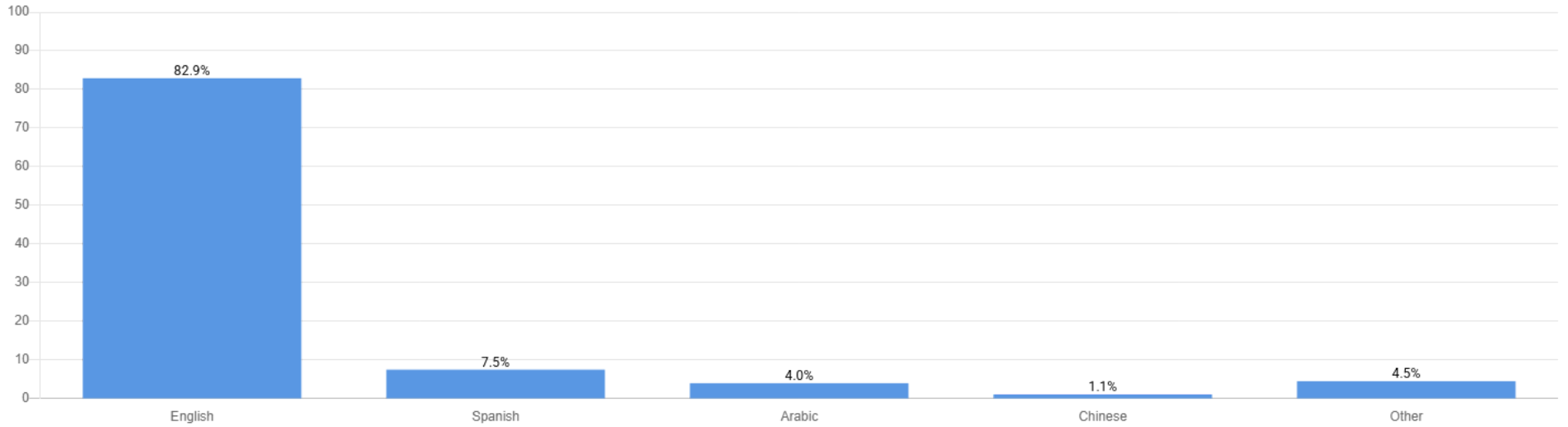

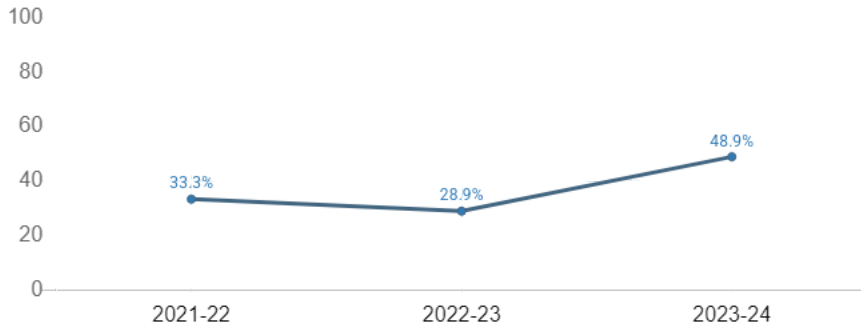

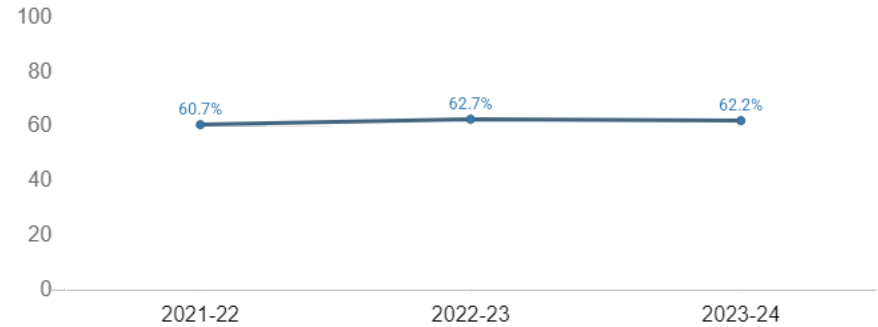
English Language Arts and Mathematics Performance Trends

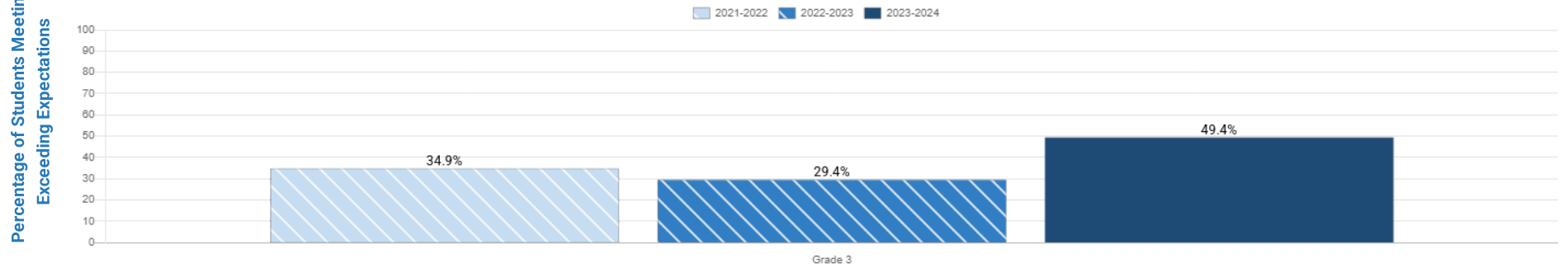

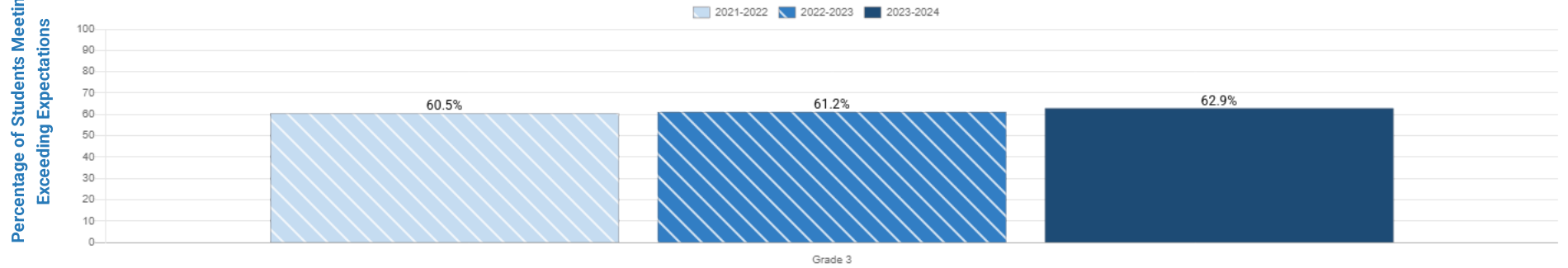

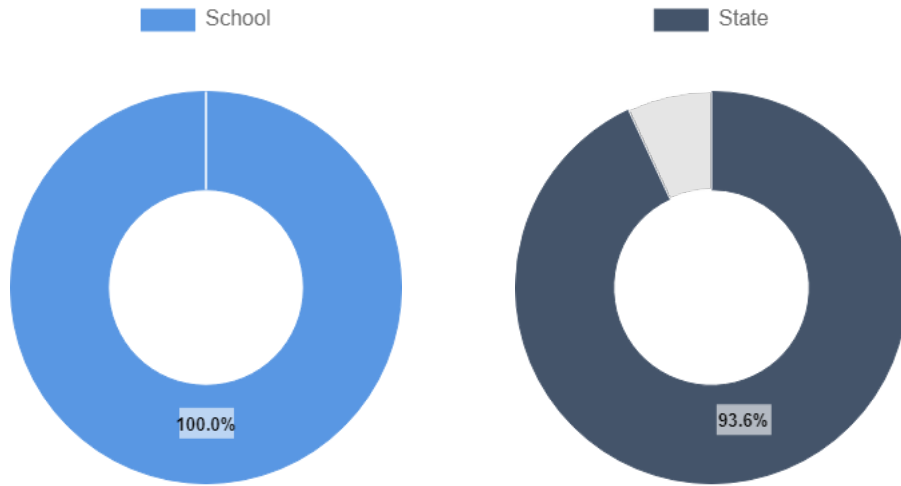

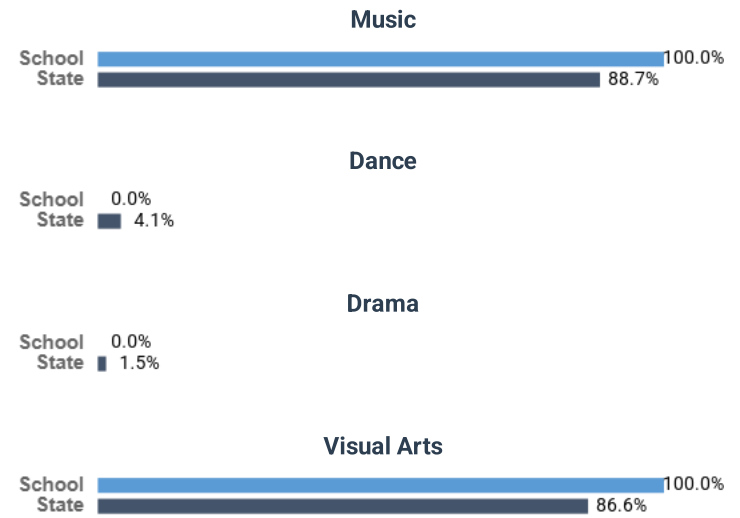

Students enrolled in one or more classes by discipline:



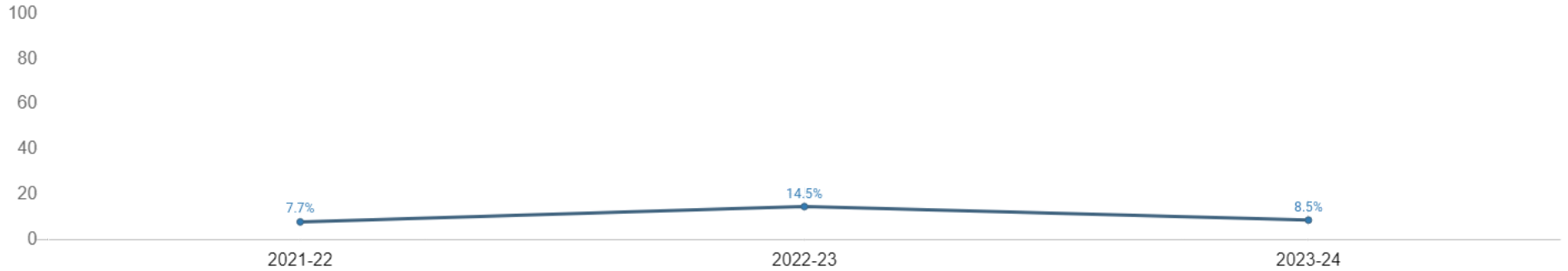
Climate and Environment

Student absences provide important information about a school's culture and climate. Research shows that absences impact a student's ability to succeed in school. The NJDOE used input from stakeholders to select chronic absenteeism as its measure of school quality and student success for the ESSA accountability plan. **Chronic absenteeism** is defined as being absent for 10% or more of the days enrolled during the school year. A student who is not present for any reason, whether excused, unexcused, or for disciplinary action, is considered absent unless permitted by state statute or regulations. Students with fewer than 45 days in membership are excluded from attendance calculations.

Chronic Absenteeism Trends

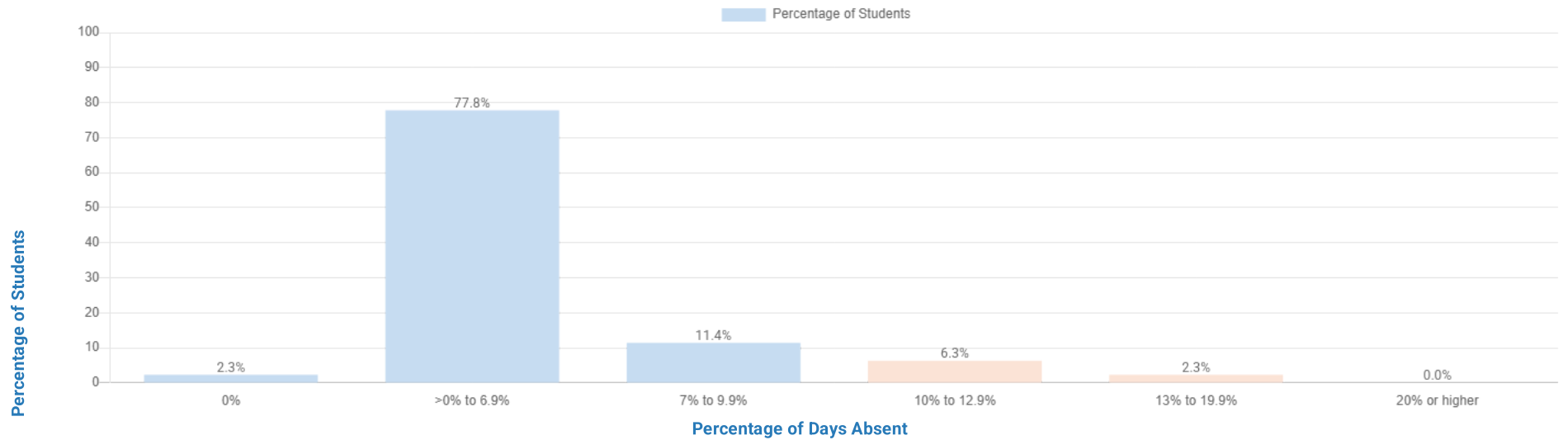

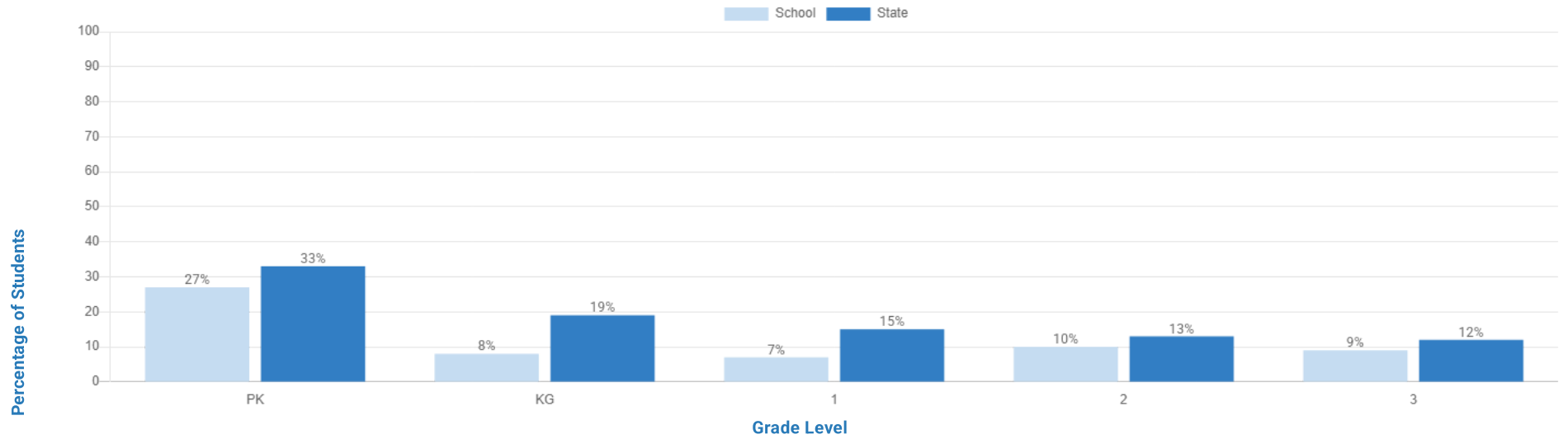

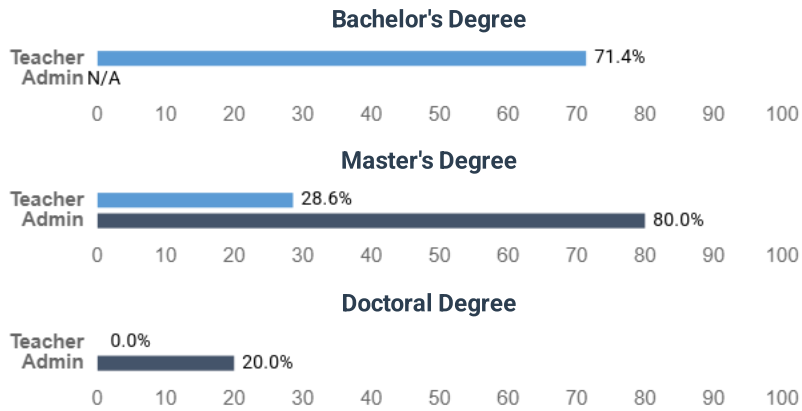

Early Childhood Education:

Milltown has 2 pre-K programs for special education and general education populations. Milltown additionally has included two other special education programs. A K-3 Autism room and K-3 LLD room. The Autism room is ABA-based and uses an AAC (augmentative alternative communication) approach to teaching language and also occupational and physical therapies. The LLD class has a specifically modified curriculum combined with ABA based practices as well. The preschool integrated half-day program integrates both special and general education students which follows Creative Curriculum. Our full-day preschool disabled program is a classroom that only contains preschool students with disabilities who work intensively with discrete trials and ABA style strategies. Parkview offers a full day Kindergarten program that reflects a balance of child-initiated and teacher guided learning activities introduced in a variety of formats, and embedded across curricular domains.
