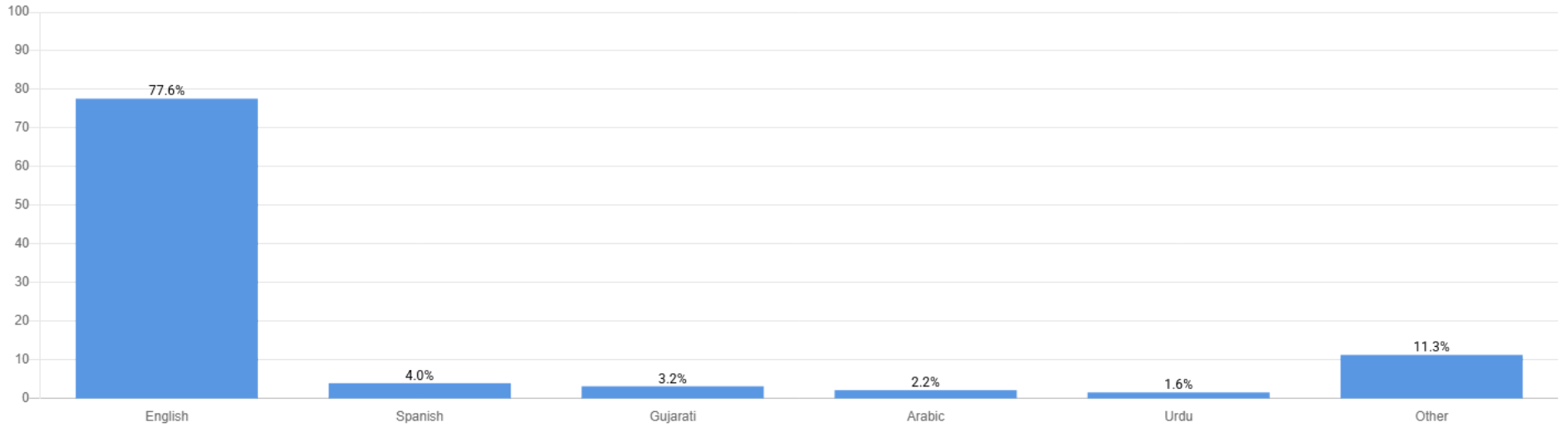

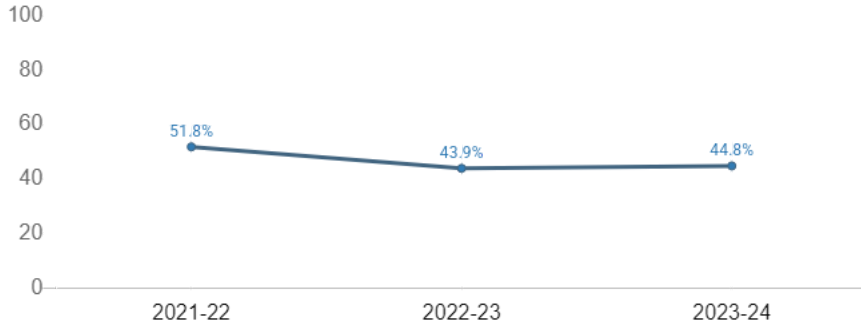

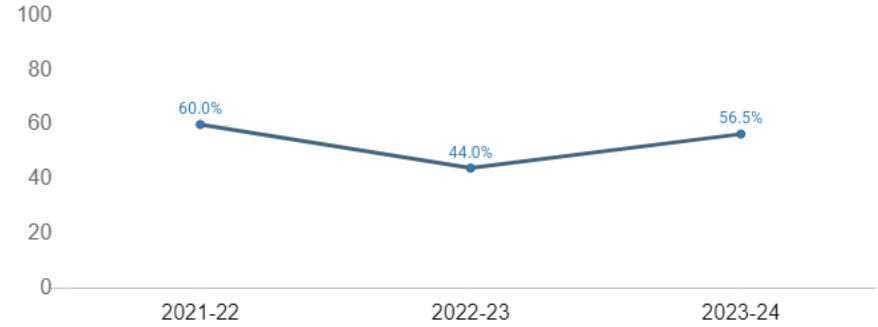
English Language Arts and Mathematics Performance Trends

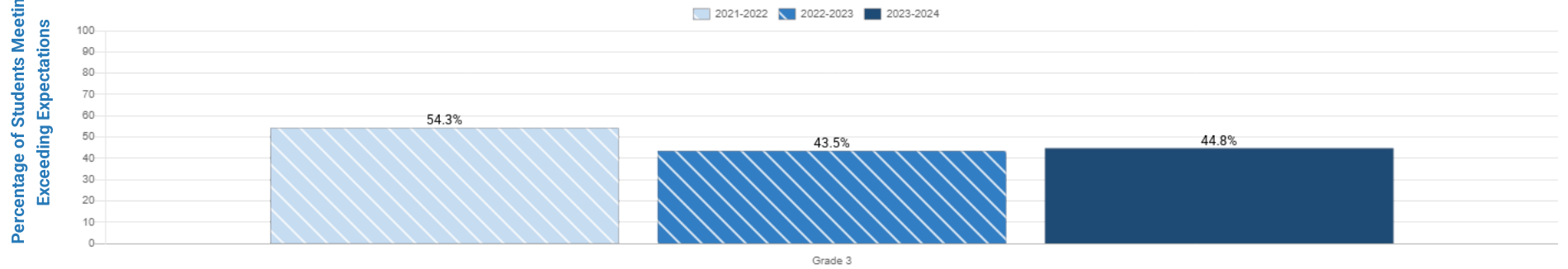

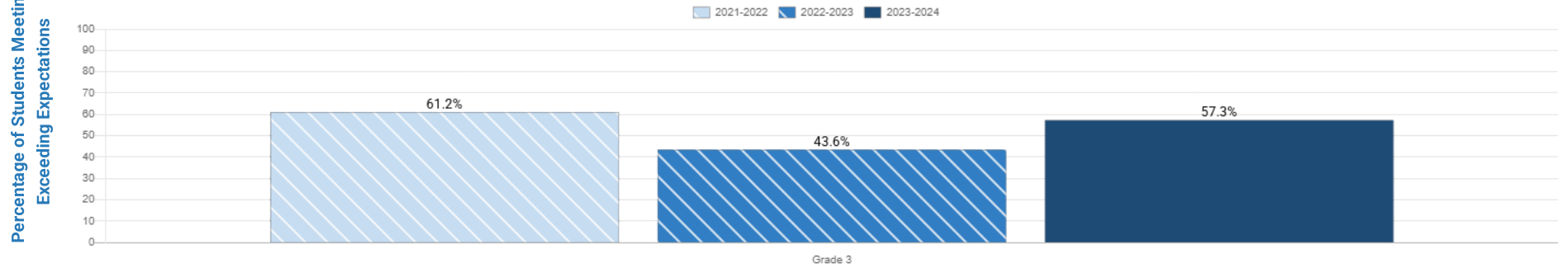

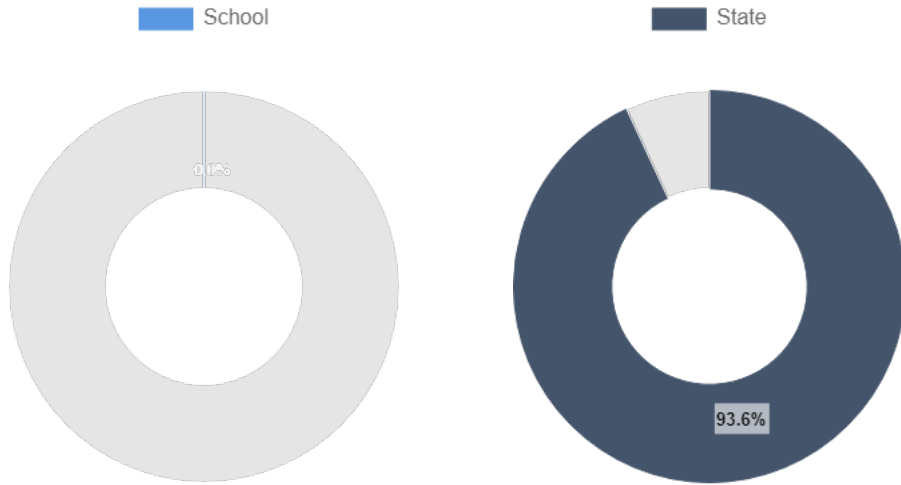

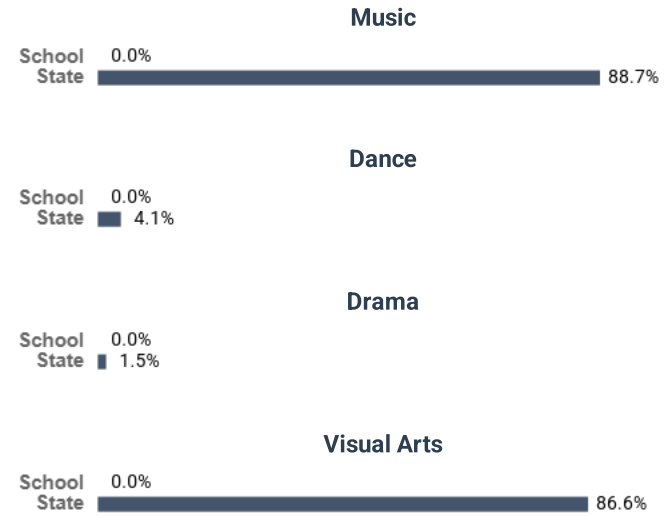

Students enrolled in one or more classes by discipline:



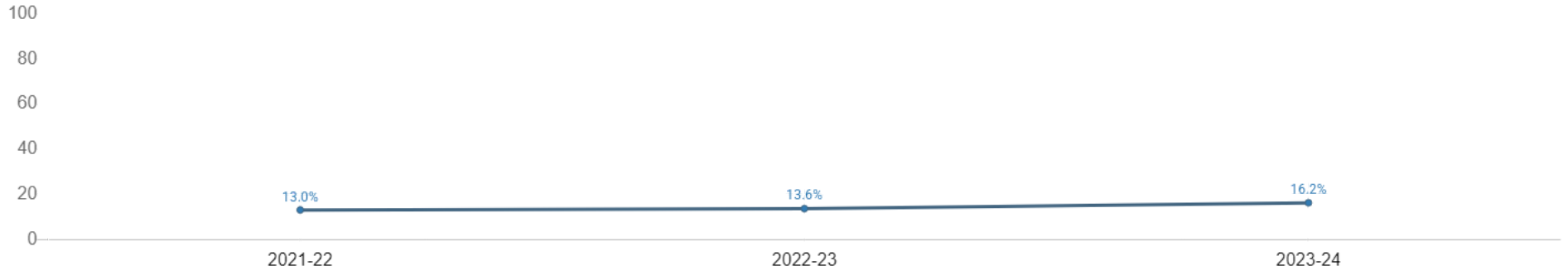
Climate and Environment

Student absences provide important information about a school's culture and climate. Research shows that absences impact a student's ability to succeed in school. The NJDOE used input from stakeholders to select chronic absenteeism as its measure of school quality and student success for the ESSA accountability plan. **Chronic absenteeism** is defined as being absent for 10% or more of the days enrolled during the school year. 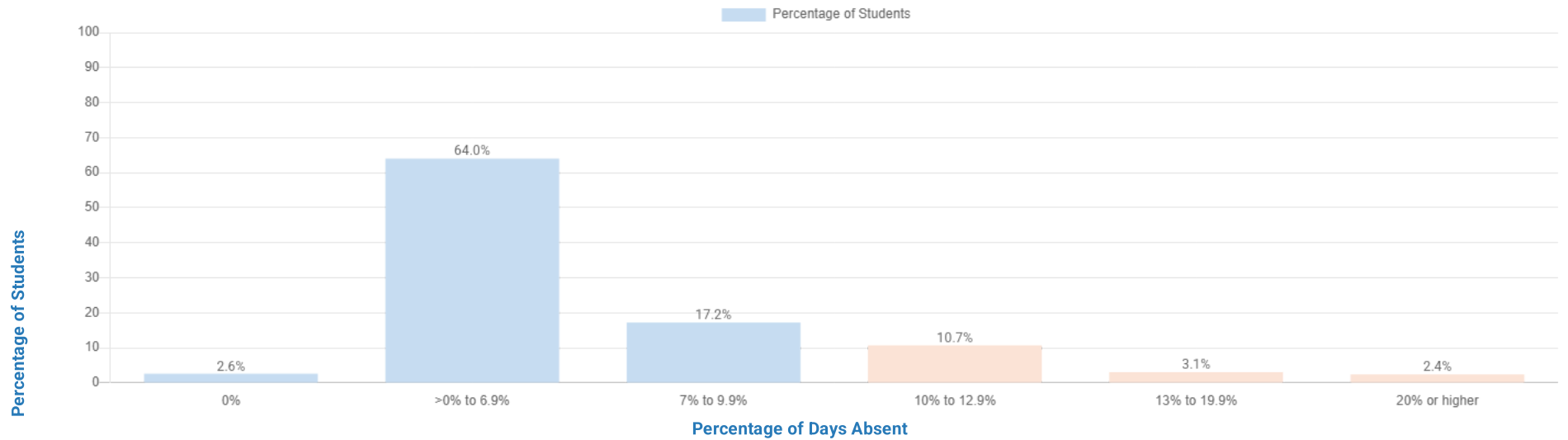

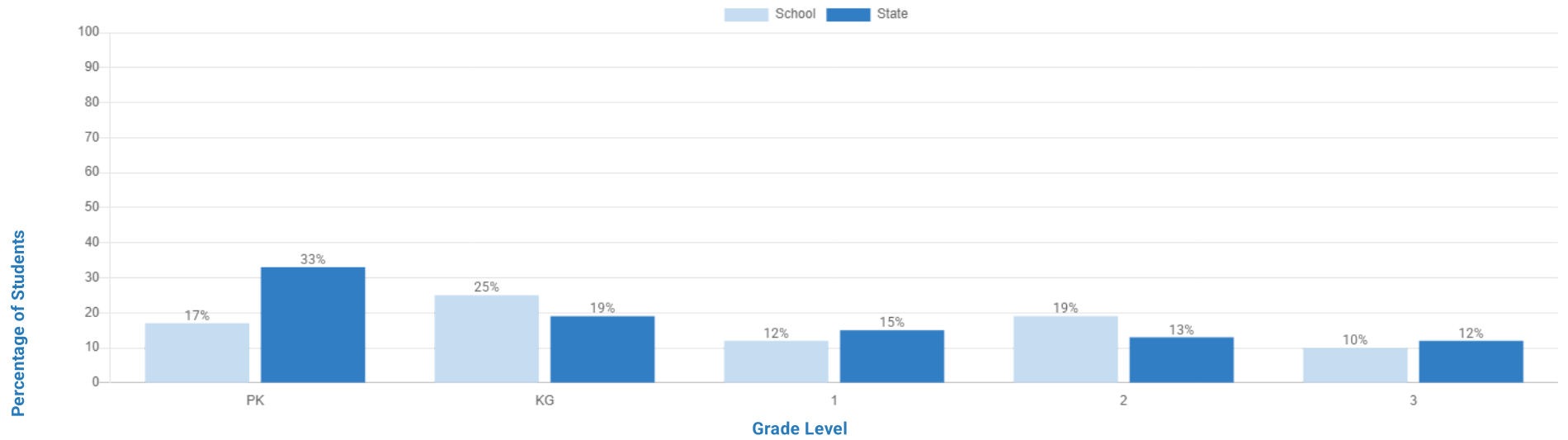

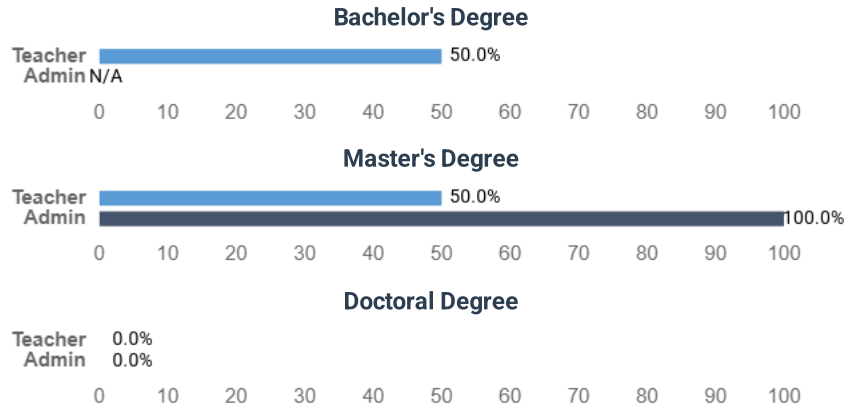

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Courses, Curriculum, Instruction:

Curriculum is current and aligned with the New Jersey Student Learning Standards. Teachers infuse technology throughout their instructional programs allowing students to reach beyond the confines of their classroom walls. STEAM experiences are incorporated into lessons within the classroom and the STEAMaker Lab, which enhances critical thinking and problem solving skills, preparing students to be successful 21st century thinkers and innovators. Cluster grouping is available for gifted and advanced learners.

Staff and Professional Learning:

Our district's Professional Development Plan provides multiple learning opportunities for staff members and stresses a personalized professional development experience. Collaborative planning opportunities are afforded to staff. The school Social and Emotional Learning Team supports the district SEL and Whole Child Initiative within the school.

Student Supports and Services:

Multi-Tiered Systems of Support (MTSS) provides educators with strategies and supports to assist students who require additional academic and behavioral assistance. Basic Skills teachers and a Reading Specialist provide additional support in the areas of Language Arts and Math. Special education services are available based on student need, as recommended by the child study team. Social and emotional needs are supported through guidance and counseling services. Support services are available for English Language Learners.



Student Health and Wellness:

A wellness council meets to promote healthy living practices including mental, nutritional, and physical health throughout the school year culminating with the annual School Wellness Week. Health office services are available based on student need, including routine vision and hearing screenings. Student physical activity occurs during Physical Education classes and recess.



Parent and Community Involvement:

An active PTO supports the school by providing educational assemblies, teacher grants, and charitable benefits for our community. American Education Week, Parent/Teacher conferences, Family Nights, and classroom celebrations provide opportunities for families to collaborate with the school. Early Childhood Education:

Mill Lake School offers a 2.5 hour Integrated PreSchool Program that is open to all township 3 and 4 year old children. Enrolled students pay tuition to attend an AM or PM session. There is currently a waiting list for our integrated PreSchool Program. PreSchool students who qualify for special education instruction are enrolled tuition-free. A 5.5 hour PreSchool Program is offered tuition-free for students with special needs who require a longer instructional day.
