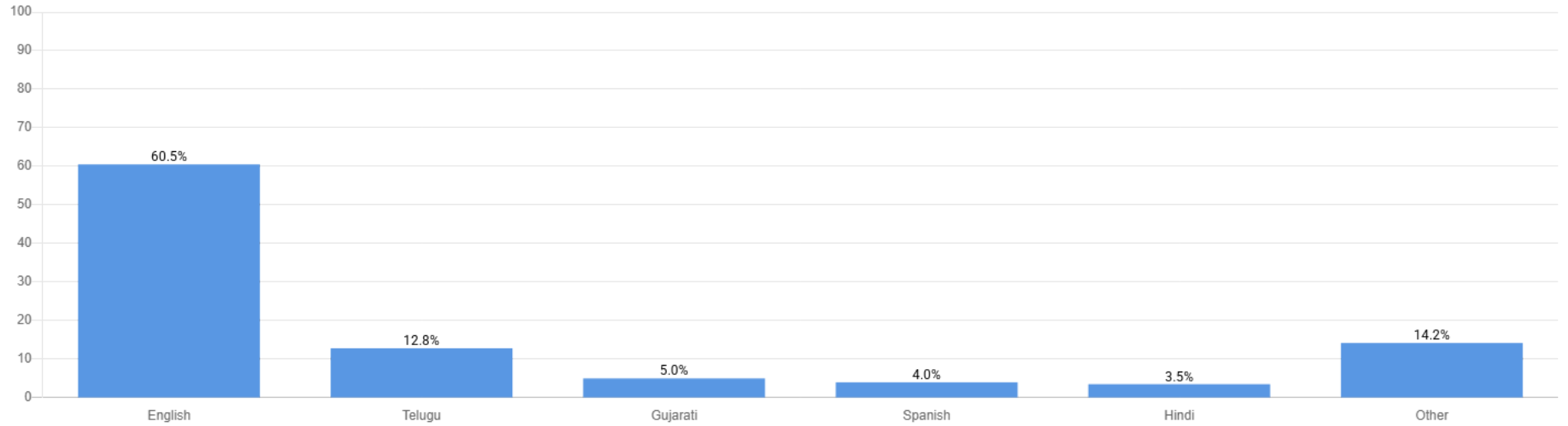

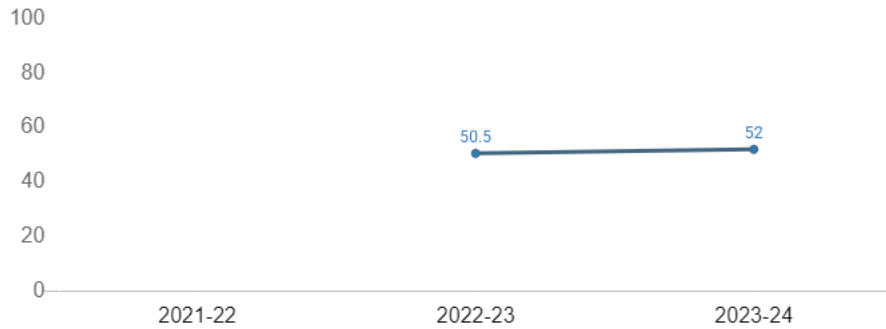

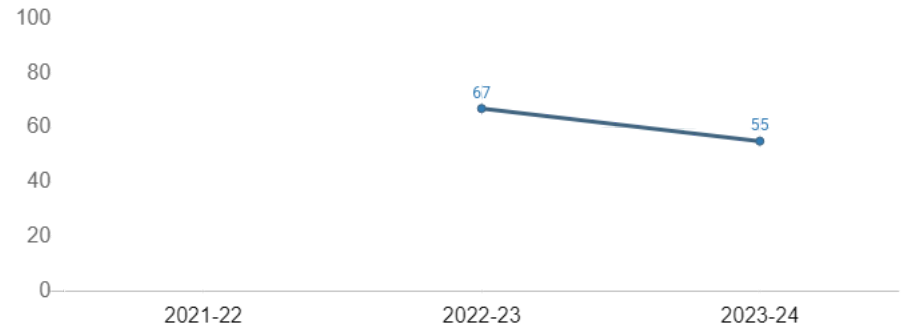

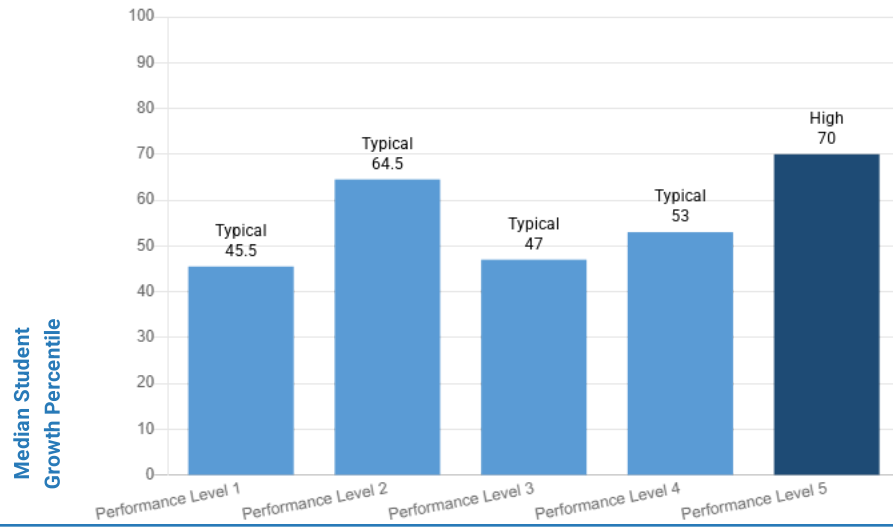

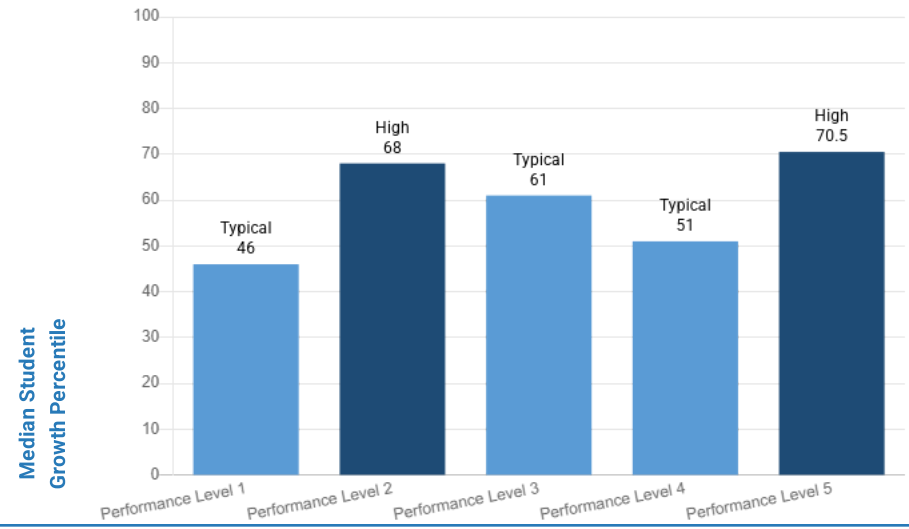

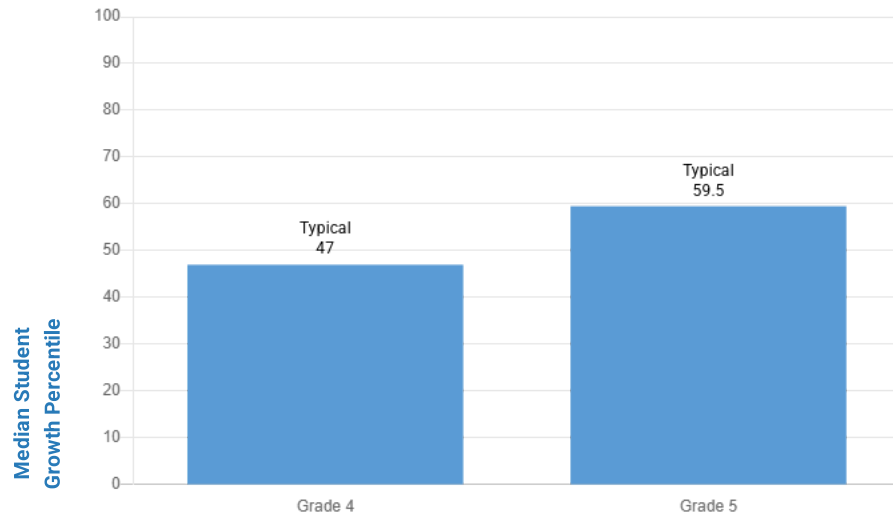

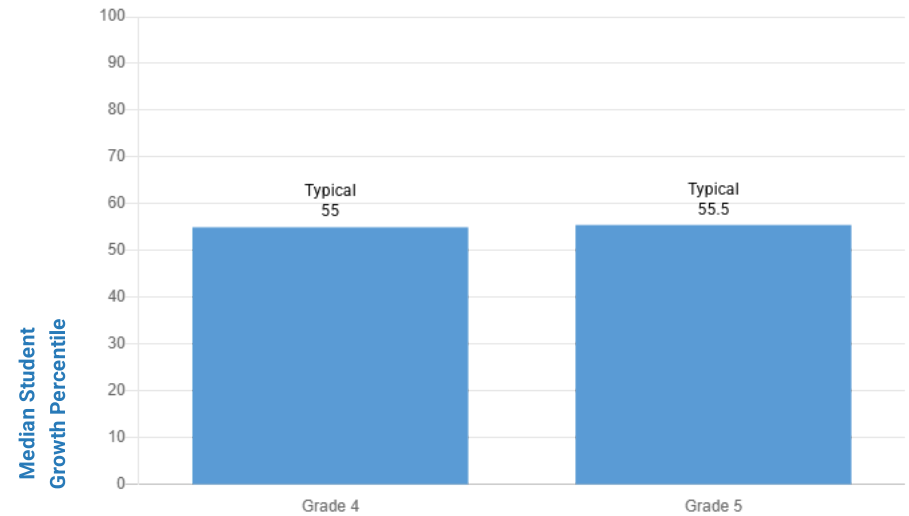

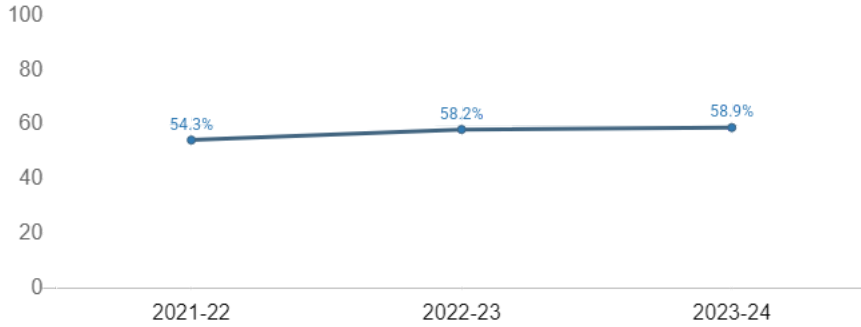

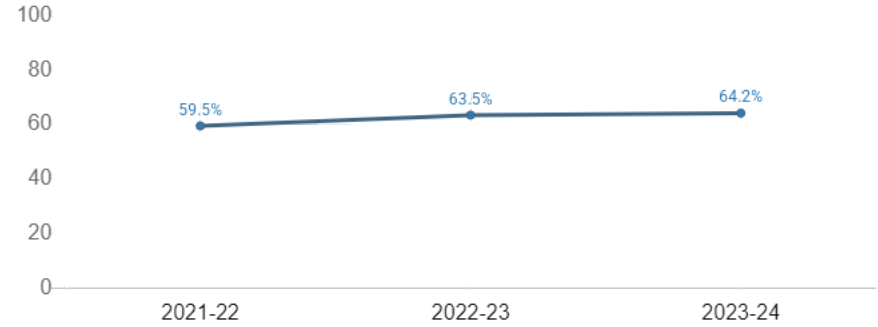
English Language Arts and Mathematics Performance Trends

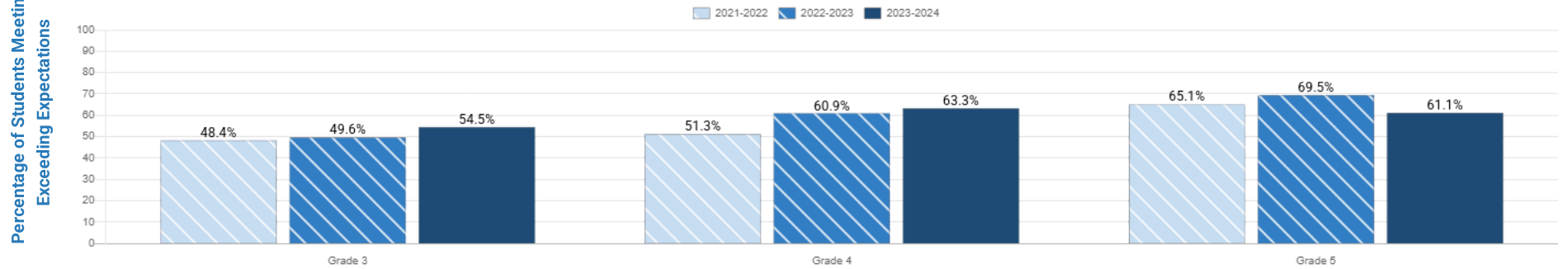

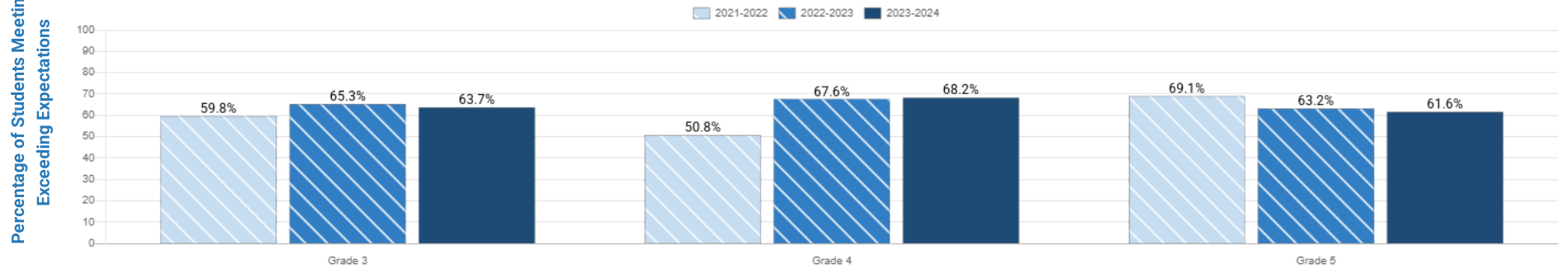

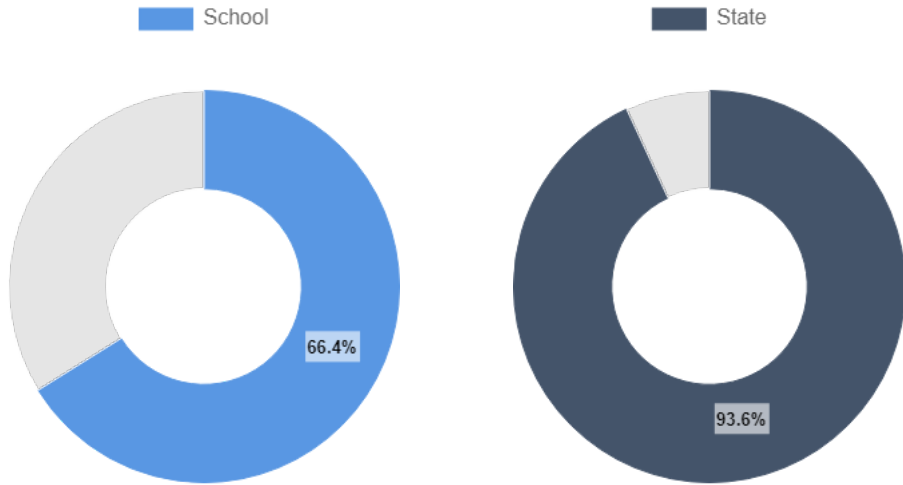

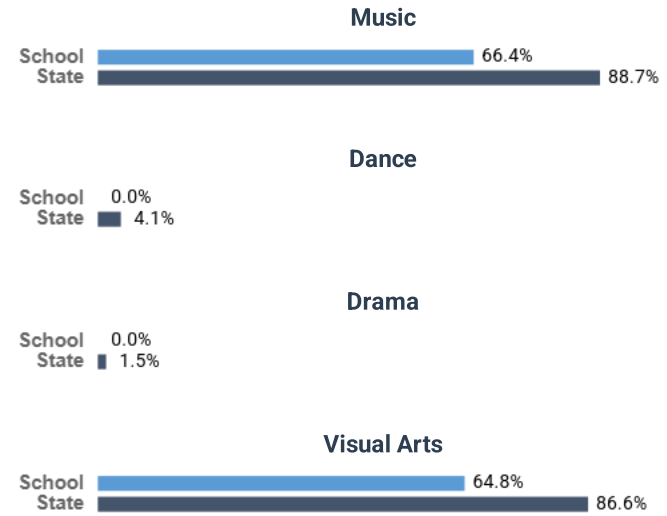

Students enrolled in one or more classes by discipline:



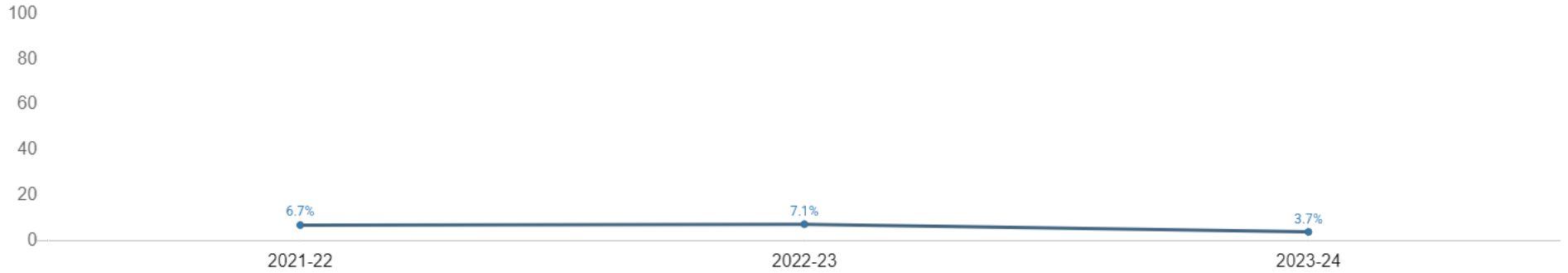

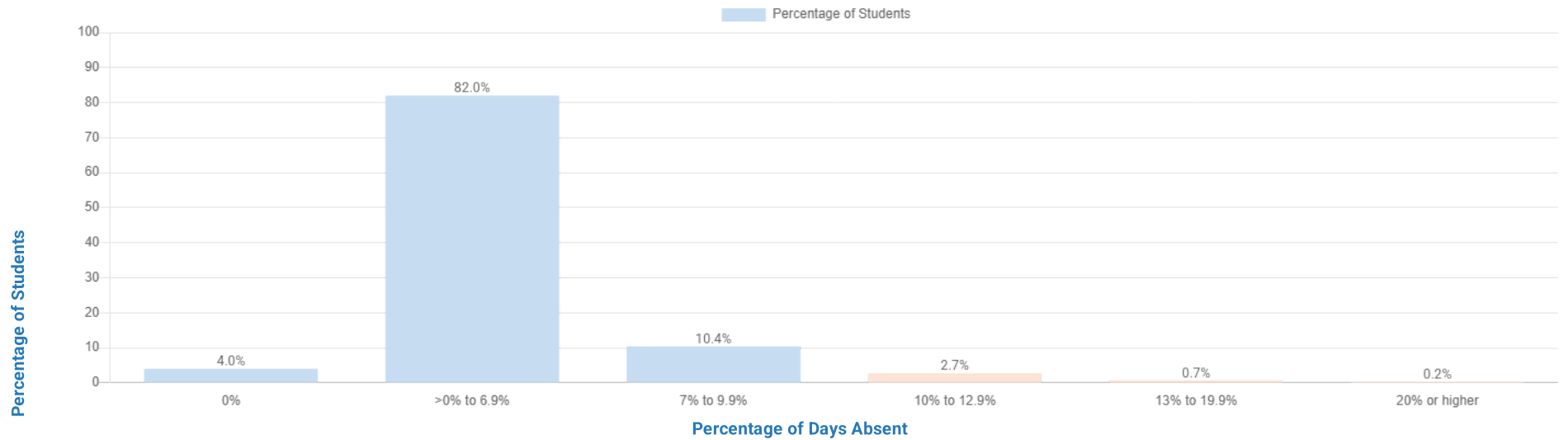

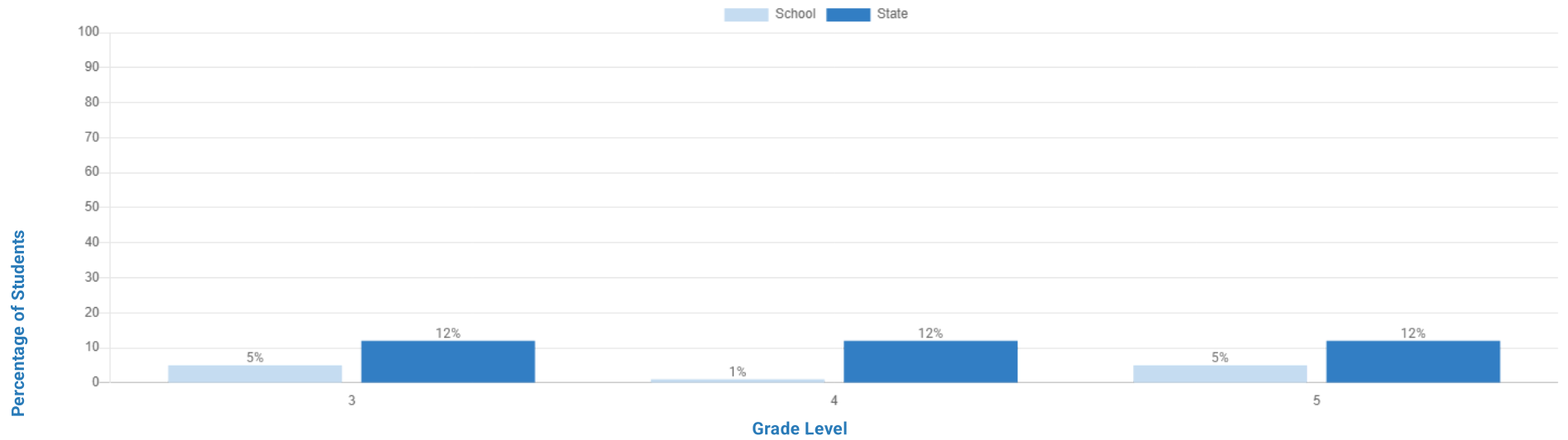

Staff

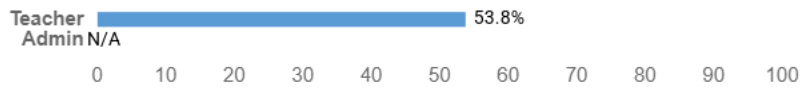

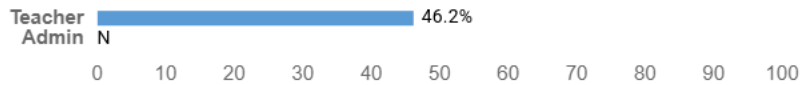

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Technology and STEM:

STEAM experiences are incorporated into lessons within the classroom and the maker space area of our Media Center. Our school librarian facilitates maker opportunities for all grades. A Family Math Night is offered during the year. Students have access to Chromebooks and iPads throughout the instructional day. A zero period coding class is offered, in addition to an after school Club Code program with Vex robotics.
