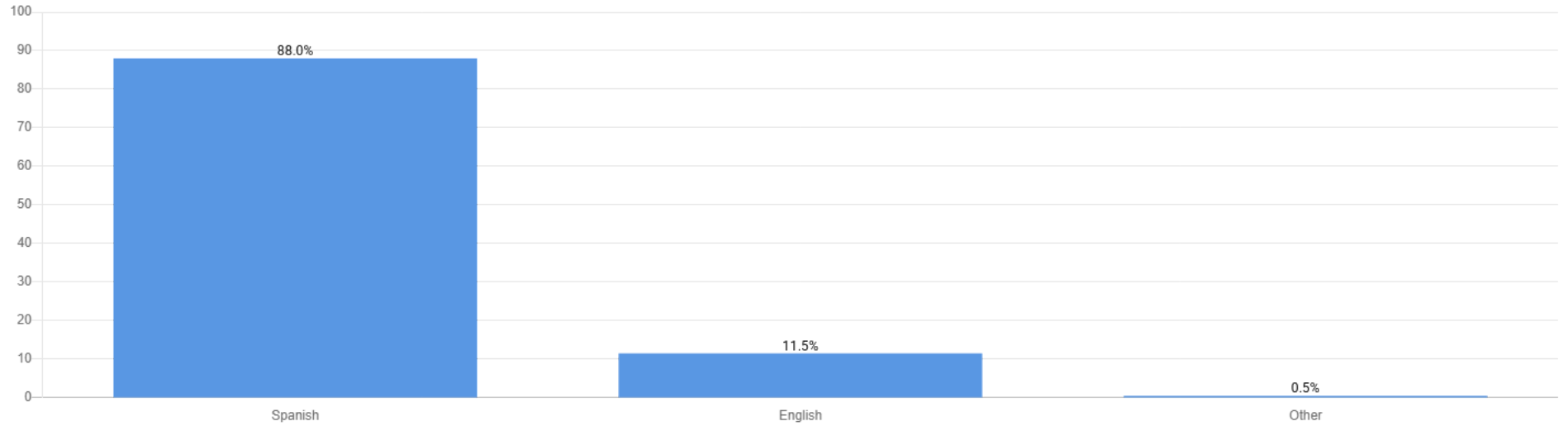

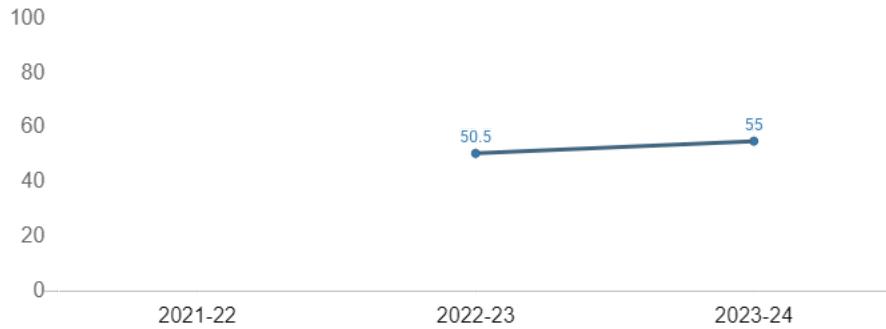

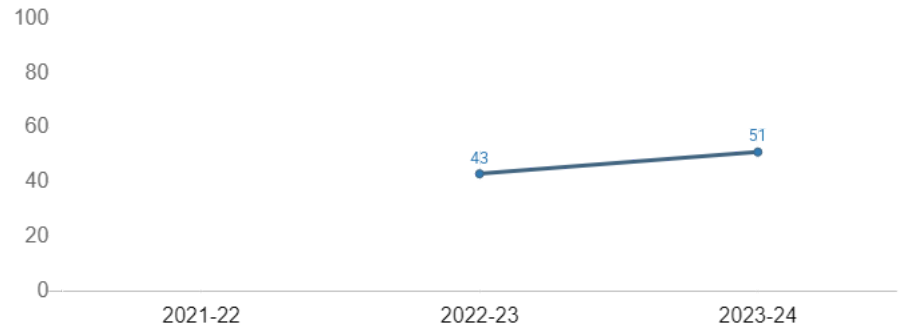

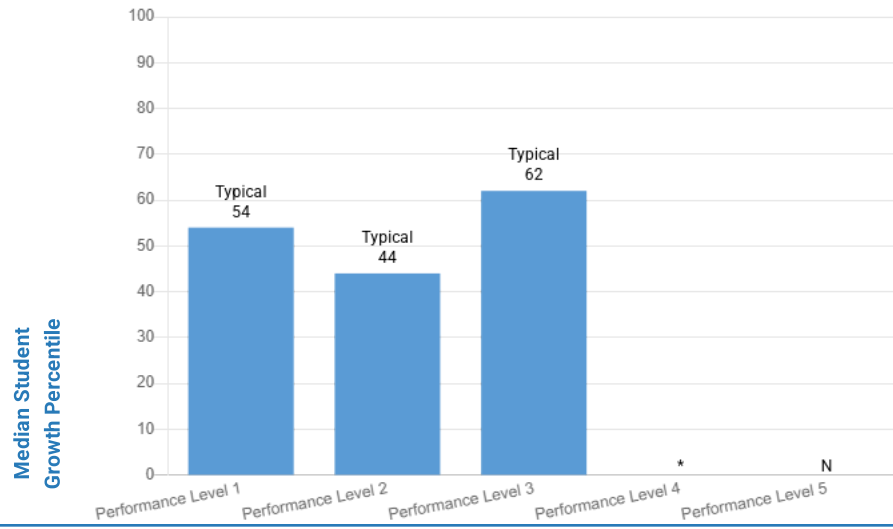

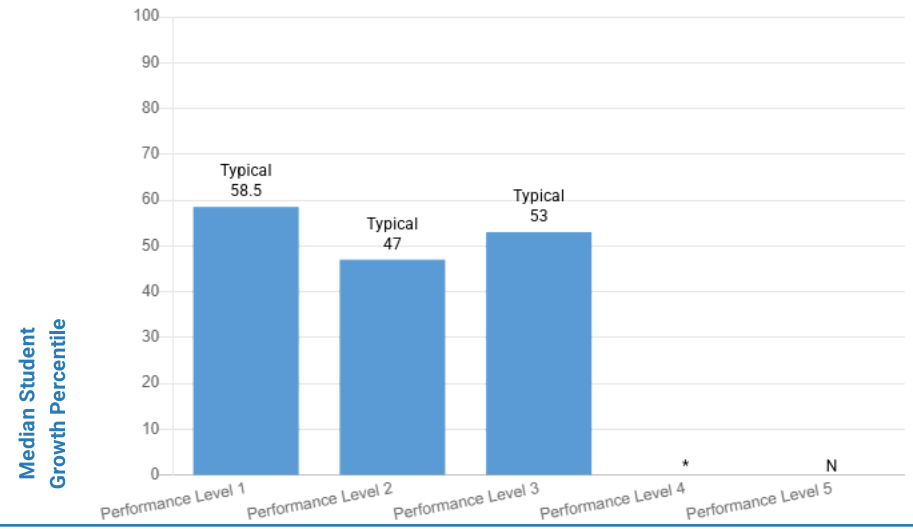

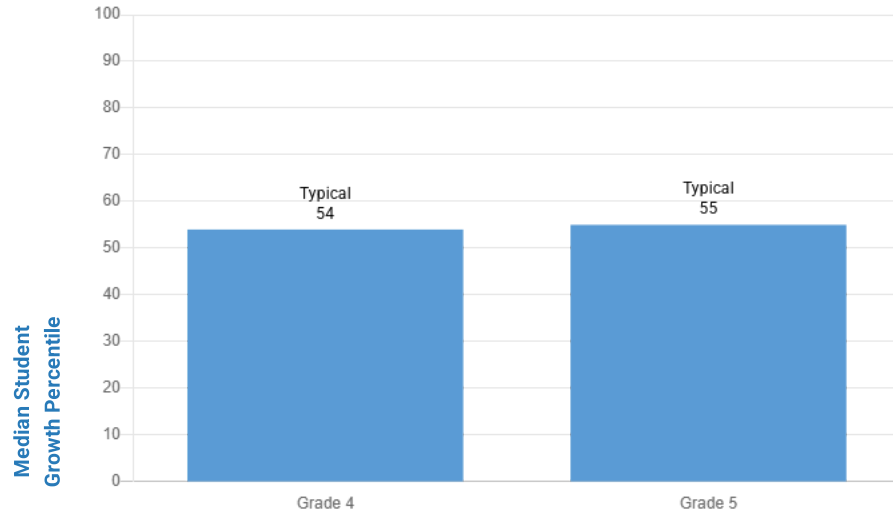

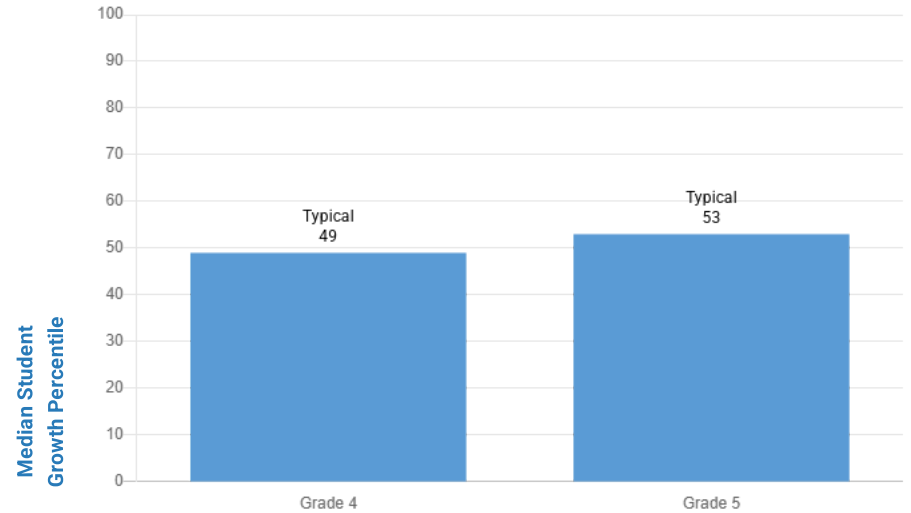

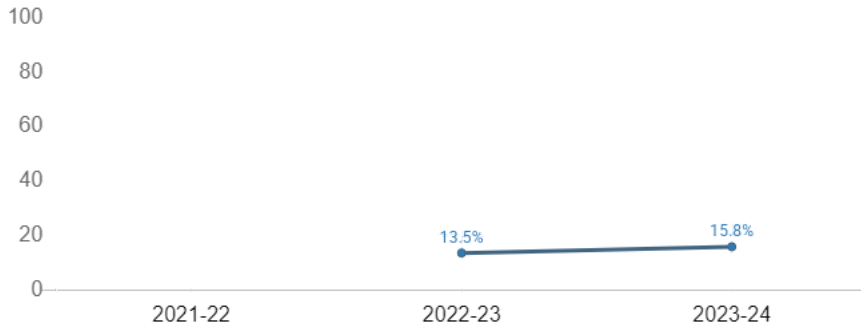

English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. 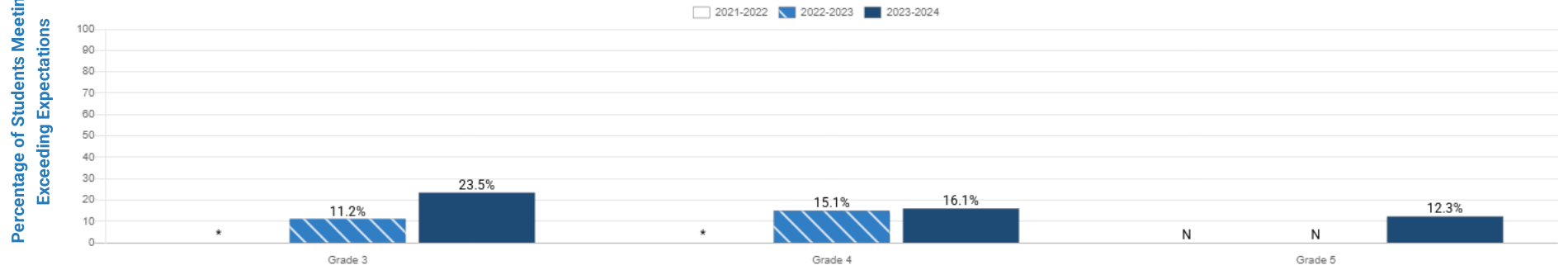

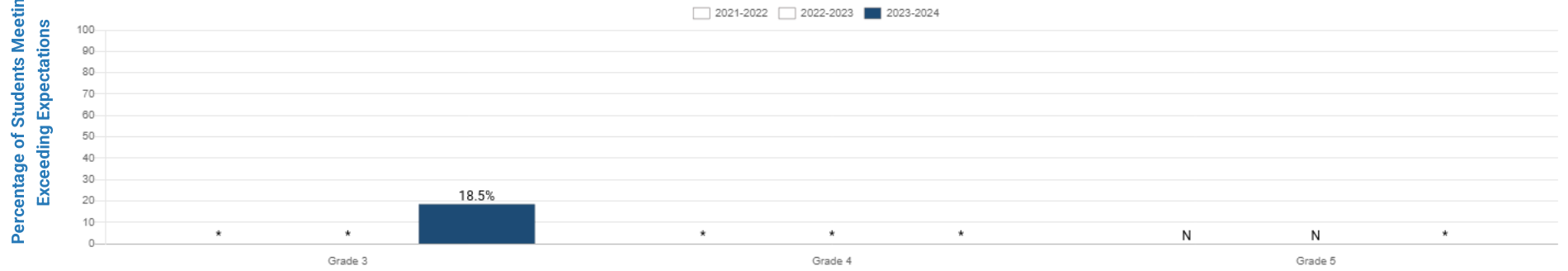

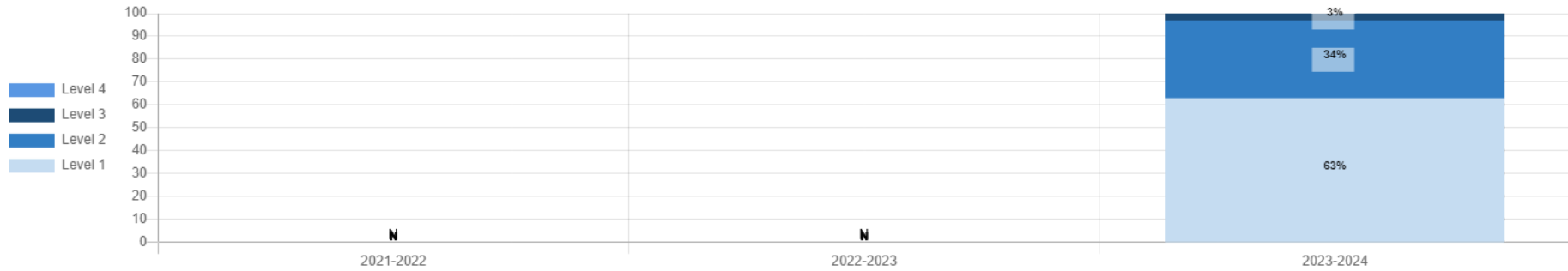

Students enrolled in one or more classes by discipline:



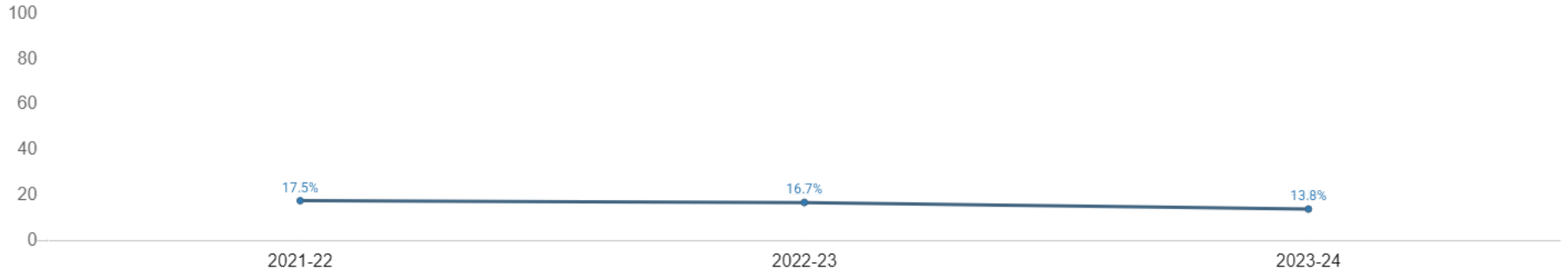

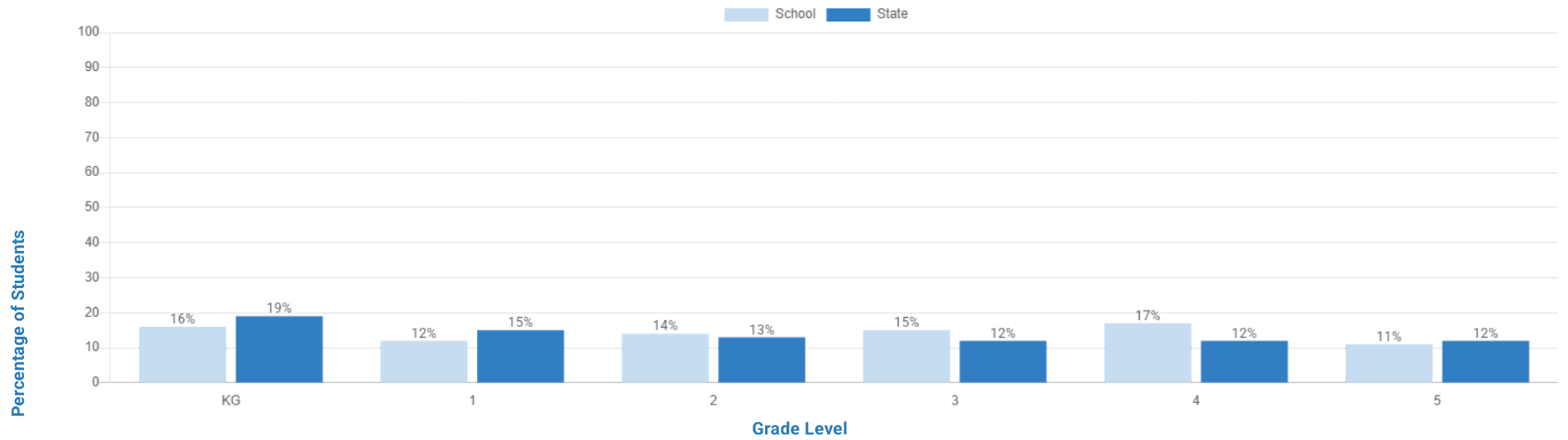

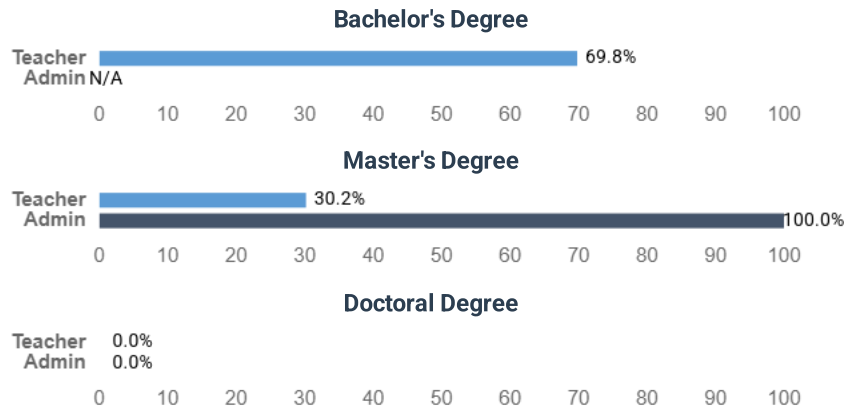

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. Lincoln Elementary School offers Basic Skills Instruction, Speech, Bilingual and ESL classes, In-class Support, OT/PT, An after-school tutoring program is always available as well as a Summer school program for intervention and enrichment. All students participate in our district's Breakfast-in-the-Classroom program and receive free lunch. Students in Grades 3-5 have an intervention and enrichment block built into their classes 3 days a week.
