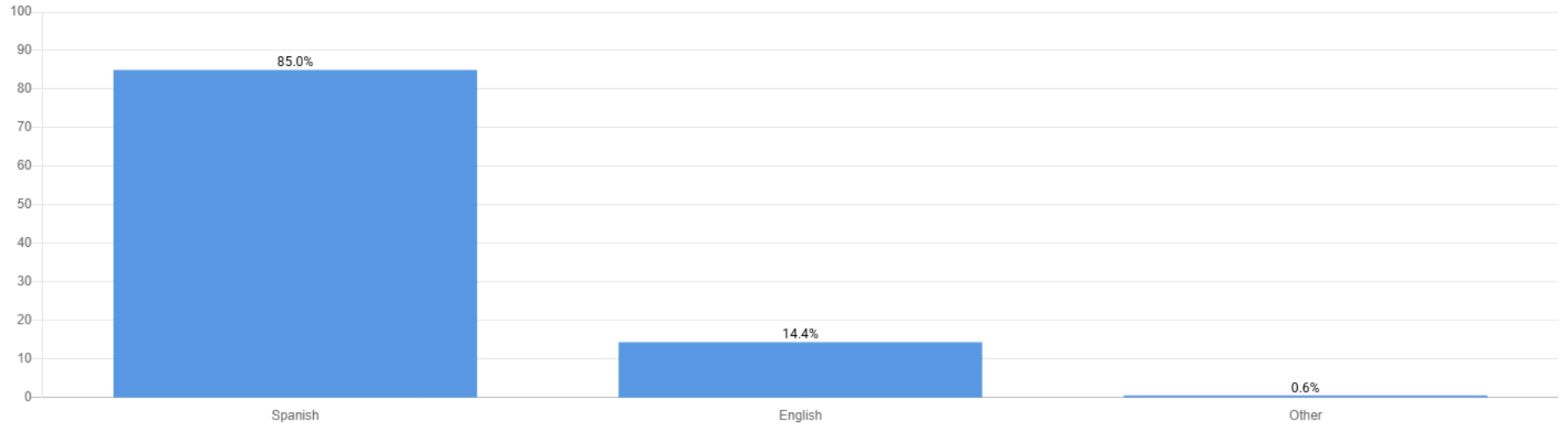

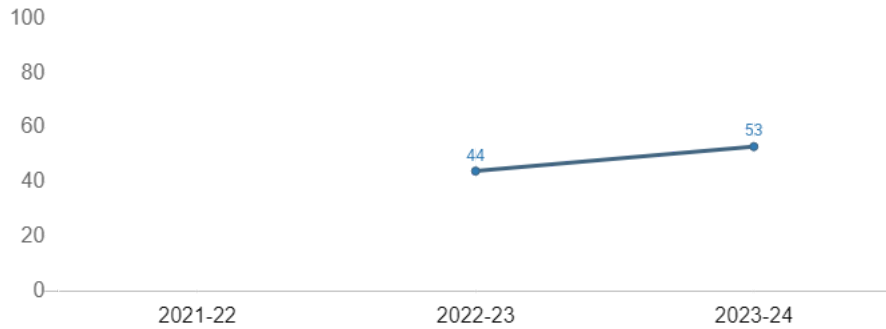

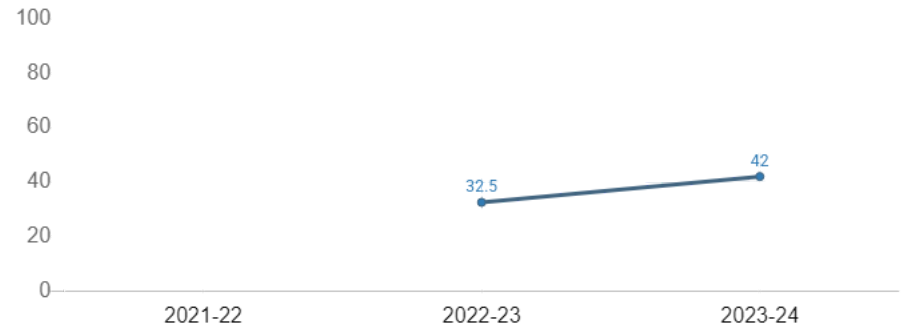

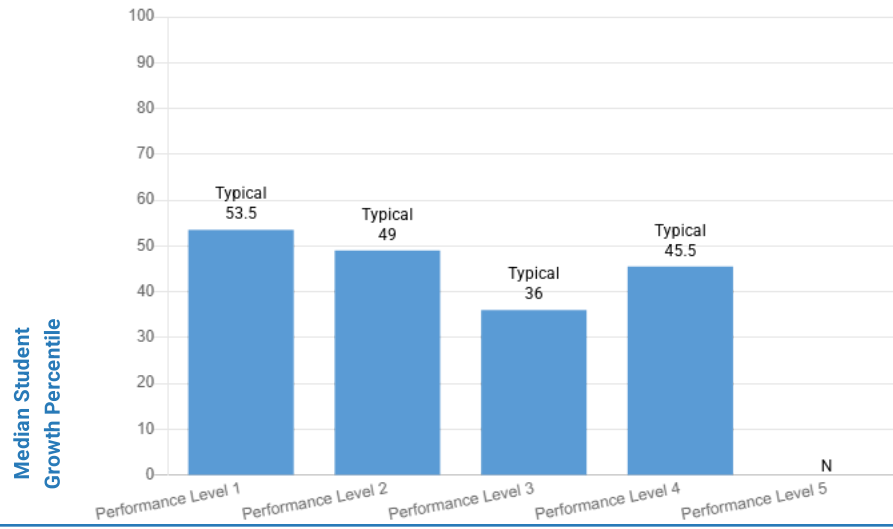

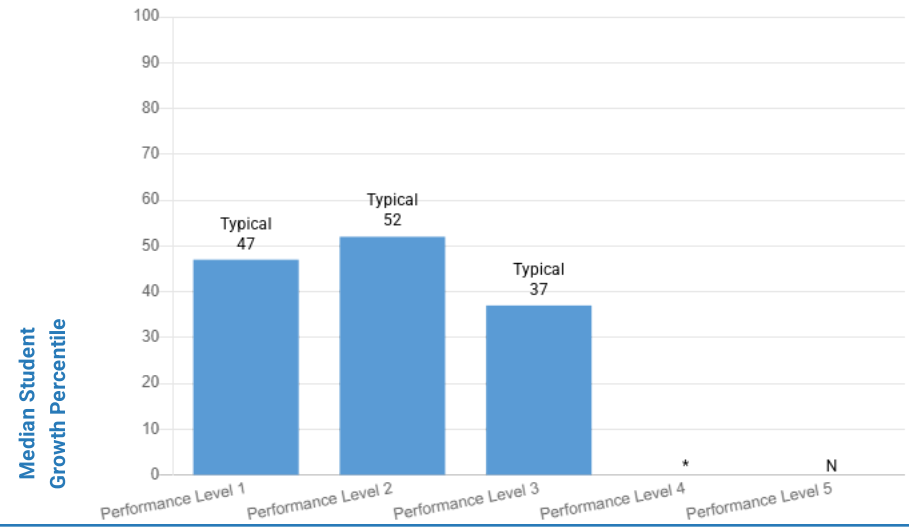

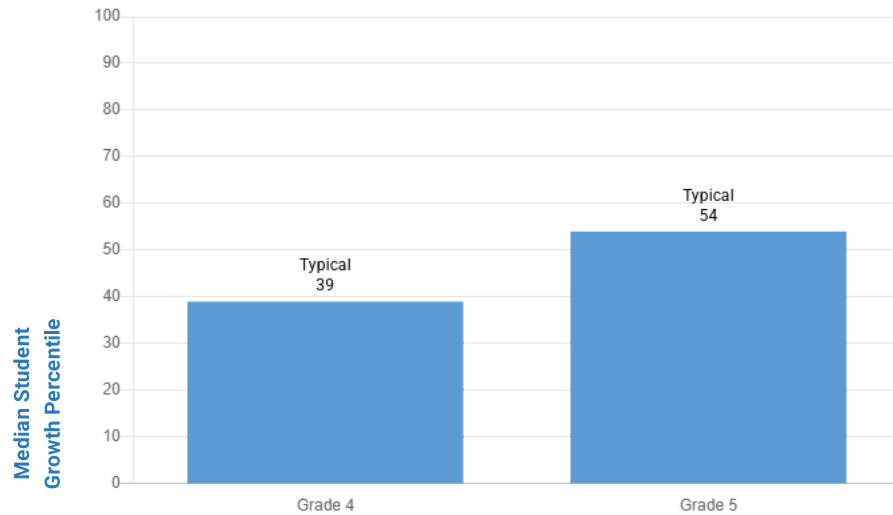

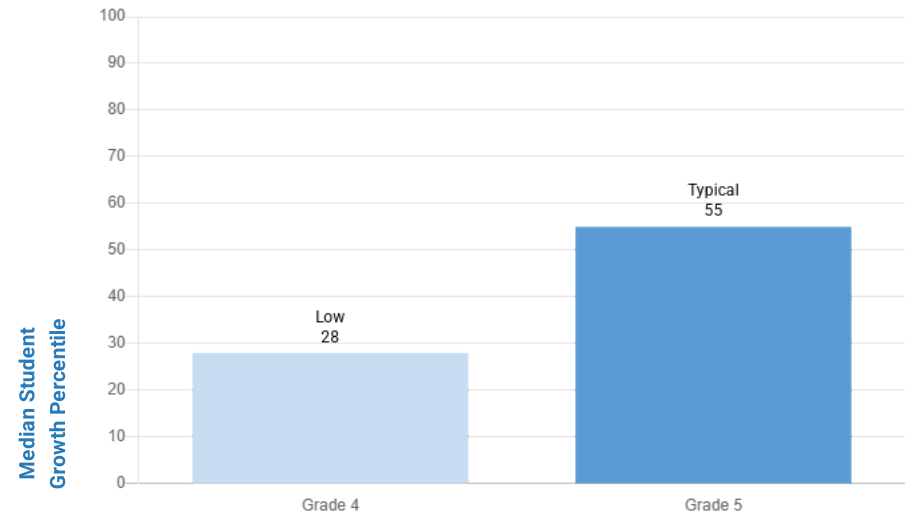

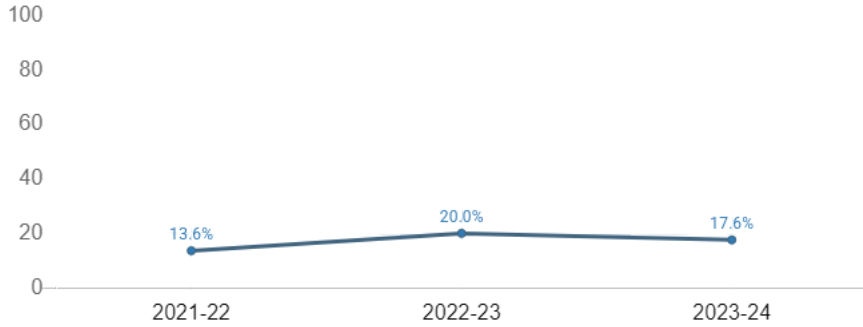

English Language Arts and Mathematics Performance Trends

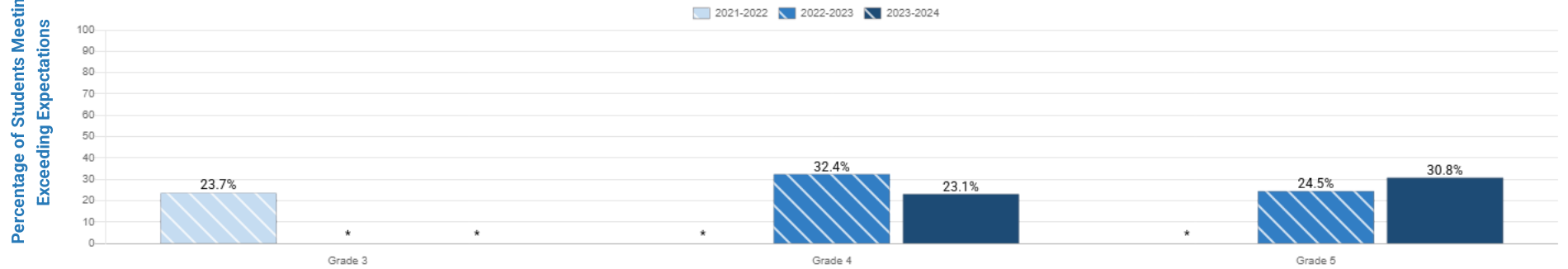

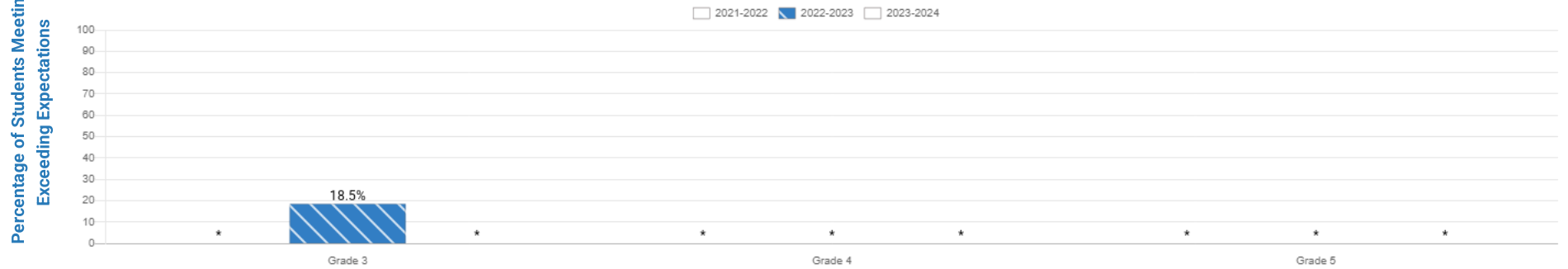

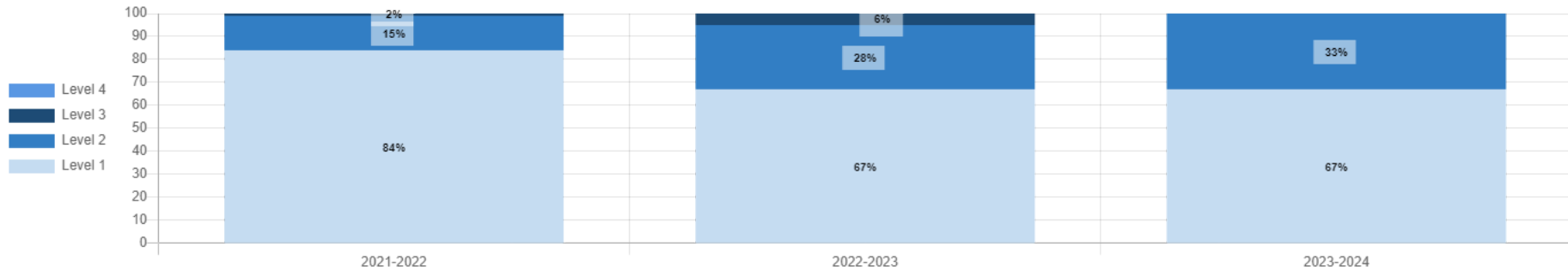

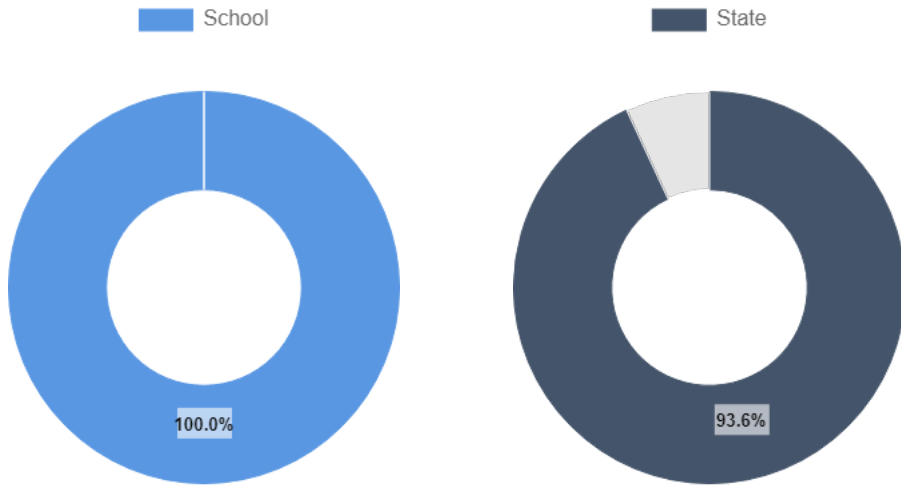

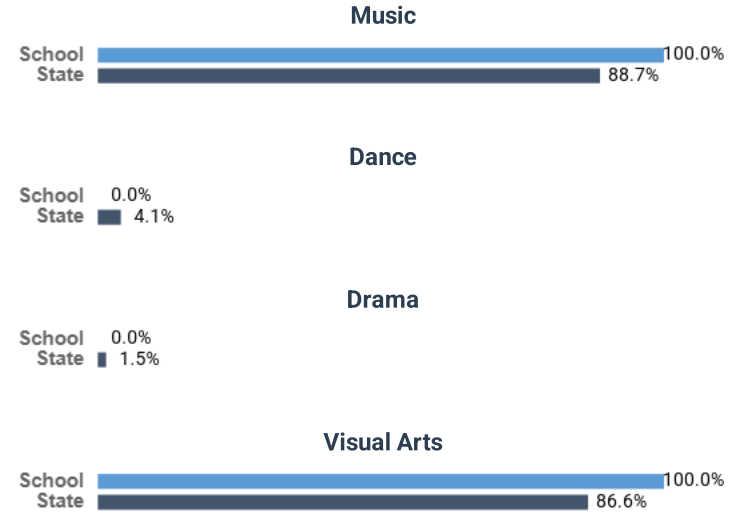

Students enrolled in one or more classes by discipline:



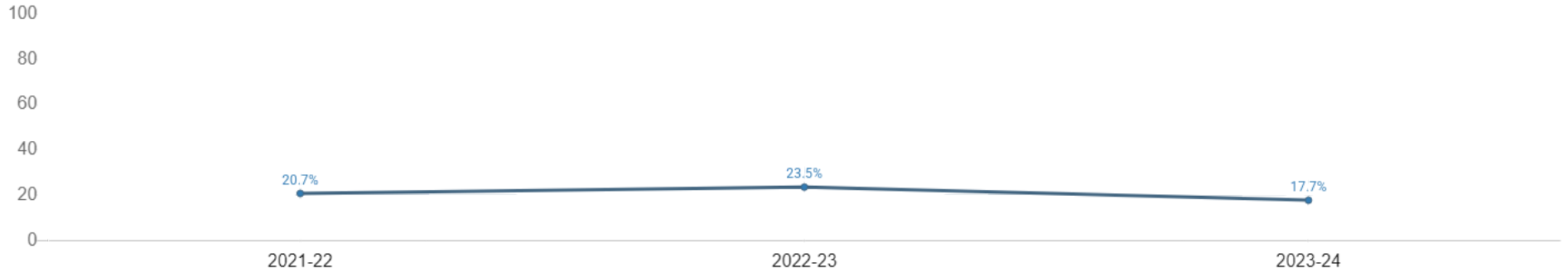

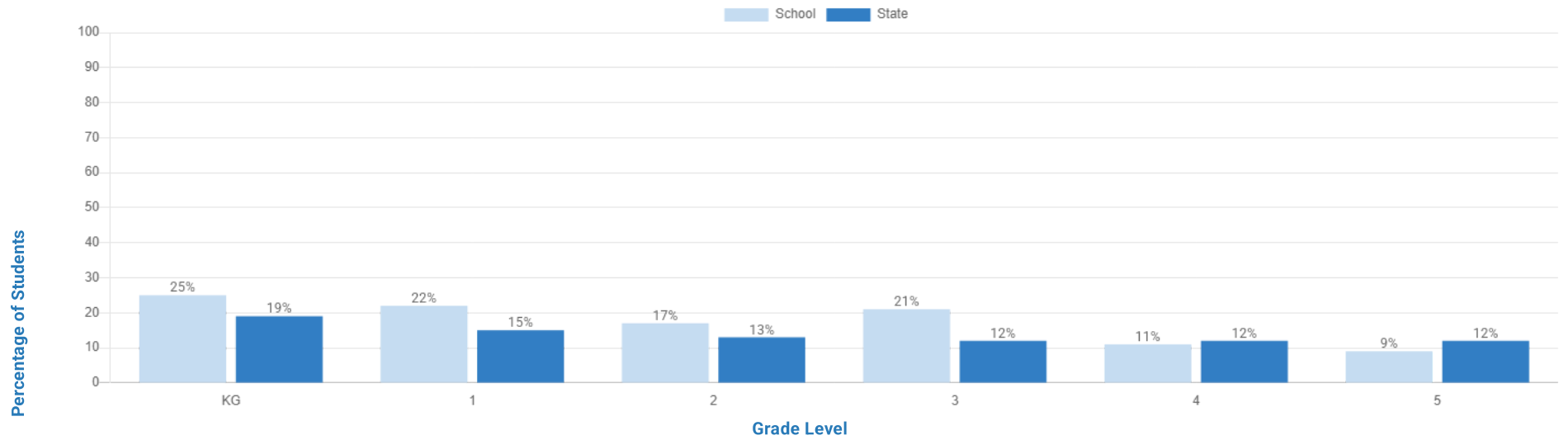

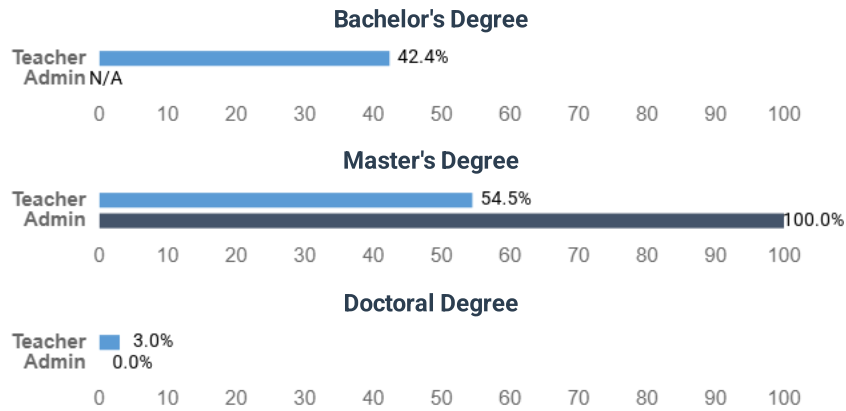

Accountability Summary by Student Group - 2023-24 School Year

Students in grades 3-5 can participate in Girls on the Run, while the Boys Fitness Club is available for 4th graders. Additionally, 4th and 5th graders can take part in Social Justice writing enrichment. Our 3rd graders benefit from creative dance classes as part of the district's Dance Power project. Fifth graders also engage in the DARE initiative, collaborating with our community police department to promote safe and healthy choices. These enrichment programs foster students' creativity, teamwork, and social responsibility, enriching their overall educational experience. "



Before and After School Programs:

Livingston provided an early literacy extended school day program for our youngest learner in grades K-2 to build foundational skills for reading success. Teachers participate and organize these programs and are dedicated to ensuring academic excellence for all students.

Student Supports and Services:

Livingston provides intervention for students through the school's small group instruction, Response to Intervention (RTI) and ESL services during the school day. We provide an Extended School Day Program to support our youngest learners with reading success and upper grade students in core subjects. We also partner with the community to provide tutoring services and after school programming. Our school also has a team of educators and specialists who help teachers provide supports and interventions for students. We have an I&RS team that works with teachers to provide strategies and assist with documentation throughout the process- before, during, and after meetings.



Student Health and Wellness:

Livingston School offers breakfast daily to all students. We have a counseling program which supports the district's social and emotional learning requirements and continues to utilize comprehensive anti-bullying through character education and conflict resolution strategies. Students engage in daily recess, as well as physical education and health classes on a weekly basis. Our Kindergarten students engage in play based activities as part of the Tools of the Mind curriculum.
