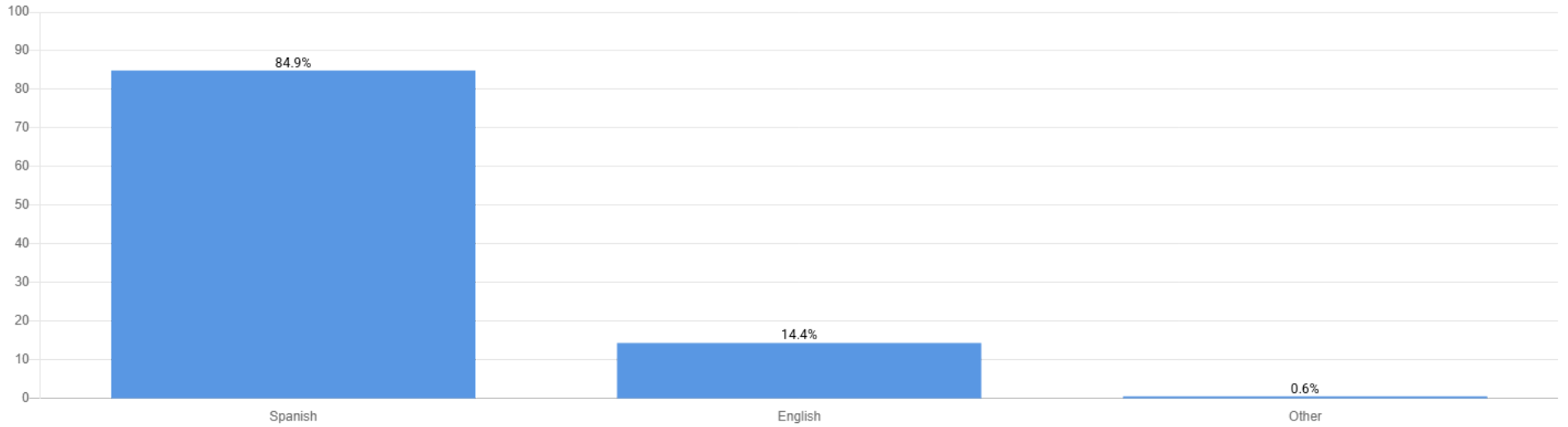

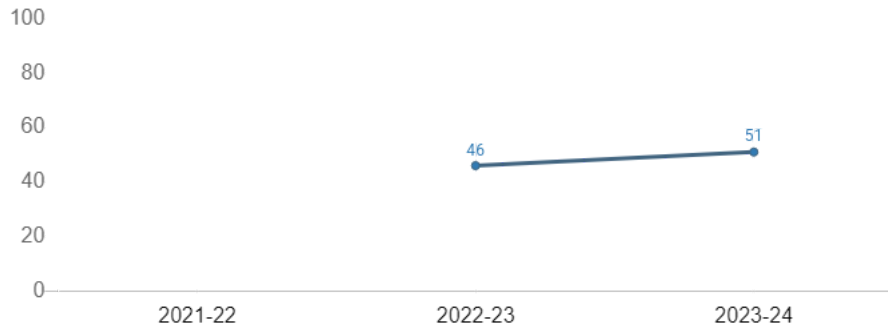

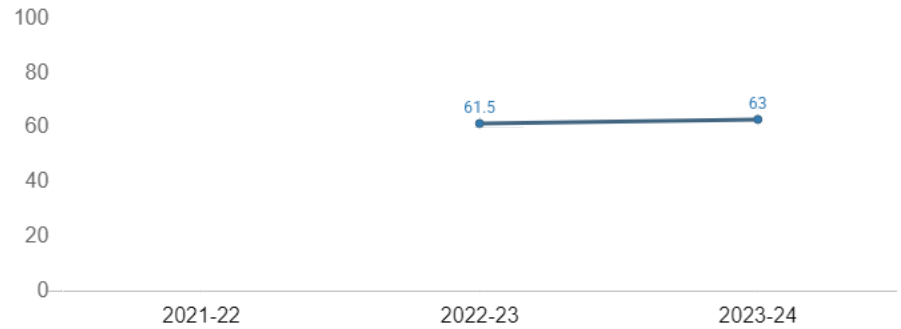

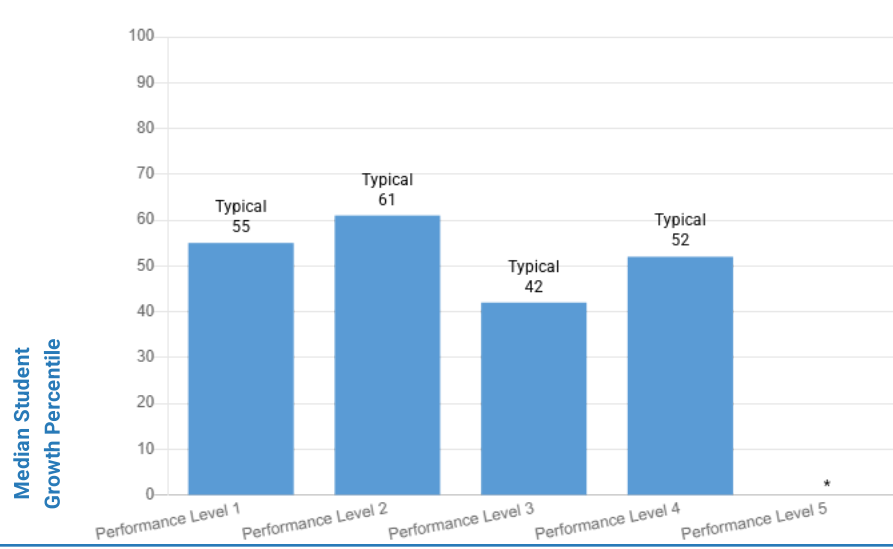

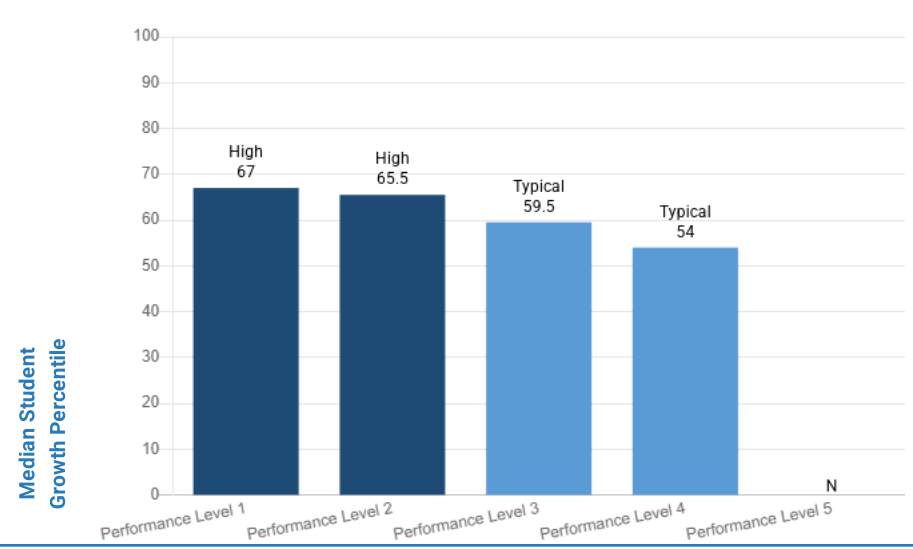

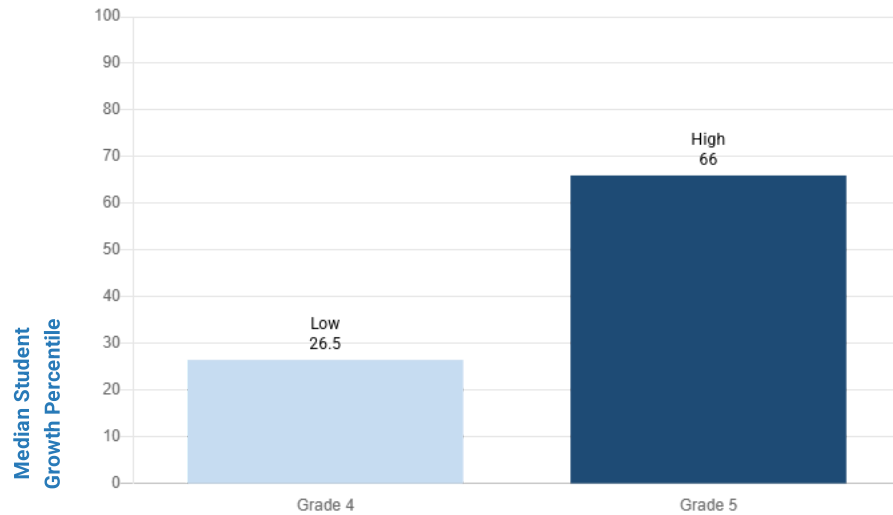

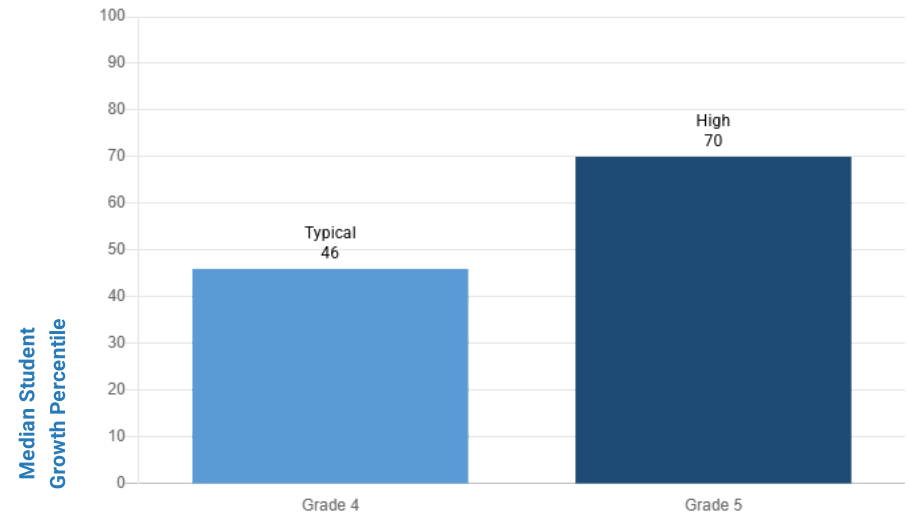

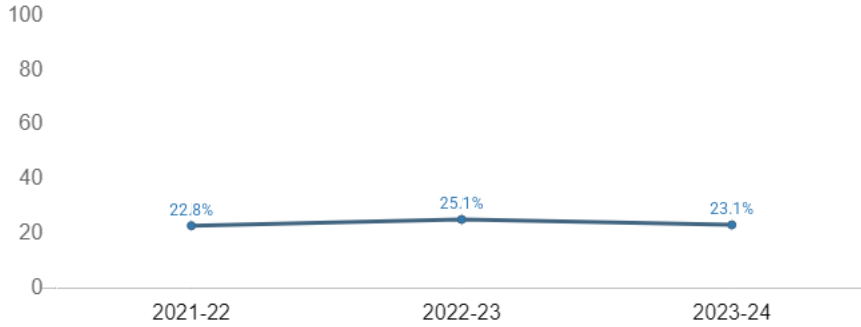

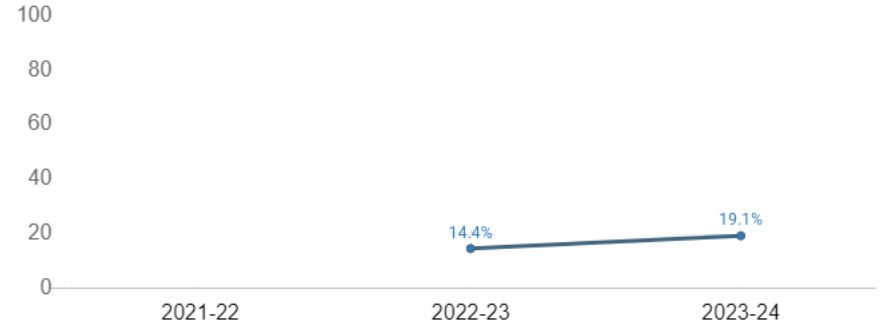
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. 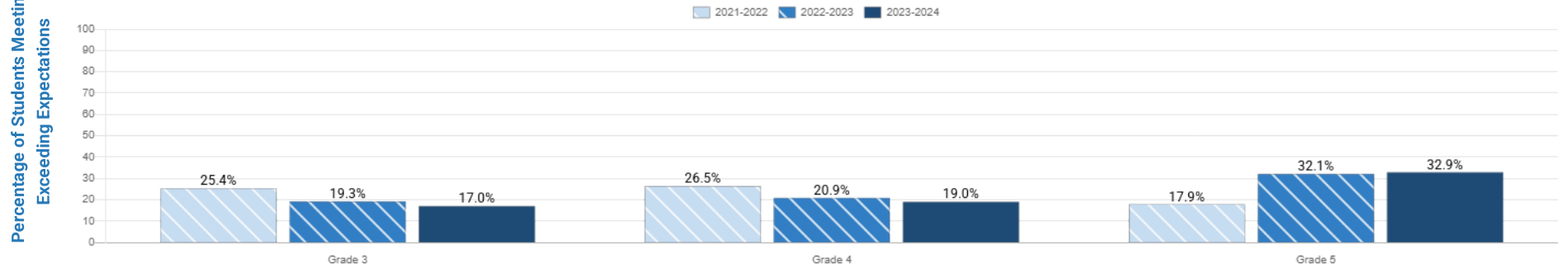

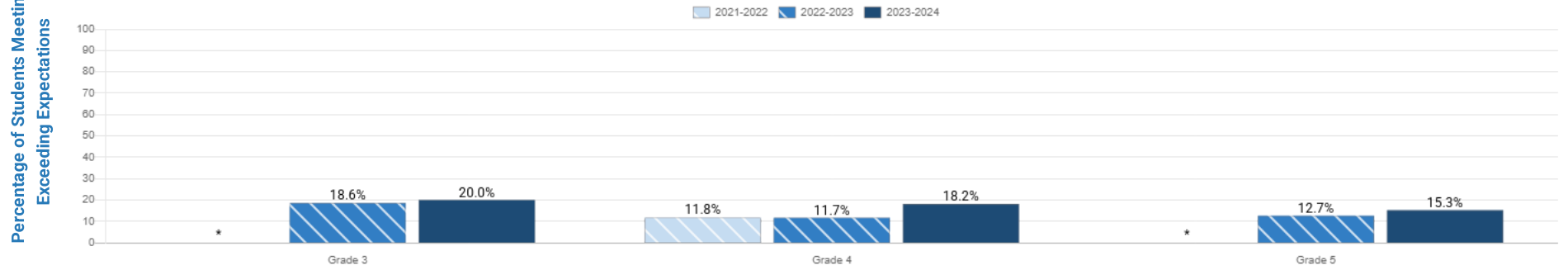

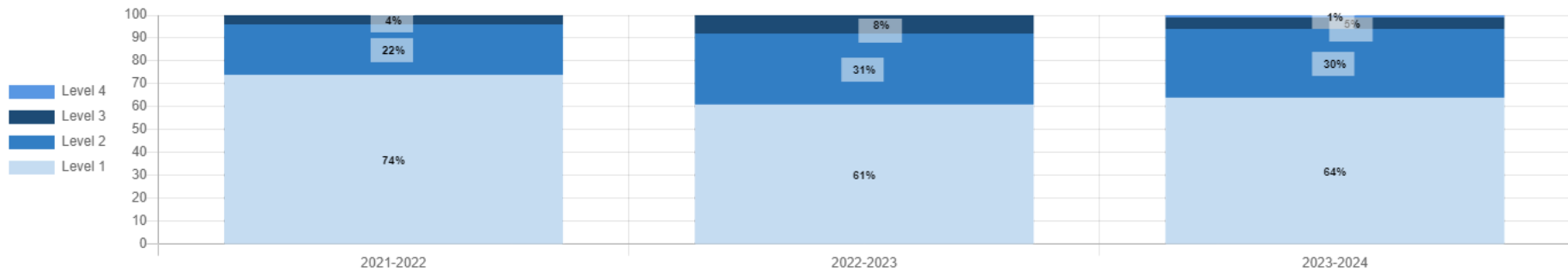

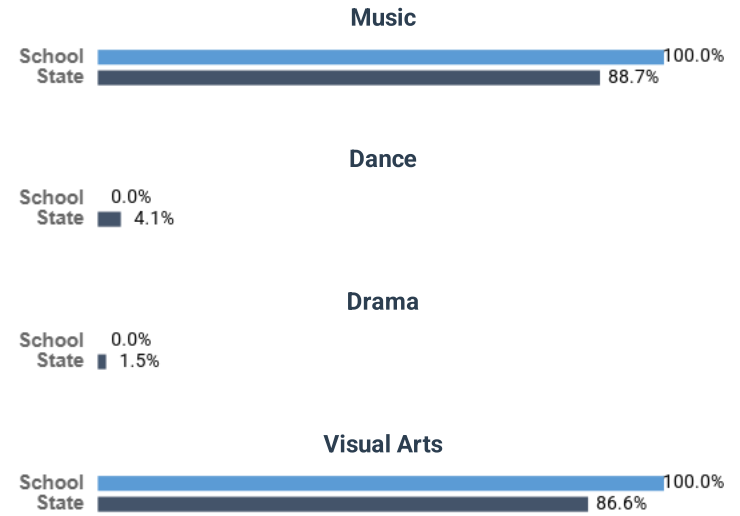

Students enrolled in one or more classes by discipline:



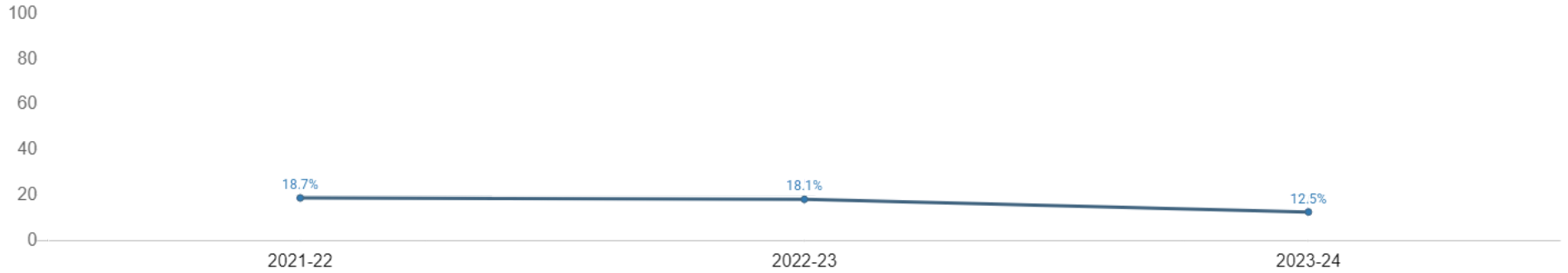

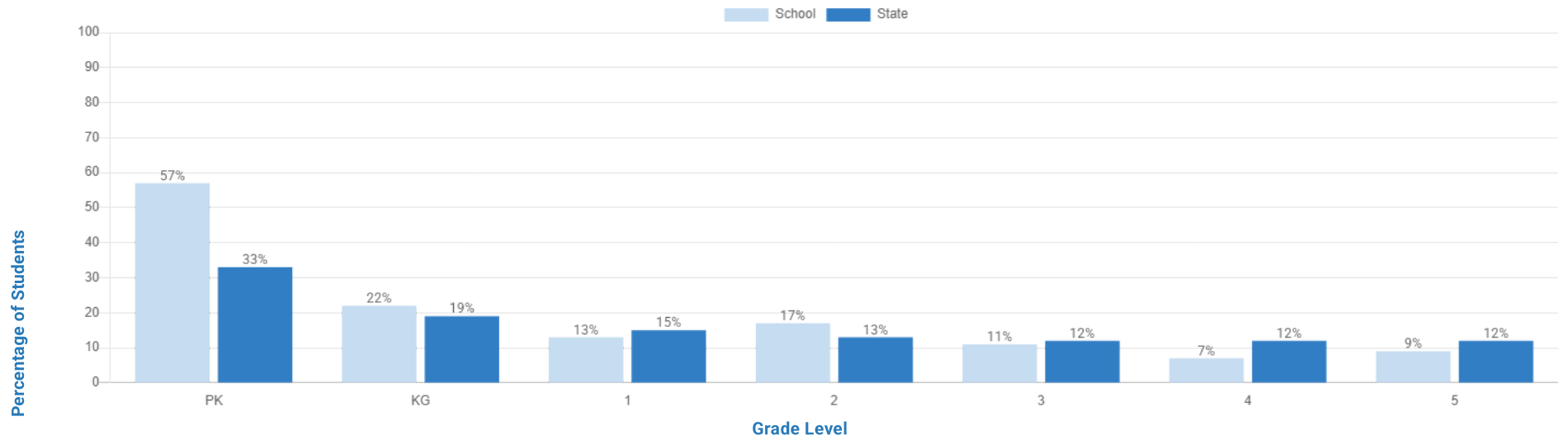

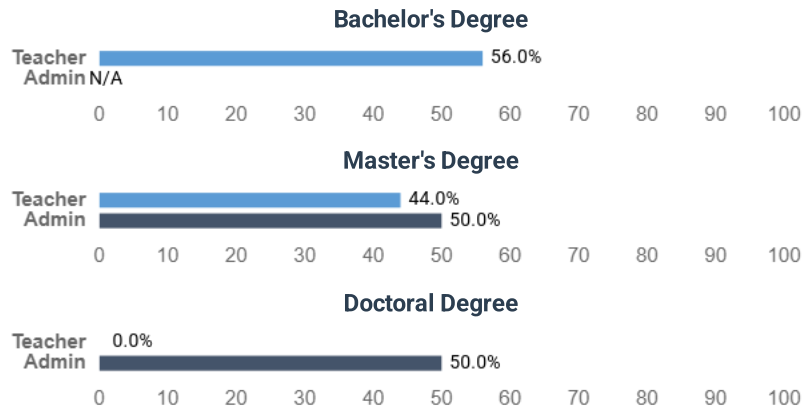

Accountability Summary by Student Group - 2023-24 School Year

"Lord Stirling Community School aligns its instructional plans and goals with the New Brunswick School District curriculum and the New Jersey Student Learning Standards. The school adopts an interdisciplinary approach to Language Arts Literacy and Mathematics, integrating these subjects across all K-5 classes. In grades 3 through 5, a teacher teaming approach is implemented, with teachers specializing in either English Language Arts and Social Studies or Mathematics and Science. We have also introduced a new values system, known as our FRRS Freeze Values-Family, Responsibility, Respect, and Safety-which reflects the perspectives of parents, students, and staff, fostering a unified and positive school culture."



Before and After School Programs:

Before and After School activities have included YSS and Civic League after school partner programs The Extended School Day programs are designed to enhance student proficiency in Language Arts Literacy and Math through STEAM activities. Virtual Tutoring was also available for students. Parental involvement is encouraged through a PTO leadership team. and our Parental Involvement Committee.
