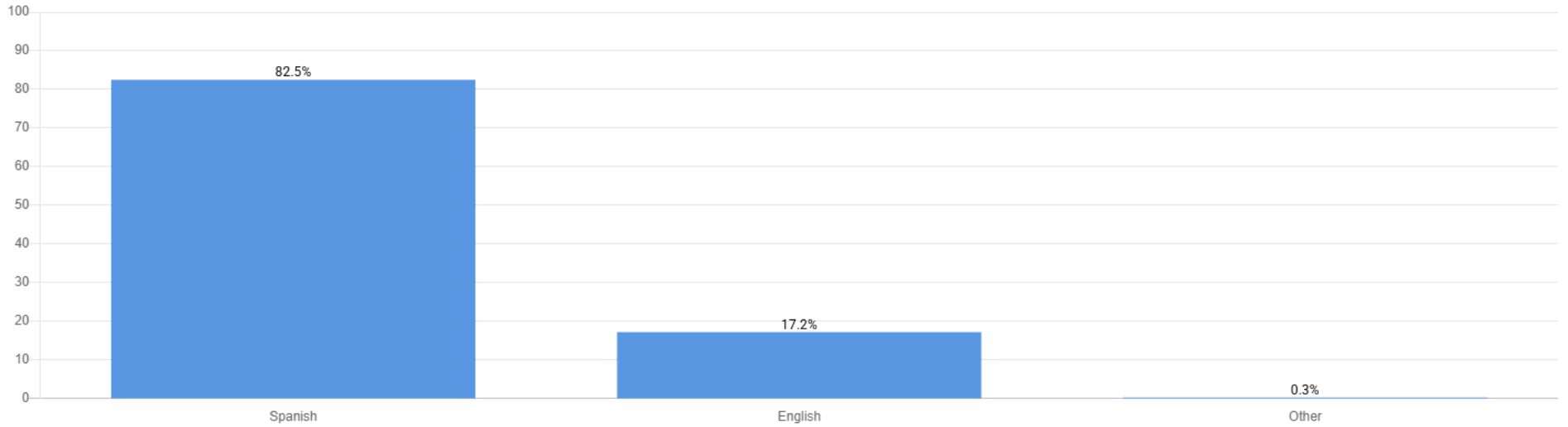

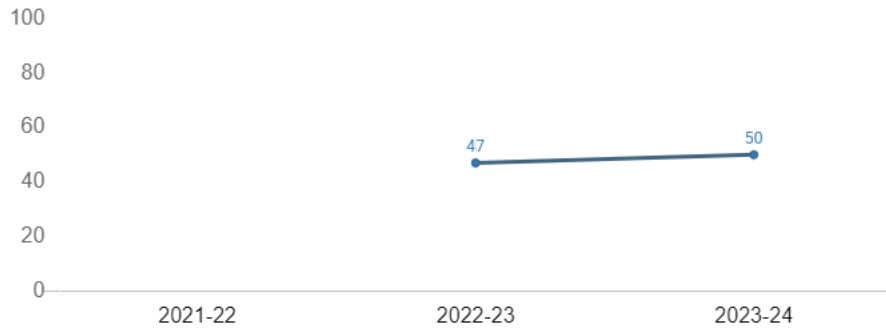

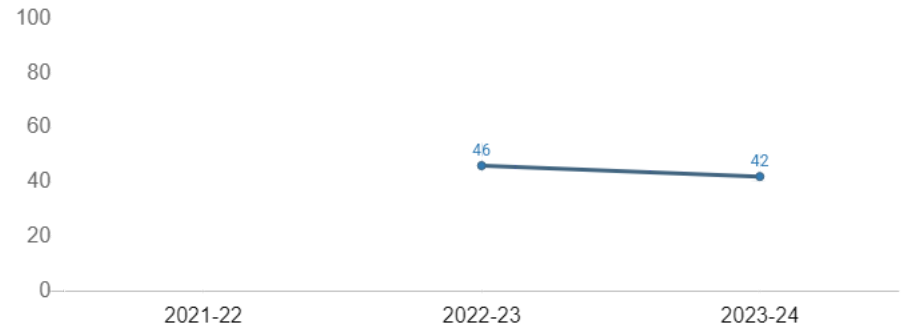

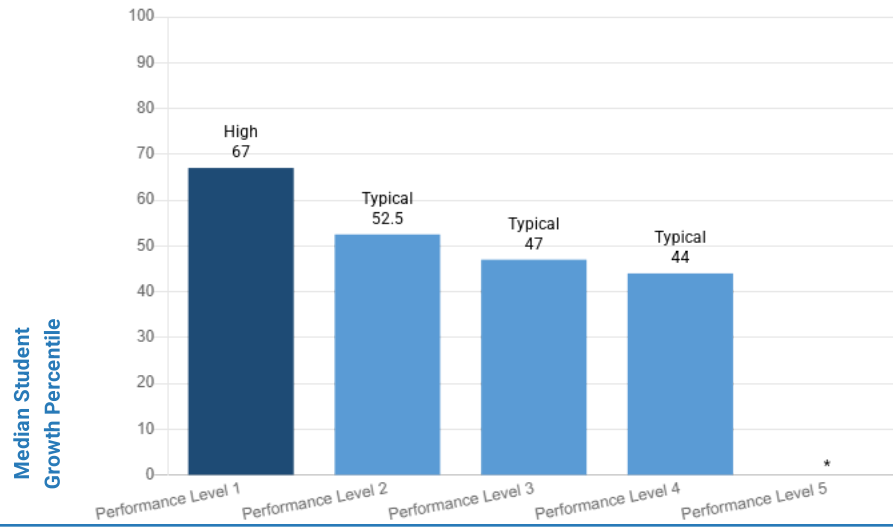

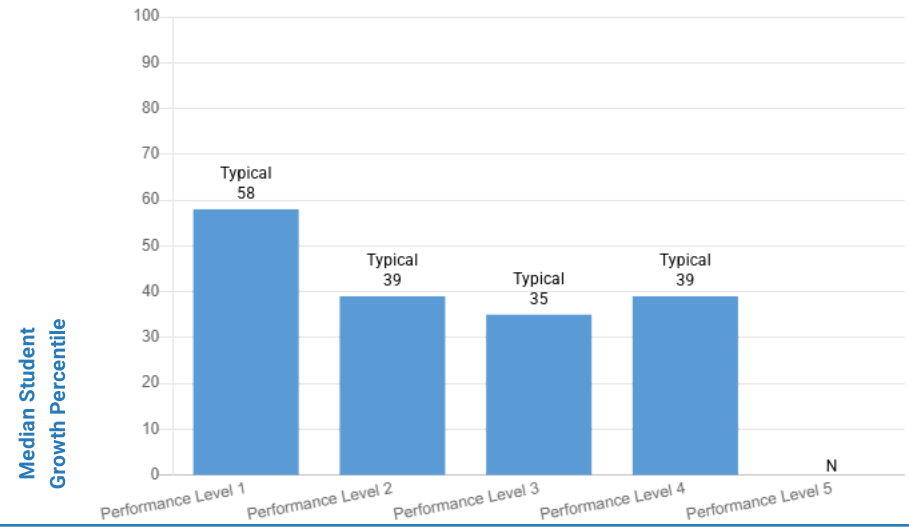

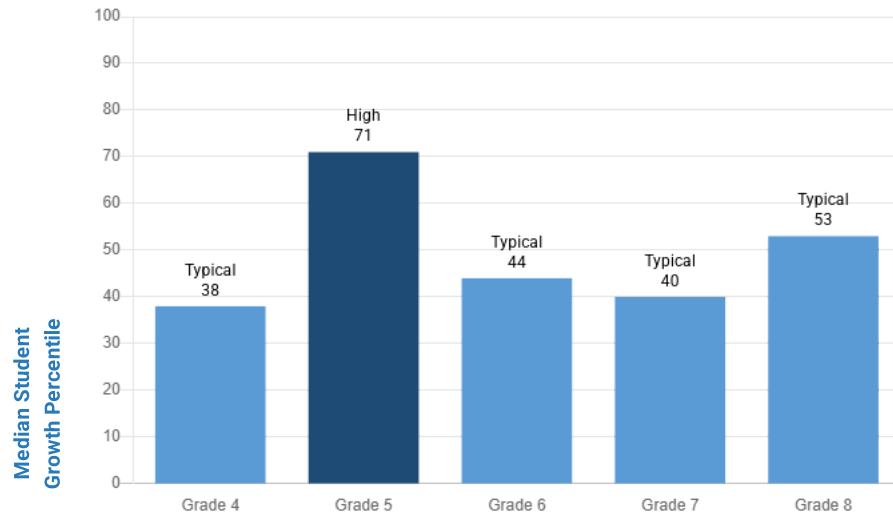

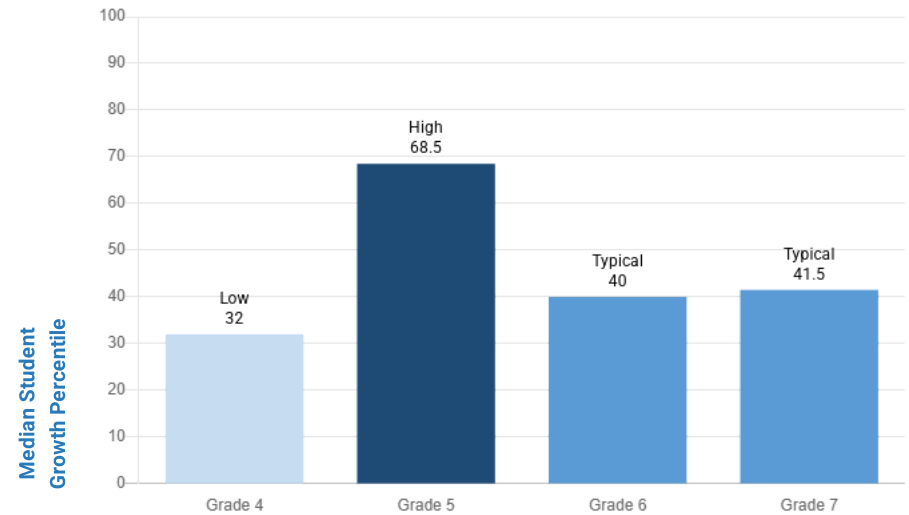

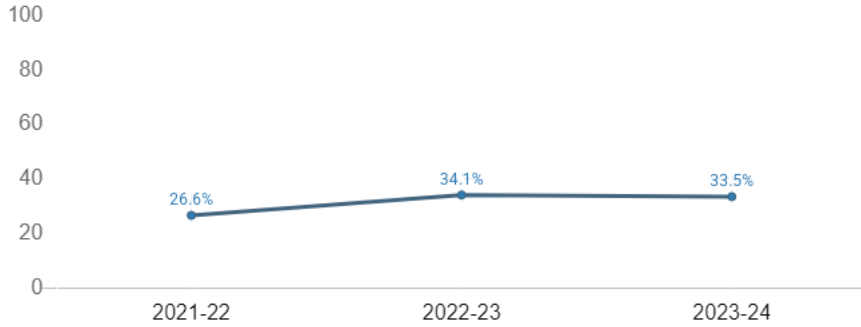

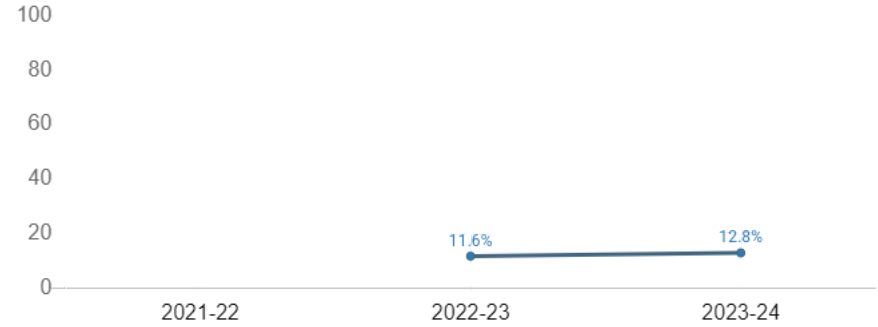
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. 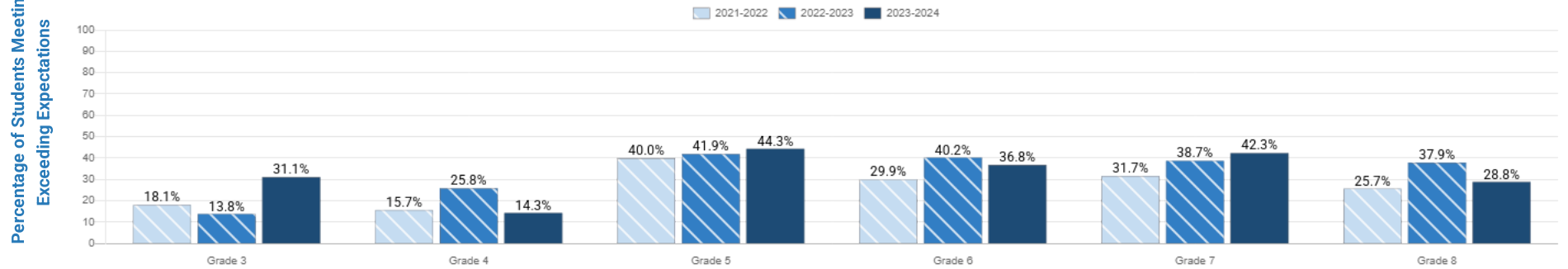

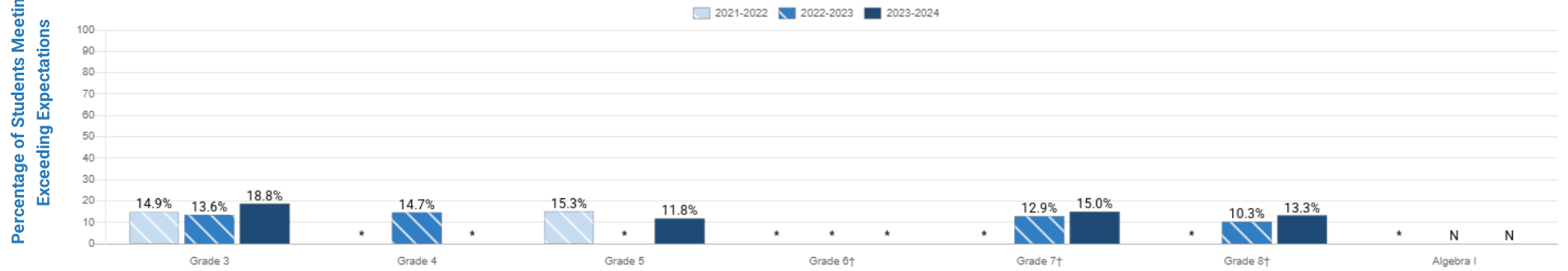

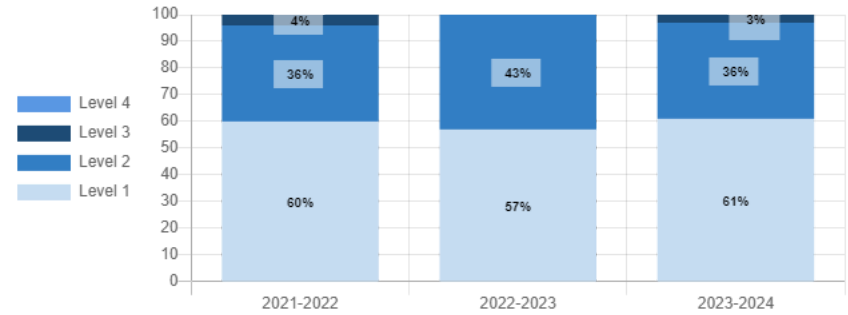

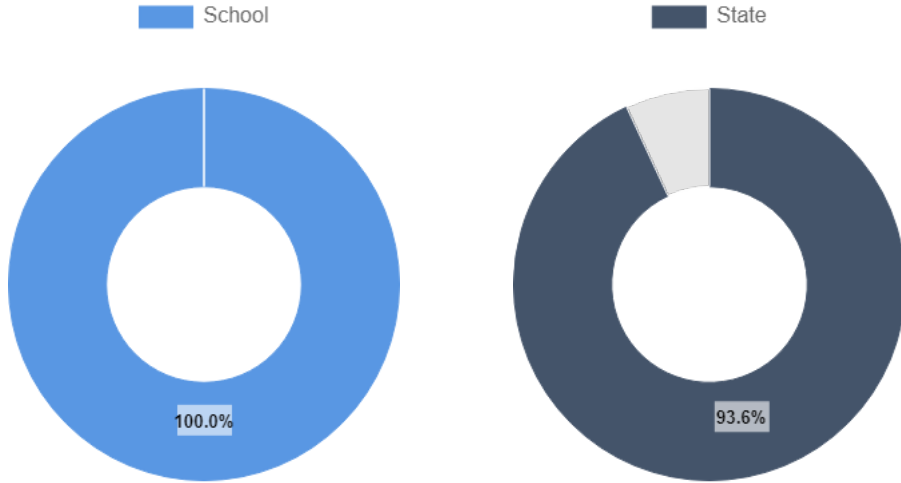

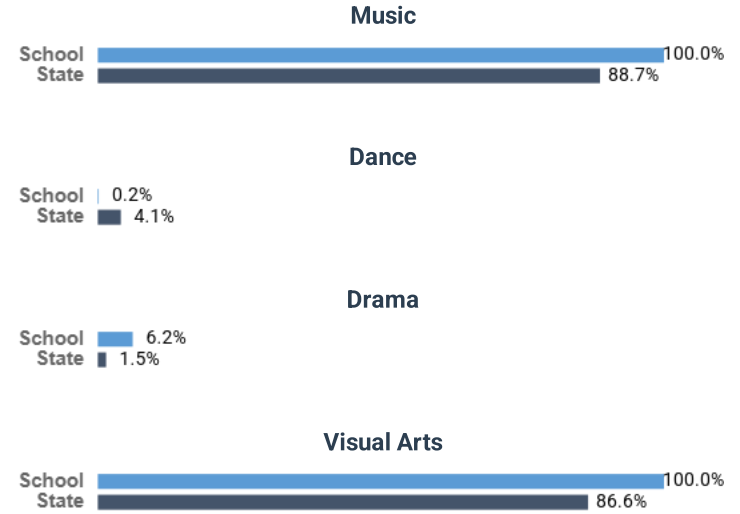

Students enrolled in one or more classes by discipline:



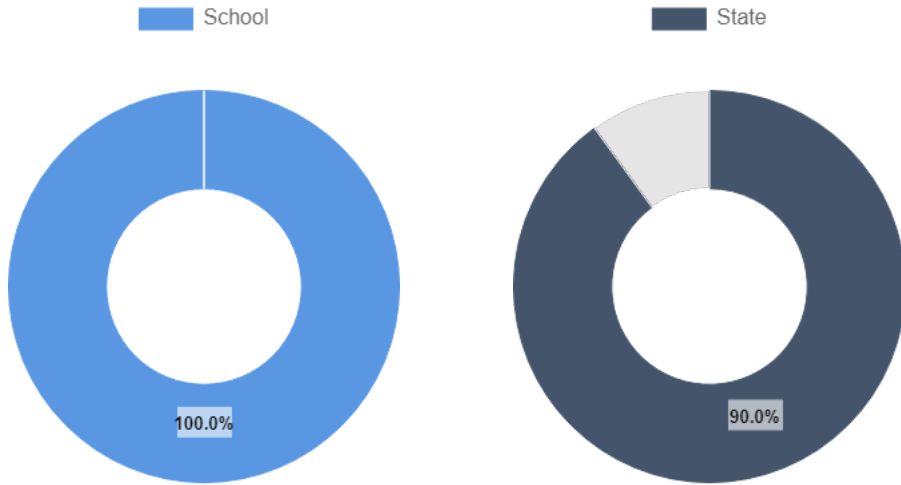

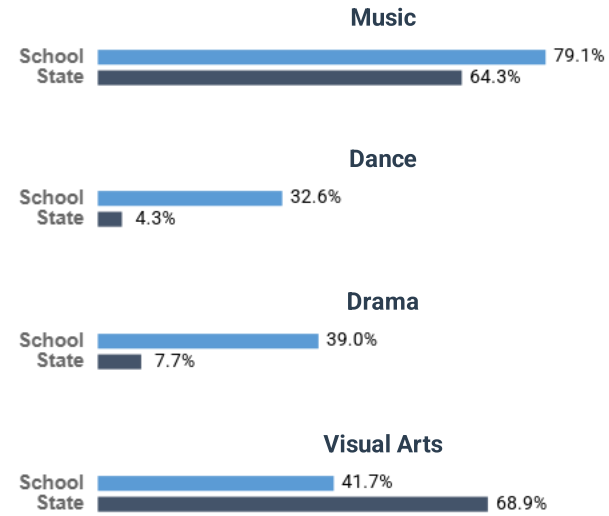

Students enrolled in one or more classes by discipline:



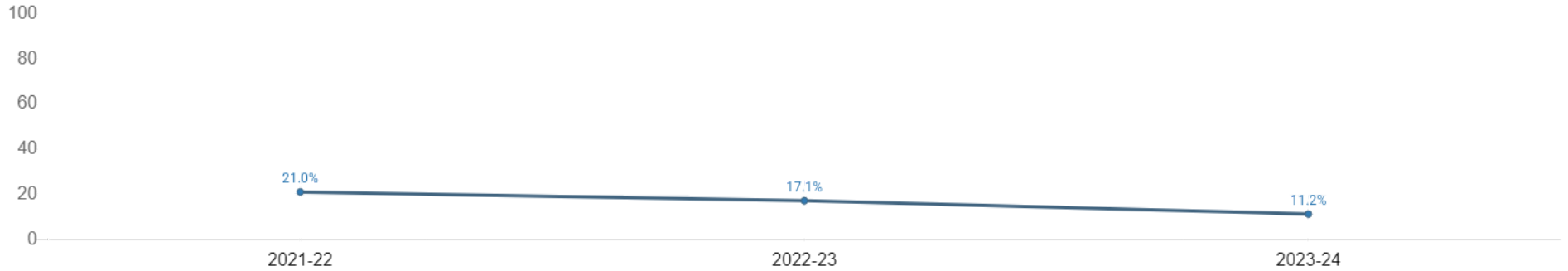

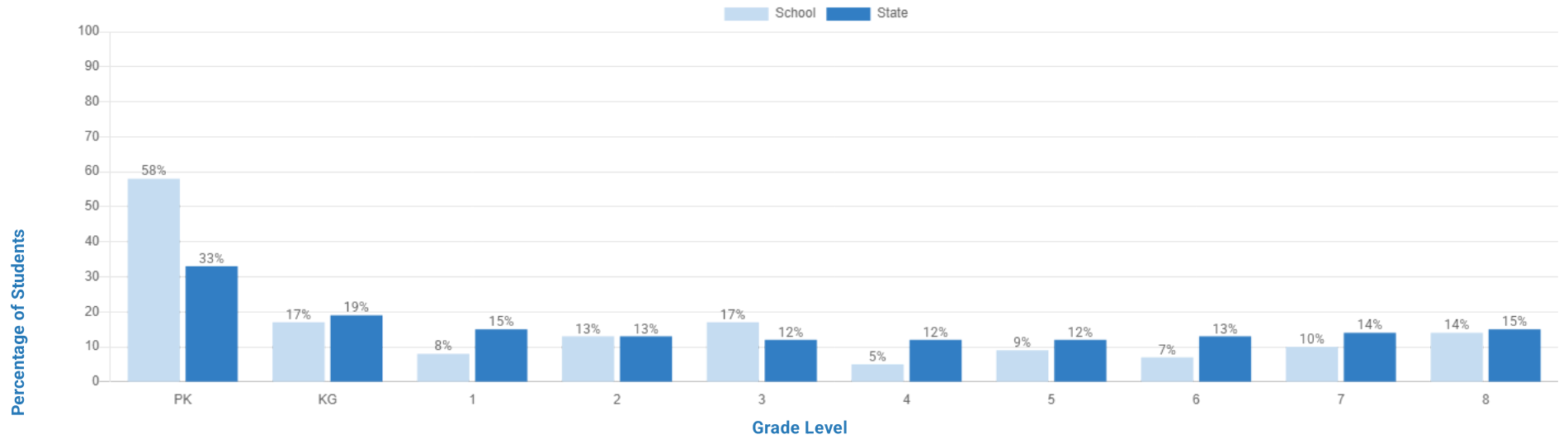

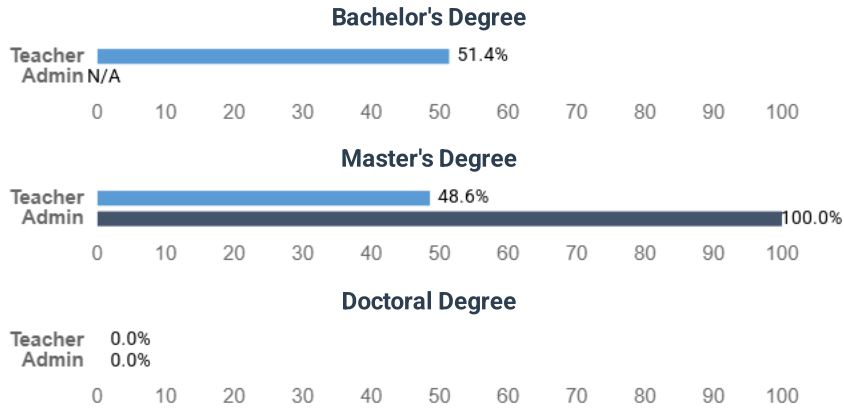

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. "Paul Robeson Community School for the Arts integrates arts into the established district curriculum by providing opportunities for students to participate in English Language Arts, Math, Science, and Social Studies through academic units integrated with at least one of the following new Academic Arts standards. Teachers and staff participate in professional development activities that support teachers in both integrating the Academic Arts Standards into instruction and also in providing students with rigorous activities that include high level tasks promoting student achievement. Classroom teachers focus on providing students with engaging, high level tasks that promote the development of independent thinking and reasoning skills in Math. After working to solve the high level tasks independently, students work in small groups with classmates to identify optimal solutions to problems and then share their findings and techniques for solving the problem with their classmates and teacher. Teachers seek to support students in developing fluency with numbers and mathematical operations. As the district's theme school for the arts, over the last 6 years, we continue to maintain our partnerships with organizations focused on promoting rich and meaningful arts education such as George Street Playhouse, New Jersey Arts Foundation, American Repertory Ballet, and New Jersey State Theatre with whom we have in-school theater, dance, vocal and instrumental residencies with teaching artists working at the school. Students and teachers continue partnerships with the American Repertory Ballet and the New Jersey Symphony Orchestra. Our students continue to benefit from these and other experiences with professionals in the world of the arts as we provide students from Kindergarten through Grade 8 opportunities to be Prepared, Empowered, and Inspired Leaders and Lifelong Learners."
