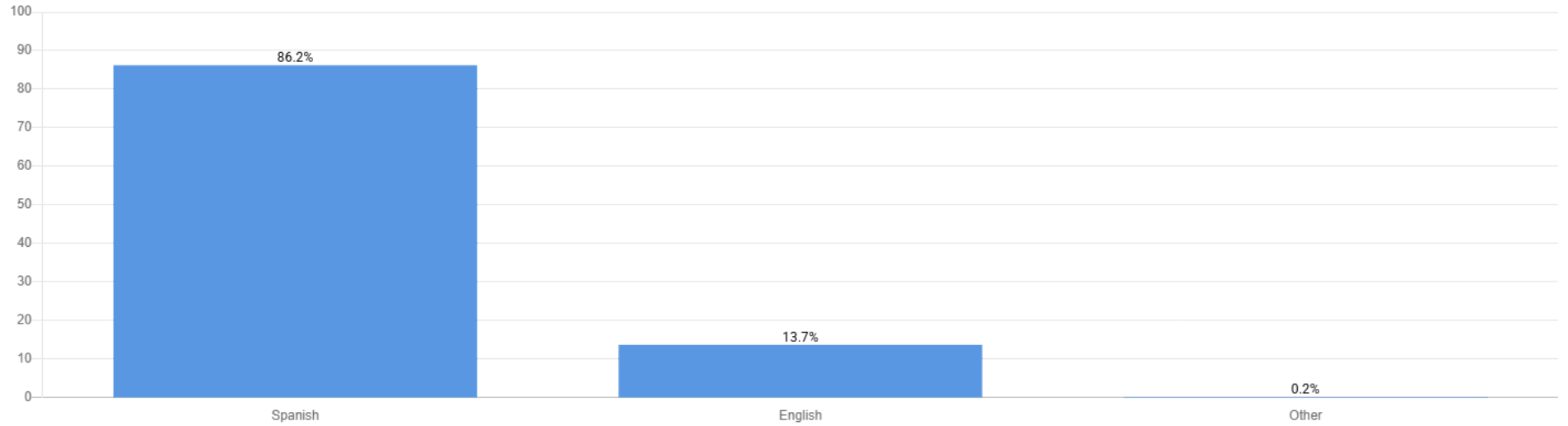

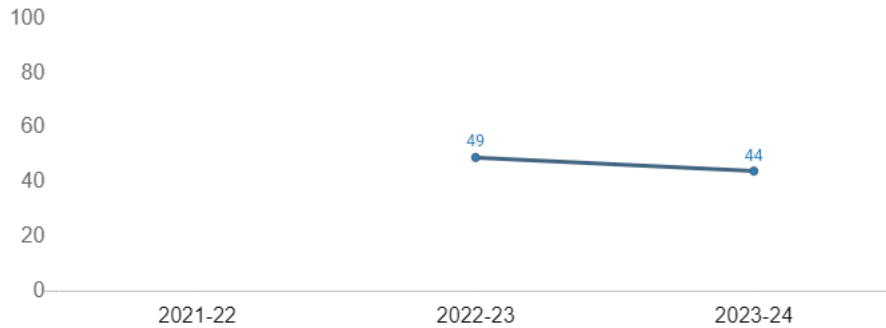

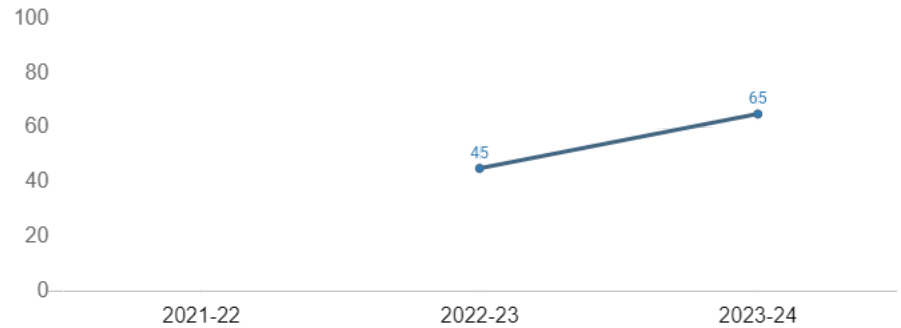

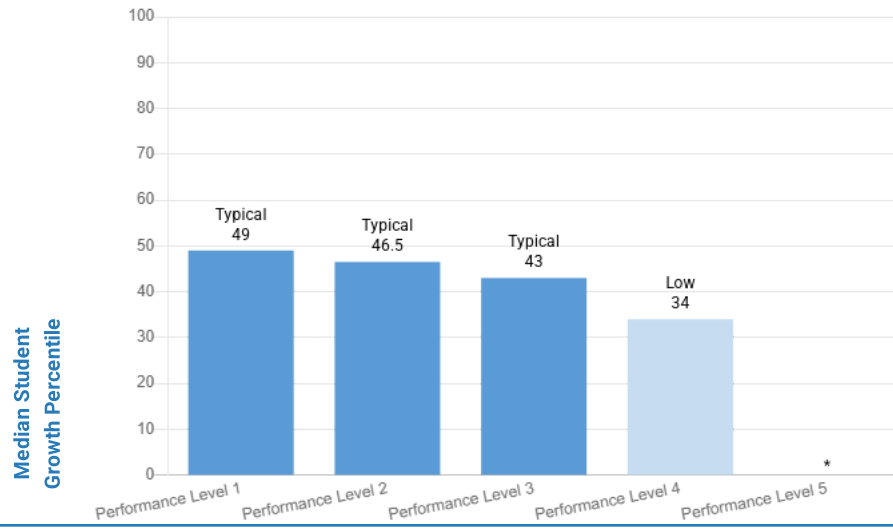

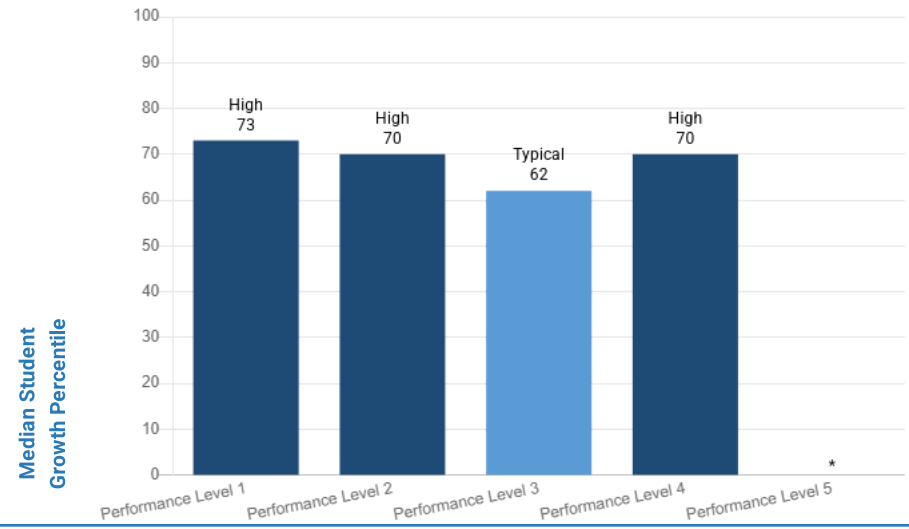

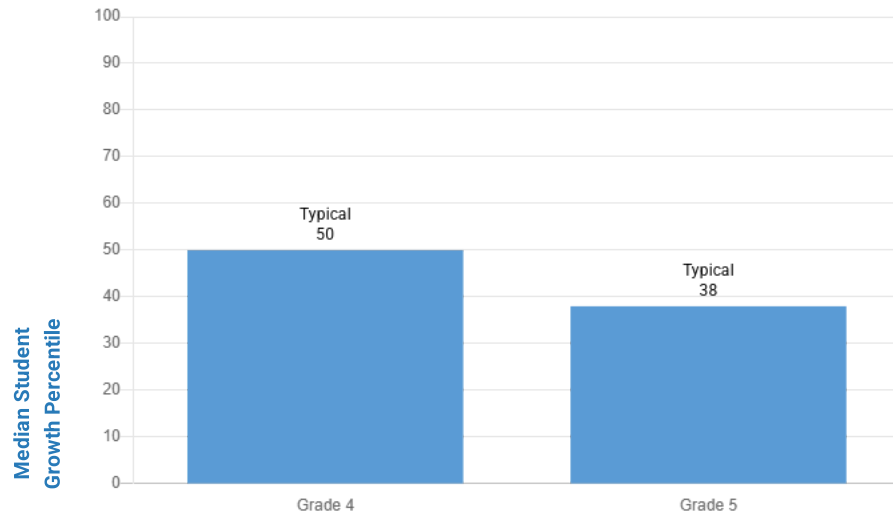

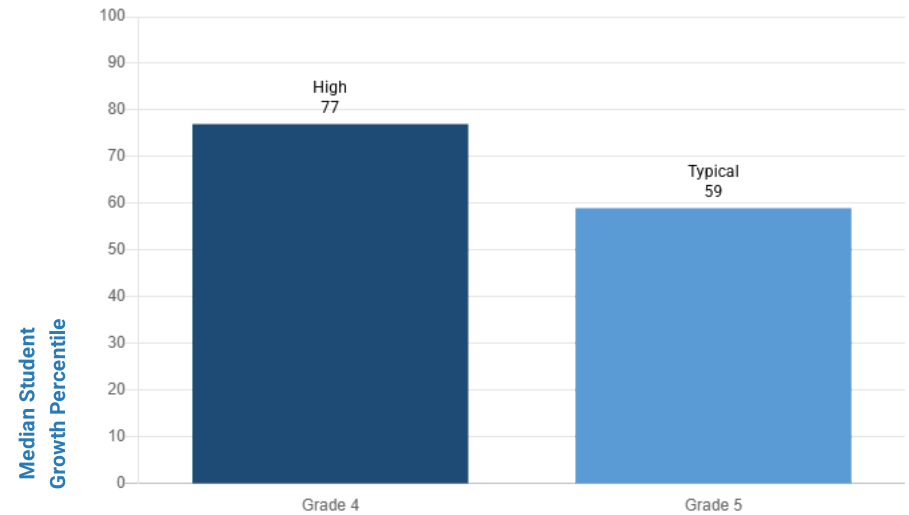

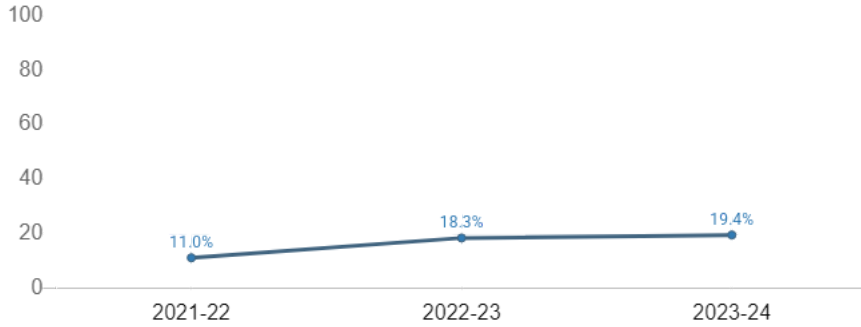

English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. 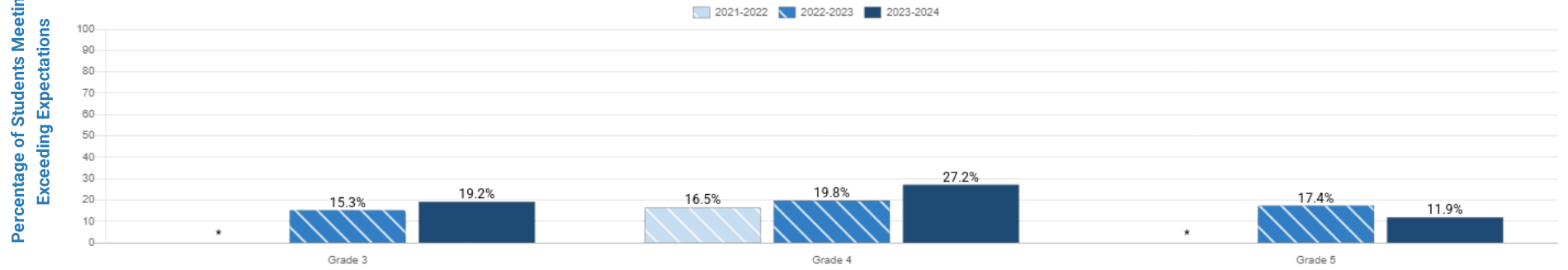

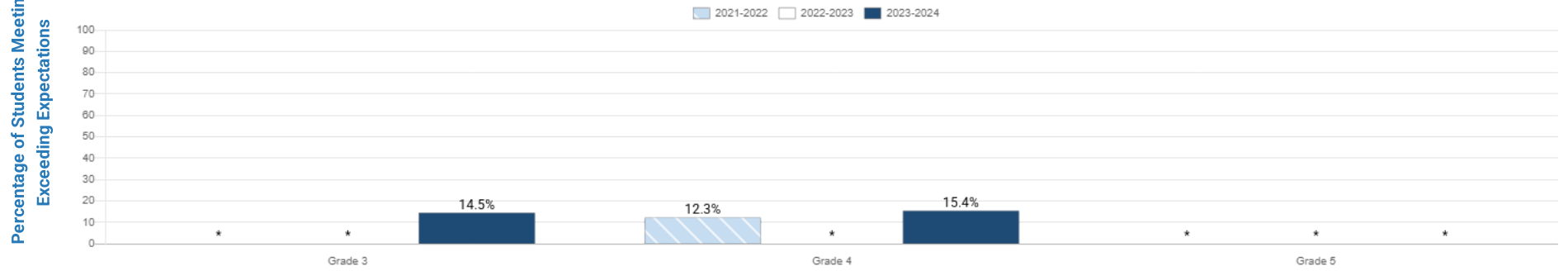

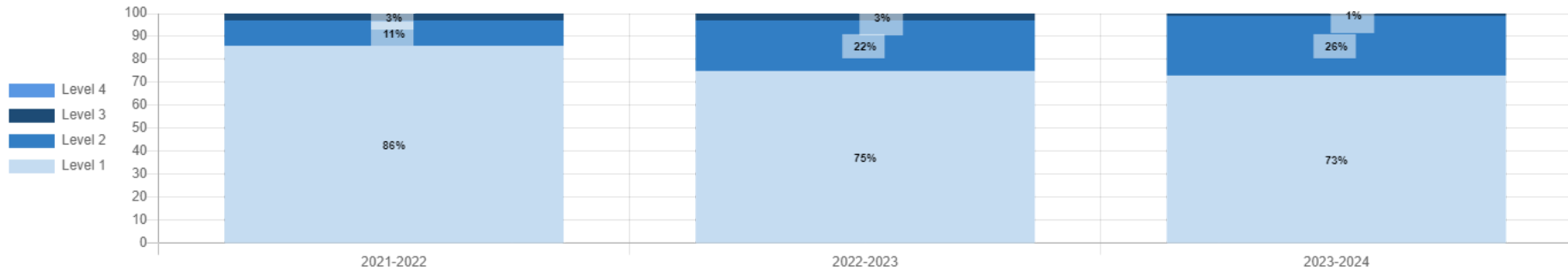

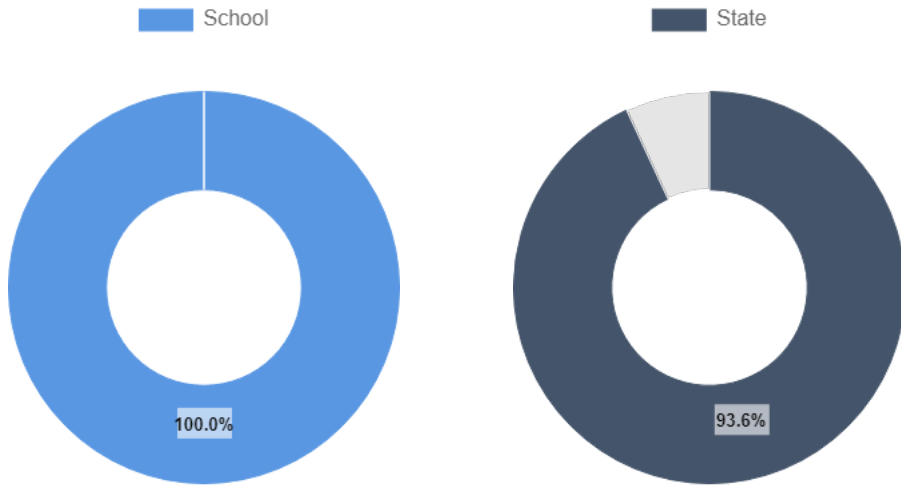

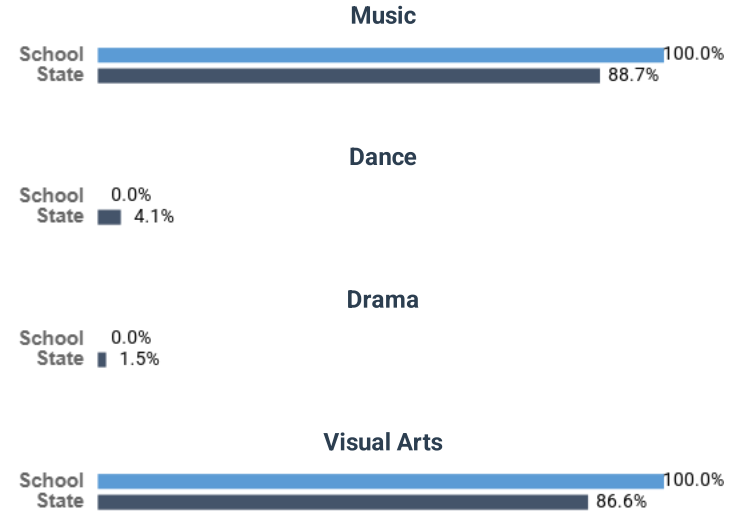

Students enrolled in one or more classes by discipline:



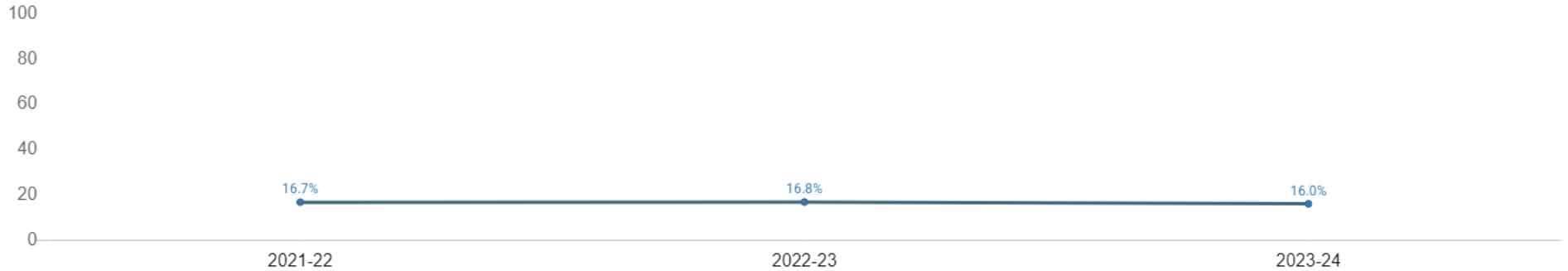

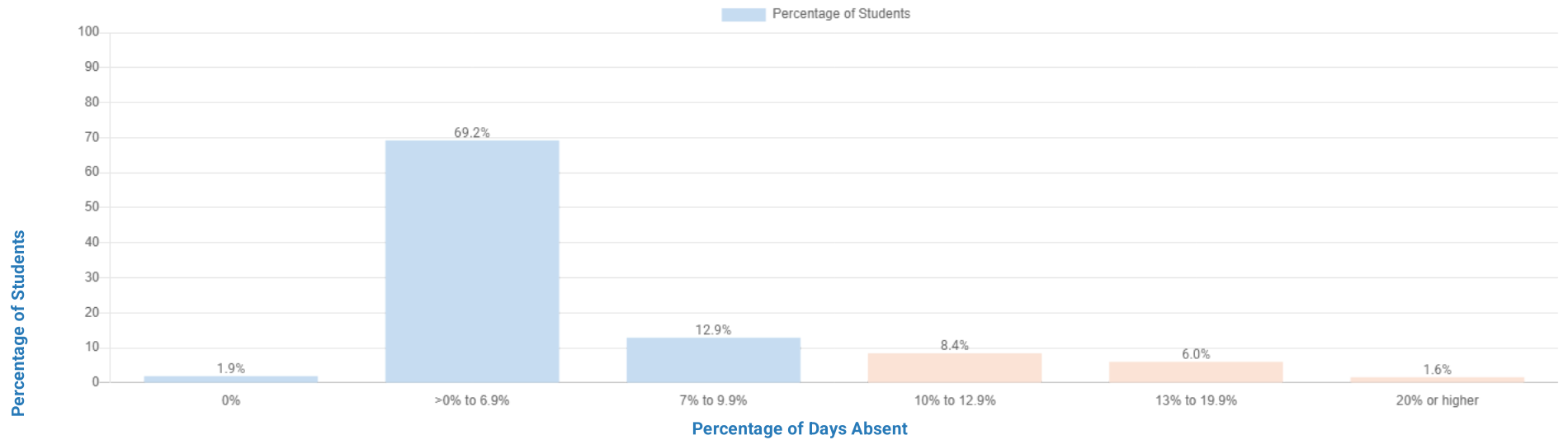

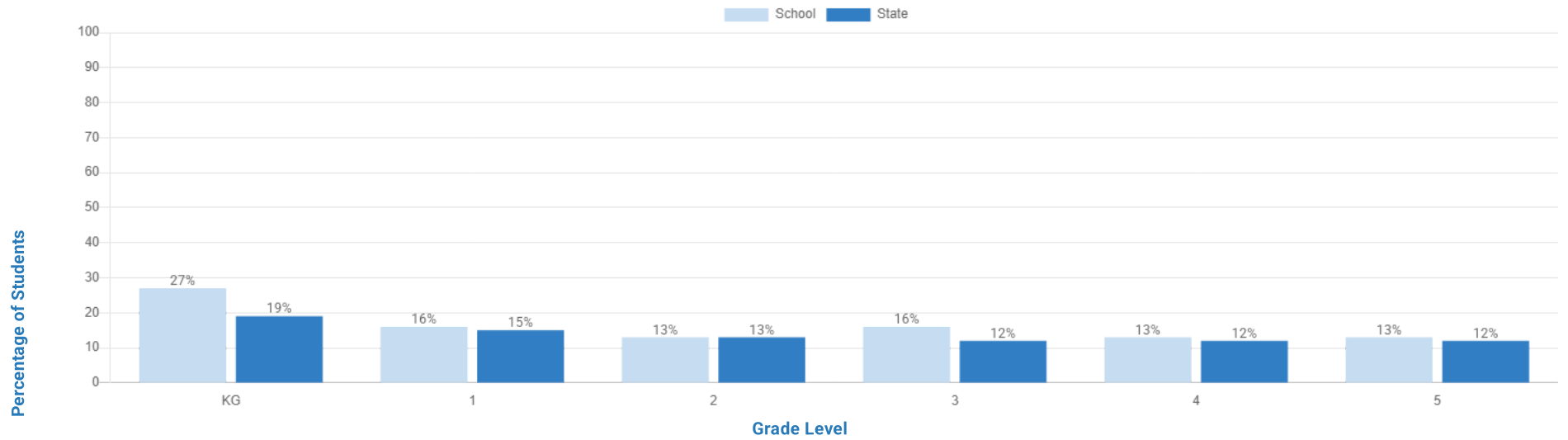

Staff

Staff data reflects teachers and administrators reported by districts at the beginning of the school year.

Key terms for staff data:

Teachers: All classroom teachers

Administrators: Principals, assistant principals, supervisors, coordinators, directors, and other central-office administrators, as well as superintendents and other district-level administrators

Experience: Experience is based on information submitted by districts on all their staff members. For purposes of this report, the ESSA Educator Equity and federal reporting requirements, NJDOE has defined teachers as "inexperienced" if they have fewer than four years of prior experience in a given district. 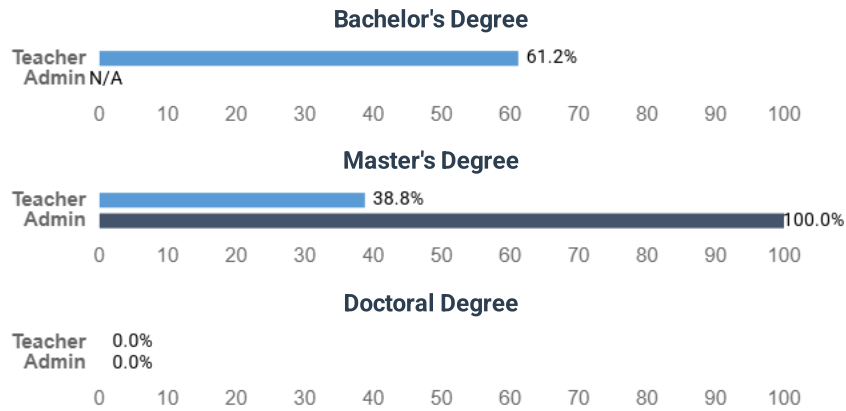

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. "New Brunswick Public Schools is committed to providing students with high-quality, cognitively engaging instruction to foster the advanced cognitive development essential for productive citizenship and future employment. During the school day, Academic Intervention programs offer tailored, tiered instruction based on each student's unique needs to ensure their success. These programs are rooted in the belief that challenges provide valuable opportunities for growth. At Roosevelt School, students participate in a "What I Need" (WIN) period, where they receive targeted instruction focused on their specific areas of need or enrichment. Additionally, students receive academic support through Basic Skills Intervention, specifically designed for tier 3 students in mathematics and language arts. This program follows a pull-out model and includes evidence-based interventions such as *Leveled Literacy Intervention* (ELA) and *SOAR* (Math), providing students with focused support to streng



Clubs and Activities:

"We are proud to offer a variety of clubs and activities designed to enrich our students' school experience, foster leadership, and build important life skills. Here are some of the fantastic opportunities available to our students: Safety Patrol (5th Grade) Our 5th-grade students have the opportunity to apply for the Safety Patrol. This club empowers students to take on leadership roles by assisting with school safety, such as helping peers during arrival and dismissal. Safety Patrol members serve as role models, promoting responsibility and setting a positive example for others. Hero Squad (4th and 5th Grades) The Hero Squad is a group of dedicated 4th and 5th graders who focus on promoting a positive school environment. These students are trained in peer conflict resolution and play an active role in supporting their classmates by encouraging kindness and collaboration.
