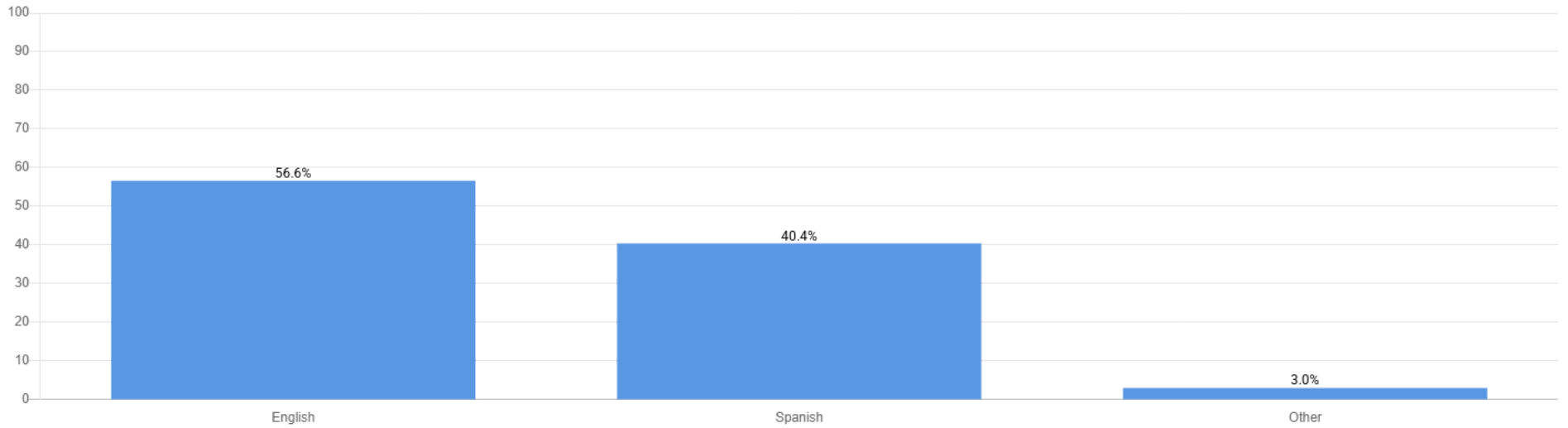

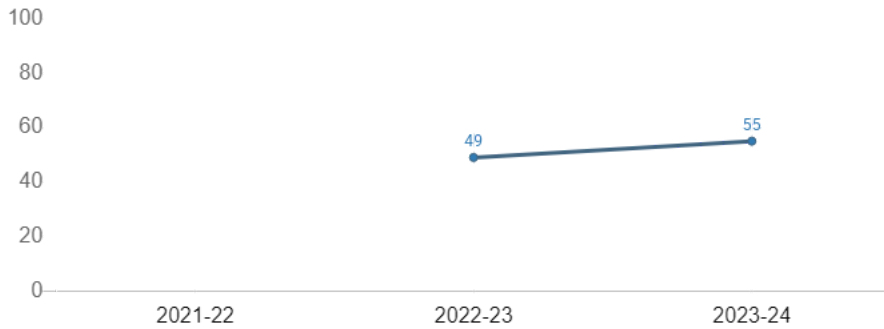

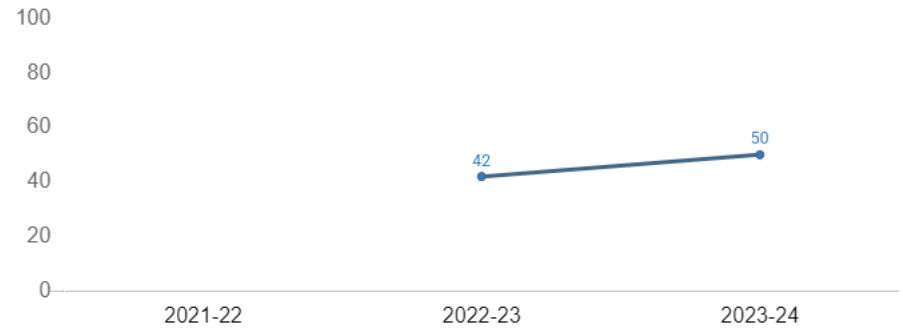

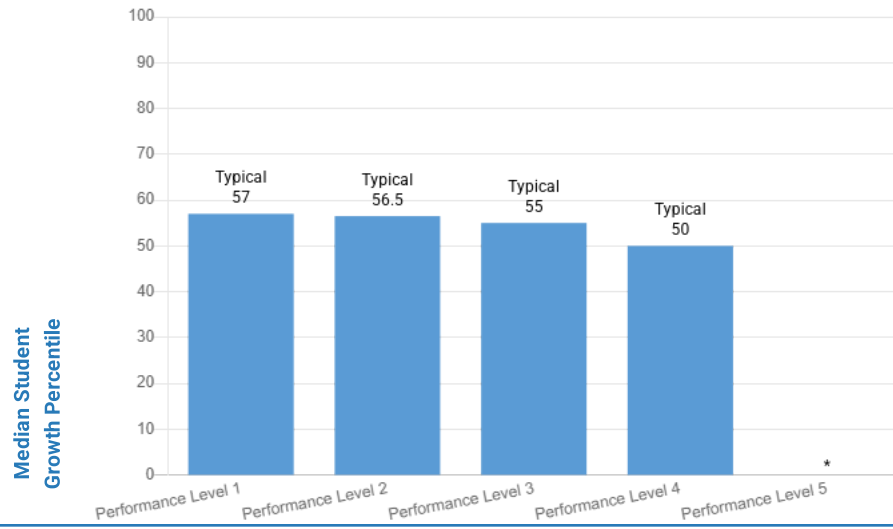

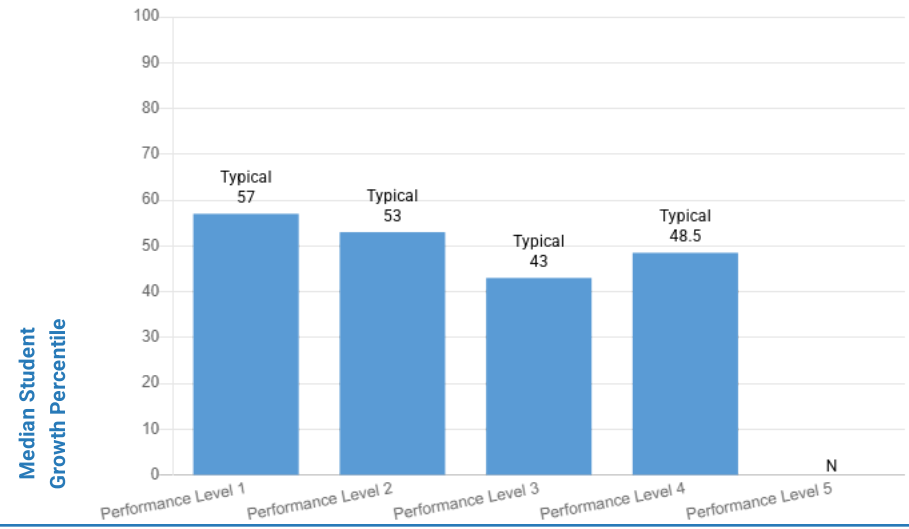

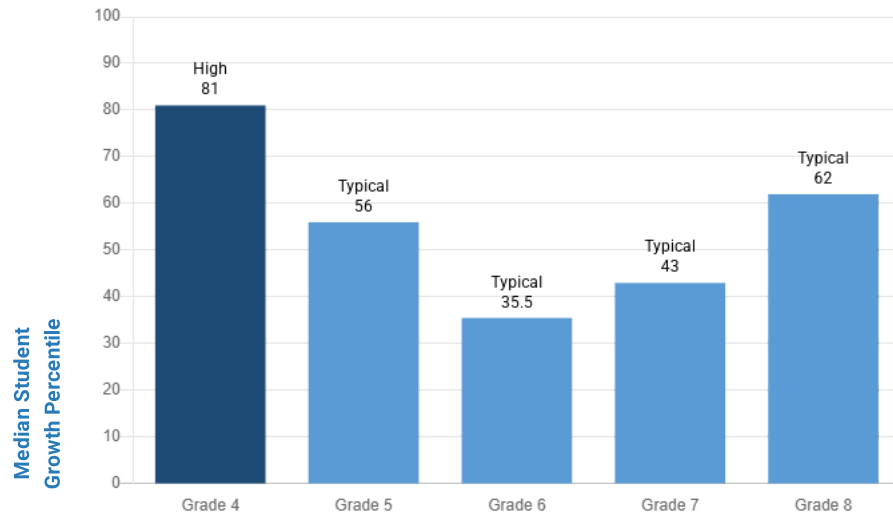

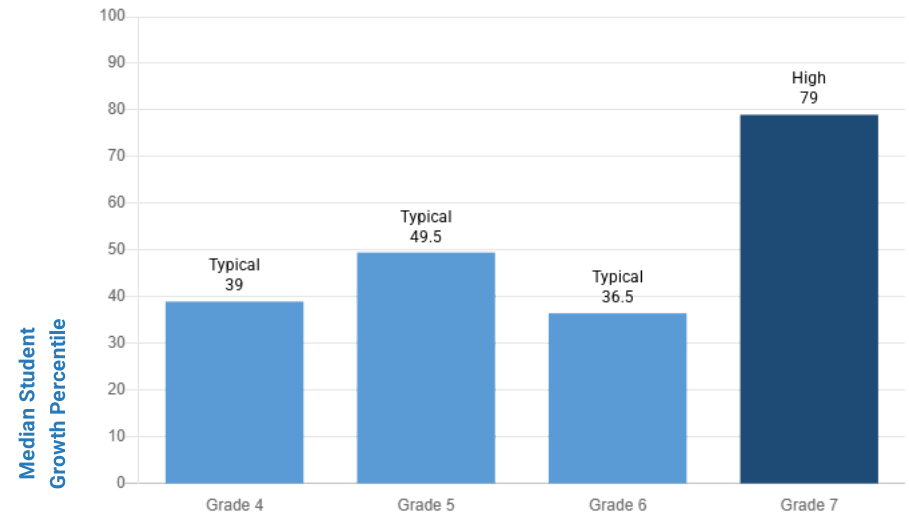

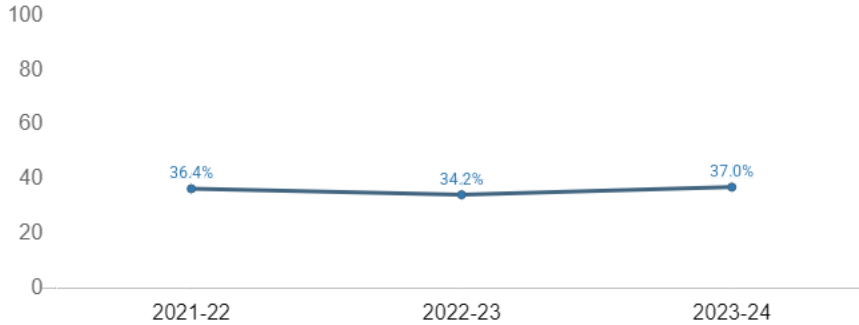

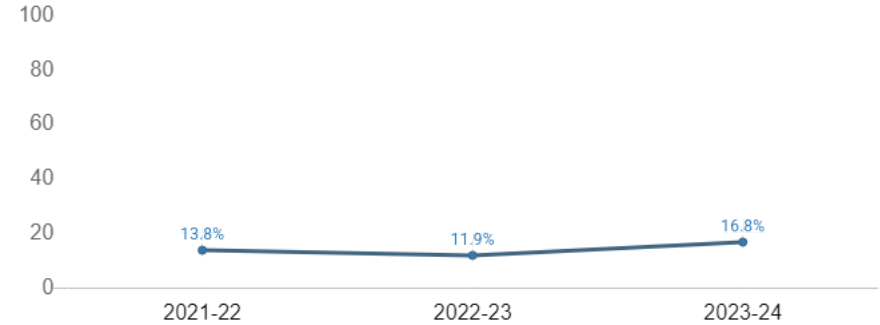
### English Language Arts and Mathematics Performance Trends

### English Language Arts Assessment - Participation and Performance

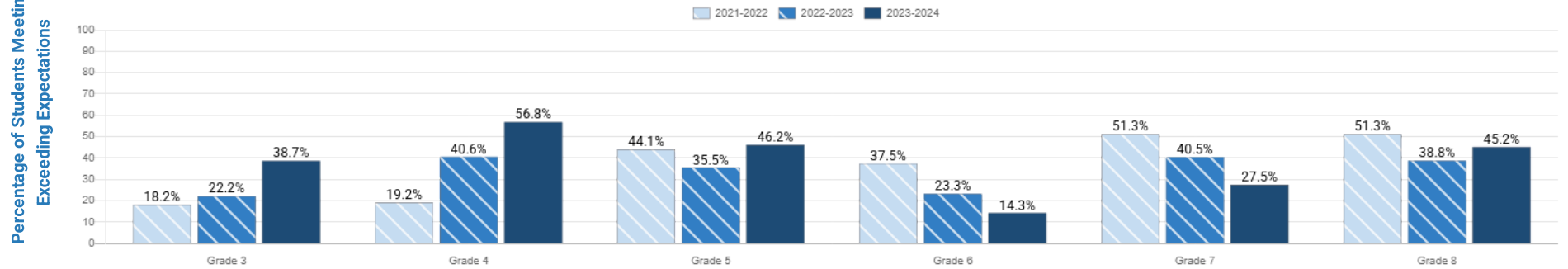

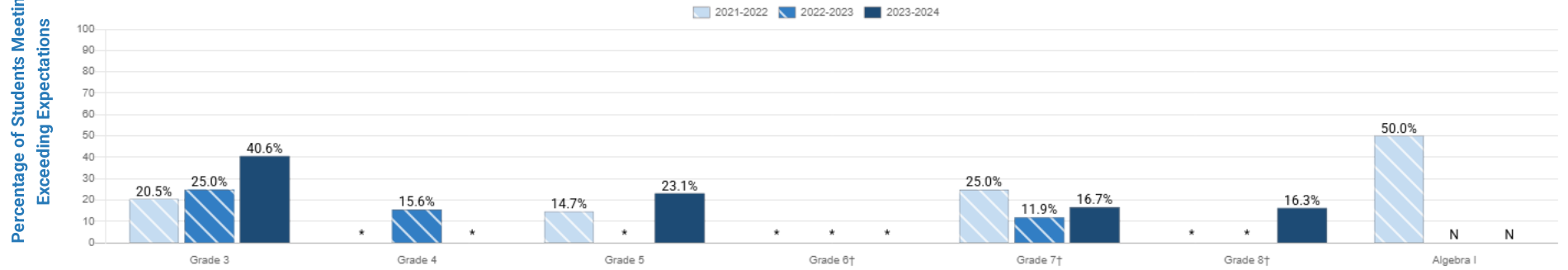

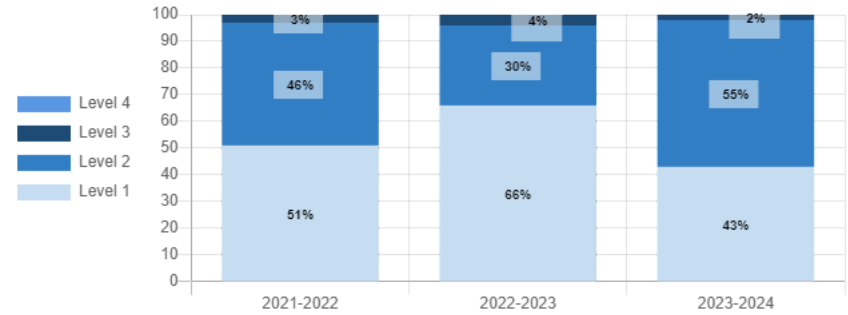

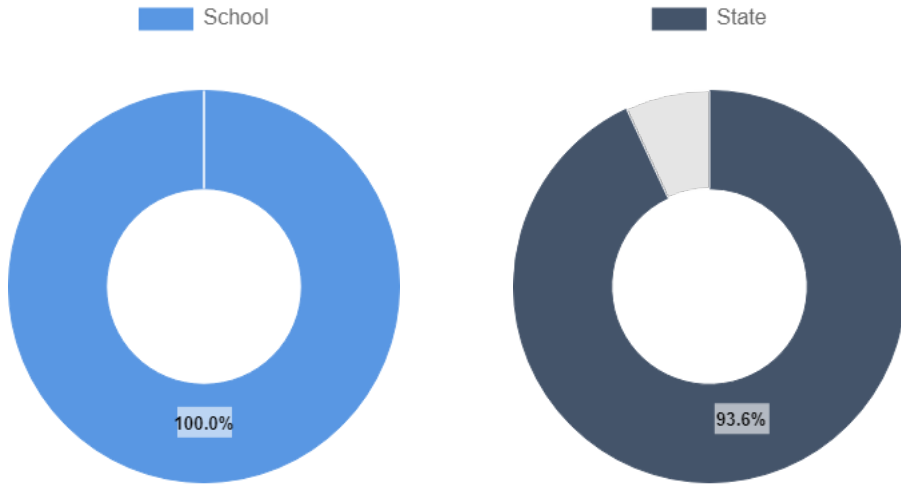

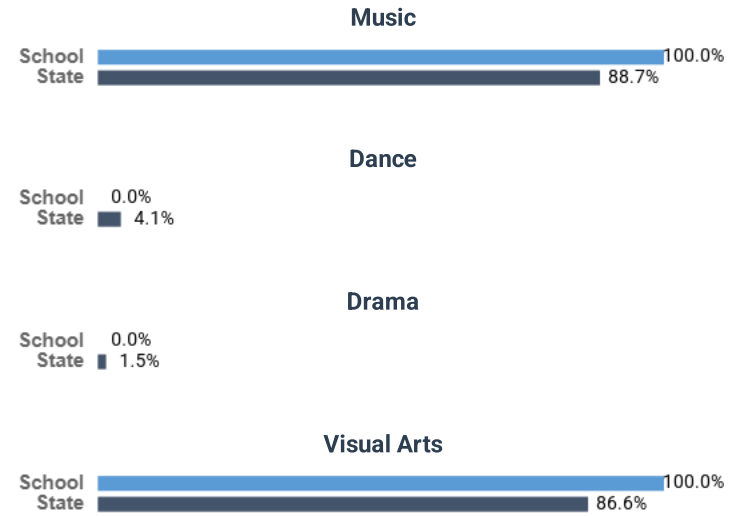

**Students enrolled in one or more classes by discipline:**



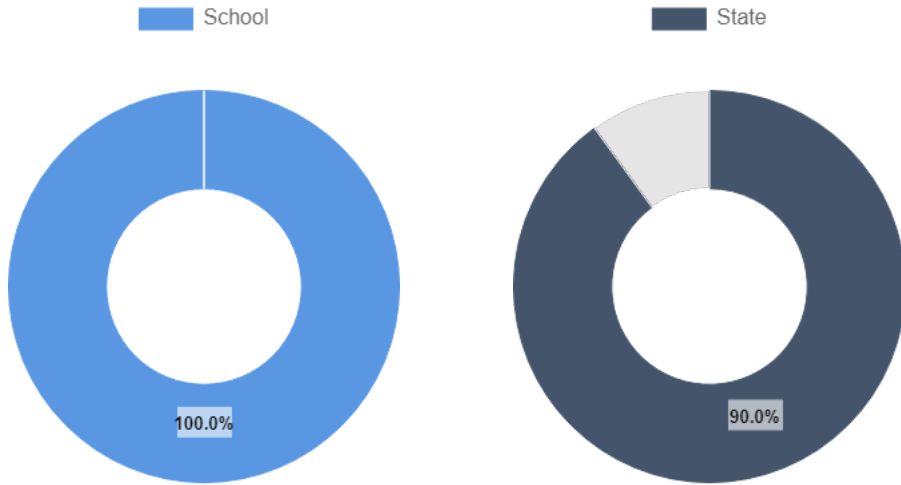

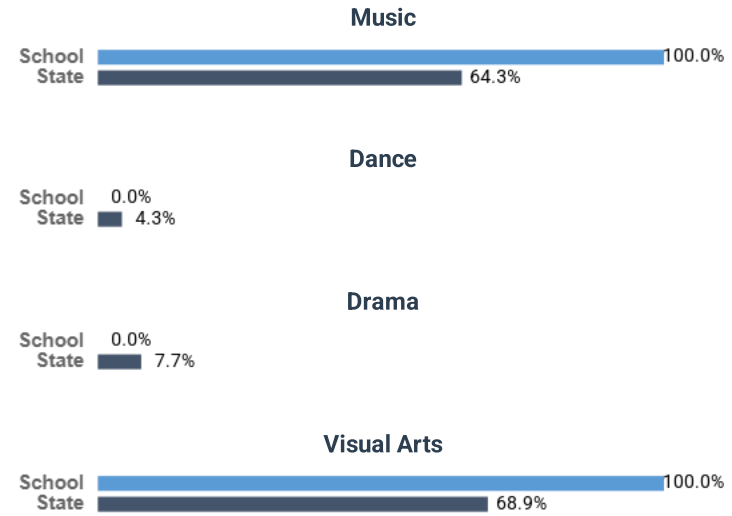

**Students enrolled in one or more classes by discipline:**



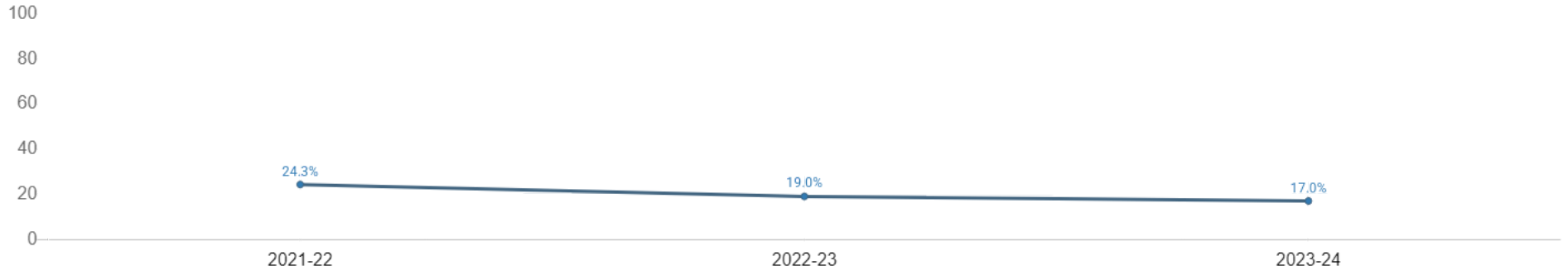

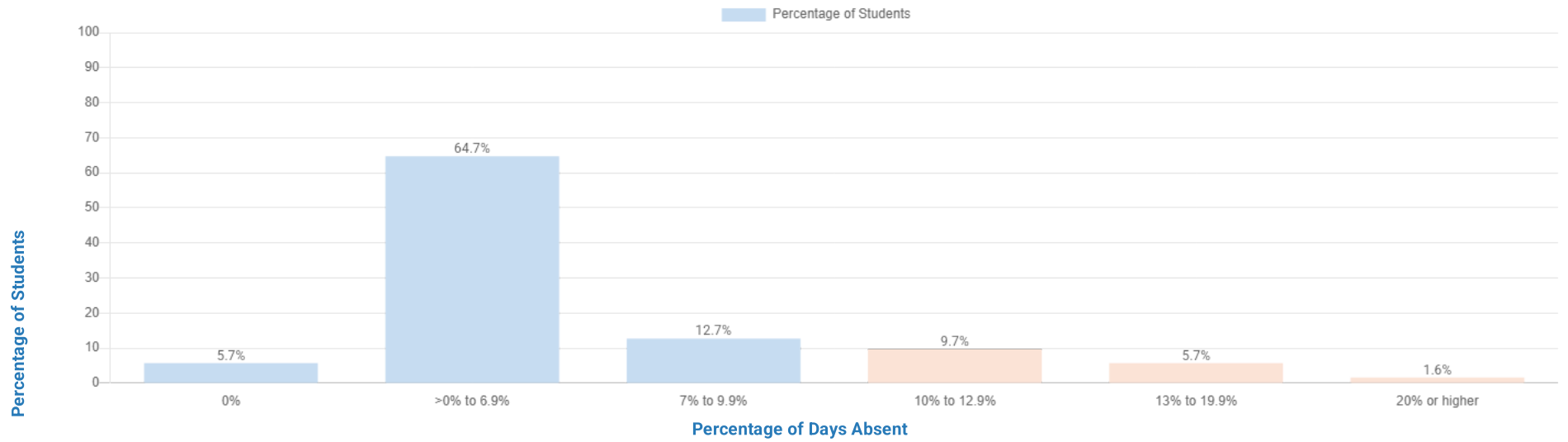

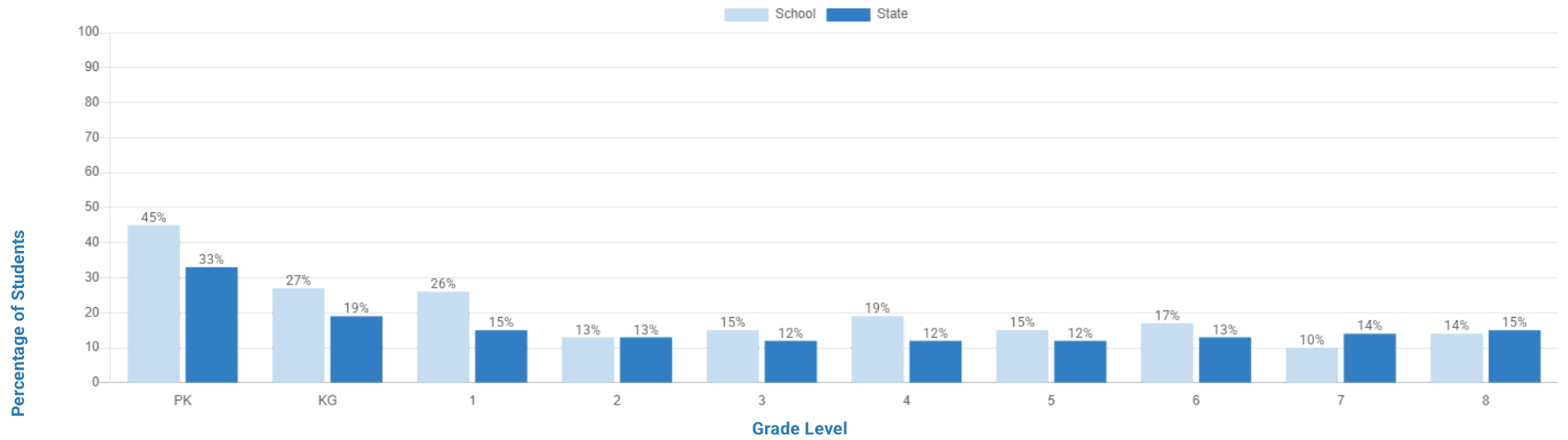

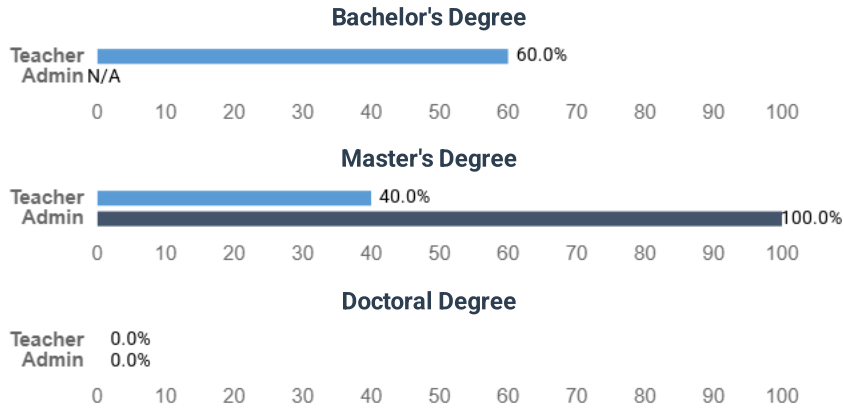

### Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. Woodrow offers Advancement Via Individual Determination (AVID) courses for sixth, seventh, and eighth grades. We celebrate academic success during the Honor Roll assembly after each marking period. The 21st century skills of critical thinking, communication, collaboration, and creativity are embedded in our curriculum. Teachers receive professional development to stay current on new educational technologies. As a "one-to-one" school, each student is given daily access to their own Chromebook in their classroom. We maintain open communication with parents and families through OnCourse, a web-based tool that provides parents and students access to student progress notes, grades, and other school information.

### Before and After School Programs:

An Extended Day Foundational Skills Literacy Program is offered to students in kindergarten, first, second, and third grade. An Extended Day Math Program is offered to students in fourth, fifth, sixth, seventh, and eighth grade. Academic Parent-Teacher Team (APPT) workshops are offered in the fall and spring for both ELA and Math for parents of first through fifth graders. Our students also benefit from the New Brunswick Community Youth Support Services (YSS) program after school which provides additional academic support, physical fitness, social activities, and healthy snacks.



### Staff and Professional Learning:

Institute For Learning (IFL) provides Math and Language Arts professional development sessions are offered throughout the school year. District employees have monthly professional development opportunities. Professional development opportunities, are lead by experts in the field. District leaders conduct learning walks which focus on providing teachers with helpful feedback to for further teacher development and increase student academic growth. Also, teachers volunteer their personal time to provide staff with professional developments throughout the school year to improve teacher and student learning. Additional professional development trainings cover Danielson, NJSLA , school safety, and health and well-being. Another PD goal includes having 80 % of the staff to become Google Certified.



### Student Supports and Services:

ESL is offered for limited English speaking students. A Child Study Team committee designs IEP plans. The 504 coordinator designs and revises 504s as needed. An I&RS (Intervention and Referral Services) team meets bi-monthly. A Positive Behavioral Support team meets bi-monthly. The school counselor and school social worker provide additional support for the school and for individual students who are in need of social/emotional assistance. Speech, Occupational Therapy, and Physical Therapy are provided to needed students. The Title 1 Program for Basic Skills is provided to students who need academic support. Orton Gillingham is provided to second and third grade students. Special Education services are provided to students who have IEP's.

Students receive a free breakfast and lunch program with an online menu listing the ingredients, calories, carbohydrates and other nutritional information alerting students with potential food allergies. The school nurse also provides students with regular yearly screenings. The screenings include vision and hearing, scoliosis screening, and blood pressure monitoring. Other yearly screenings will include dental, measurement of height and weight, monitoring student chronic diseases, administration of medication.



### Parent and Community Involvement:

Fully staffed Parent Teacher Organization with monthly meetings. Community links include the Civic League of Greater New Brunswick, Sister Cities Exchange Program, Play Unified, and LINKS Raritan Valley Chapter. OnCourse Parent Night\* offered each fall to all parents, Parents also trained in Google Suite applications and on the new OnCourse parent portal. Academic Parent-Teacher Teams (APTT) is a family engagement model, that strengthens teacher-family relationships by focusing on student academic growth and achievement.

School was built in 1954; 70 years old. Renovations included an wing addition which currently houses the sixth-eighth students. Eight portable classrooms have been added to the rear of the school. In June of 2024, the school received an updated Media Center and a school wide beautification project through Heart of America. An early-childhood playground was added to the facilities approximately 10 years ago. Students have access to a Library/Media center, Art room, Music room, and a multi purpose room which houses our gymnasium and cafeteria. We do not have an auditorium, all school events are held in the multi purpose room. Newly installed electronic temperature check machine, plexi glass protection at high traffic areas in the building.

We conduct two security drills each month, one fire drill and a lock down drill. We have a bus safety evacuation drill which is held twice a year for all students who ride the bus. School classes consist of nine 40-minute periods. Regularly scheduled in-service days allow for ongoing professional development opportunities on content areas, technology, social-emotional learning, school climate, and more. Current activities and events are updated daily on our school website. We maintain an active social media presence as well. We have a mandatory student uniform policy to deter bullying and ensure student safety. Students have the option to wear gym clothing for physical education classes. To address chronic absenteeism, we monitor student attendance closely and take appropriate action to reduce it. Students are acknowledged for perfect attendance during the quarterly awards ceremony.
