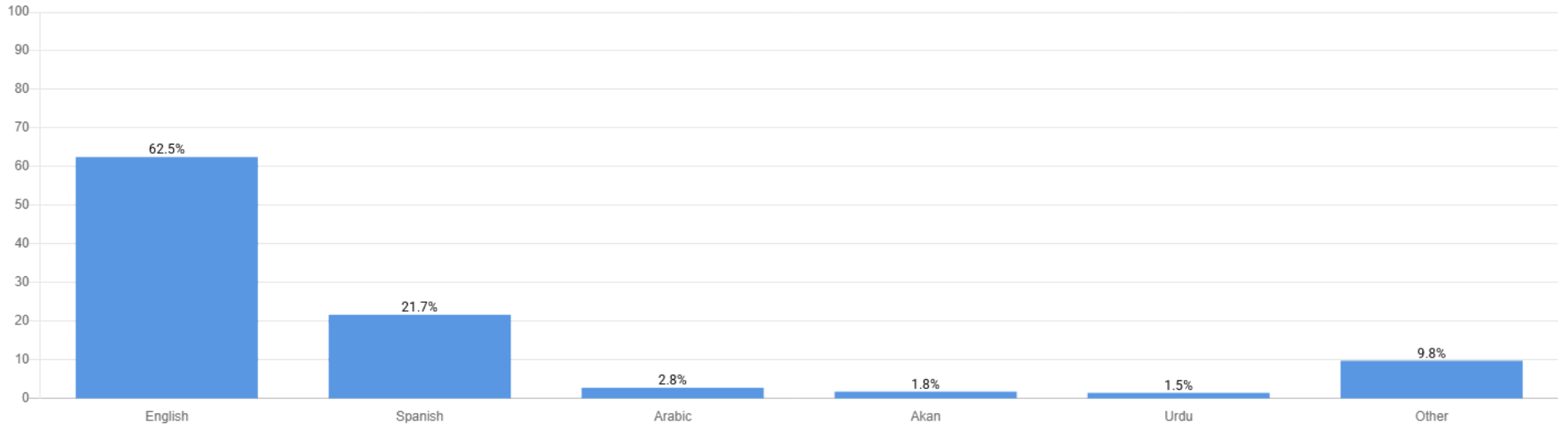

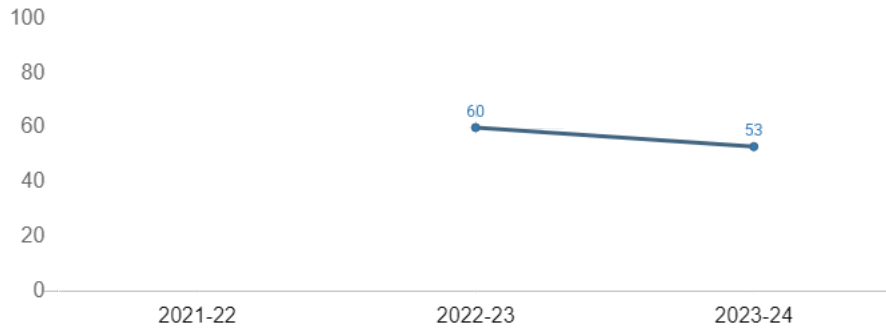

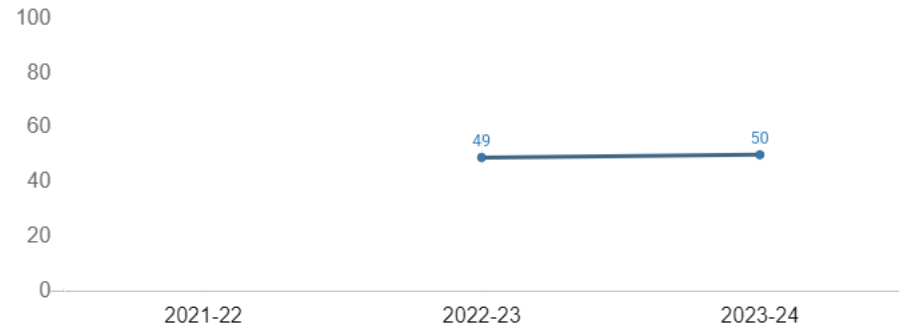

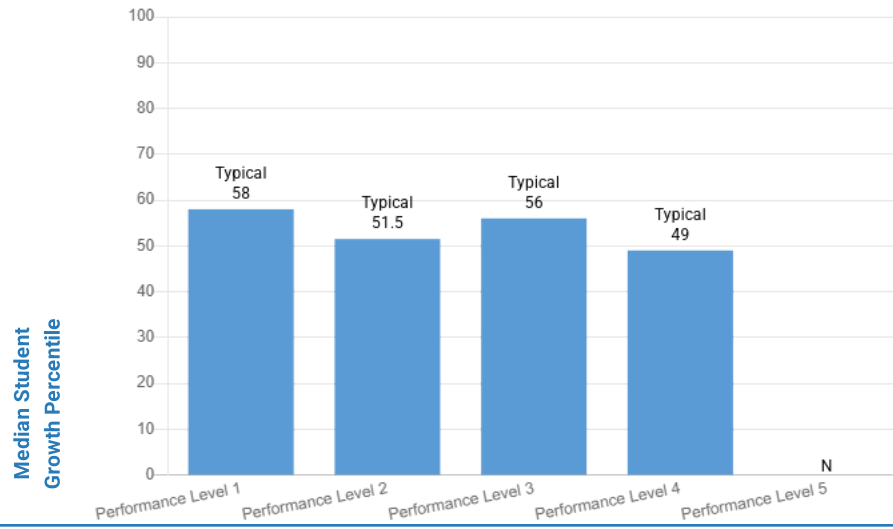

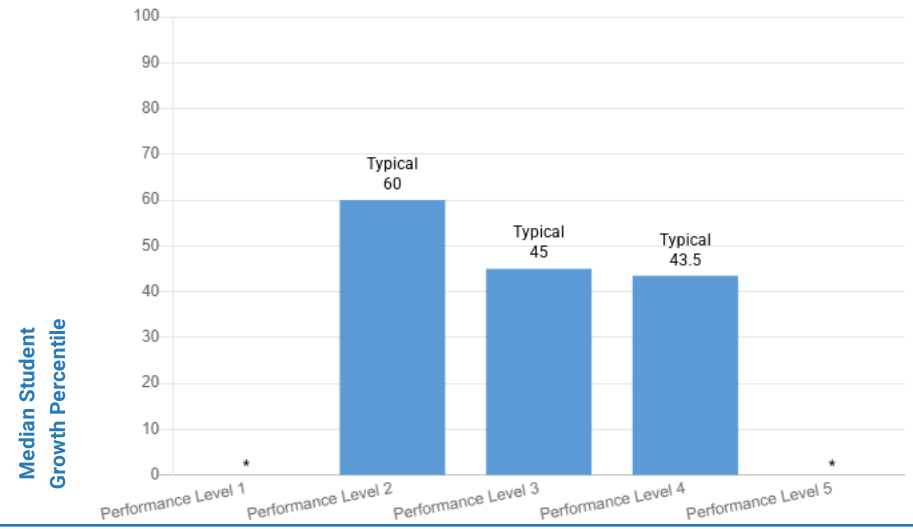

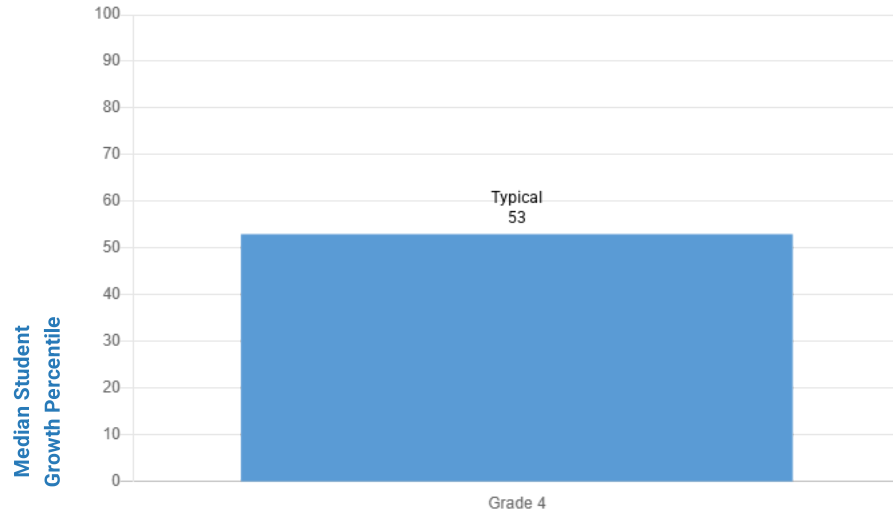

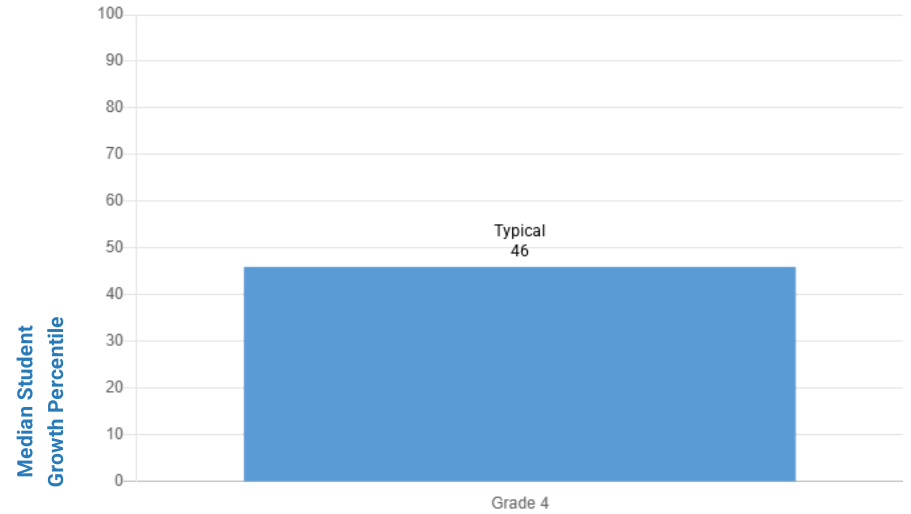

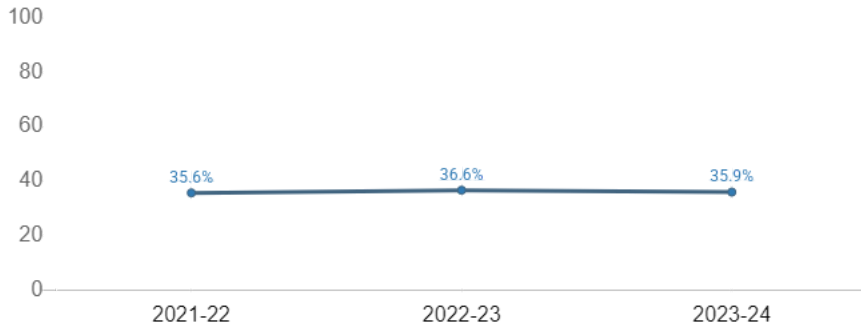

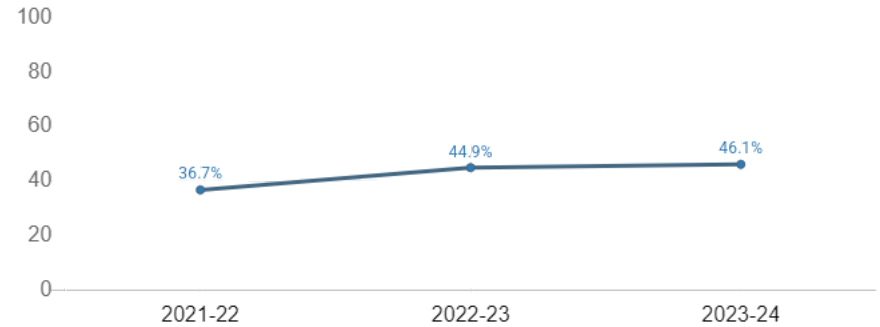
### English Language Arts and Mathematics Performance Trends

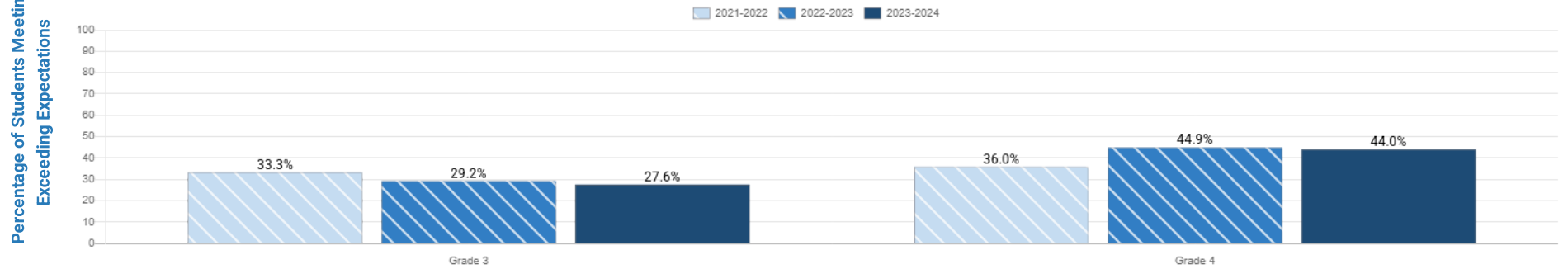

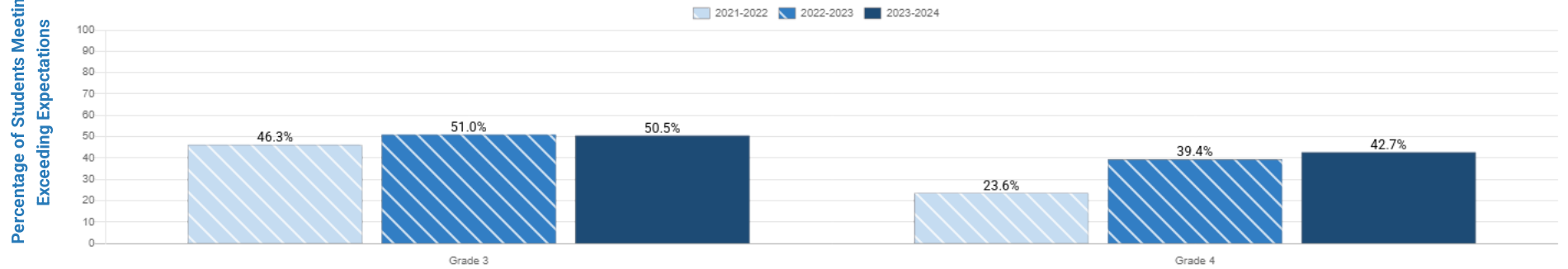

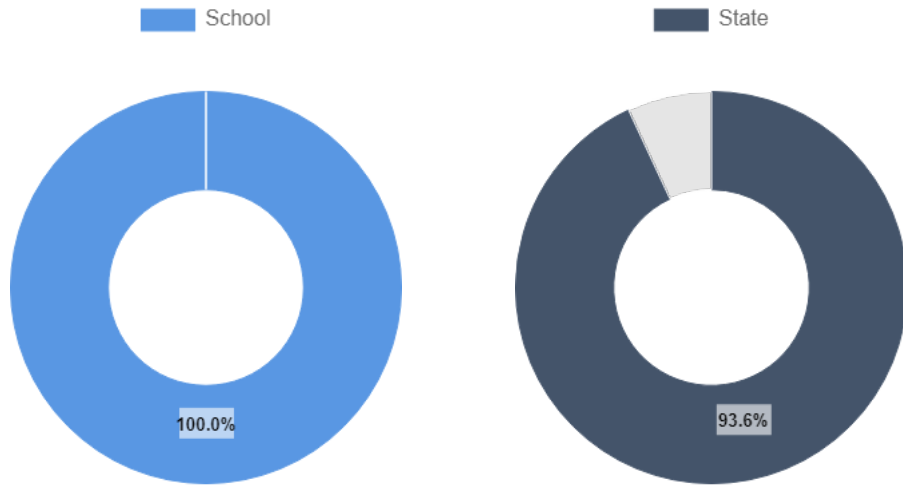

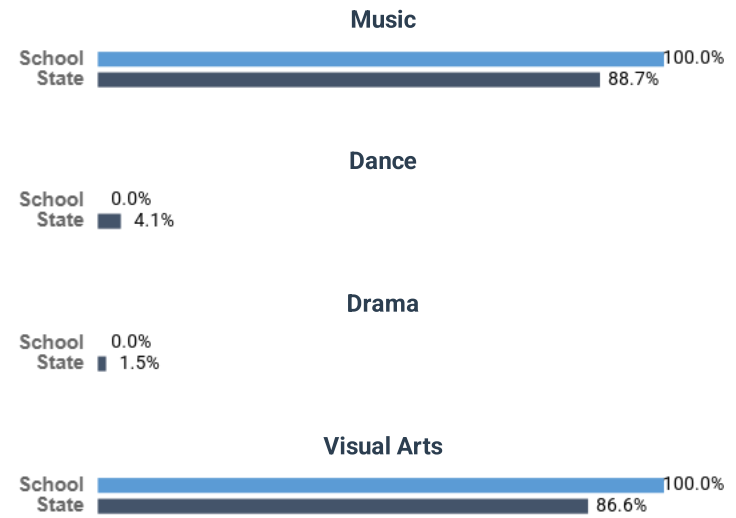

**Students enrolled in one or more classes by discipline:**



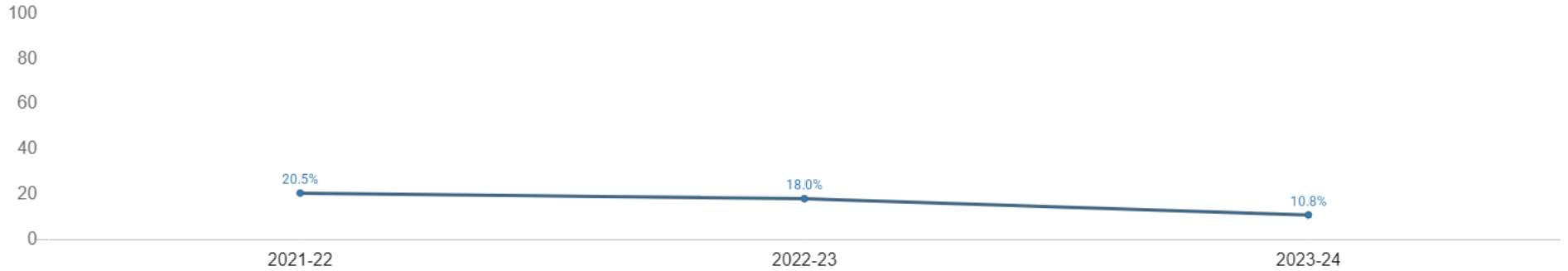

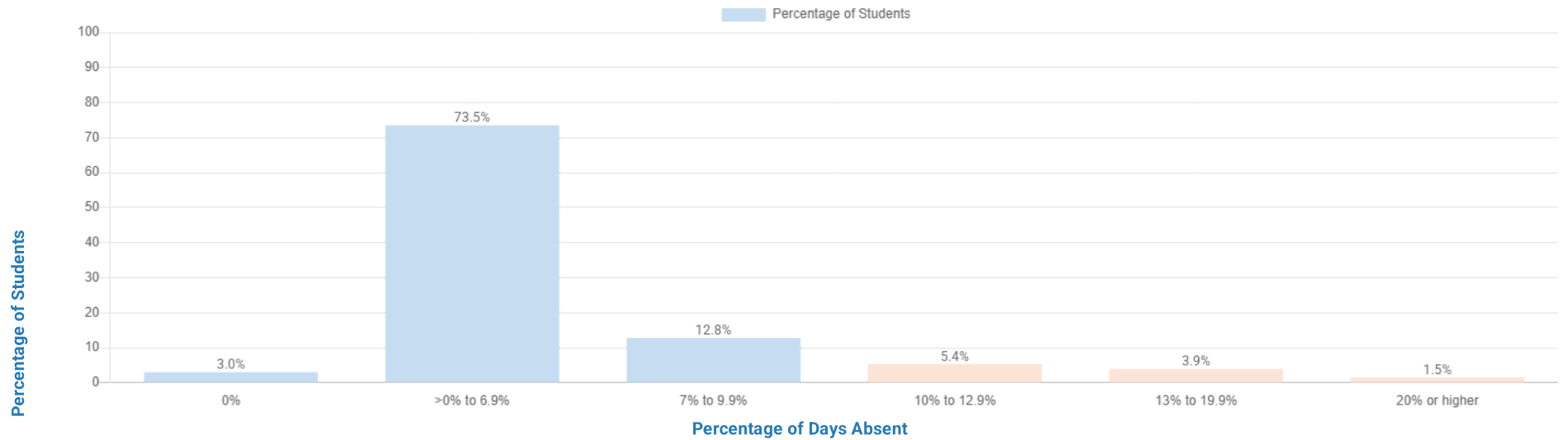

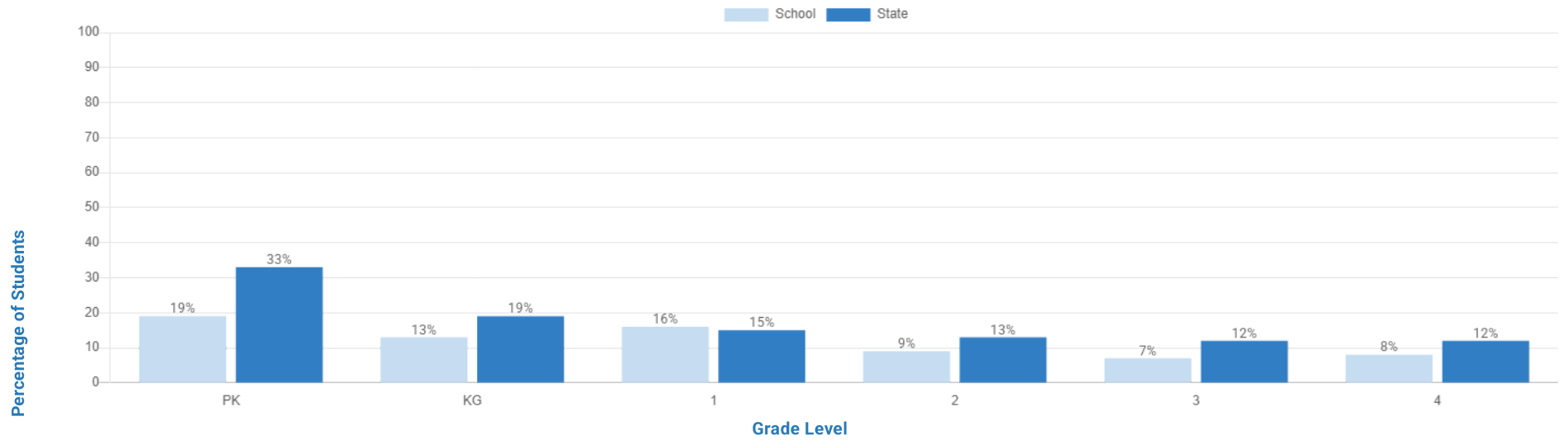

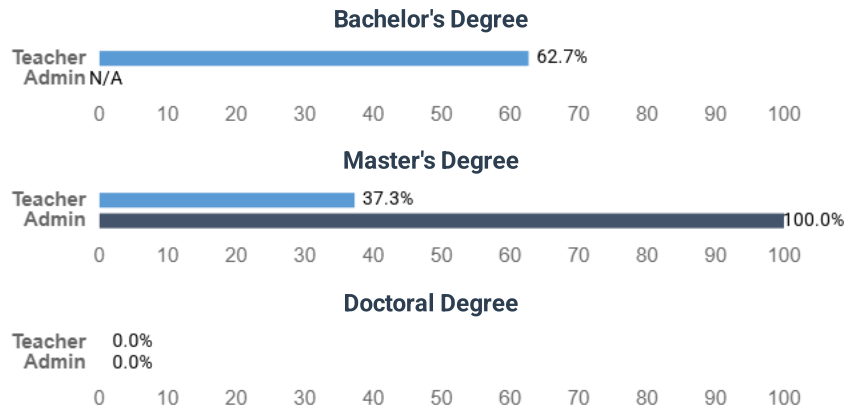

### Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. Schools are identified for ATSI if they have at least one student group that has a summative score that would be in the bottom 5% of Title I schools if it was its own school. Although our physical building is more than 50 years old, our building is "state of the art!" We house a full technology lab, gymnasium, and media center. In the area of fine arts, we have two music rooms (one for choral instruction and one for instrumental instruction). New floors, air conditioning, and painting throughout the building makes Judd an inspiring place to work and learn.



### School Safety:

Our fourth-grade students take an active role in promoting a safe and positive school environment through our expanding Safety Patrol program. This initiative, conducted in partnership with AAA, now includes bus patrols to help mediate potential conflicts during transit. It's a wonderful opportunity for students to contribute to school safety while developing critical life skills. Judd School is also in its eighth year of implementing the PBSIS (Positive Behavior Support in Schools) Initiative. Each classroom is equipped with interactive Newline boards which promote engagement and interaction among students and teachers, offering an immersive learning experience. These boards enable educators to incorporate multimedia elements into their lessons, making complex topics more accessible and stimulating for students. Plus, they encourage collaborative learning, allowing students to actively participate and share their ideas. With the integration of technology, these boards can transform traditional teaching methods into dynamic, interactive sessions.



### Early Childhood Education:

North Brunswick Township continues to be one of the school districts in New Jersey, afforded the wonderful opportunity to expand our preschool program through the Preschool Expansion Grant/State Aid Program. We have classrooms across all of our district four elementary schools and our two community partners, Lightbridge Academy and Acelero Learning Center. The NBT Preschool Community believes that building relationships and collaborating with all district stakeholders is critical in supporting our community of preschool learners. We have done this by working together with community partners and developing connections that will support our students and their families. We have a district wide NBT Preschool Family Group that meets monthly and is open to all district preschool families from all of our locations and programs. This group meets monthly for educational opportunities, program updates, and collaboration on preschool events.
