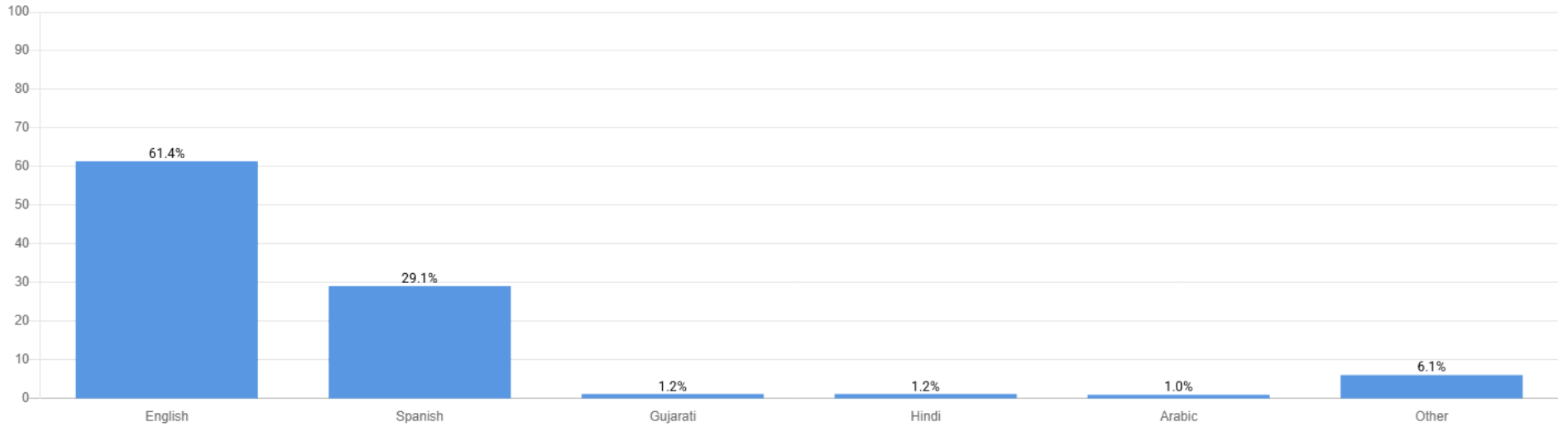

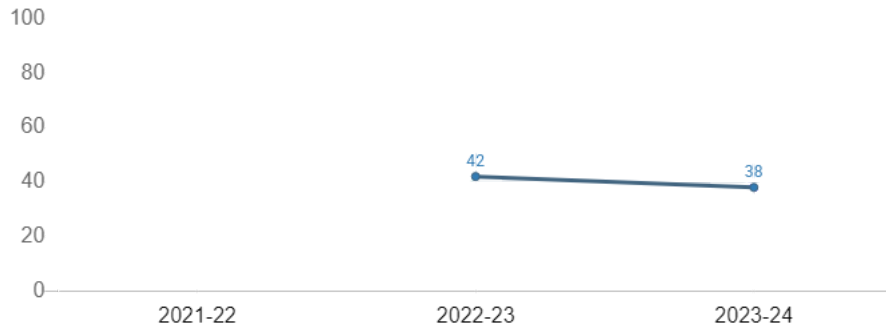

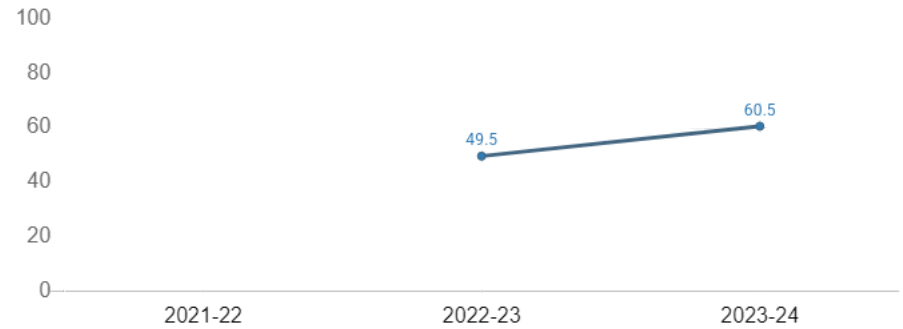

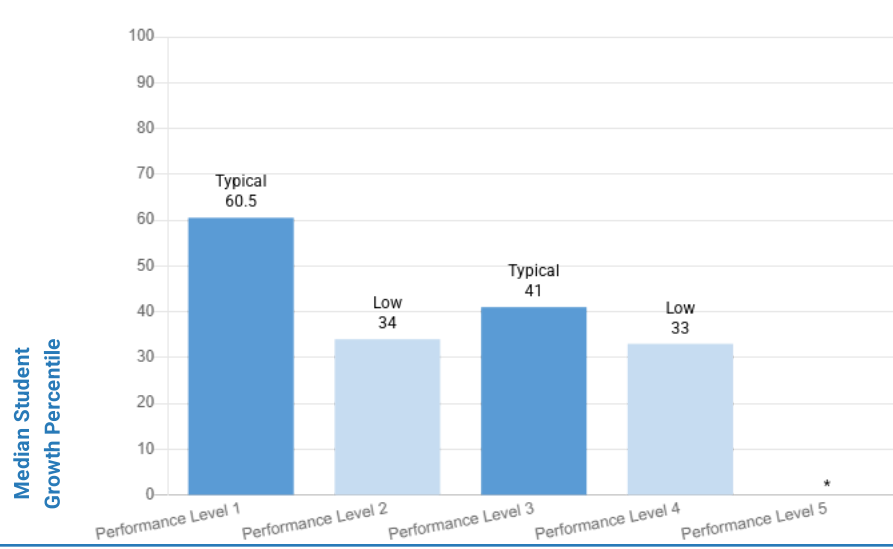

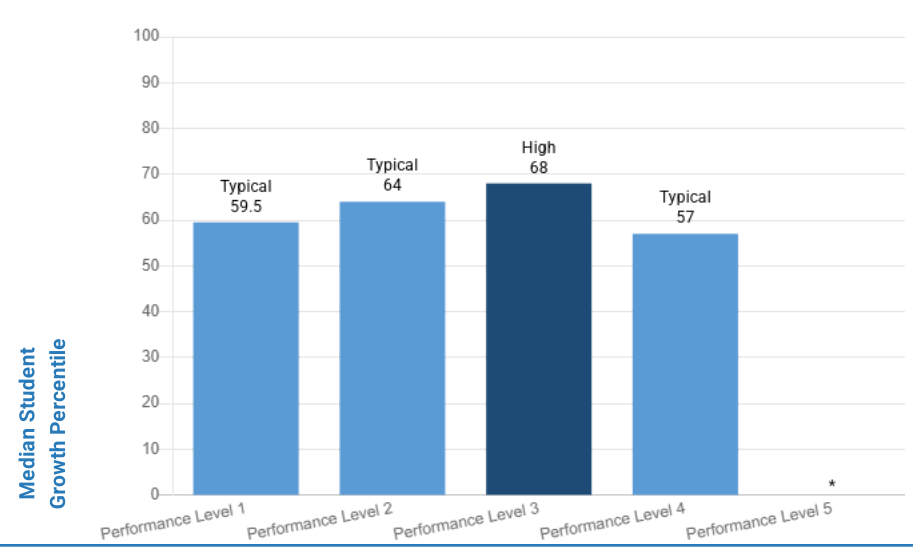

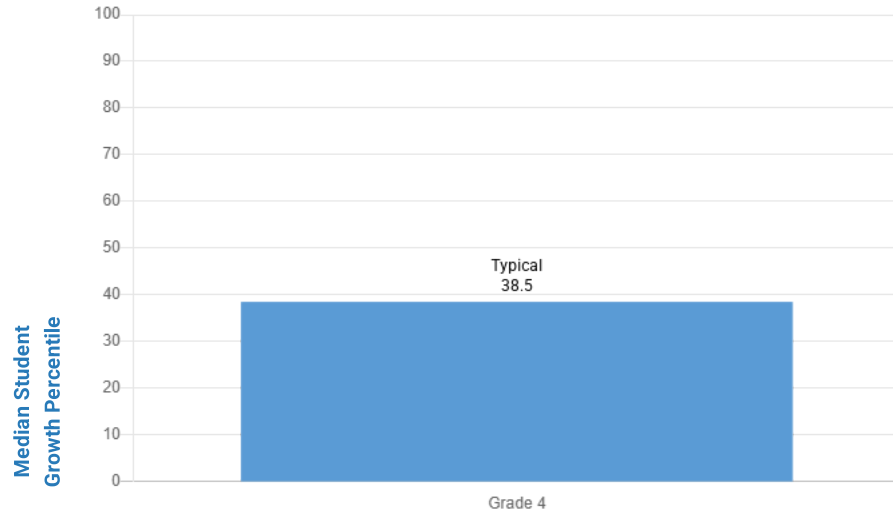

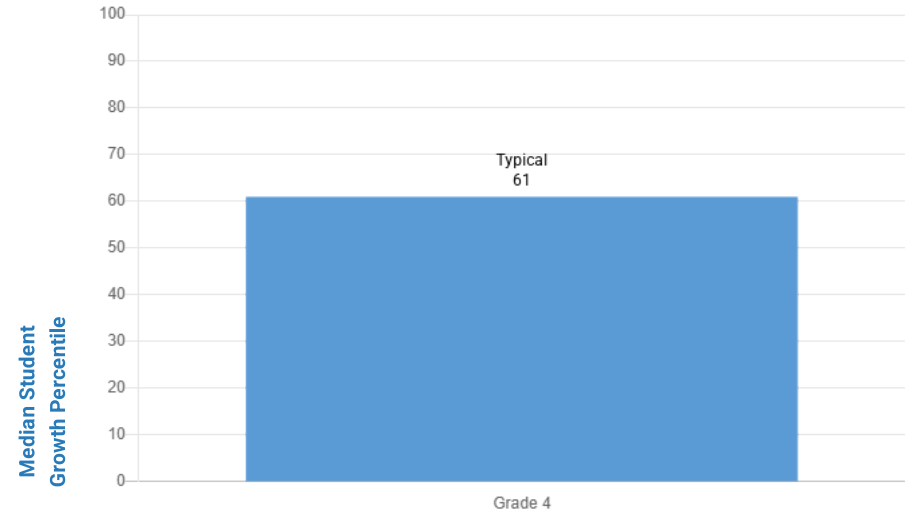

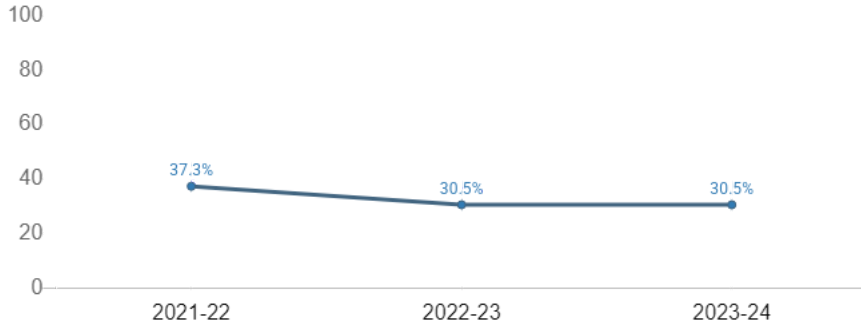

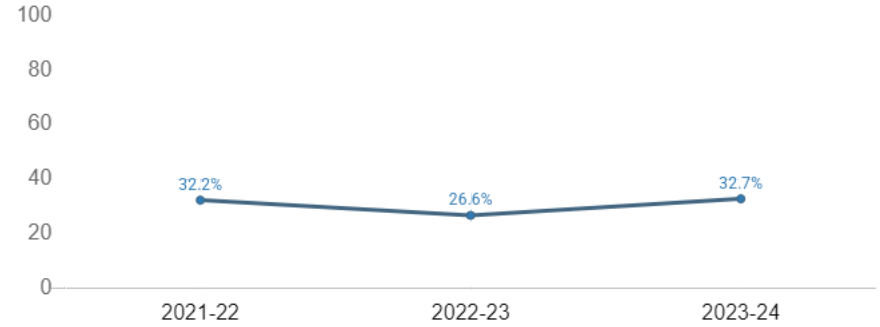
### English Language Arts and Mathematics Performance Trends

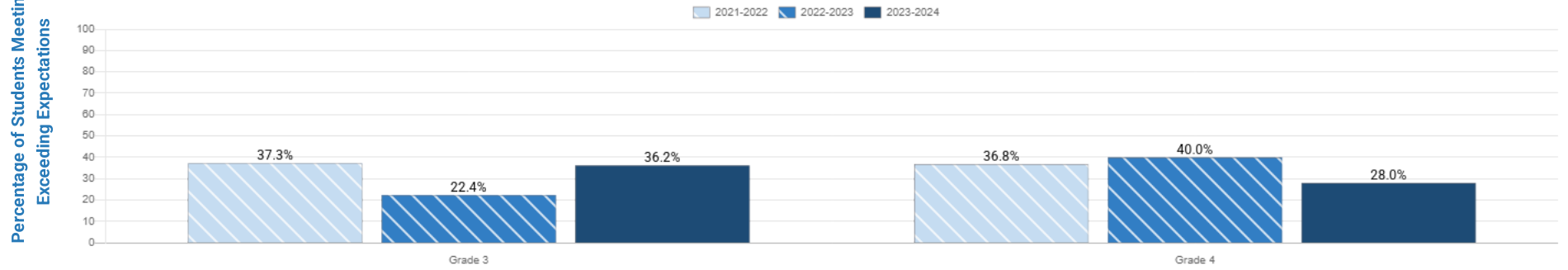

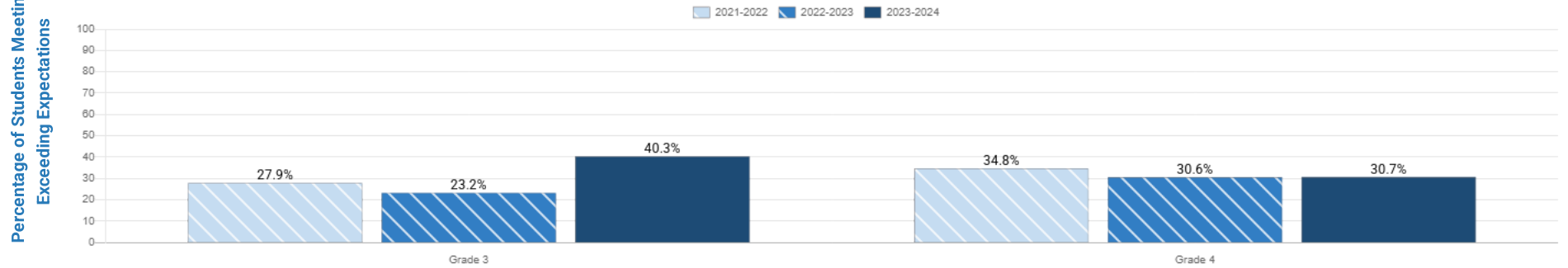

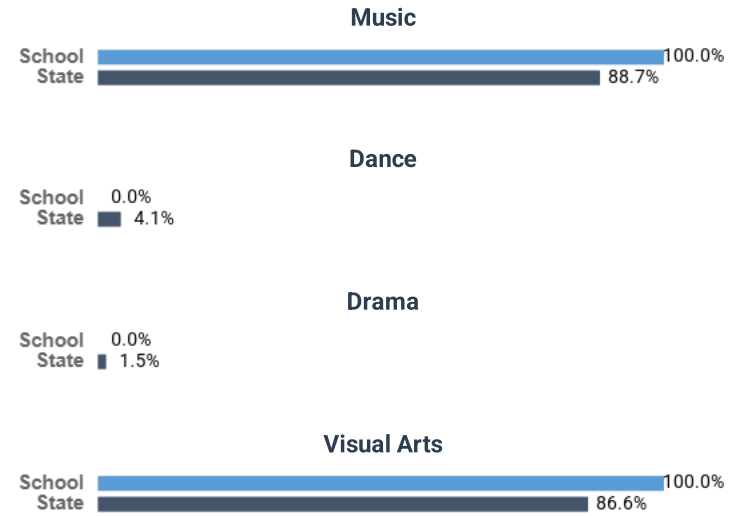

**Students enrolled in one or more classes by discipline:**



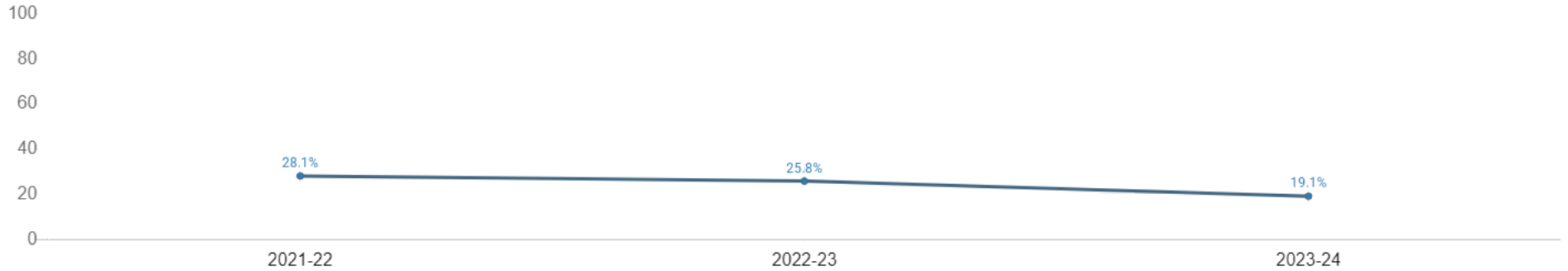

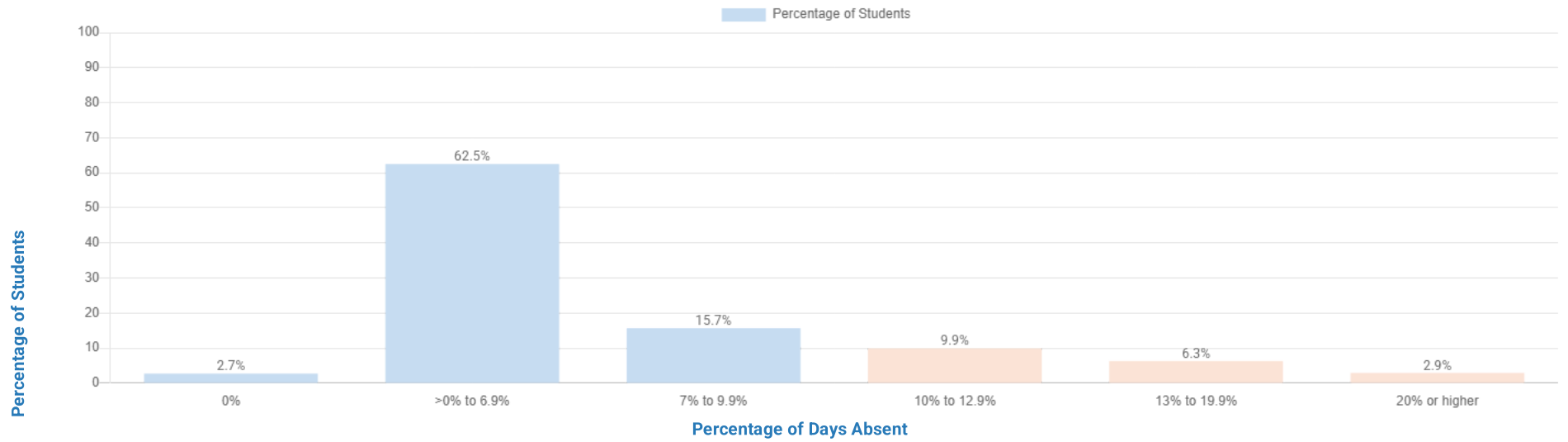

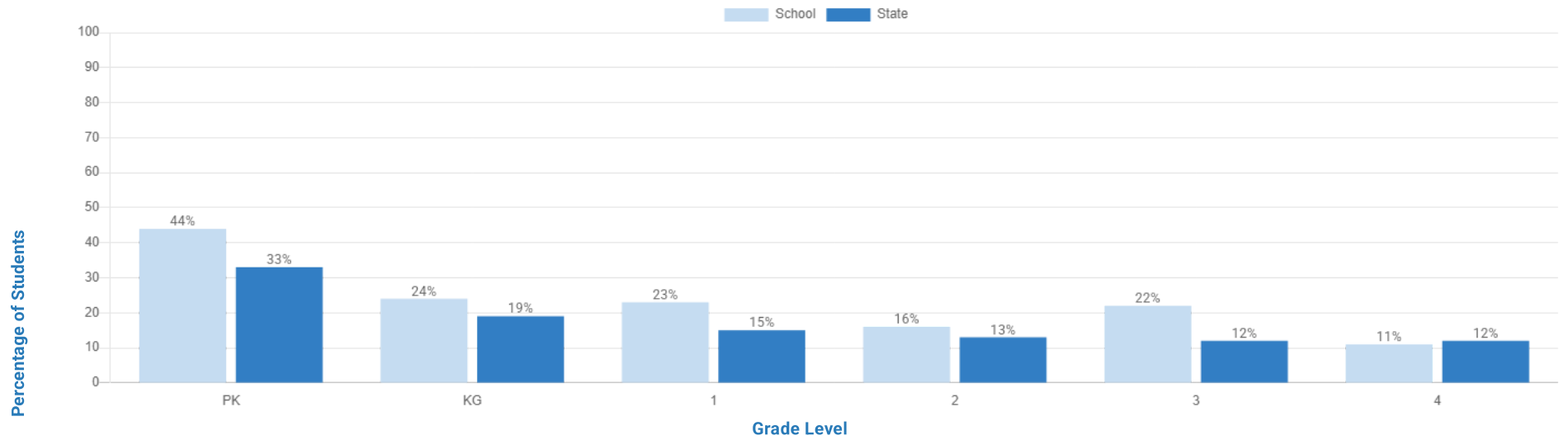

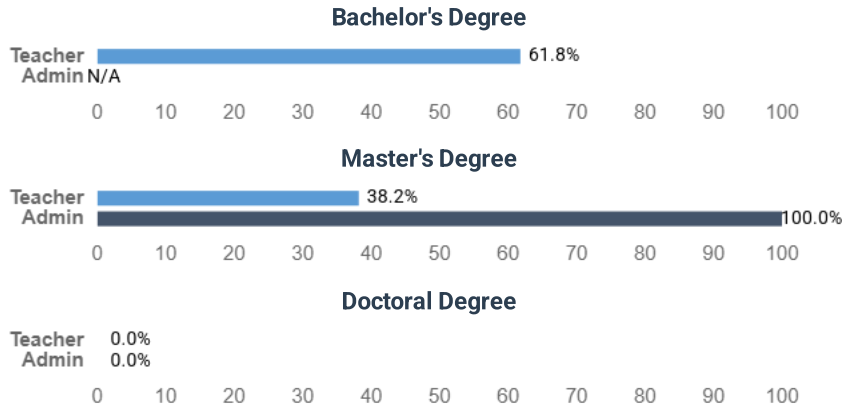

**Experience:** Experience is based on information submitted by districts on all their staff members. For purposes of this report, the ESSA Educator Equity and federal reporting requirements, NJDOE has defined teachers as "inexperienced" if they have fewer than four years of prior experience in a given district. The tables below report on "experienced" teachers and administrators for federal reporting purposes.

**Out-of-Field:** A teacher is labeled "out-of-field" if they are potentially teaching outside their area of certification. This could occur if the teacher cannot be found in the NJDOE's certification system, if their job code does not match their certification, or if the teacher has an expired certificate.

**Provisional Teacher:** A teacher with provisional certifications is a fully certified novice teacher of record who must meet further requirements of evaluation and mentoring during their induction into the profession before being granted "standard" or permanent certification.

### Teachers by Subject Area

This table shows the counts of teachers by subject area with gender breakdown, experience, and level of education. The staff counts in this table reflect staff assignments as submitted by districts to NJ SMART and reflect any teachers assigned and are not based on full-time equivalent (FTE). Note that some teachers may teach in multiple subject areas and may be counted more than once in this table, or they may only be counted in their primary subject area. Additionally, in many elementary schools, teachers are not assigned to specific subject areas, so they will appear in the Elementary (Not Subject Specific) category and not in the other subject areas, but that does not mean those subjects are not being taught in the school. ### Accountability Summary by Student Group - 2023-24 School Year

### Mission, Vision, Theme:

Livingston Park Elementary School serves a diverse population of students in grades PreK-4 in North Brunswick, New Jersey. We believe that all students can learn, and that everyone is entitled to a rigorous, high quality education in a safe and positive environment. We know that good character is developed through teaching, example and practice, and that creating a caring school community is a prerequisite to effective teaching and learning.



### Awards, Recognition, Accomplishments:

Livingston Park recognizes students in all grades from PK-4 who are demonstrating Cougar Pride, which corresponds with our Positive Behavior Support System. Four times a year, each teacher can nominate one of the students in their class who is demonstrating the core values of "Cougar Pride". The students come to school early with their families for a special ceremony, have their names and nomination letters read aloud, and are awarded with prizes and medals. Livingston Park has developed a dual language immersion program that supports the development of bilingual students. Students in the program receive instruction in both English and Spanish.



### Clubs and Activities:

Livingston Park provides multiple opportunities to be a part of clubs and activities. Livingston Park's Student Council gives youngsters a voice in school issues. The student government experience promotes citizenship and shared responsibility for the school. These values will carry over into the child's life and develop a sense of community. Students may also participate in Student Council Committees, Youth in Action, Chess, Robotics, Morning Math, Achieve, and Yearbook. Fourth graders have multiple opportunities to demonstrate leadership skills by taking part in a school job, such as bus safety helper, flag raiser, PBSIS helper, morning announcer, and peer mediator.

### Staff and Professional Learning:

All staff are required to engage in professional learning opportunities, and the district offers and provides various professional courses throughout the school year. Staff complete 17 hours of professional learning each year outside of school hours. Robust professional learning programs are offered by both administrators and certificated staff. The focus in 2023-2024 was on technology, SEL/self-care, dyslexia, and equity/culturally responsive teaching.



### Student Supports and Services:

Livingston Park provides tiered supports and services to meet the needs of our students. These services directly assist multi-lingual learners, students with disabilities and gifted and talented learners. Data teams meet regularly to analyze assessment data, and an I&RS team consults with teachers to design personalized supports.



### Student Health and Wellness:

Several programs allow our students to learn about health and wellness. In addition to physical education, all students have access to recess and a healthy breakfast program. Assembly programs work to teach children to stop bullying, have positive interactions with one another, and live healthy lifestyles. A Positive Behavioral Supports program helps students learn the expectations for safe and positive behavior in school. A Mental Health Screener is given to students 3 times per year to identify additional students who may be struggling or need support. We also utilize a mentor program where teachers can volunteer to mentor a student in the school to provide additional support.

### Parent and Community Involvement:

Parents are valued partners in the educational process and their participation is welcomed. Parents support and strengthen school programs and contribute greatly to our children's success through Livingston Park's PTO. The PTO sponsors assembly programs, coordinates classroom volunteers, and hosts a series of events for our students and their families. The local police and fire departments partner with our school to help students learn about safety and responsibility.



### Facilities:

Though Livingston Park was constructed in 1896, the building has been renovated extensively over time. Our school is air-conditioned and has a school library, computer lab, cafeteria, gymnasium, and many classrooms. Multiple play areas are available for students. A kind and caring facilities staff, led by our plant manager, keeps our school spotlessly clean and in tip-top shape.



### School Safety:

Staff have been trained at the very beginning of the year on school safety protocols, drills, and what to do in each type of emergency. Not only are the staff prepared in their classrooms, but they are prepared if there is an emergency in any location in the building (cafeteria, hallway, etc.).

### Technology and STEM:

Technology is integrated throughout the curriculum both in the use of specific software (Letterland, BrainPop, Reading Eggs, Math Seeds, Benchmark Universe, Savvas Realize, Scholastic Lit Pro, Smithsonian Science, Learning A-Z, G suite for Education, Tynker, SeeSaw, Typetastic) and in the sense that students have access to digital materials and resources. We are a 1:1 school with each student having access to a chromebook. Students are taught more targeted skills during technology class where they learn about Digital Citizenship, keyboarding skills, computer coding, and Lego Robotics.



### Early Childhood Education:

North Brunswick Township continues to be one of the school districts in New Jersey, afforded the wonderful opportunity to expand our preschool program through the Preschool Expansion Grant/State Aid Program. We have classrooms across all of our district's four elementary schools and our two community partners, Lightbridge Academy and Acelero Learning Center.
