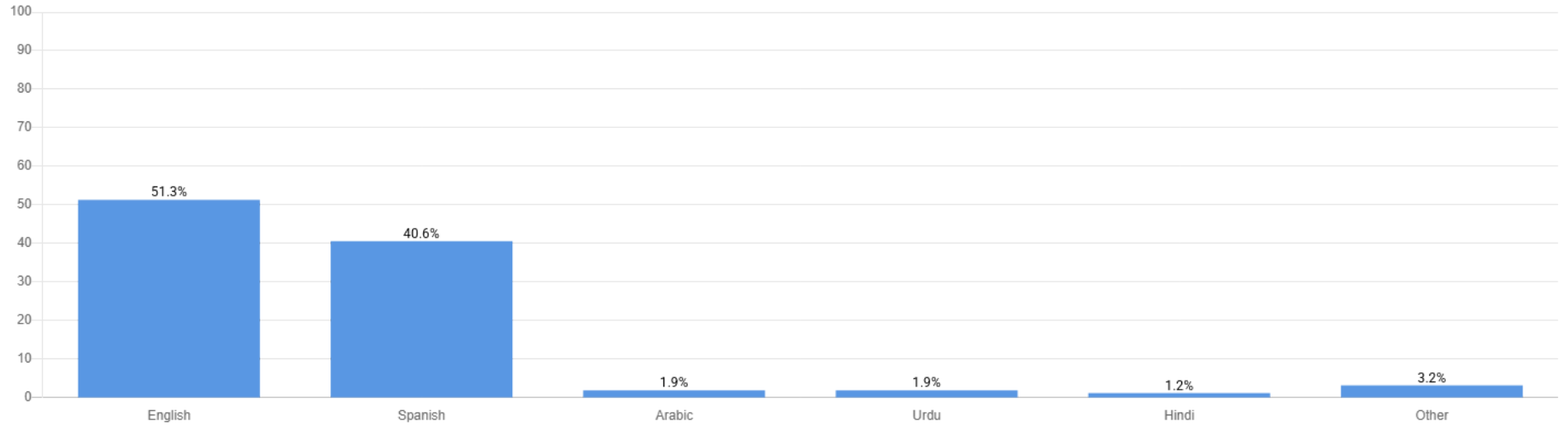

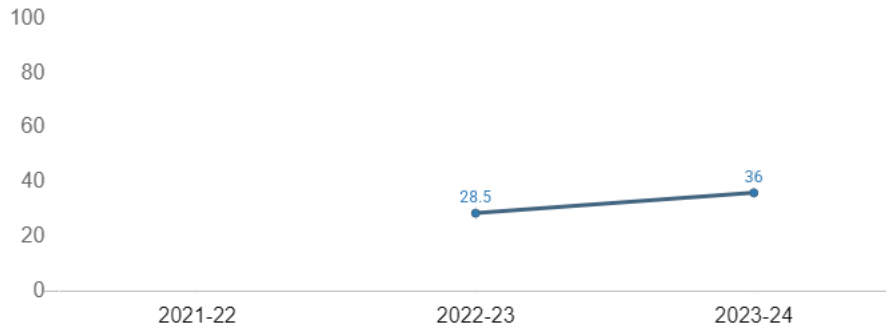

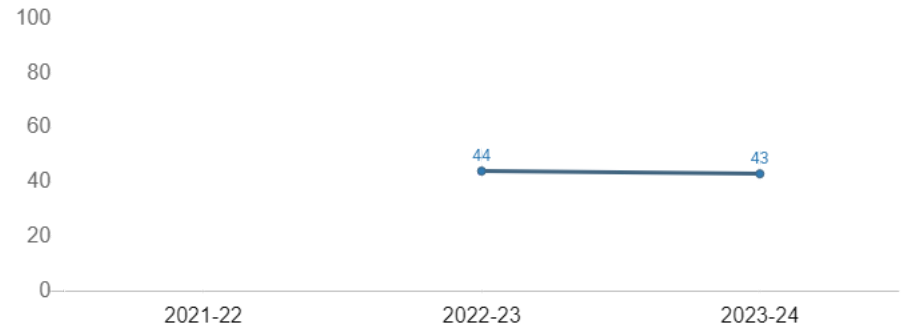

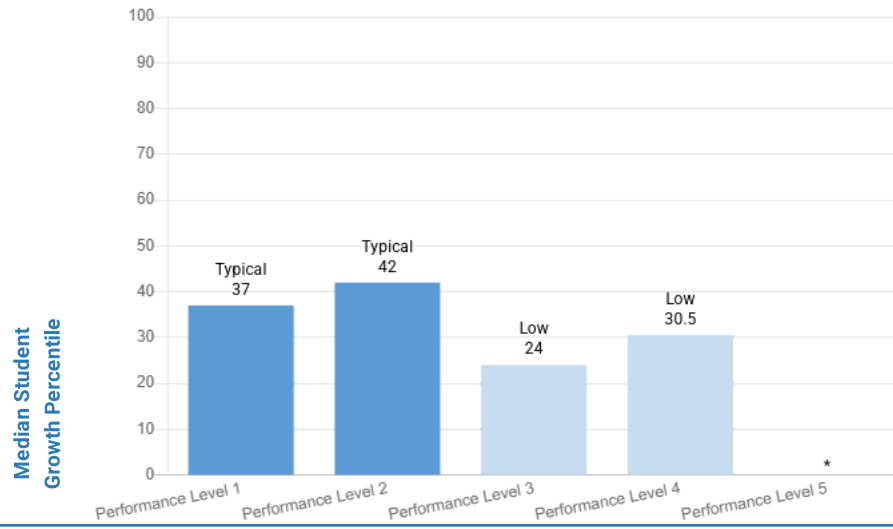

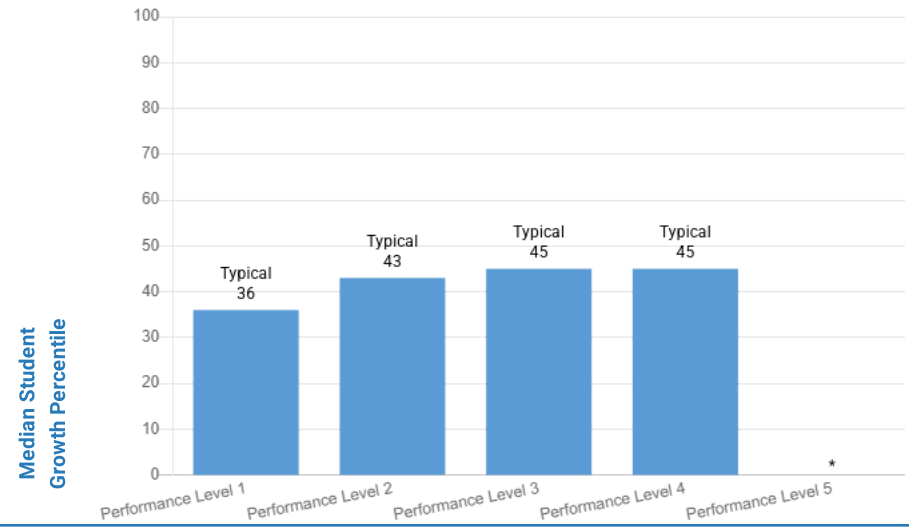

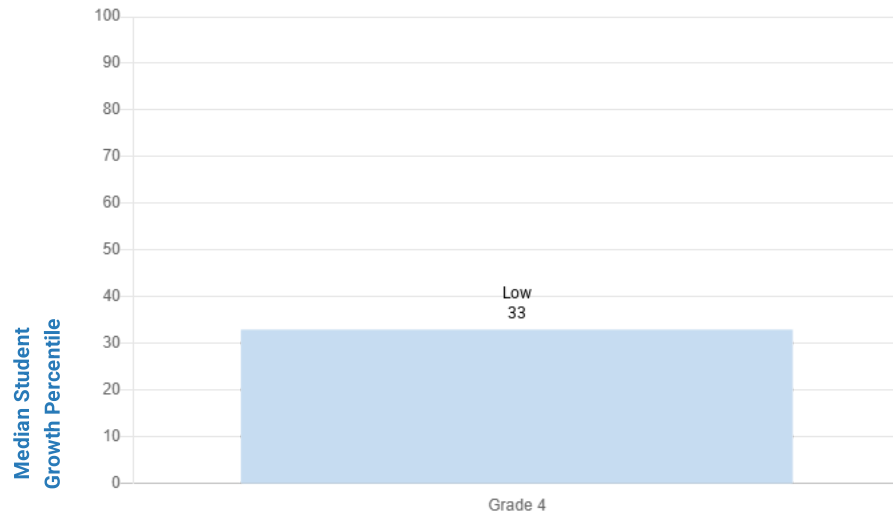

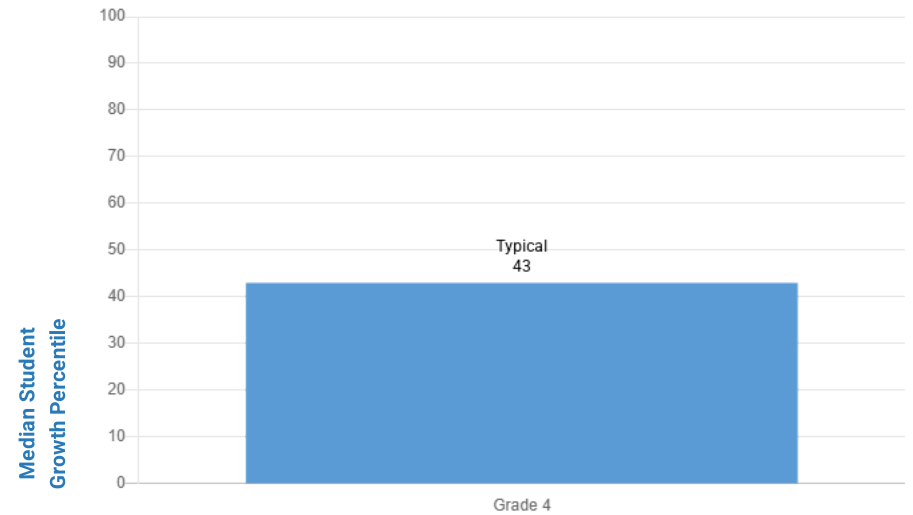

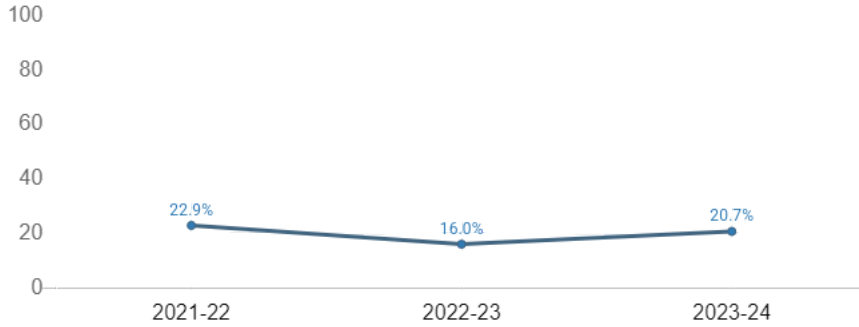

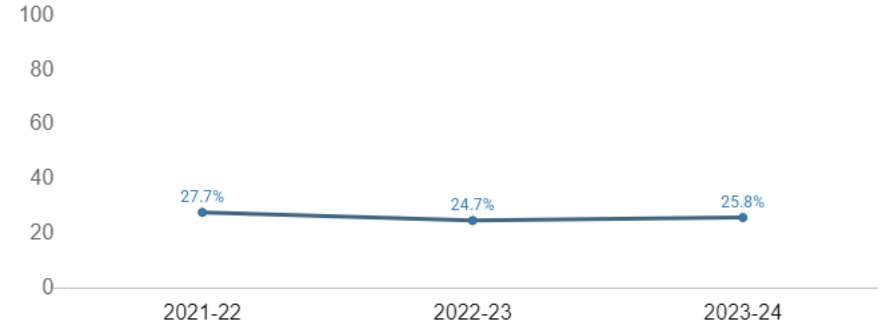
### English Language Arts and Mathematics Performance Trends

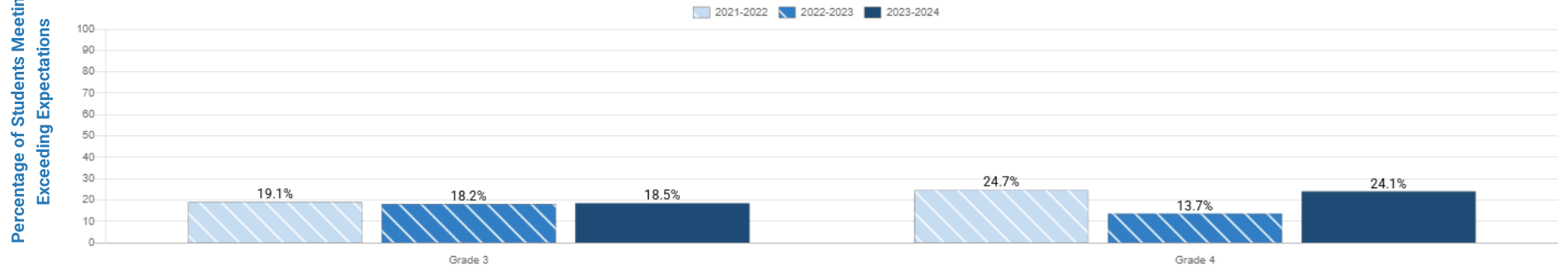

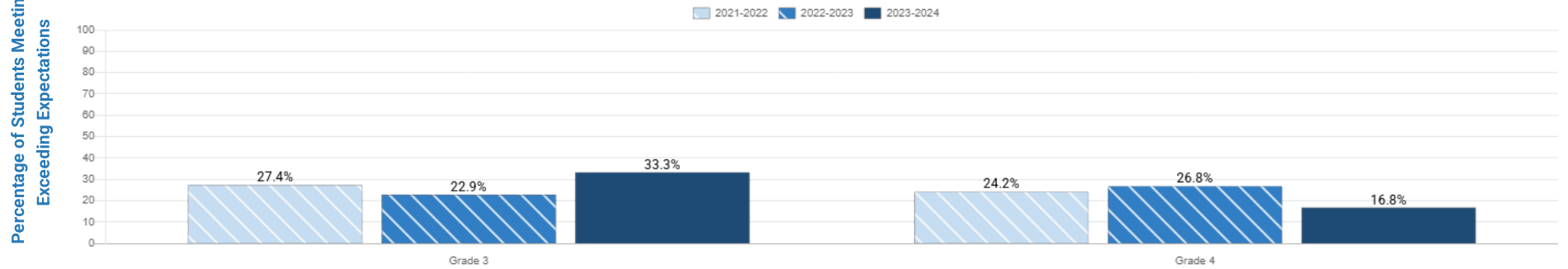

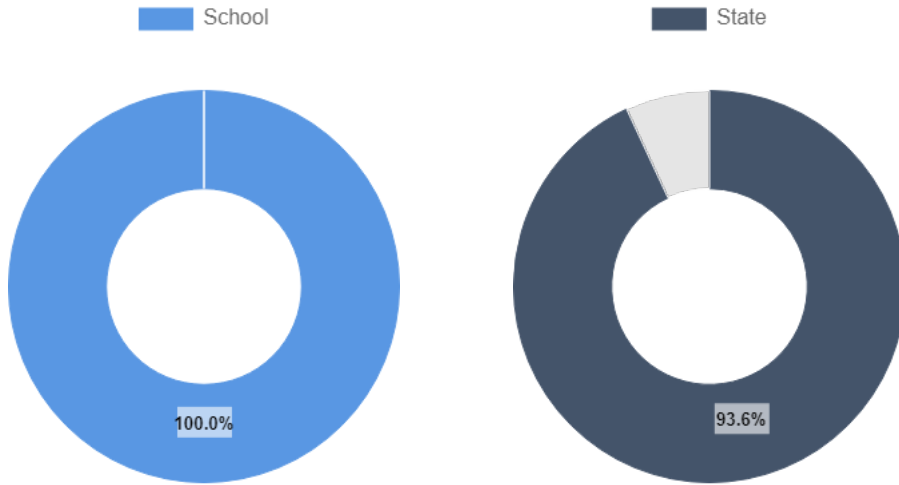

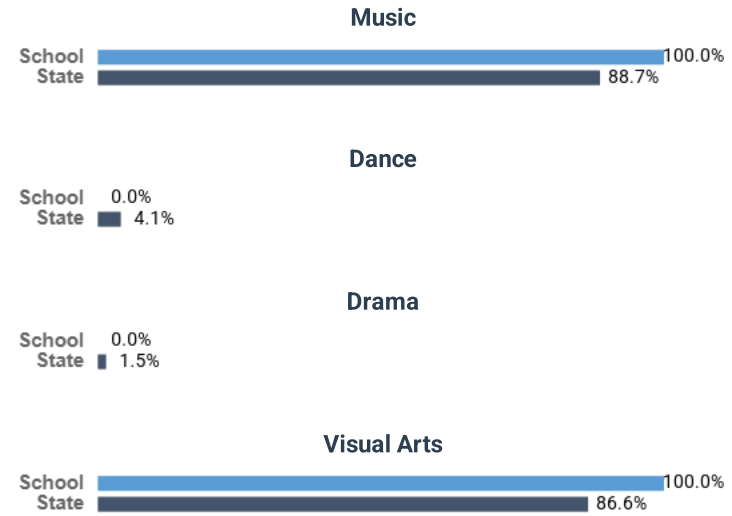

**Students enrolled in one or more classes by discipline:**



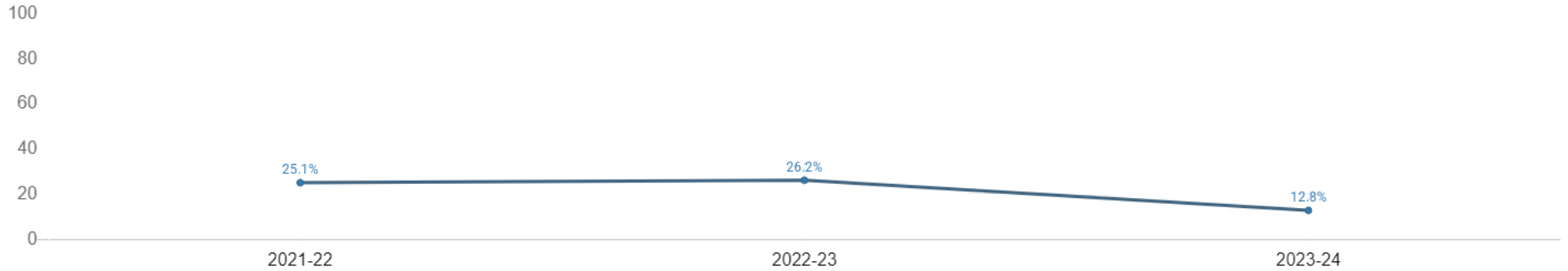

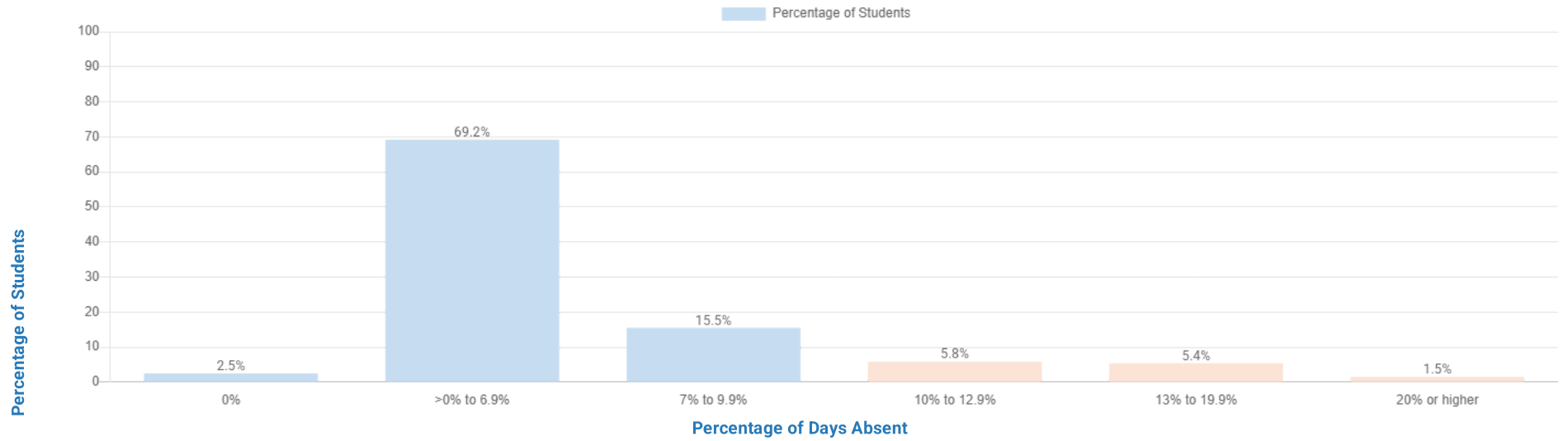

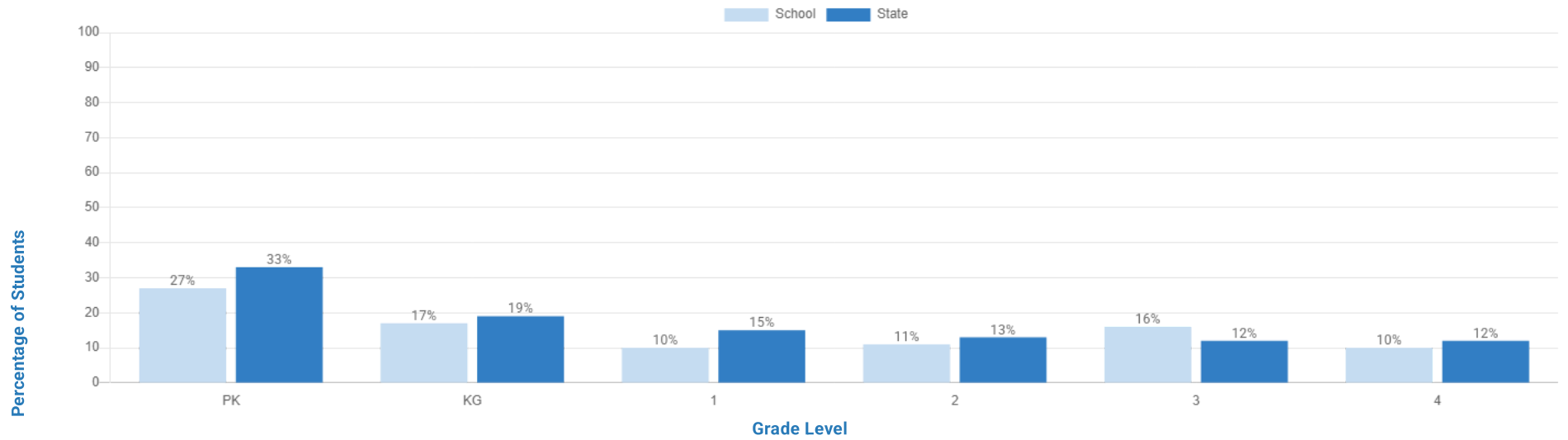

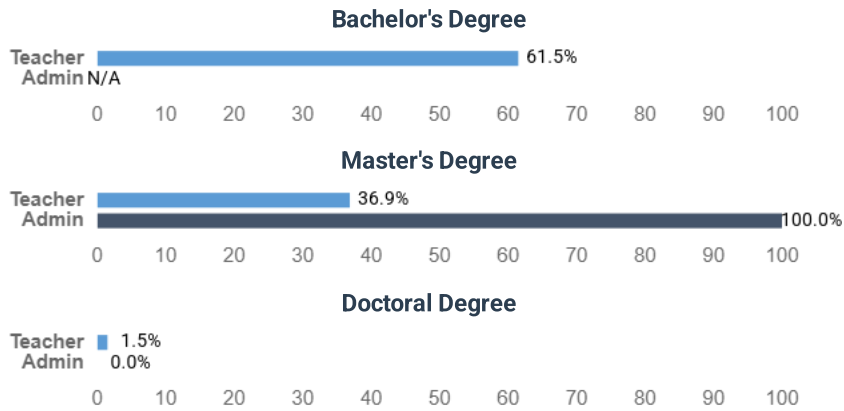

### Courses, Curriculum, Instruction:

In ELA we utilize the Science of Reading model through Benchmark which includes reading, writing & language. Our phonics instruction utilizes Letterland and Heggerty. The enVisions Math program utilizes a combination of problem-based learning with visual learning. Students learn more about math by solving rich, reality-based problems. They gain a deeper, clearer understanding of math concepts with visual models and scaffolds. Our Science literacy program utilizes hands-on explorations, which provide a framework for standards-driven learning goals and student-centered instruction. Our teachers utilize differentiated instruction to meet the needs of individual learners. SOAR, our program for gifted and talented students, offers challenging supplemental activities during the school day. We offer a dual language immersion program (Eng/Span) beginning in Kindergarten. The program follows our ELA/Math/Science/SS curriculum as well as Estrellita, Heggerty & Lunita for phonics.



### Clubs and Activities:

At Parsons school our students participate in a variety of activities including, Student Council, Peer Mediators and Safety Patrols. Students also participate in Achieve, Robotics, SOAR, Chess and Parsons Pride.



### Before and After School Programs:

We offer before and after school intervention and enrichment programs including Achieve-ELA, Morning Math, Robotics and Chess. We also offer Parson's Pride whose mission is to provide students an opportunity to succeed by developing school relationships that will increase their self esteem, help foster stronger grades and provide a friendly atmosphere that will develop positive relationships here at Parsons School. We offer before and after care through The L.E.A.L. program, facilitated by our township, and the Right at School program, through a private provider.

### Staff and Professional Learning:

ELA, Math and Special Education coaches provide ongoing professional development and support to help differentiate instruction to meet the needs of all learners. A Dual Language consultant provided guidance on best practices for the progression of dual language from Kindergarten-Grade 4. Faculty meetings focused on differentiated instruction utilizing multi-tiered system of supports in reading and math to improve delivery of instruction. Weekly Professional Learning Communities met to analyze data to purposefully meet the needs of our subgroups (ED, SE, ELL). Staff participated in professional development in a multitude of areas including, data analysis, intervention strategies, multi-sensory strategies, I&RS process and social emotional learning.



### Student Supports and Services:

Classroom support models include but are not limited to, co-teaching, resource room, and self-contained classrooms. Our ELL population is supported by our Dual Language program, Bilingual program and ELL specialists through push in and pull out programs. Students with disabilities are supported through our CST, behaviorist and counselor to provide an educational program in a least restrictive environment. Intervention and Referral Services team through a collaborative effort assists teachers, parents and students with learning and behavioral issues. Academic Support in ELA/Math/Dual Language provides intervention and enrichment to identified students. In addition, students and staff are supported by an ELA coach a Math coach and a Special Education Coach.



### Student Health and Wellness:

We offer a breakfast and lunch program at our school. Teachers promote healthy snacks in the classroom. Students participate in physical education class twice a week and recess daily. Students participate in a daily social emotional wellness activity daily. We have a partnership with UBHC to provide clinical counseling and mental health services to those students in need who qualify. We have a mental health thrive team that analyzes students emotional health and wellness throughout the year providing necessary supports and resources. Our school nurse provides health resources to families. Our school nurse provides screening in: vision, hearing, height, weight and scoliosis. Parsons School, nestled in the corner of beautiful Babbage Park, serves 550 students from PreKindergarten through Grade 4. Our building has been in existence for 58 years and has had significant additions and renovations. Our school includes a library, computer lab, two music rooms, cafeteria, gymnasium and many classrooms. All instructional classrooms have air conditioning as well as smartboards. Multiple playgrounds are available for students as well as our courtyard.

### Early Childhood Education:

North Brunswick Township continues to be one of the school districts in New Jersey, afforded the wonderful opportunity to expand our preschool program through the Preschool Expansion Grant/State Aid Program. We have classrooms across all of our district four elementary schools and our two community partners, Lightbridge Academy and Acelero Learning Center. The NBT Preschool Community believes that building relationships and collaborating with all district stakeholders is critical in supporting our community of preschool learners. We have done this by working together with community partners and developing connections that will support our students and their families. We have a district wide NBT Preschool Family Group that meets monthly and is open to all district preschool families from all of our locations and programs.
