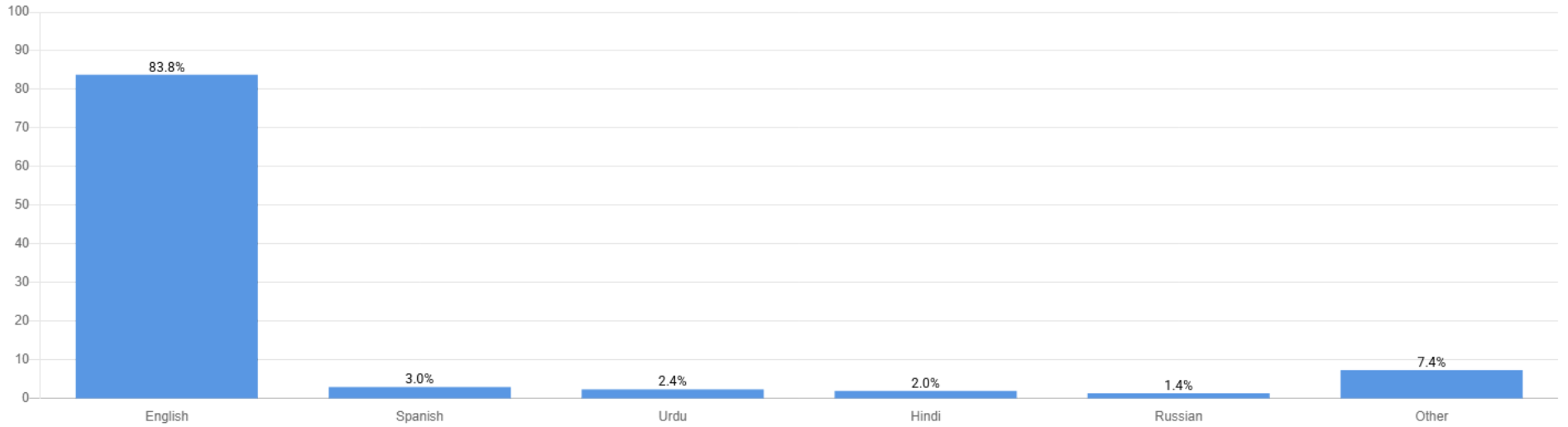

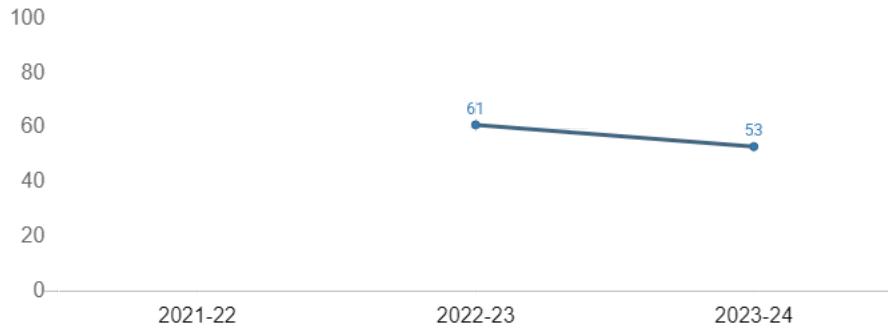

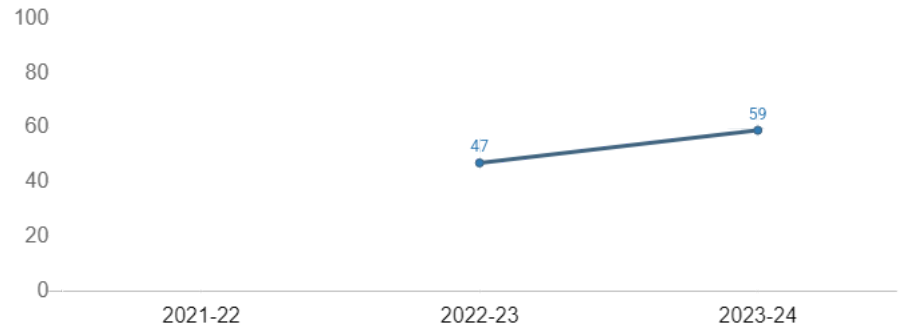

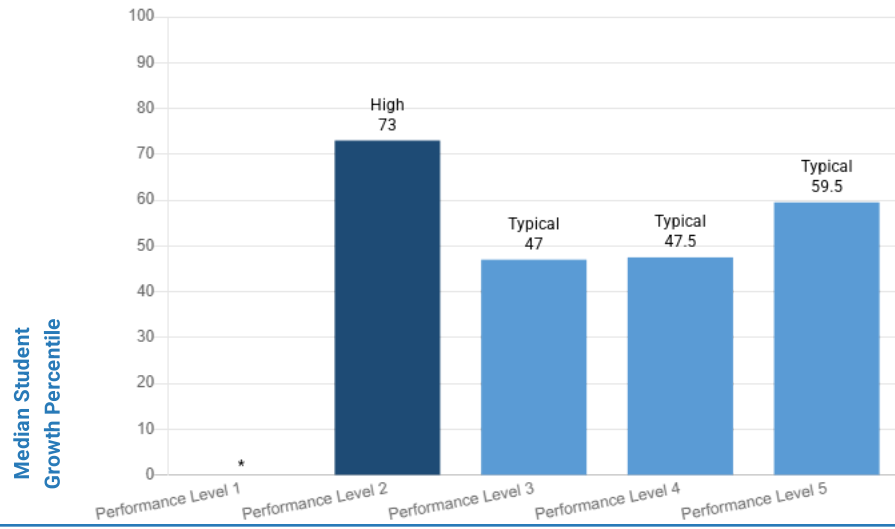

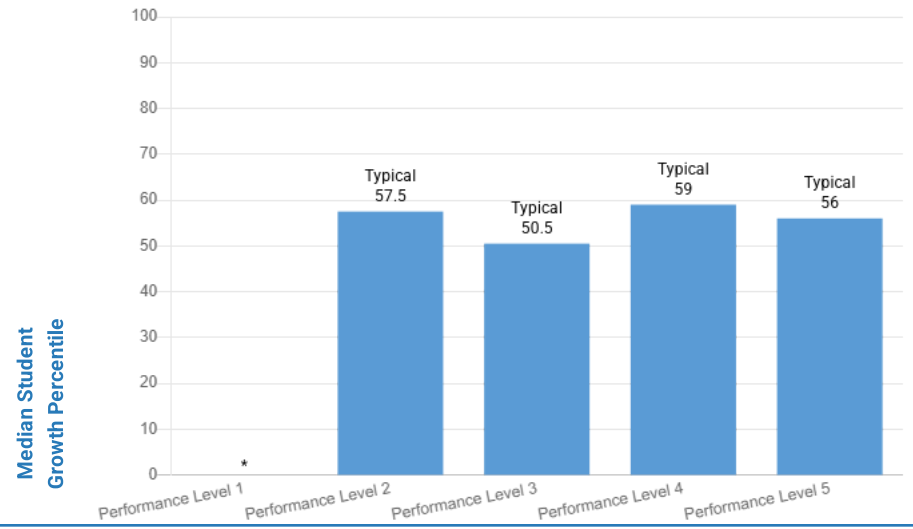

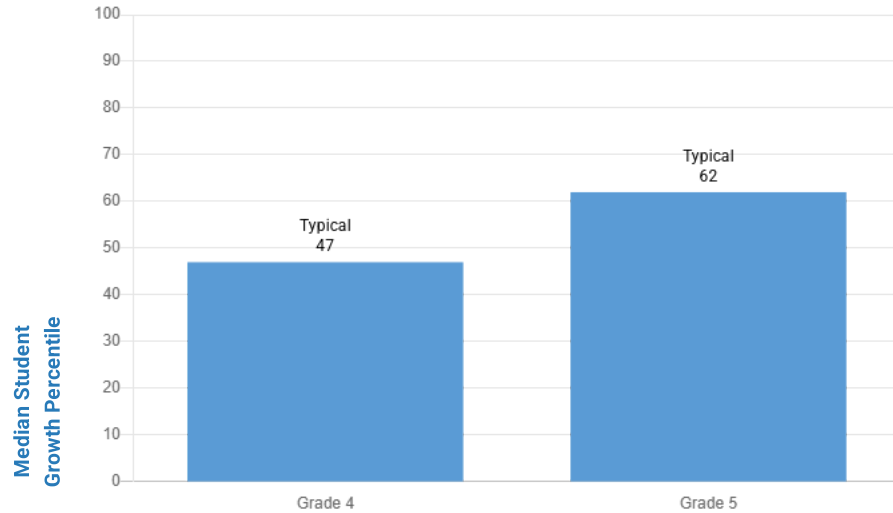

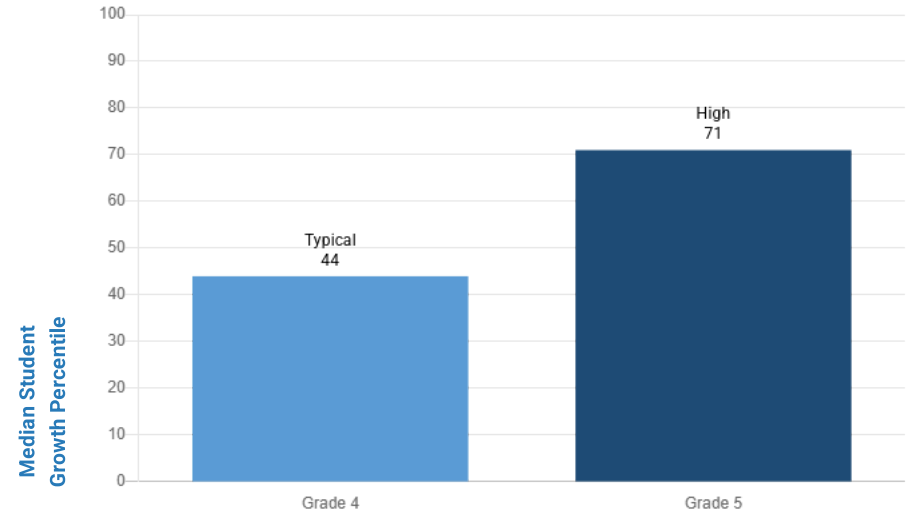

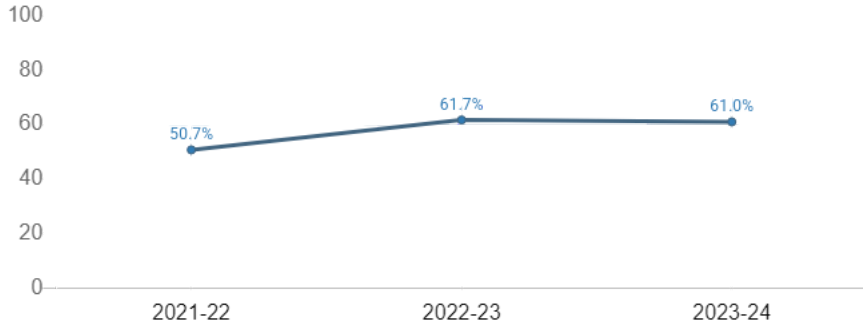

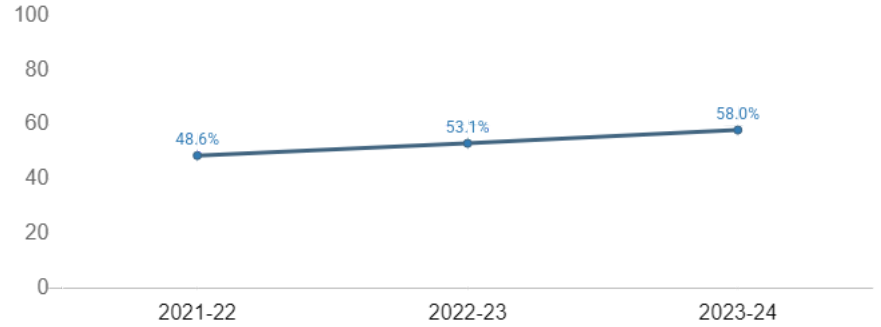
English Language Arts and Mathematics Performance Trends

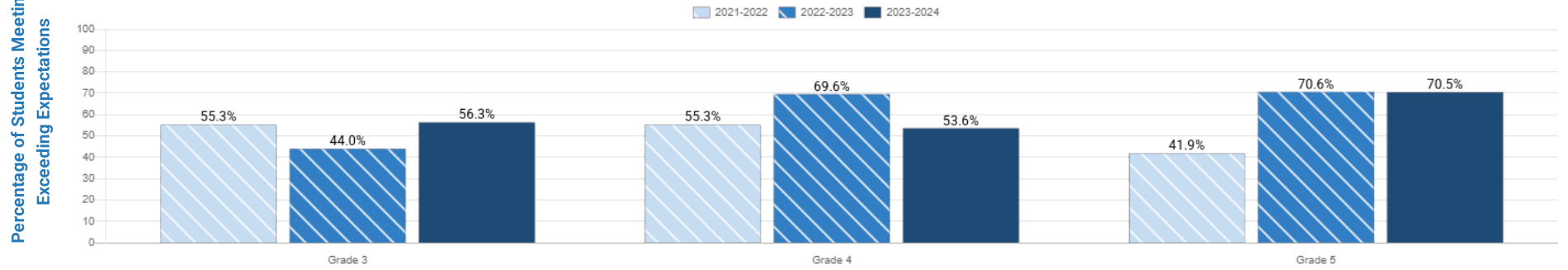

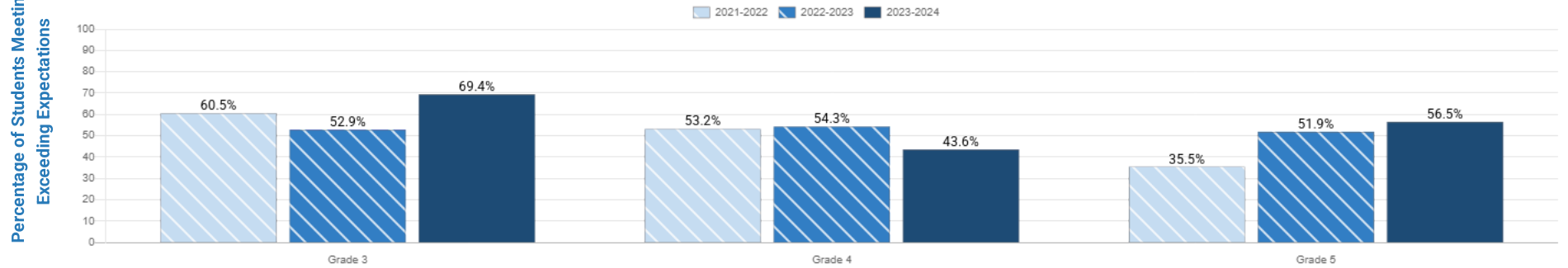

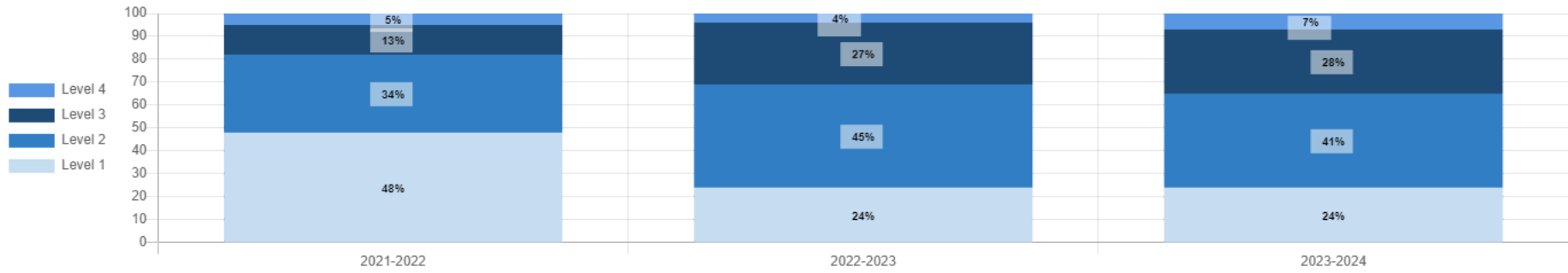

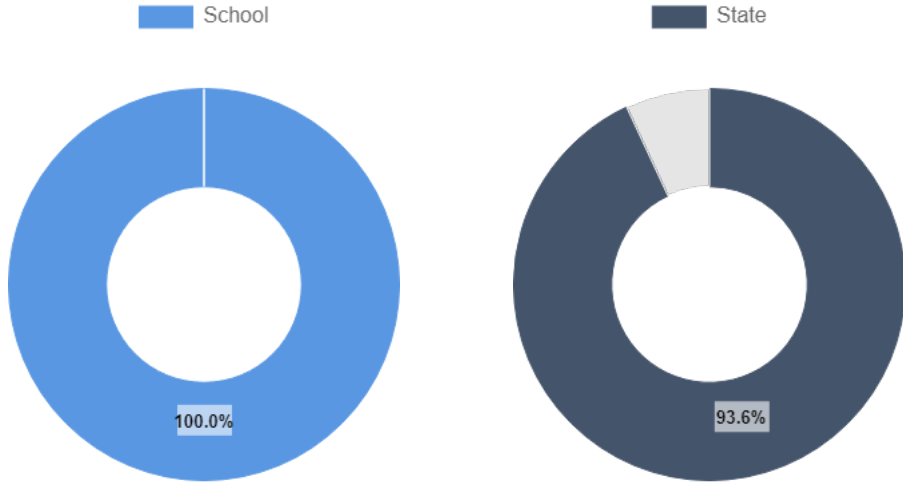

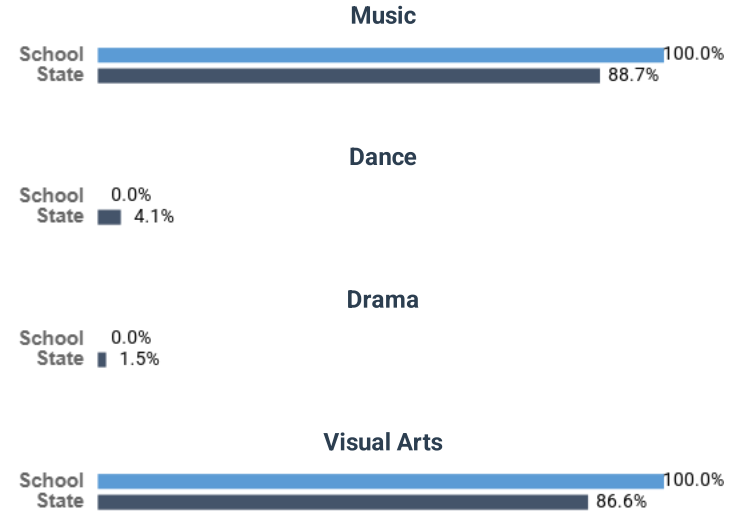

Students enrolled in one or more classes by discipline:



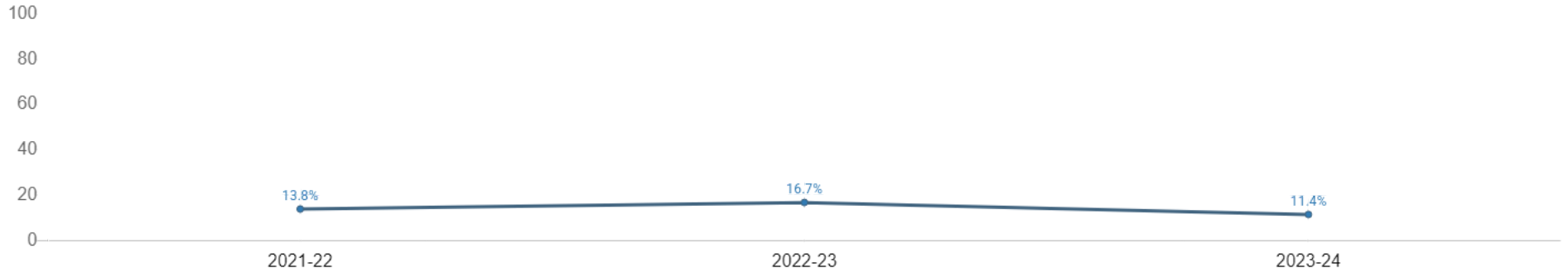

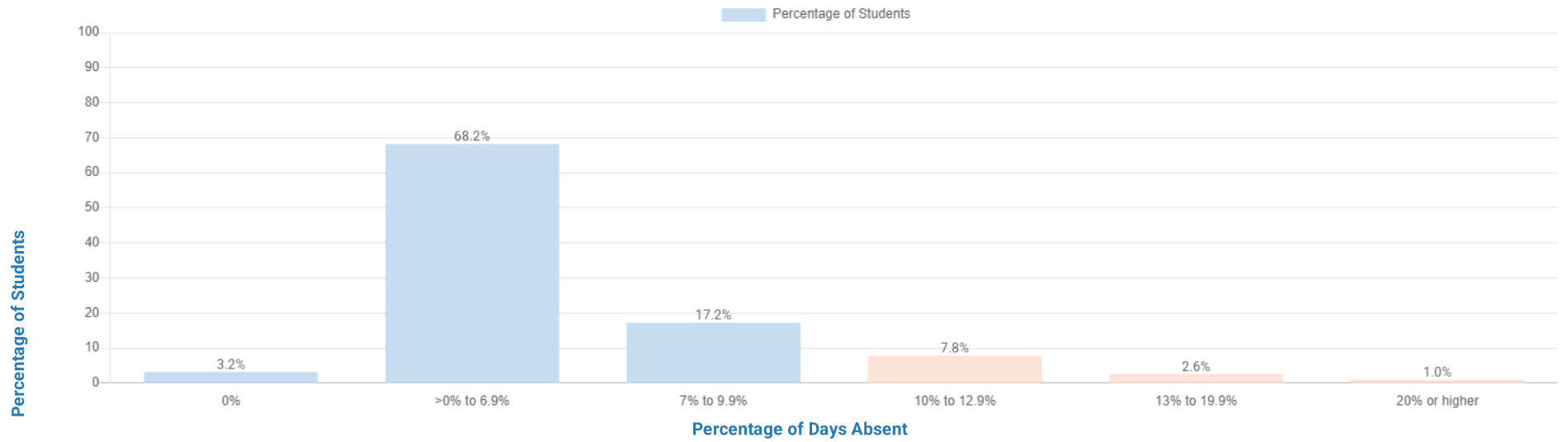

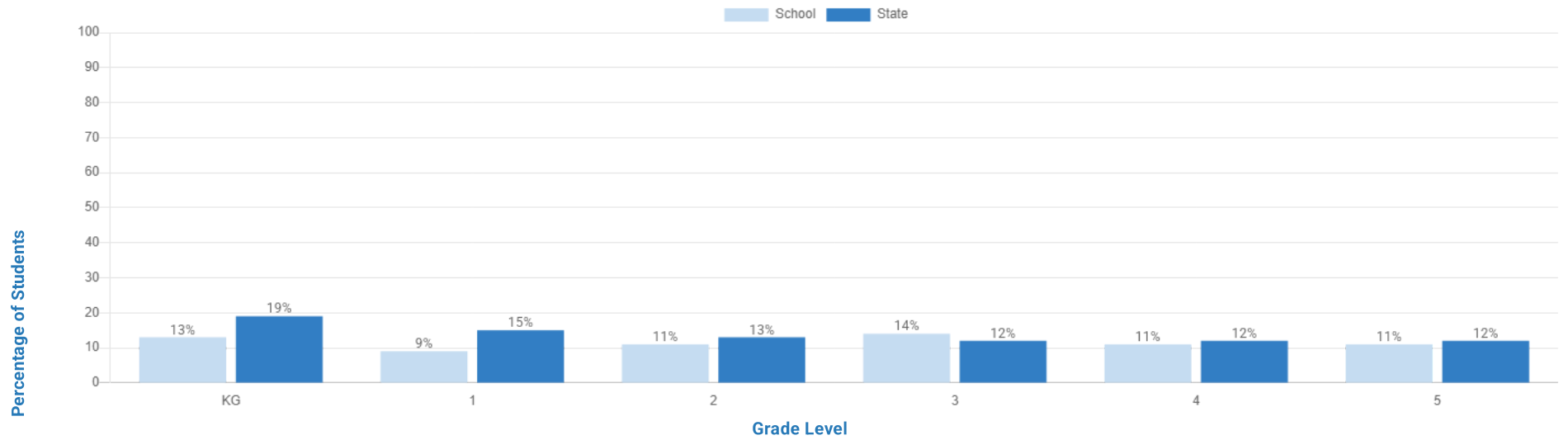

Staff

Staff data reflects teachers and administrators reported by districts at the beginning of the school year.

Key terms for staff data:

Teachers: All classroom teachers

Administrators: Principals, assistant principals, supervisors, coordinators, directors, and other central-office administrators, as well as superintendents and other district-level administrators

Experience: Experience is based on information submitted by districts on all their staff members. For purposes of this report, the ESSA Educator Equity and federal reporting requirements, NJDOE has defined teachers as "inexperienced" if they have fewer than four years of prior experience in a given district. 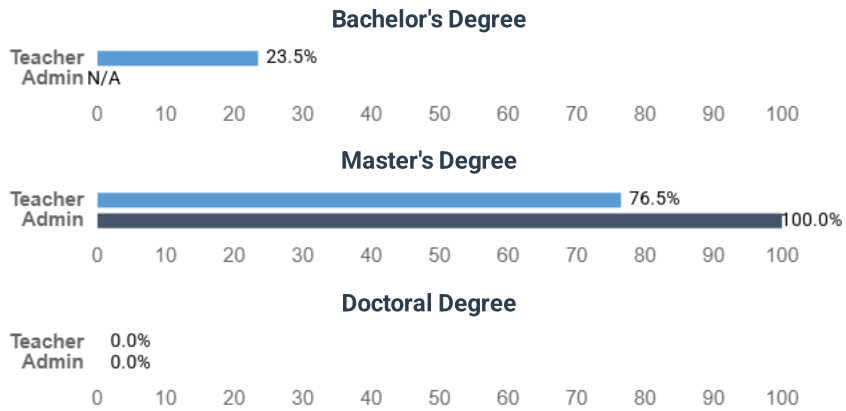

We engage students in active learning through a blend of textbooks, online resources, teacher materials, and supplemental tools, encouraging problem-solving, hypothesizing, creative exploration, and critical thinking. Our reading instruction follows a balanced literacy approach within an integrated curriculum. Additionally, each K-5 student now has access to their own HP Stream device, supporting a 1:1 technology environment.



Clubs and Activities:

Our school community enjoys a variety of cherished activities, including the Thanksgiving Feast, Pink Out Event, school musicals, an intramural program, and Field Day. Each spring, our 5th graders join a volleyball team to compete in a district-wide tournament with other Old Bridge schools. Our Student Safety Patrol assists younger students in navigating the building safely, while our Student Council, composed of 4th and 5th graders, works to make positive improvements to the school. We also offer clubs such as Art Club, Ukulele Club, Play Unified, and the K Club.

Attendance:

Weekly communication from attendance liaisons with families has positively impacted student attendance. Liaisons begin conversations by assuring parents that their role is to support, not judge, and to work together to ensure student success. These discussions cover absenteeism regulations, emphasizing how attendance in early grades, such as kindergarten and 1st grade, affects future reading skills, promotion, and graduation outcomes. Liaisons also explain that missing school leads to missed community-building time, which can increase student anxiety as they work to catch up. This supportive approach helps families understand the full impact of regular attendance.
