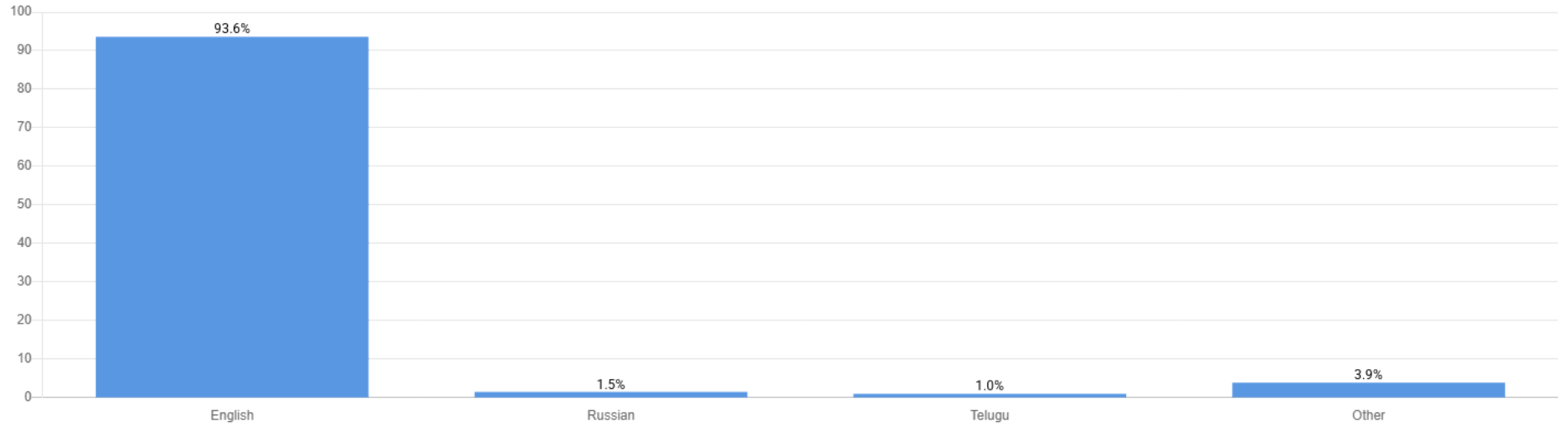

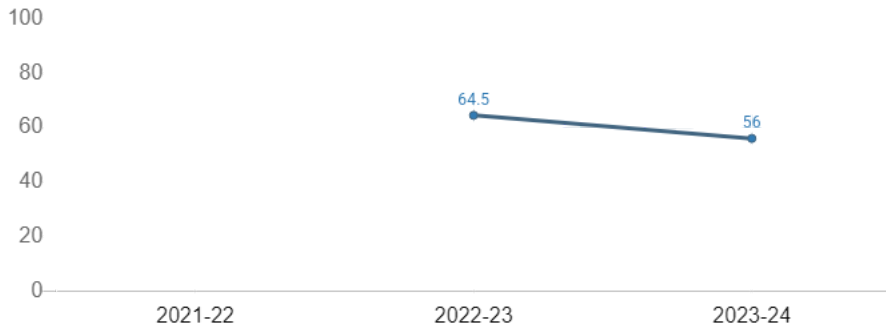

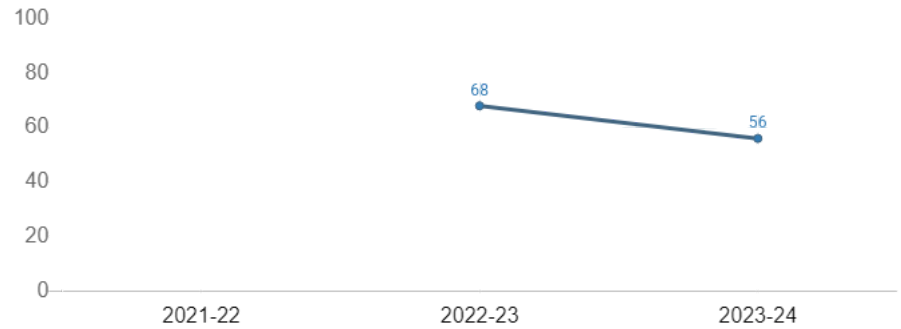

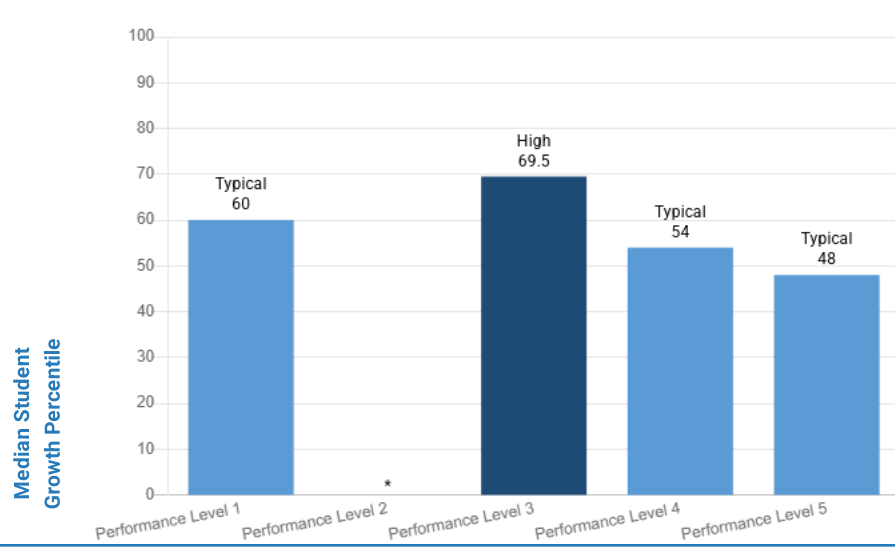

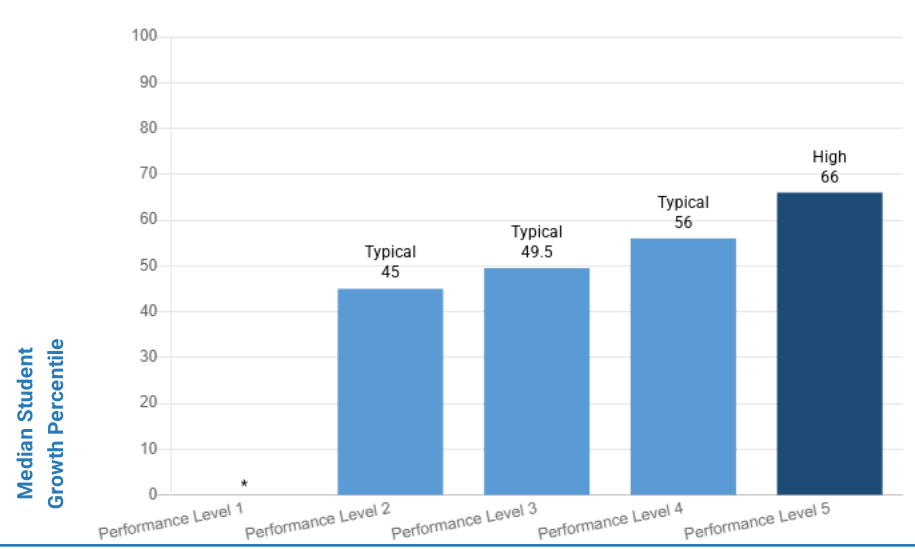

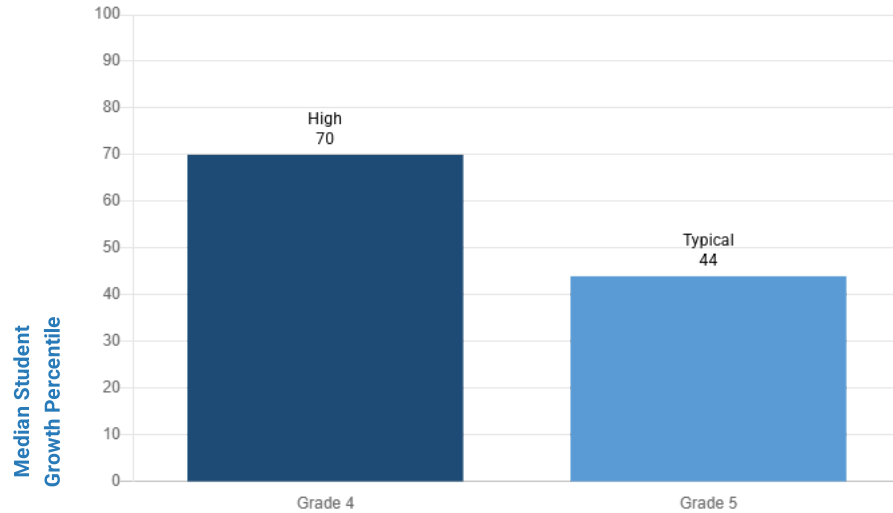

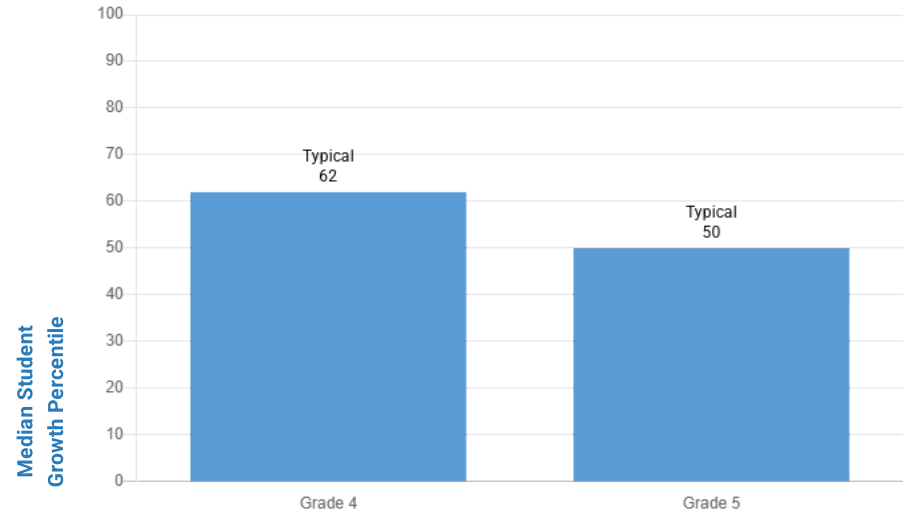

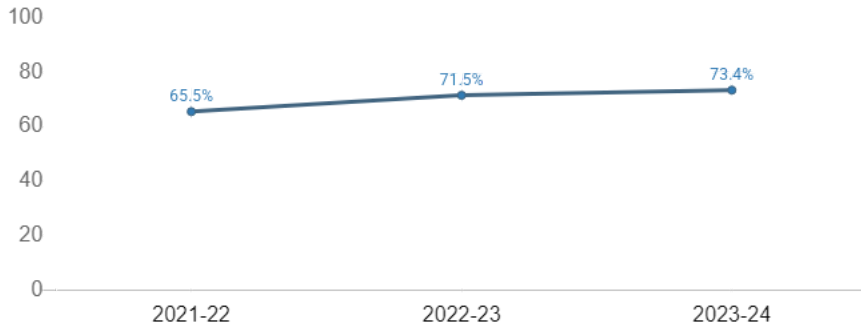

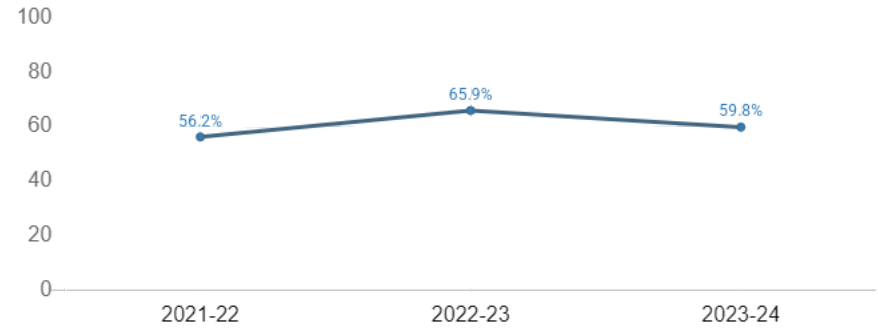
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. 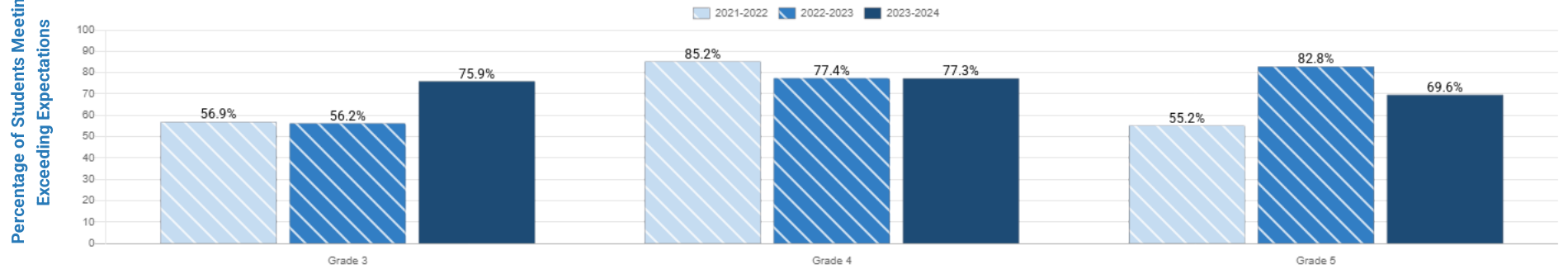

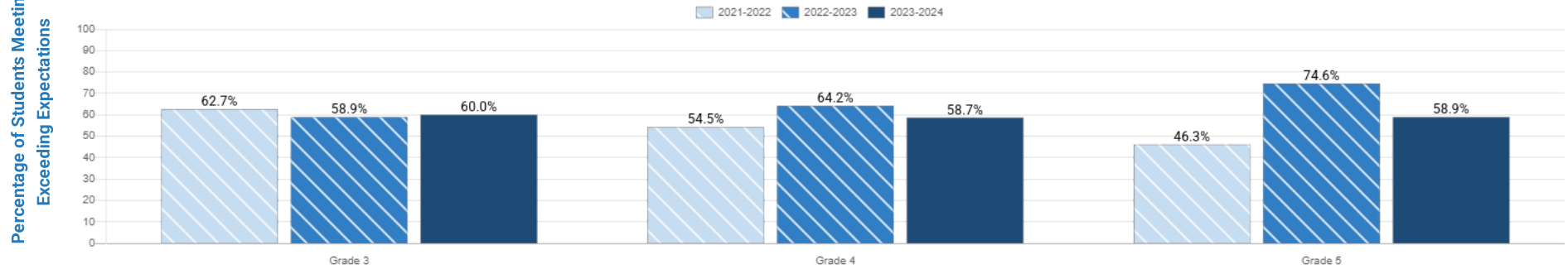

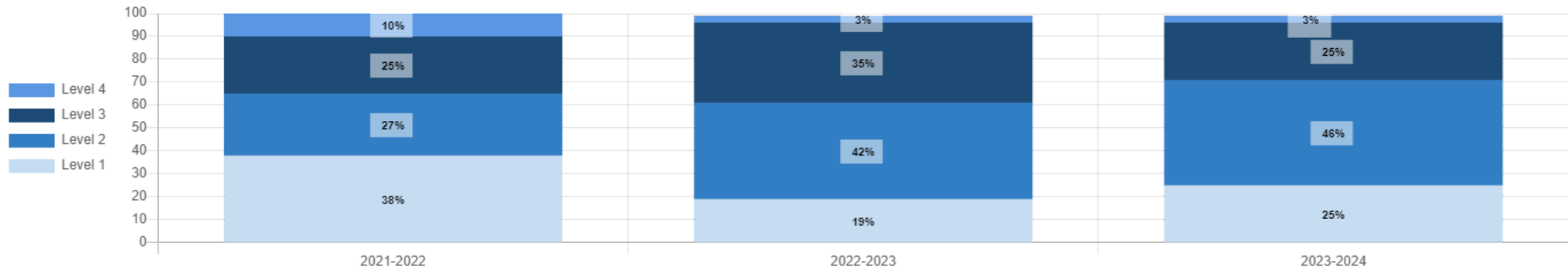

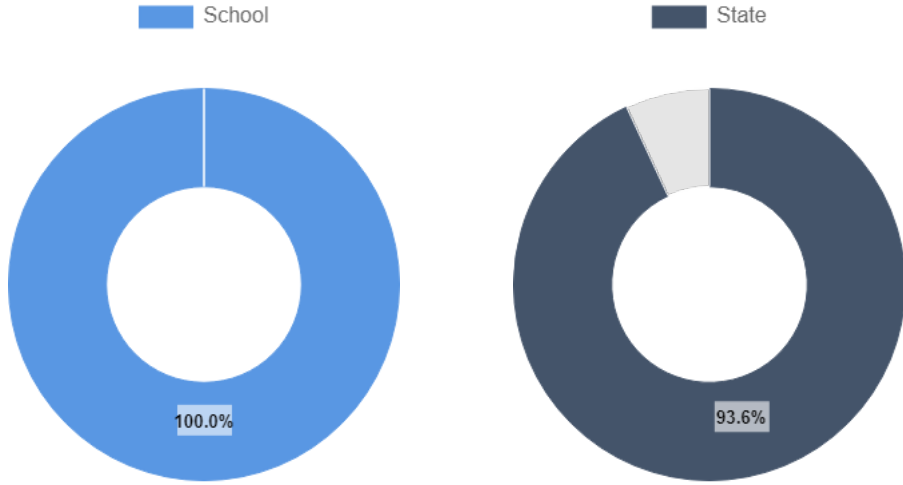

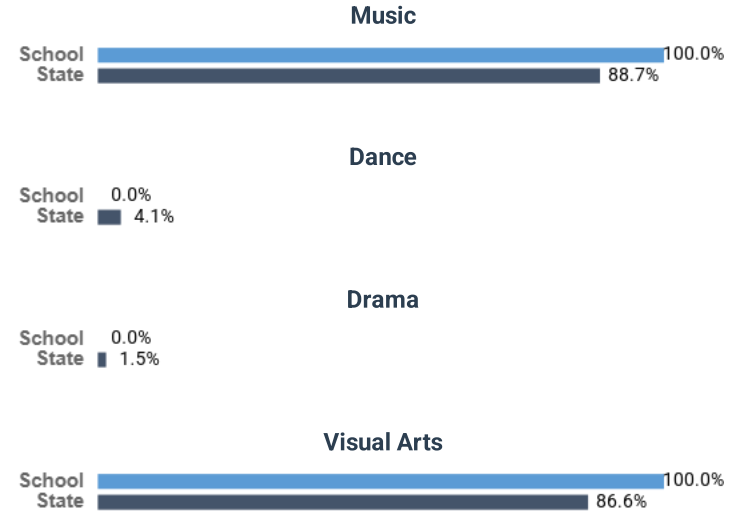

Students enrolled in one or more classes by discipline:



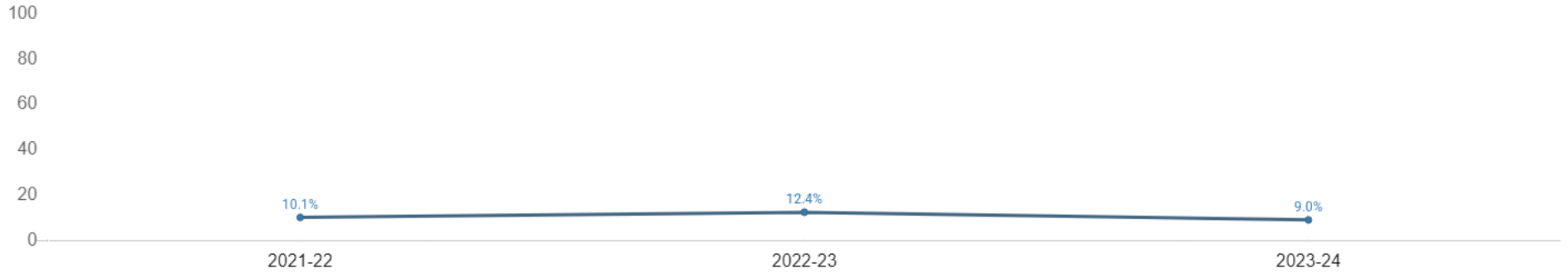

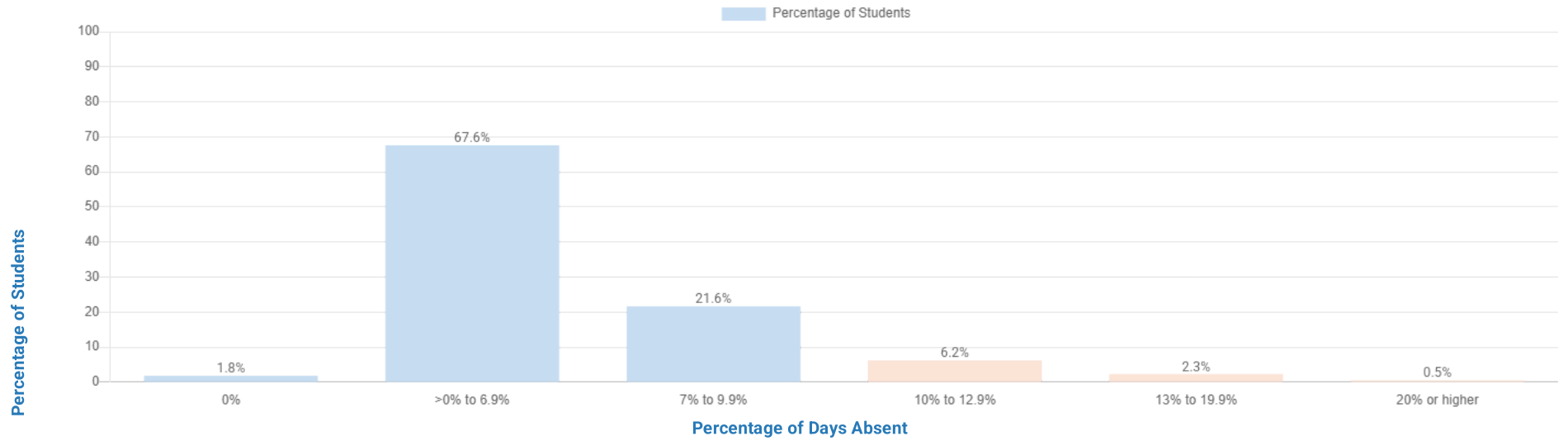

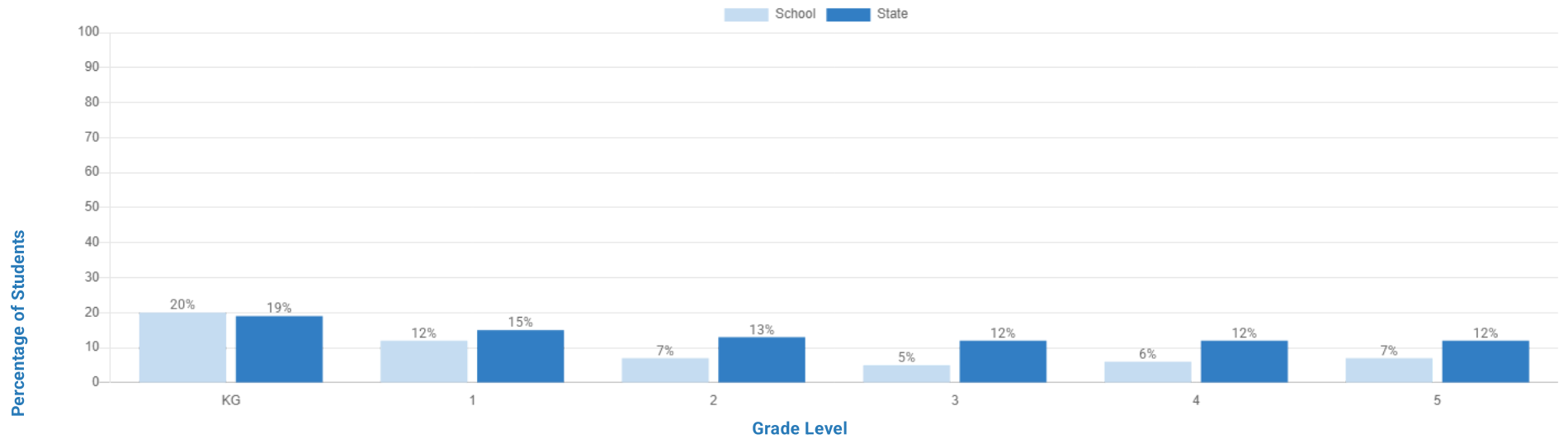

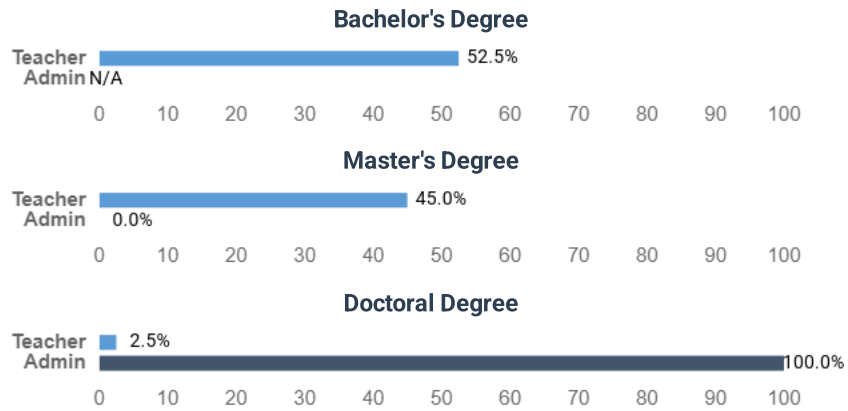

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. The incorporation of traditional books, online platforms, learning apps, teacher and online resources, and supplemental materials promote active student learning which includes problem solving, hypothesizing, creative discovery, and critical thinking. We implement a balanced literacy approach to reading through an integrated curriculum. Technology enhancements, such as the use of HP Streams & Chromebooks, Smartboards, and more are continually updated to prepare students for their future, and we leverage technology to enhance teaching and learning. Other Information:

Voorhees Elementary School promotes core ethical and performance values of Character Education based on the Six Pillars of Character: Trustworthiness, Respect, Citizenship, Caring, Responsibility and Fairness. These values are promoted at every grade level, and the common language was adopted by the district and is supported throughout the curriculum. The importance of outstanding character is supported with visual representations of good character throughout the building. Morning announcements and morning meetings reinforce schoolwide expectations. Lesson plans and intentional, consistent language are used throughout the school to emphasize the importance of good character using Six Pillars of Character. All new staff are trained on Character Education, Anti-Bullying and tolerance. Character Education is discussed collaboratively at faculty meetings, grade level meetings, and PLC days. Reflection and concrete data from climate surveys are used to promote continuous improvement. Our core values are consistently incorporated in every aspect of school life, during instructional and non-instructional time.
