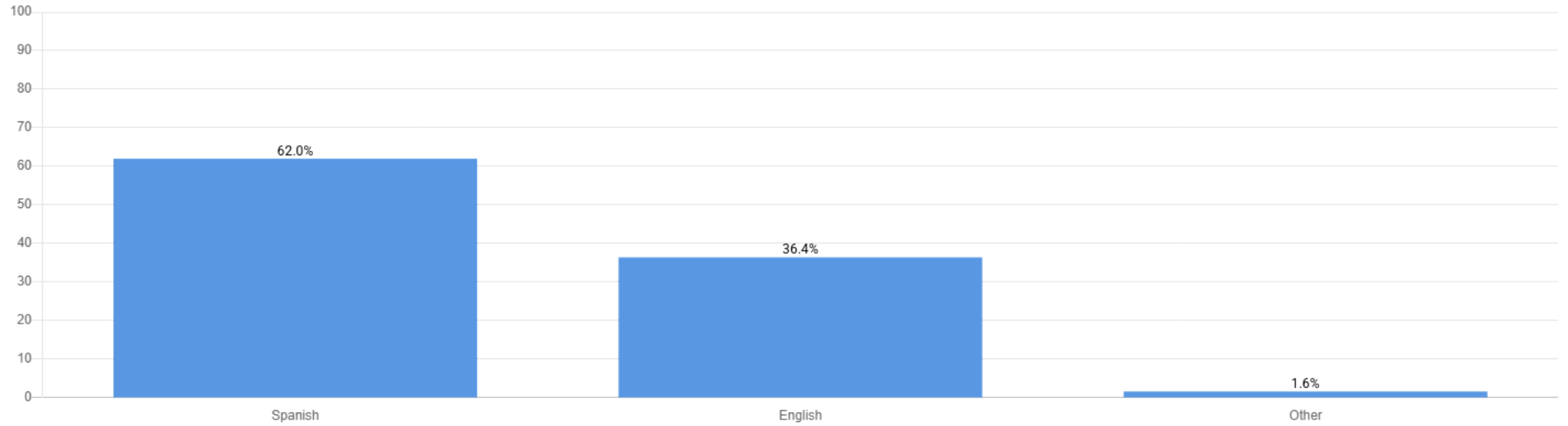

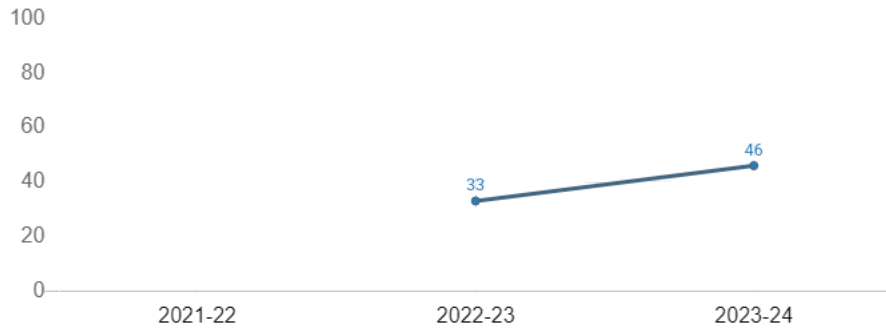

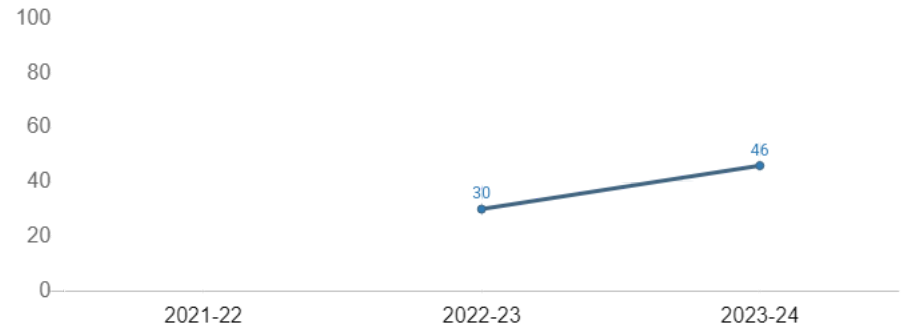

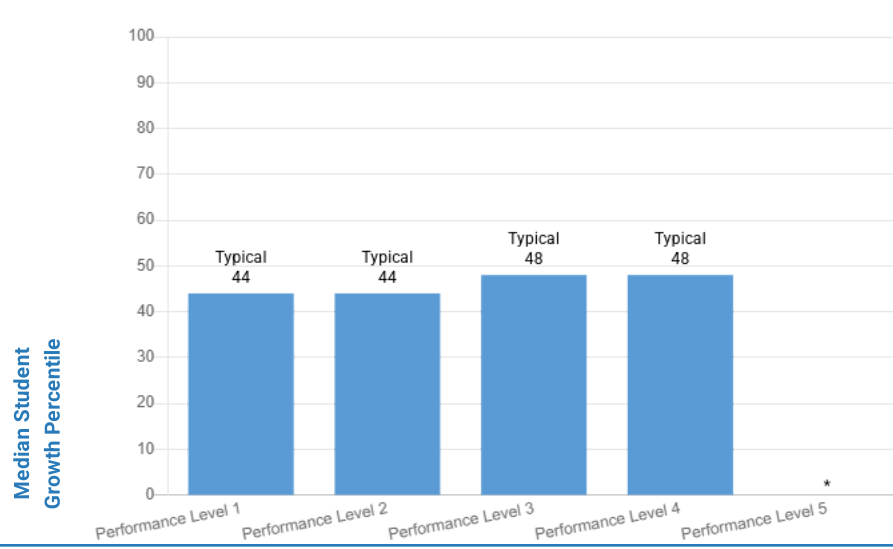

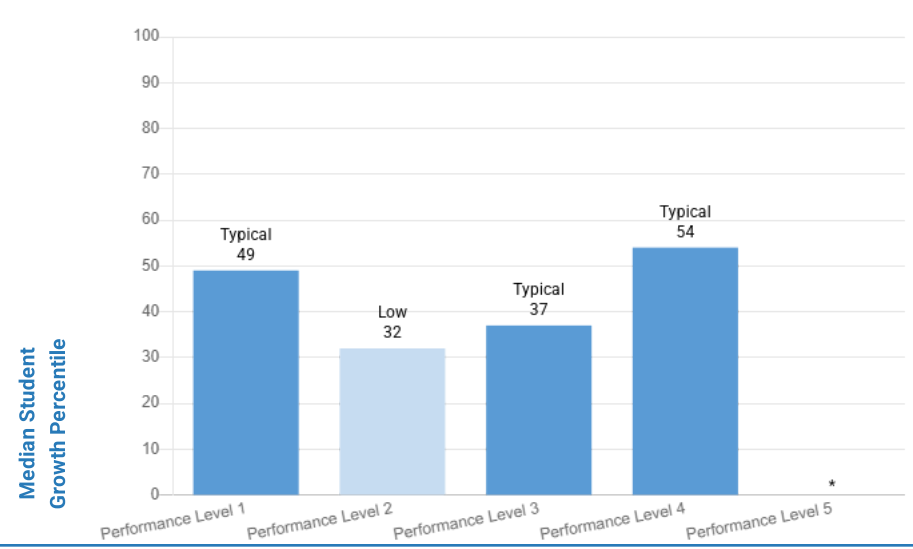

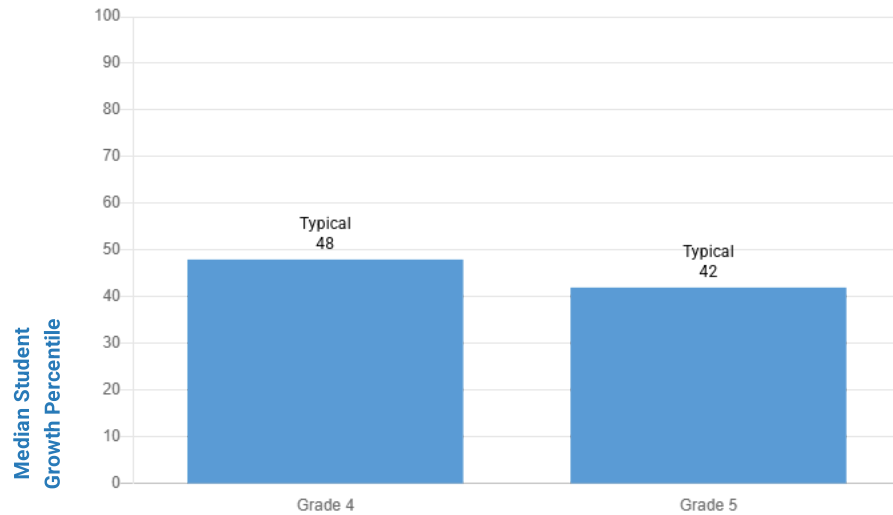

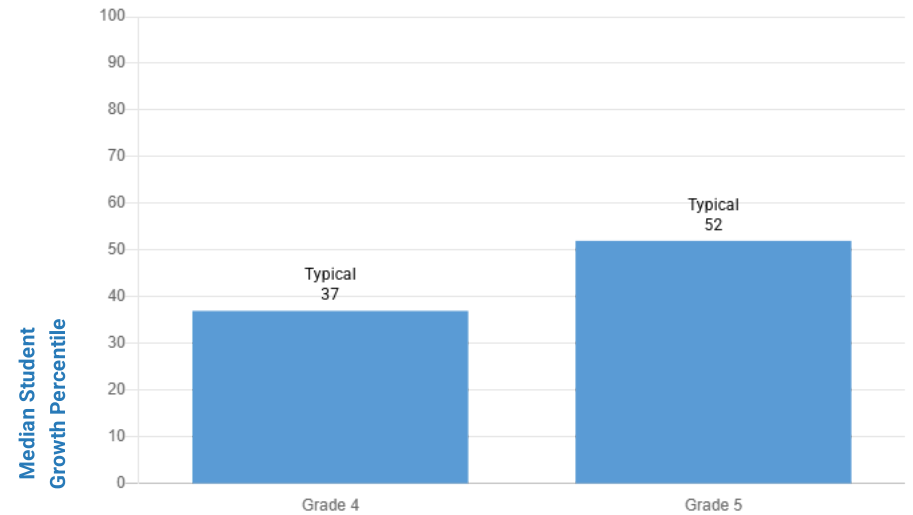

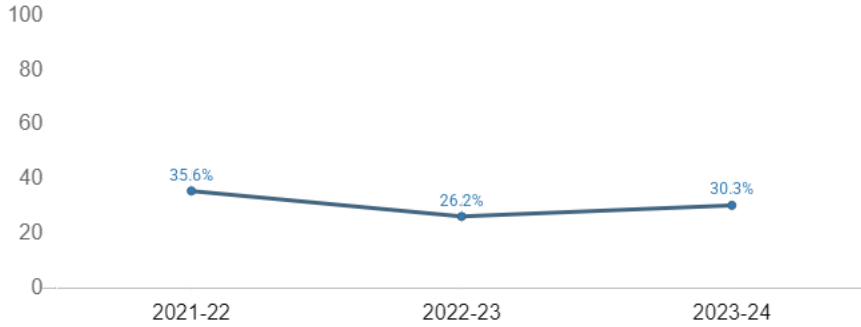

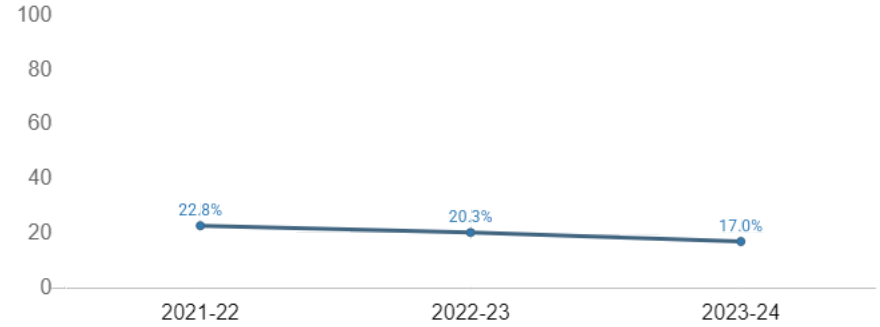
English Language Arts and Mathematics Performance Trends

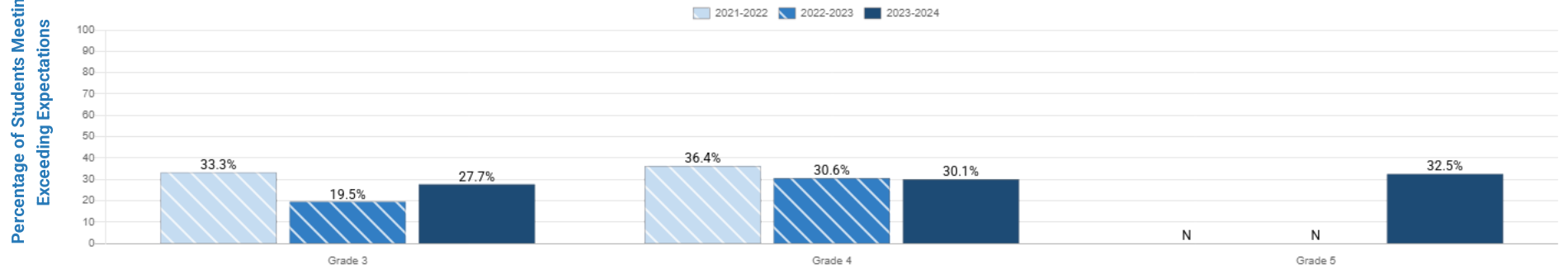

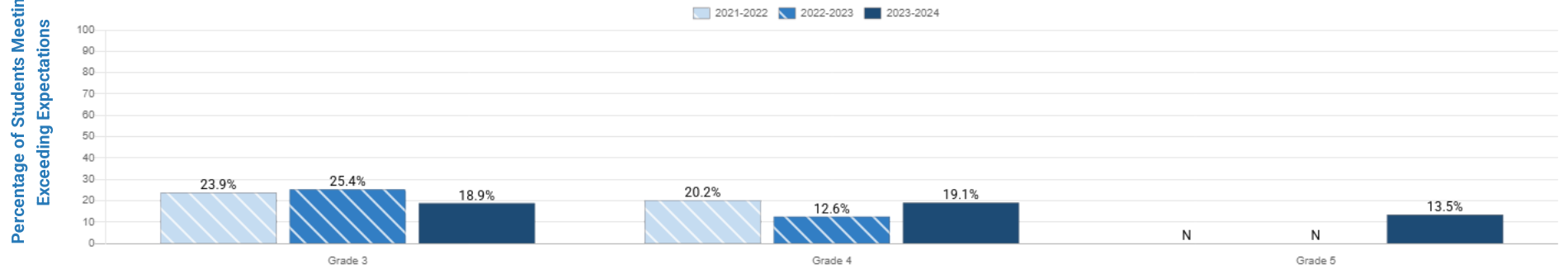

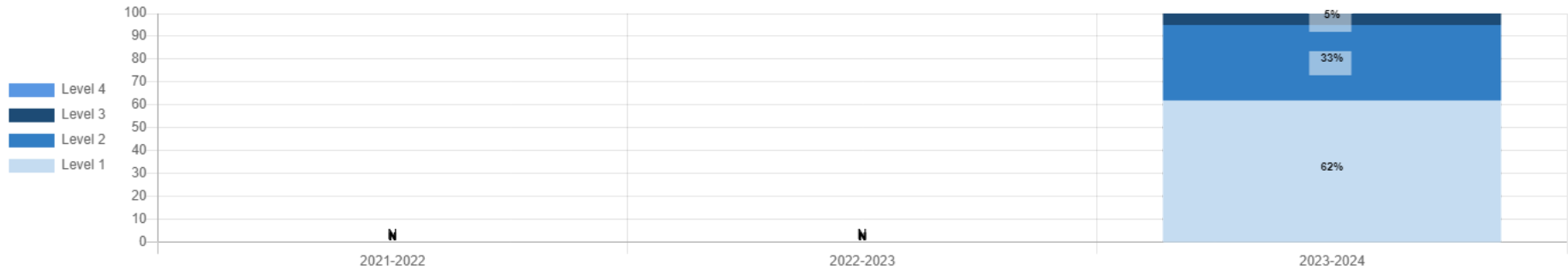

Students enrolled in one or more classes by discipline:



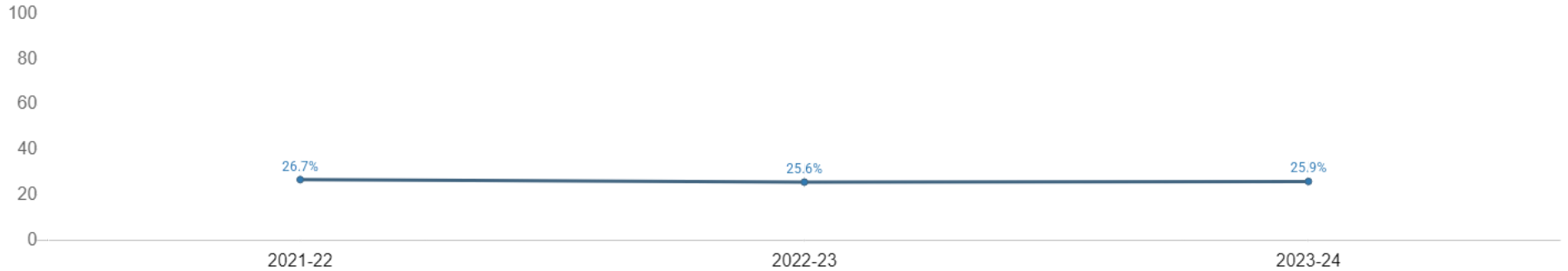

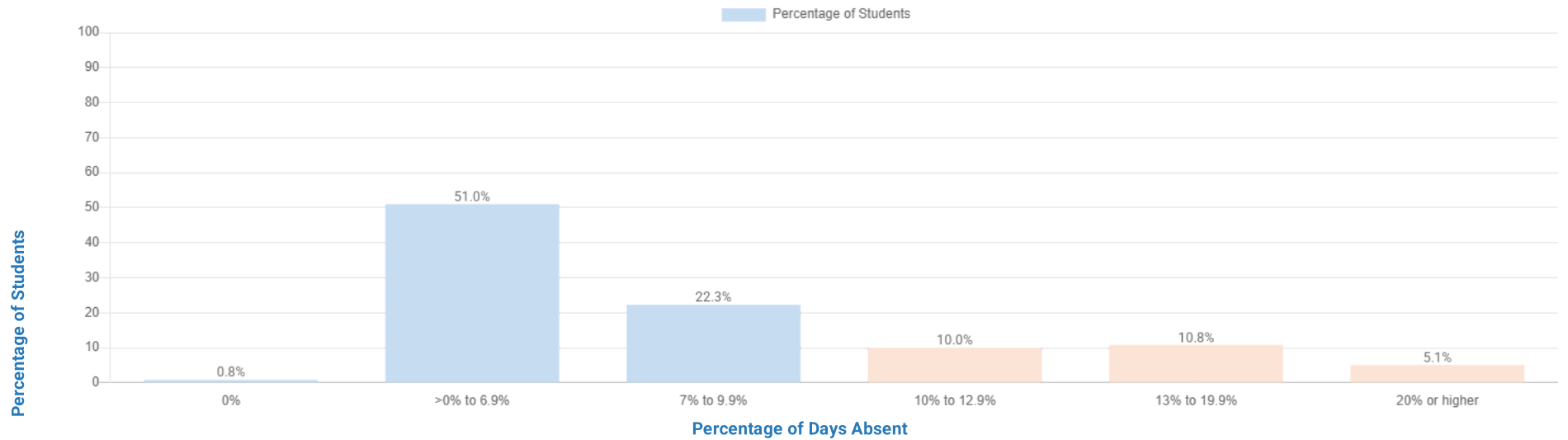

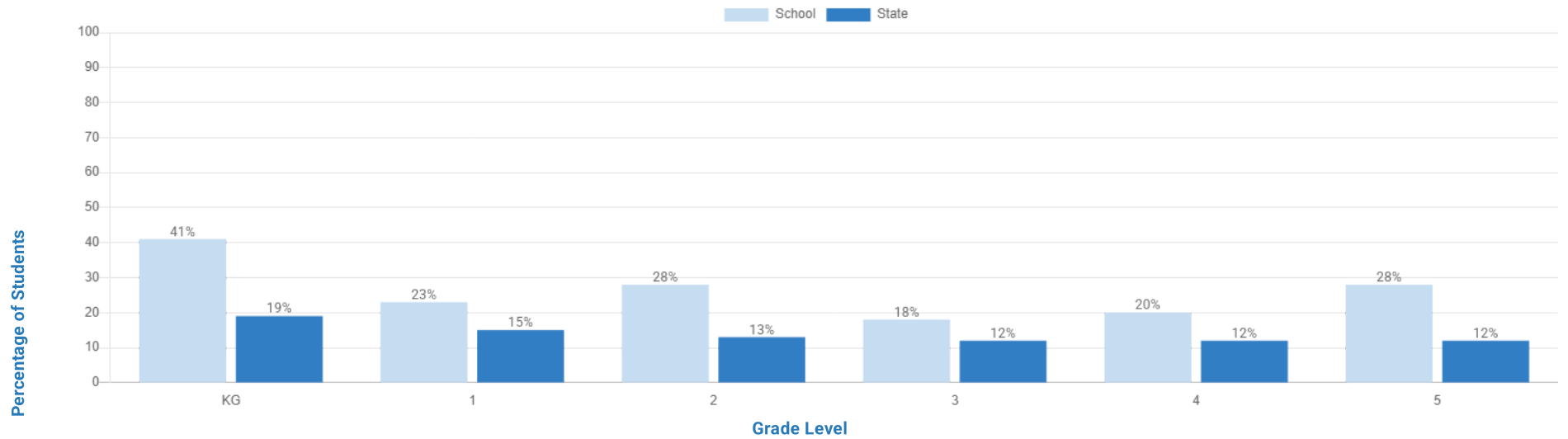

Staff

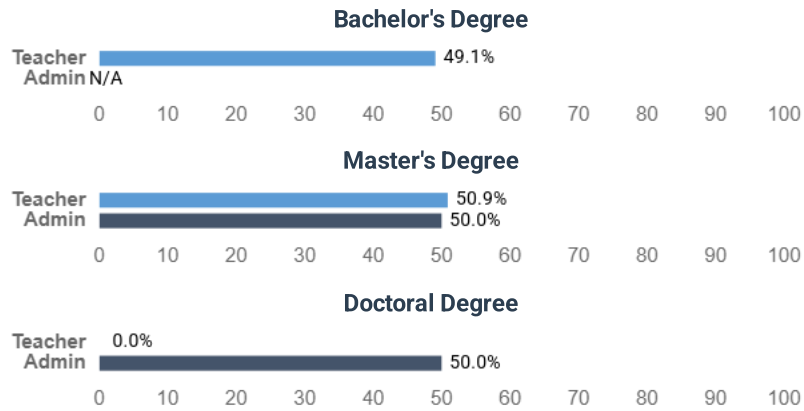

Professional Learning Communities (PLCs) are conducted for our teachers and administrators to learn, analyze data, and work together to improve student achievement. Teachers have common planning time during the school day and professional development is incorporated into staff meetings that are held after school twice a month.



Student Supports and Services:

For our students who are Multilingual Learners (MLs) the school offers a Transitional Bilingual Education program that includes ESL for students in grades K-5. Our school has 2 full-time guidance counselors and a non-traditional school psychologist who coordinate the student support team services (SST) of which the intervention and referral services is a component.



Student Health and Wellness:

The Responsive Classroom approach and a peer mediation program is used daily for social and emotional learning to employ strategies and practices that emphasize positive social interaction. Our staff creates an atmosphere which promotes the development of a lifelong love of learning and the character skills essential for college and career readiness. Our school offers a morning breakfast program for all students.
