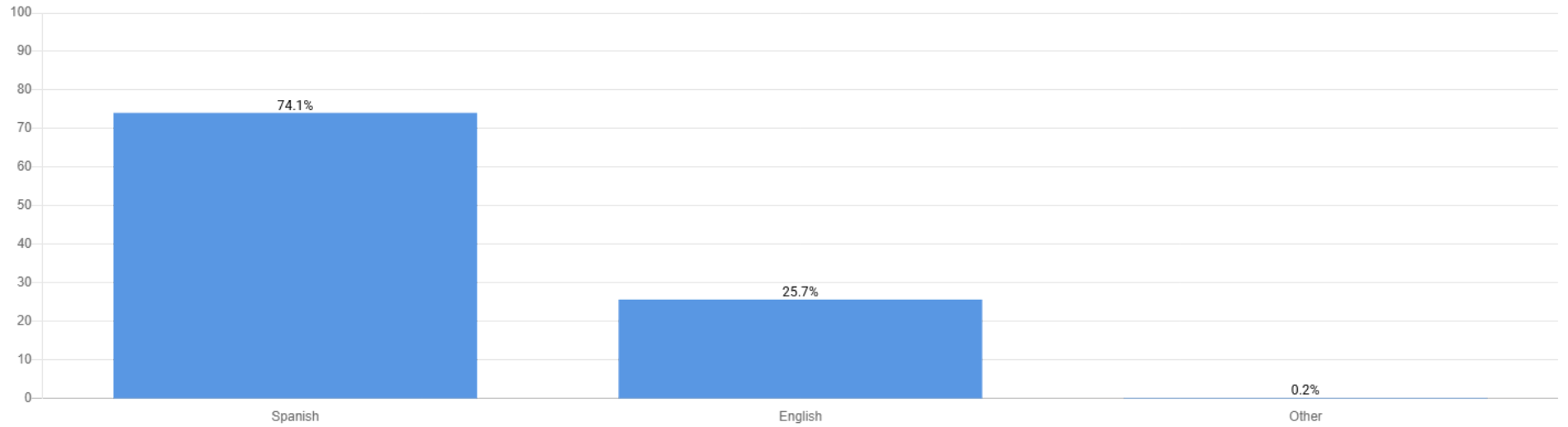

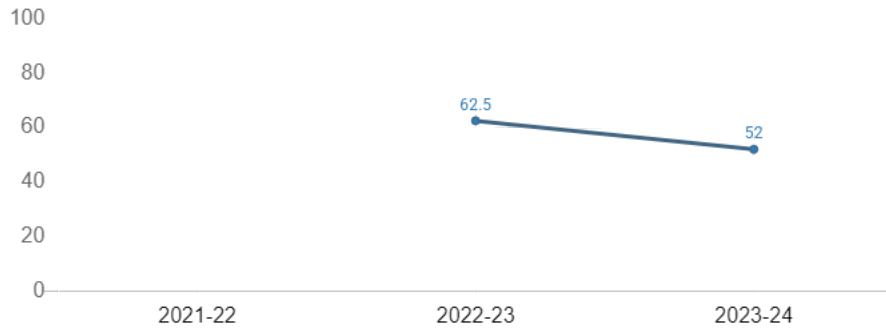

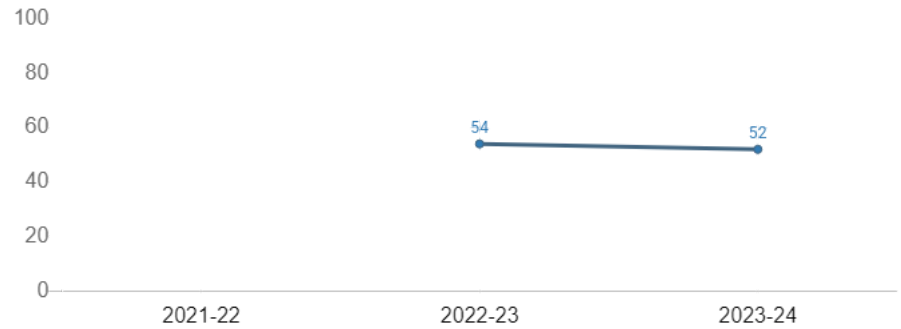

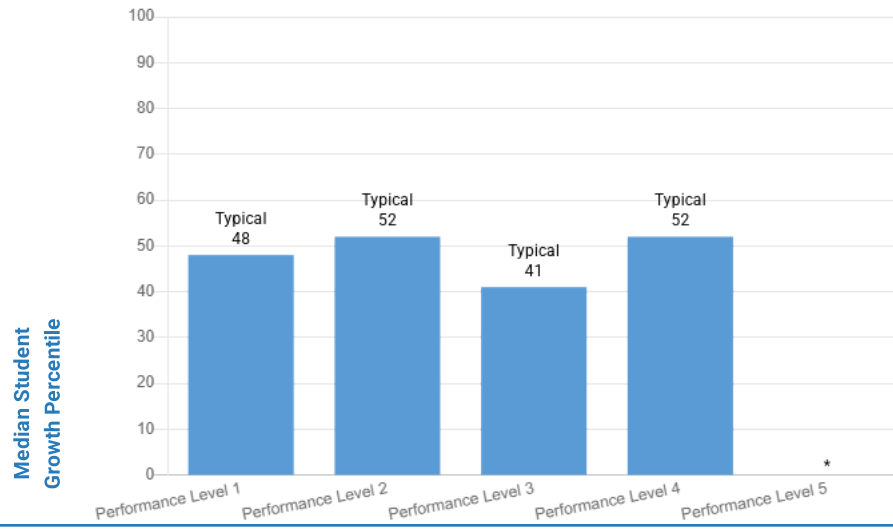

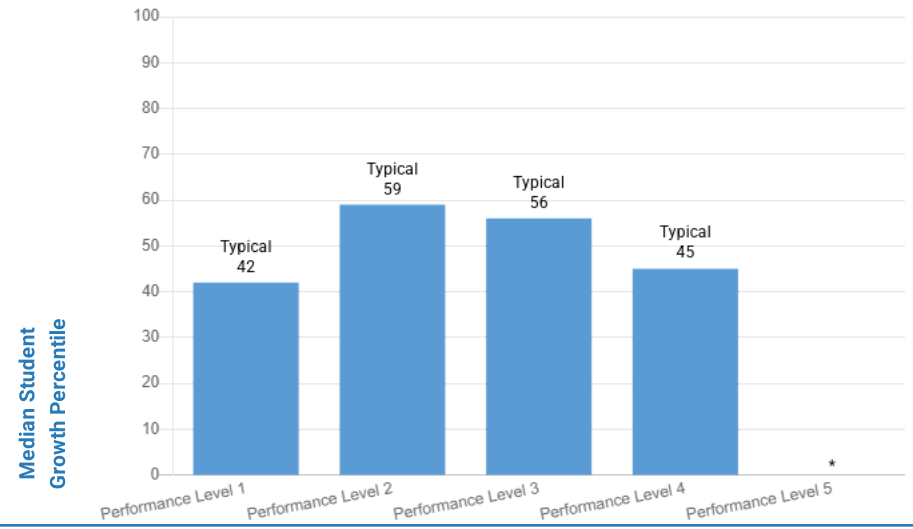

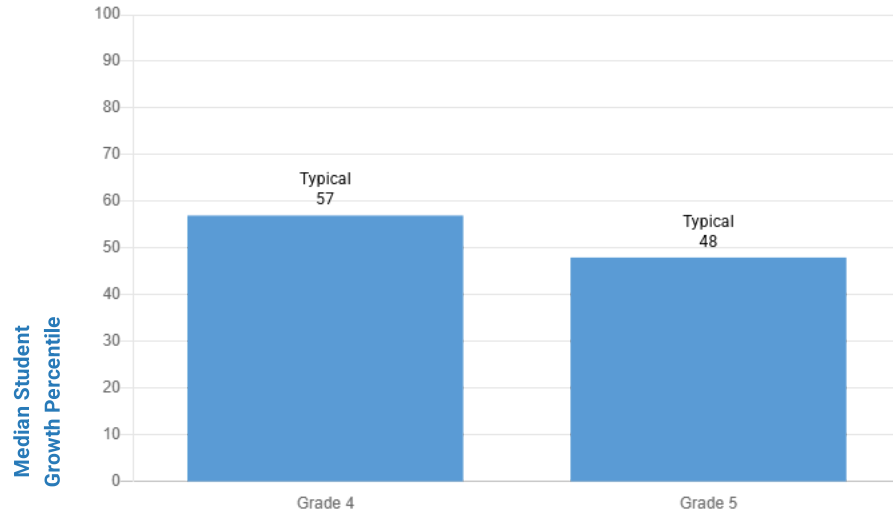

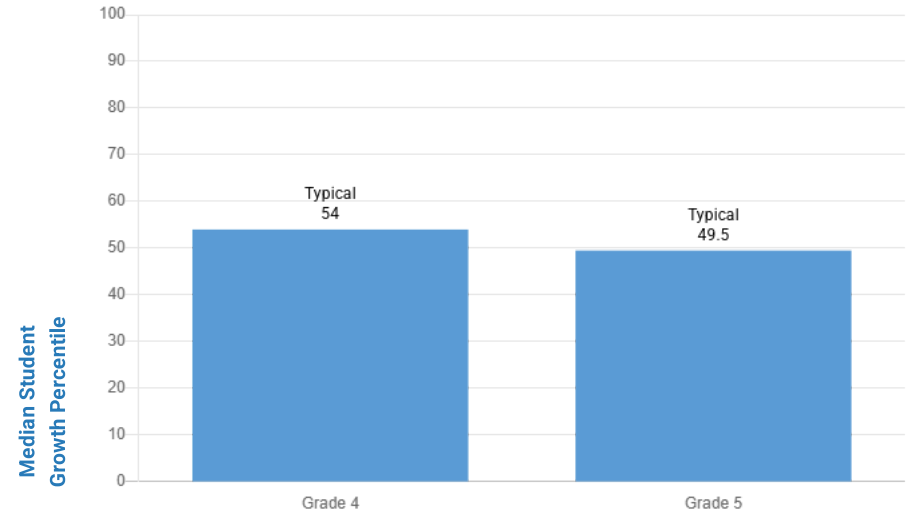

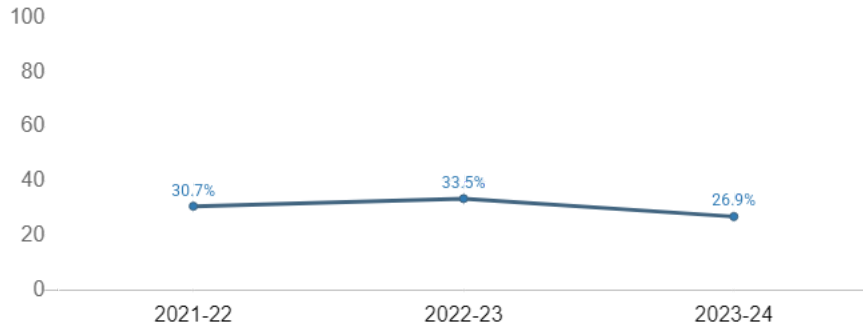

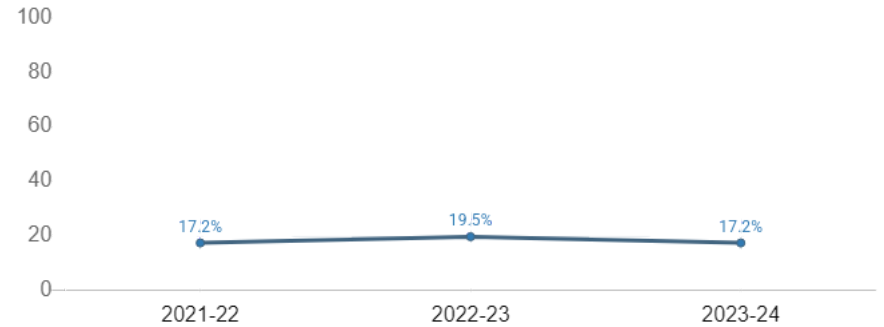
English Language Arts and Mathematics Performance Trends

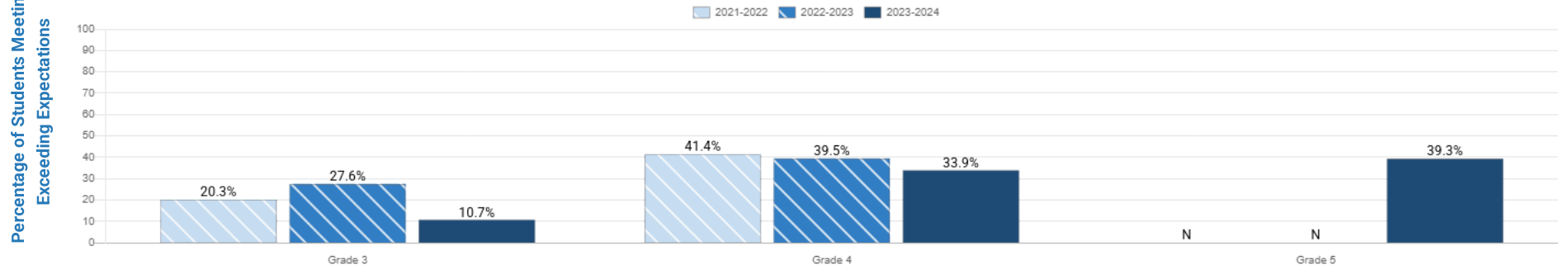

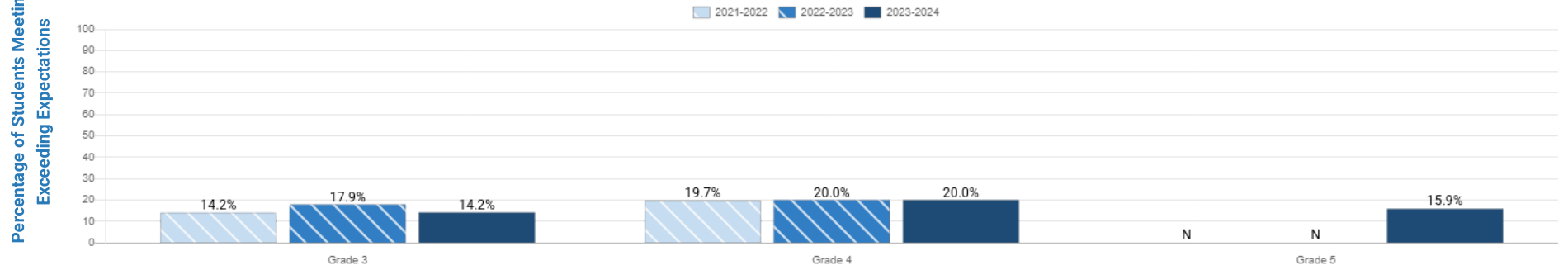

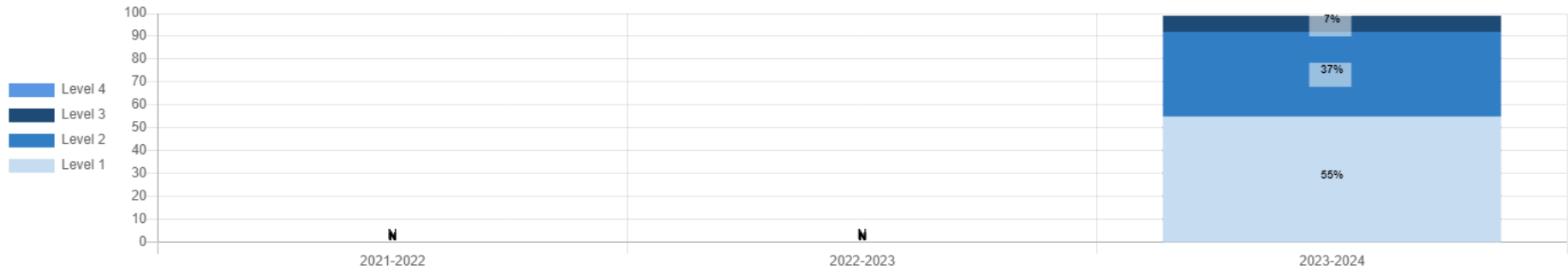

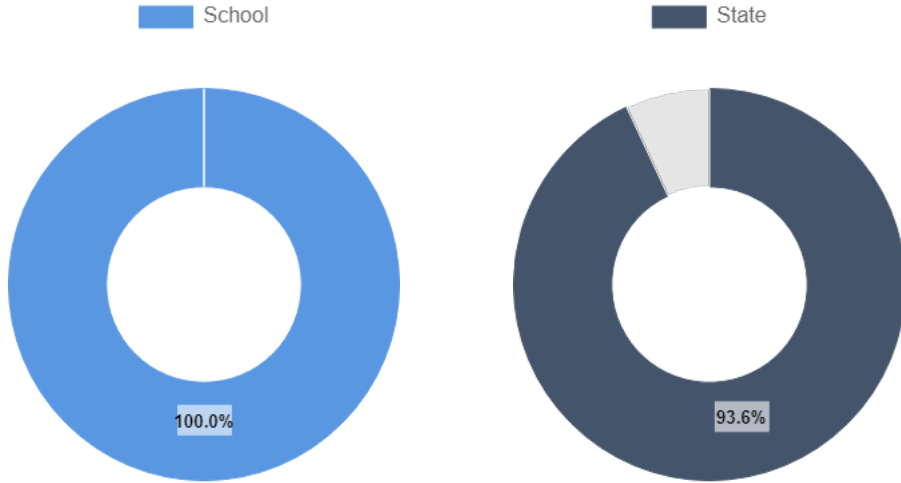

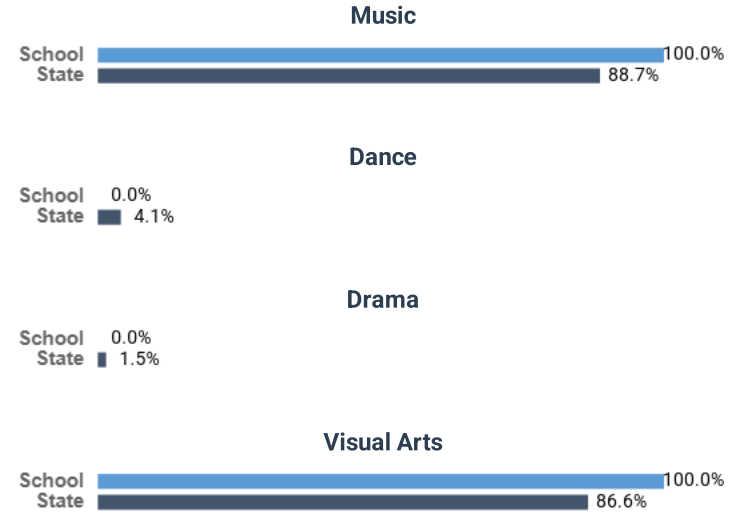

Students enrolled in one or more classes by discipline:



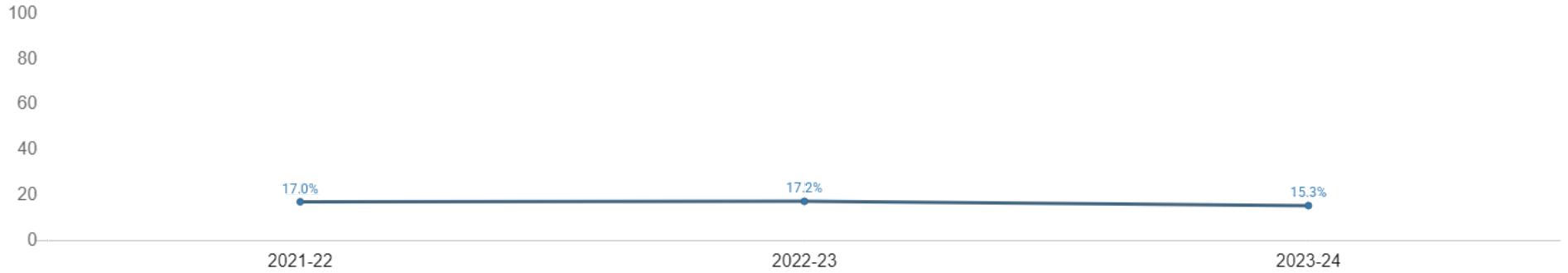

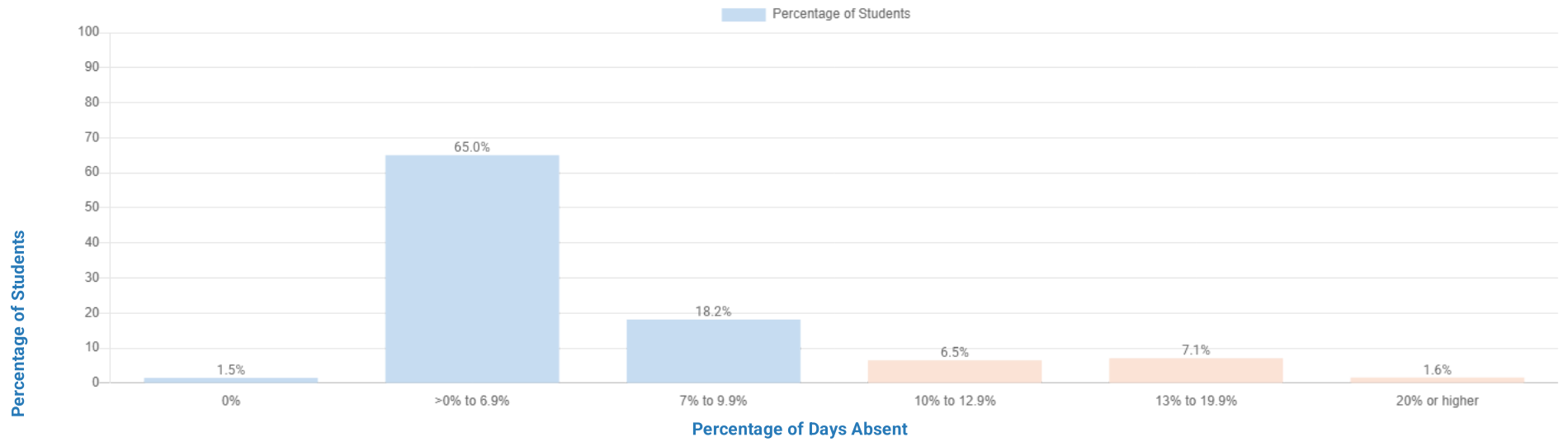

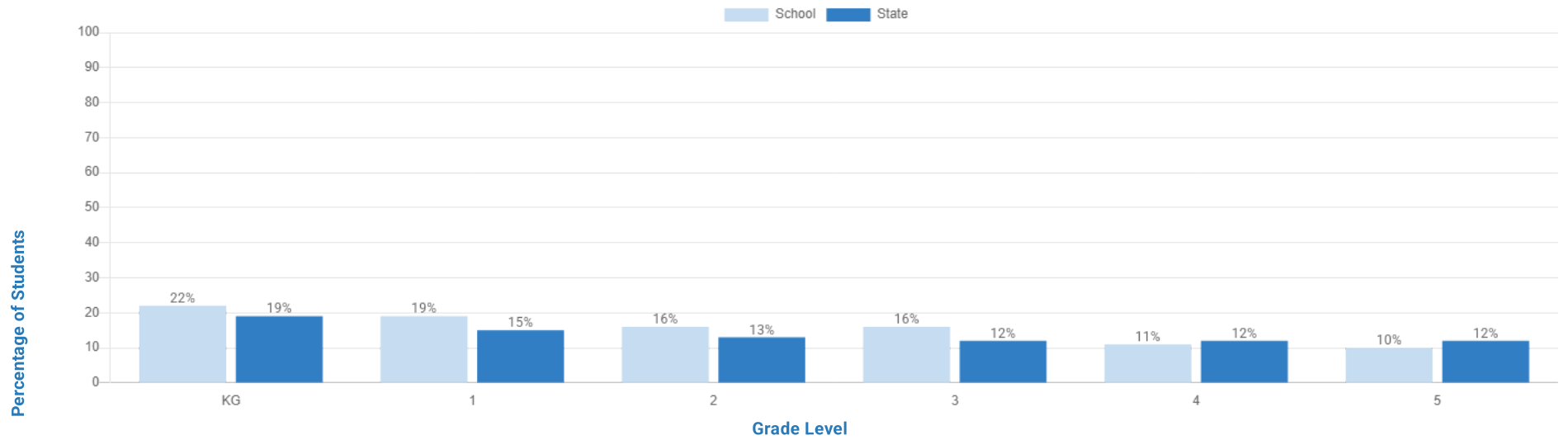

Staff

Staff data reflects teachers and administrators reported by districts at the beginning of the school year.

Key terms for staff data:

Teachers: All classroom teachers

Administrators: Principals, assistant principals, supervisors, coordinators, directors, and other central-office administrators, as well as superintendents and other district-level administrators

Experience: Experience is based on information submitted by districts on all their staff members. For purposes of this report, the ESSA Educator Equity and federal reporting requirements, NJDOE has defined teachers as "inexperienced" if they have fewer than four years of prior experience in a given district. The tables below report on "experienced" teachers and administrators for federal reporting purposes.

Out-of-Field: A teacher is labeled "out-of-field" if they are potentially teaching outside their area of certification. This could occur if the teacher cannot be found in the NJDOE's certification system, if their job code does not match their certification, or if the teacher has an expired certificate.

Provisional Teacher: A teacher with provisional certifications is a fully certified novice teacher of record who must meet further requirements of evaluation and mentoring during their induction into the profession before being granted "standard" or permanent certification.

Teachers – Experience

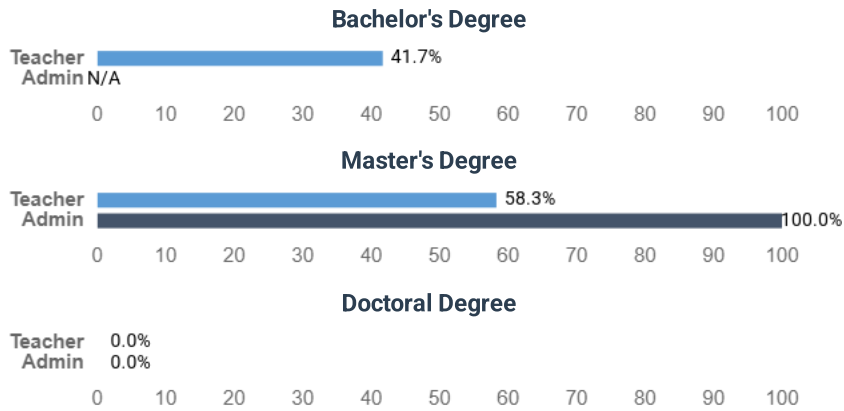

Courses, Curriculum, Instruction:

Our curriculum is aligned to the New Jersey Student Learning Standards and ensures that our students are exposed to the critical skills that they must develop at each grade level and throughout their K-5 educational experience. Both our ELA and Math Framework features an instructional model that provides our students with flexible educational learning environments and differentiated instruction. Our students enhance their skills through whole group instruction and targeted instruction. Opportunities are provided to engage in higher-order thinking skills and for students to work collaboratively while teachers foster a student-centered and student-driven learning environment. Science/Social Studies are also implemented on a bi-weekly basis. Additional courses offered are: physical education/health, music, art, and library/media/technology skills.



Clubs and Activities:

We offer the school musical for our upper grade students. Each year, students are provided the opportunity to audition for various roles on the stage, and to sign up to participate in roles behind the scenes to support our Musical presentation. Our before/after school programs include opportunities to support identified students in the areas of literacy and mathematics.



Before and After School Programs:

Our school offers a variety of activities for our students. Our extended day programs are conducted before and after school in the areas of Language Arts Literacy, Mathematics and other programs related to Visual Performing Arts. Our academic programs include opportunities to support identified students in the areas of literacy and math. Small group instruction allows for individualized attention and differentiated instruction. We offer the school musical to our students in the upper grades. The students come together for a culminating musical performance at the end of the year.

Staff and Professional Learning:

The school provides professional development activities derived from the needs of our students. Professional learning communities (PLCs) are in place for our teachers and administrators to learn, analyze data, and work together to improve student achievement. Teachers have common planning time during the school day and professional development is incorporated into staff meetings that are held after school twice a month. Additionally, coaching sessions are in place to support instruction and implementation of our curriculum resources.



Student Supports and Services:

Multilingual Learners are supported via the Transitional Bilingual Education program and English as a Second Language (ESL). Our full-time guidance counselors and non-traditional school psychologist coordinate the Student Support Team (SST) for our students. The school's student support team meets weekly to discuss behavioral/academic supports and interventions to help meet their social emotional learning needs. Students with disabilities are supported in inclusion classrooms, self-contained classrooms, and LLD Classrooms under the purview of our CST.



Student Health and Wellness:

Our nurse, school counselors, and physical education/health teachers work collaboratively to promote healthy lifestyles through Health classes, and classroom presentations. Additionally, our School Climate & Safety Team brings teachers, support staff, parents, and Administrative staff together on a monthly basis to brainstorm ways to create an emotionally, physically, and socially safe school community. The school has a full time registered nurse available to the students and staff during the day. In addition, our nurse conducts vision, hearing, weight, height, and scoliosis throughout the school year for different grade levels. Our health office provides a variety of information to our student body and their families. We are also actively involved in the Fresh Fruit and Vegetable Program which makes it possible for our students to receive a fresh fruit or vegetable twice a week for the entire school year.

Parent and Community Involvement:

Our school has security personnel and utilizes a weapons detection system in which all staff, students, and visitors must pass through upon entry into the building.

Technology and STEM:

Our school houses a Computer Lab and Multi Media Center furnished with a Maker-Space which is run by our media specialist and technology teacher. Students are provided with opportunities to participate collaboratively in activities which require the use of 21st Century skills (coding, engineering, etc.). There is a one-to-one chromebook initiative in grades 1-5, where all students have a chromebook to support and enhance learning. All Kindergarten classrooms are equipped with iPADS to support instruction. Furthermore, every classroom is equipped with a projector and whiteboard.
