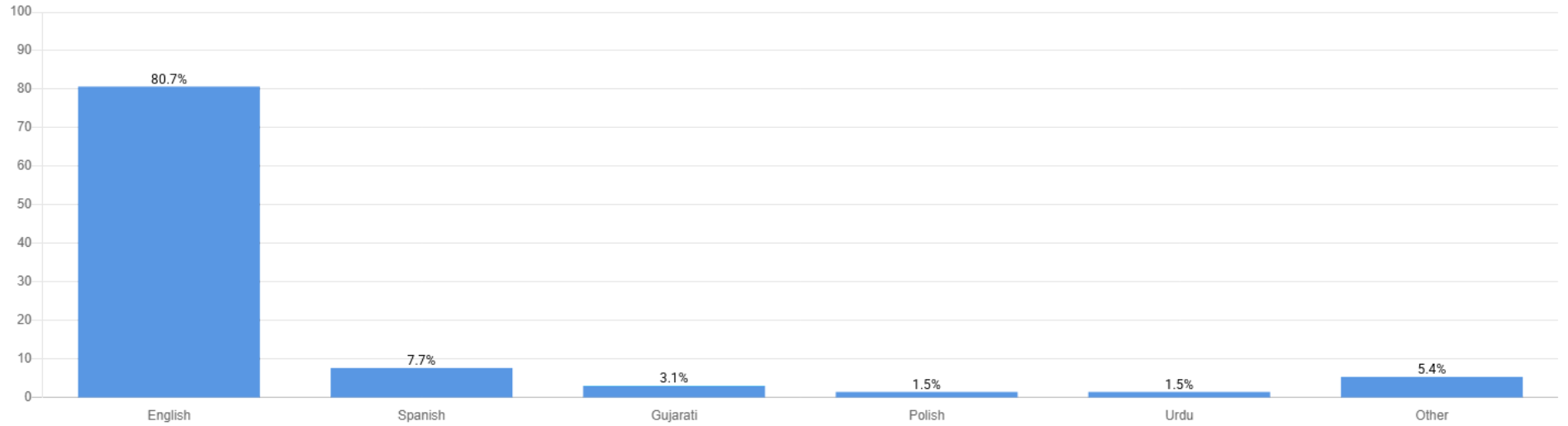

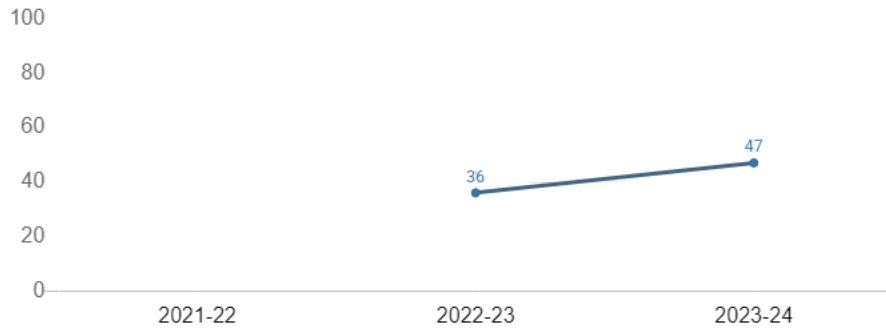

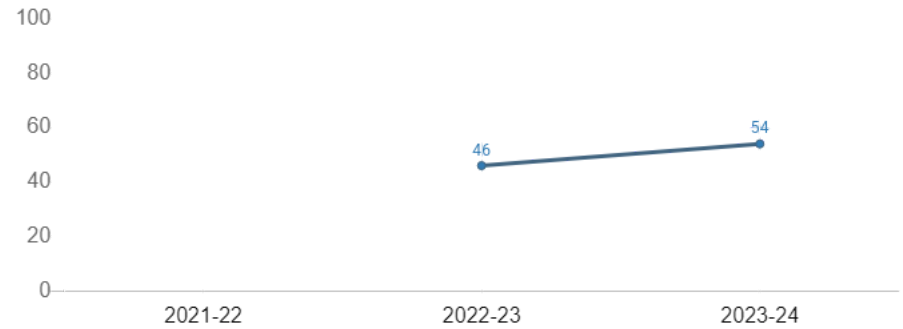

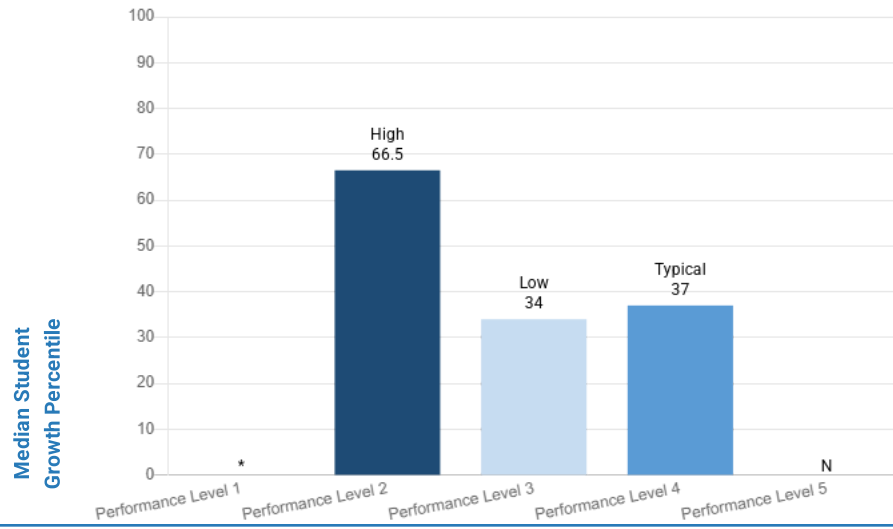

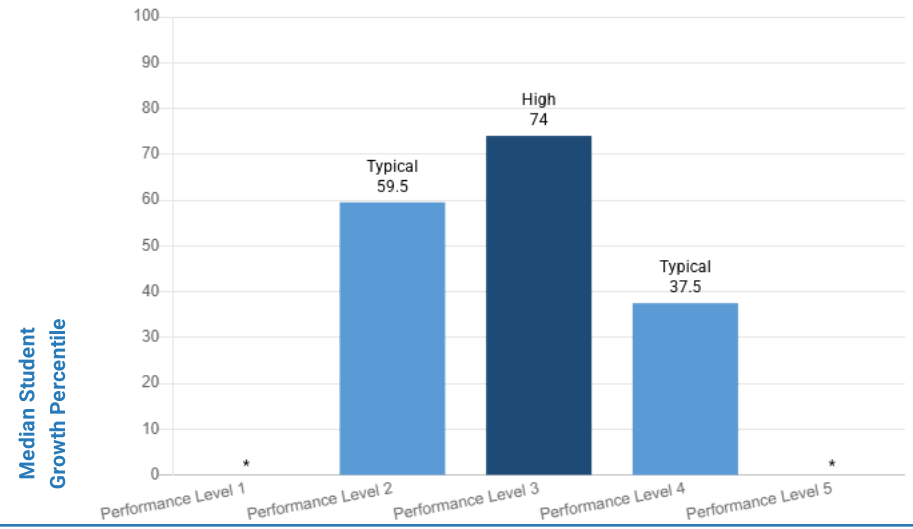

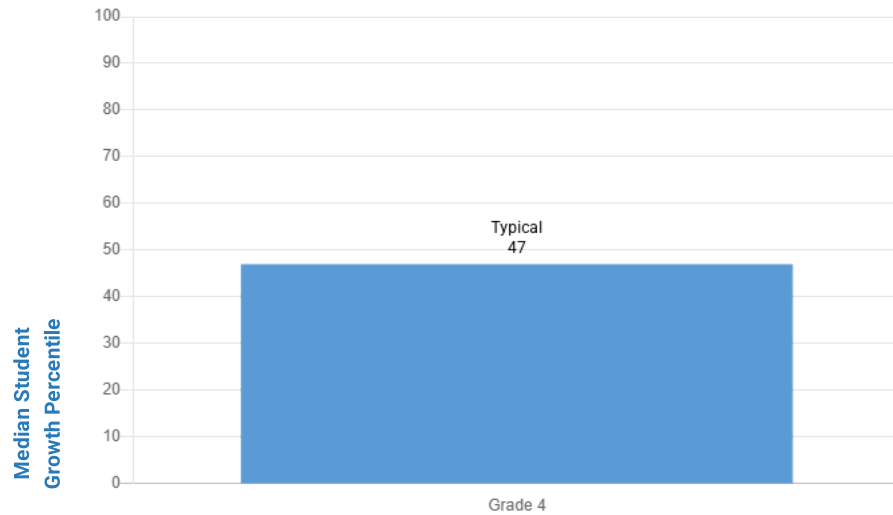

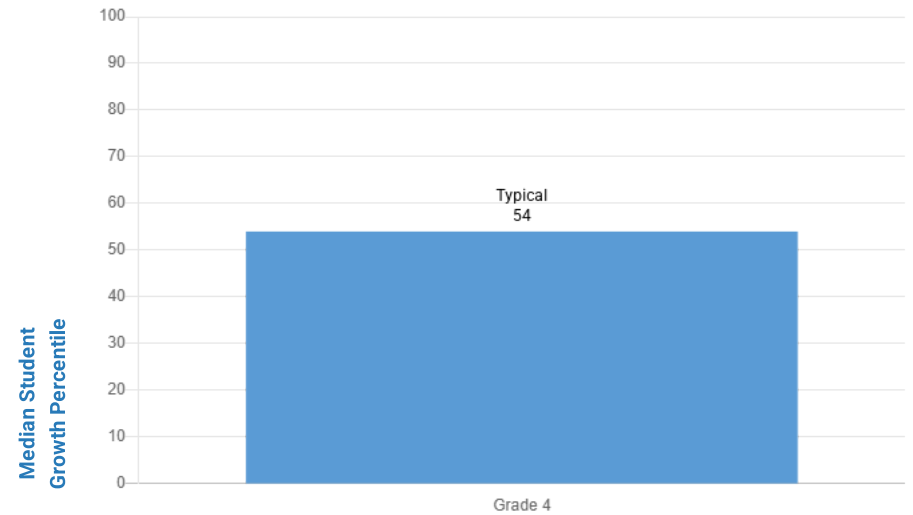

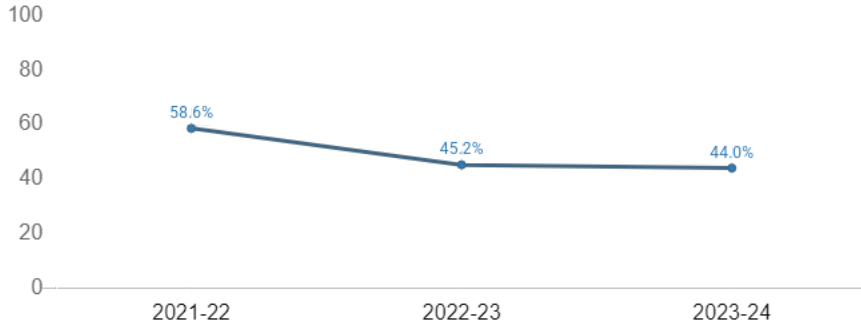

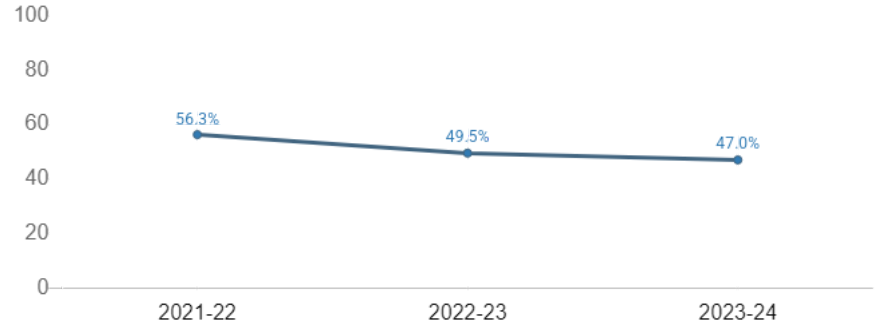
### English Language Arts and Mathematics Performance Trends

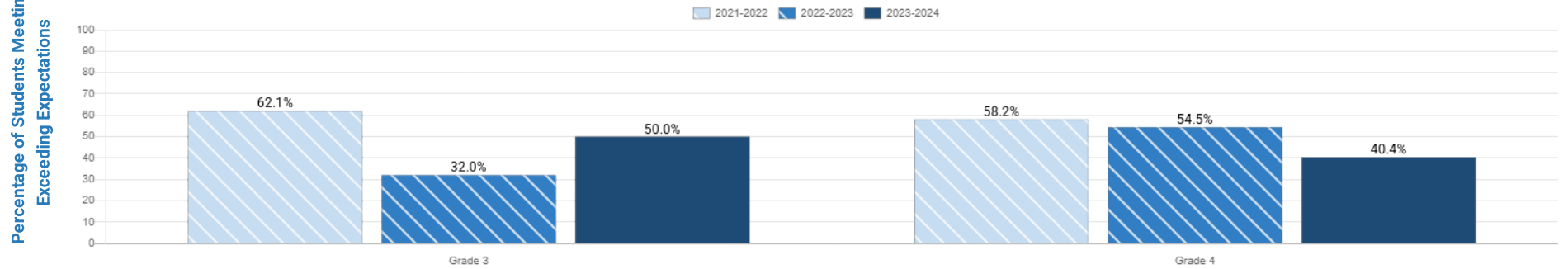

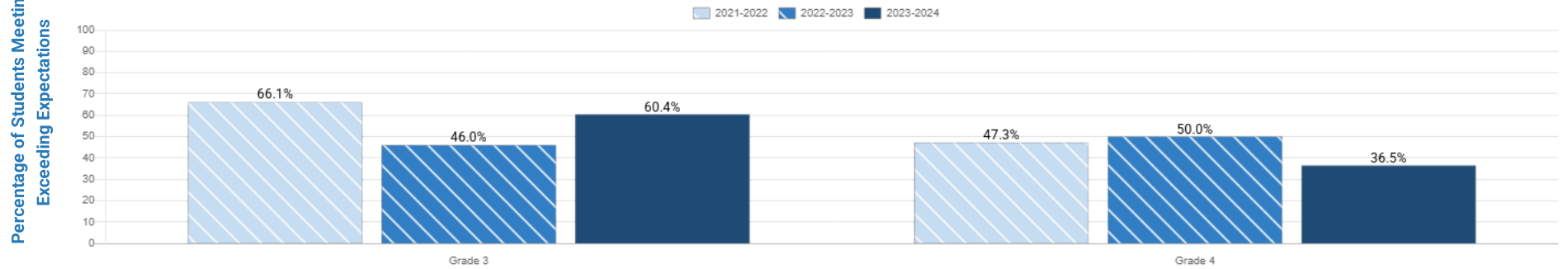

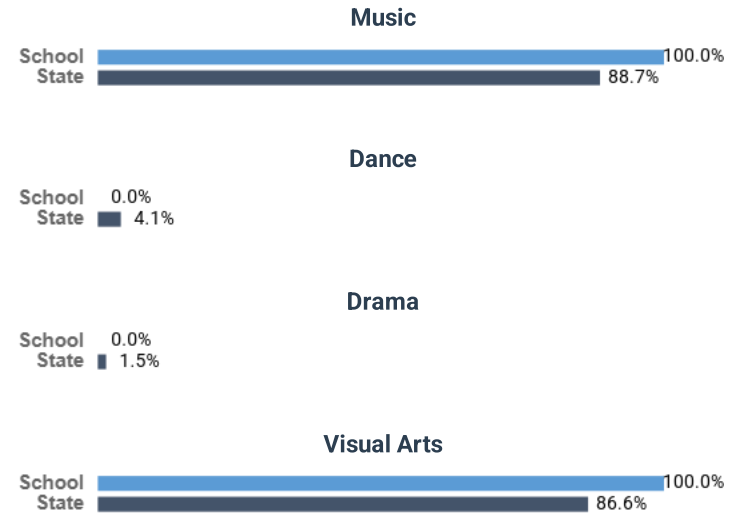

**Students enrolled in one or more classes by discipline:**



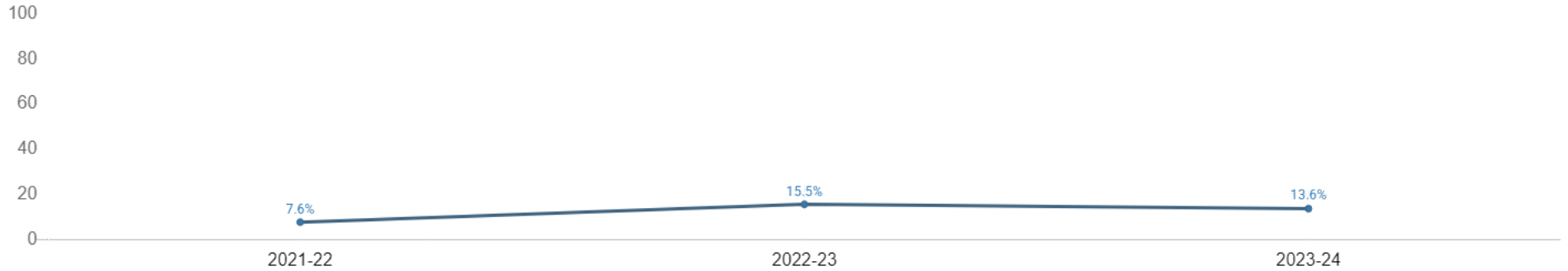

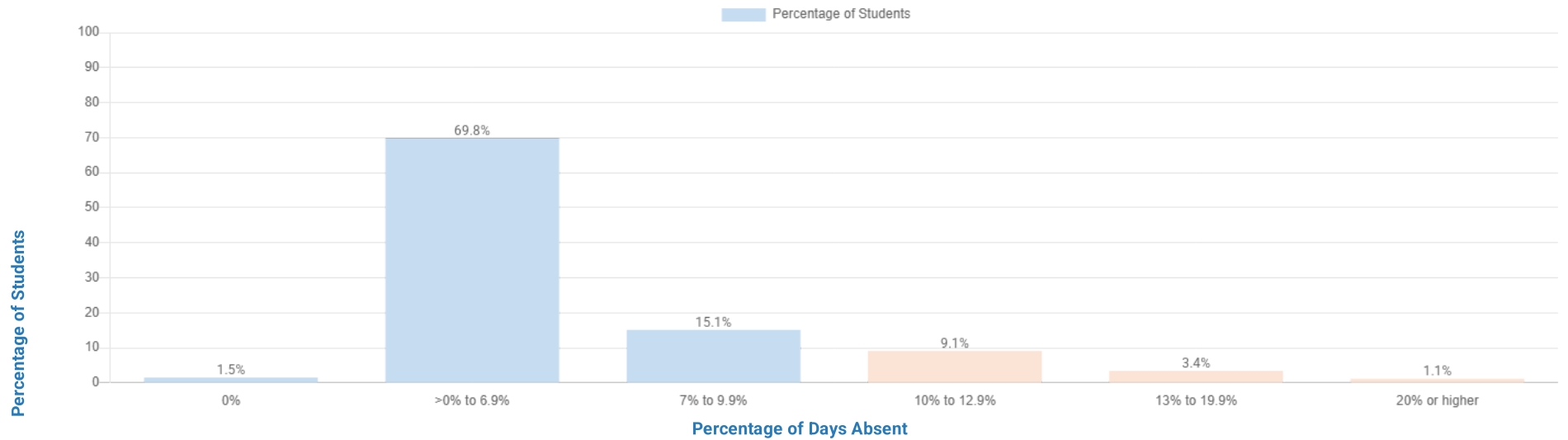

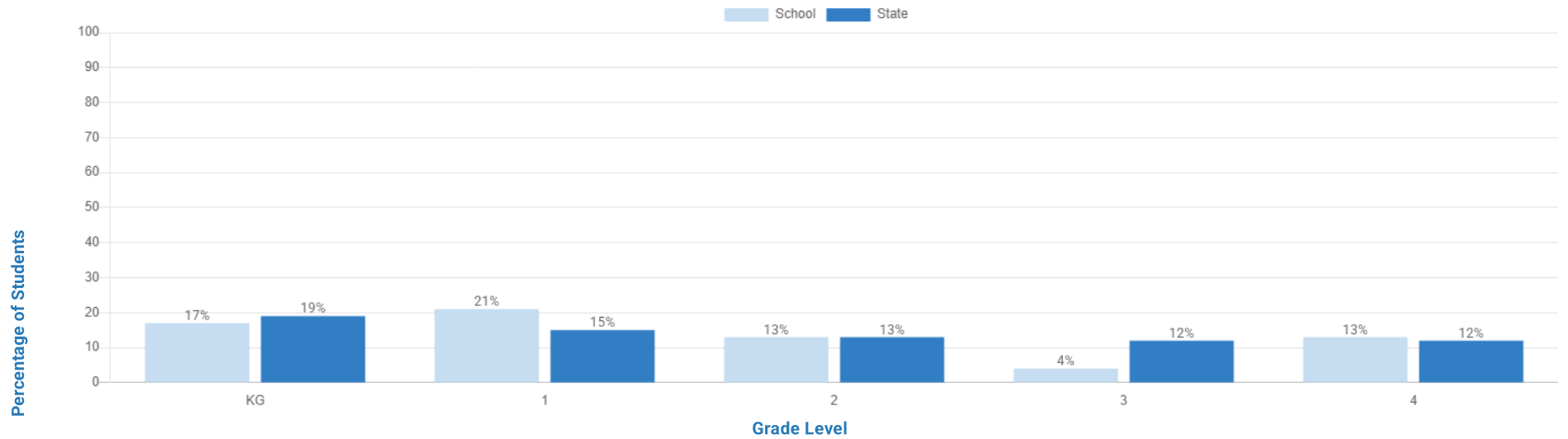

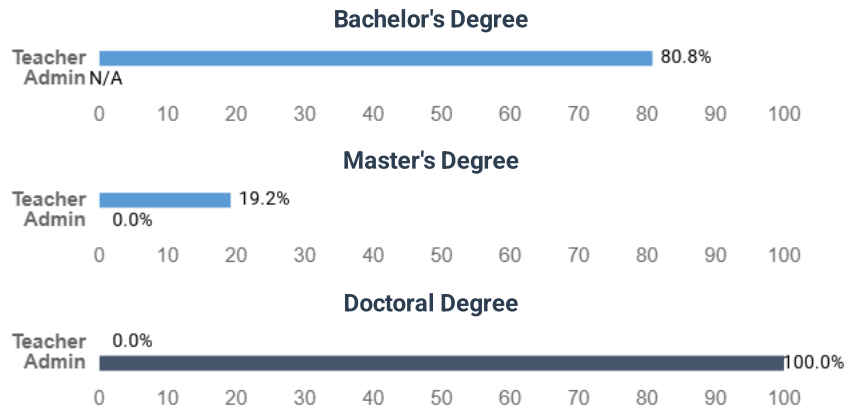

### Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. Schools are identified for ATSI if they have at least one student group that has a summative score that would be in the bottom 5% of Title I schools if it was its own school. Students who are identified for these programs receive intense supplemental instruction that improves their content knowledge throughout the school year. The Gifted and Talented Program is offered to eligible students.

John F. Kennedy School offers a wide variety of clubs and activities for students who are looking for an additional way to learn and grow while attending our school. ### Staff and Professional Learning:

Throughout the school year, faculty and staff participate in various opportunities for continued professional development. Professional Learning Communities (PLCs) and articulation meetings are held on designated Wednesdays. In addition to weekly meetings, the South Plainfield School District provides several full-day and half-day in-service programs throughout the year. Kennedy School teachers have common planning time to increase collaboration throughout our building.



### Student Supports and Services:

Kennedy School offers support and services for students of all levels and needs. Students with IEPs are provided with in-class resource support, pull-out resource, and self-contained classes. Section 504 modifications are monitored regularly. Basic skills programs are offered in ELA and Math to support struggling learners. The Intervention and Referral Services Team (I&RS) works to support teachers when students are identified as requiring academic, behavioral, or emotional assistance. Kennedy School also has a Guidance Counselor and Child Study Team that monitors students' emotional well-being. A Gifted and Talented program and science enrichment is also provided. All teachers work to support students with extra help as needed.



### Student Health and Wellness:

Students participate in physical education classes as well as a daily outdoor recess, weather permitting. A healthy morning breakfast program is offered. The school nurse is proactive in educating our school population on healthy living habits and providing first aid treatments, and the Student Assistance Counselor provides SEL groups for students who are struggling with emotional or behavioral challenges.

### School Safety:

The South Plainfield School District provides school resources officers (SRO's), sworn law enforcement personnel, who add a layer of security to the schools' campuses as well as provide education and mentoring for our students. Annual training is provided to staff on the topics of safety and security; students and staff participate in monthly security/safety drills. An Anti-Bullying Specialist provides programs and resources to parents, students, faculty, and staff.



### Attendance:

The students at John F. Kennedy Elementary had the opportunity to participate in push in daytime academic support programming, after school STEM clubs, and schoolwide mindfulness programming to support students' social and emotional health.
