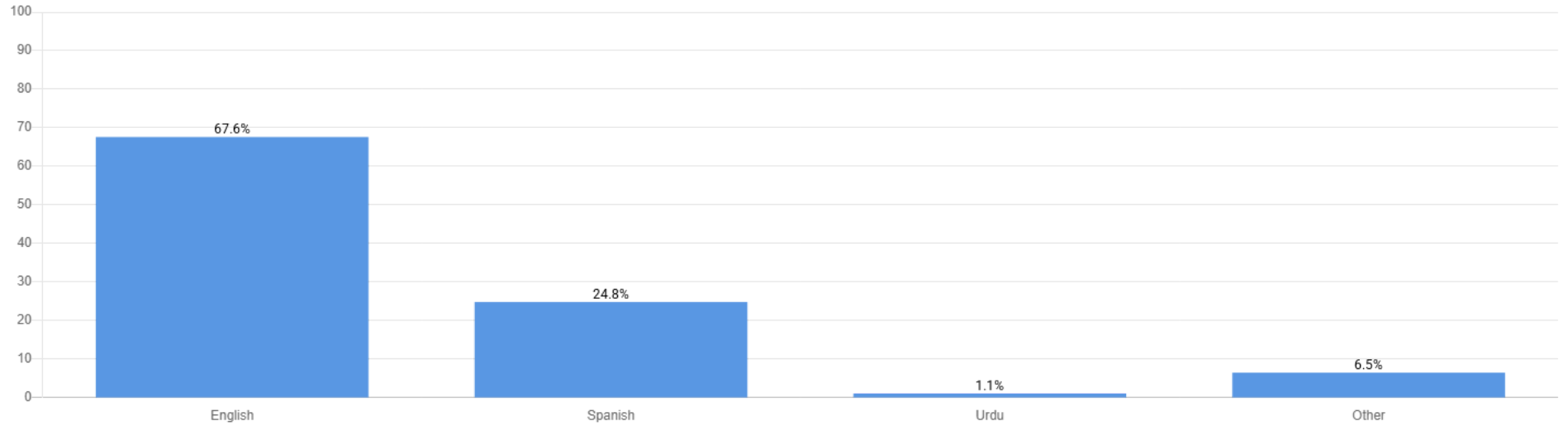

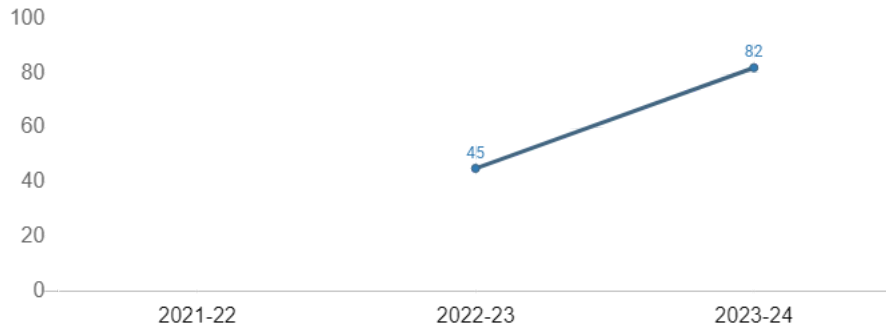

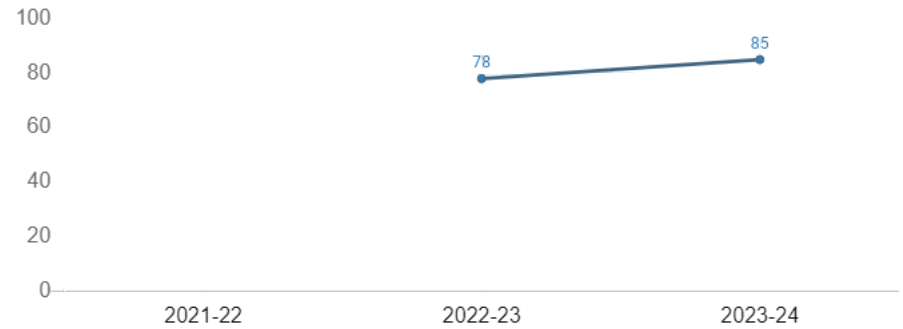

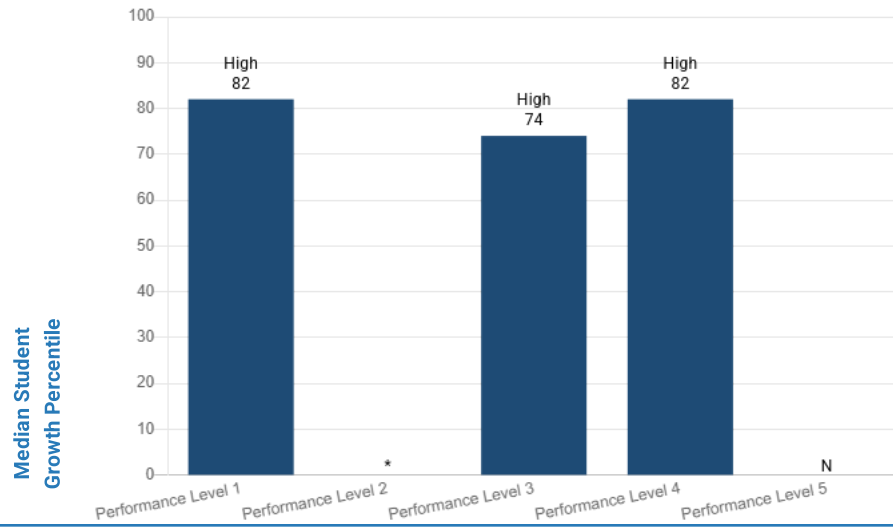

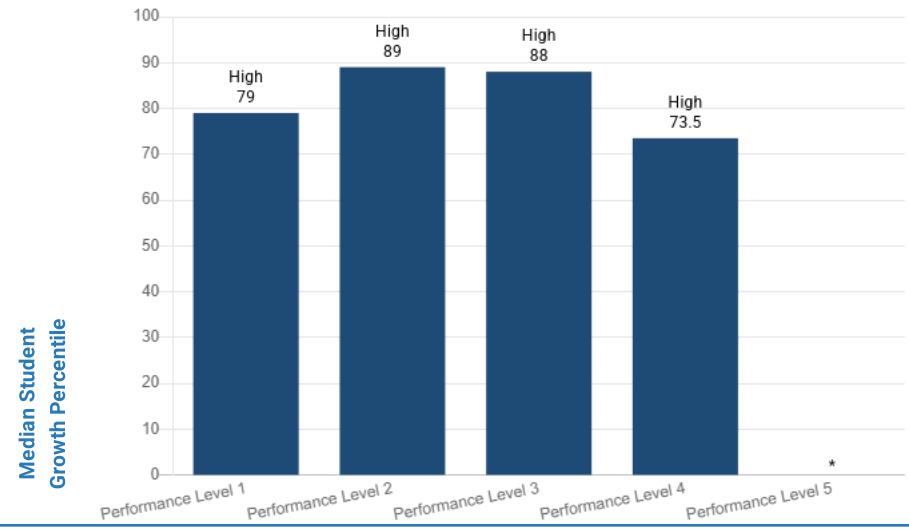

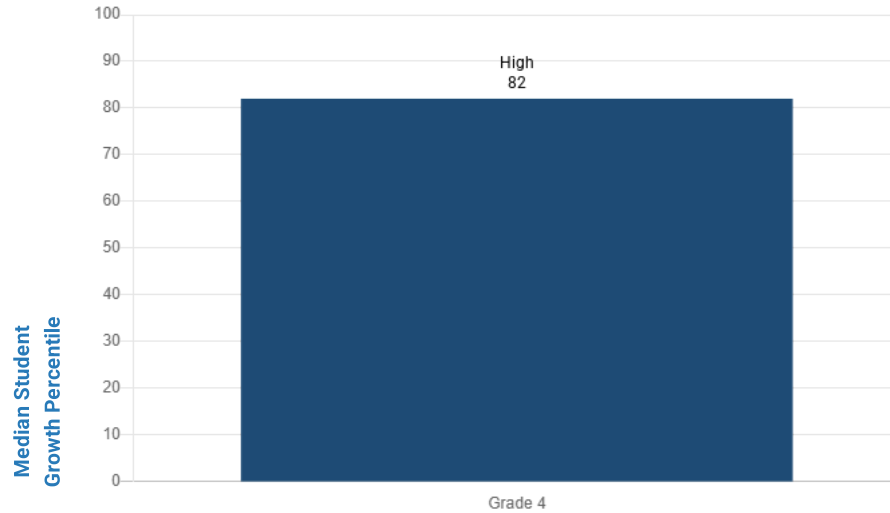

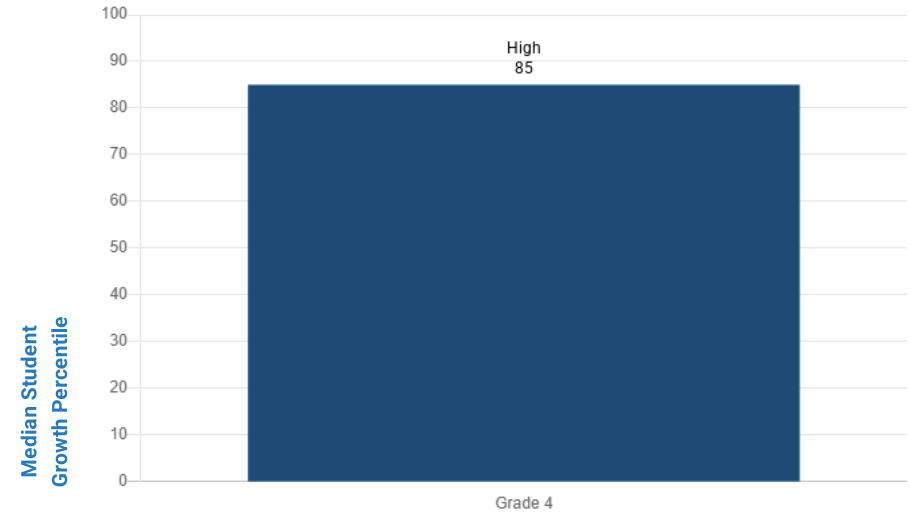

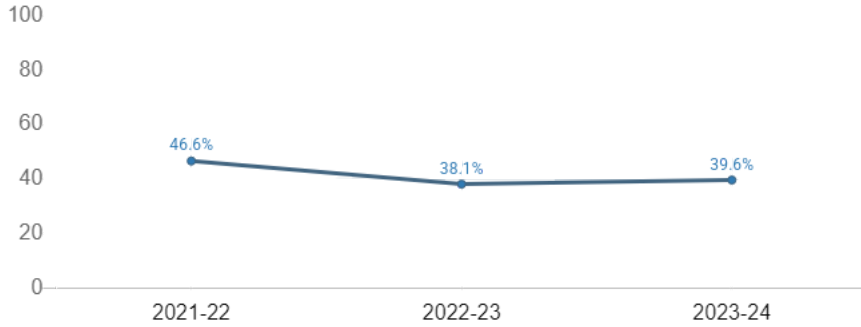

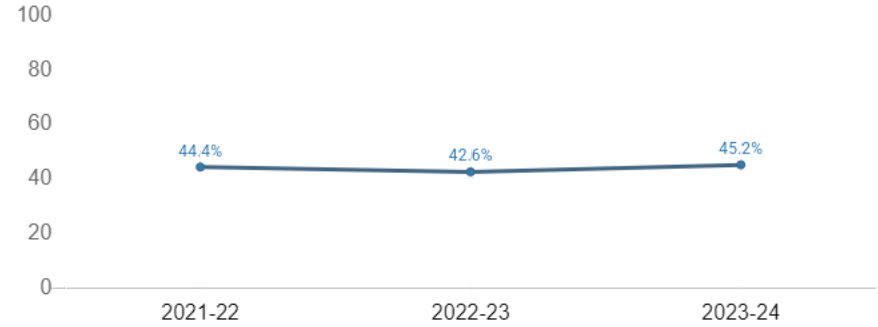
### English Language Arts and Mathematics Performance Trends

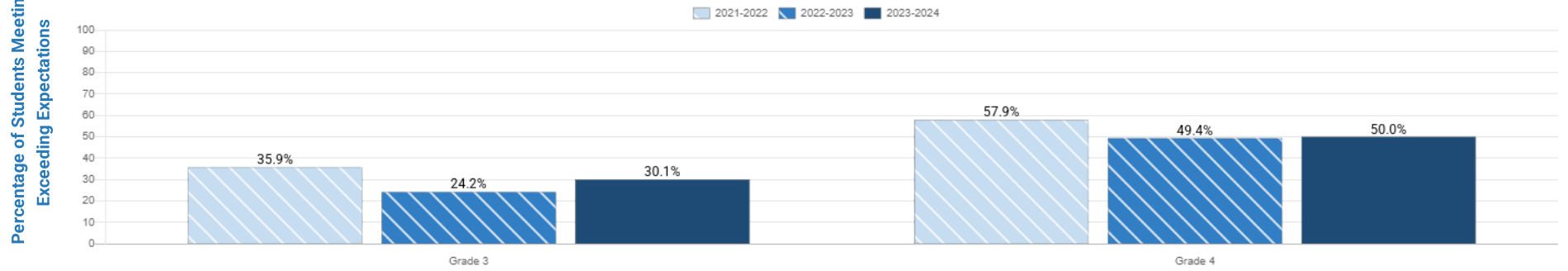

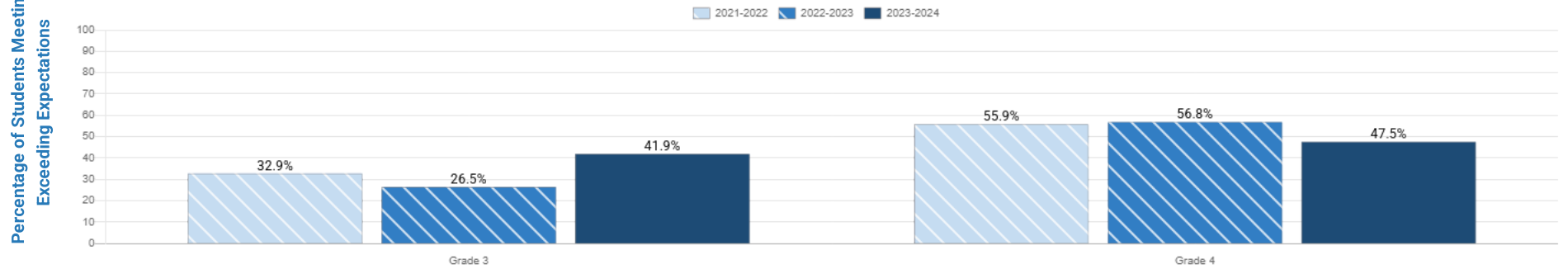

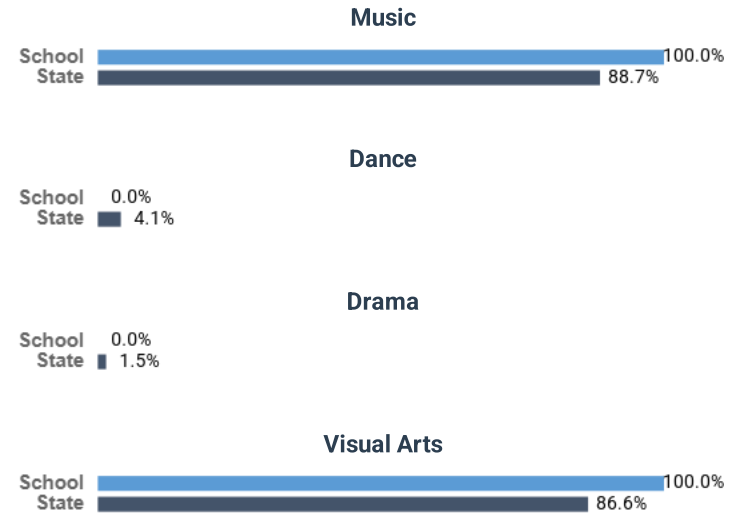

**Students enrolled in one or more classes by discipline:**



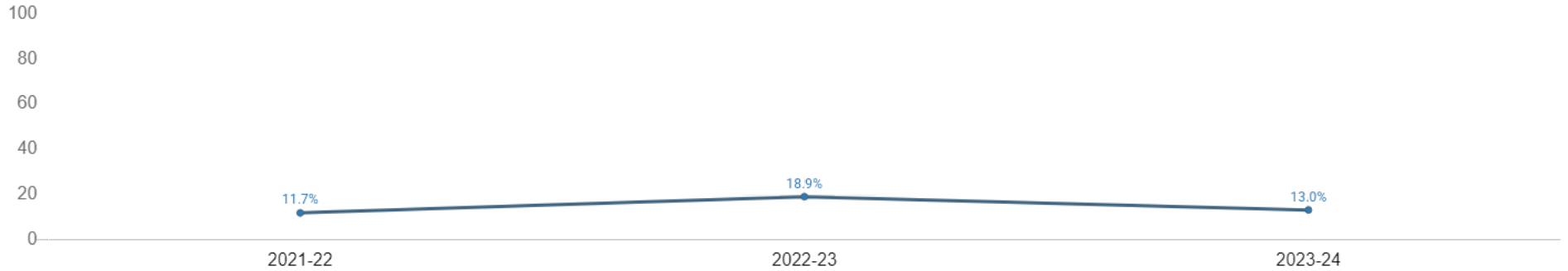

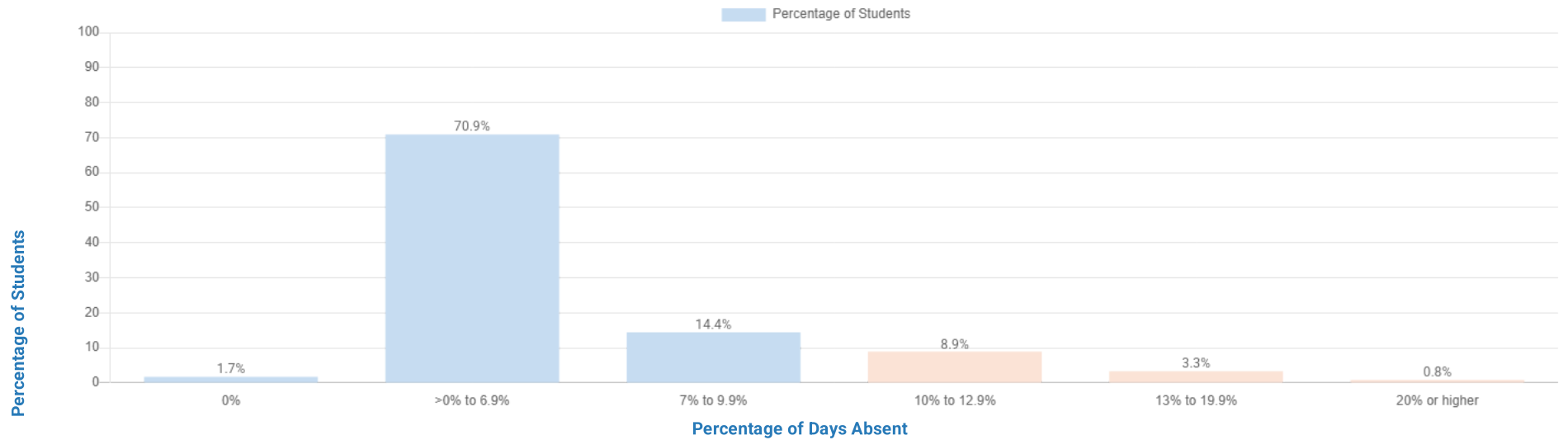

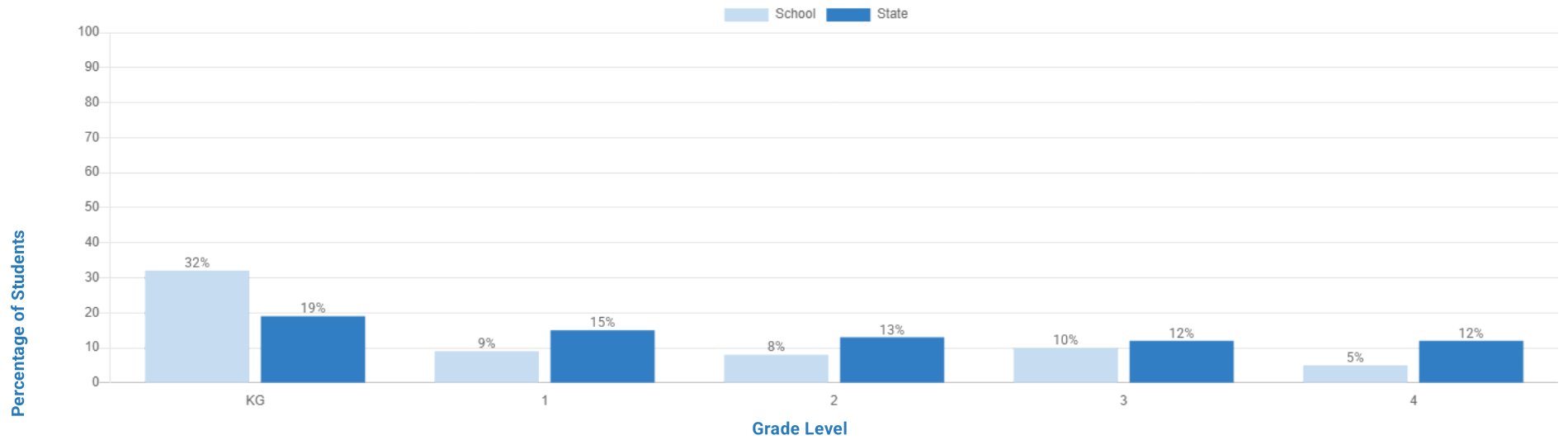

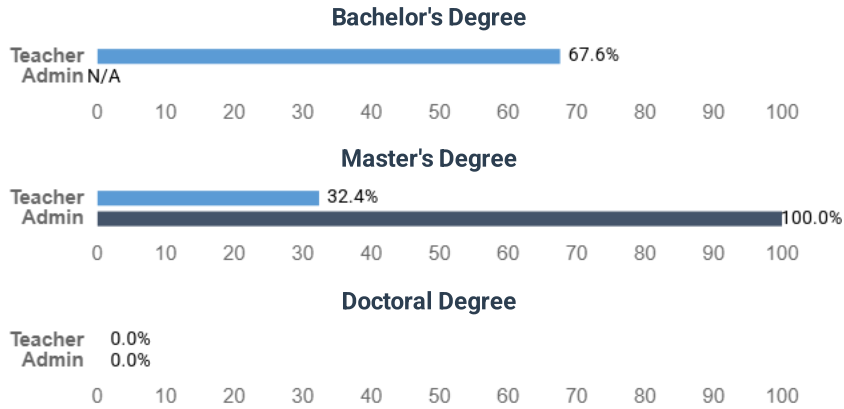

### Courses, Curriculum, Instruction:

Riley School provides several programs to ensure students' needs are being met. We have a full day program for students from kindergarten through 4th grade. Our curriculum focuses on the core areas of reading, writing, mathematics, social studies and science. We offer specials such as STEM, Spanish, Art, Music, Physical Education, and Chorus. Our students have access to ELA and Math Basic Skills Programs that are integrated in all classes. These programs are created to provide intense supplemental instruction to improve students' content knowledge throughout the school year. We also have a Gifted and Talented Program for those students who qualify.



### Clubs and Activities:

John E. Riley Elementary School has a variety of clubs and organizations students can participate in and learn together inside and outside the classroom. These extracurricular and co-curricular programs include but are not limited to, the 4th Grade Student Council, School Safety Patrol, chorus, orchestra, band, Wingman Leaders. These programs form a diverse mix of opportunities for our students to explore their talents and to learn to work well with one another.



### Before and After School Programs:

Before and After School Care programs are offered by the South Plainfield School District. The service is available to all students in kindergarten through 4th grade. ### Staff and Professional Learning:

Riley School follows the district wide schedule for all faculty and staff. Professional development is utilized to focus on specific needs of the faculty. Teachers regularly meet in PLC's (Professional Learning Communities) by grade levels or by departments/content to address and discuss student data, student needs, and vertical and horizontal articulation to help guide classroom instruction. Throughout the year, the district has full and half day professional development sessions to provide staff the opportunity to meet to learn and apply new and improved skills.



### Student Supports and Services:

Riley School offers support and services for students of all levels and need. Special Education courses are available for students with IEPs including in-class resource support, pull out resource, and self-contained classes. Basic skills programs are offered in ELA and Math to support struggling learners. The Intervention and Referral Services Team (I&RS) works to support teachers when students are identified as requiring academic or emotional assistance. Riley School also has a Guidance Counselor to support students' emotional well-being. English as a Second Language (ESL program) supports multilingual students who are learning to read, speak, and write English. All teachers work to support the Riley School students with extra help as needed.



### Student Health and Wellness:

Students participate in physical education classes as well as a daily outdoor recess, weather permitting. A healthy morning breakfast program is offered. The school nurse is proactive in educating our school population on healthy living habits and providing first aid treatments, and the Student Assistance Counselor provides SEL groups for students who are struggling with emotional or behavioral challenges.

All classrooms feature central heating and air conditioning including the gymnasium. It has a staff parking lot, open grass areas, two playgrounds and a large recess area with a ball field.



### School Safety:

The South Plainfield School District provides school resources officers (SRO's), sworn law enforcement personnel, who add a layer of security to the schools' campuses as well as provide education and mentoring for our students. Annual training is provided to staff on the topics of safety and security; students and staff participate in monthly security/safety drills. An Anti-Bullying Specialist provides programs and resources to parents, students, faculty, and staff.
