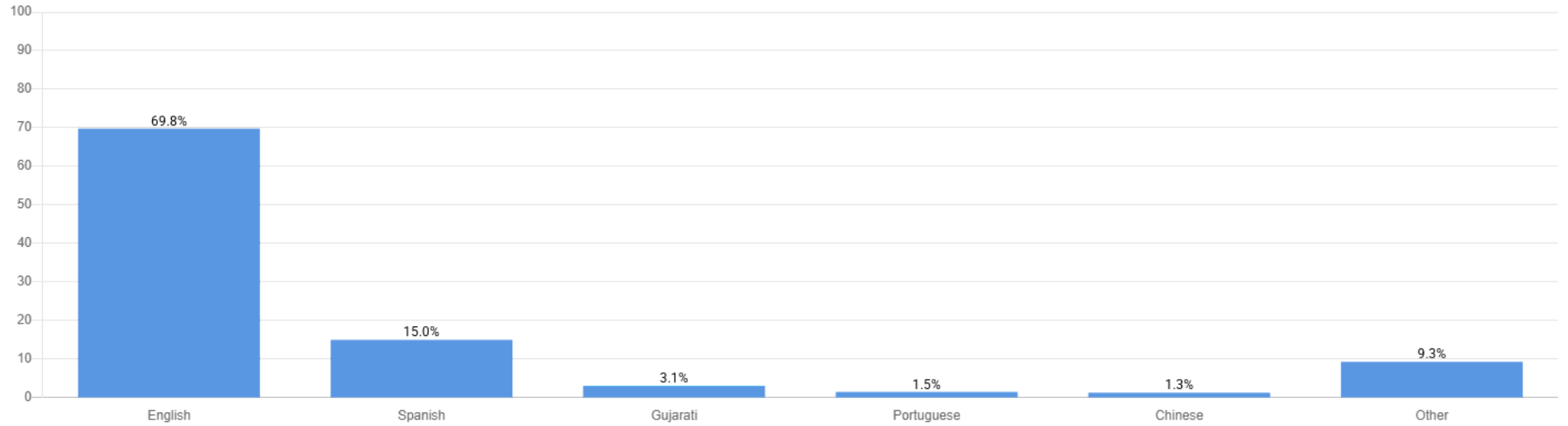

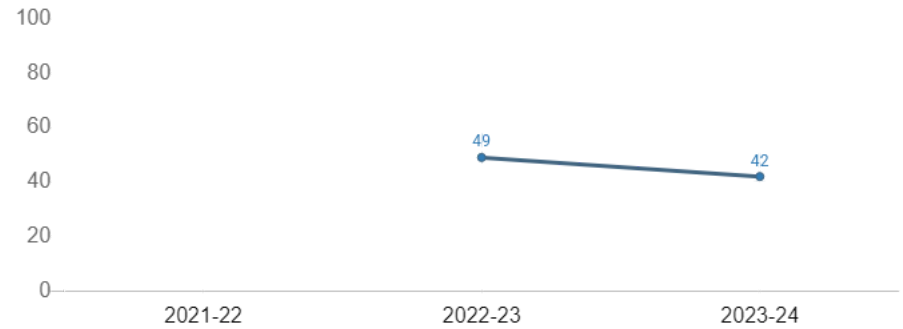

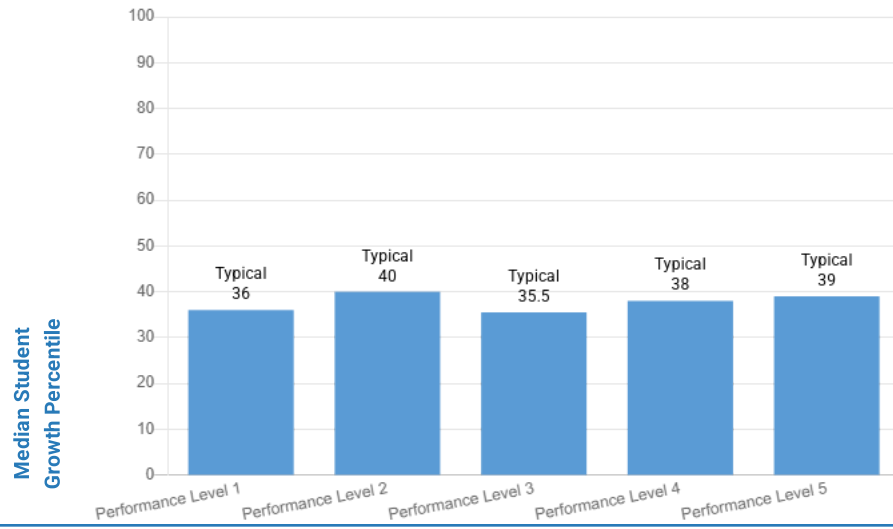

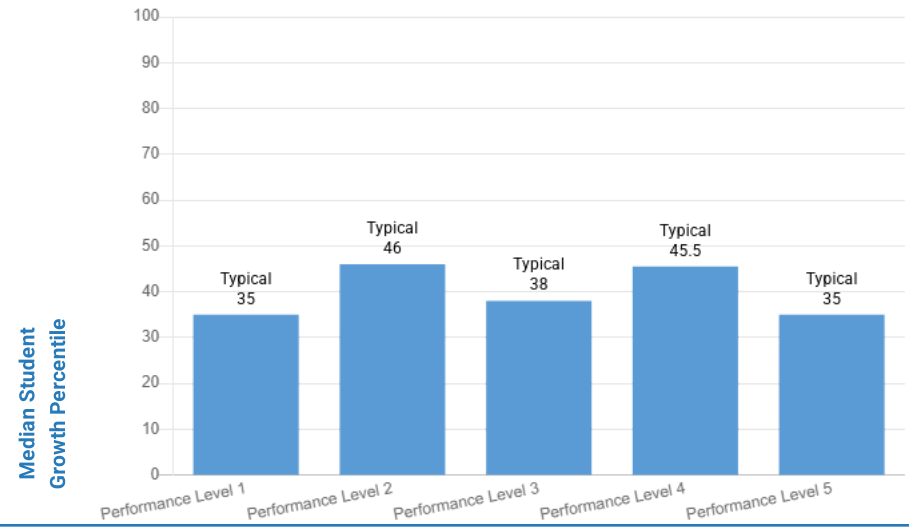

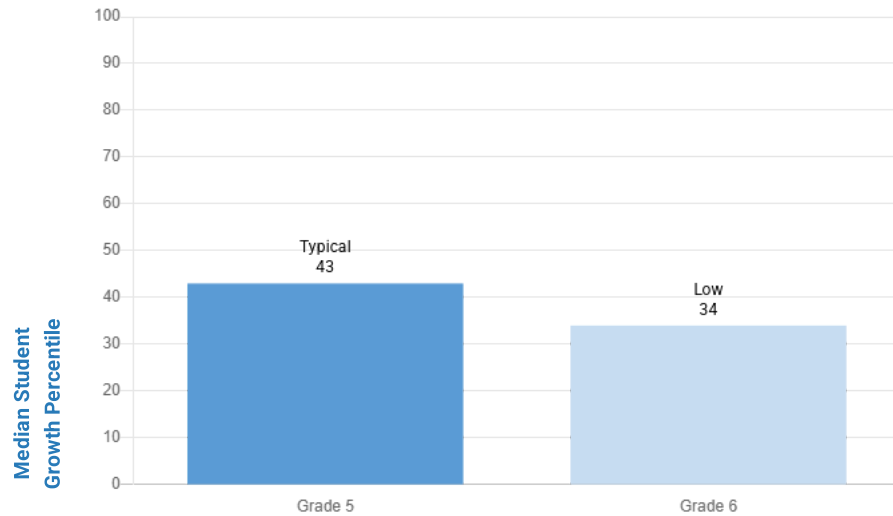

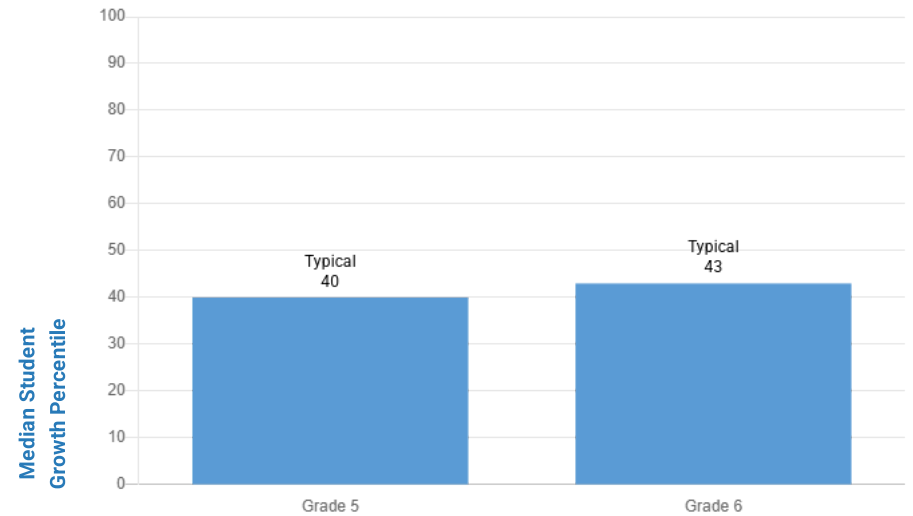

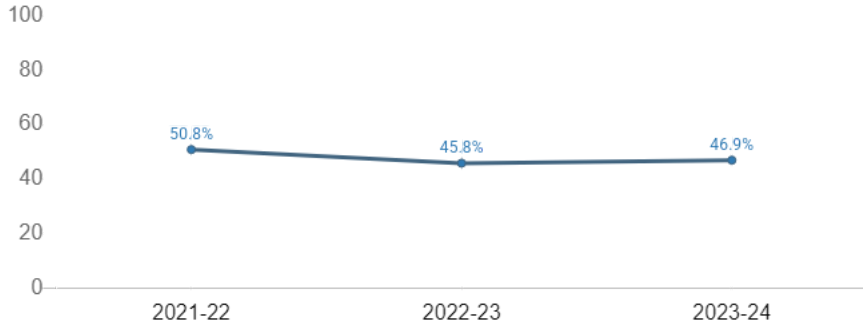

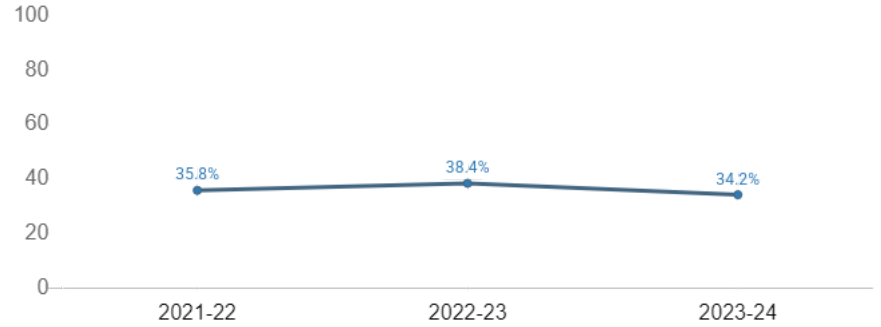
English Language Arts and Mathematics Performance Trends

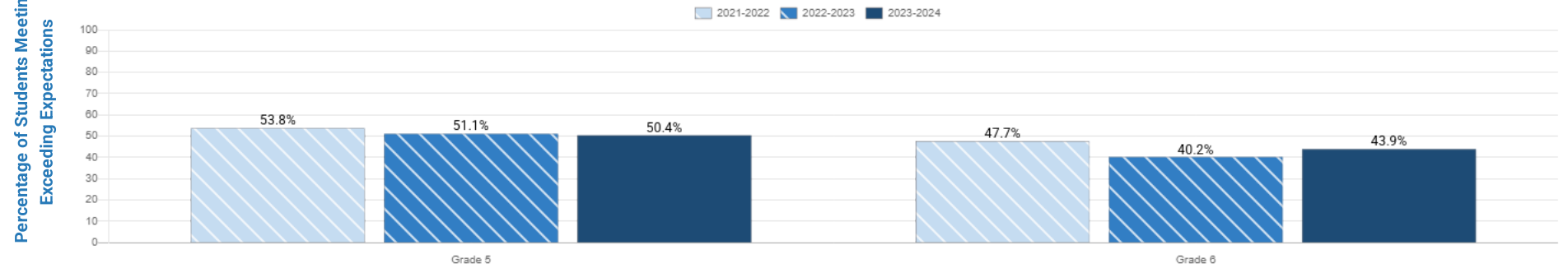

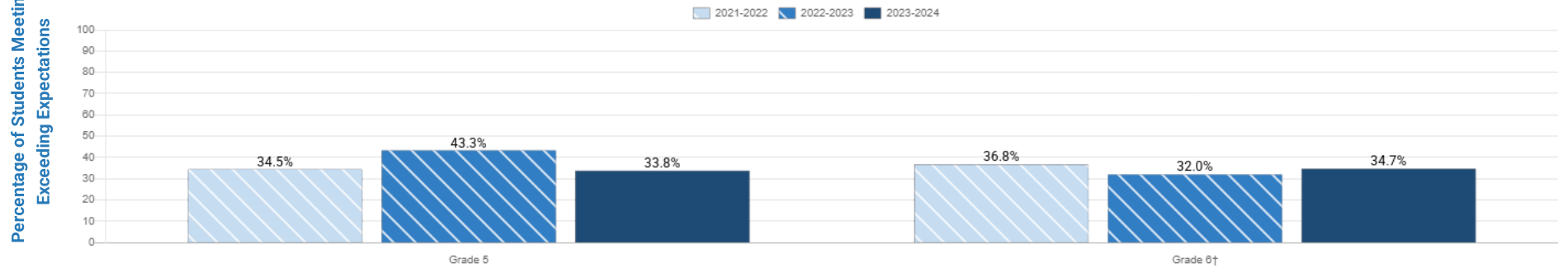

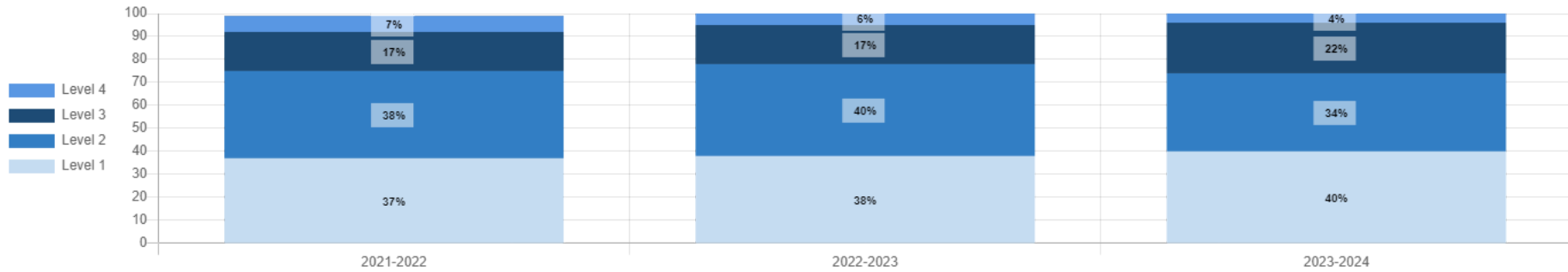

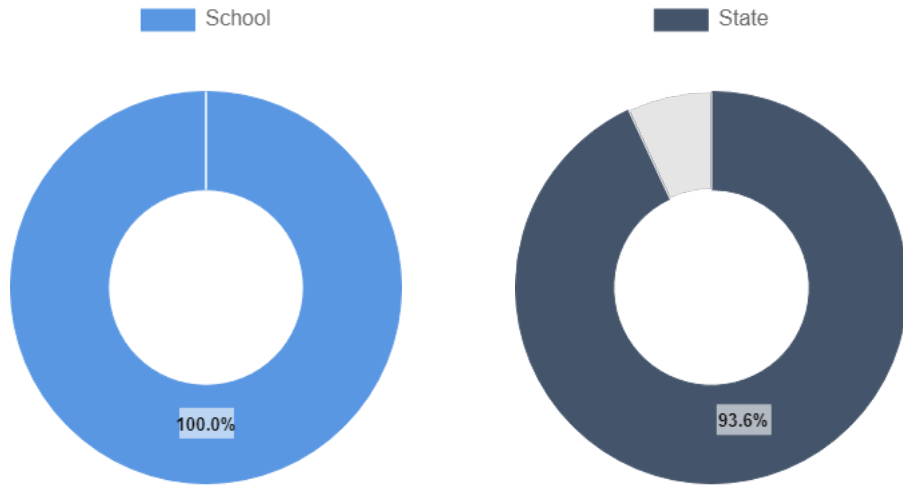

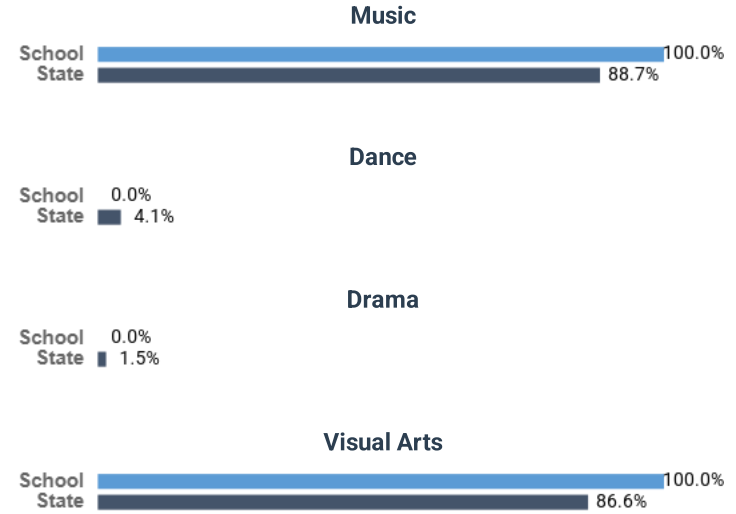

Students enrolled in one or more classes by discipline:



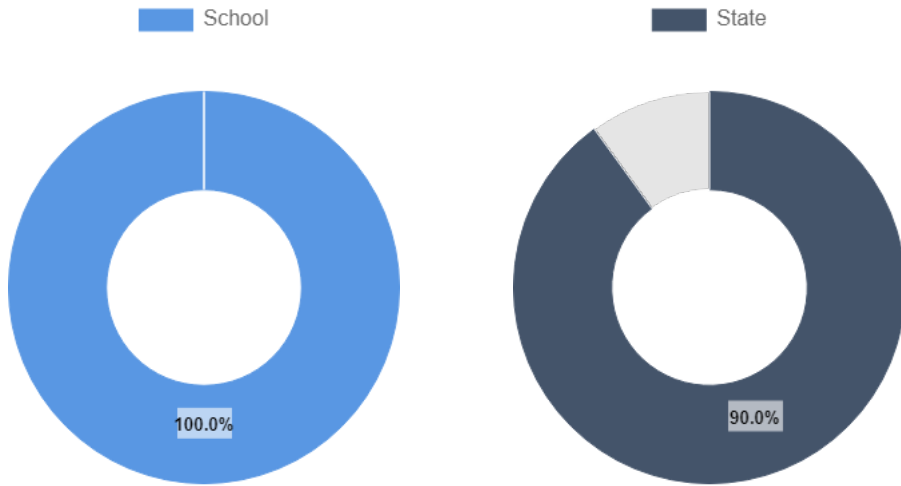

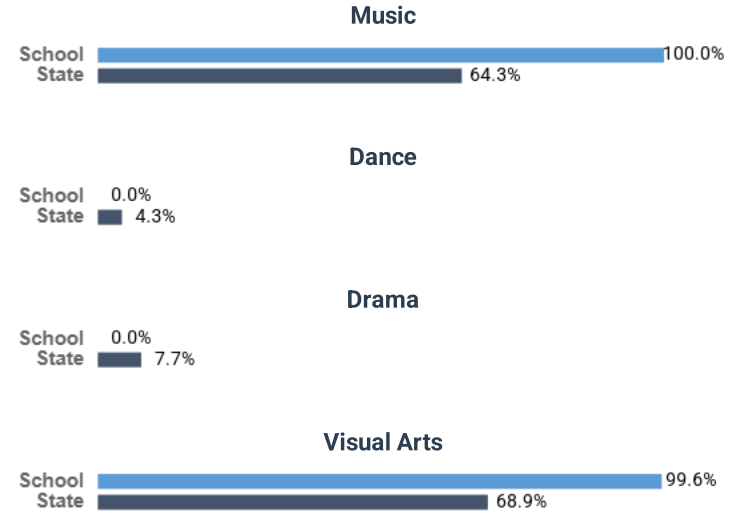

Students enrolled in one or more classes by discipline:



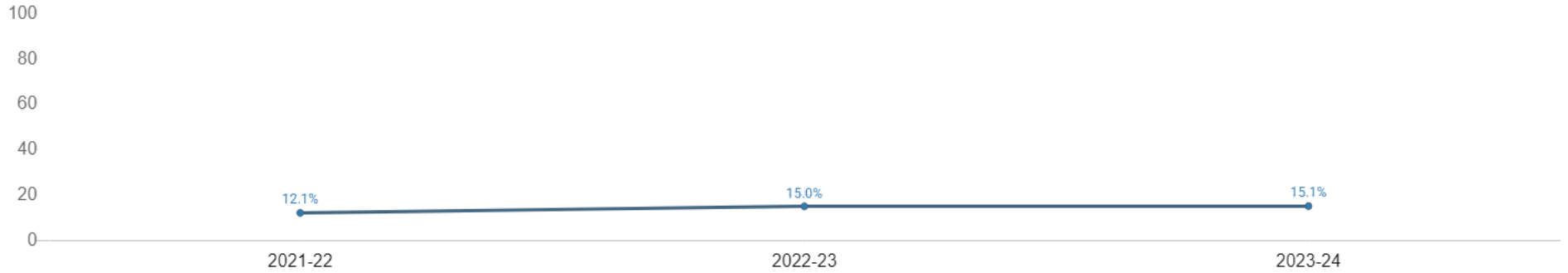

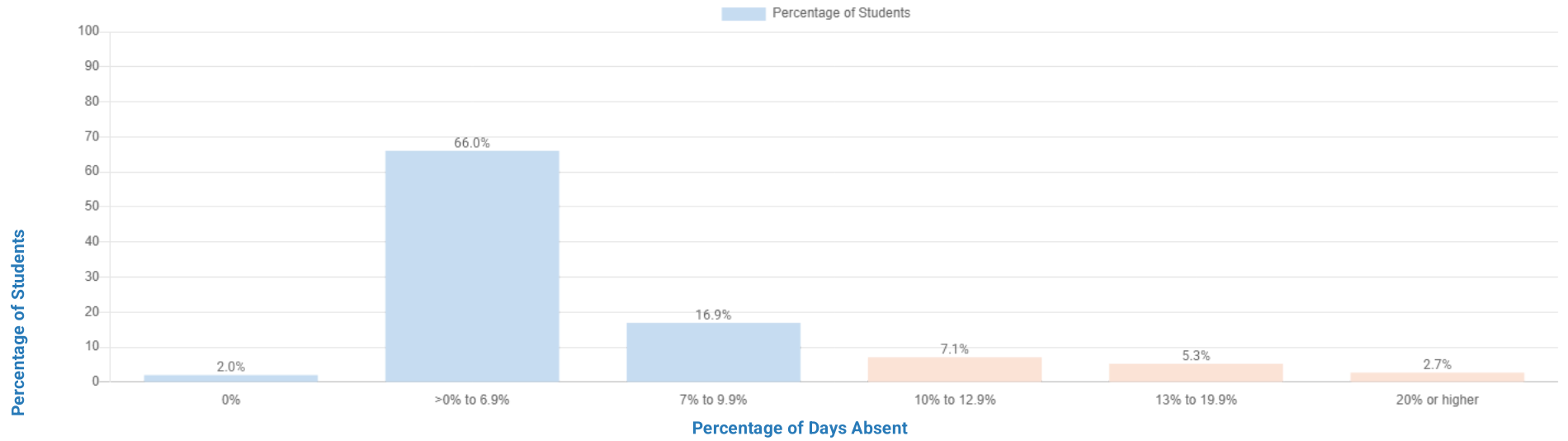

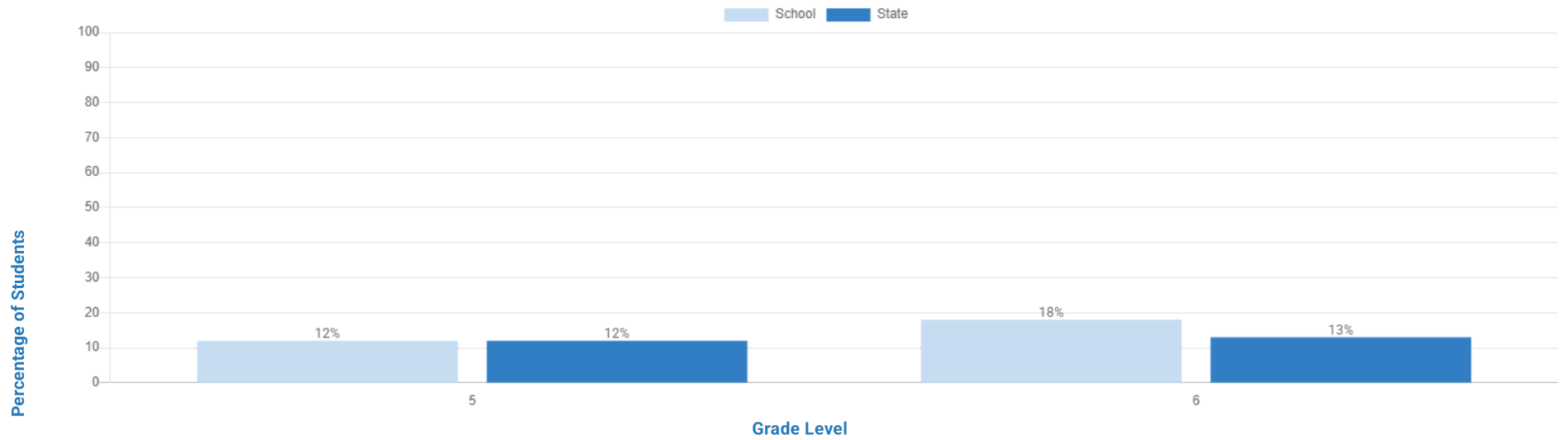

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. - Students are provided with a Chromebook that is used throughout the day. Technology is integrated in daily lessons to offer students a variety of communication, collaboration, and engagement methods.
- Students participate in Character Education and Social Emotional Learning to encourage the growth and development of the skills and values necessary to meet challenges and find individual success.



Students are the focus of the South Plainfield Public Schools. We will provide a dynamic, rigorous, relevant and technology-enriched curriculum, guided by the New Jersey Student Learning Standards. Our mission is to develop life-long learners who are prepared to succeed in a global and diverse society. We are resolved to educate the whole child, instilling the desire within our students to question and to become divergent thinkers who can achieve their fullest potential.



Grant School offers a variety of awards and recognition programs to celebrate student achievements. These include: High Honor Roll - Awarded to students with exceptional academic performance, typically requiring all As. Honor Roll - Awarded to students with solid academic performance, typically those maintaining As and Bs. Tiger Buck Winner - Acknowledges students who demonstrate outstanding behavior, responsibility, and a positive attitude, earning "Tiger Bucks" for their efforts. Character Education Winner - Recognizes students who exemplify strong character traits such as respect, responsibility, and integrity. Student of the Month - Honors students who show consistent excellence, leadership, or improvement, selected each month. These programs are designed to motivate students and highlight their hard work, behavior, and contributions to the school community.

Courses, Curriculum, Instruction:

The New Jersey Student Learning Standards set the framework for Grant School's rigorous curriculum. Each day students study 80 minutes of English Language Arts and Math, 40 minutes of Science, Social Studies, Physical Education/Health, and 40 minutes of an expressive arts class (Music, Art, STEM, World Language) that rotates quarterly. In addition to general music education, students in Grades 5 and 6 have the opportunity to participate in chorus, band, and orchestra.



Clubs and Activities:

There is a variety of clubs and activities available to Grant School students. Concert Band, Jazz Band, Chorus, Orchestra, Student Council, Drama Club, Literary Magazine, Academic Bowl, Chess Club, Grant Gazette Newspaper, Multicultural Club, and the Peer Leaders give students the opportunity to learn and explore individual interests.



Before and After School Programs:

Students can participate in the After Care Program, a tuition-based after-school care program, where students may work on homework, small group activities, planned events, and socialize with peers.

Staff and Professional Learning:

Throughout the school year, faculty and staff participate in variety of opportunities for continued professional development. Professional Learning Communities (PLCs) and department meetings are held on designated Wednesdays. In addition to weekly meetings, the South Plainfield School District provides several full day and half day inservice programs throughout the year. Grant School teachers have common planning time to increase the collaboration amongst our teams.



Student Supports and Services:

Grant School offers support and services for students of all levels and need. Special Education courses are available for students with IEPs including in-class resource support, pull out resource, and self-contained classes. Basic skills programs are offered in ELA and Math to support struggling learners. The Intervention and Referral Services Team (I&RS) works to support teachers when students are identified as requiring academic or emotional assistance. Grant School also has a two Guidance Counselors; both support students' emotional well-being. Academically enriched ELA and Math classes are open to excelling 6th grade students; students in both grades can be selected for participation in the Gifted and talented program. English as a Second Language (ESL program) supports multilingual students who are learning to read, speak, and write English. All teachers work to support the Grant School students with extra help as needed.



Student Health and Wellness:

Grant School Students participate in 40 minutes of physical education daily as well as outdoor recess (weather permitting) during their lunch period. The Guidance Counselors offer sessions for students in need of support with emotional or behavioral challenges.

Instructional facilities include lab-type science classrooms in the 6th grade wing, along with a computer lab, media center, and dedicated music and art rooms.

Annual training is provided to staff on the topics of safety and security; students and staff participate in monthly security/safety drills.
