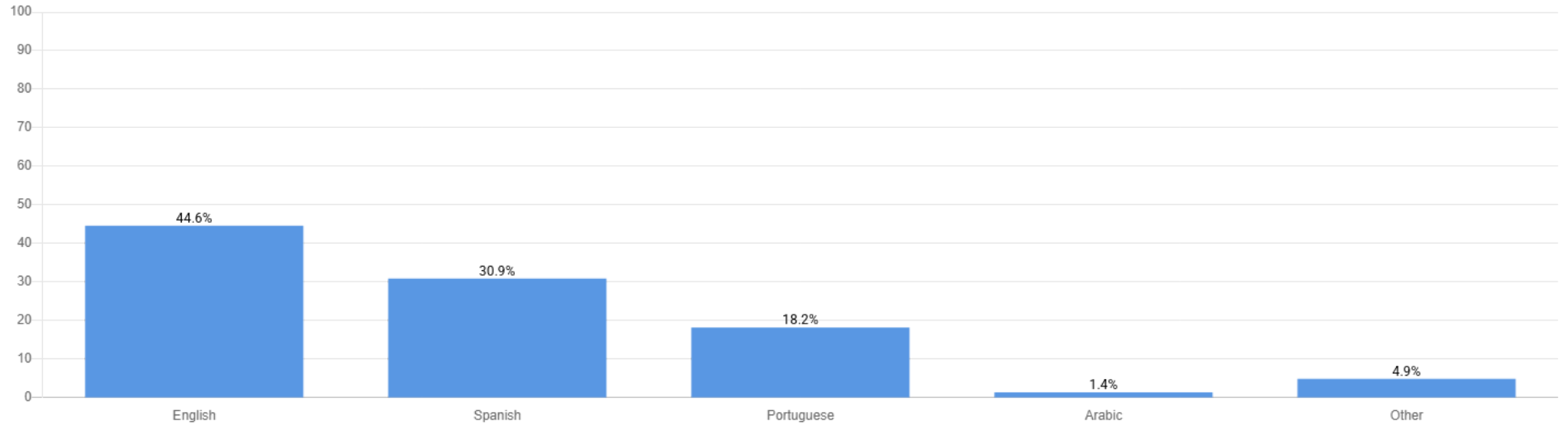

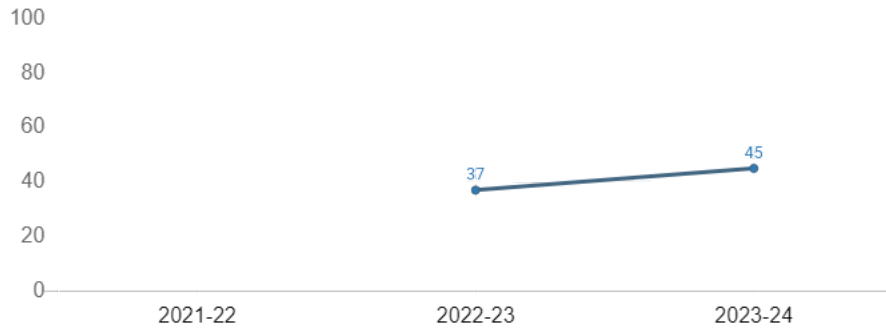

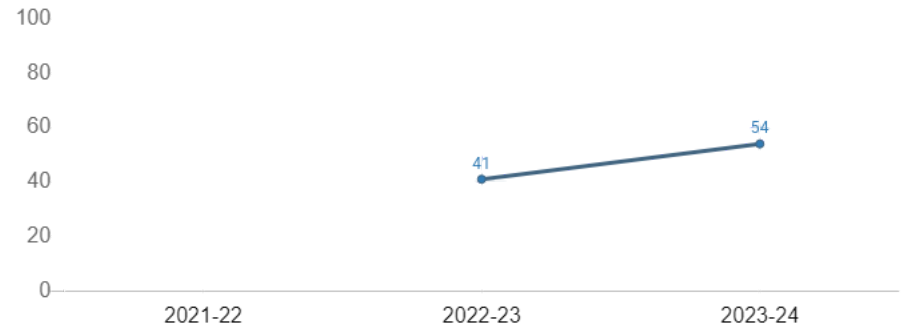

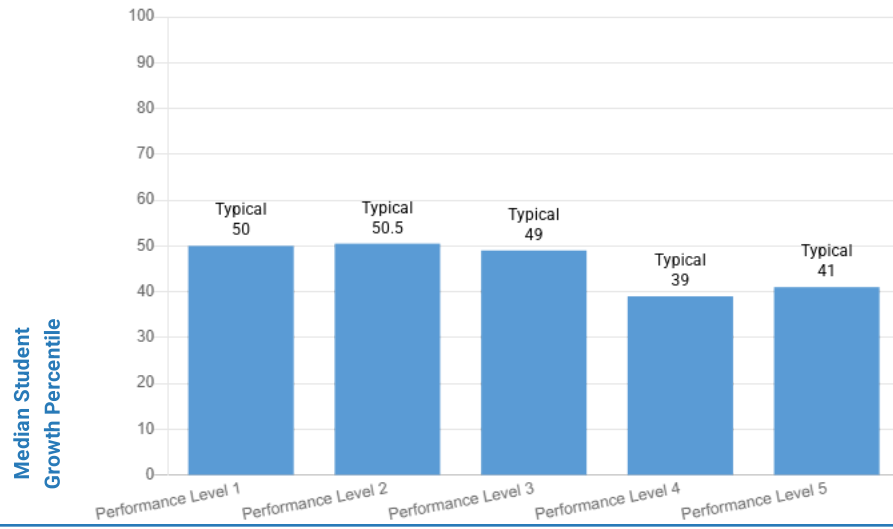

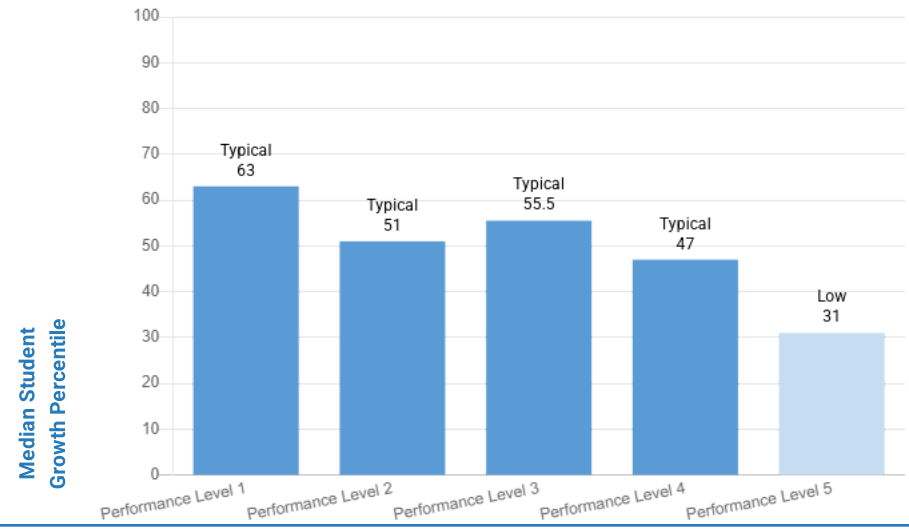

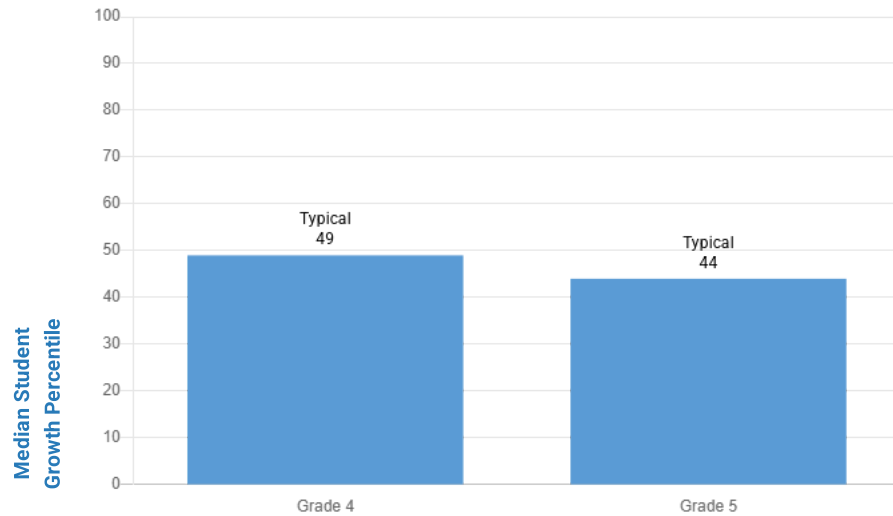

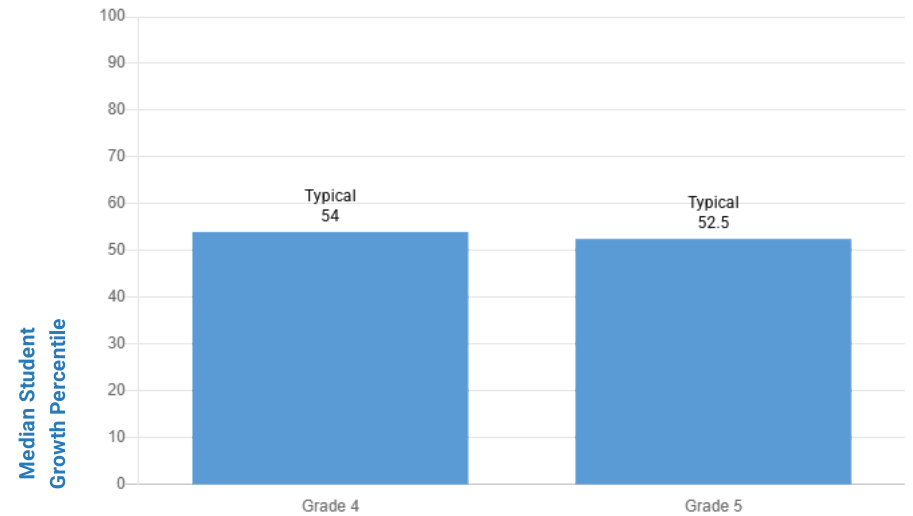

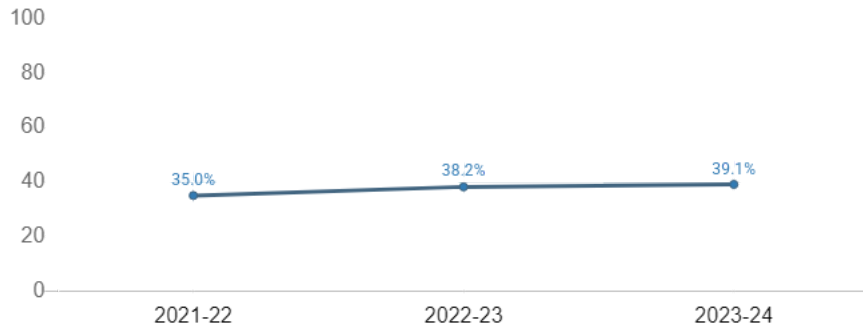

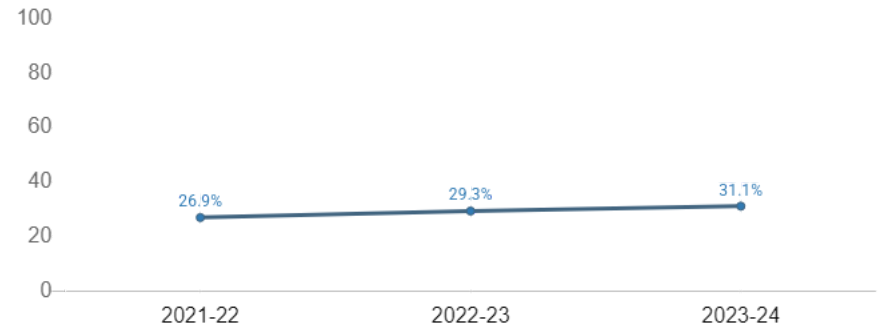
English Language Arts and Mathematics Performance Trends

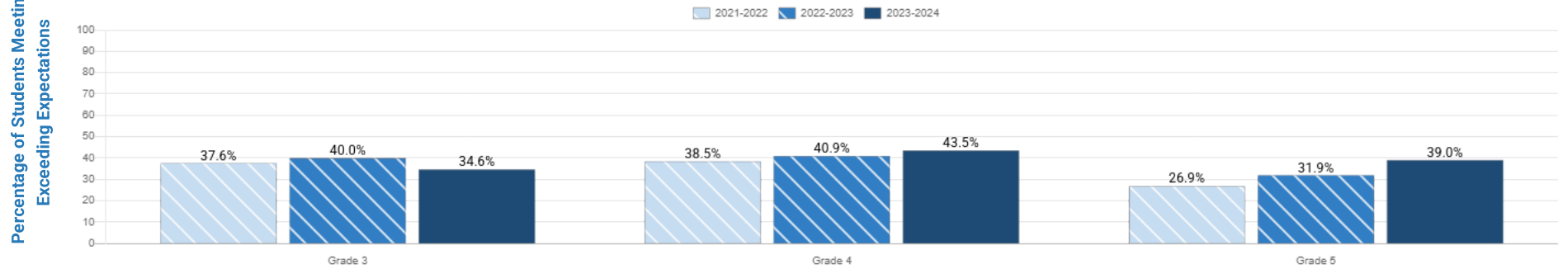

Mathematics Assessment - Participation and Performance

This table shows performance on statewide assessments for mathematics both overall and by student group. It includes the results of students taking both the NJSLA and DLM. NJSLA results include students taking end-of-grade assessments in grades 3 through 8, as well as end-of-course assessments (Algebra I, Geometry, Algebra II) in middle school and high school. High school mathematics assessment results include all results for Algebra I and Geometry and/or Algebra II results only for students who took Algebra I in middle school and who are enrolled in their first high school mathematics course that corresponds to an end-of-course assessment. Students who were enrolled for less than half a school year are excluded from performance results. Student are considered to have met or exceeded expectations if they score at Level 4 or 5 on the NJSLA or at Level 3 or 4 on the DLM assessment.

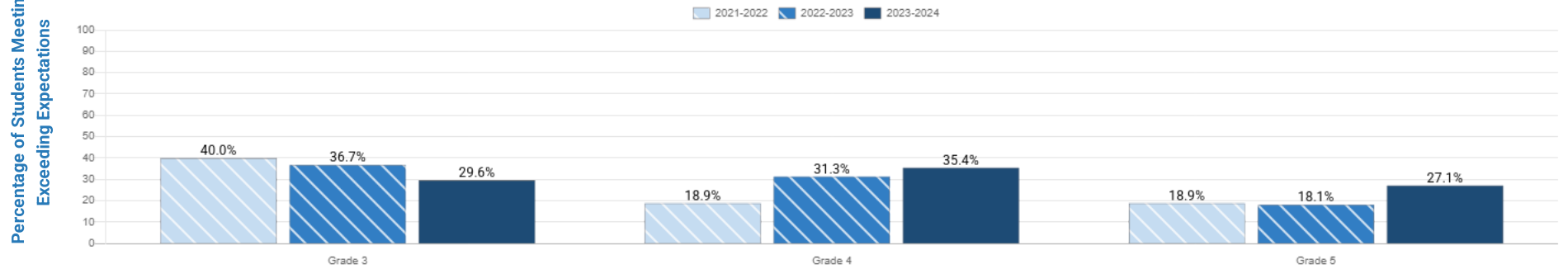

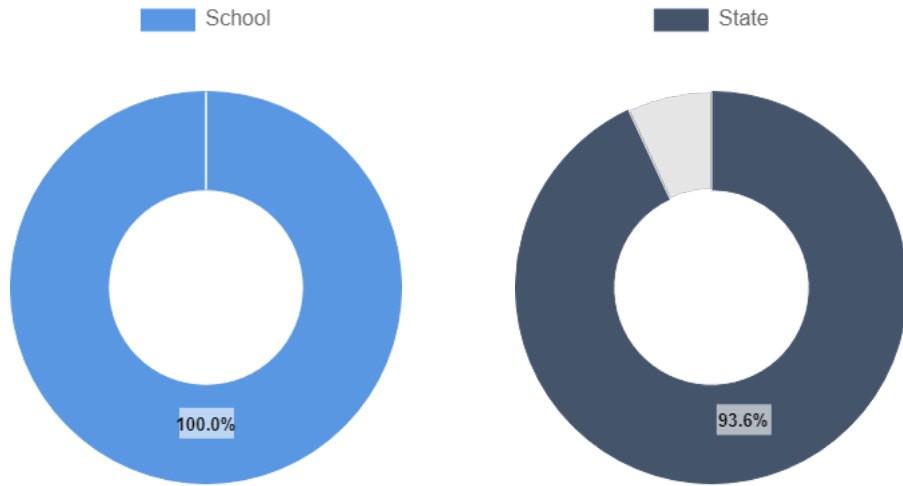

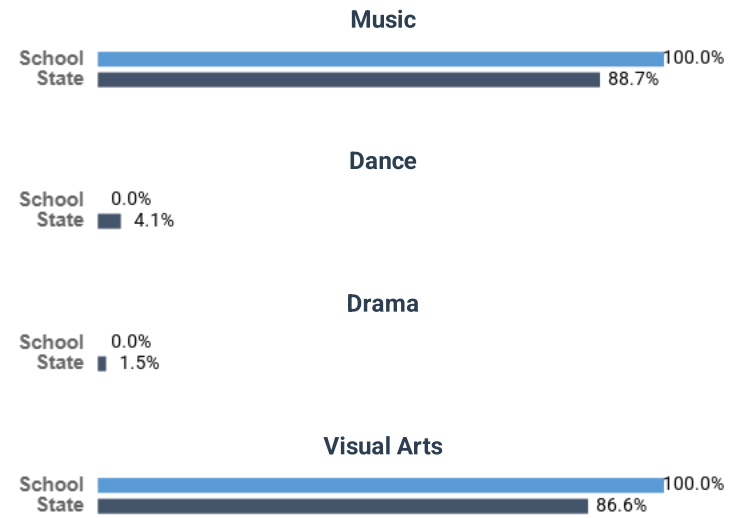

Students enrolled in one or more classes by discipline:



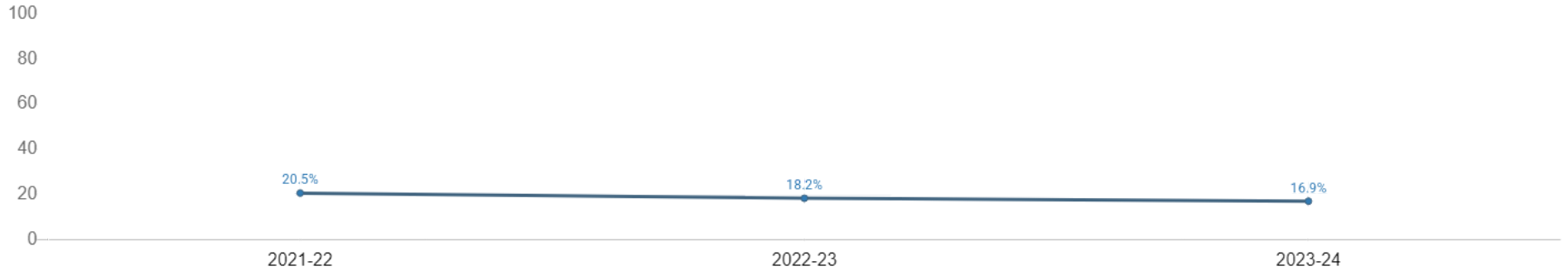

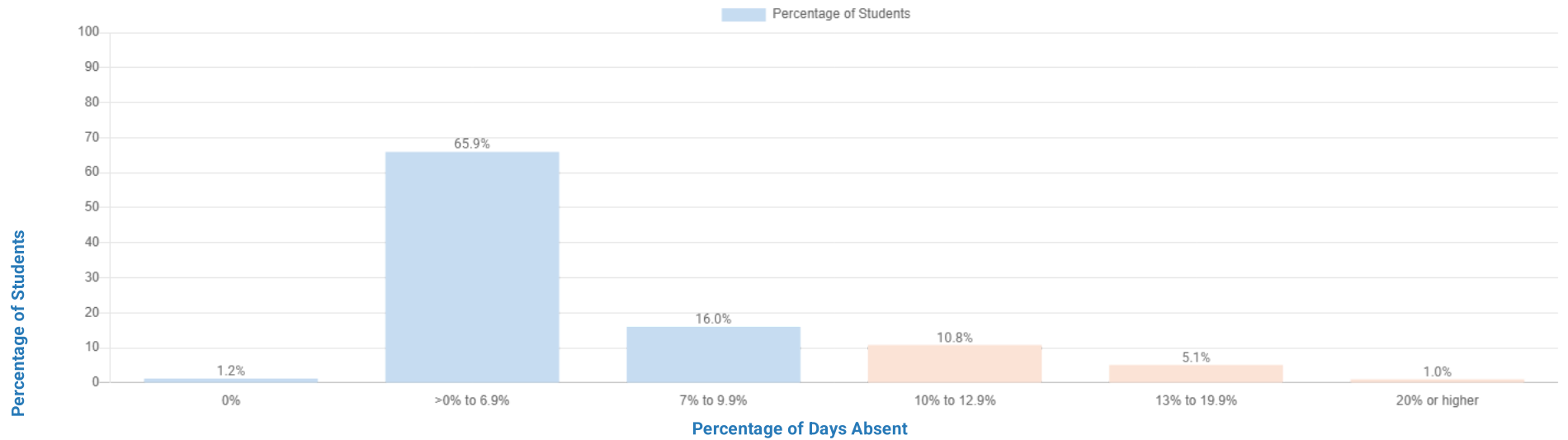

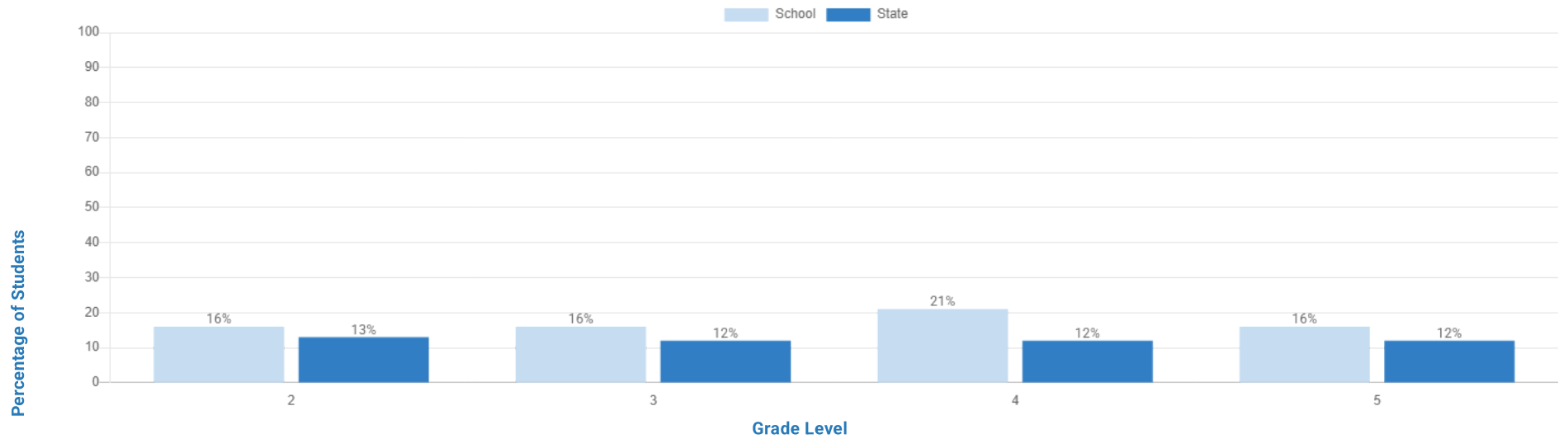

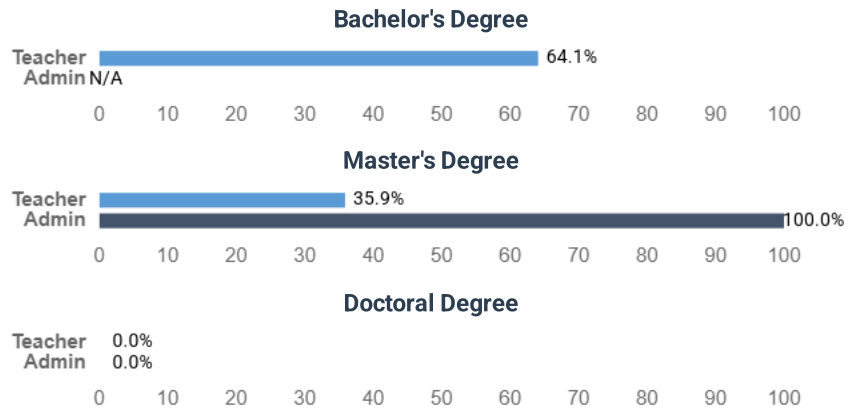

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Facilities:

Our school building opened in 1997 and we share our building with South River Middle School. A recent renovation includes a state-of-the-art outdoor classroom and learning space.



School Safety:

The safety of our students and staff is paramount. Cameras are located throughout the building. Visitors to the building must be buzzed in and present a photo ID. We have a close working relationship with our local police department, and conduct carefully designed school security and fire drills on a monthly basis. A Class III Police Officer is assigned to the school.



Technology and STEM:

Technology infusion is evident throughout all contents and grade-levels at our school. Math and ELA instruction is supplemented with the use of iReady. Classroom teachers have access to Promethean Boards, LCD projectors, Smart Response clickers, and access to online programs which enhance the curriculum. The use of Chromebooks and laptops, via a wireless network, enhances student and staff access. Google Classroom is used by teachers in the school, and Chromebooks are allotted for each student.
