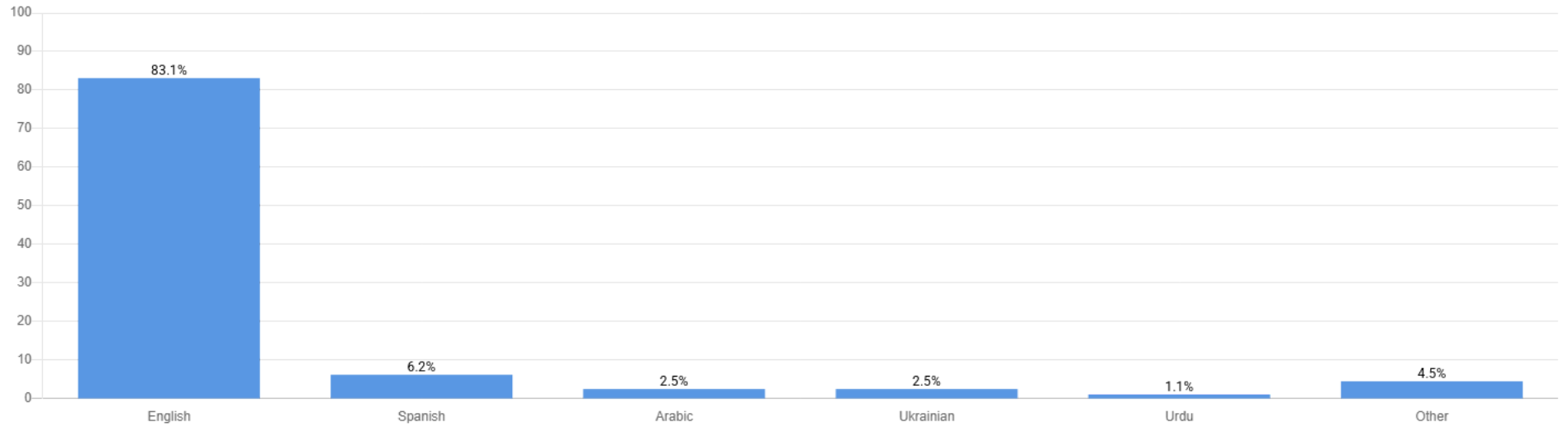

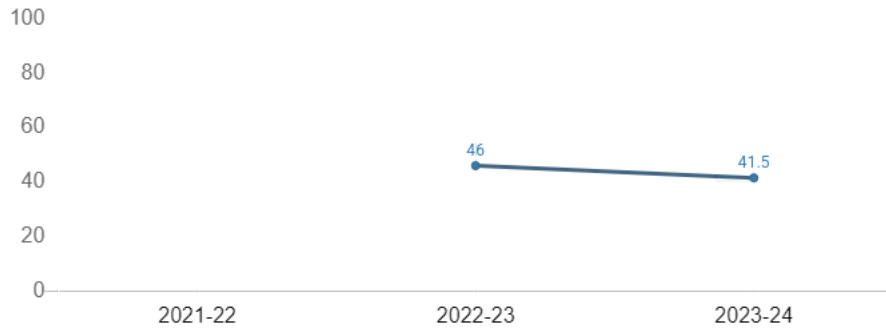

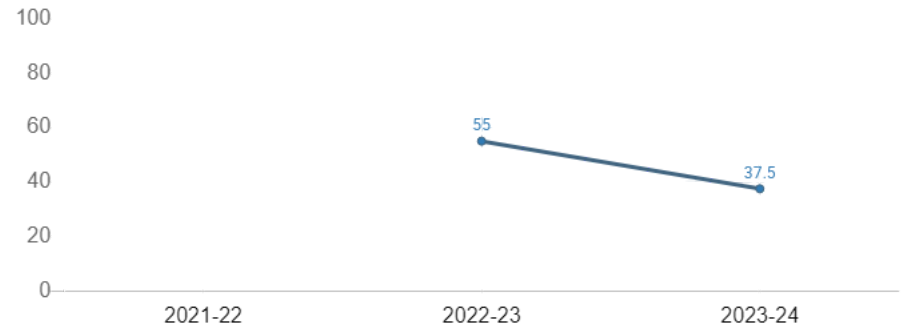

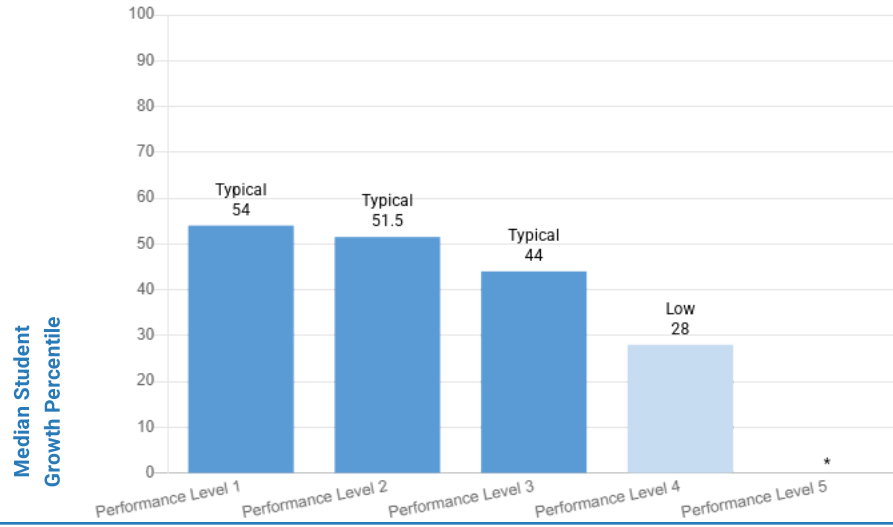

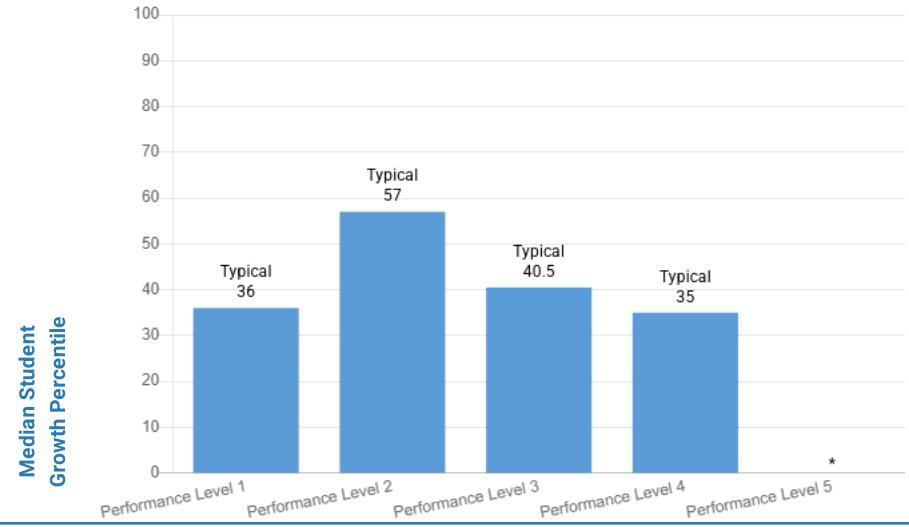

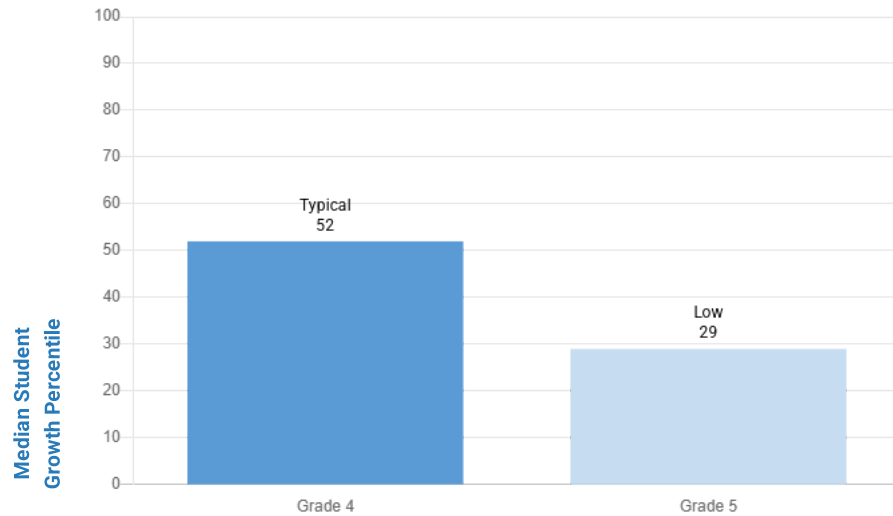

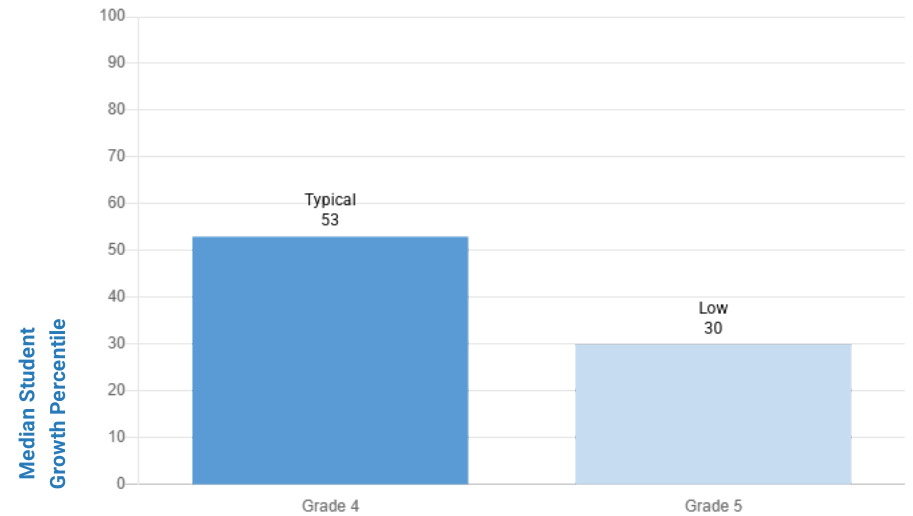

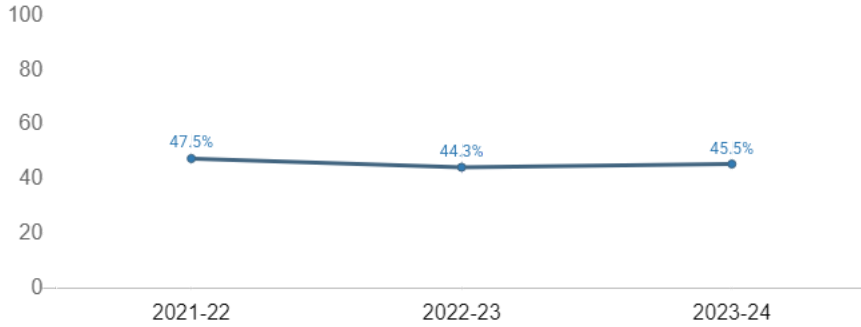

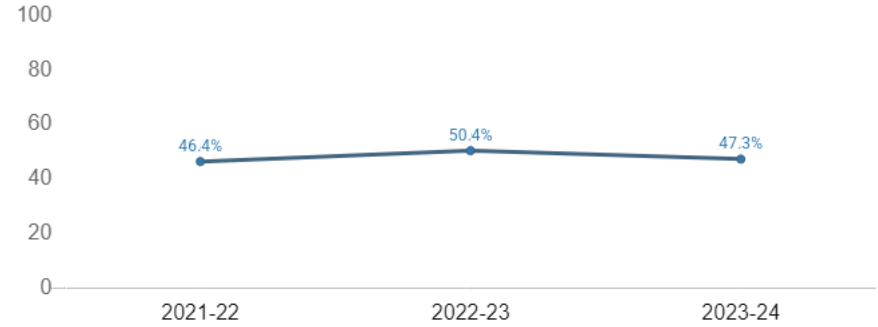
English Language Arts and Mathematics Performance Trends

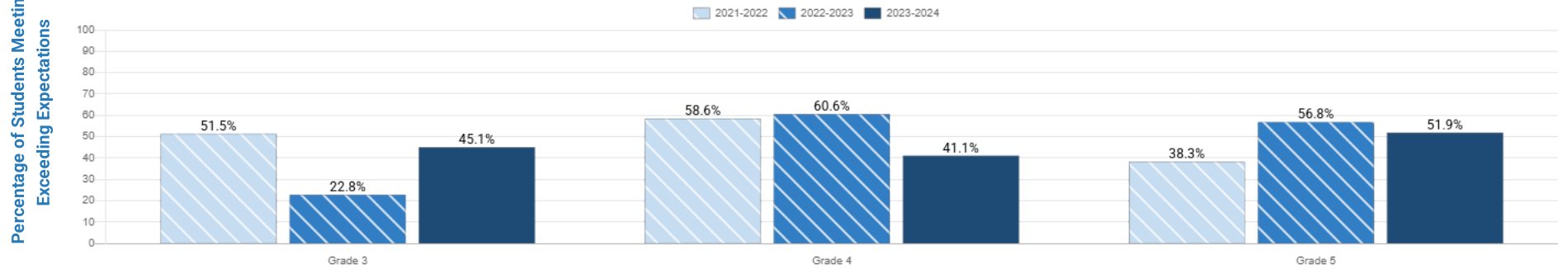

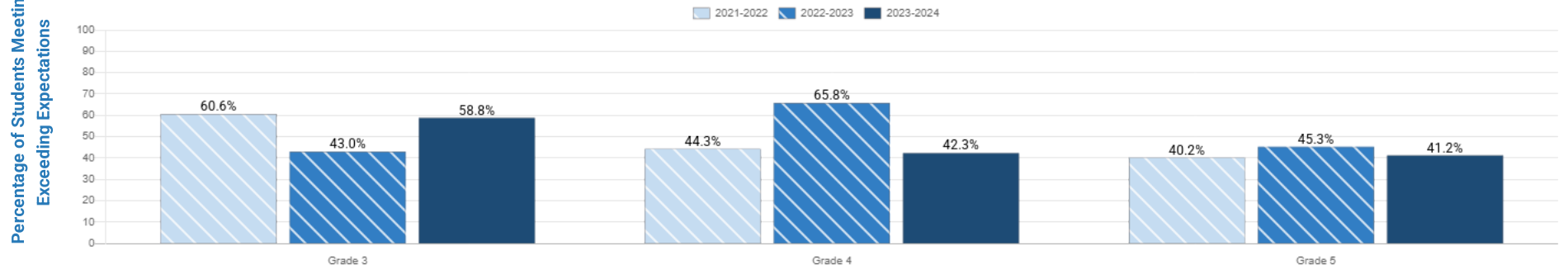

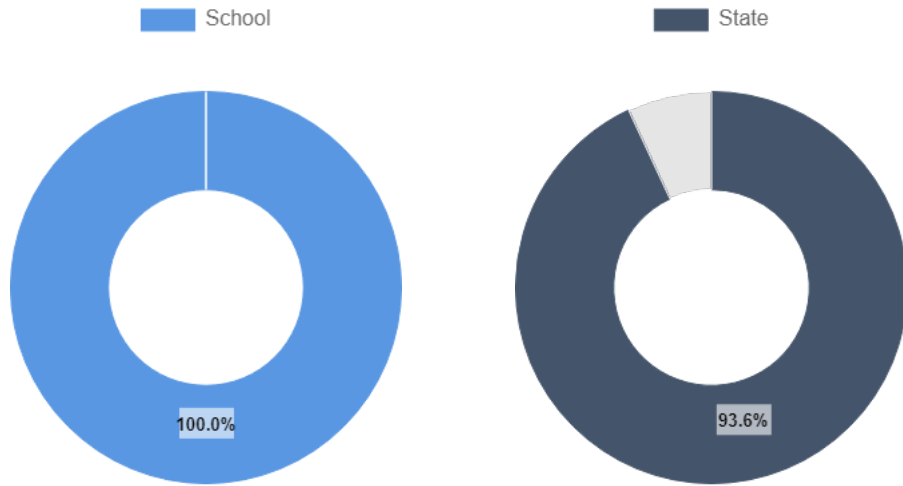

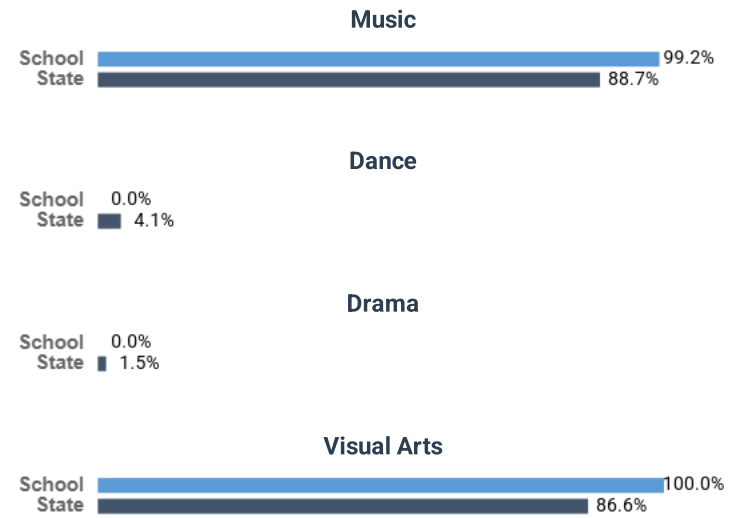

Students enrolled in one or more classes by discipline:



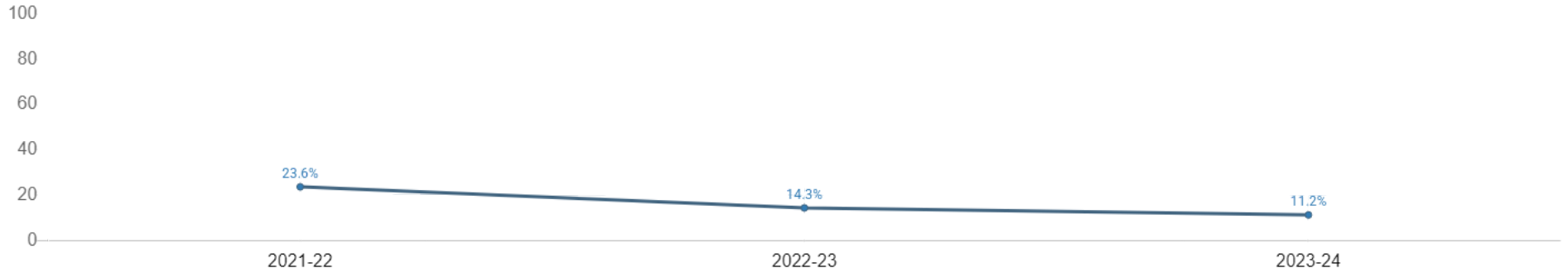

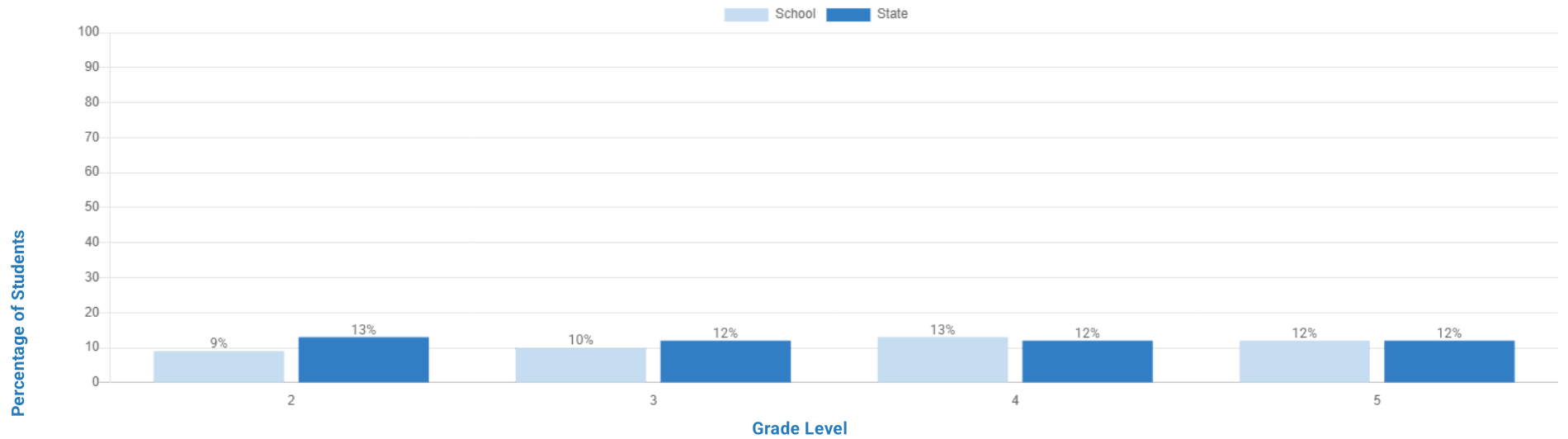

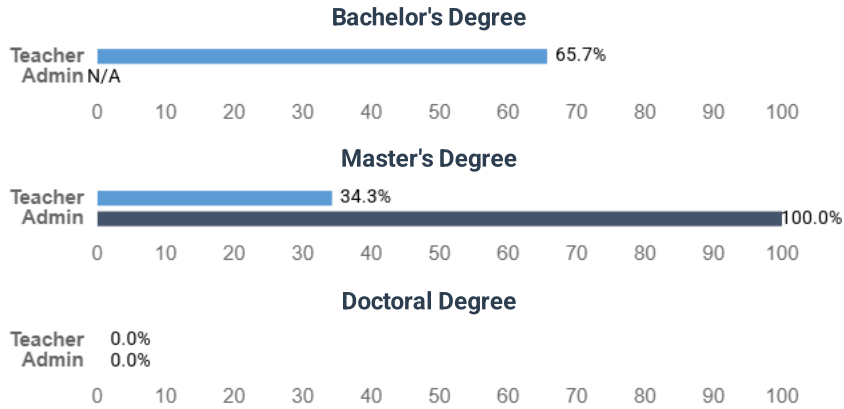

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. We also participate in the Heroes and Cool Kids program which pairs high school and 5th grade students with the goal of guiding students to make healthy choices. Appleby is a moderately sized elementary school housing grades two through five. Appleby was originally constructed in 1953. The building has continued to expand based on need. Appleby has 20 regular classrooms, ten small group instructional areas, a vocal music room, an instrumental music room, a newly designed (2018) art studio, a computer lab, a 3,500 square foot media center, and an all-purpose room.

Additionally, we utilize a number of educational applications which help our teachers deliver and enrich instruction. Our students attend weekly "techknowledgy" classes where they build foundational skills which support their learning, promote exploration of the world, and encourage the sharing of ideas through a variety of STEAM activities including robotics, coding, and multimedia presentations.
