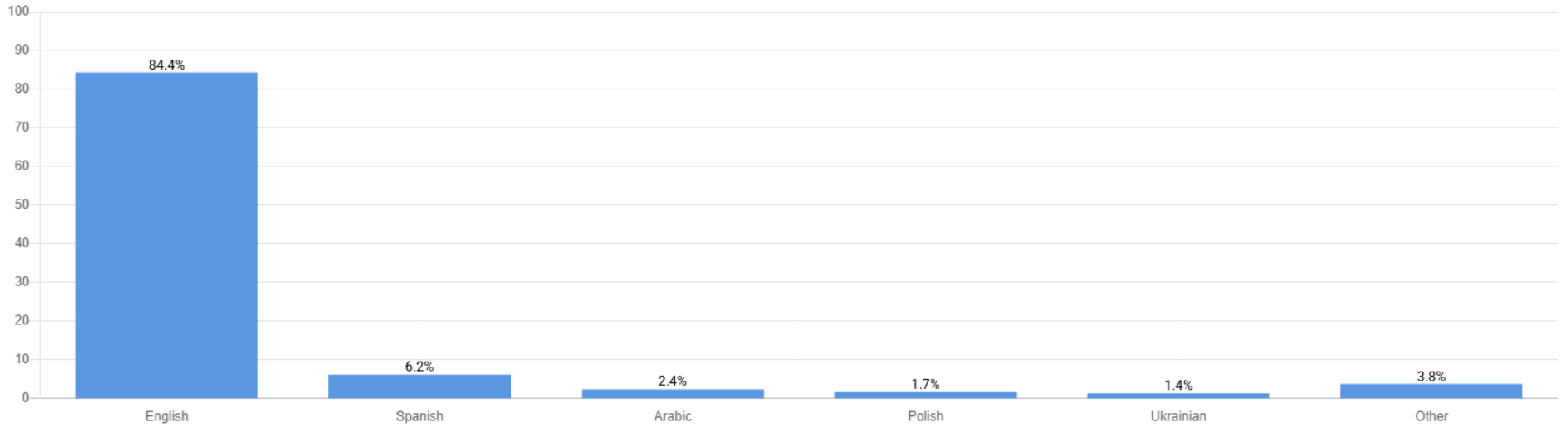

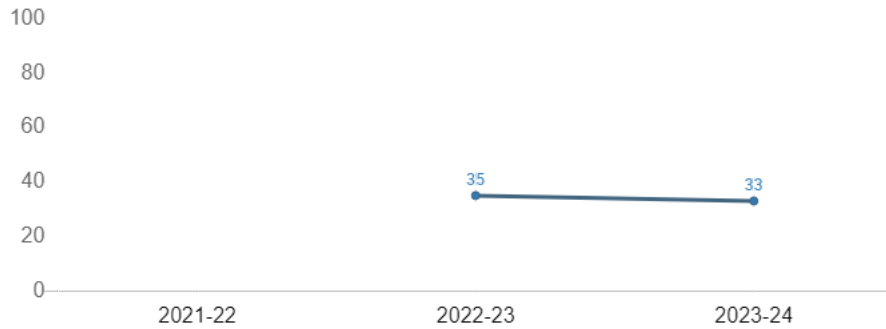

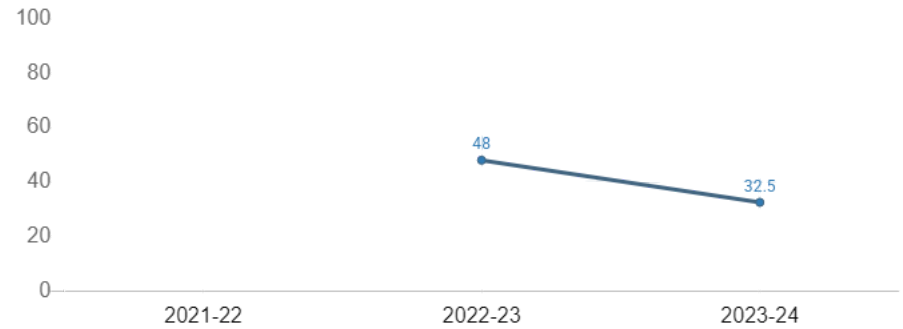

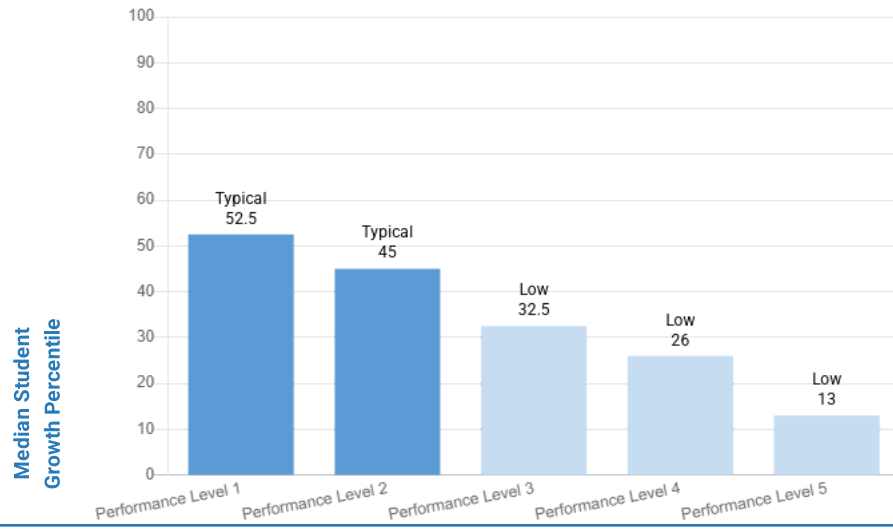

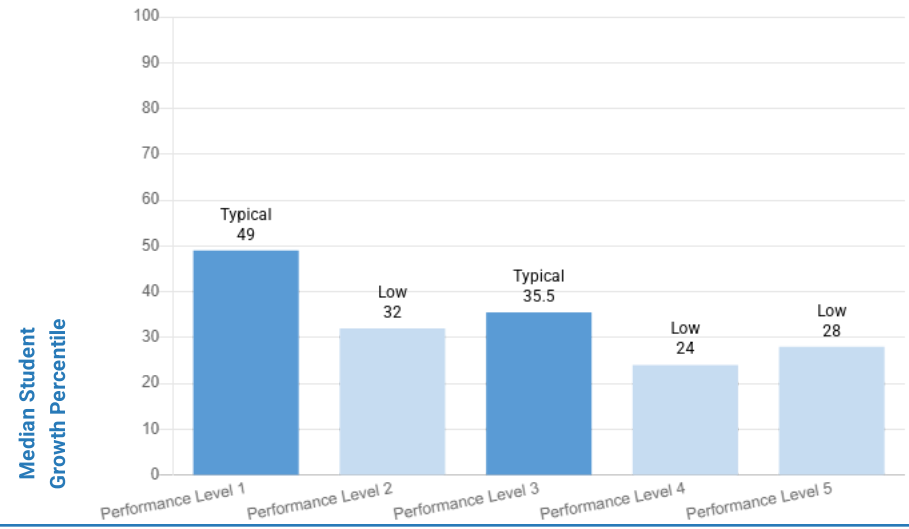

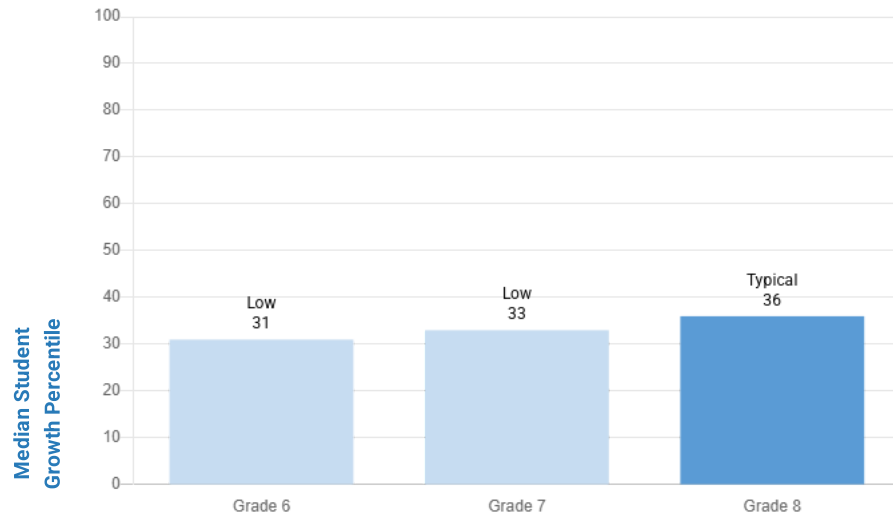

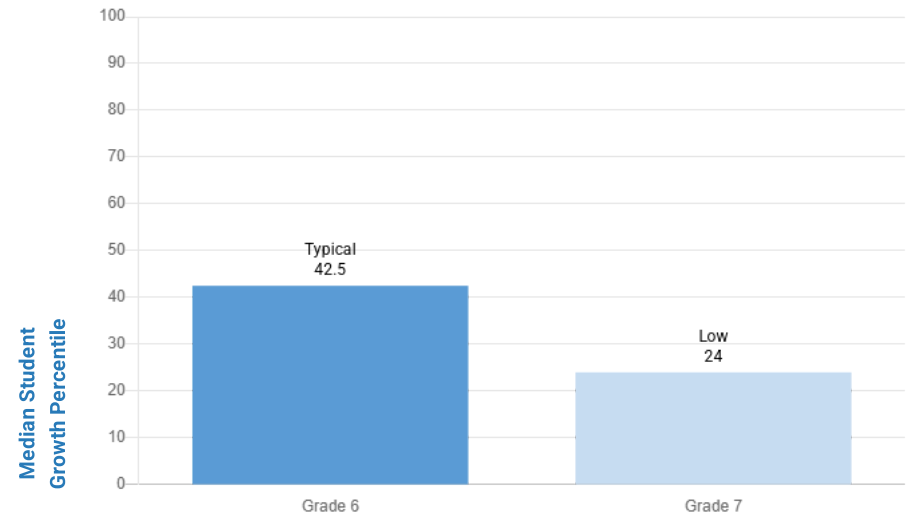

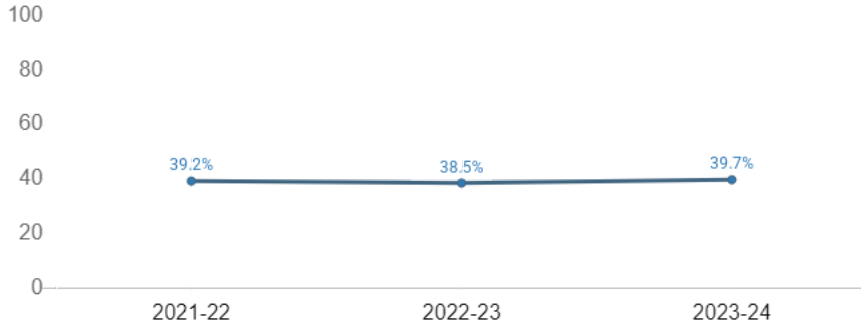

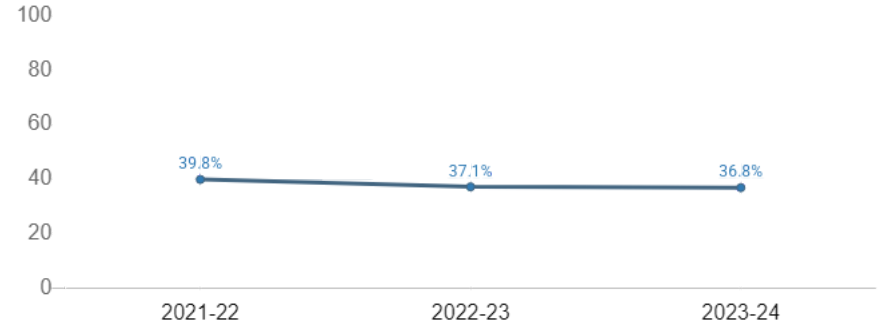
### English Language Arts and Mathematics Performance Trends

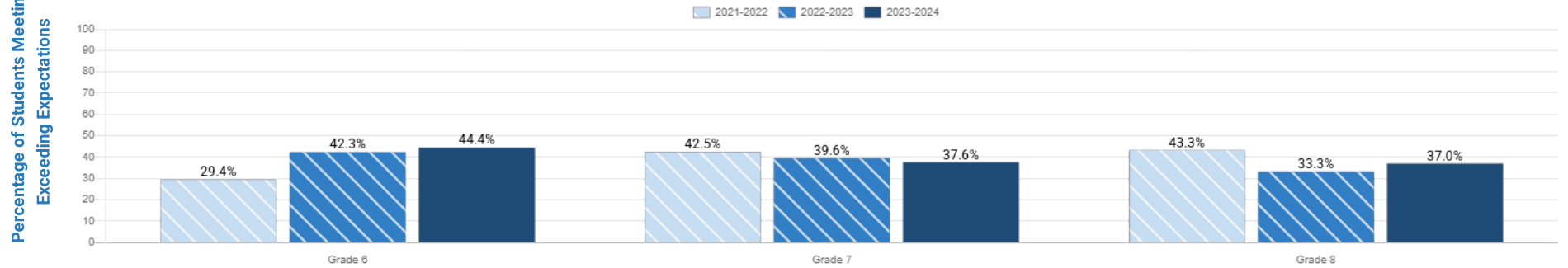

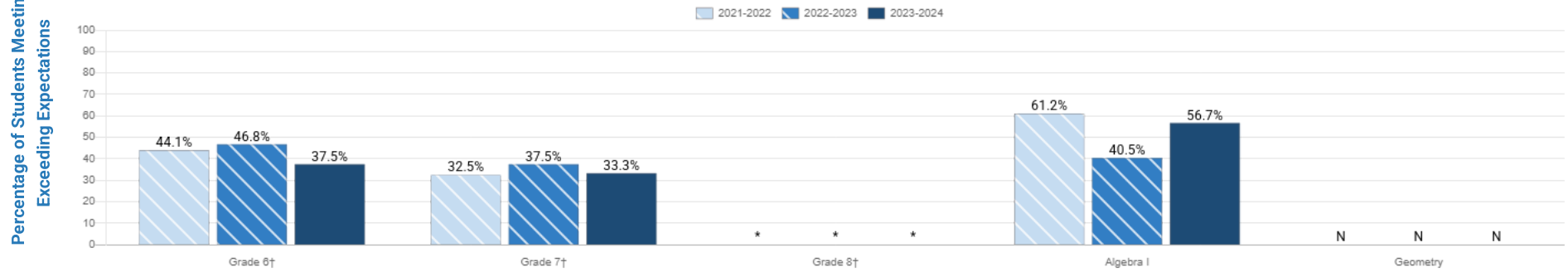

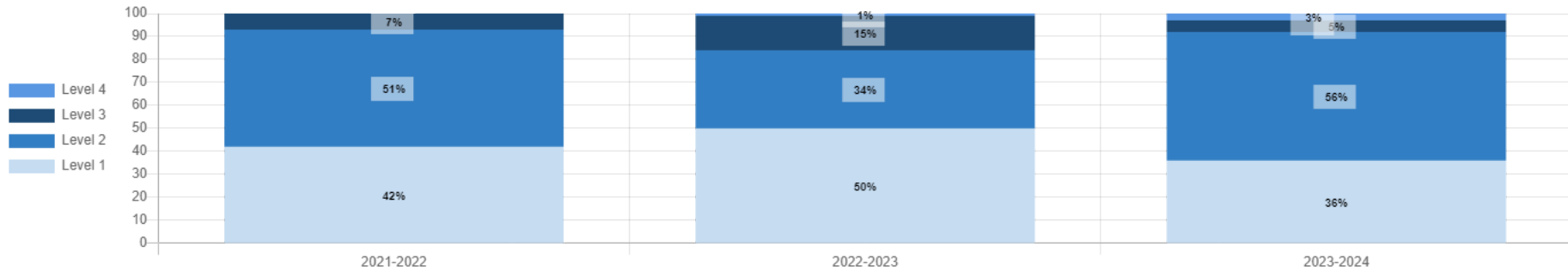

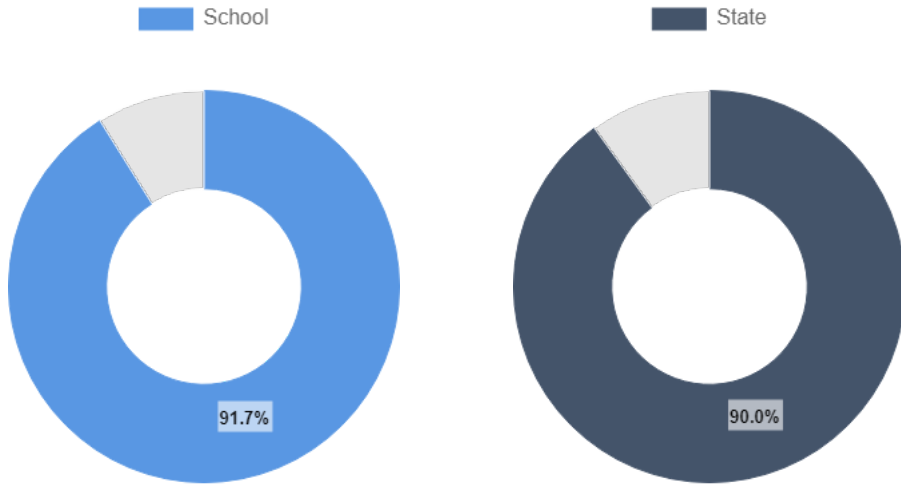

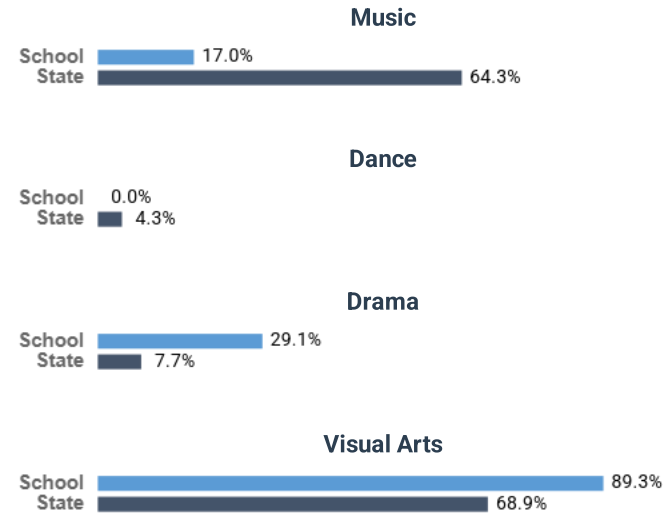

**Students enrolled in one or more classes by discipline:**



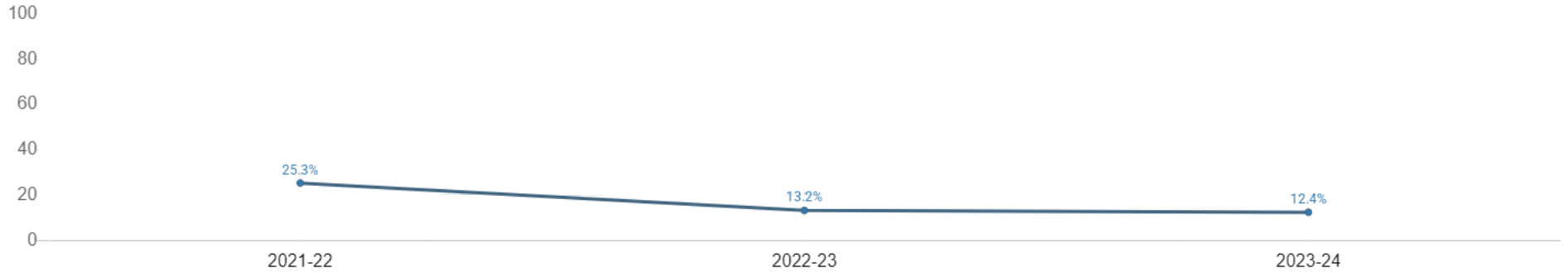

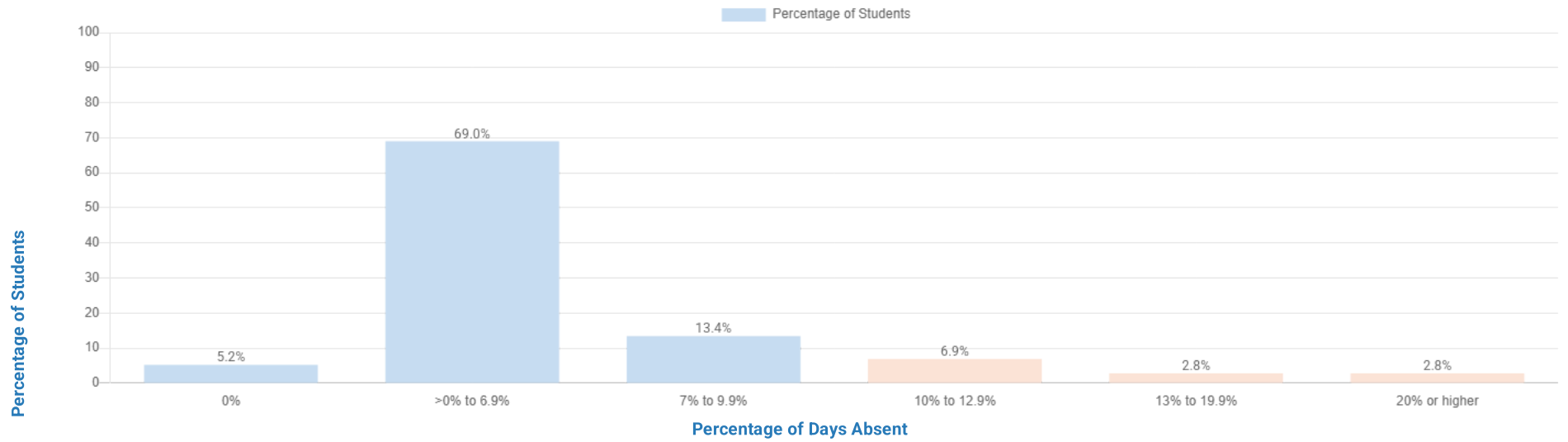

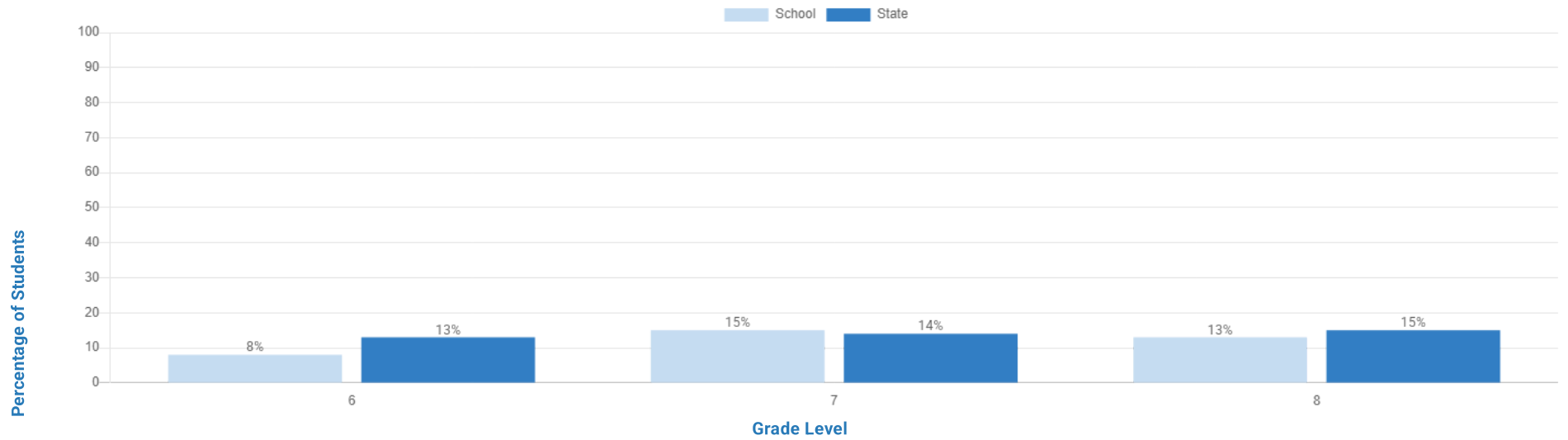

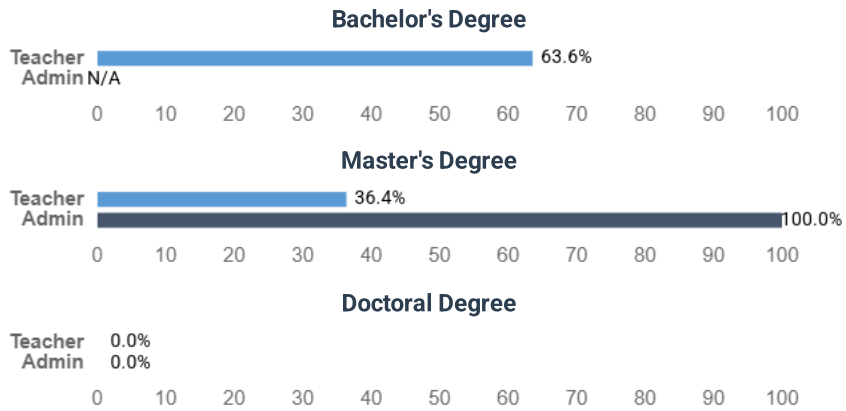

## Accountability

### Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. Schools are identified for ATSI if they have at least one student group that has a summative score that would be in the bottom 5% of Title I schools if it was its own school. Memorial Middle School was originally constructed in 1967 and has been renovated multiple times since then. Facility updates continue to ensure that our classrooms are designed to meet the evolving needs of 21st Century Learners with an increasing focus on keeping our technological resources in the classroom current so that our students have all the tools and resources necessary for success in a safe and secure environment. Memorial Facilities are continually being upgraded as well with new flooring being installed because of asbestos removal, which will continue over the coming years. Air conditioning systems will be updated, with new units being installed over the summer. Students are now completely 1:1 with Chromebooks. Student devices are able to be taken to and from school so that assignments can be completed at home.



### School Safety:

Spotswood School District understands that the health and safety of our students is paramount in creating an environment in which all of our members feel safe and secure. To ensure this, the Spotswood School District utilizes a comprehensive approach to school safety and security with a focus on the following areas: \* Security Coordination \* Communications and Alerts \* Training and Drills \* Plan Review/Climate Assessment The administration of the Spotswood School District works closely with the Spotswood Police Department through our School Resource Officer, who works with all school administration. Additionally, monthly meetings are held to review all district security matters with District and Spotswood community leaders.
