




English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. 
















Graduation/ Postsecondary

Information about students enrolling in colleges and universities after graduation is collected from the [National Student Clearinghouse \(NSC\)](#), which collects data from at least 97% of higher education institutions nationwide. New Jersey graduates are matched to postsecondary enrollment data by NSC each year. While most students who enroll in a postsecondary institution each year are able to be matched by NSC, there are some students each year who cannot be matched. Some reasons that students may not be matched are: 1. Postsecondary enrollment cannot be shared with the NJDOE if students request a FERPA block on their postsecondary enrollment records; 2. Students who attend a college or university outside of the United States are not included in NSC data; 3. Certain colleges or universities may not participate in sharing data with NSC or may fail to report data for a certain semester or a certain group of students; and 4. NSC may not be able to match a student's name or date of birth in NJ SMART to the information provided by the postsecondary institution(s) with a high level of confidence.

In 2023, NSC implemented an additional manual review process to reduce the number of students who do not match due to #4 above, which may result in NSC matching additional students to postsecondary records moving forward. As a result, the NJDOE is not including trend data from prior to 2022-2023 in the reports.











Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Postsecondary Information:

In 2020, 88% of JFKMHS graduates entered college. The school, in conjunction with the College Board, provides SAT test fee waivers to students who receive free and reduced lunch. The WTSB provides SAT, PSAT and ACT tests free each year the student attends JFKMHS. Additionally, an SAT Boot Camp is offered before each regular College Board SAT Administration Date. Our curriculum offers to students in their junior year an SAT/ACT course offering with faculty trained by The Princeton Review. JFKMHS also partners with Middlesex County College in offering a Dual Enrollment programs that culminates in students graduating with both an Associates Degree and High School Diploma. JFKMHS also partners with Lincoln Technical Institute to offer students experience in various medical and nursing trades.

The JFKMHS Parent Faculty Forum organizes multiple yearly events, most notably the annual Gift Auction that raises money for the senior class. Parents/Guardians are also kept abreast of student academic progress and assignments through teacher G-Suite Sites and our new mobile Apptegy website. Community service activities have been infused into the existing curriculum as students participate in broad-based, multi-disciplinary Service-learning projects.

School Safety:

The school has approximately 75 security cameras throughout the grounds and on the interior of the school. There is a bell and camera system used during school hours to verify all entrants into the building as well as a two full-time security officers and one Police Officer on duty at all times during school hours. In addition, the school boasts a Safety Ambassador Program that promotes and teaches others about safety. In 2023, a school-based threat assessment team was formed to increase safety in the school.



Technology and STEM:

Each classroom in JFKMHS is equipped with an updated desktop capable of operating Windows 10 or higher. Four business classrooms comprised of over 100 computers, and the school utilizes two computer labs for general classroom use, in addition to each student having their own Chromebook. Several courses utilize Apple iPads giving our students experience with multiple technological platforms. In October of 2024, the district installed 22 smartboards in various classrooms.
