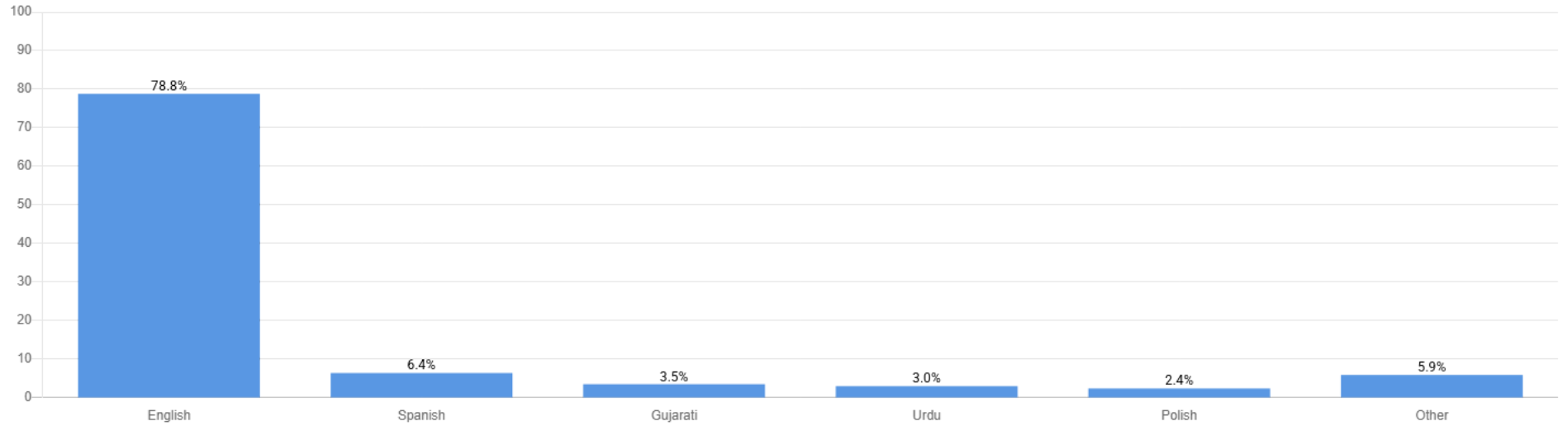

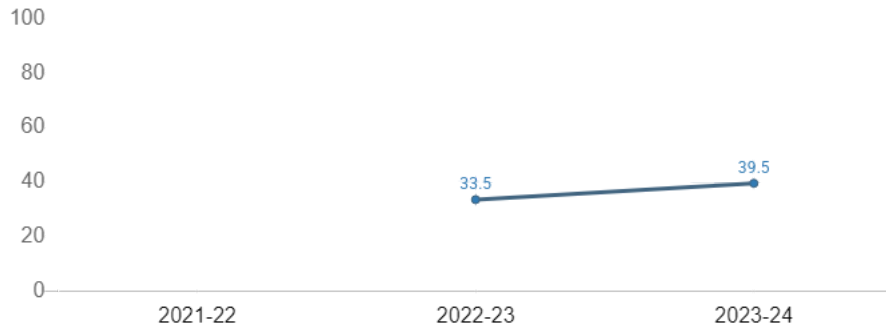

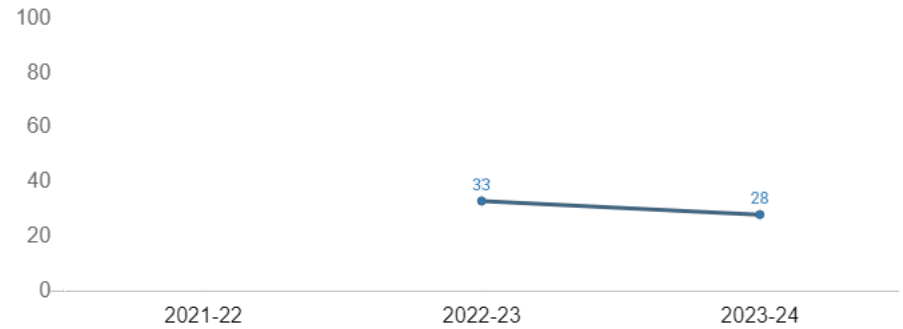

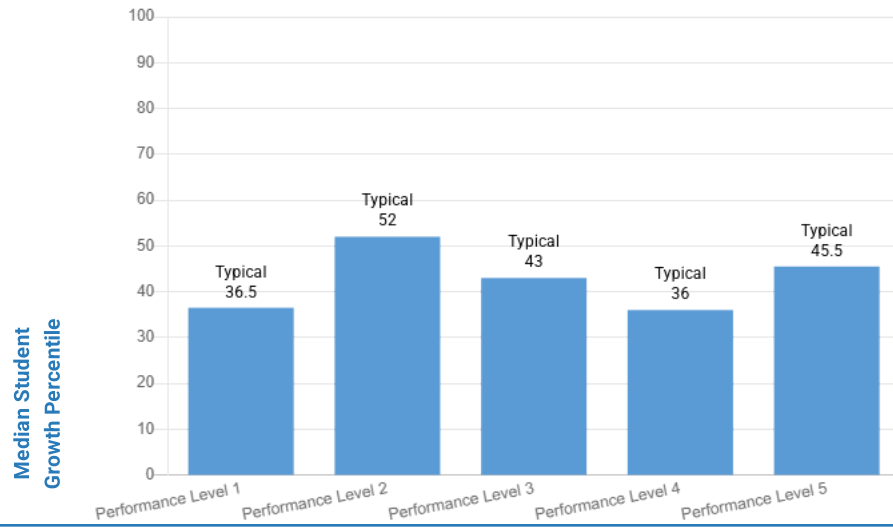

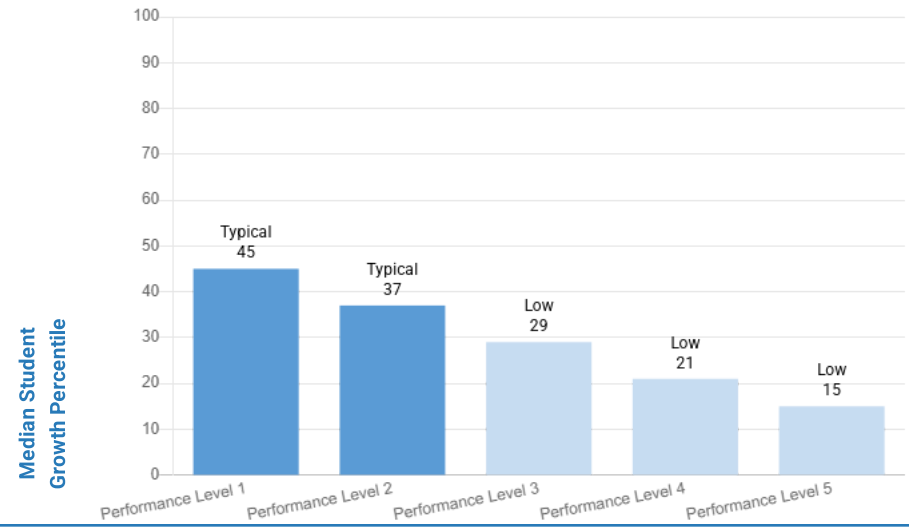

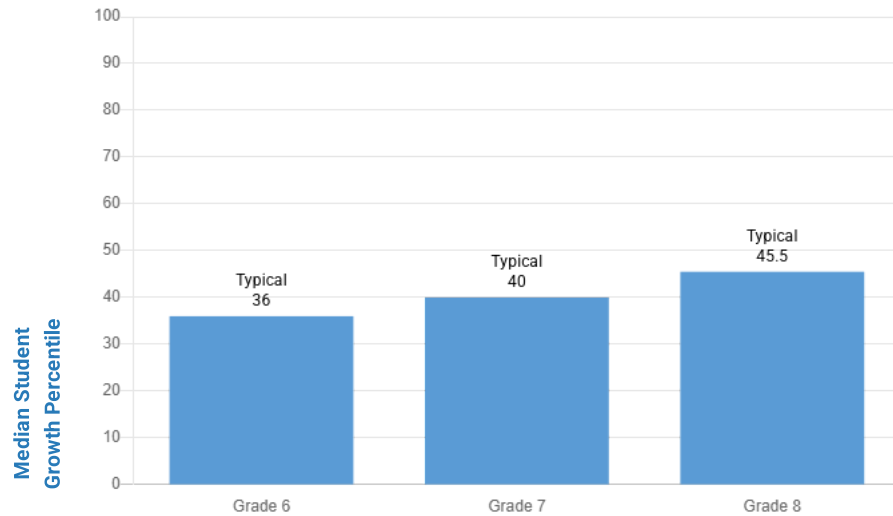

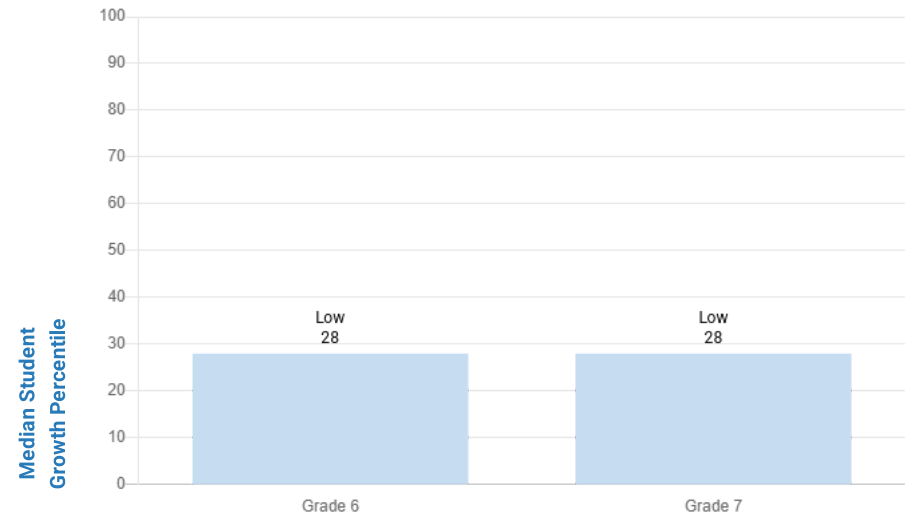

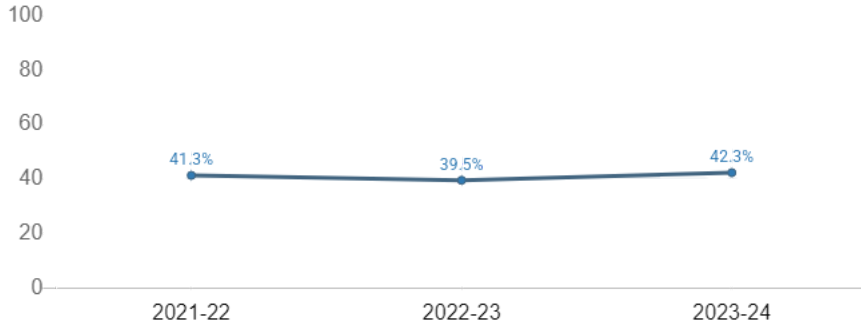

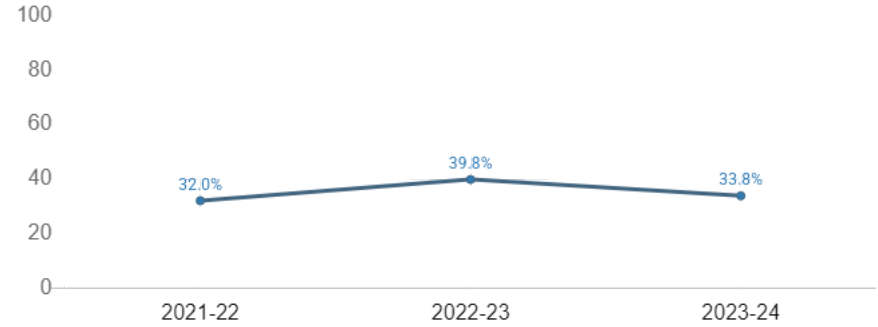
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. The data includes the results of students taking both the New Jersey Student Learning Assessment (NJSLA) and the DLM alternate assessment for English language arts (ELA) and mathematics. 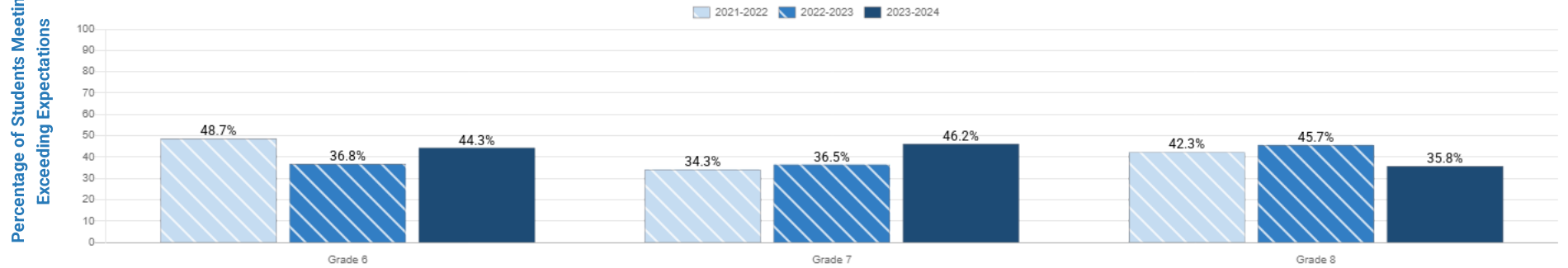

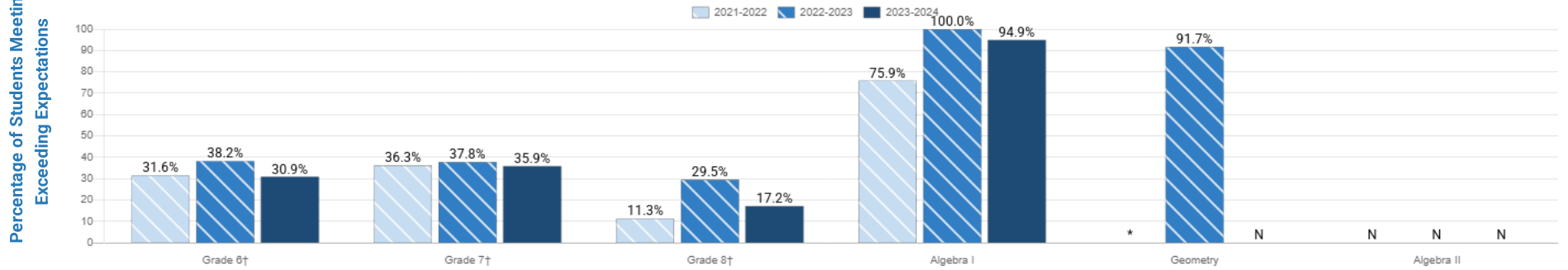

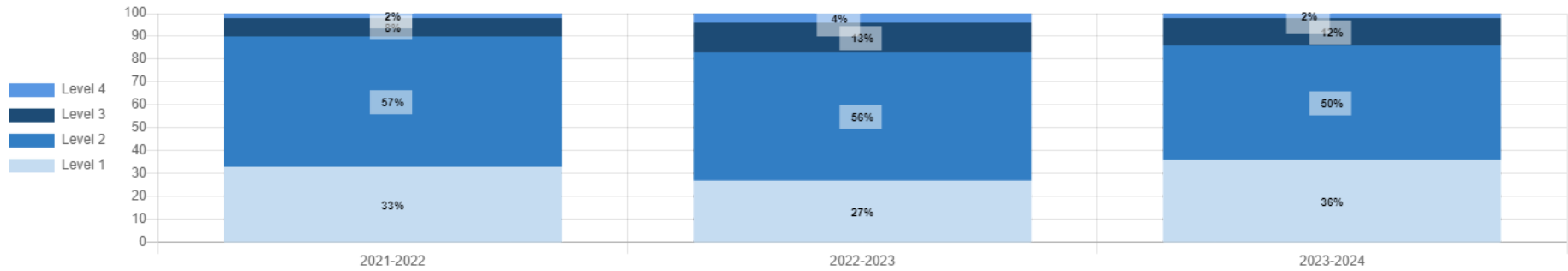

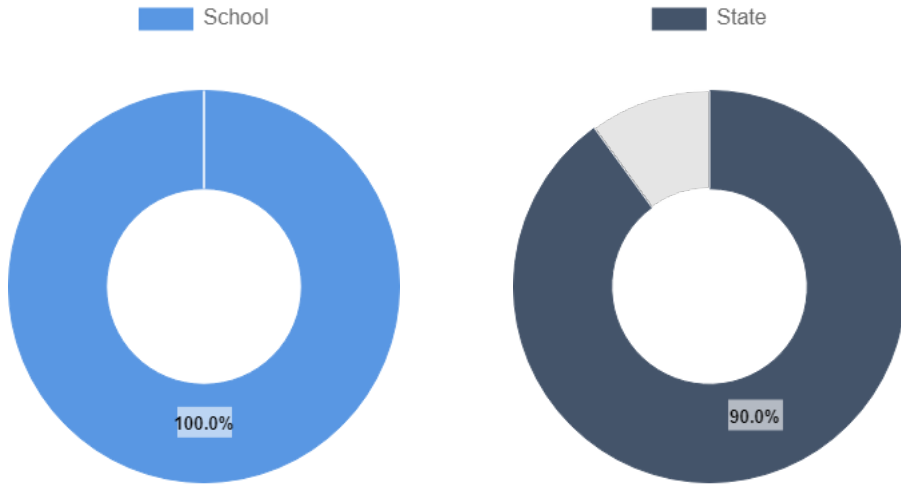

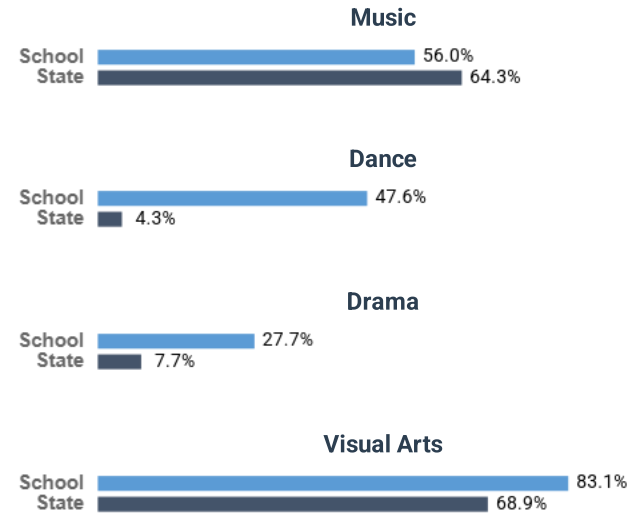

Students enrolled in one or more classes by discipline:



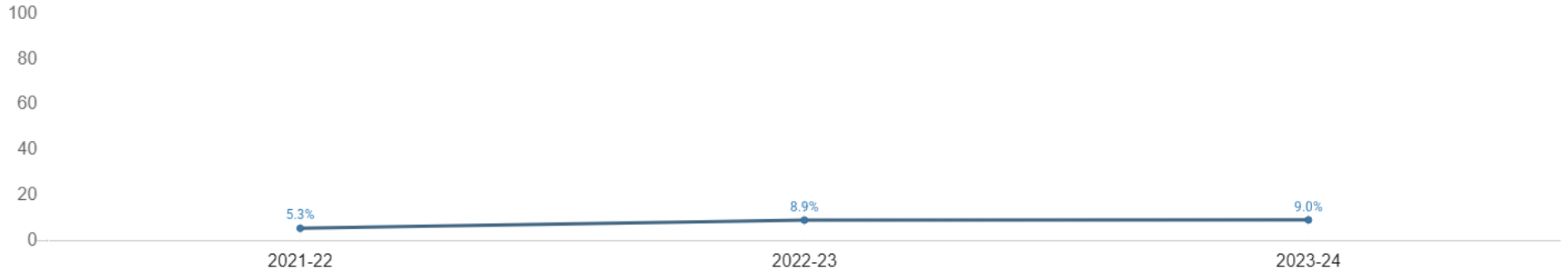

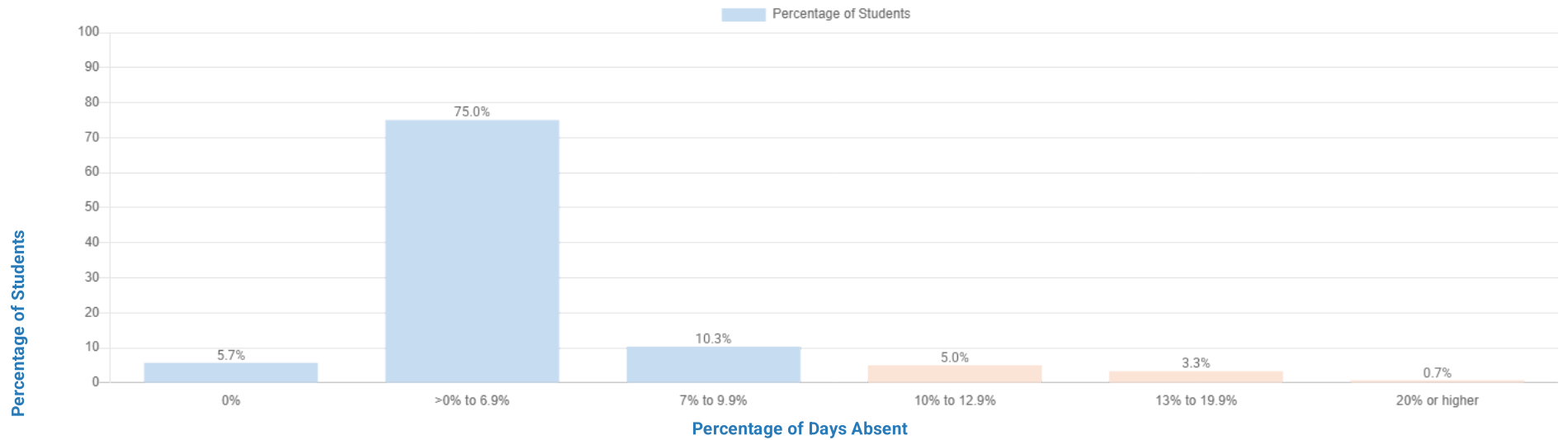

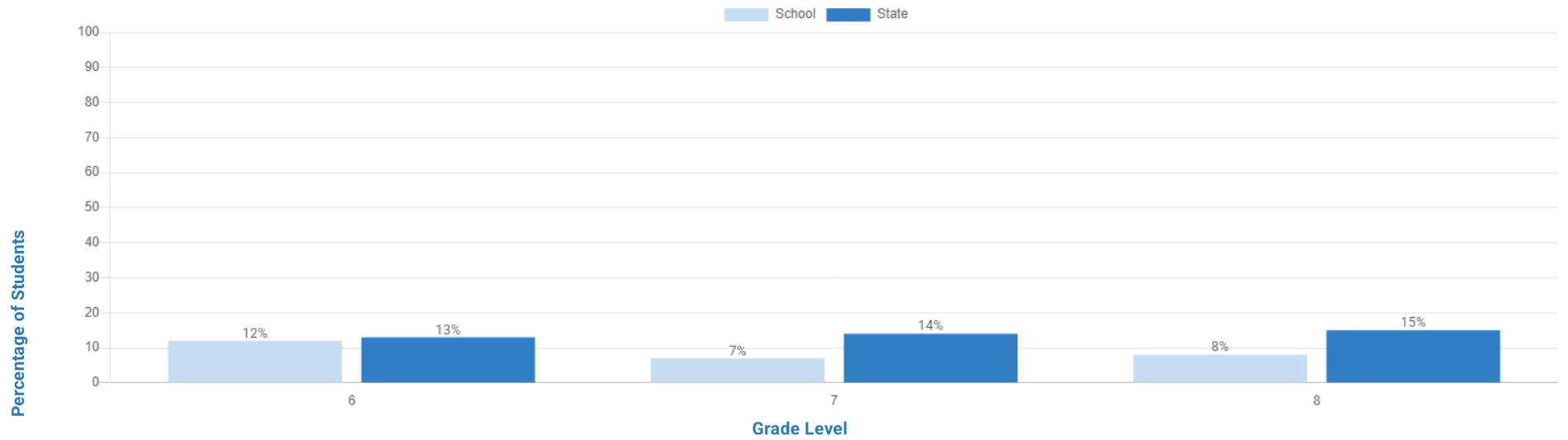

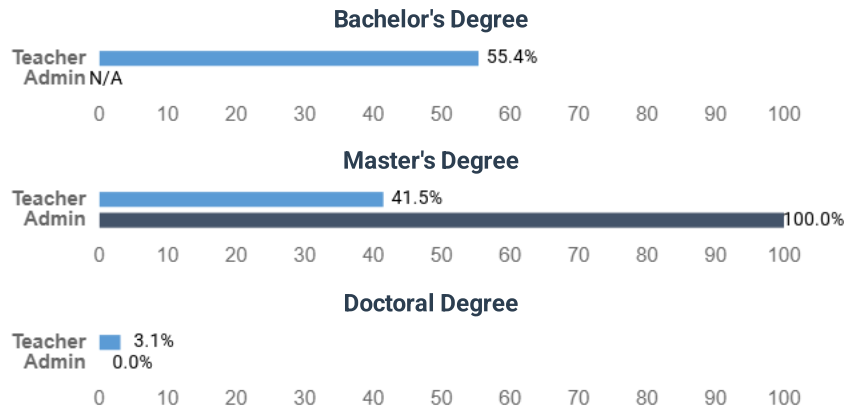

Accountability Summary by Student Group - 2023-24 School Year

- We provide a challenging curriculum for all students. Honors classes are offered for advanced students while support classes are offered to students with special needs. We embrace our diversity.
- Our students participate in the PBIS program which encourages them to behave appropriately in the school setting and in the community. Students are awarded points that can be exchanged for prizes.



Our theme at Colonia Middle School is that all students experience "Nothing Less Than Success". Students are continually recognized for their efforts and accomplishments. We are determined to provide students with the opportunity to develop an awareness of their strengths and improve on their weaknesses. We provide a positive atmosphere that is conducive to learning and based on respect. It is our intent that all students at Colonia Middle School be proud of their accomplishments and strive for continued excellence.



Our Friday's Friends class has garnered statewide recognition and will receive a yearly grant from a local sponsor for its unique programming. It is a peer mentoring program in which our regular education students spend time daily working with students in our special needs classes on a variety of activities. This practice allows for the special needs students to expand social and life skills. The Friday's Friends students learn lessons in teamwork, leadership as well as patience, tolerance, and empathy. Since 2013 over 500 students have been inducted into our NJHS. CMS students consistently perform well on standardized assessments, demonstrating academic growth. Our STEM students regularly develop inventions and enter competitions, earning national recognition. Our Math team has had success competing in local competitions. Our "Colonia Cup" program gives special needs students the opportunity to experience running a small business.

Our students participate in a variety of advanced academic courses. Students are fortunate to be part of an exciting reading and writing program developed by analyzing strengths and weaknesses. All students are enrolled in an online program that enables students to access NJSLA type questions in all tested areas. In addition, students complete LinkIt! benchmark assessments throughout the year. This allows staff to closely monitor student progress. All students are provided a school-issued Chromebook to assist with instruction. Students may choose to take classes in instrumental music, vocal music and art. We also offer STEM, robotics, multimedia and publication, journalism, creative writing, graphic novel, medal of honor, and public speaking courses.

At Colonia Middle School we are committed to our students' success. Our I&RS team meets regularly to identify struggling students. Strategies are developed and shared with both teachers and parents to implement in the classroom and at home. Teachers provide additional assistance before or after school to ensure student understanding. We are staffed with three full time guidance counselors who provide students with academic support and assist with social and emotional growth. Our Student Assistance Coordinator is on site five days a week to meet with students in need of support. We provide several before and after school academic support programs for struggling students, as well as individualized support during the school day.

This is a groundbreaking substance abuse and violence prevention program based on more than 35 years of rigorous scientific research. In addition to helping kids resist drug, alcohol, and tobacco use, the Life Skills Training Middle School program also effectively supports the reduction of violence and other high-risk behaviors.

CMS has two computer labs and a state of the art MacLab equipped with iMacs, iPads, and MacBooks along with a soundproof booth for recording and green screens to create movies. All classrooms are equipped with 85-inch Viewsonic Boards to assist with instruction.



Attendance:

The WTSD employs a variety of attendance procedures to ensure students are attending school, as attendance is essential for academic success, continuity of instruction, and student growth. Our schools avail their resources with a variety of communication methods for our families to stress the importance of being present in school.
