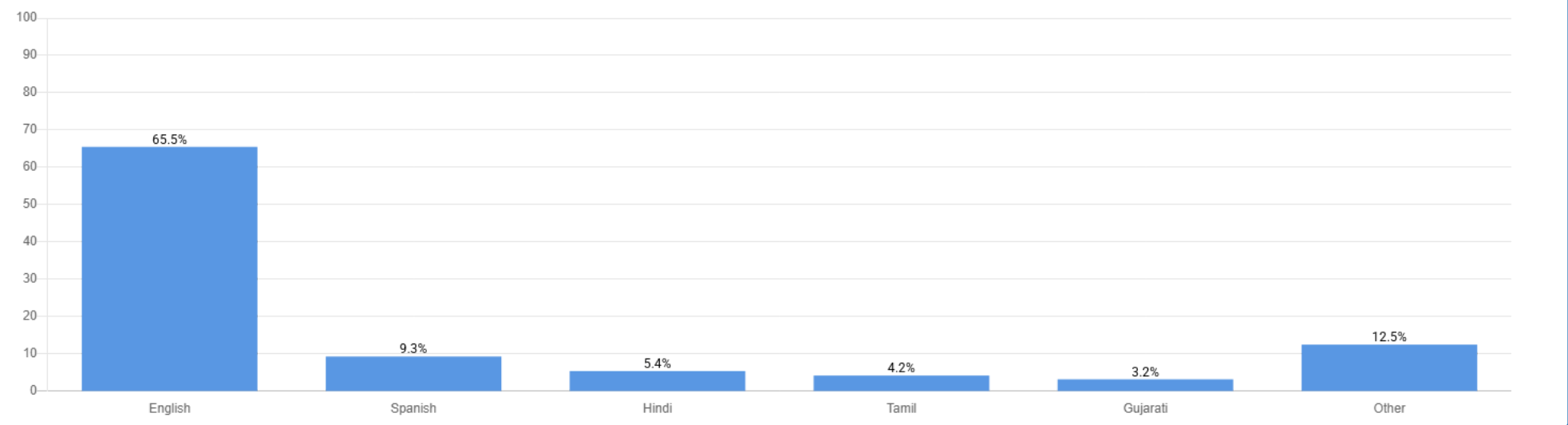

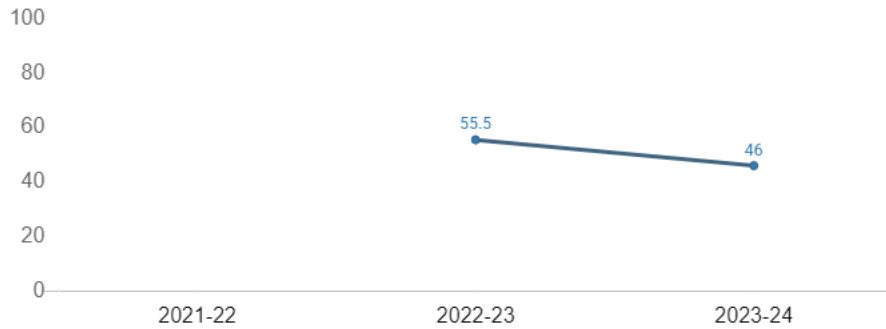

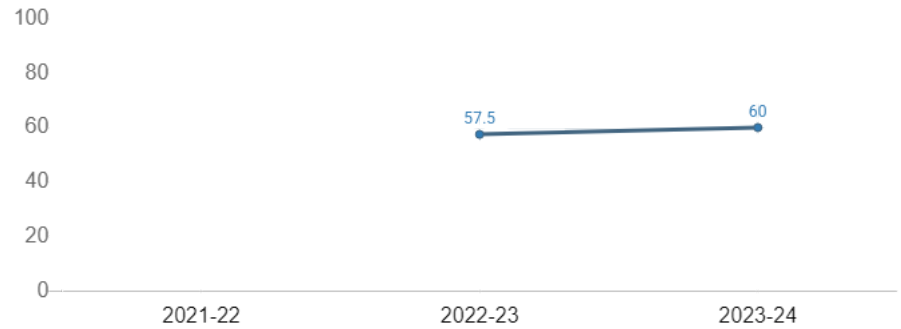

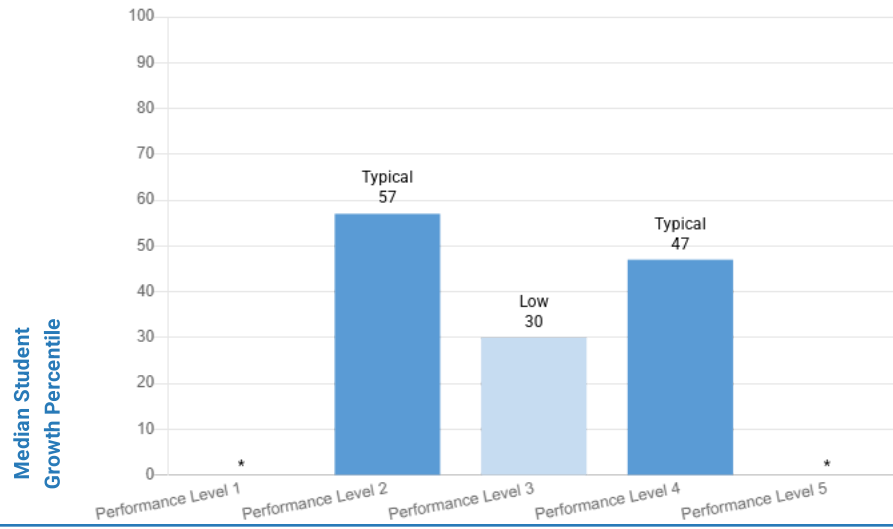

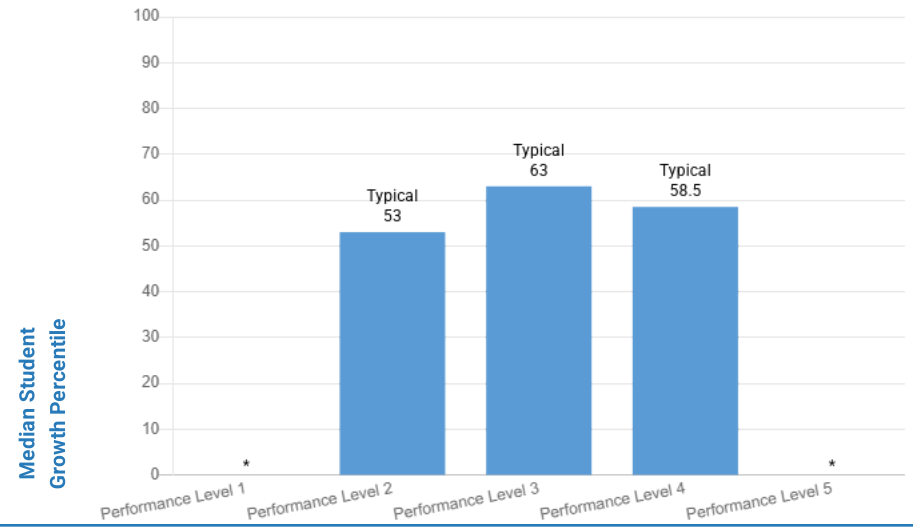

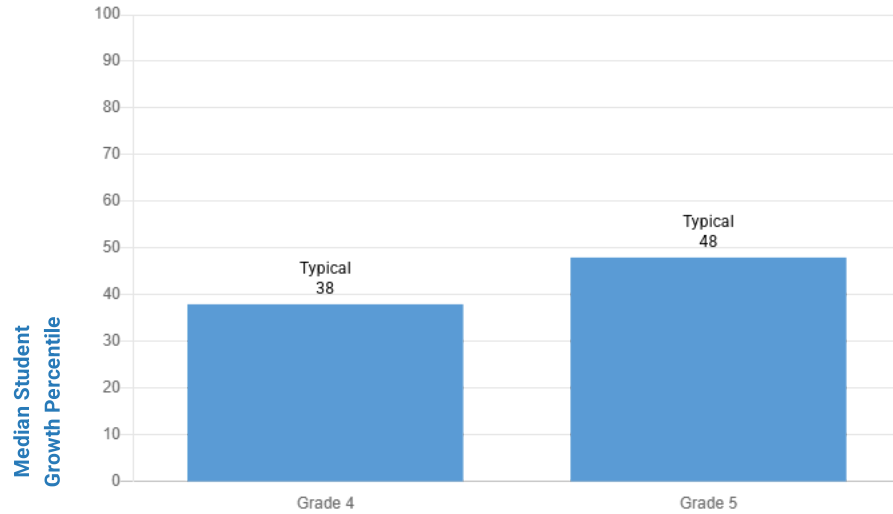

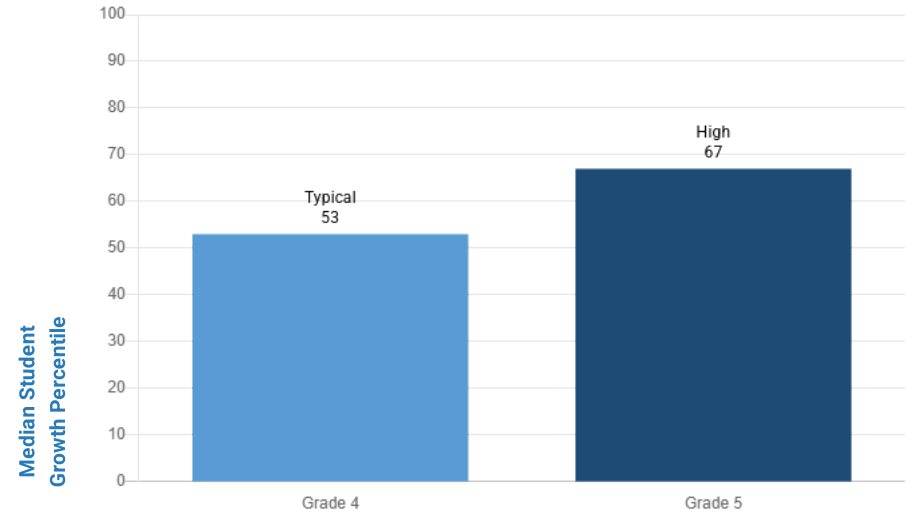

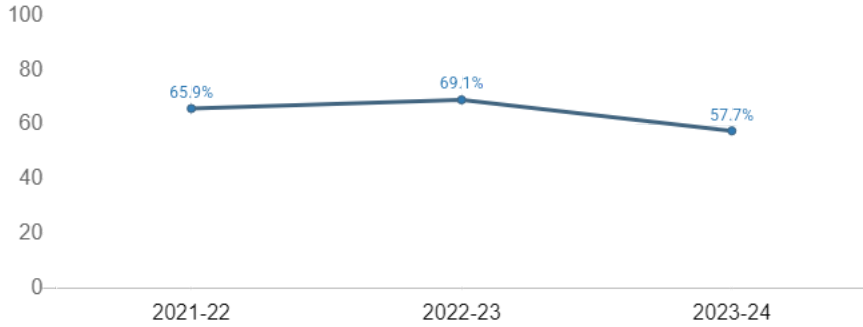

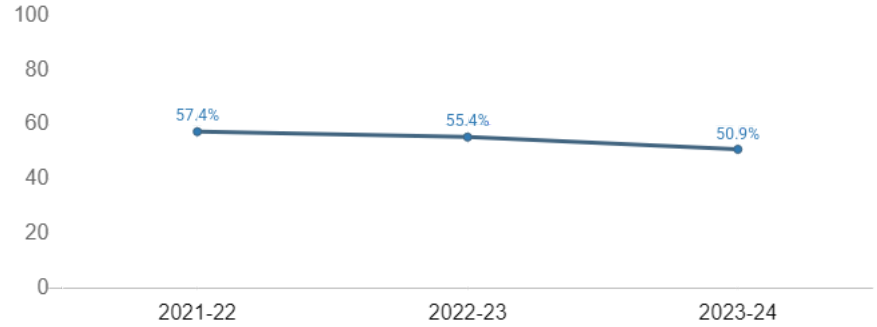
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. 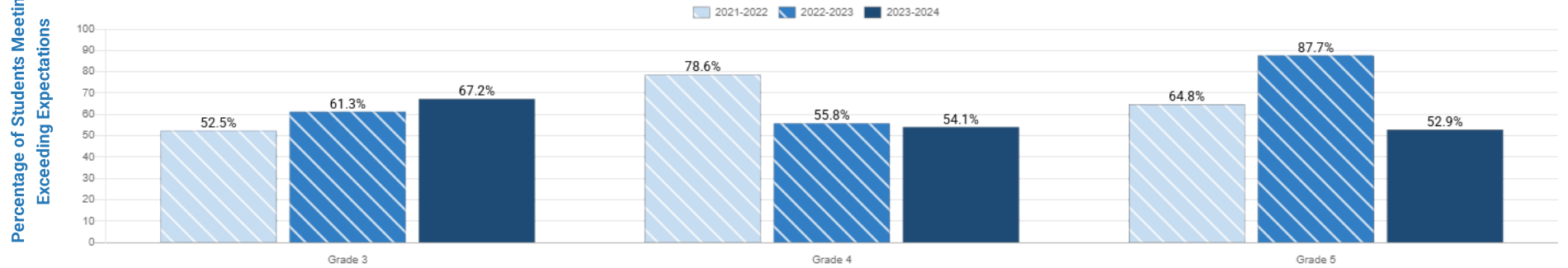

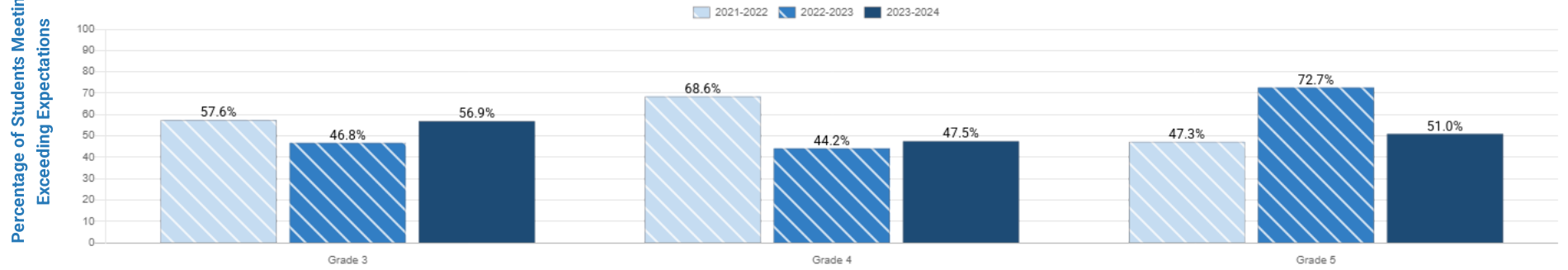

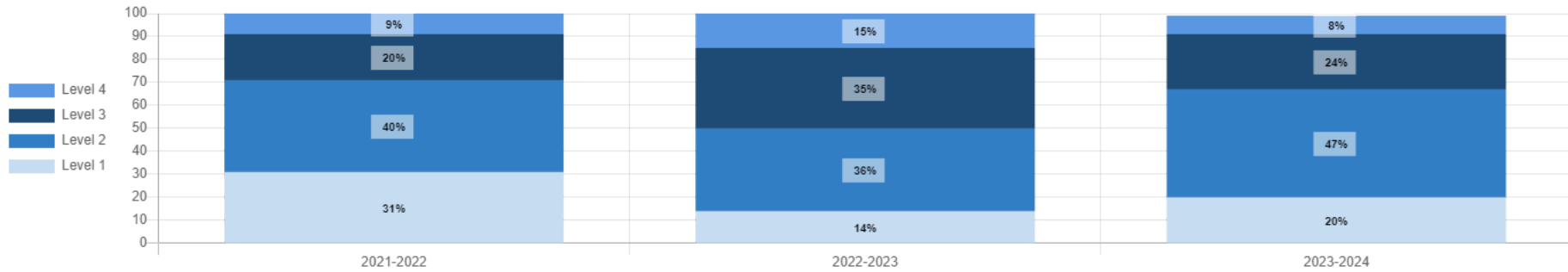

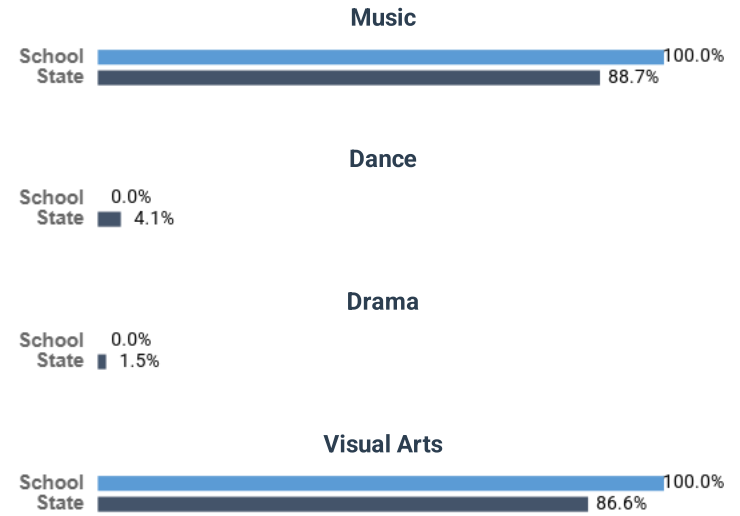

Students enrolled in one or more classes by discipline:



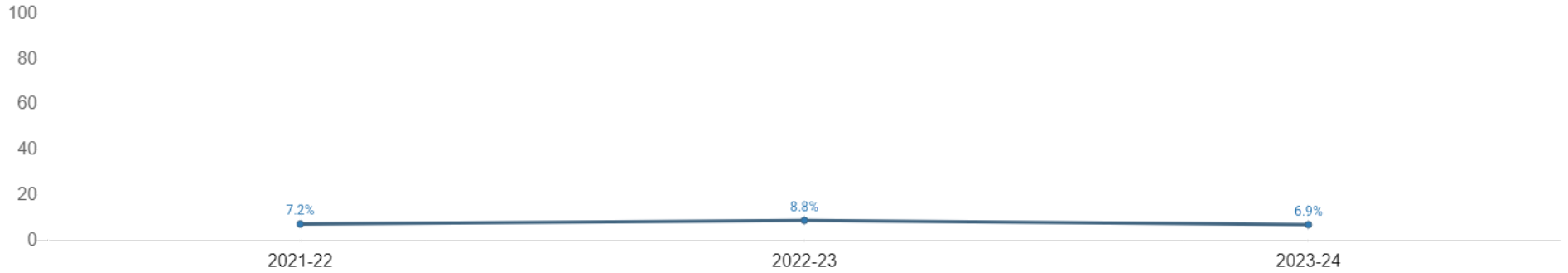

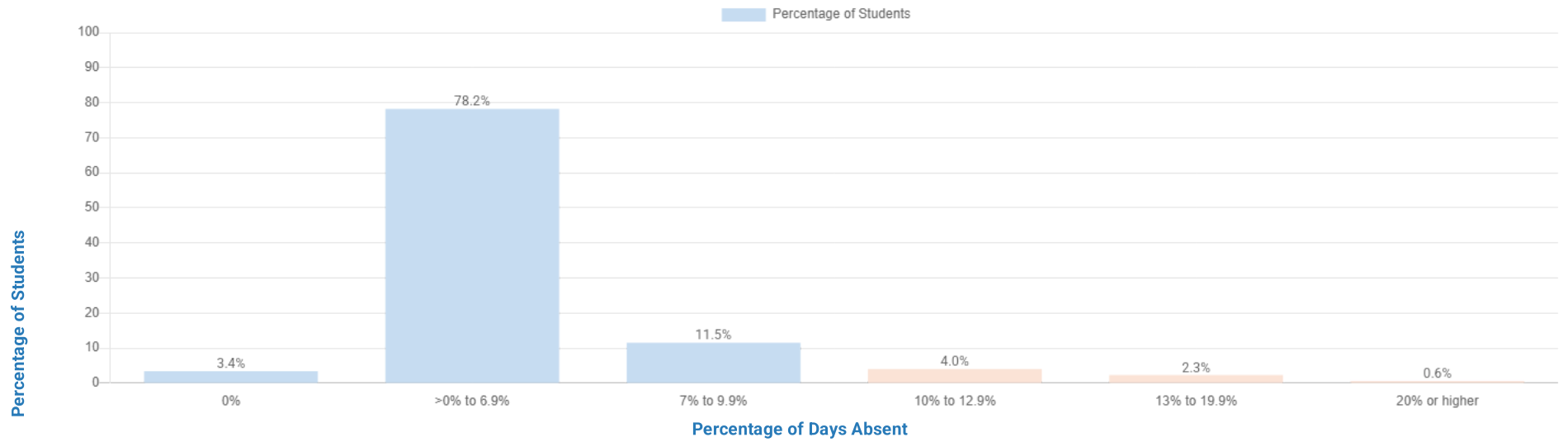

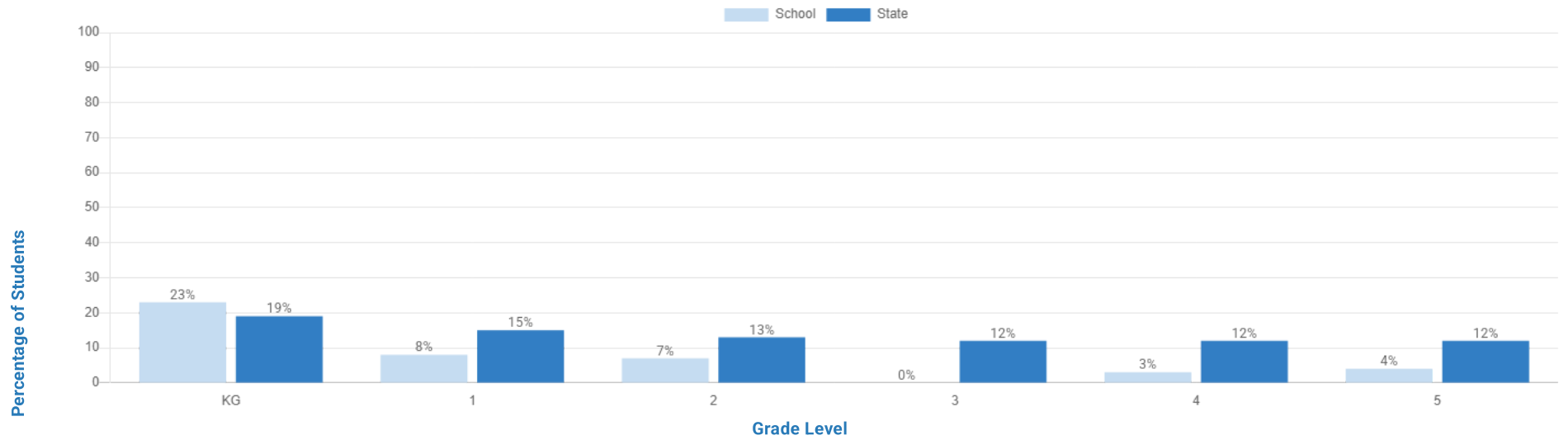

Staff

Staff data reflects teachers and administrators reported by districts at the beginning of the school year.

Key terms for staff data:

Teachers: All classroom teachers

Administrators: Principals, assistant principals, supervisors, coordinators, directors, and other central-office administrators, as well as superintendents and other district-level administrators

Experience: Experience is based on information submitted by districts on all their staff members. For purposes of this report, the ESSA Educator Equity and federal reporting requirements, NJDOE has defined teachers as "inexperienced" if they have fewer than four years of prior experience in a given district. The tables below report on "experienced" teachers and administrators for federal reporting purposes.

Out-of-Field: A teacher is labeled "out-of-field" if they are potentially teaching outside their area of certification. This could occur if the teacher cannot be found in the NJDOE's certification system, if their job code does not match their certification, or if the teacher has an expired certificate.

Provisional Teacher: A teacher with provisional certifications is a fully certified novice teacher of record who must meet further requirements of evaluation and mentoring during their induction into the profession before being granted "standard" or permanent certification.

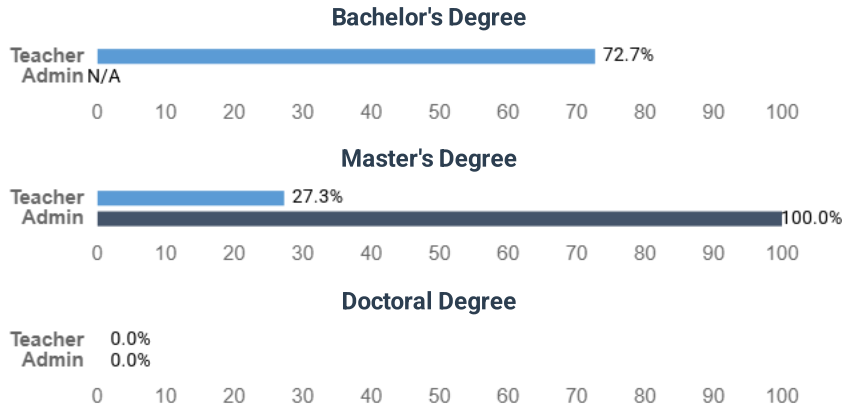

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. Our school offers the Strengthening Families Program for students/parents/guardians that takes place in the evening for the convenience of family participation. Our Family Math is available for grade three and Family Science for grade four. The Woodbridge Township Board of Education sponsors an After/Before School Child Care program for public elementary school-age children.



Staff and Professional Learning:

The WTSD offers a variety of professional learning opportunities during in-service days, virtually and throughout the year via PLC and Faculty meetings. Facilities:

Mawbey Street Elementary School #1 was built in 1962 and is a one story, handicap accessible elementary school. All 17 classrooms are air-conditioned and students have access to an expanded playground and a renovated courtyard for quiet reading time or to enjoy a special outdoor lunch.



School Safety:

Student safety is a top priority. A school based full-time security officer is on campus at all times. There is an updated security system. All exterior doors remain locked and security cameras monitor both indoor hallways and the building entrance. Exterior doors are equipped with door alarms that sound when doors are opened without permission. Furthermore, periodic patrol from the Woodbridge Police Department occurs daily when school is in session. One "emergency drill" and one "fire drill" are conducted each month. Our campus is equipped with 15 security cameras which broadcast to our district's security office 24 hours/day. Each classroom is equipped with a bulletin board maintaining safety and emergency response information.



Technology and STEM:

Technology enhances our curriculum with iPads & Chromebooks currently available for students & staff. Each faculty member is provided with a laptop. A 1-1 device initiative has been integrated for students in grades K-5. Seventeen ViewSonic boards were installed in each of the classrooms to facilitate and enhance learning.

Mawbey exceeded the the 90% attendance rate required by NJQSAC. Our enrollment in June 2024 was 313. According to our records 17 students experienced an absenteeism rate of at least 10 %.
