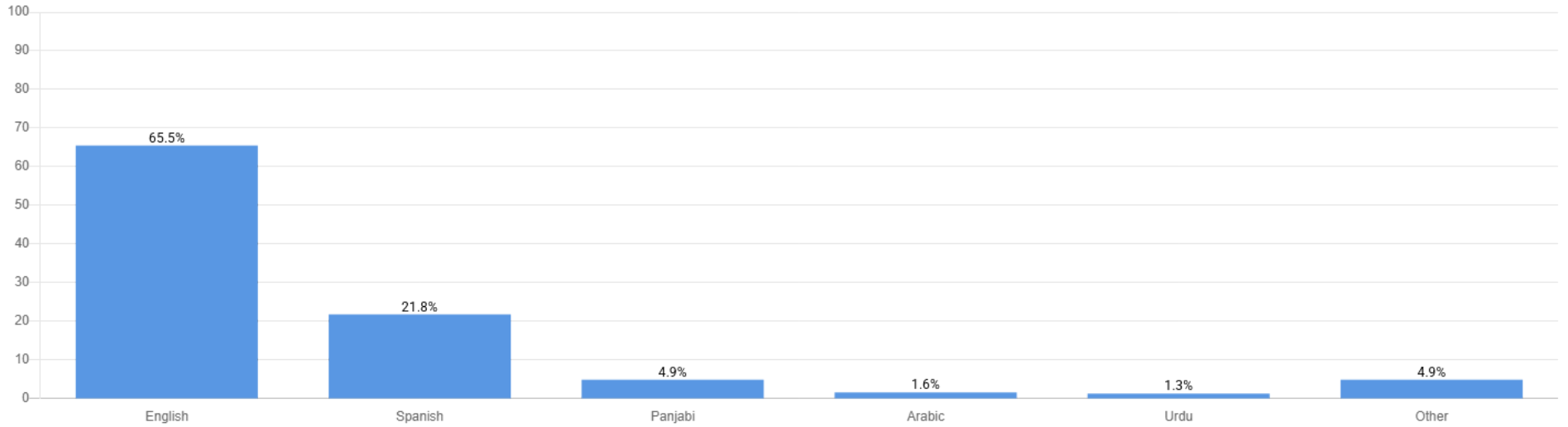

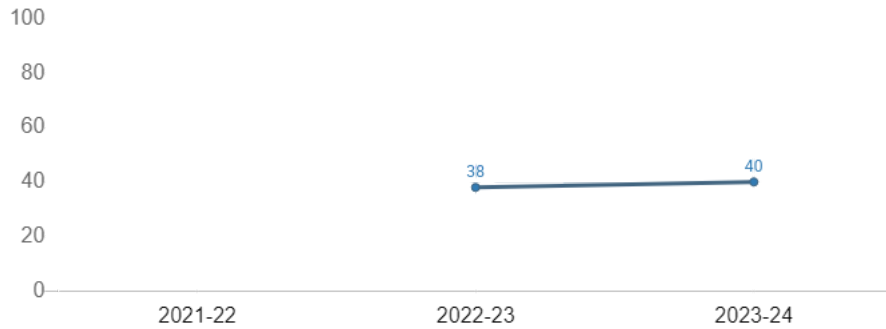

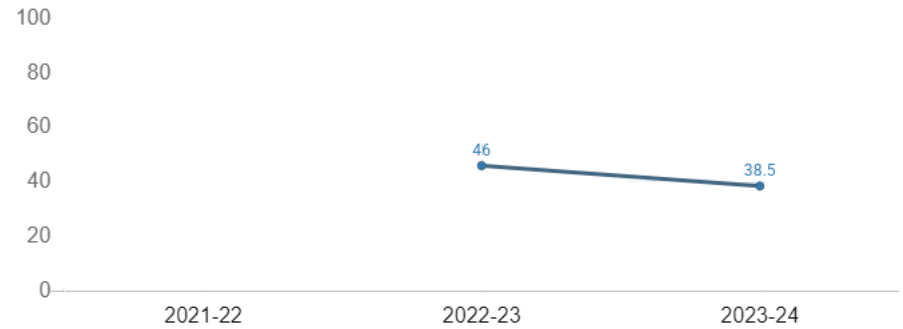

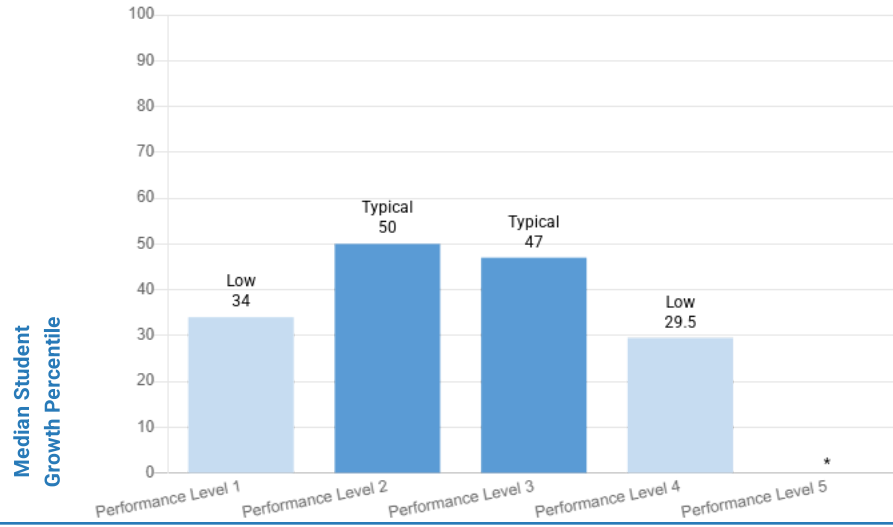

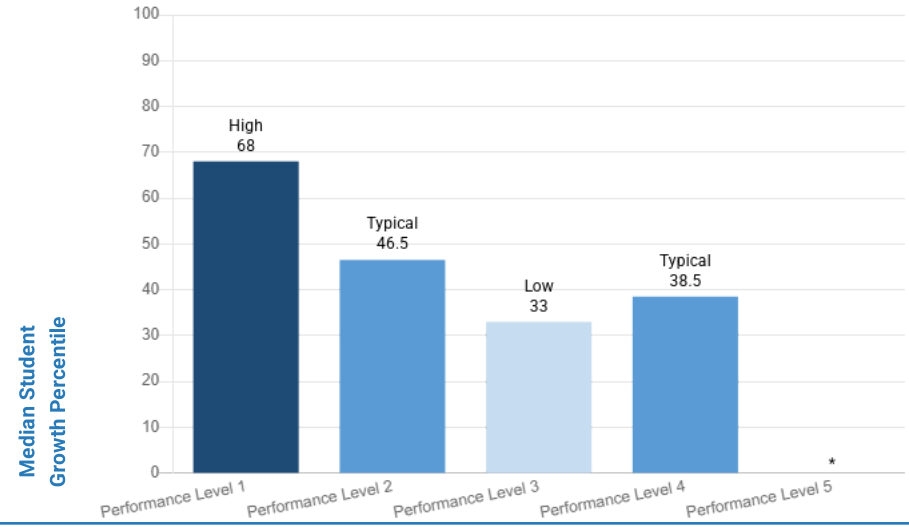

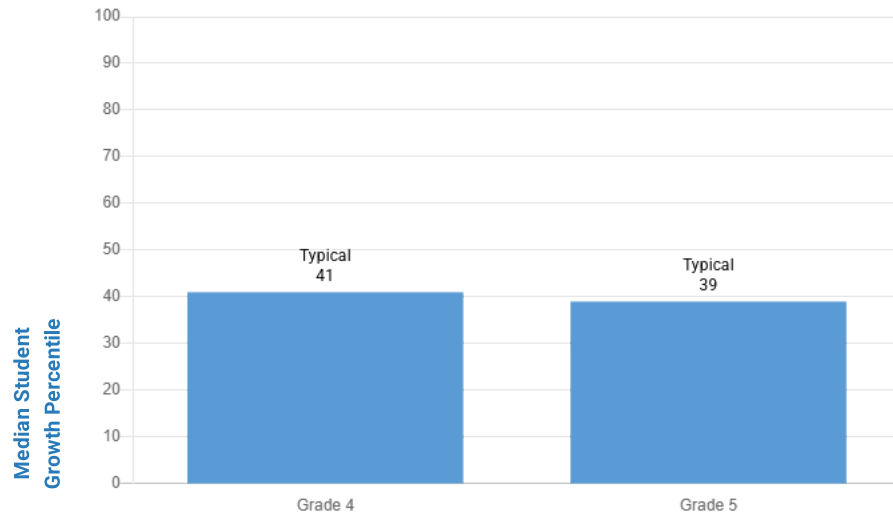

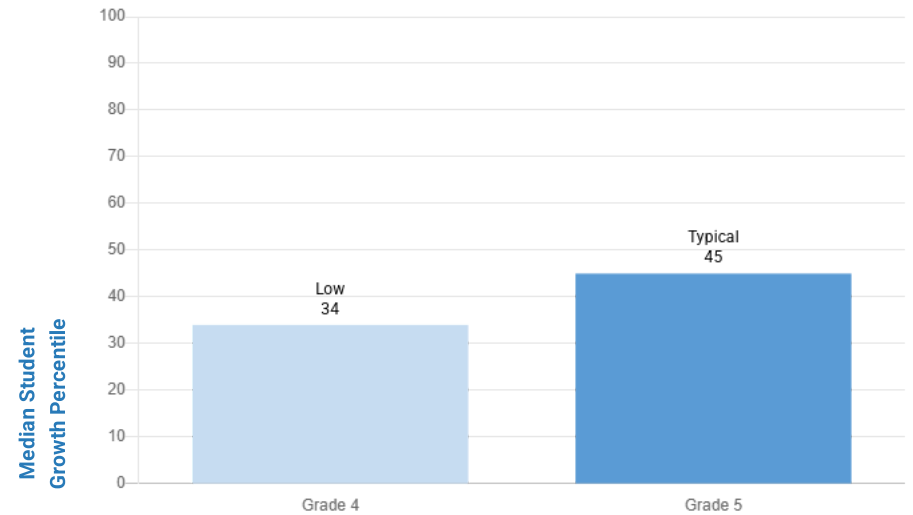

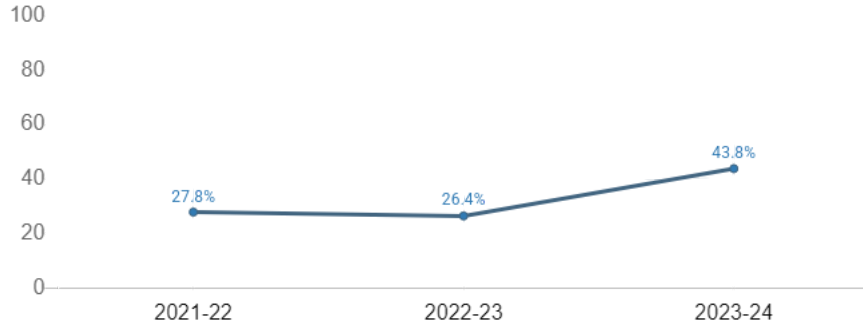

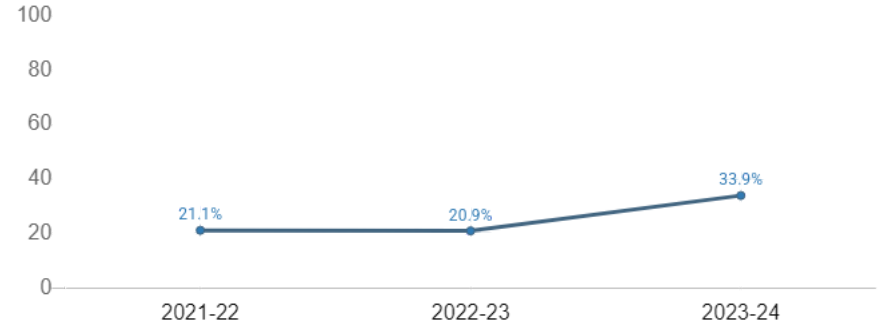
### English Language Arts and Mathematics Performance Trends

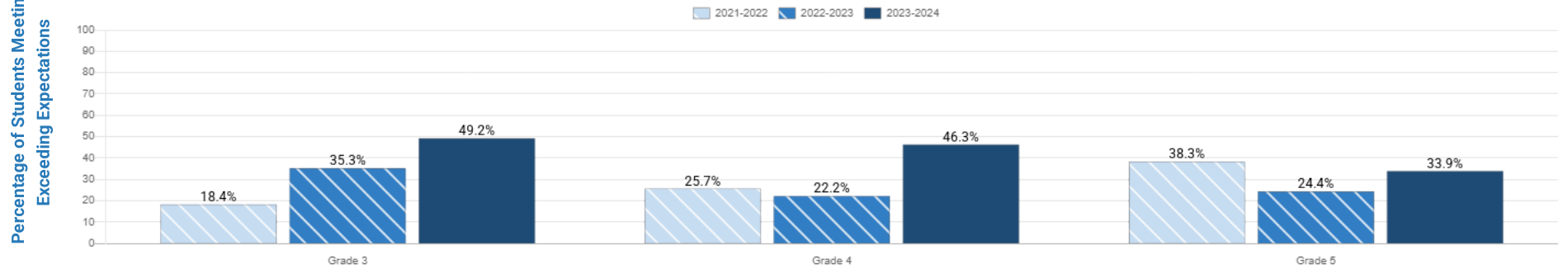

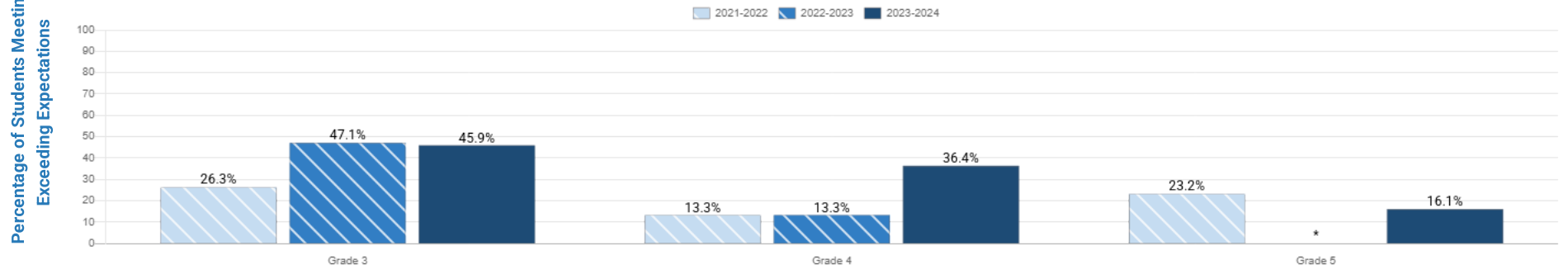

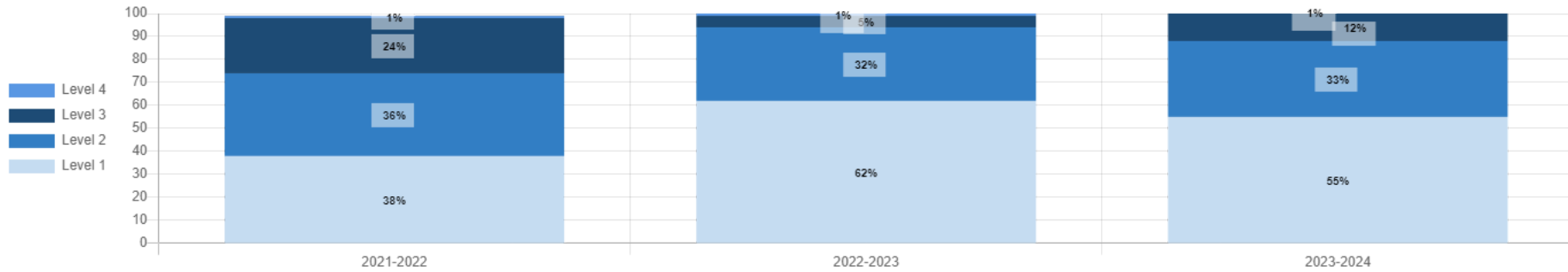

**Students enrolled in one or more classes by discipline:**



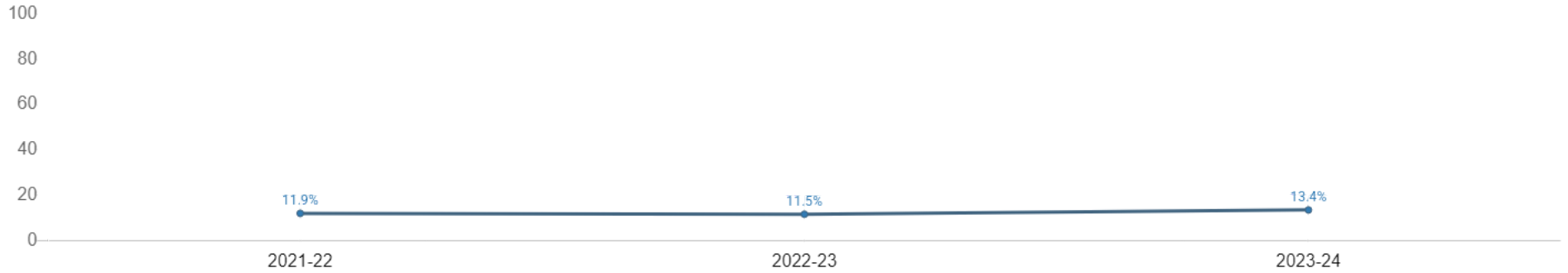
## Climate and Environment

Student absences provide important information about a school's culture and climate. Research shows that absences impact a student's ability to succeed in school. The NJDOE used input from stakeholders to select chronic absenteeism as its measure of school quality and student success for the ESSA accountability plan. **Chronic absenteeism** is defined as being absent for 10% or more of the days enrolled during the school year. A student who is not present for any reason, whether excused, unexcused, or for disciplinary action, is considered absent unless permitted by state statute or regulations. Students with fewer than 45 days in membership are excluded from attendance calculations.

### Chronic Absenteeism Trends

This table shows the number and percentage of students in grades K-12 both overall and by student group who were chronically absent during the school year. Pursuant to N.J.S.A. 18A:38-25.1, any school where 10 percent or more of the students enrolled are chronically absent must develop a corrective action plan to improve chronic absenteeism rates. The Requires Corrective Action Plan column in the table indicates whether the school's chronic absenteeism rate is 10% or higher, meaning that the school must complete a corrective action plan. The NJDOE Data-based Decision Making for Addressing Chronic Absenteeism guidance document (found on the [NJDOE attendance page](#) under Chronic Absenteeism) provides districts with guidance on responding to chronic absenteeism and includes sample corrective action plan templates.

The ESSA Target: State Average for Grades Served column is the target used for ESSA accountability purposes. It reflects the statewide average for students in the grades offered by the school. 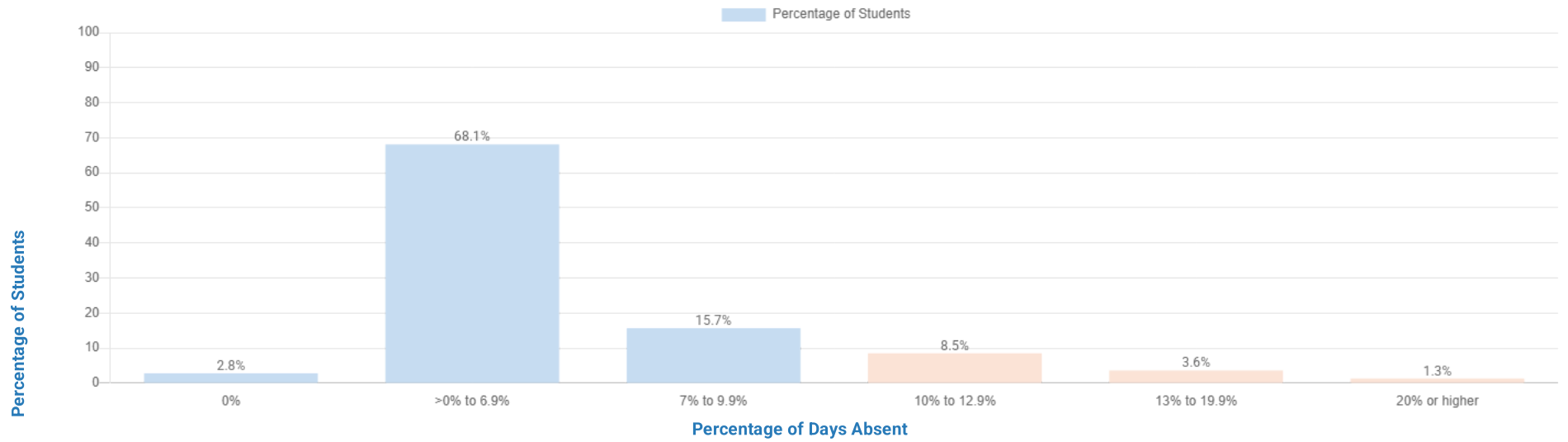

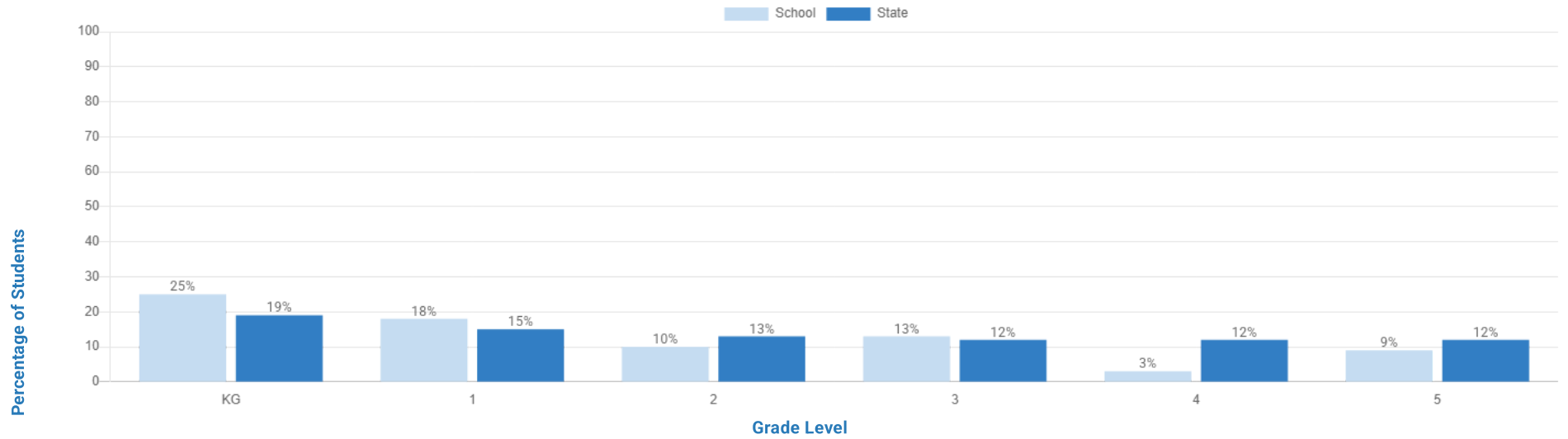

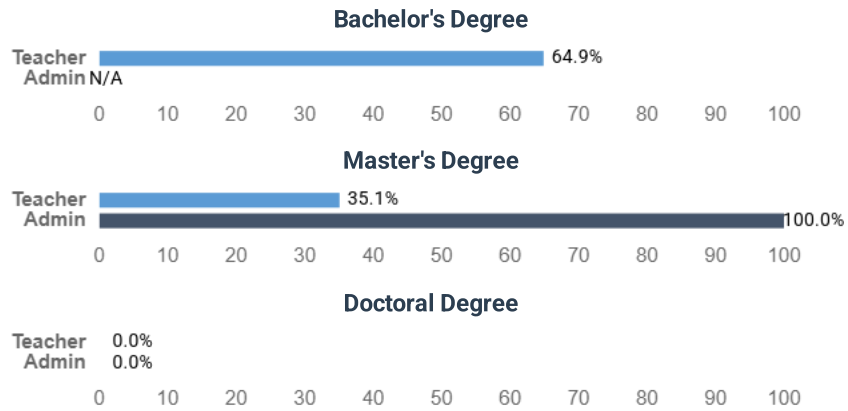

- In addition to ELA, Math, Science, & Social Studies, students receive weekly Art, Music, and PE instruction.
- Parents and students can participate in four different Family Programs over four different grades, including ELA, Math, Science and STEAM nights.



School #9 is committed to providing a safe, nurturing environment of mutual respect while inspiring children to achieve their academic potential. Students are valued for their individuality and diverse capabilities as they are taught to face the future and contribute to society with compassion, courage, knowledge, and vision. The staff believes and endorses the vision of Woodbridge Township School District and understands that dedication and commitment are essential if each student is to receive a chance at equal educational opportunities. Grades K-5 all share the Benchmark Advance Language Arts program that provides daily explicit phonics instruction and word study, supports vocabulary development, and specifically targets skills for accessing complex texts, using textual evidence, and building knowledge equitably within and across grade levels. Throughout the school year, Port Reading Elementary School also recognizes and celebrates various cultures to promote an inclusive environment. An off-site Gifted and Talented program is offered to meet the needs of the advanced student.
