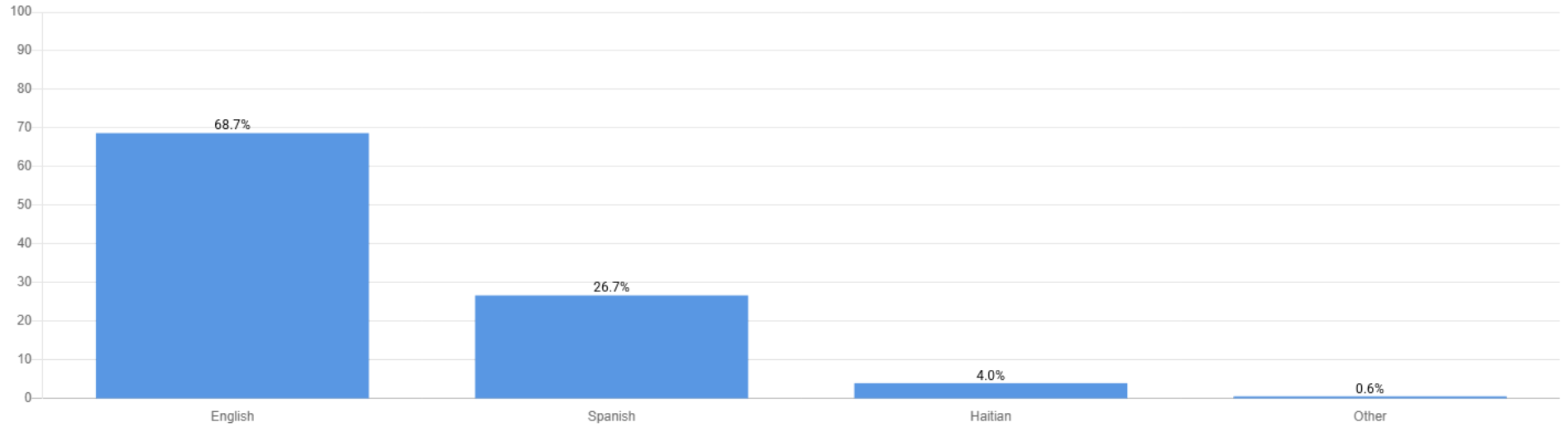

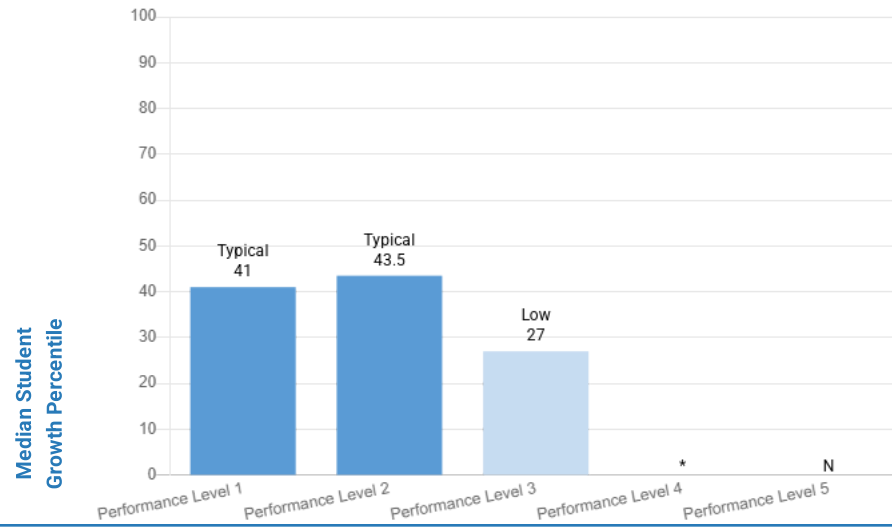

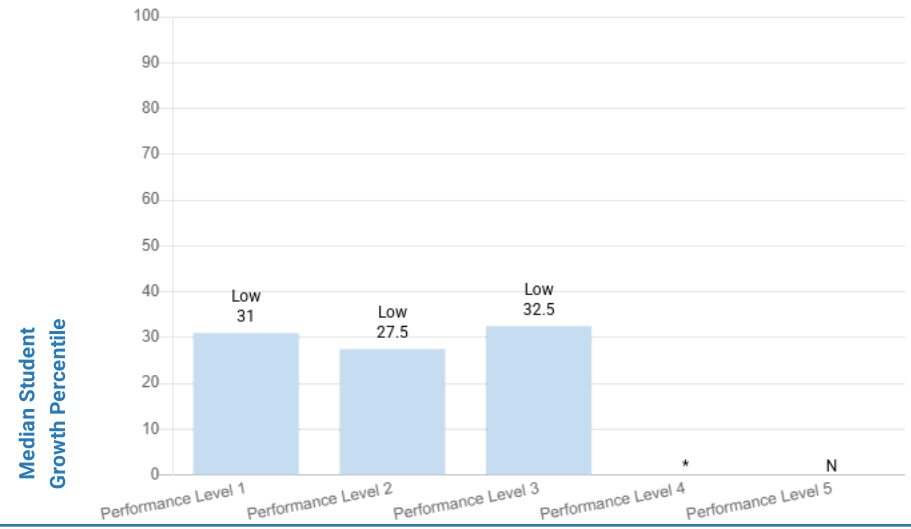

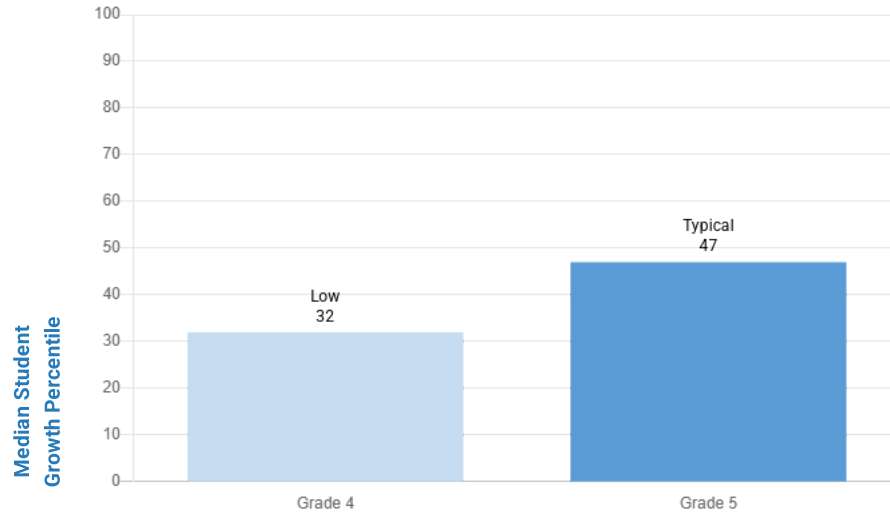

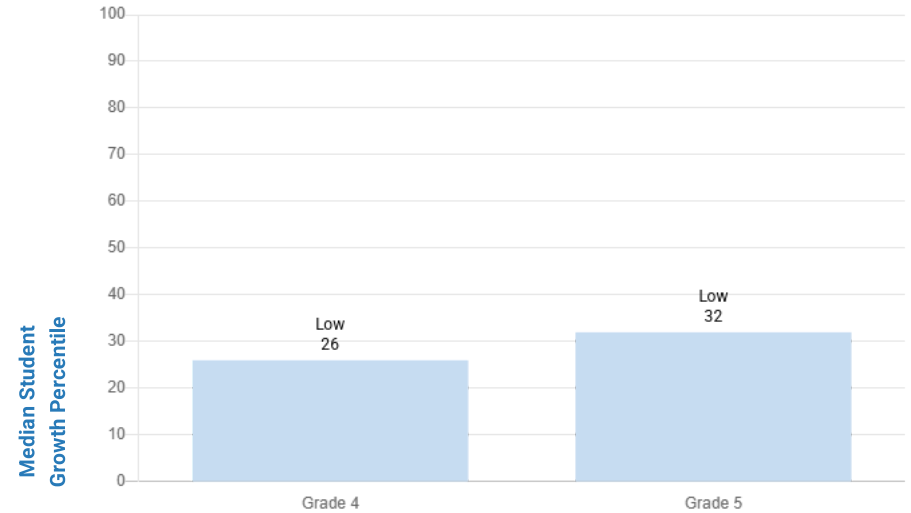

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. 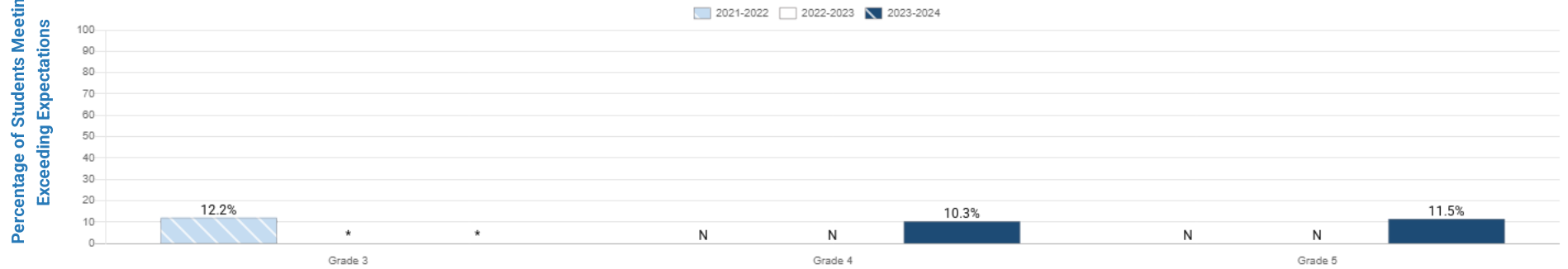

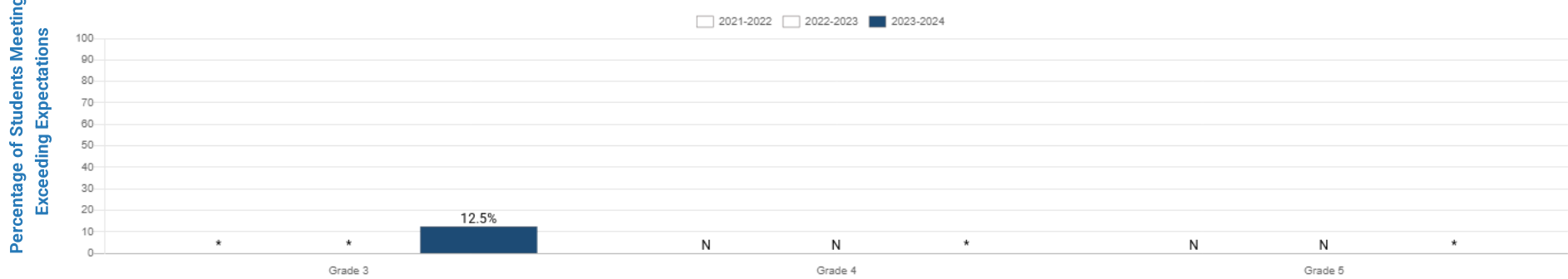

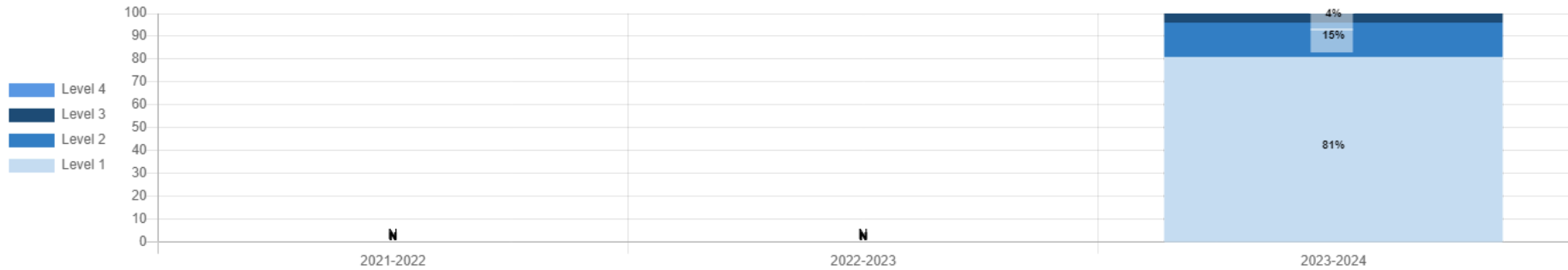

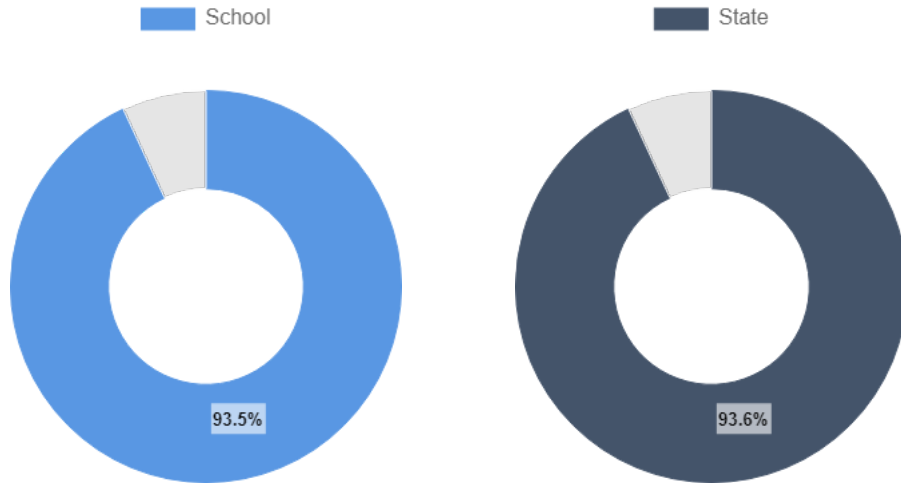

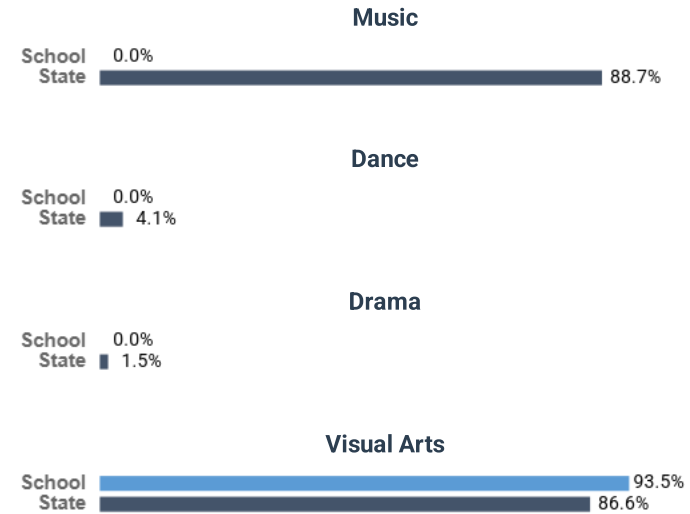

Students enrolled in one or more classes by discipline:



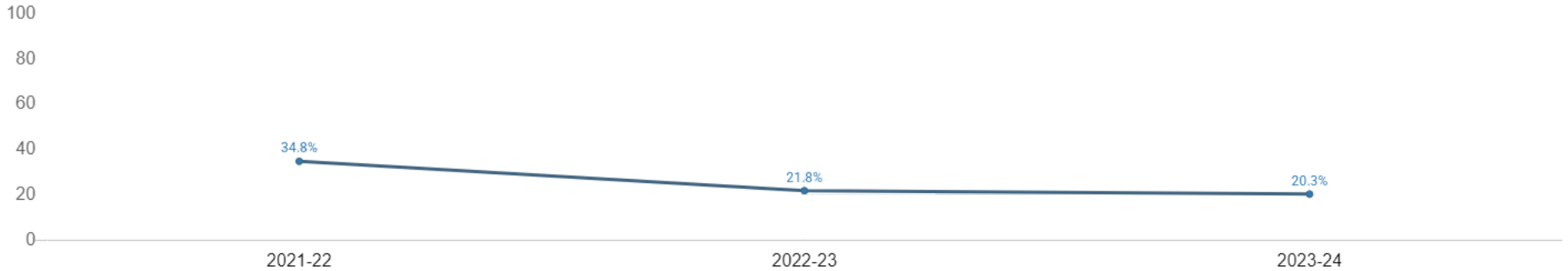

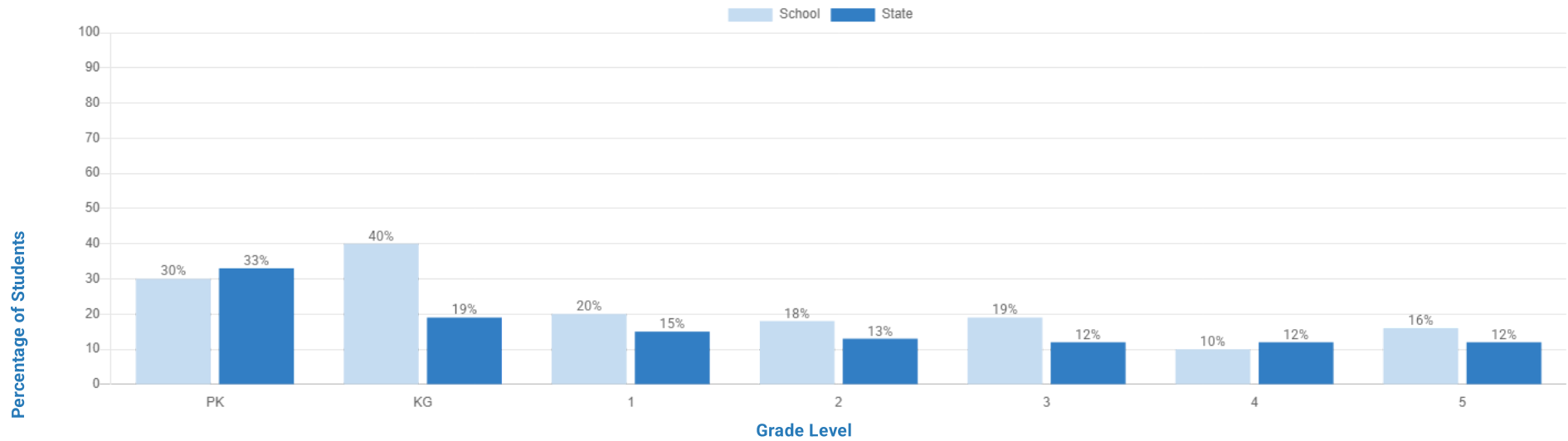

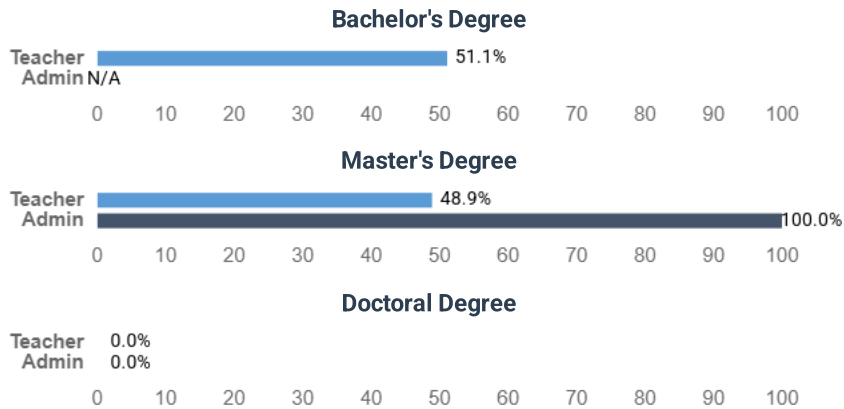

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Thurgood Marshall offers a variety of instructional programming. All Preschool classes use Creative Curriculum and Teaching Strategies Gold assessment tool. Kindergarten through 5th Grade implements the Journeys program for English Language Arts, the Into Math program for Math, and the Into Science program for Science instruction. iReady is also used as an individualized diagnostic assessment tool in classrooms, along with standards-based assessments through the LinkIt! platform. Preschool through 2nd Grade implements the Second Step program for social-emotional development and 3rd Grade classrooms follow the responsive classroom approach.



Clubs and Activities:

Thurgood Marshall Elementary School provides participation for students in the Student Advisory Committee, Safety Patrol, Saturday Preparatory Academy, STEAM/BGC After School Academy, Girl Scouts, Boy Scouts, Mentoring Program, a PTO and various school-level committees.



Before and After School Programs:

The Thurgood Marshall Elementary School offers all PK-5 students the STEAM (Science, Technology, Arts, Athletics, Math) After School program from 2:45 PM to 5:15 PM daily and the program was transitioned to the Boys & Girls Club in February 2024. All students and families also have access Before and After Care each day.

Student Supports and Services:

All students are supported at Thurgood Marshall through tiered services. ELL/Bilingual students receive a pull out-push in program through a certificated Bilingual teacher. Students with special needs are serviced through placement in an Inclusion Resource class or via a pull out resource program for ELA and/or Math. An Intervention and Referral Services program is also in place to designed to provide individualized supports for any student in need.



Student Health and Wellness:

Social and emotional services are provided for all Thurgood Marshall students, if needed, via YMCA counseling and in-school mentoring programs. Additionally, the school implements a building-wide positive behavior supports program to develop and promote self-regulation and good choice making. All students also receive breakfast and lunch each day, along with a 20-minute recess period and 25-minute social-emotional period. Thurgood Marshall also has an active partnership with the Safe Routes to School program through participation in annual "Walk 2 School Day" and "Bike Rodeo" events. Our school also provides health services via the Mobile Dentist and Optical Academy.

Additionally, the school is in partnership with the Alpha Phi Alpha Fraternity to provide supports for our family and community via volunteerism, donations, and on-site mentoring. Thurgood Marshall also implements a School Leadership Committee that oversees the planning of various involvement opportunities, including but not limited to, Grandparents Day, Hispanic Heritage Month Celebration and Dance, Halloween Parade, Breast Cancer Awareness, PBIS Holiday Store, Giving Thanks Food Drive, Family Luncheons, Valentine's Day Dance, Spring Dance, Seasonal Concerts, Black History Month Celebration, Haitian Heritage Month Celebration, Field Day, Moving Up Ceremonies, and Mother/Father Day Celebrations. All families have access to Parent Portal to view their child's academic information.



Facilities:

Thurgood Marshall Elementary School is 27 years old. The building has three floors, that includes a gymnasium and a cafeteria/multi-purpose room. The building has classrooms of all sizes, a media center, two computer labs, art room, STEAM lab, music room, and community room. The entire building has air conditioning and one elevator. Two playgrounds are provided for students to utilize, along with two small fields. Recently the school has undergone renovations to receive new flooring in the multi-purpose room and solar panels.



School Safety:

Thurgood Marshall has security officers on-site that work with the building administration and district Office of Security and Safety to ensure the safety and well-being of our students and staff members. A School Safety Plan documents the planning, intervention, and response protocol and procedures and provide a common frame of reference to increase stability of an emergency response. The School Safety Plan was developed with input and support from a variety of public agencies including, the NJ Department of Education and local law enforcement, in addition to school personnel. This plan is in alignment with N.J.A.C. 6A:16 - Programs to Support Student Development which addresses safety, code of conduct, emergency and crisis Management planning and incident reporting.

Technology and STEM:

All classrooms have Smart Boards for use during instructional time, along with a 1:1 Chromebook program for all students in grades K-5 and iPad initiative for all Preschool students. Students are also introduced to integrative practices of STEAM throughout their day. In core subject areas, students have the opportunity to utilize various digital tools, robotics and materials to learn important standards and produce artifacts in a creative way of their choosing that document their learning. STEAM is also being conducted in special areas like Music, Art and Media Arts. Thurgood Marshall also has a STEAM teacher that works with our K-5 students. Using a Learning Management system like Google Classroom has helped our teachers to organize student learning.



Early Childhood Education:

Thurgood Marshall Elementary School offers free full-day 5-star rated preschool program for our community. All preschool classes follow a daily schedule that adheres to state guidelines and can seamlessly incorporate elements of developmentally-appropriate virtual instruction for remote learning. Hours of operation generally fall between 8:00 AM to 2:30 PM and class sizes maximize at 15 students and provide learners with at least one full-time classroom teacher and one full-time classroom paraprofessional. Teaching and learning occurs in a variety of high-quality, developmentally-appropriate approaches through Teaching Strategies Creative Curriculum and the use of the Gold Performance Based Assessment.
