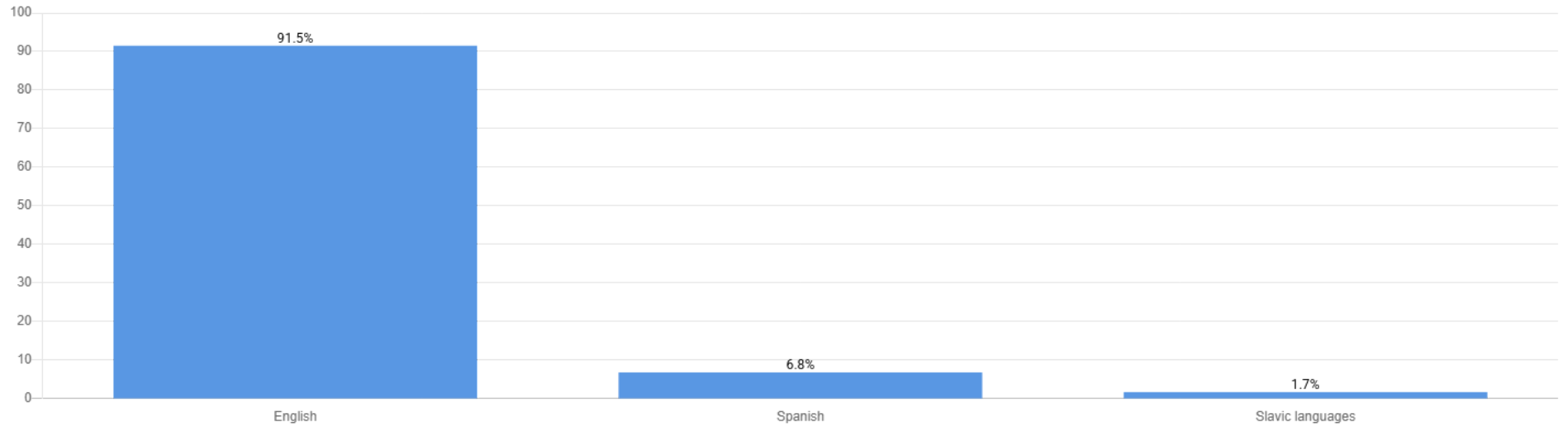

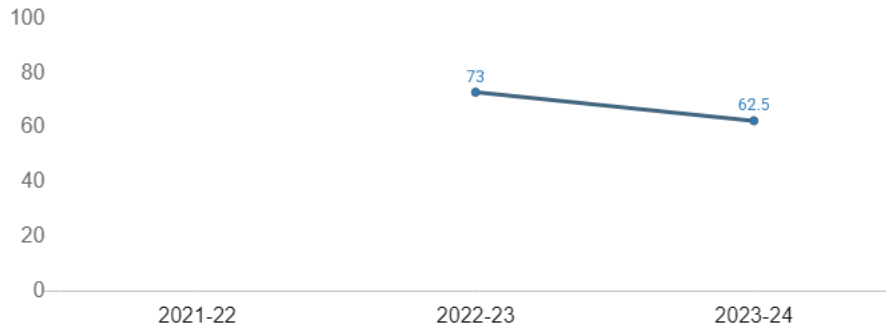

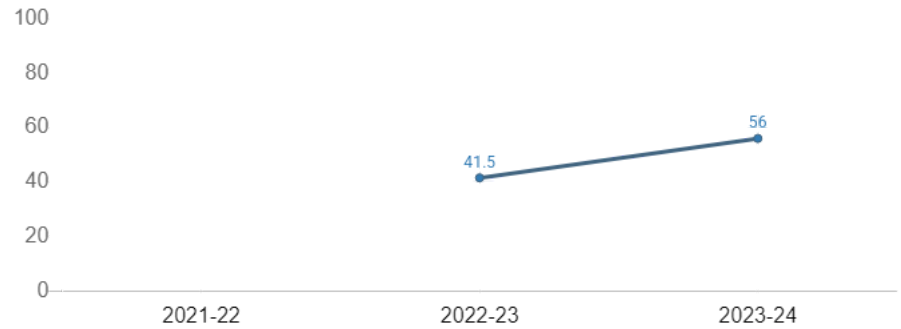

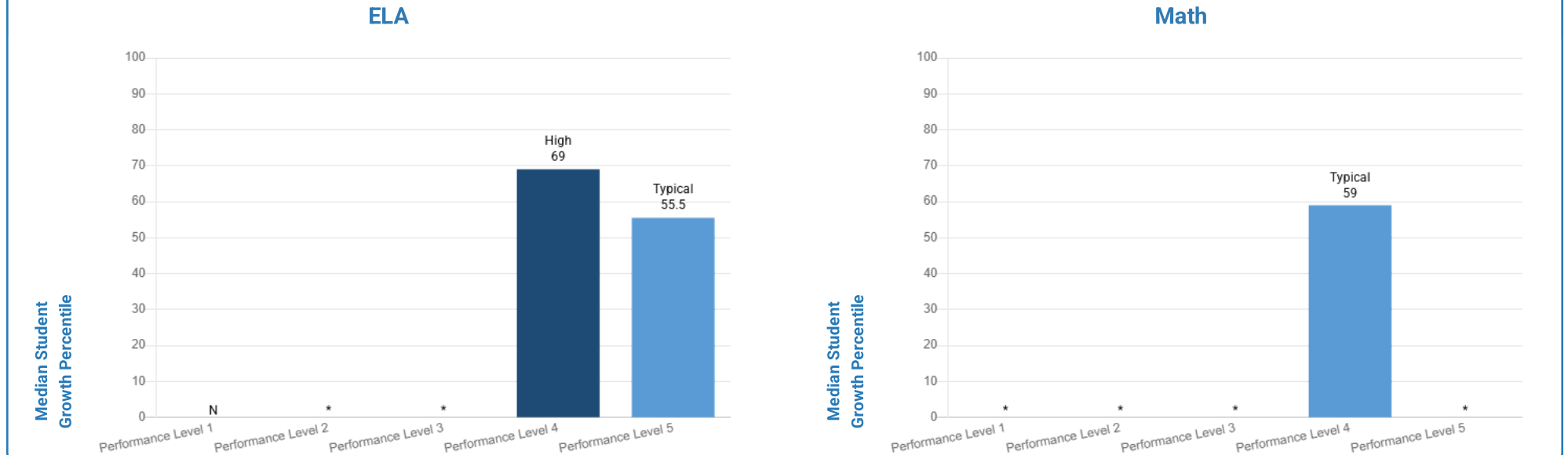

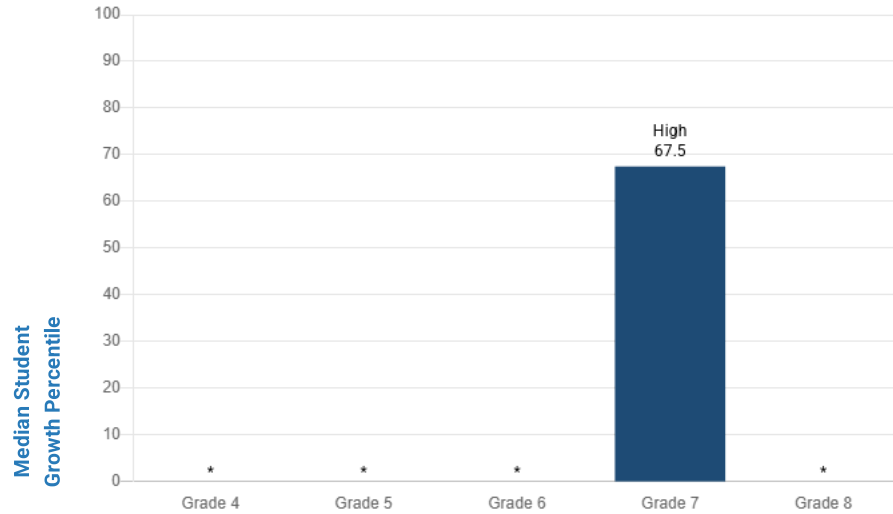

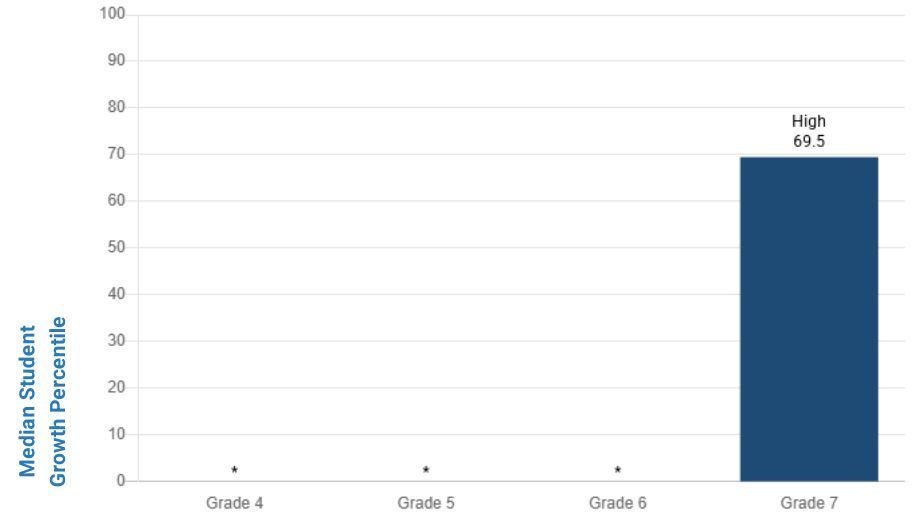

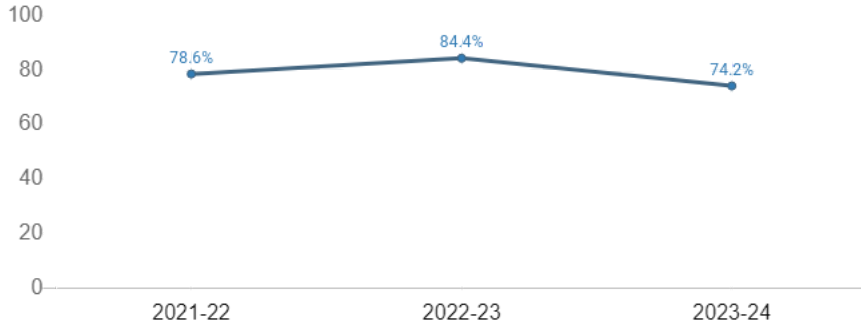

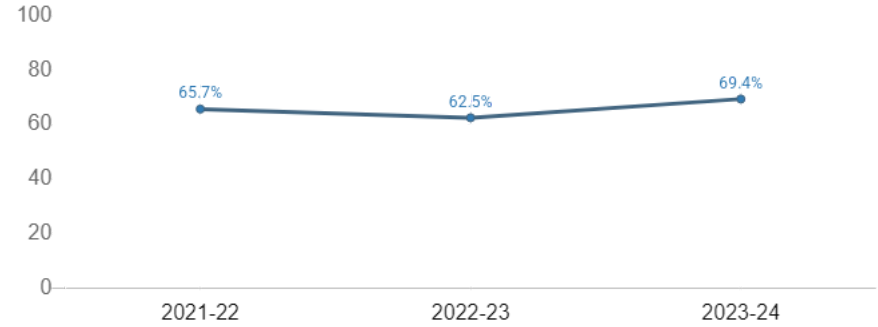
English Language Arts and Mathematics Performance Trends

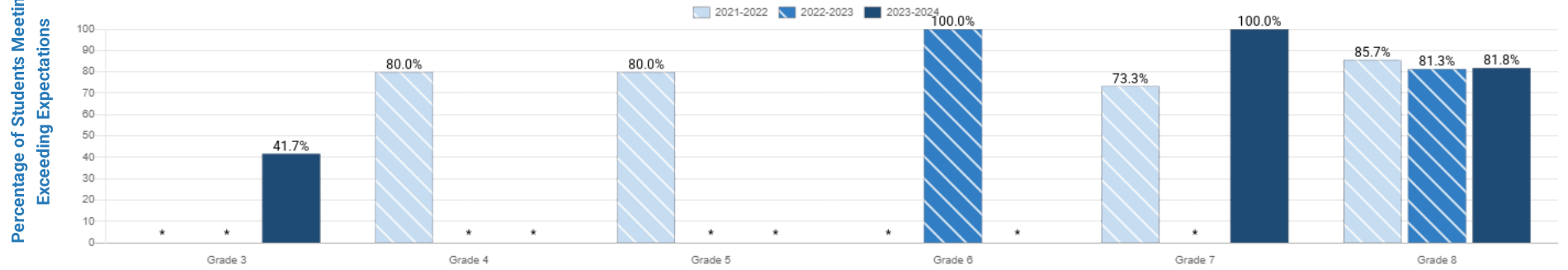

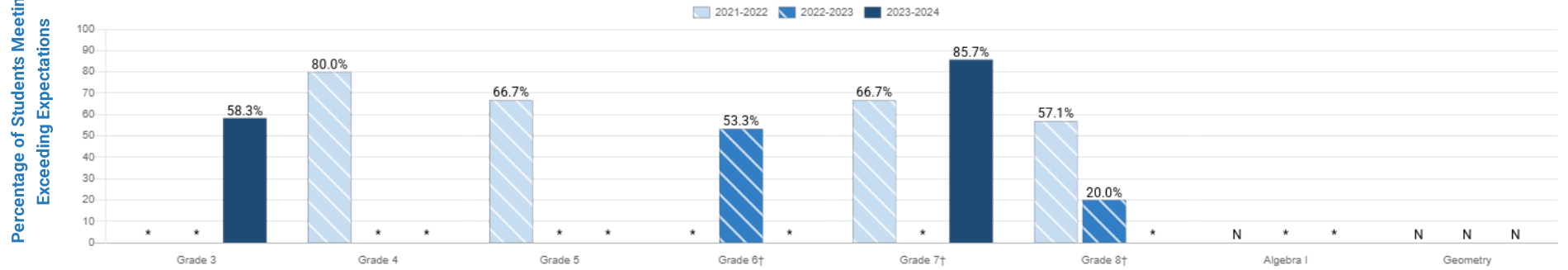

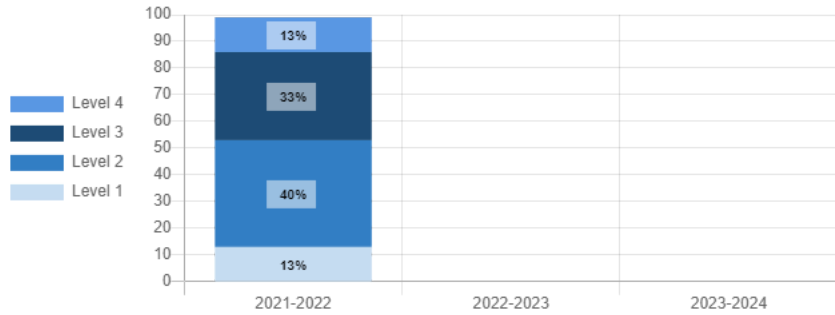

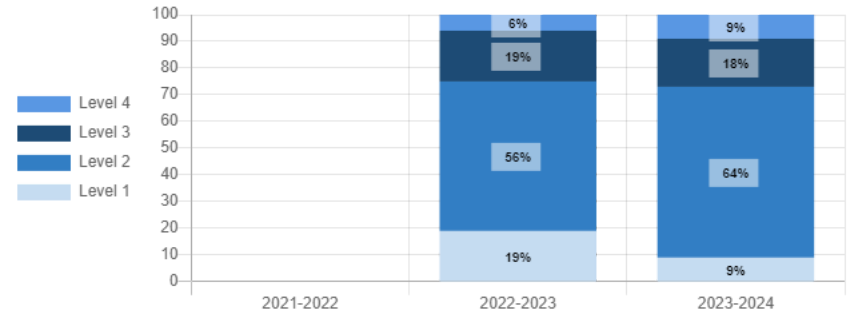

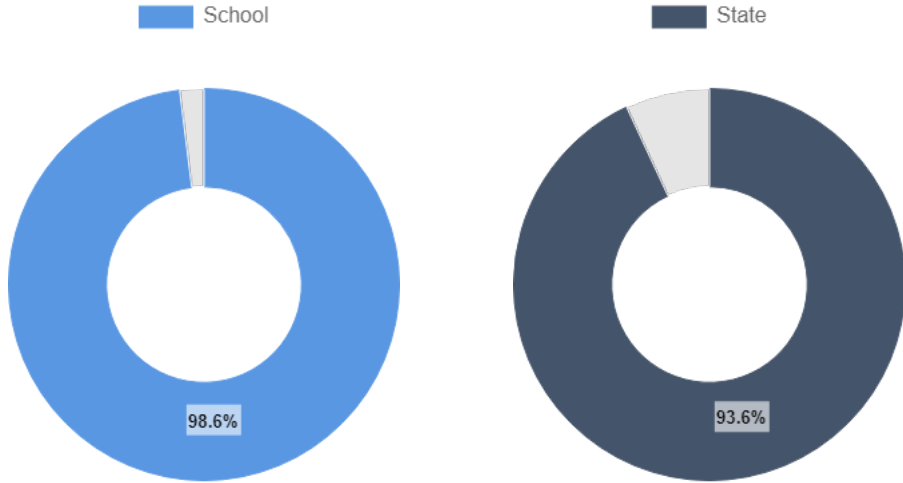

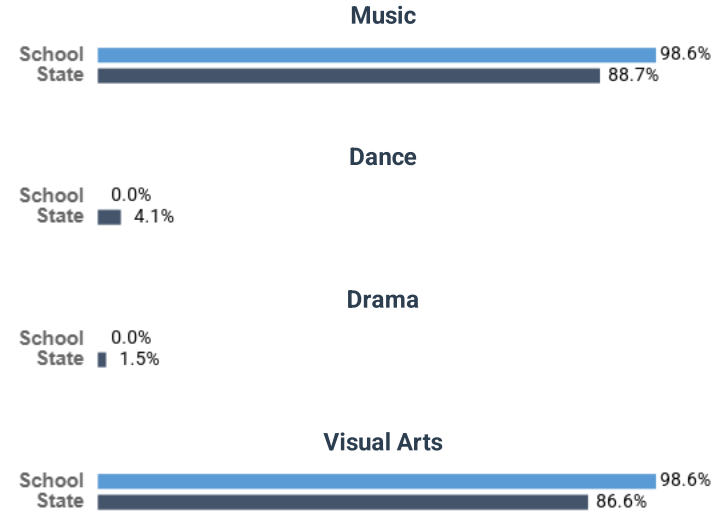

Students enrolled in one or more classes by discipline:



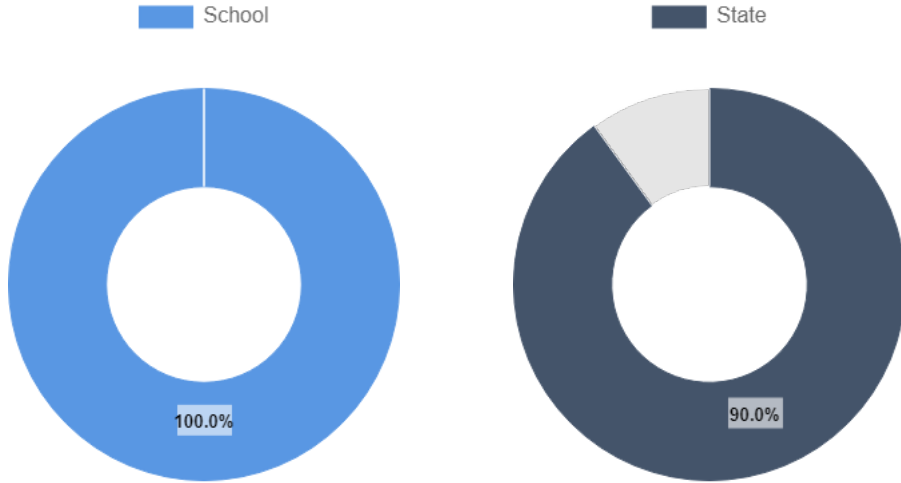

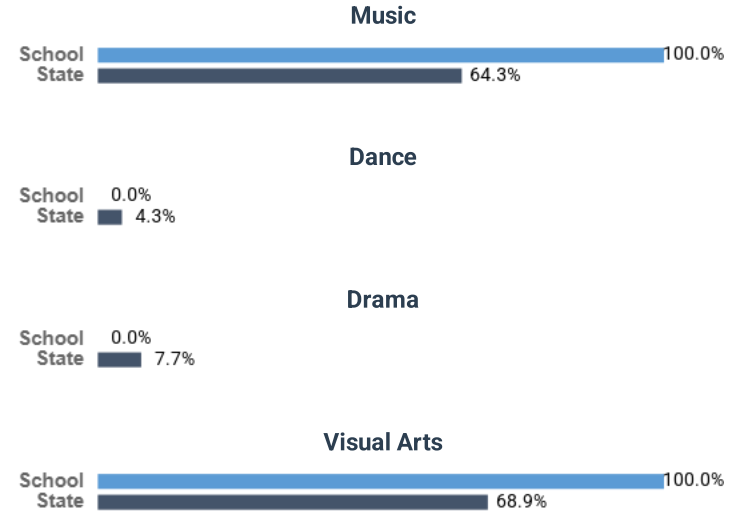

Students enrolled in one or more classes by discipline:



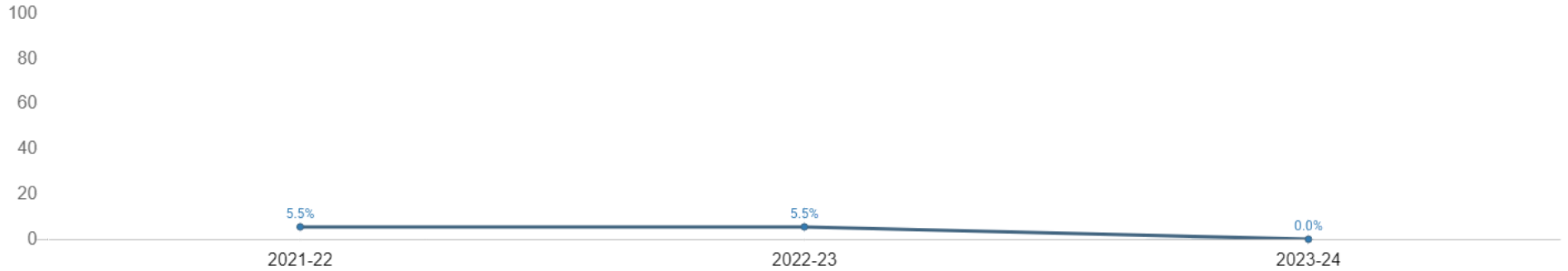

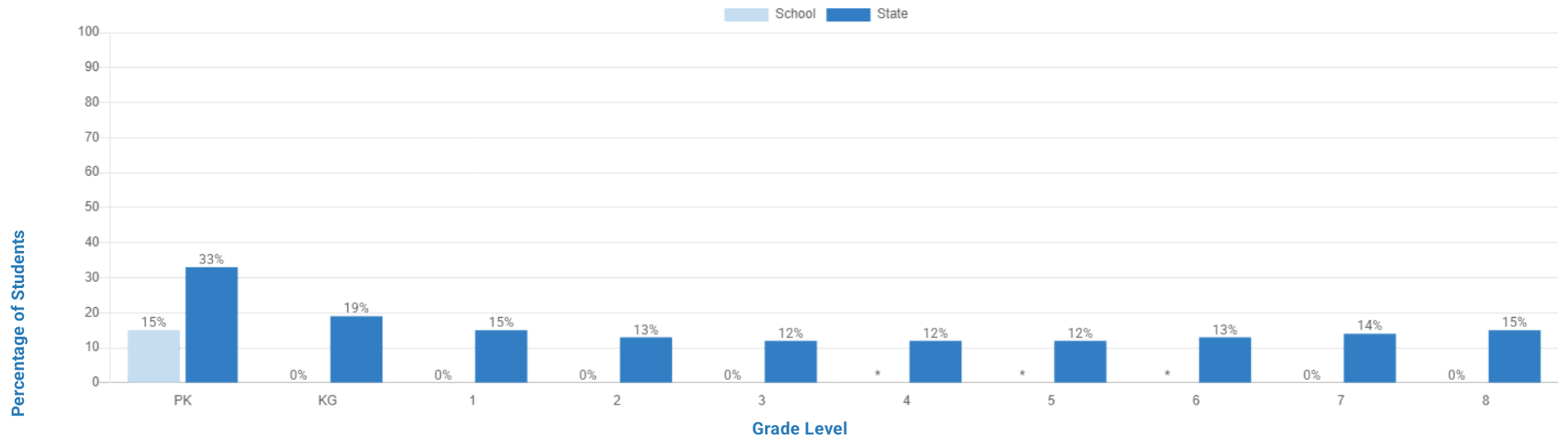

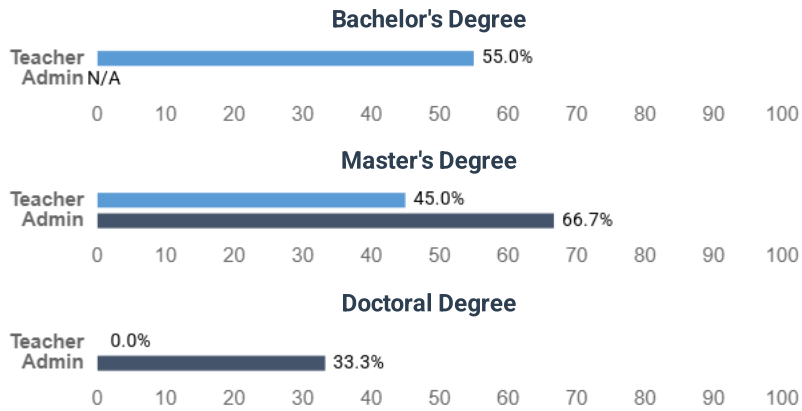

This begins each day, in every grade level with a Morning Meeting/Advisory where students develop classroom community and build skills using a Responsive Classroom framework. This is supplemented with lessons in social-emotional learning, conflict resolution, mindfulness, and growth mindset. A multi-tiered system of support is utilized to ensure reflective and responsive practice that targets individual needs that are inclusive of all learners, from intervention to gifted and talented from both an academic and behavioral lens, to ensure equal access to learning in the classroom for all students.
