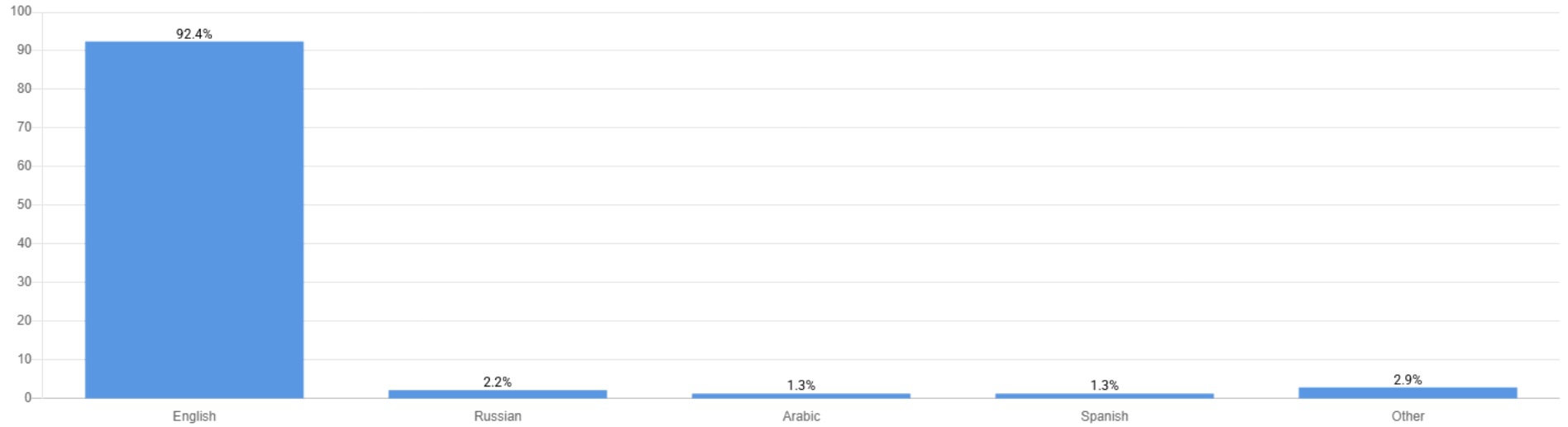

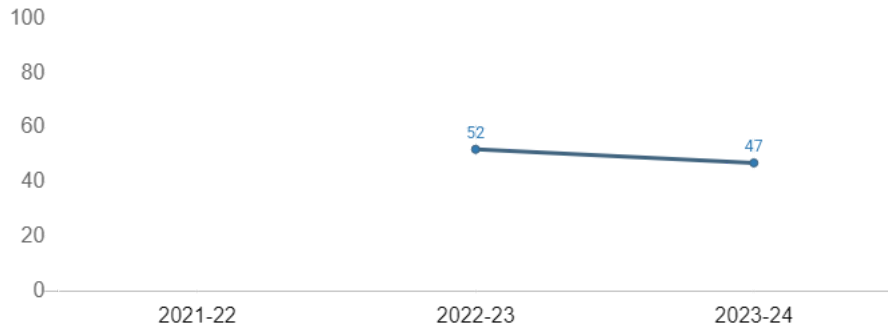

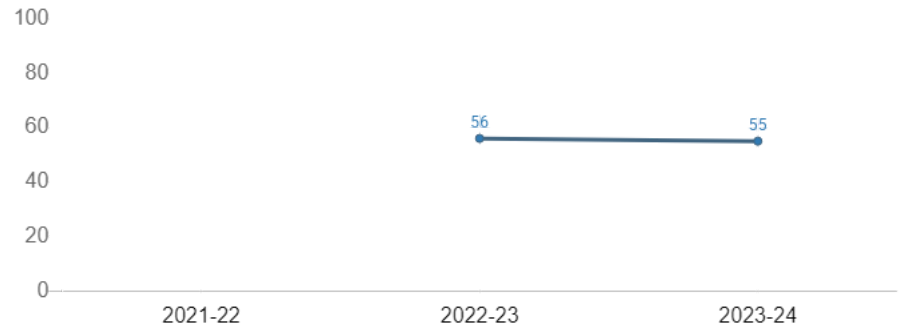

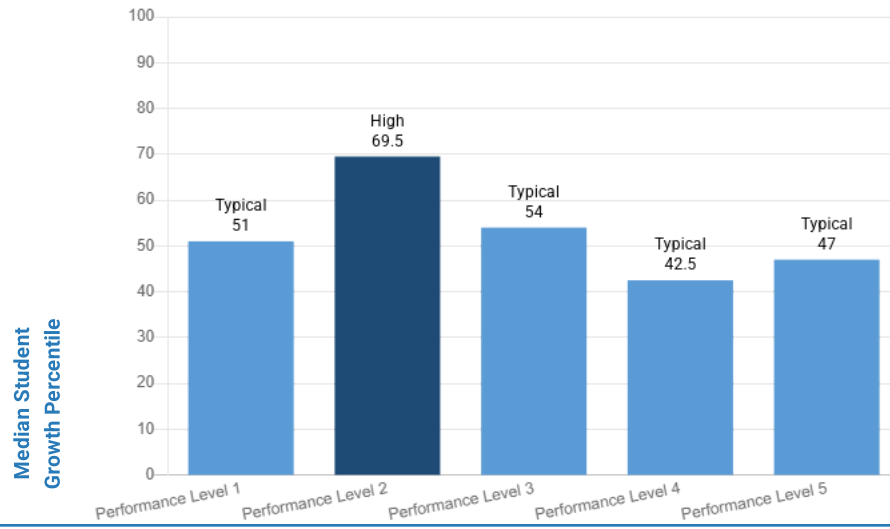

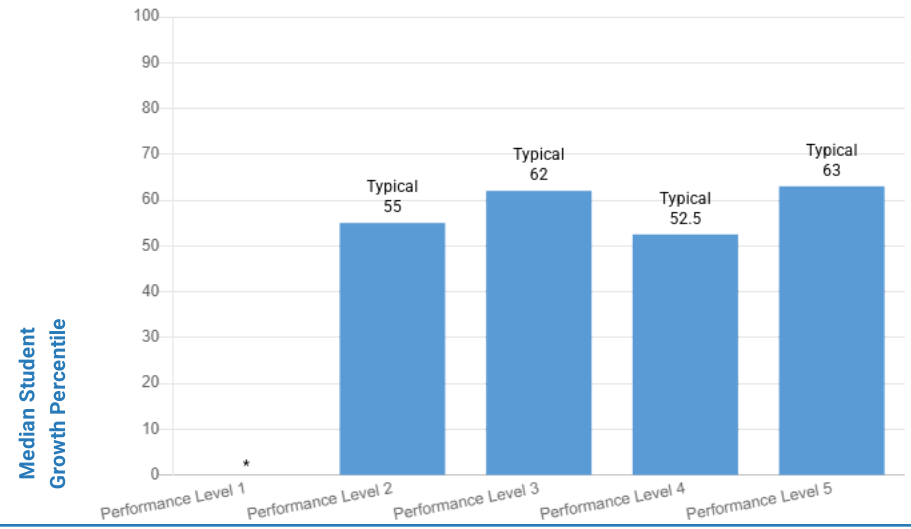

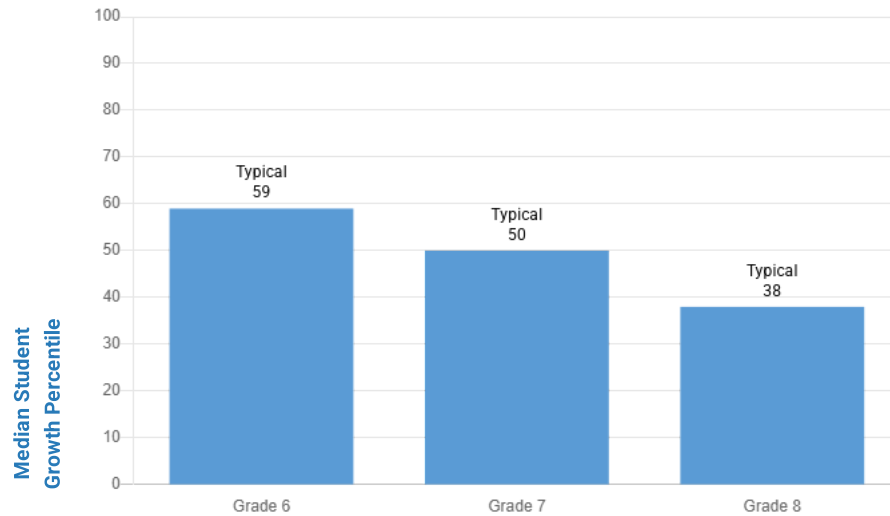

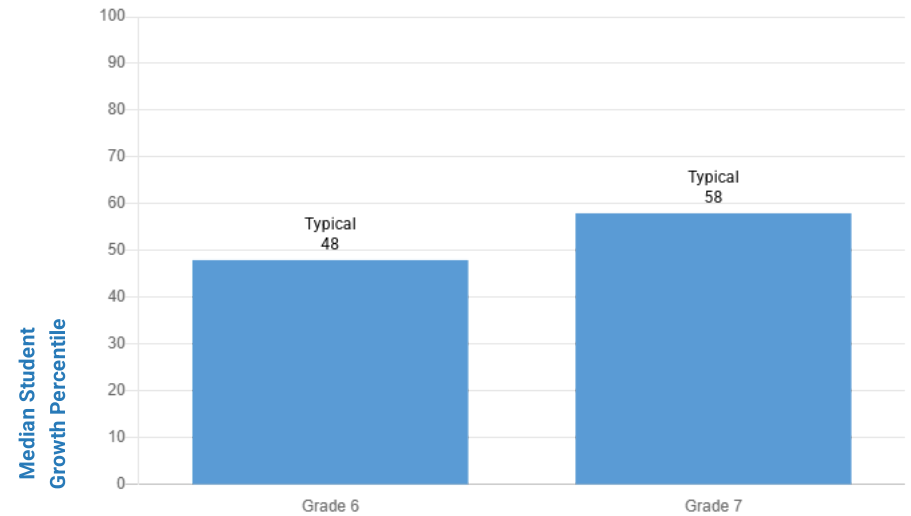

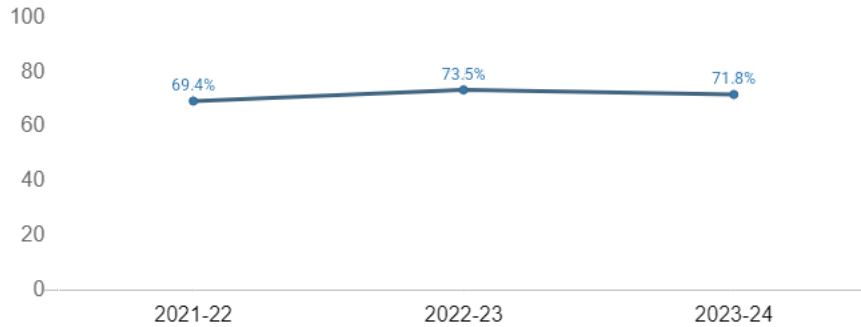

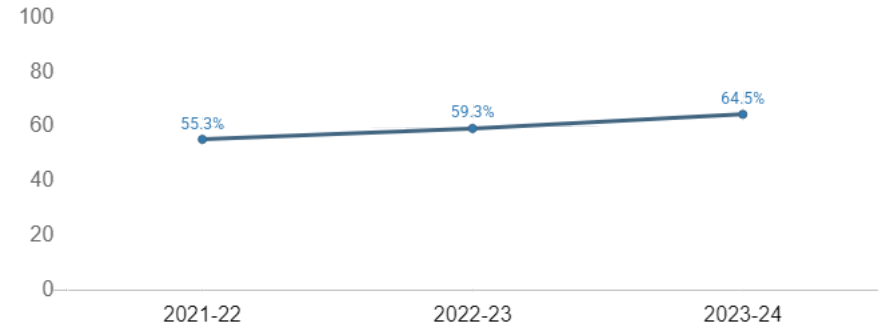
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. 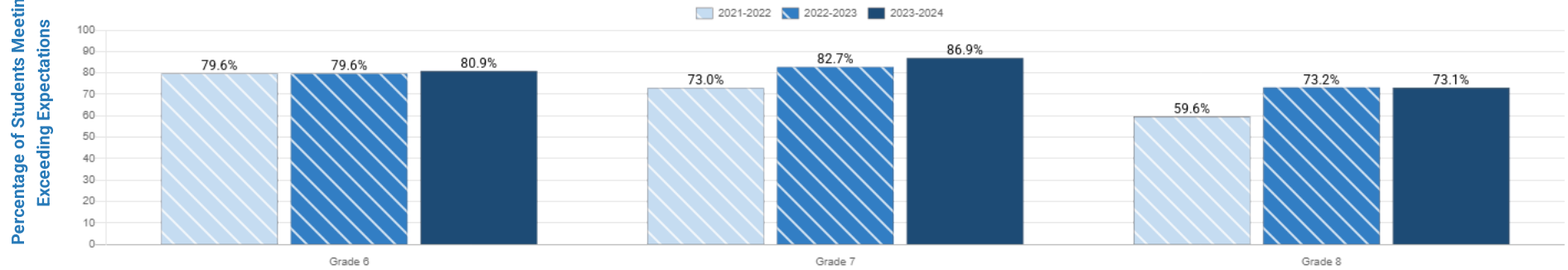

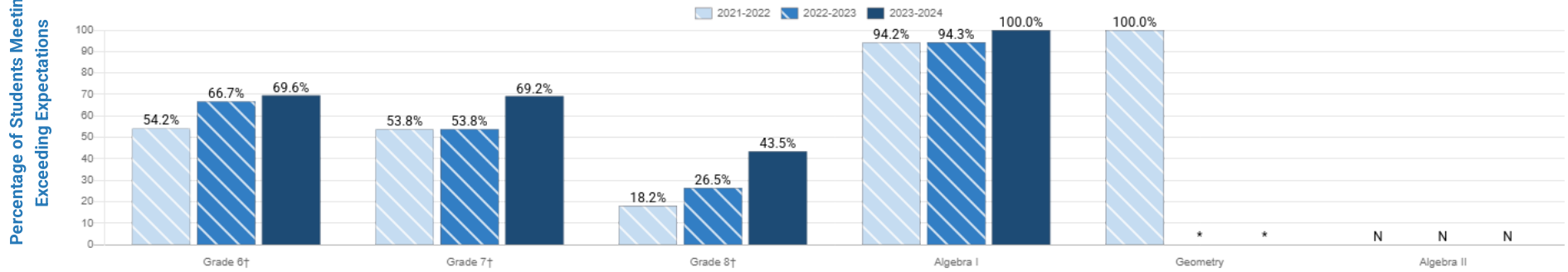

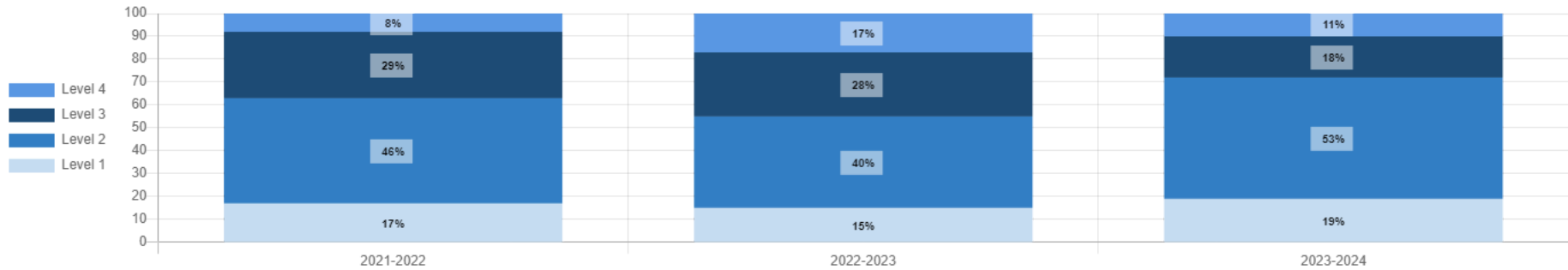

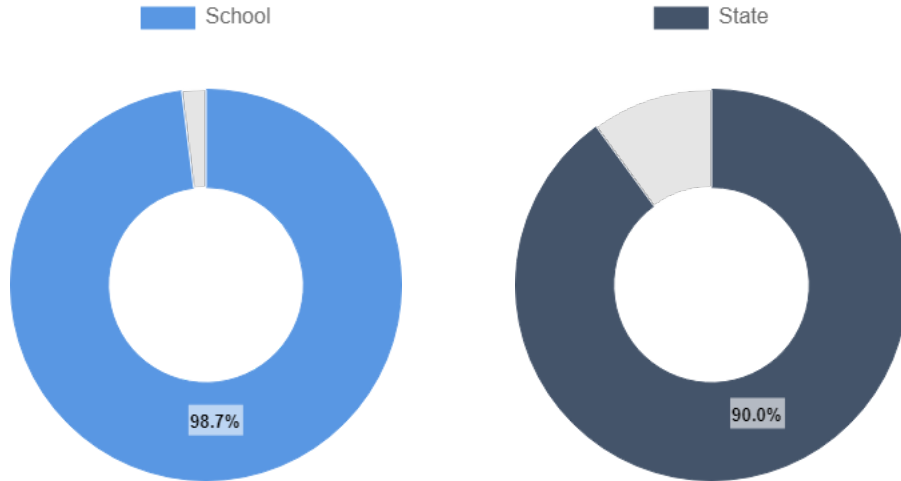

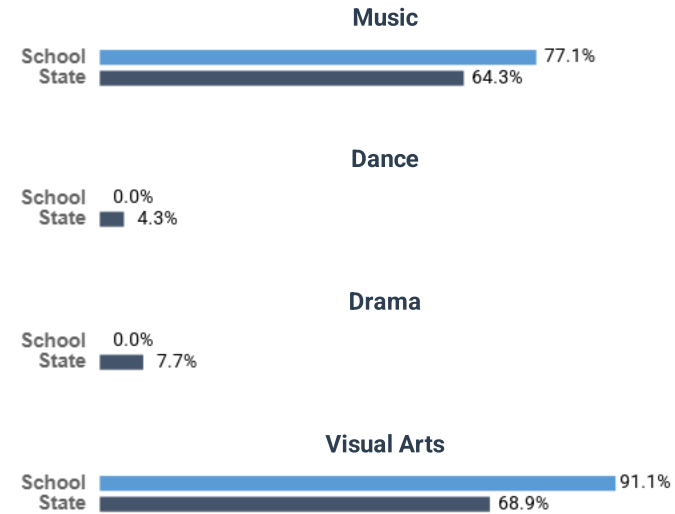

Students enrolled in one or more classes by discipline:



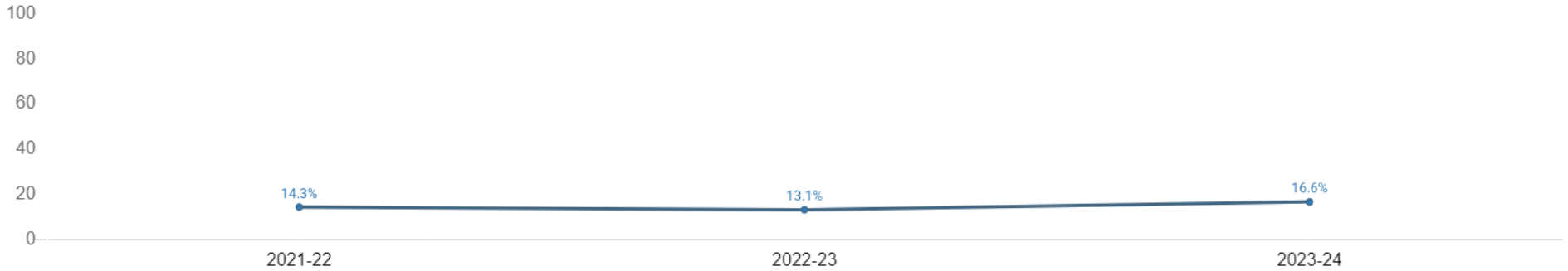

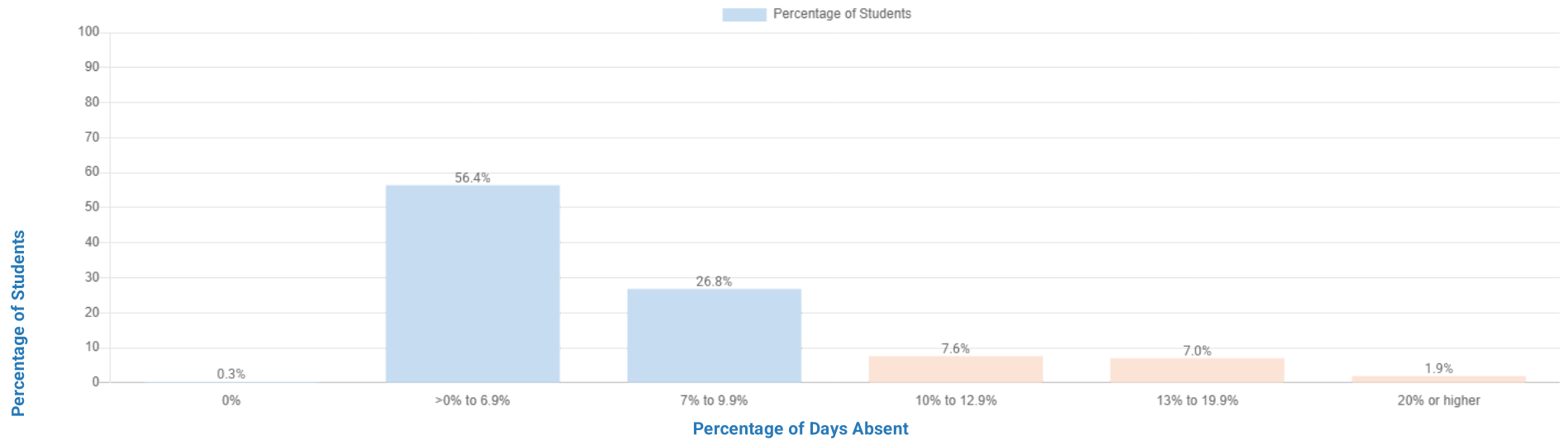

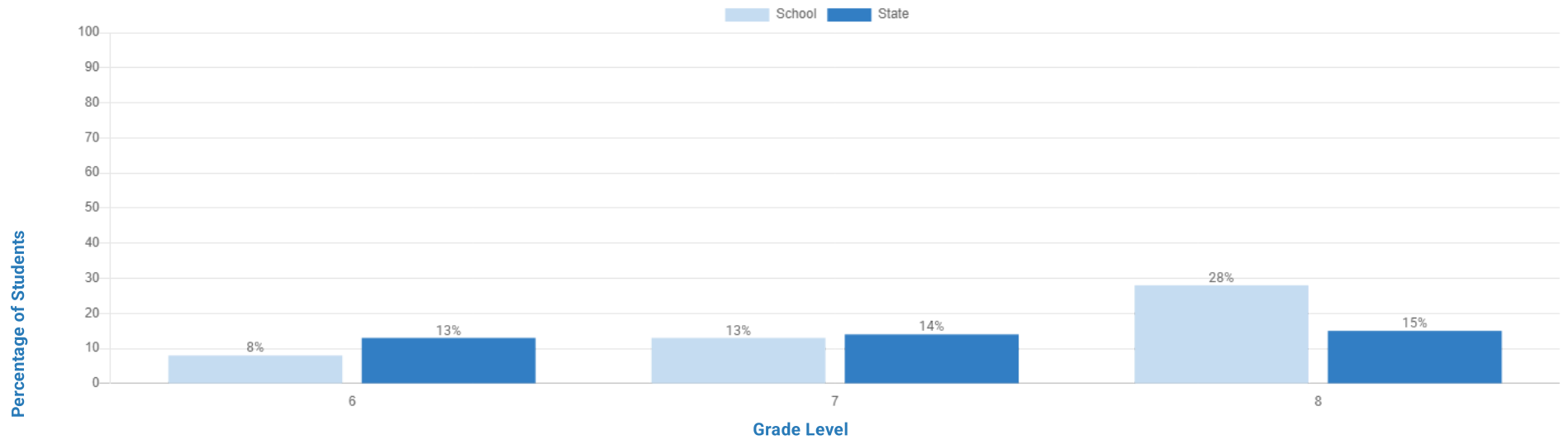

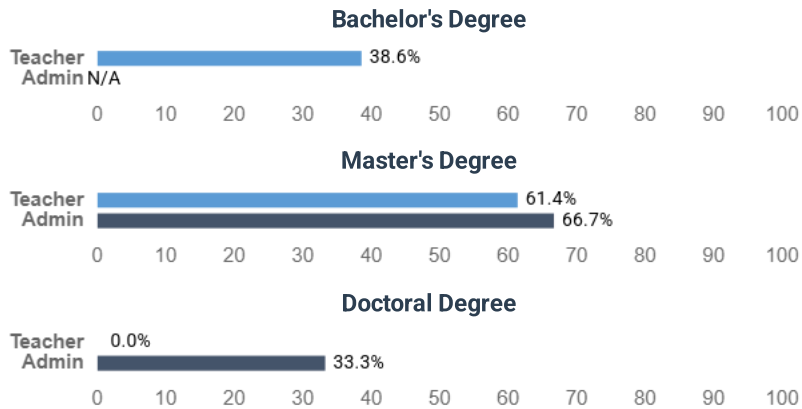

Schools are identified for ATSI if they have at least one student group that has a summative score that would be in the bottom 5% of Title I schools if it was its own school. Schools are identified for TSI if they have at least one student group that missed annual targets or standards for all indicators for two years in a row. Only student groups that have data for at least 20 students are included in the accountability determinations.

The NJDOE identified schools for ATSI status based on data from the 2022-2023 school year, so schools will not be identified for ATSI status based on data from the 2023-2024 school year. The table below will show the summative score for each student group, but it will not show a cut-off score or indicate that a student group has been identified for ATSI status since it is not an identification year.

Schools will be identified for TSI status based on data from the 2023-2024 school year, since that is required annually. The remaining columns in the table show whether each student group met annual targets or standards for all indicators for the 2023-24 school year. If at least one student group did not meet all targets and also did not meet all targets in the 2022-23 school year, then the school will be identified as requiring TSI.

We are fortunate to be located adjacent to the beautiful Bucks Mill Park which allows our students to enjoy physical education classes outdoors during the fall and spring as well as experience outdoor science explorations which include water testing, ecology walks, and marine life analysis.



School Safety:

The safety and security of our students remains a priority for Colts Neck Township Schools. Board of Education Policies and Regulations are strictly adhered to for purposes of maintaining this priority. The Board of Education continues to support a whole-child approach to safety and security by providing resources for facilities improvements, personnel, and infrastructure upgrades that support social and emotional learning, mental health, security, and safety. In addition to district personnel, we have a team of security monitors with law enforcement experience and a Class III Special Law Enforcement Officer at each school.

We also offer Innovation Lab to all students as an additional opportunity to foster creativity and explore new technologies through the lens of "real life" applications. Cedar Drive Middle School proudly sponsors an annual, statewide robotics competition each spring and hosts local scientists and engineers who are active contributors in their respective fields as part of the Girls In STEM Luncheon.

Our language arts literacy curriculum has been designed to reflect the Teachers College Readers and Writers Workshop approach and is aligned to the New Jersey Student Learning Standards. Our math program consists of both regular and advanced courses which foster a sense of self-confidence and excitement about mathematics through promoting the ability to reason, construct mathematical ideas, and apply problem-solving strategies. In science, hands-on laboratory investigations are offered, as well as inquiry-based learning experiences so that students are motivated to seek knowledge, information, and meaning through questioning and discovery. The social studies curriculum includes U.S. I, U.S. II and World History topics and incorporates non-fiction reading and writing strategies in an effort to enhance students ability to analyze and interpret informational text. Spanish and Italian are taught through an interpersonal approach and offered to all students on an alternate day schedule. Our related arts program includes art, music, chorus, explorations of 21st century technology skills, instrumental music, physical education, health, and communications arts. In addition, Cedar Drive offers opportunities to support the social, academic, and emotional development of every student through mentoring opportunities, team building initiatives ("Colt Connections"), and whole-school programs that help build a strong sense of connectedness among all members of the school community. Our goal is to empower students to believe in themselves as individuals and to realize the impact that their words and actions have on others.
