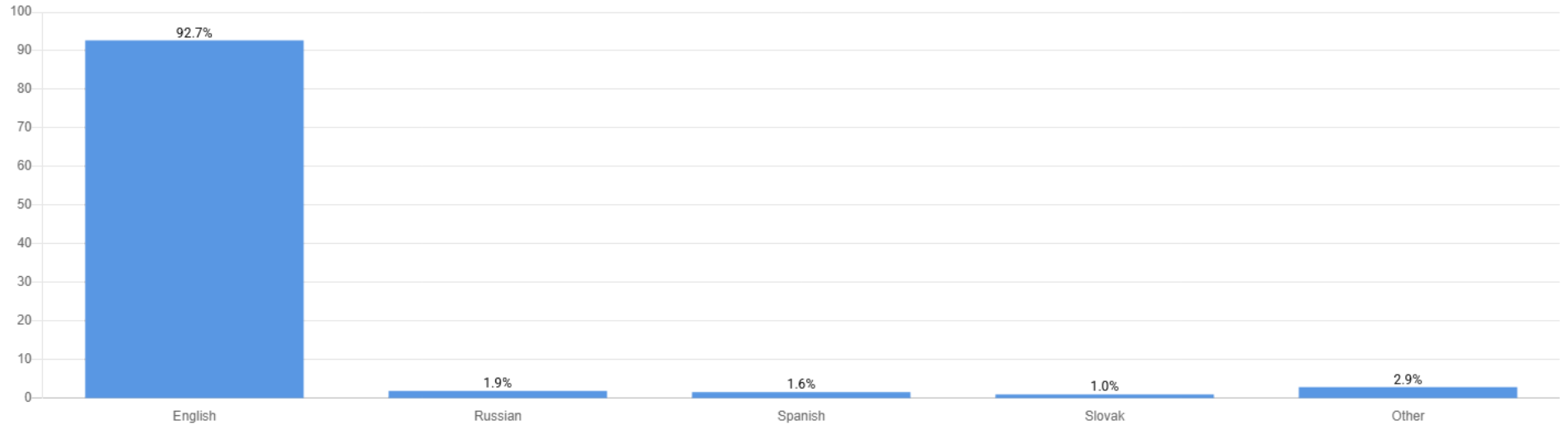

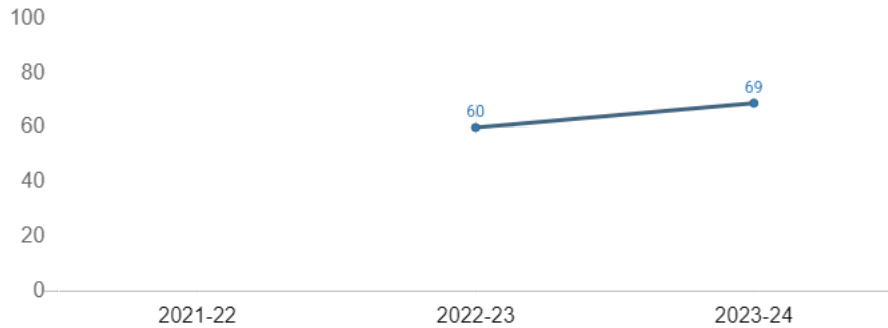

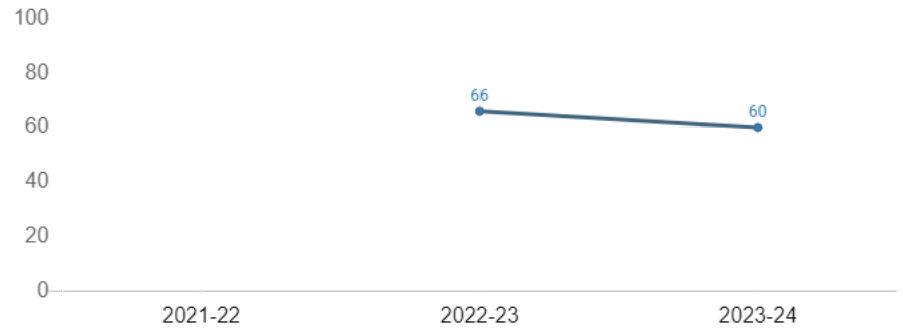

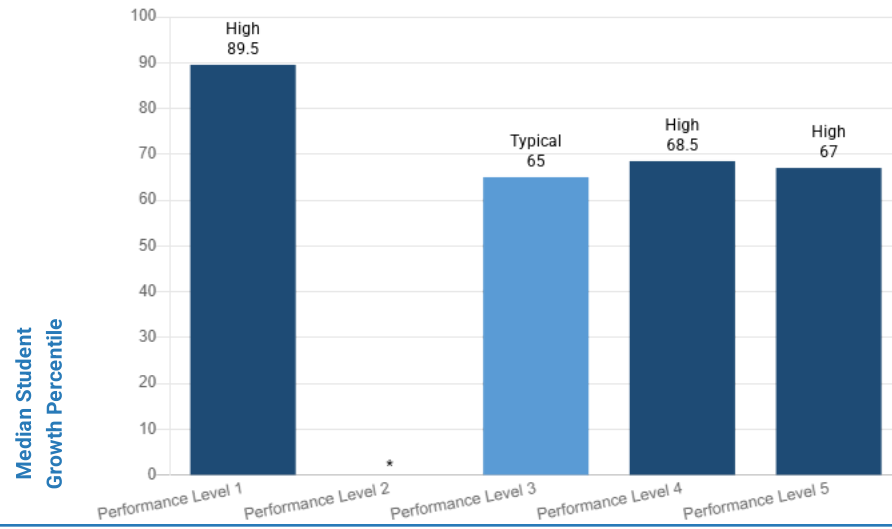

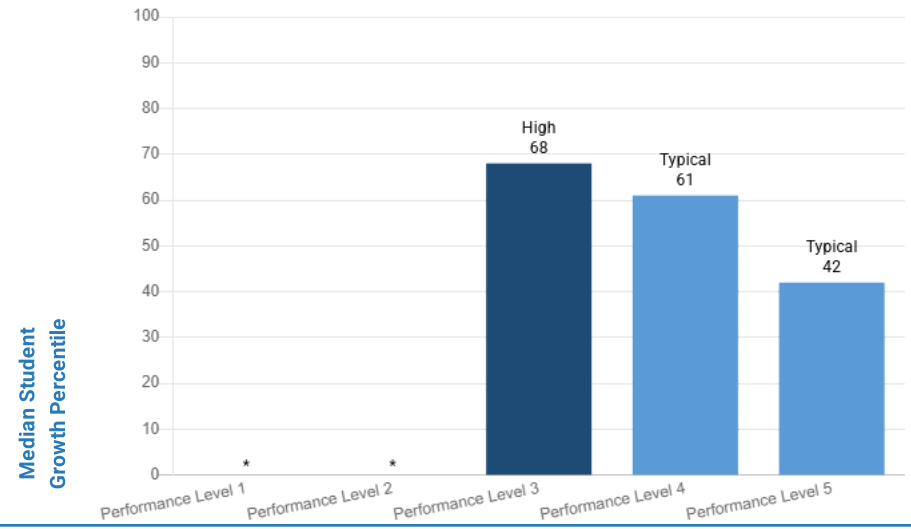

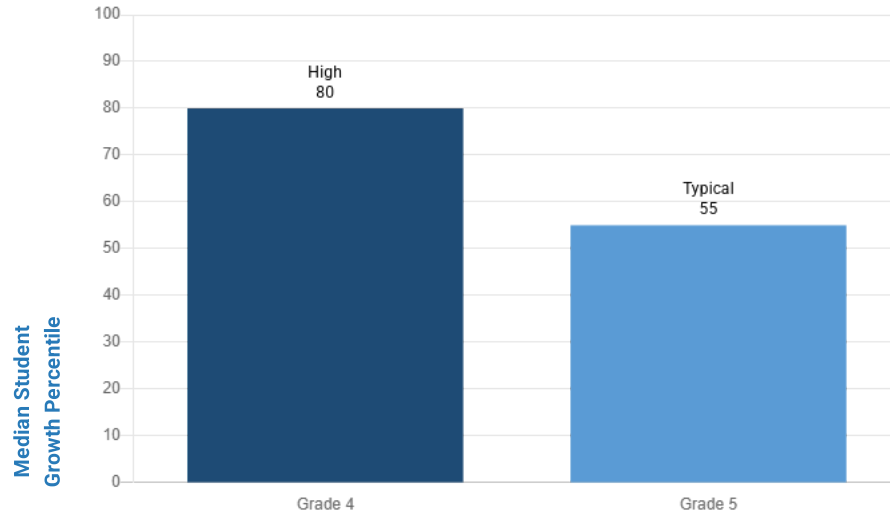

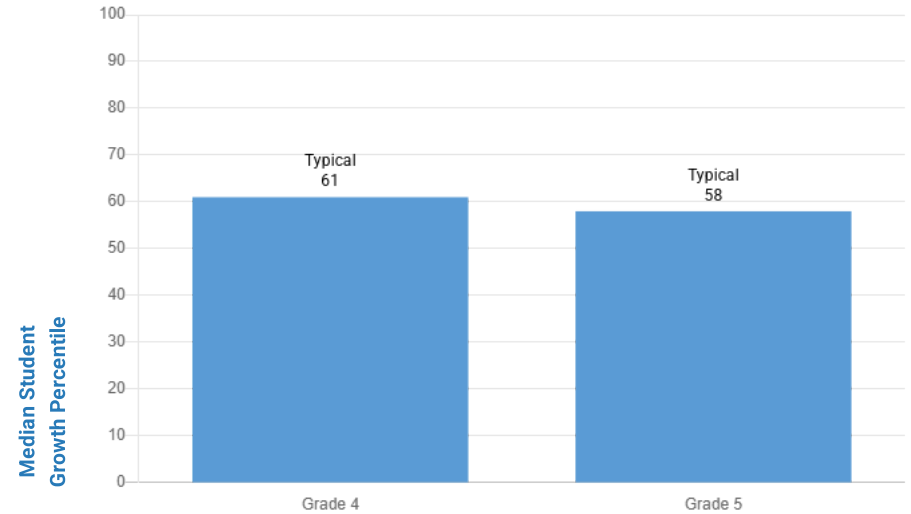

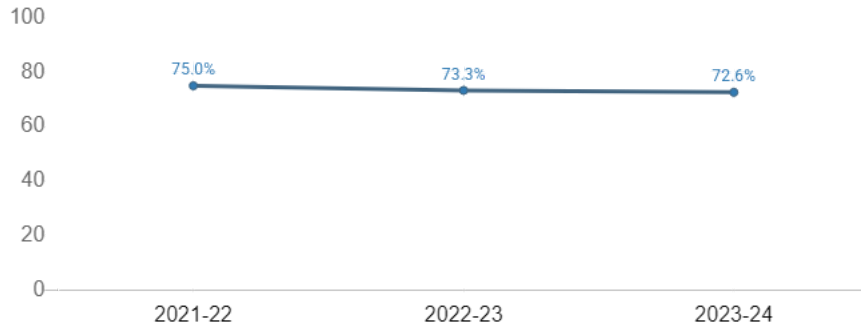

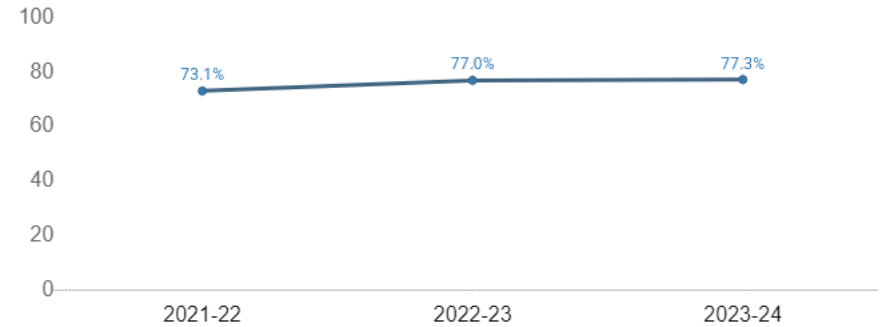
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. The data includes the results of students taking both the New Jersey Student Learning Assessment (NJSLA) and the DLM alternate assessment for English language arts (ELA) and mathematics. The Proficiency Rate for Federal Accountability measures the percentage of students who met or exceeded expectations on the assessments (NJSLA or DLM) with an adjustment made if the participation rate is below 95% to ensure reporting on at least 95% of students. 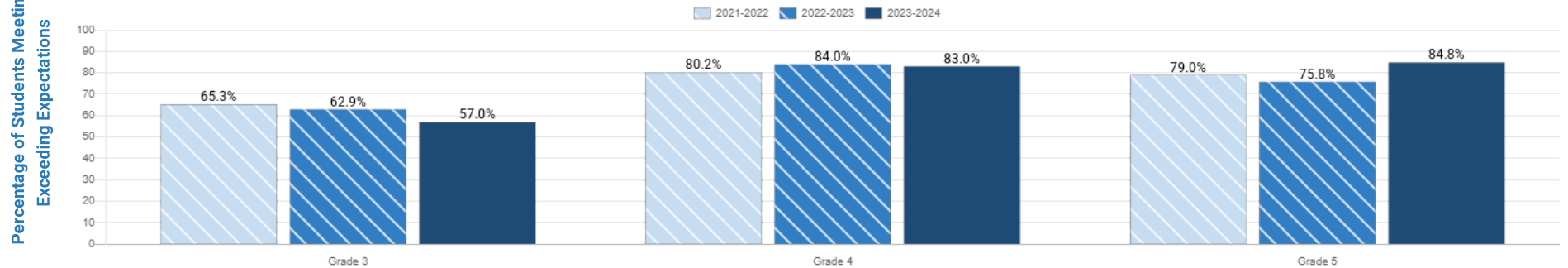

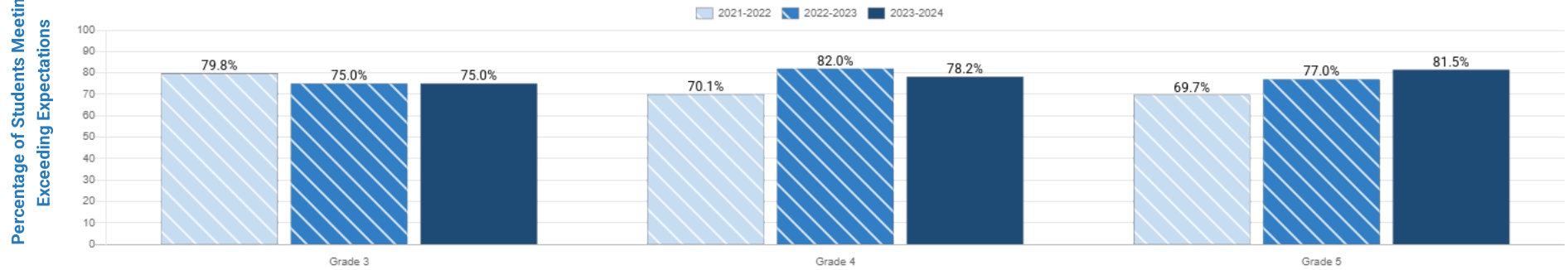

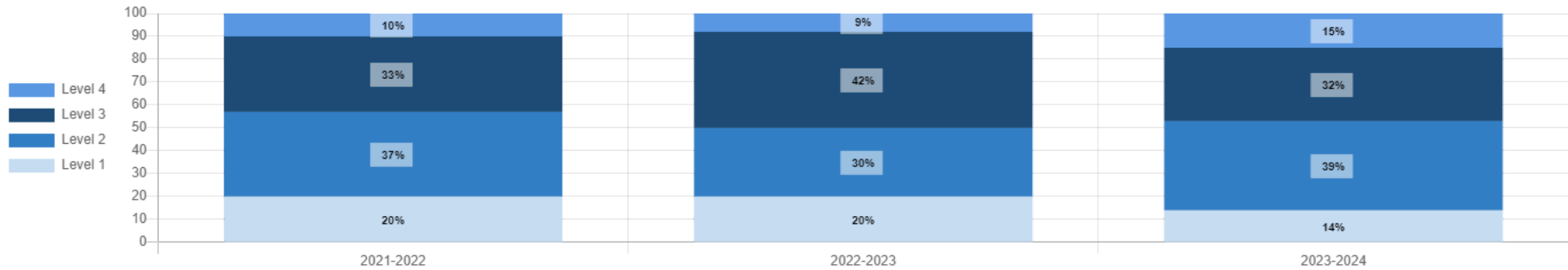

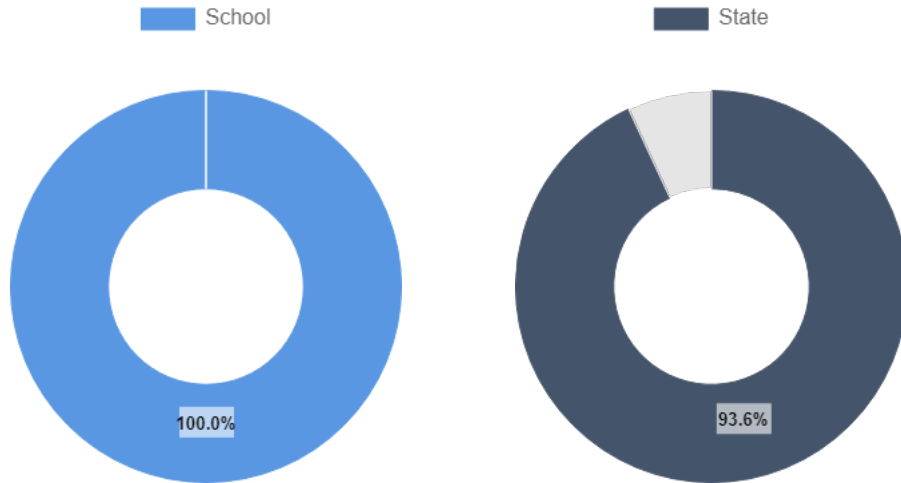

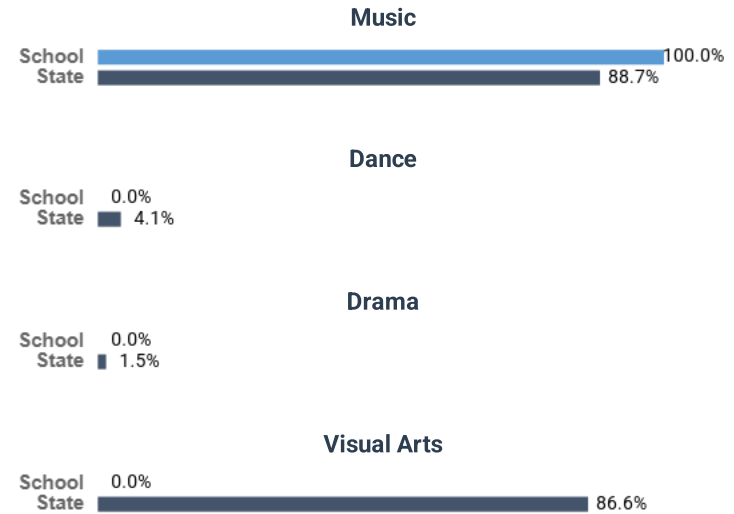

Students enrolled in one or more classes by discipline:



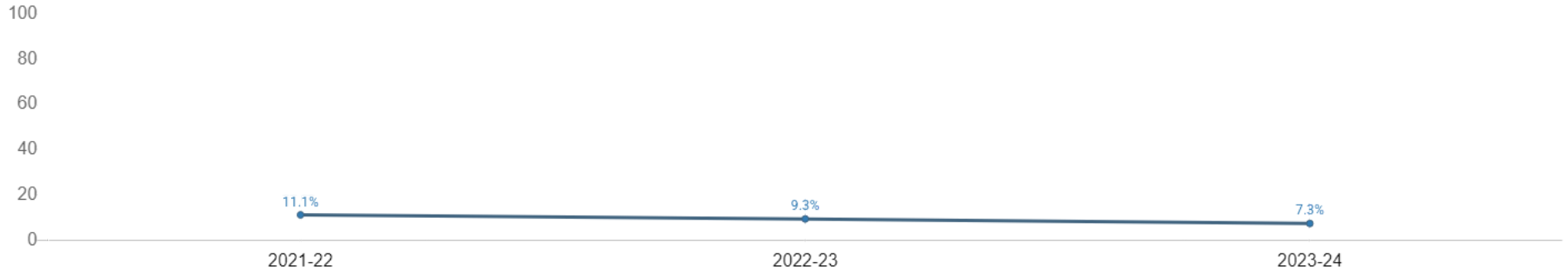

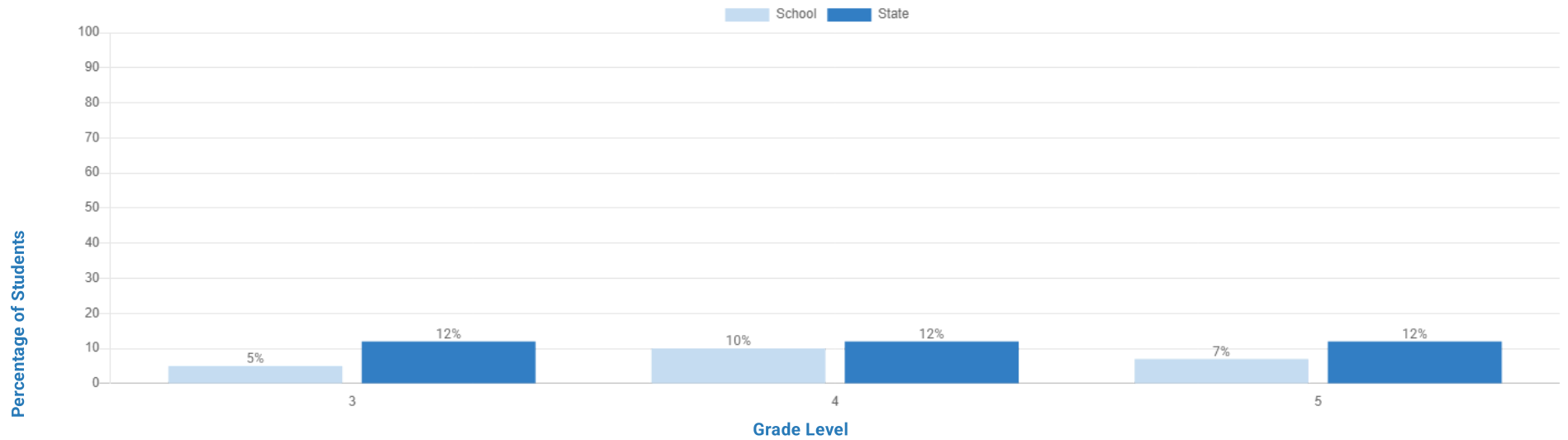

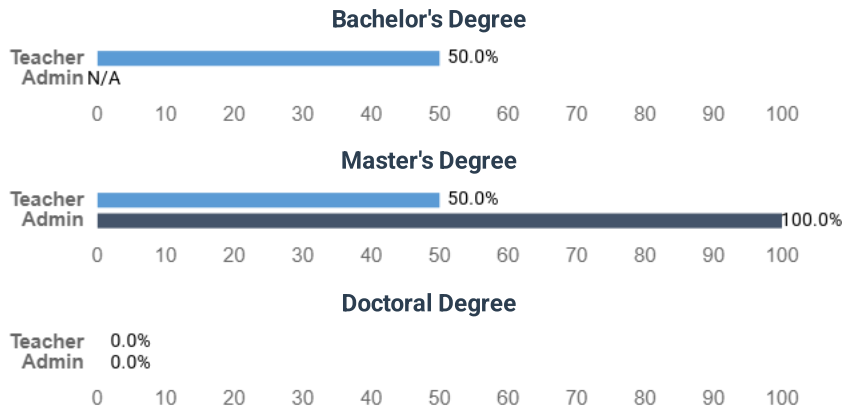

Accountability Summary by Student Group - 2023-24 School Year

- Literacy Instruction is modeled after the work of Being a Reader for Literacy and Columbia University's Writing Project.
- Our Math instruction is also differentiated with a focus on small group instruction to meet the needs of all of our learners.



Mission, Vision, Theme:

Conover Road Elementary School encourages children to become life-long readers, writers and mathematical thinkers. Our students are provided with opportunities to take risks and ask essential questions as they discover, create, and problem-solve in a myriad of learning experiences such as our iLab and SciLab. School culture is tantamount as we encourage strong connections to the greater community and offer a comprehensive club program after school hours.



Courses, Curriculum, Instruction:

Literacy instruction emphasizes comprehension, reading fluency and word study/Morphology. The "Science of Reading" is supported in our Being a Reader program that allows for word study, phonics, meaningful discussions, and Book Clubs/small group instruction. Our hands-on approach to mathematics in the enVision 2024 program allows students to discover operations and relationships before exposure to formal algorithms. Students use manipulatives and technology in all content areas to complement instruction. An inquiry-based approach is used in our science and social studies classes. Through hands-on, minds-on investigations, students become knowledgeable, thoughtful, humane citizens. A wide range of Related Arts offerings taught by content-area specialists promotes an understanding of areas such as Science Enrichment, Physical Education, Health and Wellness, Art, Music, Library/Media, World Language, and Innovation Lab.
