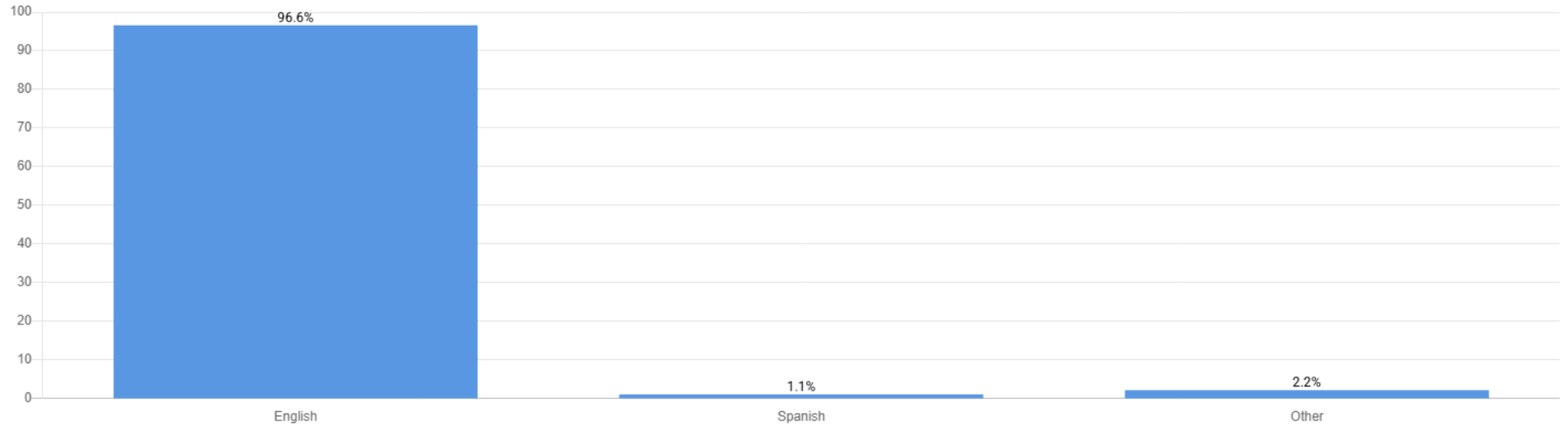

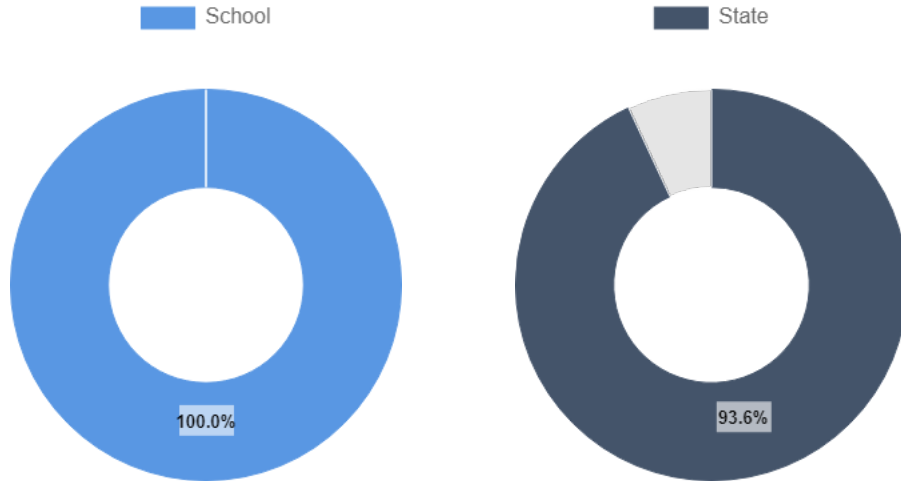

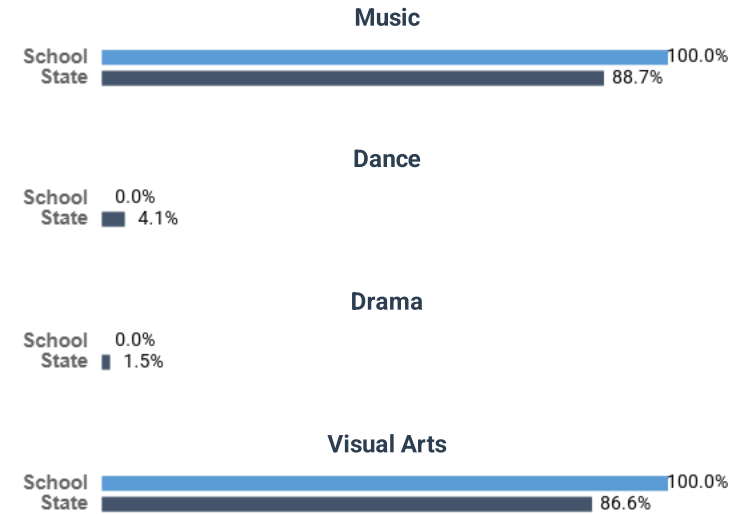

Students enrolled in one or more classes by discipline:



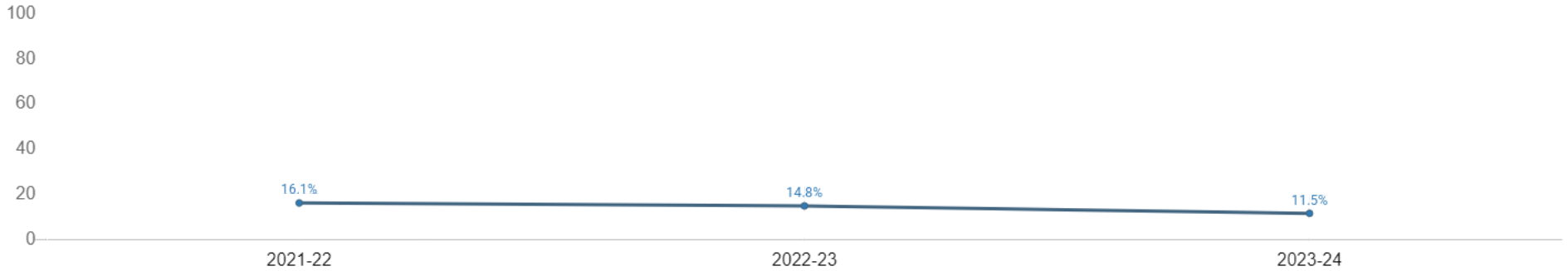

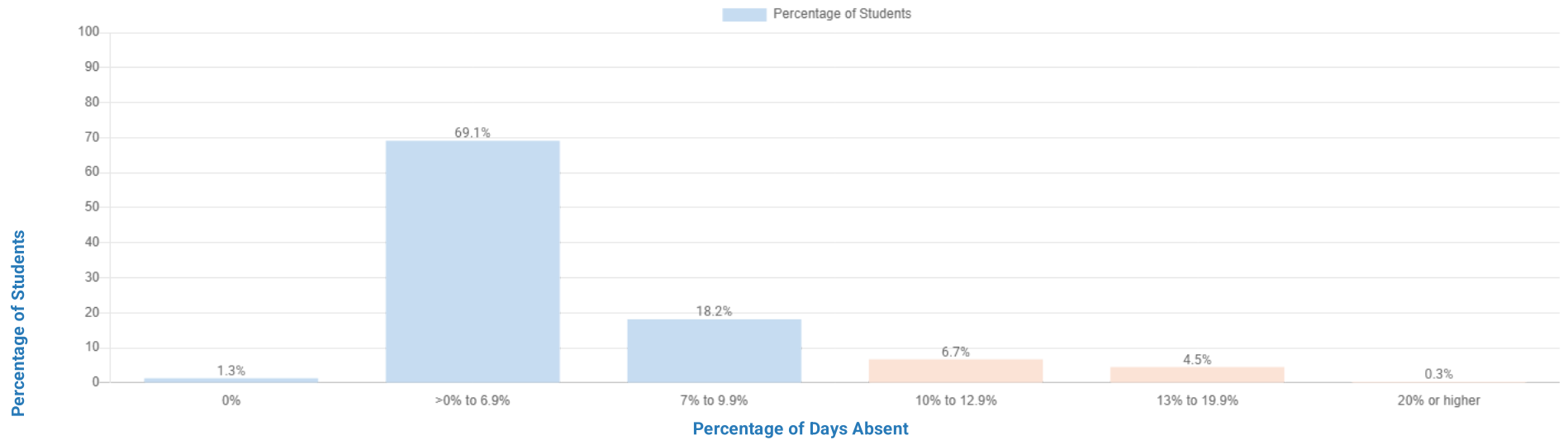

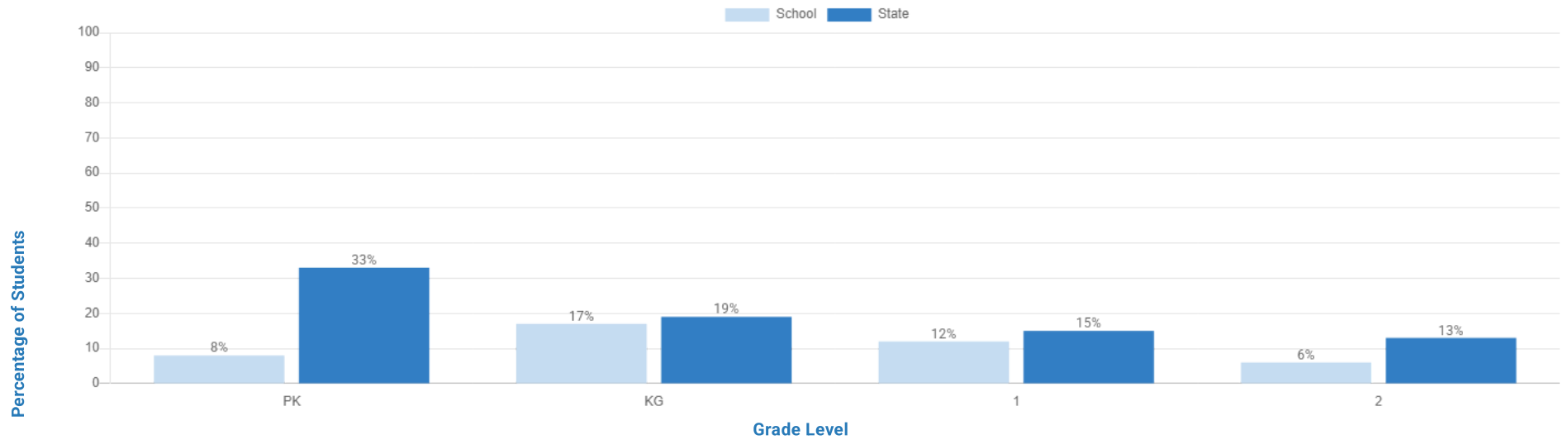

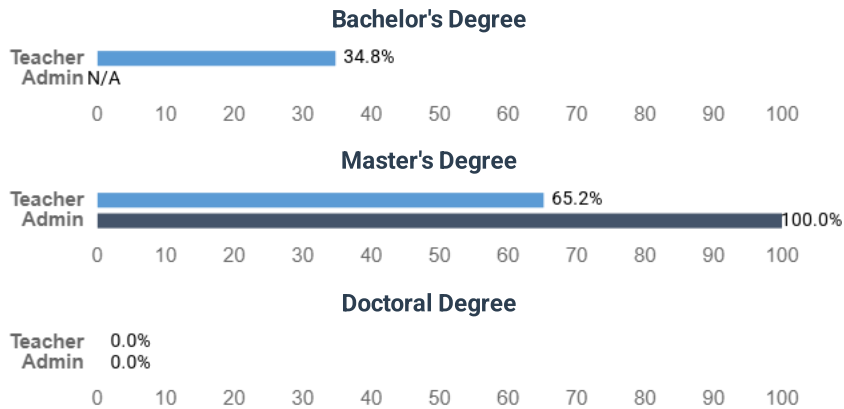

Accountability

New Jersey's Every Student Succeeds Act (ESSA) Accountability System New Jersey's school accountability system identifies schools in need of comprehensive and targeted support as required by the Every Student Succeeds Act (ESSA). Based on New Jersey's [approved ESSA state plan](#), NJDOE will identify schools in the following four federal categories every three years:

- **Comprehensive Support and Improvement (CSI): Overall Low Performing:**
 - Title I schools with a summative score in the bottom 5% of Title I schools.
- **Comprehensive Support and Improvement (CSI): Low Graduation Rate:**
 - All high schools with a four-year graduation rate of 67% or less
- **Additional Targeted Support and Improvement: Low Performing Student Group (ATSI):**
 - All schools with one or more student group with a summative score that would be in the bottom 5% of Title I schools
- **Comprehensive Support and Improvement (CSI): Chronically Low Performing:**
 - Title I schools identified as Additional Targeted Support and Improvement; Low Performing Student Group (ATSI) that are identified for three or more consecutive years, i.e., ATSI schools that do not meet exit criteria.

Annually, NJDOE will identify schools in the following federal category:

- **Targeted Support and Improvement: Consistently Underperforming Student Group (TSI):**
 - All schools with one or more student groups that missed annual targets or standards for all indicators for two years in a row

For purposes of ESSA accountability, only schools and student groups with data for 20 or more students are included in calculations.

The NJDOE identified schools for CSI and ATSI status in fall 2023 based on data from the 2022-2023 school year, so the NJDOE did not identify schools for CSI or ATSI status based on 2023-2024 school year data. The NJDOE only identified schools for TSI status based on data from the 2023-2024 school year.

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. Schools are identified for ATSI if they have at least one student group that has a summative score that would be in the bottom 5% of Title I schools if it was its own school. Mission, Vision, Theme:

Conover Road Primary School encourages children to become life-long readers, writers and mathematical thinkers. Our students are provided with opportunities to take risks and ask essential questions as they discover, create, and problem-solve in a myriad of learning experiences. The acquisition of literacy is central to learning and the development of lifelong communication skills. Instruction is tiered and differentiated so that each learner is appropriately challenged.



Courses, Curriculum, Instruction:

Literacy instruction emphasizes phonemic awareness, comprehension, and reading fluency. The "Science of Reading" is supported in our Being a Reader program that allows for word study, phonics, meaningful discussions, and leveled readers. Our hands-on approach to mathematics in the enVision 2020 program allows students to discover operations and relationships before exposure to formal algorithms. Students use manipulatives and technology in all content areas to complement instruction. An inquiry-based approach is used in our science and social studies classes. Through hands-on, minds-on investigations, students become knowledgeable, thoughtful, humane citizens. A wide range of Related Arts offerings taught by content-area specialists promotes an understanding of areas such as Science Enrichment, Physical Education, Health and Wellness, Art, Music, Library/Media, World Language, and Innovation Lab.

Before and After School Programs:

The Colts Neck Township School District offers daily before and after school care, through the YMCA of Greater Monmouth County. Beginning at 7:30 a.m., children enjoy opportunities for games, thematic projects, and crafts before being escorted to their classrooms. At the conclusion of the day, children may work with YMCA staff on homework, enjoy the playground, or small group activities. The program concludes at 6:30 each evening.



Staff and Professional Learning:

Staff members of CRPS are proactive contributors to our Professional Learning Community. Department/grade level teams pursue Professional Development workshops; engage in professional "book clubs"; and have regular dialogue with administrators regarding student progress/data and curriculum. Teachers at grade level teams have daily common planning time to collaborate on team events and curricula.



Student Supports and Services:

Our Targeted Enrichment Program (TEP) is offered to qualifying students who have shown a high degree of proficiency in ELA/Literacy and/or Mathematics. Students who may need additional attention in these areas may qualify to participate in our Targeted Intervention Program (TIP). Services are offered to English Language Learners. Qualifying students receive therapies in OT, PT, and Speech.

Student Health and Wellness:

Children at Conover Road Primary School participate in a daily outdoor recess, two Physical Education classes each week, and children in Grades K-2 participate in one Health class per week. To encourage a sense of community and positive emotional health, children join in daily classroom morning meetings using the "Responsive Classroom" methodologies. Additionally, teachers in grades PK-2 have daily "Mindful Moments" and movement breaks incorporated into daily classroom routines.



Parent and Community Involvement:

A strong partnership exists between home and school. Parents participate through the Colts Neck Parent Teacher Organization and individually to enhance the education of their youngsters. Parents volunteers assist in the classrooms, the library, art appreciation, and the Innovation Lab. The PTO has graciously brought cultural arts assemblies and stimulating programs to our children. Our district is also proud to partner with our Friends of Different Learners advocacy group which includes community and staff members and parents.



Climate Surveys:

Annually, Colts Neck Township Schools administers the New Jersey School Climate Survey to students (Grades 2-8), staff, and parents/guardians. Facilities:

Students and staff at Conover Road Primary School enjoy state-of-the-art amenities that fully support our district's mission and vision. Instructional spaces include an Innovation Lab, Science Enrichment Lab, Computer Lab, Reading Silo/Media Center, Music Room, and Art Room. Children have access to technology including iPads, Chromebooks, and Desktop computers. The grounds allow children to play on two playgrounds and enjoy shaded outdoor classrooms.



School Safety:

The district has a "School Safety Specialist" as well as a team of security monitors and each school building also has its own Class III Special Law Enforcement Officer on site. The students, staff, and community have a voice in our security procedures and we conduct both security and fire drills at least once per month. Our newly established Behavioral Threat Assessment Team reviews individual incidents on a case-by-case basis and provides interventions to support a child's overall wellness.



Technology and STEM:

The district's youngest learners are engaged with age-appropriate technology that supports their understanding of basic coding, digital citizenry, and keyboarding skills. Students are encouraged to use web-based programs to enhance their early learning skills and foster home-school connections. From iPads to Chromebooks, from their first year of entry into the district, students are exposed to digital learning platforms.

Conover Road Primary School offers a full-day tuition-based preschool program for children who are aged three or four years of age on or before October 1 of a given year. A full-day, tuition-free kindergarten is offered to all Colts Neck residents. Our expanded Innovation Lab and Science Lab offerings allow children to explore the Next Generation Science Standards and STEAM education as they develop and construct with magnetic building tiles; learn to code robots; and engineer solutions to real-world issues. A special emphasis is placed on making sure that every individual understands his/her importance in our school community. We embrace the Northeast Foundation's Responsive Classroom methodologies for Daily Morning Meetings, Logical Consequences, and Academic Choice.
