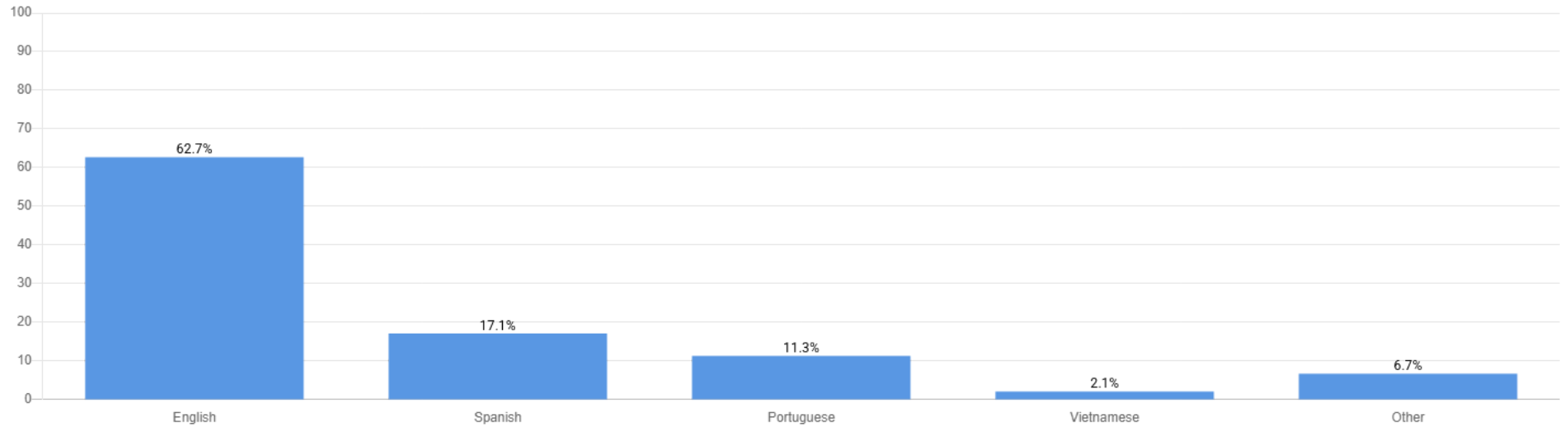

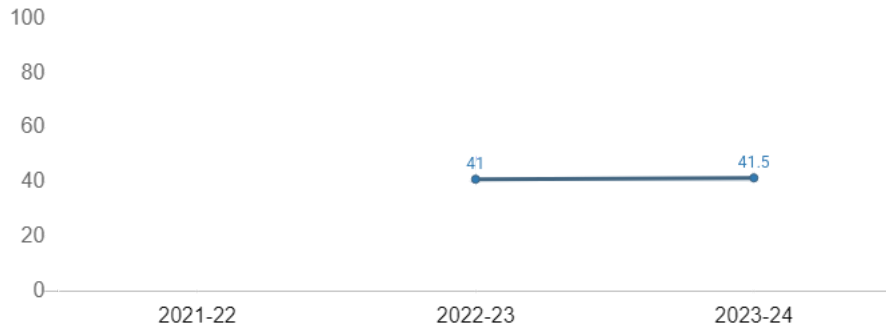

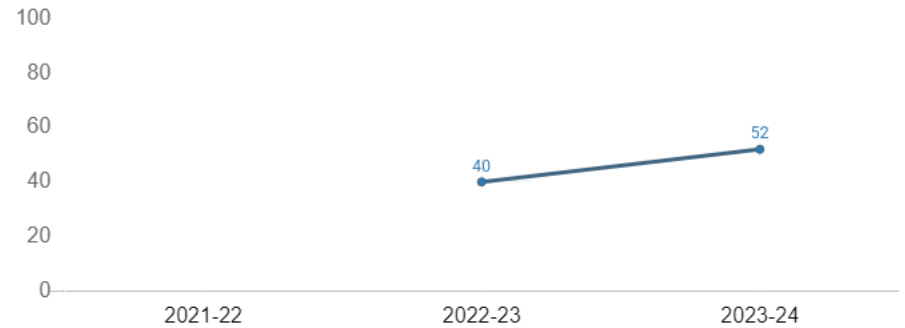

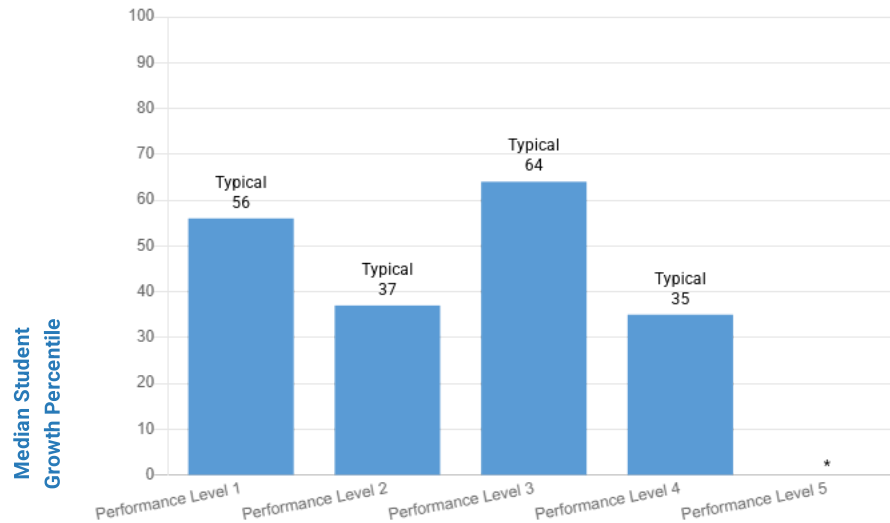

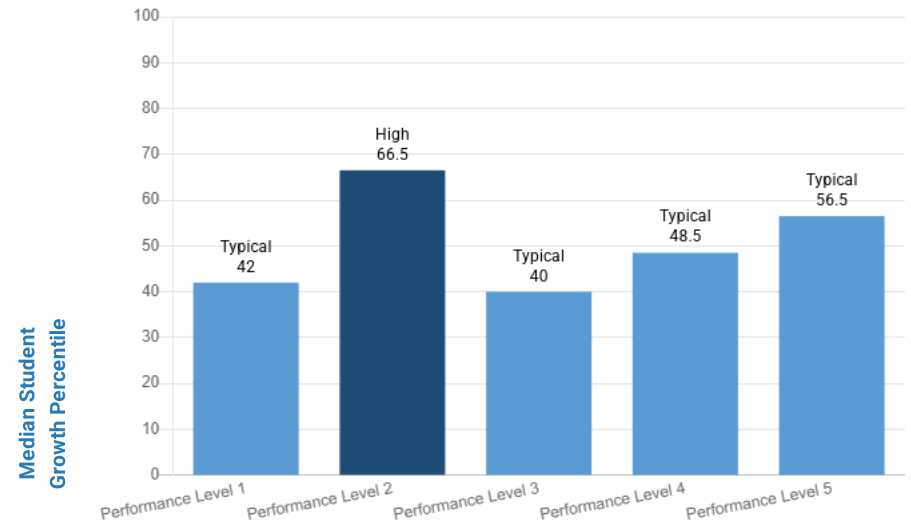

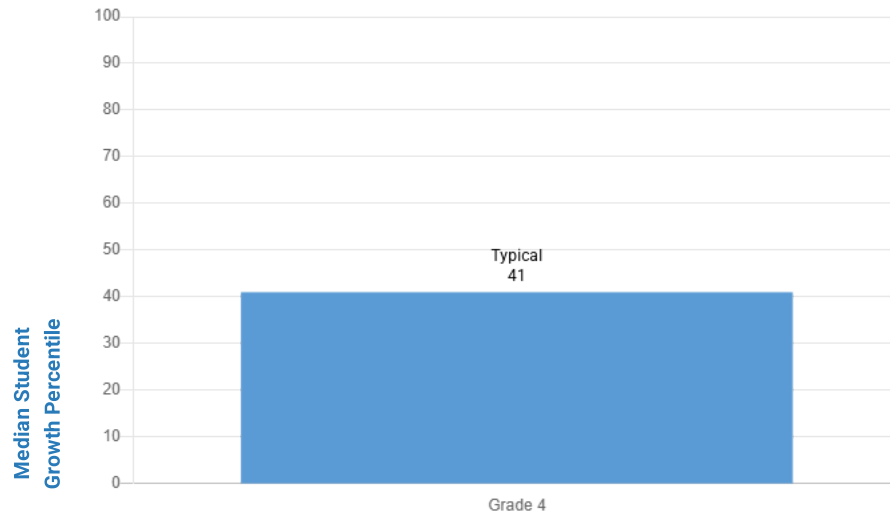

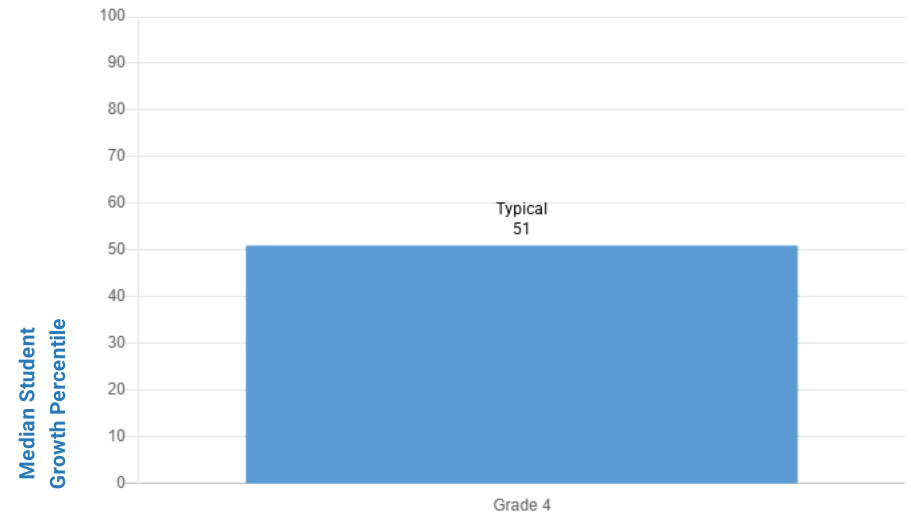

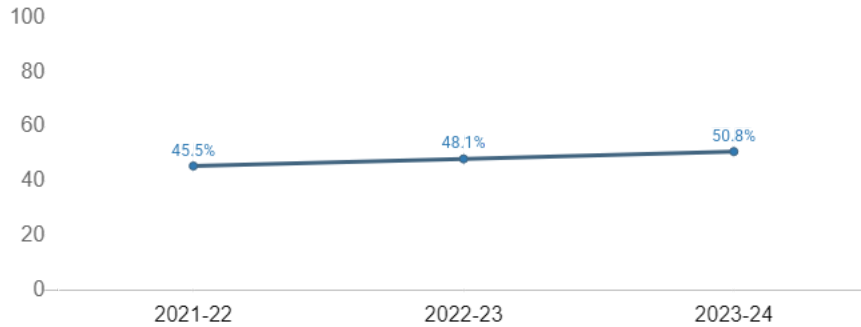

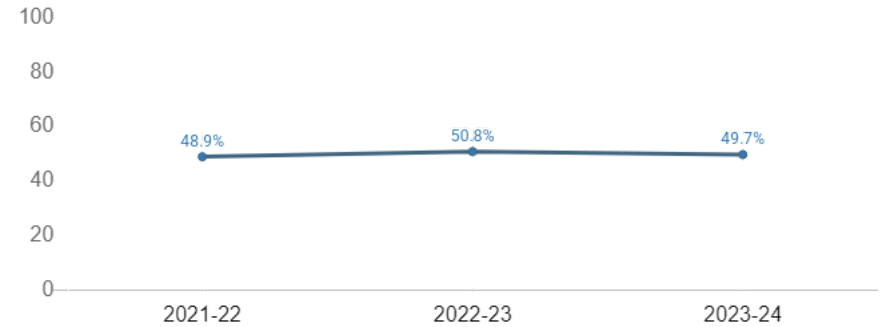
### English Language Arts and Mathematics Performance Trends

### English Language Arts Assessment - Participation and Performance

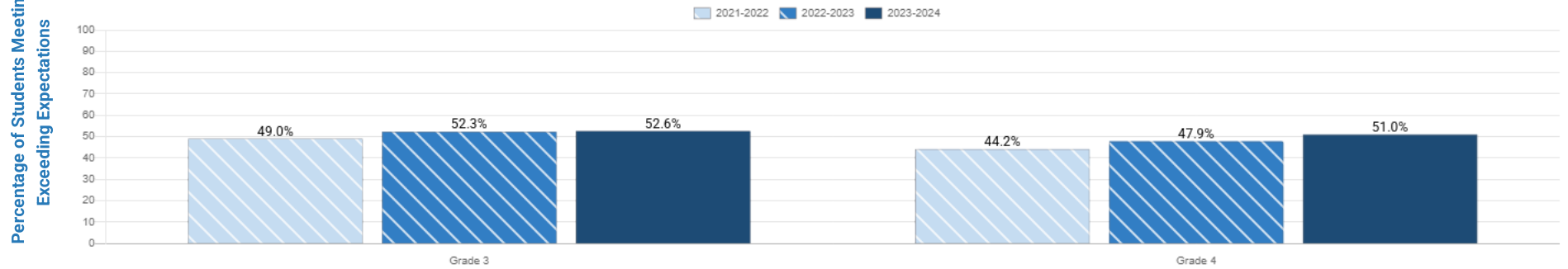

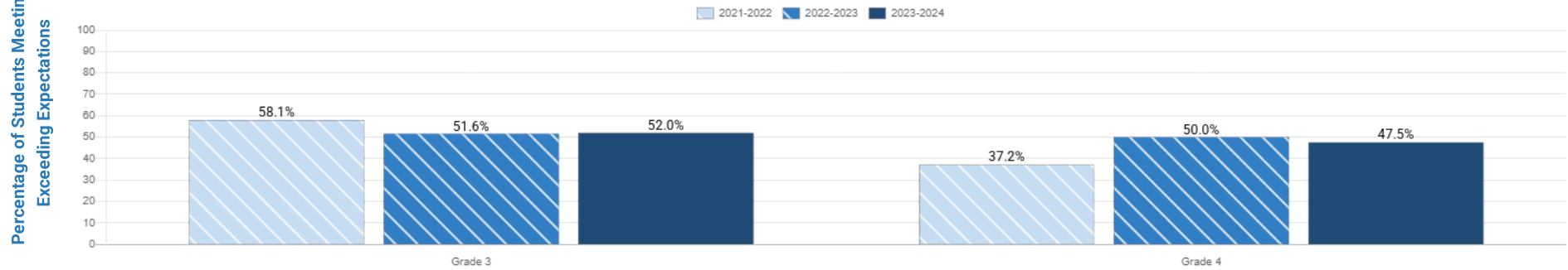

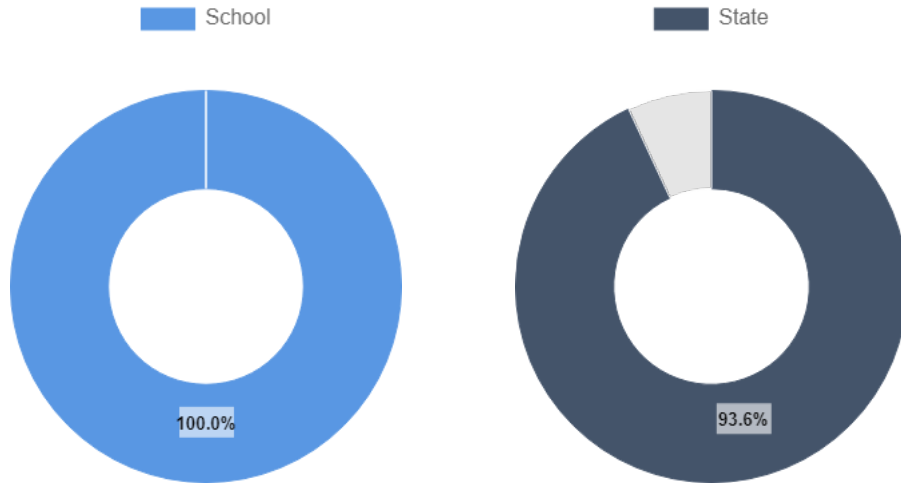

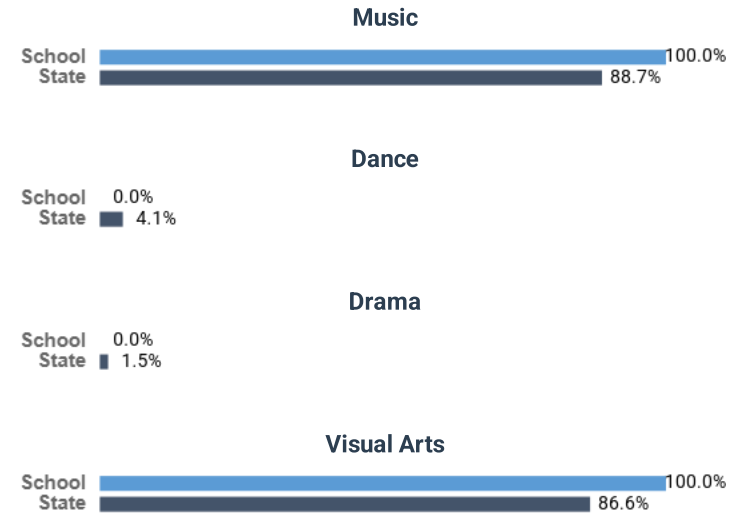

**Students enrolled in one or more classes by discipline:**



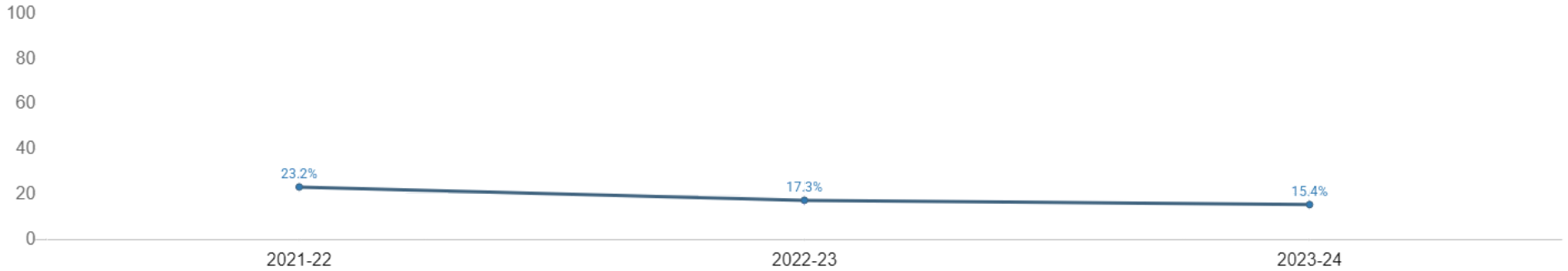

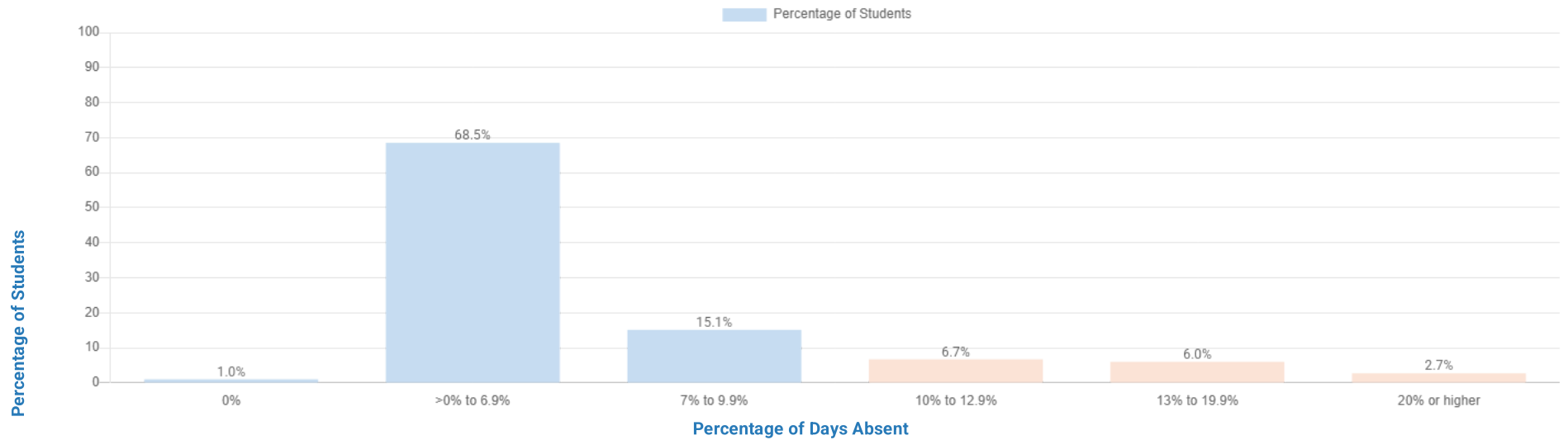

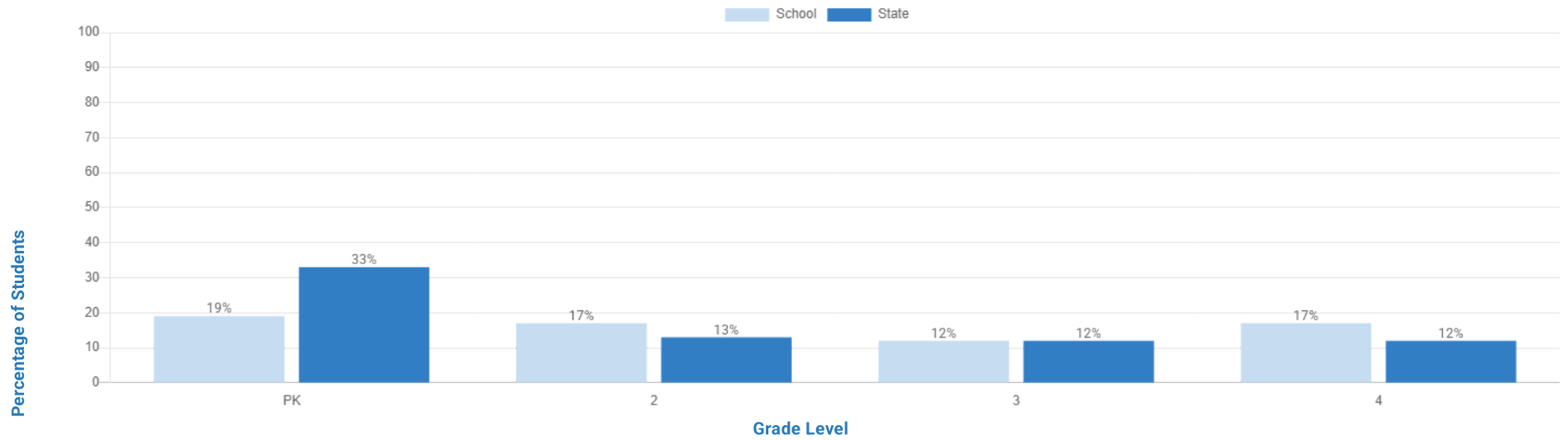

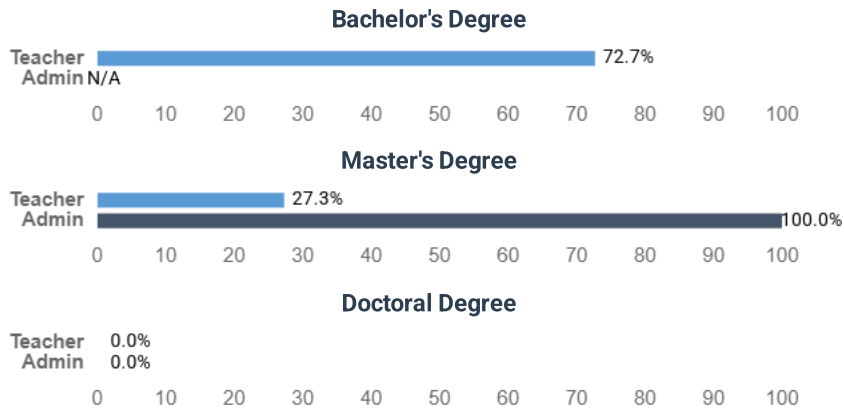

### Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. NJ SCI is an organization affiliated with Rutgers University and supports districts and schools to administer a school climate survey as well as develop school goals based upon the data. Each school analyzes the data and creates goals through the School Equity Team.



### Facilities:

Eatontown Public Schools has four schools. Each school in the district reflects the age level of the students housed within the building. In 2007, renovations were completed at each school in the district. The schools possess modern Heating and Air Conditioning Systems and recently updated their HVAC system to include GPS Ionization technology to purify building air exchange. The BOE takes pride in maintaining the schools and ensuring the schools are clean and safe. Each school is wired to support robust technology for both students and staff.

Woodmere is addressing chronic absenteeism with a Check-In, Check-Out (CICO) intervention designed for students whose attendance behaviors are unresponsive to Tier 1 practices and systems. Mentors reach out to parents of recommended students via a phone call to introduce themselves and the program. An outline was provided and permission slips were sent home. Mentors meet with individual students up to twice a week and set goals for attendance improvement. In addition, in conjunction with various school wide committees, Woodmere has implemented a school wide reward system for classes with high percentages of daily attendance. This is based on individual classroom data and class specific goals, set in part with student input. To start, one week goals were set, followed by 2 week goals. Beginning in the second marking period, and lasting throughout the remainder of the school year, monthly goals will be targeted and class rewards will be issued if their goal is met.

Woodmere School has a School Safety Team that meets several times a year and always looks for ways to improve the school as well as the climate. Technology also plays a big role in school. Technology is utilized as a daily instructional resource for both students and staff at Woodmere School. Our school is fully equipped with wireless internet access, 1:1 student and teacher laptops, and a state of the art communication system that directly links school security to local emergency officials. All classrooms in Woodmere School have interactive Smartboards which assist learn opportunities and experiences for our students and technology is utilized to hold virtual meetings, conduct research, enhance ELA and Mathematics skills and expand their knowledge base through the use of specialized, educational software.
