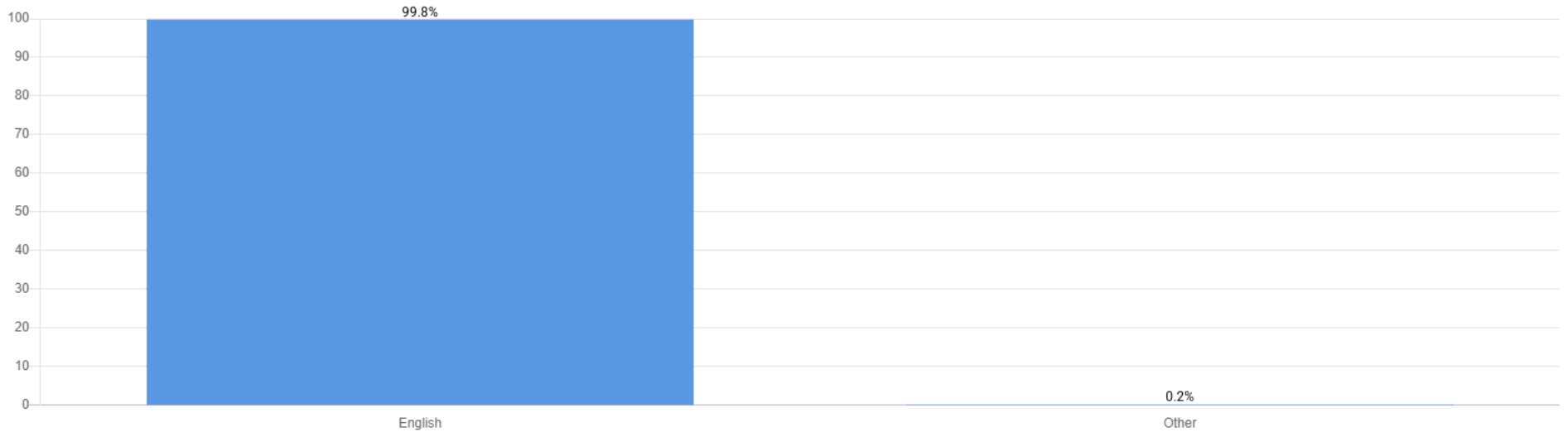

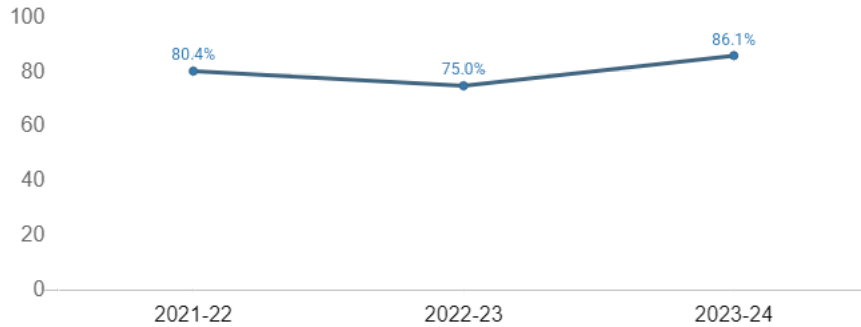

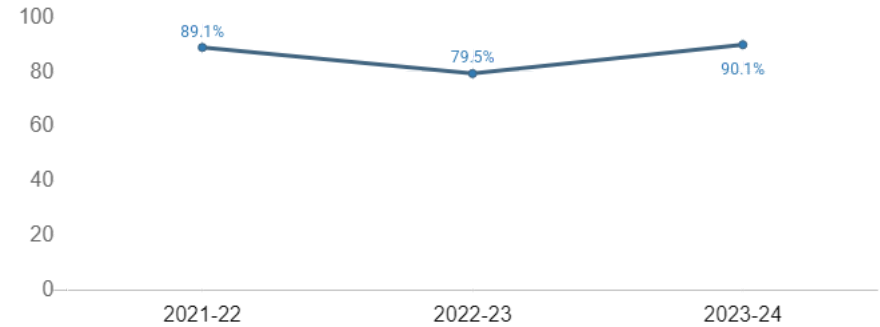
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. 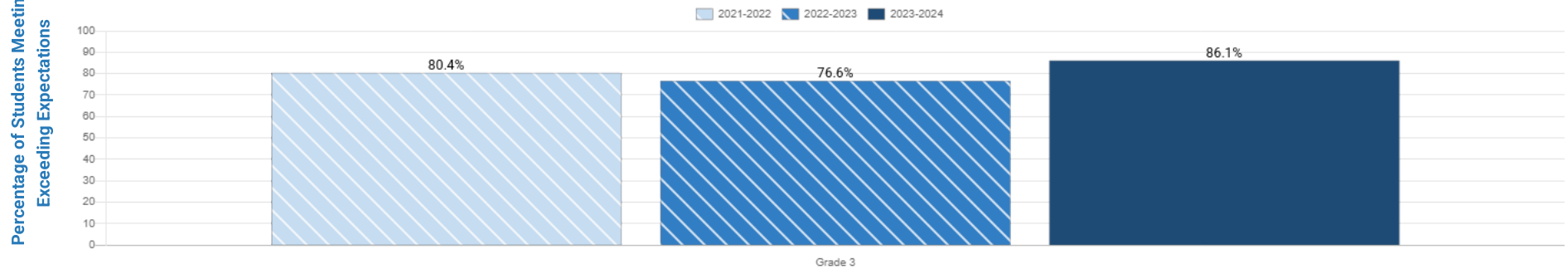

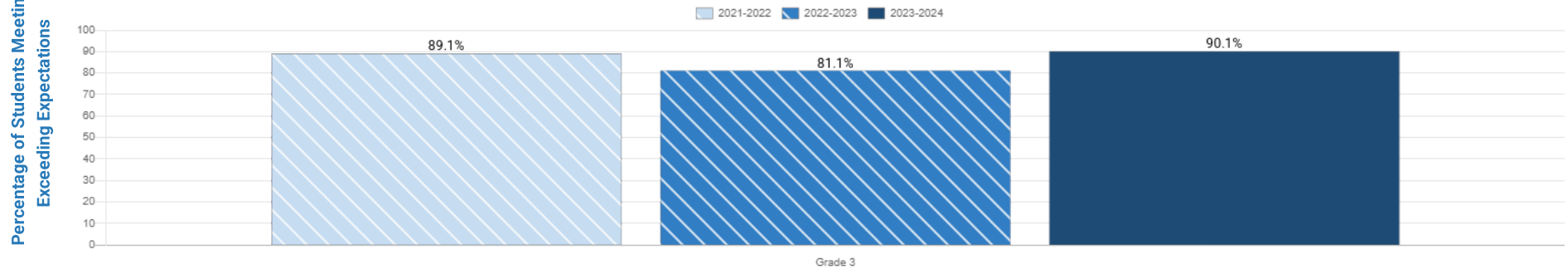

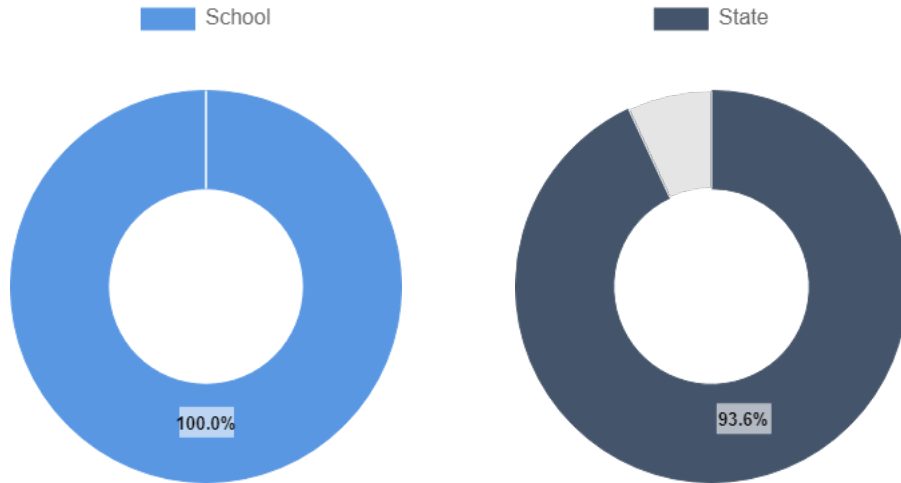

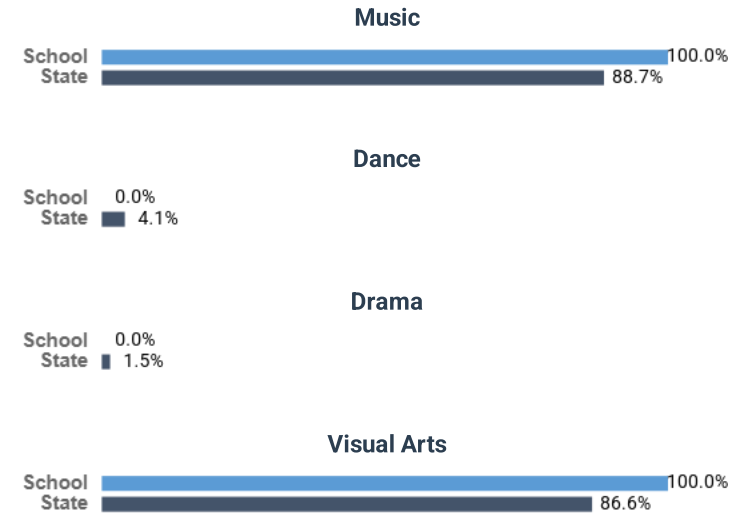

Students enrolled in one or more classes by discipline:



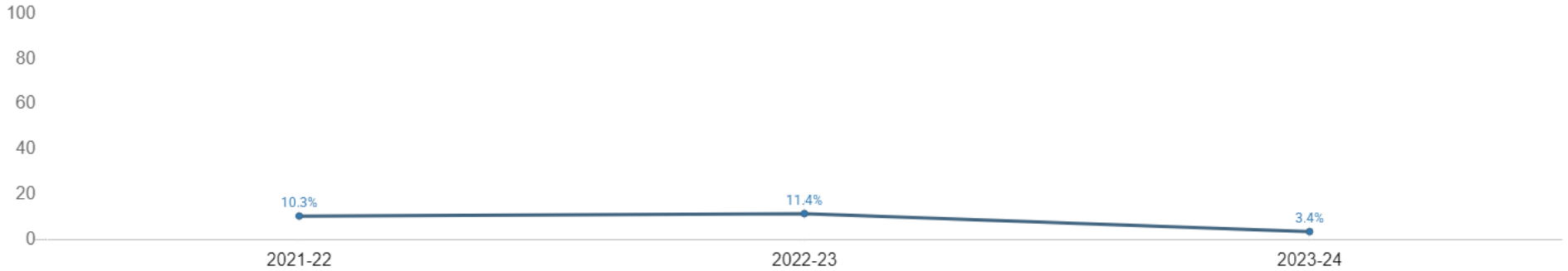
Climate and Environment

Student absences provide important information about a school's culture and climate. Research shows that absences impact a student's ability to succeed in school. The NJDOE used input from stakeholders to select chronic absenteeism as its measure of school quality and student success for the ESSA accountability plan. **Chronic absenteeism** is defined as being absent for 10% or more of the days enrolled during the school year. 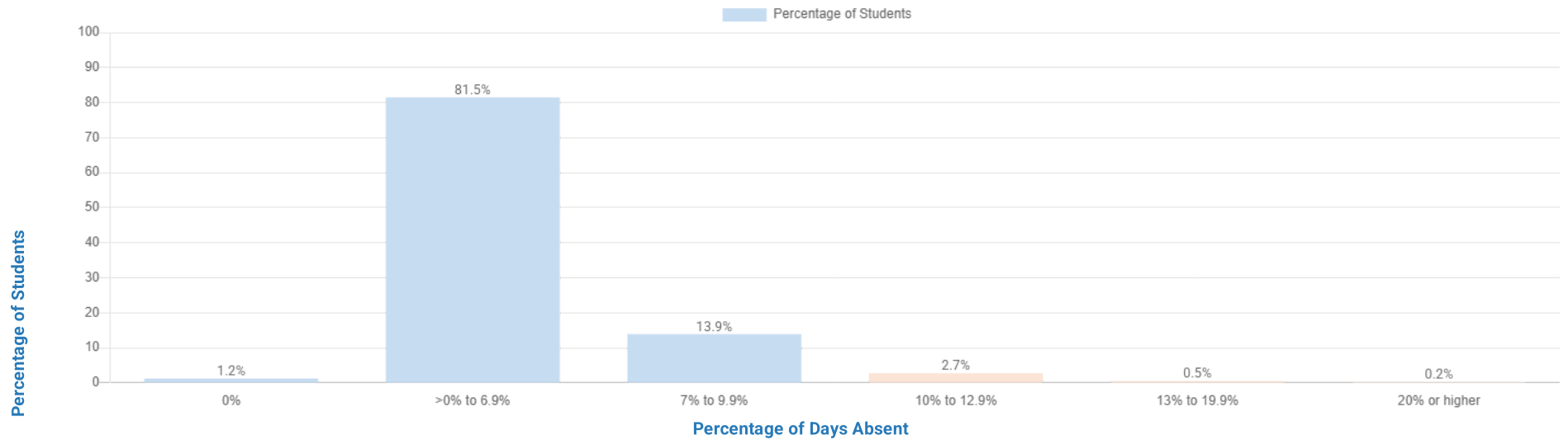

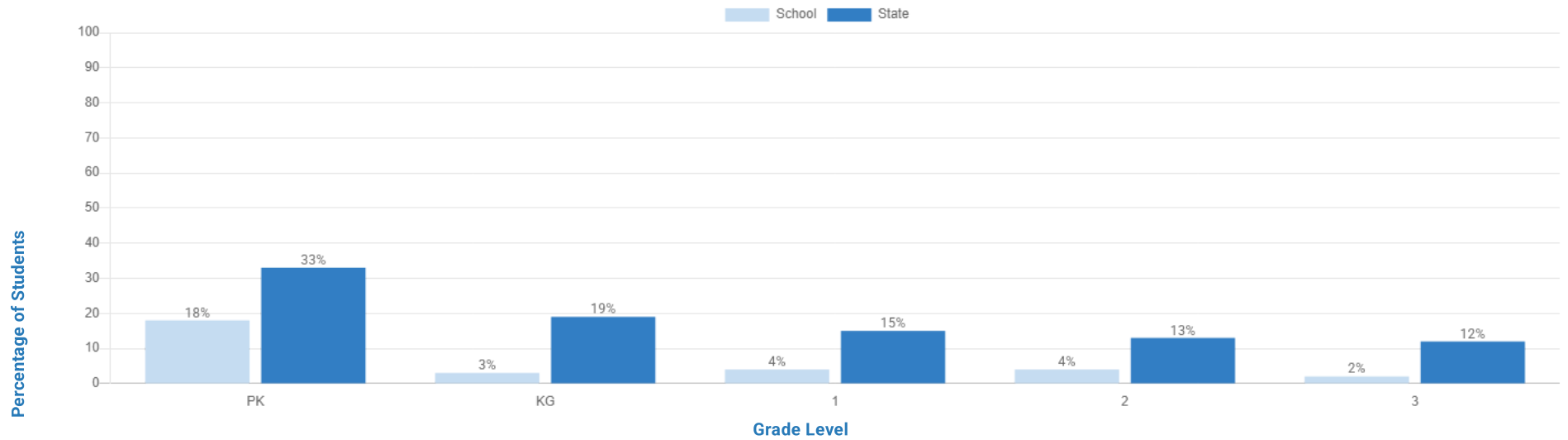

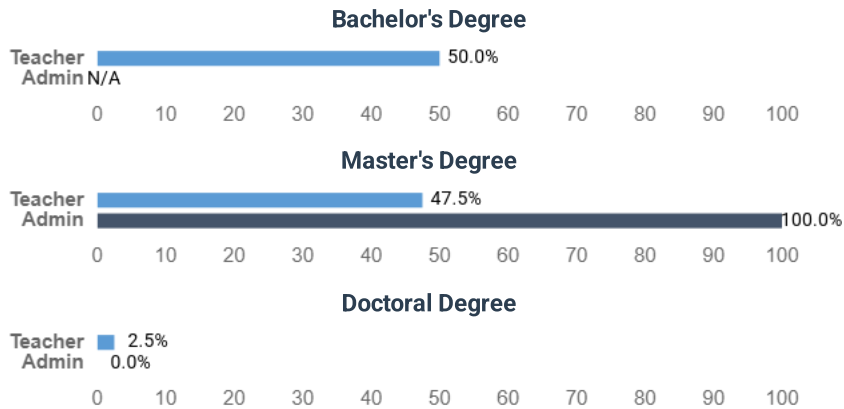

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. Mission, Vision, Theme:

The mission of the Viola L. Sickles School community is to educate children while accepting and nurturing the unique academic, social, emotional, physical and creative needs of the whole child in a supportive and collaborative environment.



Courses, Curriculum, Instruction:

Using a workshop model, daily mini-lessons in reading and writing occur. In addition, explicit, systematic phonemic awareness and phonics instruction occurs in a whole group setting. During the reading workshop, children eagerly practice individually and with partners while teachers work with small flexible groups to target instruction in phonemic awareness, phonics, fluency, comprehension, and vocabulary, based on assessments. Teachers monitor student selection of books based on the individual needs of each reader. Readers have access to a variety of texts including decodable and leveled text in all genres to allow them the sufficient practice that they need in order to bridge the reading process. During the writing workshop, children are given time to work their way through the writing process to communicate their stories, information, and opinions. Teachers provide direct instruction.

Other Information:

All curricula are aligned to the New Jersey Student Learning Standards to provide a robust and rigorous path for our students. Pre-K uses Creative Curriculum and Kindergarten through 3rd Grade use the enVisionmath 2.0 program to help support their learning and help build number sense and mathematical thinking. Our district has made great strides in providing access to all our students and teachers. All students in grades K-3 are assigned individual Gmail accounts and use these accounts to log into Chromebooks for various explorations, research, publishing, game based learning and collaborative learning experiences. Students work together on Google Drive to create projects and teachers collaborate on digital unit plans. Our school shifted to 1:1 Chromebooks for Grades 2 & 3 with all students using Chromebooks during media instruction. All K-1 classes have iPads and students utilize the apps to support learning in all content areas. Students have access to RAZ Kids, Pearson Realize, IXL, Newsela, and other online subscriptions to enhance instruction and learning. Teachers are posting #FHLeads class happenings and leveraging their school based social media accounts to increase family engagement. Website design continues to evolve through Weebly and Google Classroom in order to enhance student motivation, family connectedness, and public awareness of our school community's accomplishments. Students can be seen actively learning with QR codes, digital photography, iMovie and Kahoot! Mindfulness activities are part of our regular school day in Grades K-3. As students transition from the excitement of recess back into their afternoon of learning, teachers will lead various exercises and routines to help children self-regulate their minds, bodies, and emotions. In collaboration with our school psychologist and occupational/physical therapists, we have created a toolbox for teachers to easily access and implement.
