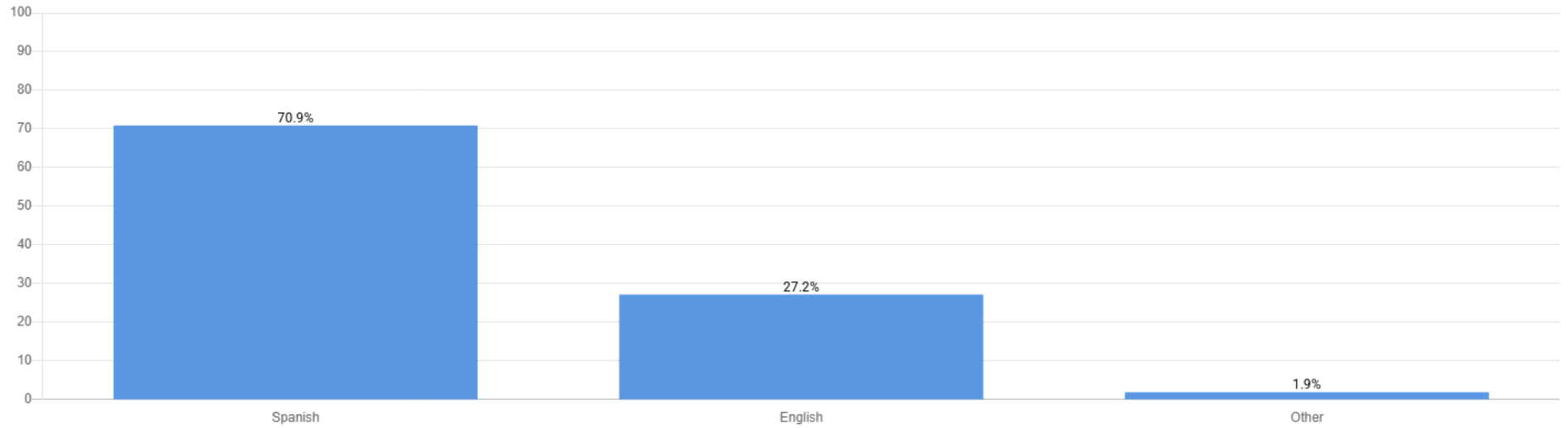

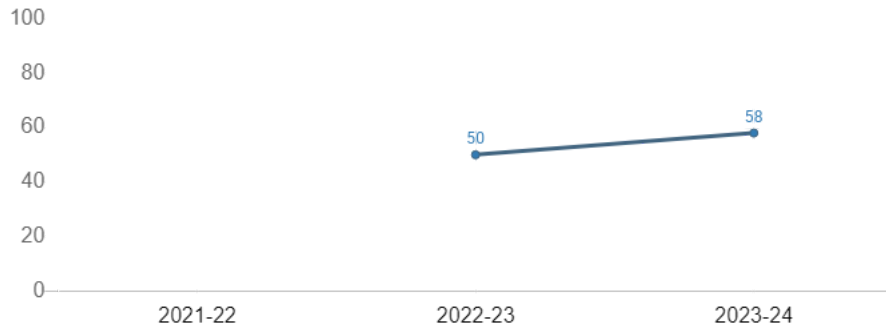

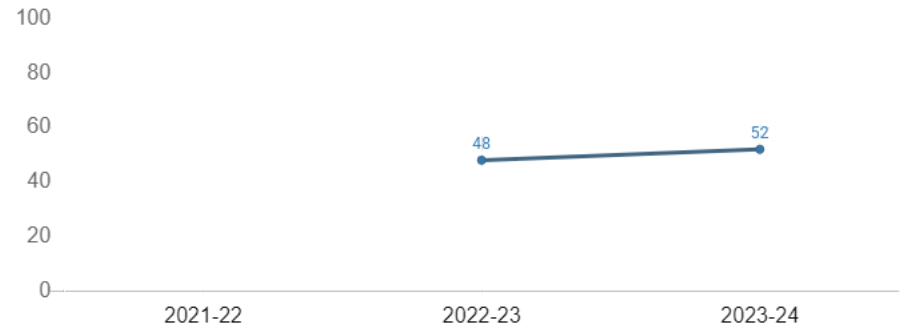

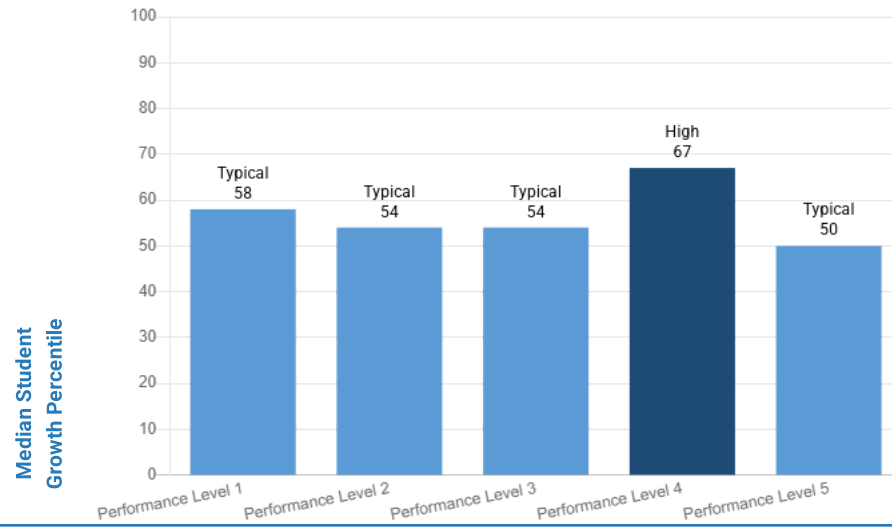

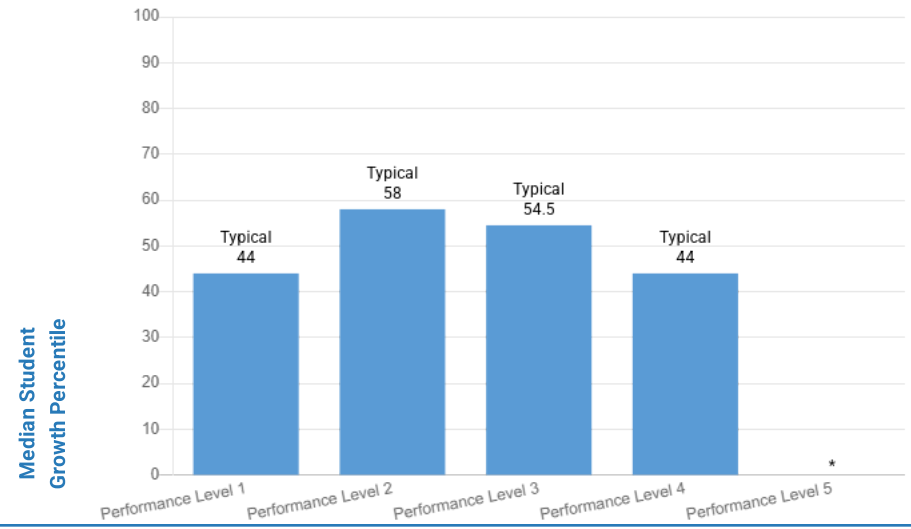

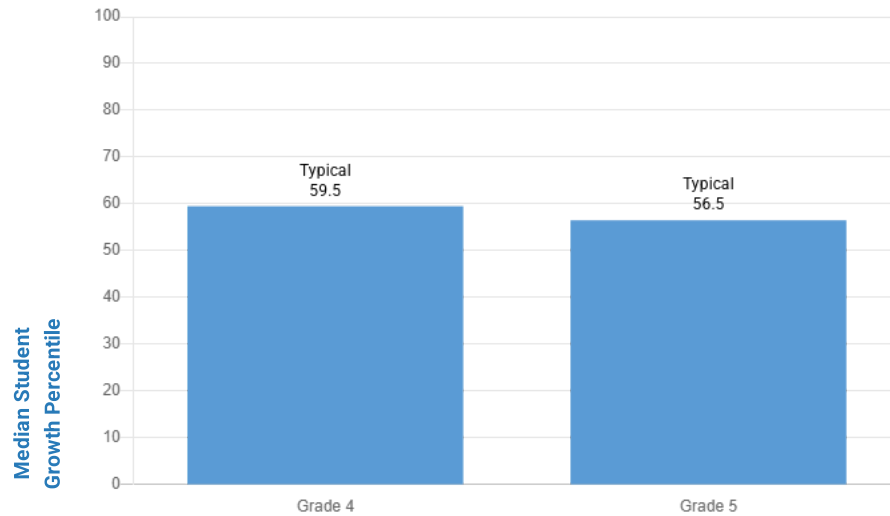

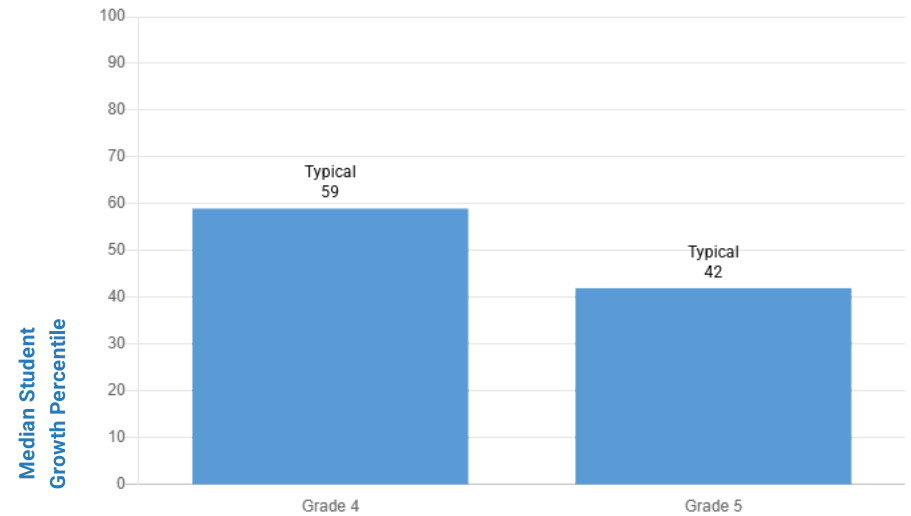

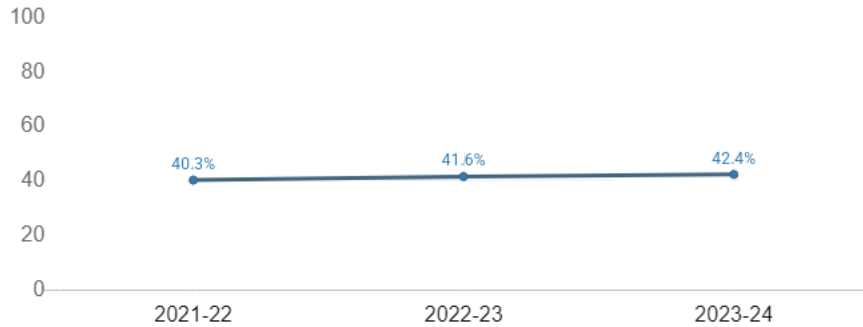

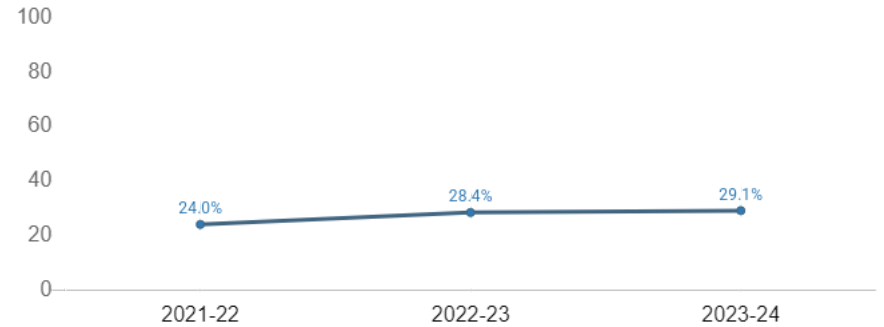
English Language Arts and Mathematics Performance Trends

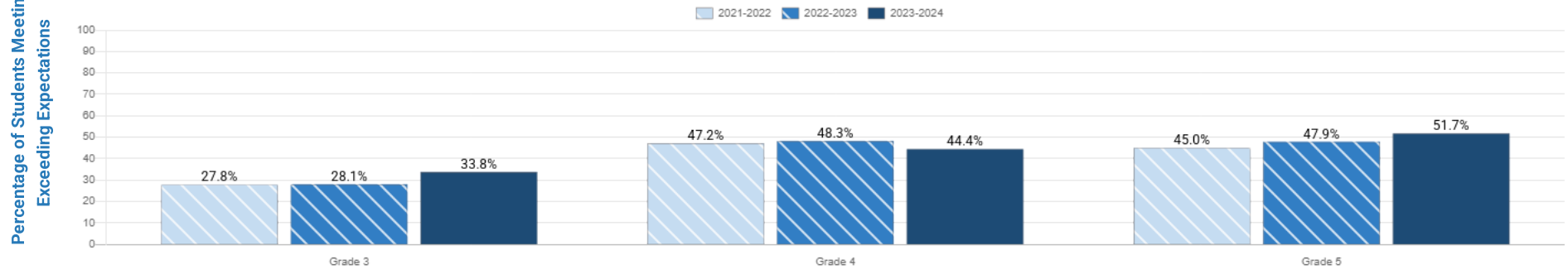

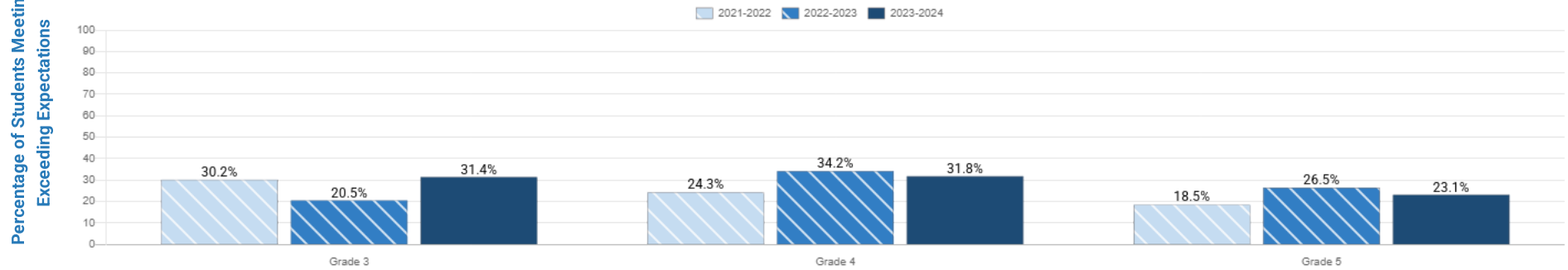

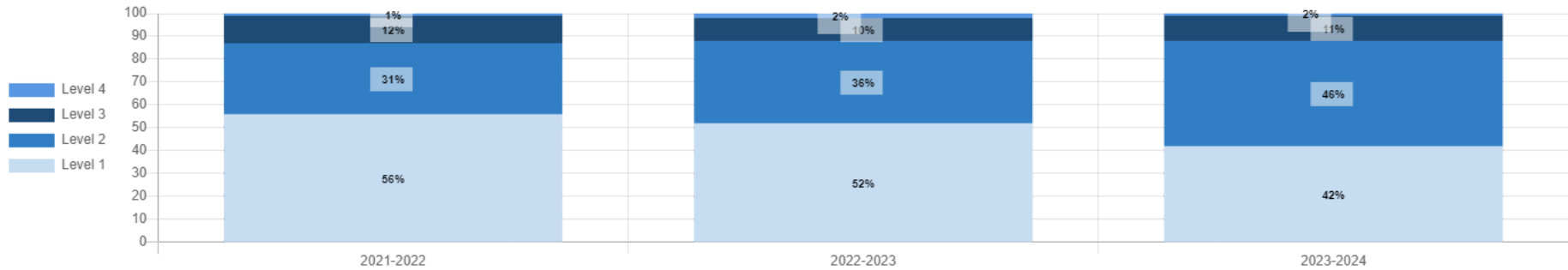

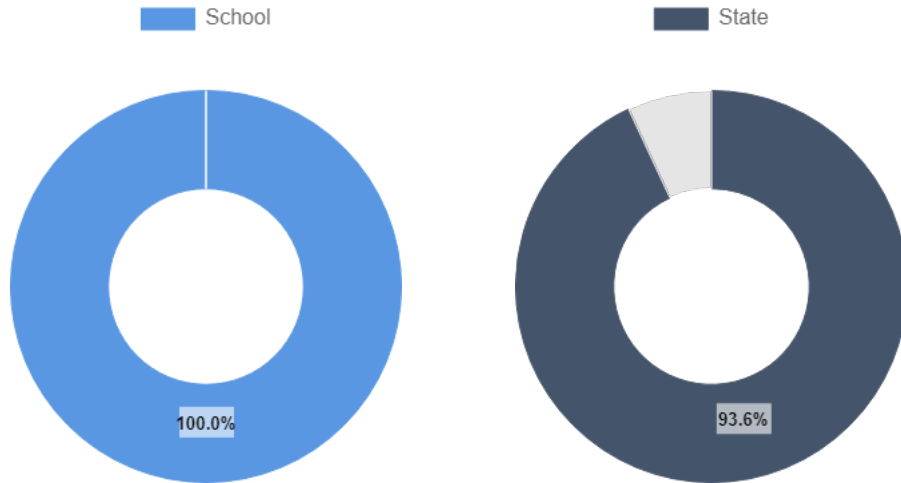

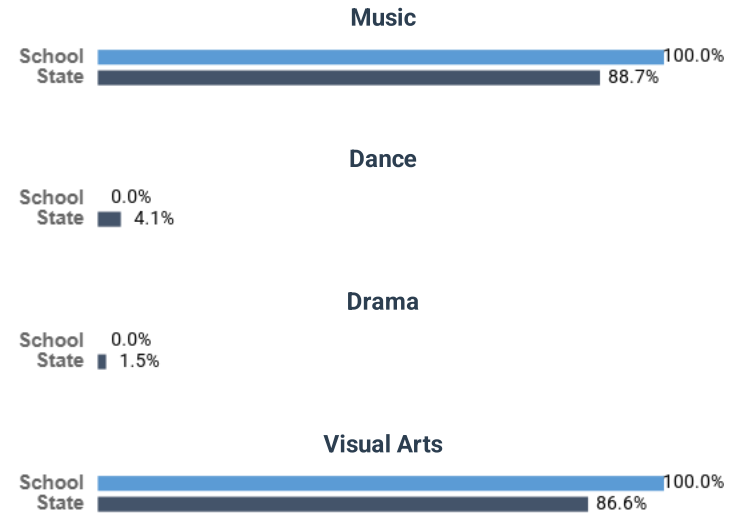

Students enrolled in one or more classes by discipline:



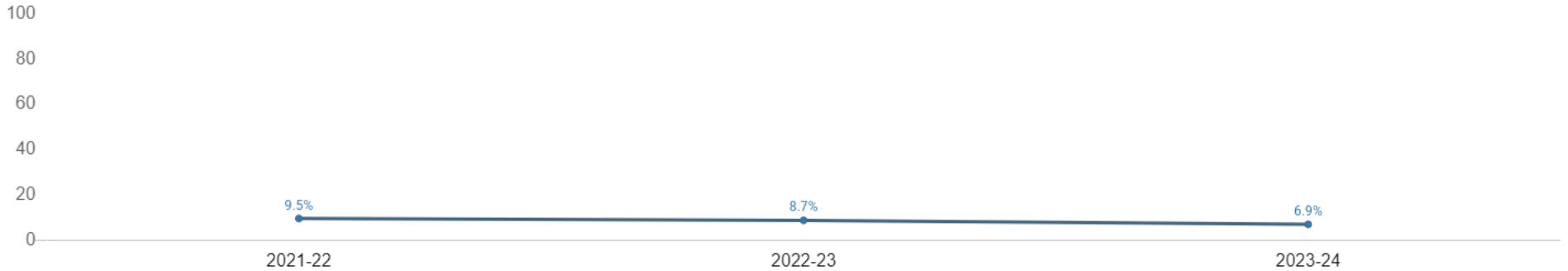

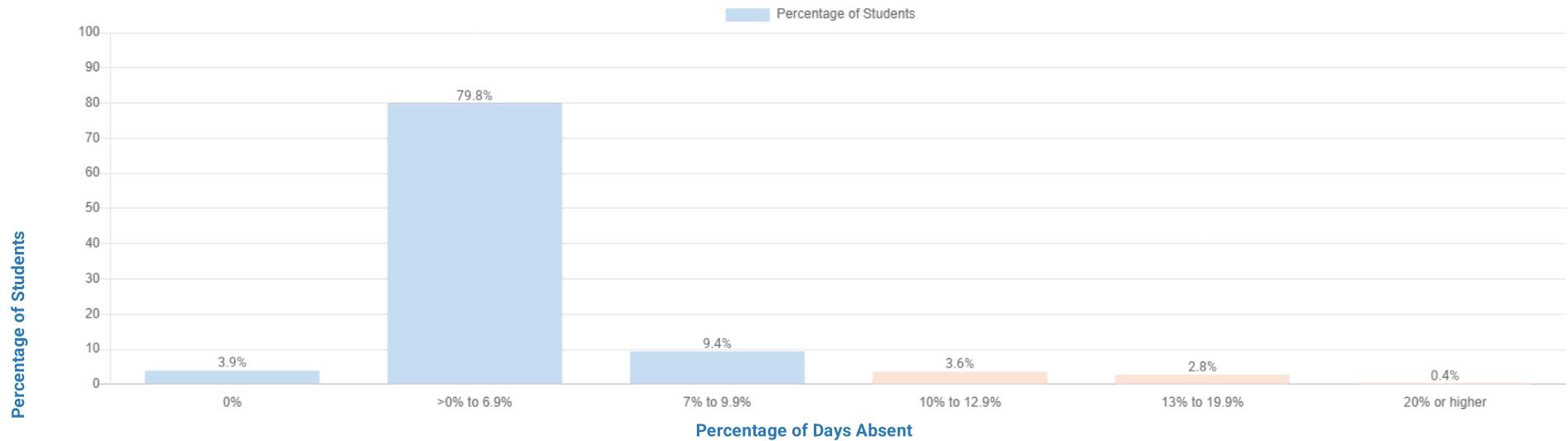

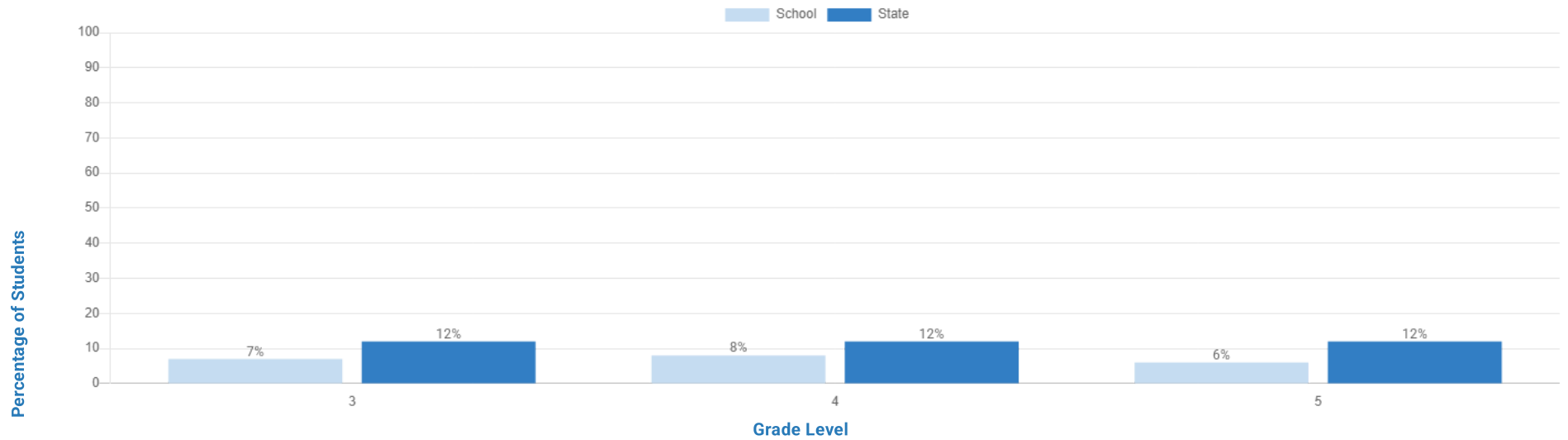

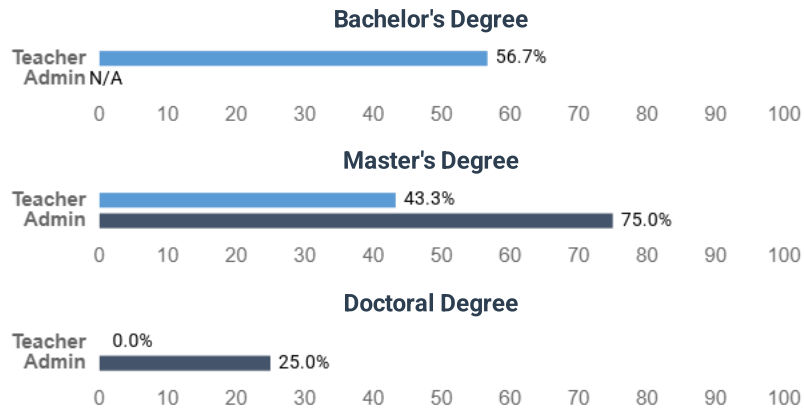

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Our campus consists of 24 General Education classrooms, 3 self-contained classrooms, 2 gyms, 2 cafeterias and additional classrooms dedicated to ELL, BSI, and Sped instruction.



School Safety:

Our school is committed to maintaining a safe and secure learning environment for all students. We have implemented comprehensive safety protocols, including secure entrances, regular emergency drills, and a security guard. Additionally we foster a culture of respect and inclusivity, ensuring that every student feels supported, valued, and protected while at school.



Technology and STEM:

In recent years, the school has introduced a one-to-one device program, ensuring each student is equipped with a tablet or laptop. Teachers use interactive whiteboards and digital platforms like Google Classroom, to assign and collect work, provide feedback, and engage students in collaborative projects. In addition, students have the opportunity to further their technological skills through technology class and our Gifted and Talented program. Also, our 5th grade students hone their STEM skills through participation in the Starbase program which presents them with hands on learning opportunities.
