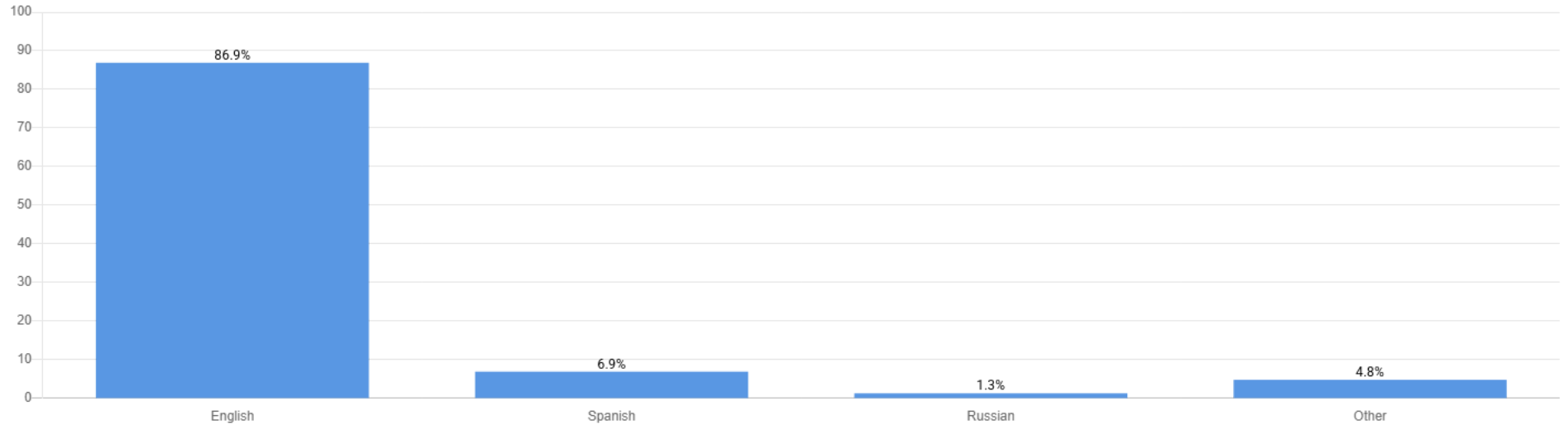

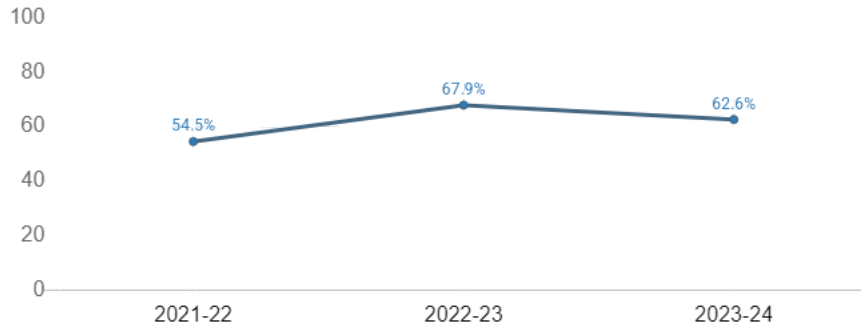

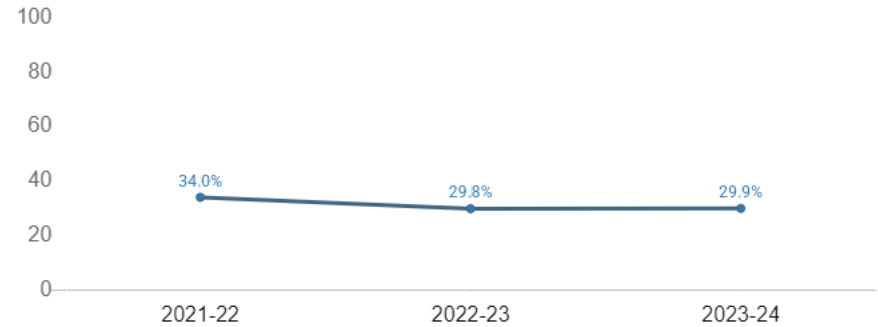
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. The data includes the results of students taking both the New Jersey Student Learning Assessment (NJSLA) and the DLM alternate assessment for English language arts (ELA) and mathematics. 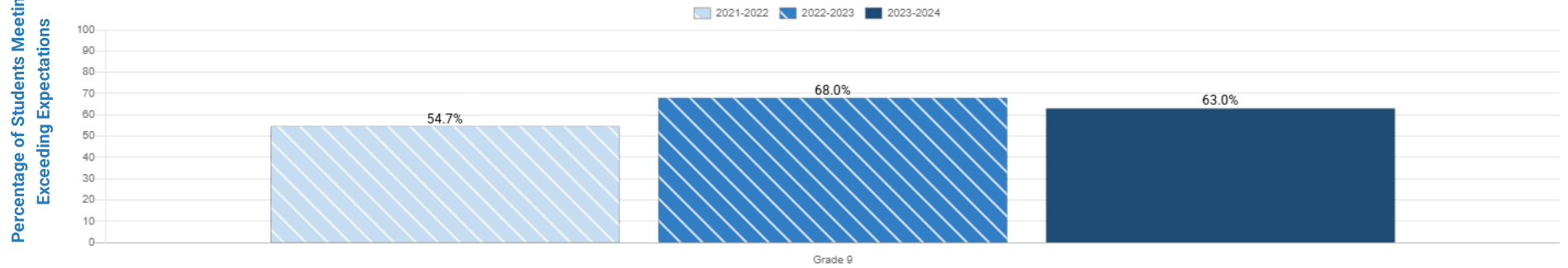

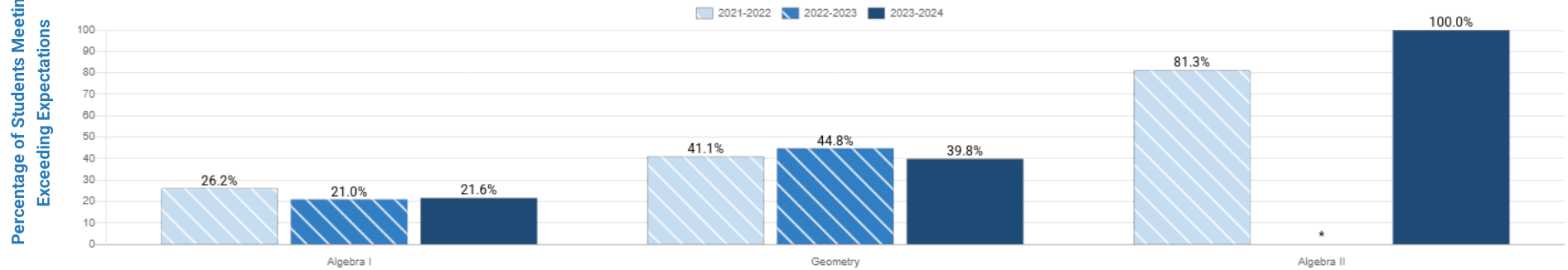

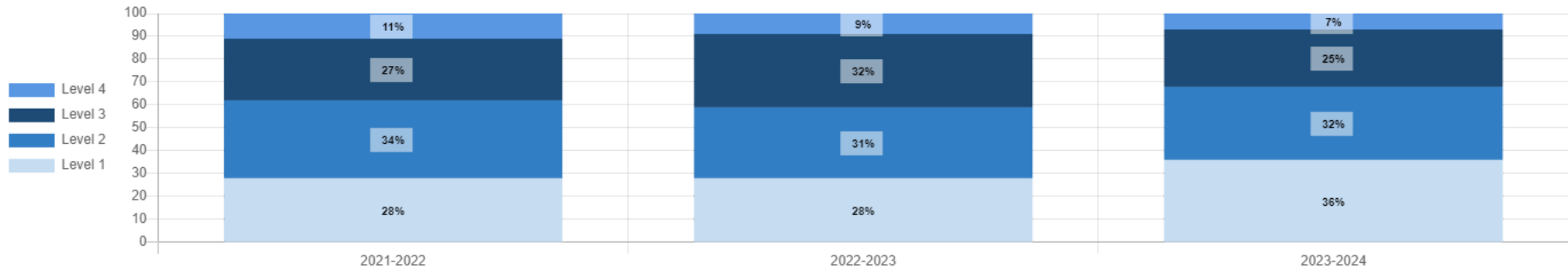

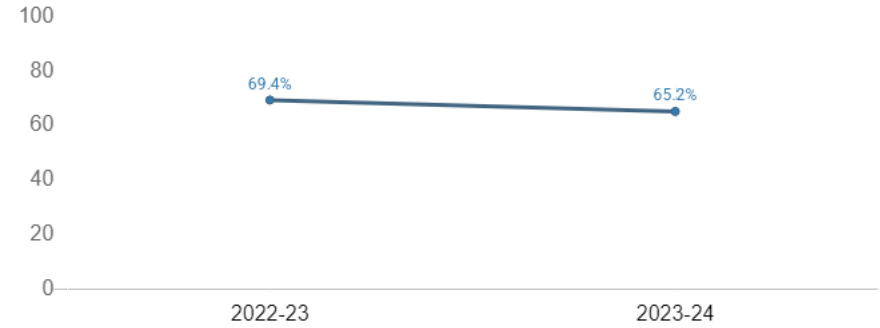

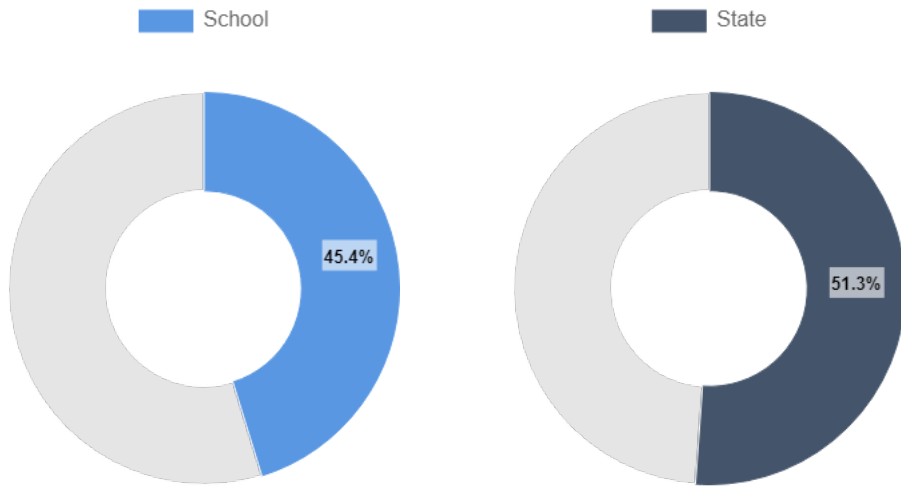

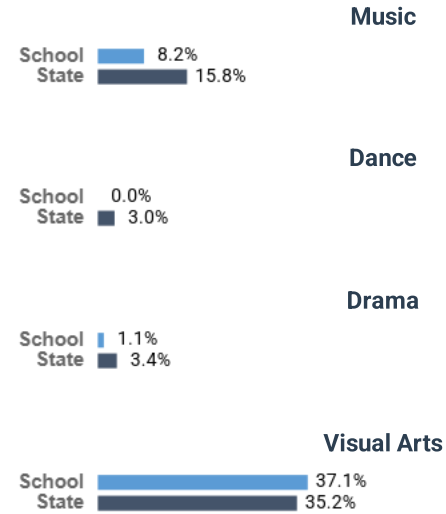

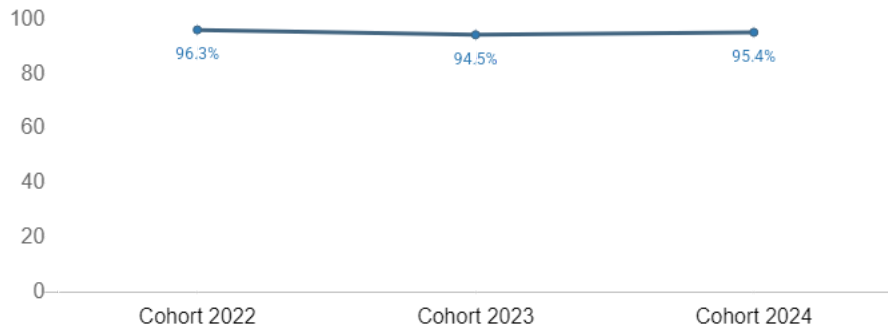

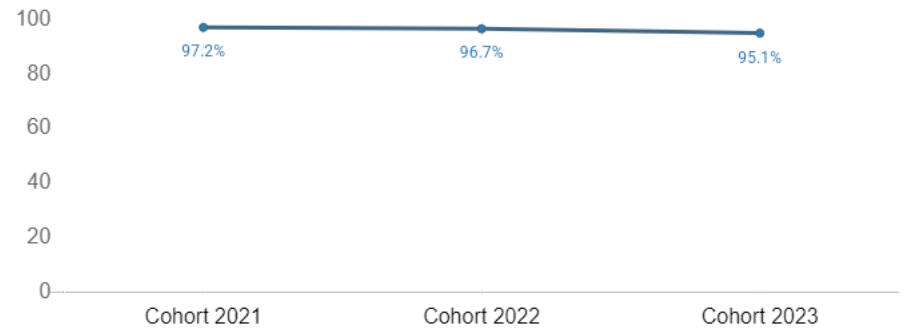

New Jersey graduates are matched to postsecondary enrollment data by NSC each year. While most students who enroll in a postsecondary institution each year are able to be matched by NSC, there are some students each year who cannot be matched. Some reasons that students may not be matched are: 1. Postsecondary enrollment cannot be shared with the NJDOE if students request a FERPA block on their postsecondary enrollment records; 2. Students who attend a college or university outside of the United States are not included in NSC data; 3. Certain colleges or universities may not participate in sharing data with NSC or may fail to report data for a certain semester or a certain group of students; and 4. NSC may not be able to match a student's name or date of birth in NJ SMART to the information provided by the postsecondary institution(s) with a high level of confidence.

In 2023, NSC implemented an additional manual review process to reduce the number of students who do not match due to #4 above, which may result in NSC matching additional students to postsecondary records moving forward. As a result, the NJDOE is not including trend data from prior to 2022-2023 in the reports.

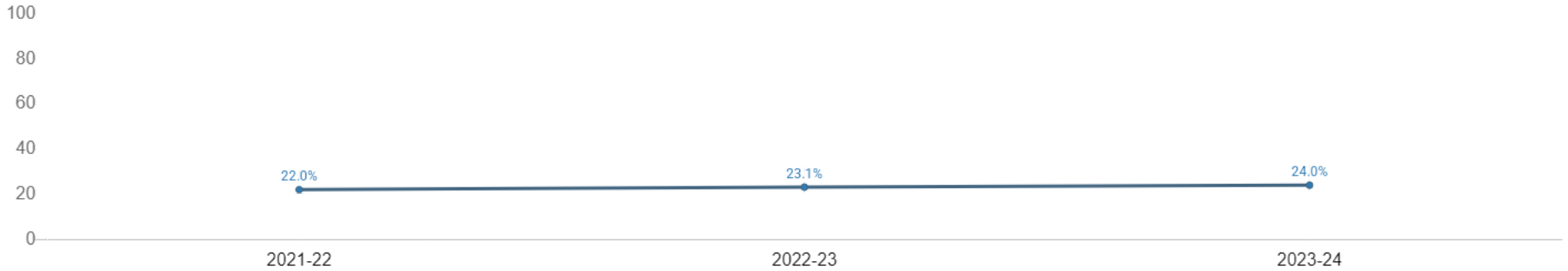

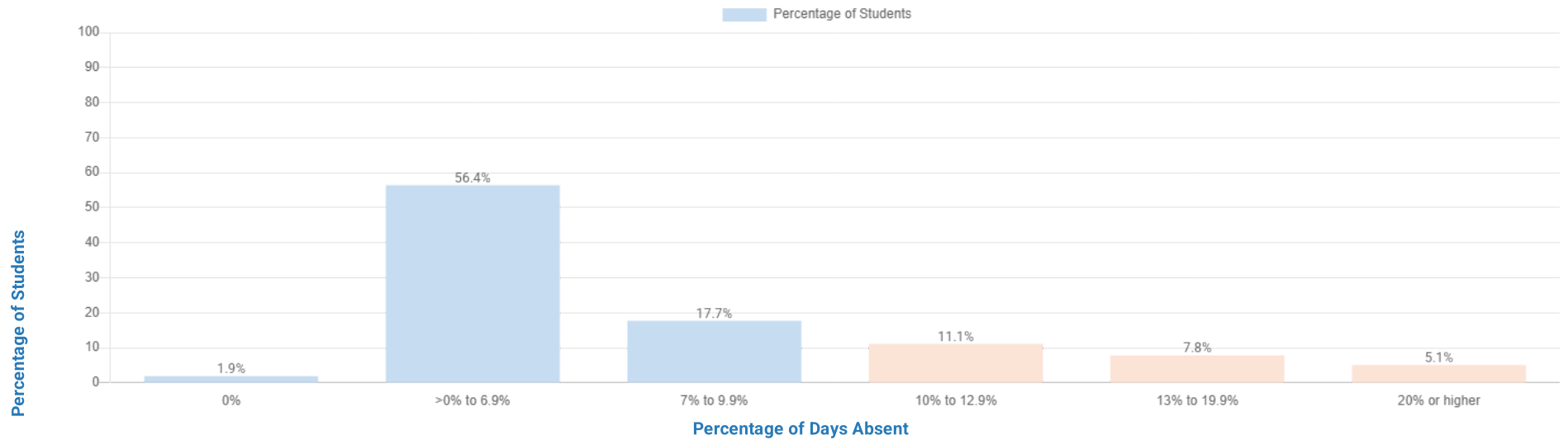

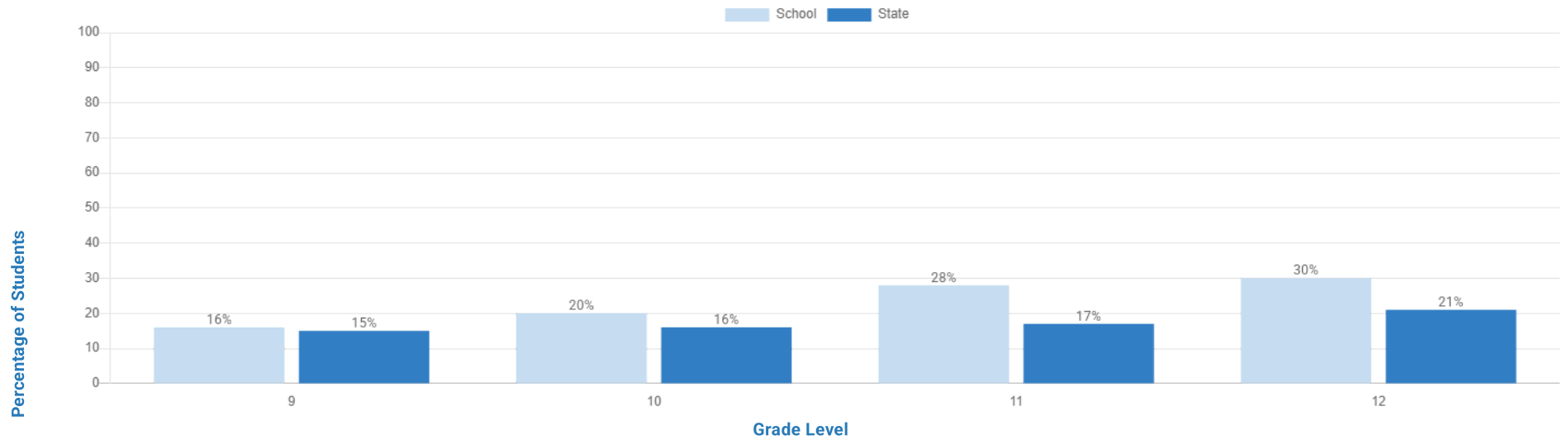

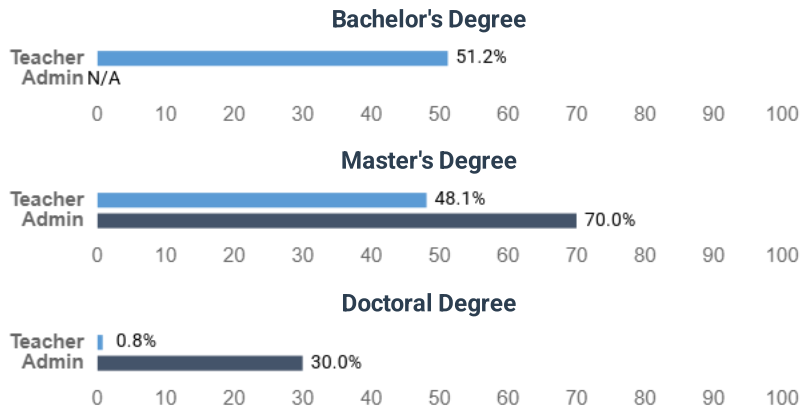

Math and English tutoring for struggling students is offered at the school in the Media Center by our certified staff members. Tutoring is offered through local funds. FTHS also offers peer tutoring through our National Honor Society.



Staff and Professional Learning:

A multitude of professional learning opportunities are available to staff including Professional Learning Communities, SciP committee programs, district-wide collaborative workshops, as well as training offered by professional organizations. All professional learning endeavors seek to maximize opportunities for students to develop important college and career readiness skills essential in a complex global society: critical thinking, collaboration, communication, and creativity. Staff are also provided professional development in Restorative Practices to proactively support the culture and climate of the school. Other Information:

The educational program at Freehold Township High School encompasses more than 180 courses, organized in 13 different academic disciplines. The high school is the site of programs unique to the Freehold Regional High School District: Global Studies Magnet Program; the Animal and Botanical Magnet Program; the Patriot Employment Program (PEP), an employment orientation program for the developmentally disabled; and the Workplace Training Program (WTP), which offers community-based internships for special needs students. The curriculum offers access to exploratory, enrichment, and specialized courses of study in accordance with state standards and graduation requirements. Advanced Placement courses are offered in 22 areas, and through a partnership with Brookdale Community College, students can earn college credits both on and off-site. Freehold Township High School was authorized in 2015 as an International Baccalaureate (IB) World School. The International Baccalaureate Diploma Program is a comprehensive and rigorous pre-university course of studies for highly motivated 11th and 12th graders. Of the 502 members of the Class of 2024, 20 students earned the prestigious IB Diploma. A comprehensive, developmental school counseling program provides career, academic and social-emotional programs, as well as individual and group counseling to assist students in reaching their full potential. Students have historically scored well on the SAT, PSAT, and Advanced Placement tests. Every year we have students recognized by the National Merit Scholarship Program. Approximately 91.34% percent of the Class of 2024 pursued further education at college, university, trade or technical school. Members of the graduating class earned over \$16 million in scholarships, grants, and financial aid.
